How to complete the information report for a for-profit corporation:

Each of the numbered instructions below corresponds to a section on the form.

1. List the business's ID number issued by the Kansas Secretary of State (this is not a tax ID number). ID numbers may be found at <https://www.sos.ks.gov/eforms/BusinessEntity/Search.aspx>.
2. Provide the complete legal business name, including words of formation (e.g., Corp., Inc., etc.)
3. Provide the principal office of the business.

Principal office: Must be a physical address that must include the building number, street, city, state, and zip code. This can't be a PO box. **Do not leave blank.**

4. Provide the reporting year for the information report. This year must reflect the year the report was due.

For revivals and foreign applications only: Review the instructions for the revival or foreign application to determine the number of information reports needed.

- 5a. Each name of the officer of the corporation must be listed along with a title for the officer and the address where they may be regularly located.
- 5b. Provide each name of the directors of the corporation along with the address where they may be regularly located. The directors may be omitted if the officers are the same individuals.
6. Provide the nature of business the business is engaged in.
- 7a. Provide an indication if the business holds a majority ownership in any other business that is currently filed with the Kansas Secretary of State's Office. Continue with section 7b if answered yes or continue with section 8 if answered no.

- 7b. Provide both the business name and the Kansas Secretary of State ID number for each business that the corporation owns a majority ownership in. Both fields must be completed.
8. Provide an indication if the business owns land suitable for agricultural use. Complete the form AG if answered yes or disregard the form AG if answered no.
9. An authorized person on behalf of the business must sign.

AG - Information Report Agricultural Attachment Instructions

1. Each tract or lot must be detailed in this section. This includes a numerical response for the location, indicate if the land was acquired after July 1st, 1981, a brief description of how the land is used, and an indication if the land is owned or leased.
2. Respond to each of the categories if applicable. At least one of the categories must have a numerical response.
3. A numerical response must be provided, even if zero.
4. Respond to each of the categories if applicable. At least one category with the value and location must have a response.

Kansas Attorney General Notice

Effective July 1, 2025, it is required for businesses or individuals owning or acquiring any interest in real property located within 100 miles of the boundary of any military installation located in Kansas, Nebraska, Colorado, Oklahoma, Iowa, and Texas to register said interest with the Kansas Attorney General's Office.

The following are subject to this requirement:

The government, any political party or subdivision, any corporate entity, any agent, or any citizen of the following:

- People's Republic of China (including the Hong Kong special administrative region)
- Republic of Cuba
- Islamic Republic of Iran
- Democratic People's Republic of Korea
- Russian Federation
- Bolivarian Republic of Venezuela
- Any organization that is designated as a foreign terrorist organization

This includes any individual having a controlling interest in any company formed for the purpose of holding interest in real property on behalf of any of the foregoing.

Any of the above businesses or individuals owning an interest in real property described above must submit the Foreign Principal Real Property Interest Registration Form found on the Attorney General's website at <https://www.ag.ks.gov> to the Kansas Attorney General on or before 90 days of either registering with the Kansas Secretary of State or upon acquisition of the real property.
