**OPINION NO. 82-43**

**Cities and Municipalities—City Councils—Members Abstaining from Voting.** Warren D. Andreas, City Attorney, Winfield, February 19, 1982.

If a quorum of a municipal council is present and a majority of the members voting vote in favor of a particular matter, abstentions from voting are to be counted as acquiescence with the votes of the majority, and the action will bind the body. Abstentions from voting may not be counted as acquiescence where there is a tie vote and the proposition fails for lack of a majority voting in favor thereof. Cited herein: K.S.A. 1981 Supp. 72-8205. **OPINION NO. 82-44**

**Public Health—Solid and Hazardous Waste—Sale or Lease of County Trash Hauling Trucks to a Private Individual.**

**Counties and County Officers—General Provisions—Sale or Lease of County Trucks to Private Individual.** Rodney K. Lyons, Stafford County Attorney, St. John, February 19, 1982.

A board of county commissioners may sell county trucks under their general authority granted in K.S.A. 19-212 *Sixth* without complying with the requirements of K.S.A. 19-211 if the appraised value of said trucks is less than \$25,000. Alternatively, the county may lease said trucks to a private individual in order to establish an effective solid waste management program. Cited herein: K.S.A. 19-211, 19-212, 65-3401, 65-3410. BLH.

**OPINION NO. 82-45**

**Elections—Registration of Voters—Expenses for Late Hours of Registration.** Jack H. Brier, Secretary of State, Topeka, February 19, 1982.

Expenses incurred by city clerks in connection with the provision of late hours for voter registration pursuant to K.S.A. 25-2311(d) are not election expenses to be borne by counties in accordance with K.S.A. 25-2201 *et seq.*, but are registration expenses to be paid by the cities pursuant to K.S.A. 25-2315. Cited herein: K.S.A. 25-2201, 25-2301, 25-2311, 25-2315. WRA.

**OPINION NO. 82-46**

**Bonds and Warrants—Cash Basis Law—Lease-Purchase and Installment-Purchase Agreements.** Mr. Charles N. Henson, Counsel for U.S.D. No. 501, Topeka, February 19, 1982.

K.S.A. 1981 Supp. 10-1116b permits the governing body of a municipality to enter into certain agreements which provide for periodic payments or monthly installments. However, any such agreement must state specifically that the municipality is obligated only to pay periodic payments or monthly installments as have been provided for in the budget of the municipality for the current budget year, or which can be paid from funds derived from a lawfully operated revenue pro-

ducing source. Accordingly, an agreement which obligates a municipality to make payments, in any year subsequent to its current budget year, or which may result in the municipality being obligated for an amount in excess of the funds provided in the budget of the municipality for the current budget year, does not comply with this statute. #### OPINION NO. 82-47

**State Boards, Commissions and Authorities—Kansas Water Office and Kansas Water Authority—Powers of Authority's Ex Officio Members.** Patrick J. Regan, Chairman, Kansas Water Authority, Wichita, February 22, 1982.

*Ex Officio* members of the Kansas Water Authority are precluded by K.S.A. 1981 Supp. 74-2622 from voting on matters considered by the Authority, but such members are entitled to participate fully in that body's deliberations regarding such matters. Participation in the Authority's deliberative process includes the ability to make or second a motion, which is but a formalized expression of proposed action, and is not an integral part of the voting process whereby members of the Authority cast their votes to express approval or disapproval. Cited herein: K.S.A. 1981 Supp. 74-2622. WRA.

Sealed bids will be received by the Board of Commissioners of the City of Lawrence, Kansas, at the City Clerk's Office in the City Hall at 6 East 6th Street at 10:00 a.m., C.S.T., Tuesday, March 16, 1982, at which time bids will be publicly opened for the purchase of General Obligation Internal Improvement Bonds of the City of Lawrence, Kansas, in the principal amount of \$1,545,000.00.

Said bonds shall be dated April 1, 1982.

Series B Bonds shall be in the denomination of \$5,000.00 each and shall mature as follows:

\$155,000.00 each year on April 1, 1983 through 1991.

\$150,000.00 on April 1, 1992.

Said bonds are not callable and will constitute general obligations of the City of Lawrence, Kansas. The principal and interest on said bonds are partially payable from special assessments levied against the benefitting lands, and if not so paid, then from ad valorem taxes which may be levied without limitation as to rate or amount upon all tangible property within the City.

Interest on said bonds will be paid semi-annually on April 1 and October 1 of each year beginning April 1, 1983; both principal and interest payable at the Office of the State Treasurer, Topeka, Kansas.

Bonds are being issued for the construction of sanitary sewers, alley paving, streets, sidewalks, storm sewers, and street overlay improvements.

The bonds, properly executed, will be furnished by the City of Lawrence, Kansas, without cost to the successful bidder. The legal opinion of Gaar & Bell of Kansas City, Missouri, will be furnished and paid for by the City of Lawrence, Kansas.

Bonds will be delivered to the successful bidder approximately May 1, 1982.

Coupon Rate: Proposals will be received on bonds bearing such rates of interest as may be specified by the bidder: However, each rate specified shall apply to all bonds of the same maturity.

*Be it enacted by the Legislature of the State of Kansas:*

Section 1. K.S.A. 1981 Supp. 82a-619 is hereby amended to read as follows: 82a-619. (a) Every district incorporated under this act shall have perpetual succession, subject to dissolution or consolidation pursuant to law; and shall have the power of: (1) To exercise eminent domain within the boundaries of such district; shall be empowered (2) to sue and be sued; shall be capable of contracting and being contracted with (3) to contract; shall be authorized and empowered (4) to hold such real and personal property as may come into its possession acquired by will, gift, purchase, or otherwise, as authorized by law; shall have power and (5) to construct, install, maintain and operate such ponds, reservoirs, pipelines, wells, check dams, pumping installations or other facilities for the storage, transportation or utilization of water and such appurtenant structures and equipment as may be necessary to carry out the purposes of its organization; and.

(b) Each such district shall have the power: (1) To cooperate with and enter into such into agreements as deemed necessary with the secretary of the United States department of agriculture or the secretary's duly authorized representative, and shall have power necessary to carry out the purposes of its organization; and (2) to accept such financial or other aid which the secretary of agriculture of the United States department of agriculture is empowered to give pursuant to 16 U.S.C.A., secs. 590r, 590s, 590x-1, 590x-a and 590x-3, or amendments thereto; and.

(c) Each such district shall have the power to acquire loans for the financing of up to 95% of the cost of the construction or purchase of any project or projects necessary to carry out the purposes for which such district was organized and to execute notes and mortgages in evidence thereof with interest, or combined interest and mortgage insurance charges, which shall not to exceed 6% 13%, except that for purposes of interim financing for a period not exceeding two years, interest or combined interest and mortgage insurance charges shall not exceed 9% 14%. Any district shall have the same power to acquire loans for the refinancing of up to 95% of the original cost of any such project or projects. The balance of the cost of construction shall be acquired by subscription, donation, gift or otherwise than through the medium of loans, except that in the case of cooperative corporations and corporations not for profit being converted to water districts as provided for in K.S.A. 82a-631 to 82a-635, inclusive, the district may assume 100% of the indebtedness of the corporation, providing the corporation originally raised at least 10% of the construction cost by means otherwise than through the medium of loans.

(d) Any such loan may be secured by any or all of the physical assets owned by the district, including easements and rights-of-way, except that no district organized under this act shall have any power or authority to levy any taxes whatsoever.

Sec. 2. K.S.A. 1981 Supp. 82a-619 is hereby repealed.

## HOUSE BILL No. 2672

AN ACT relating to the taxation of property; concerning the release, discharge, remission or commutation of taxes; authorizing the settlement of certain tax claims by boards of county commissioners; amending K.S.A. 79-1703 and repealing the existing section.

*Be it enacted by the Legislature of the State of Kansas:*

Section 1. K.S.A. 79-1703 is hereby amended to read as follows: 79-1703. (a) Except as provided in subsection (b) or as otherwise provided by law, no board of county commissioners or other officer of any county shall have power to release, discharge, remit or commute any portion of the taxes assessed or levied against any person or property within their respective jurisdictions for any reason whatever. Any taxes so discharged, released, remitted or commuted may be recovered by civil action from the members of the board of county commissioners or such other officer and the sureties of their official bonds at the suit of the attorney general, the county attorney, or of any citizen of the county or the board of education of any school district a part of the territory of which is in such county, as the case may be, and when collected shall be paid into the county treasury to be properly apportioned and paid to the county, municipalities, school districts and other taxing subdivisions entitled thereto.

(b) In the event a railroad has failed to pay any portion of the taxes assessed or levied against its property located within any county by reason of a pending bankruptcy proceeding in the federal courts pursuant to federal statutes, the county commissioners of any such county may compromise, assign, transfer or otherwise settle such tax claim in such fashion as the commissioners deem to be in the best interest of the state and all taxing subdivisions affected thereby, except that, the state and each other taxing subdivision affected by any such settlement shall receive the same proportional share of its respective tax claim.

## SENATE BILL No. 542

AN ACT making and concerning appropriations for the fiscal year ending June 30, 1982, for capital improvements for the state geological survey; authorizing certain transfers, imposing certain restrictions and limitations, and directing or authorizing certain receipts and disbursements and acts incidental to the foregoing.

*Be it enacted by the Legislature of the State of Kansas:*

Section 1. (a) The expenditure limitation established by section 29(b) of chapter 32 of the 1981 Session Laws of Kansas on the geological survey fund is hereby increased from \$59,490 to \$1,440,000.

(b) During the fiscal year ending June 30, 1982, expenditures may be made from the geological survey fund for a capital improvement project for Moore hall addition planning and construction (including equipment) and repairs to Moore hall, except that such expenditures shall not exceed \$1,380,510 and shall be in addition to expenditures authorized by section 29(b) of chapter 32 of the 1981 Session Laws of Kansas from the geological survey fund for Moore hall addition — final planning.

(c) On the effective date of this act, the director of accounts and reports shall transfer \$60,113 from the geological survey fund to the state general fund to reimburse the state general fund for expenditures for planning the Moore hall addition.

## HOUSE BILL No. 2654

AN ACT enacting the Thomas county hospital assets transfer act; relating to the transfer of all or part of the assets used by or owned by the Thomas county hospital; and providing authority for the transfer of ownership of all or part of the Thomas county hospital assets to the Thomas county hospital association.

*Be it enacted by the Legislature of the State of Kansas:*

Section 1. (a) In order to facilitate the transfer of hospital operations in Thomas county from the Thomas county hospital to the Thomas county hospital association, the board of county commissioners of Thomas county and the board of trustees of the Thomas county hospital are hereby authorized to transfer and convey to the Thomas county hospital association, a private, non-profit corporation, all or part of the assets of the Thomas county hospital as they may determine appropriate. Such transfer and conveyance of assets are in consideration of continuation of medical care services and assumption of certain liabilities of the Thomas county hospital by the Thomas county hospital association, and are deemed to be for a public purpose. These assets may include, but need not be limited to, unencumbered moneys, certificates of deposit, accounts receivable, reserve or bank accounts, supplies, inventory, equipment, fixtures and real estate used by or owned by the Thomas county hospital. Transfers and conveyances under this subsection (a) may be made from time to time as deemed appropriate by the board of county commissioners of Thomas county, Kansas and the board of trustees of the Thomas county hospital. The authority granted by this section is in addition to any other authority granted by law.

(b) Conveyances and other instruments appropriate to transfer all or part of the assets used by or owned by the Thomas county hospital to the Thomas county hospital association shall be executed by the chairman of the board of county commissioners of Thomas county.

Sec. 2. This act shall be known and may be cited as the Thomas county hospital assets transfer act.

Sec. 3. This act shall take effect and be in force from and after its publication in the Kansas register.
