**FY 83 GOVERNOR'S SPECIAL GRANT (CETA)  
REQUEST FOR PROPOSAL APPLICATIONS**

The Governor's Special Grant (CETA) Unit of the Department of Human Resources is now accepting applications for the development and implementation of collaborative projects between existing employment and training service providers (i.e., CETA, Job Service, WIN, vocational-technical schools, Vocational Rehabilitation, Economic Development, and community-based organizations).

Proposals are being requested for projects which establish collaborative projects between existing employment and training service deliverers that increase coordination and linkages between service providers. The intent of this RFP is to encourage service providers to combine resources (e.g., staff, clients, funds, facilities) for undertaking common functions to increase the efficiency and effectiveness of employment and training services. Collaborative activities may include (but need not be limited to) the following: intake and eligibility determination, employability assessment, job readiness training, planning, job development, and/or job placement. Funds may also be used to fund a community coordinator position responsible for local coordination efforts between employment and training service providers. Although funding may only be provided one year at a time, applicants are encouraged to develop a proposal for a two or three year project. The project should not establish a new administrative entity, but should develop or strengthen the collaborative bonds between existing employment and training agencies.

Based on preliminary planning estimates for Federal Fiscal Year 1983, the Governor's Special Grant Unit has allocated a maximum of \$25,000 per project. Any organization or agency wishing to be mailed a request for proposal package should contact Katie Krider or Terry Moore, Governor's Special Grant Unit, 512 West 6th, Topeka, KS 66603, 913/296-3893. The RFP package contains general information and requirements, project specifications, proposal format instructions, procedure descriptions, and proposal rating criteria.

The application deadline will be 5:00 p.m., August 27, 1982. Funded projects are expected to begin operation on or about November 1, 1982. The granting of awards is subject to the receipt of federal funds.

All of said bonds shall be negotiable coupon bonds in the aggregate principal amount of \$1,881,860.00, said bonds numbered 1 to 376, inclusive, Bond No. 1 being in the denomination of \$6,860.00 and Bond Nos. 2 through 376, inclusive, being in the denomination of \$5,000.00 each. All of said bonds will be dated September 1, 1982, and will mature serially on March 1 of each year commencing March 1, 1984, as follows:

Interest on said bonds will be payable semi-annually on March 1 and September 1 in each year through maturity, commencing March 1, 1984. Both principal of and interest on the bonds will be payable at the office of the State Treasurer in Topeka, Kansas. The bonds will not be subject to redemption prior to maturity.

All of said bonds will be and constitute the general obligation of the City of Lenexa and the full faith and credit of the City shall be pledged to the payment of the principal of and interest on said bonds. Such principal and interest shall be payable from ad valorem taxes levied upon all taxable tangible property including land and improvements thereon located within the benefit districts benefited by the special improvements as described in the resolutions and ordinances with respect to said projects passed by the Governing Body, and, further, in the event of deficiency in any such payments upon all taxable tangible property including land and improvements thereon within the territorial limits of the City of Lenexa, Johnson County, Kansas.

No bids will be considered at a price of less than par and interest accrued on the bonds to date of the payment thereof by the purchaser.

Proposals will be received on bonds bearing such rate or rates of interest as may be specified by the bidders subject to the following conditions: Not more than ten different rates shall be specified and the same rate will apply to all bonds of the same maturity. Each interest rate specified shall be in an even multiple of one-eighth ( $\frac{1}{8}$ th) of 1% or ( $\frac{1}{20}$ th) of 1%. No rate shall exceed the most recent 20 bond index, as published in *The Weekly Bond Buyer* on the Monday next preceding the date of sale by more than 2%, and the differ-

ence between the highest rate specified and lowest rate specified if any bid shall not exceed 2½%.

One bid shall be submitted for all bonds hereinbefore described on an all or none basis. Bonds will be awarded to the highest and best bidder or bidders on an all or none basis. Determination of the best bid or bidders will be made by deducting the premium bid (if any) from the total interest costs and the Bonds will be awarded to the bidder bidding the lowest net interest cost to the City. The City will be entitled to rely on the stated net interest cost in awarding the Bonds. If there is any discrepancy between said lowest net interest cost and the coupon rates specified in said bid or the average annual net interest cost specified in said bid, the net interest cost figure shall govern and the coupon rates shall be adjusted accordingly.

The bonds printed, executed and registered with the Office of the State Treasurer will be furnished by the City, and the bonds will be delivered subject to the legal opinion of Linde Thomson Fairchild Langworthy Kohn & Van Dyke, P.C., Kansas City, Missouri, Bond Counsel. The bonds will be delivered to the purchaser on or about September 21, 1982 at any such bank or trust company in the Kansas City, Topeka, or Wichita metropolitan areas, as specified by the purchaser, or elsewhere at the expense of the purchaser.

At the request of the successful bidder, CUSIP identification numbers will be printed on said bonds, but neither the failure to print such numbers on any bonds nor any error with respect thereto shall constitute cause for a failure or refusal by the purchaser thereof to accept delivery of and pay for said bonds in accordance with the terms of the purchase contract. All expenses in relation to the printing of the CUSIP numbers on said bonds will be paid for by the City. The CUSIP Service Bureau's charge for assignment of said numbers will be the responsibility of and must be paid for by the purchaser.

The population of the city is approximately 18,639. The 1981 assessed valuation of all taxable tangible property within Lenexa, Kansas is \$118,729,929, including motor vehicle valuation of \$13,247,305. The total general obligation bonded indebtedness of Lenexa, Kansas, at the date hereof, including the issue of bonds herein offered for sale, is \$16,705,414. The City of Lenexa has temporary notes outstanding in the total amount of \$7,821,170, of which \$1,480,000 will be redeemed and cancelled from the proceeds of the bonds herein offered for sale.

A good faith deposit by cashier's or certified check in the amount of 2% of the total amount of the bid for the bonds shall accompany each bid.

Mailed bids should be addressed to the City Clerk, City Hall, Lenexa, Kansas, and marked "Bid for purchase of General Obligation Bonds, Series B-1982, Lenexa, Johnson County, Kansas." Bids may also be delivered to the said officer in the City Hall at Lenexa, Kansas, at or immediately prior to 7:30 o'clock p.m.

**ATTORNEY GENERAL****OPINION NO. 82-159**

**Counties and County Officers—Public Improvements—Bond Limitation. Representative David Webb, Twenty-Seventh District, Stilwell, July 19, 1982.**

The limitation on the issuance of county general obligation bonds, set forth in K.S.A. 19-2736, does not apply to sewer districts created under the provisions of K.S.A. 19-2704 to 19-2715. Cited herein: K.S.A. 19-2704, 19-2715, 19-2731, 19-2736, 19-2752, 19-2787, 19-2792, 19-27,113. TRH

**OPINION NO. 82-160**

**State Departments; Public Officers, Employees—Department of Administration—Application of Allotment System. John Carlin, Governor of Kansas, Topeka, July 26, 1982.**

K.S.A. 75-3722 provides for an allotment system to assure that expenditures for any particular fiscal year will not exceed the available resources of the general fund or any special revenue fund for that fiscal year. In determining whether an allotment system is to be imposed, the secretary of administration may utilize the revenue estimates of the director of the budget.

An allotment system may be imposed on any appropriation from any fund for which the allotment system is established, including appropriations to fund statutorily-prescribed state aid programs, and it need not be applied equally or on a pro rata basis to all such appropriations. However, an allotment system has no application to a statutorily-prescribed transfer of money from one fund in the state treasury to another fund in the state treasury, since such transfer does not constitute an appropriation. Nor may an allotment system be imposed in any fiscal year for the purpose of increasing the estimated ending balance of any such fund for that fiscal year or for the purpose of controlling temporary cash shortages.

At the point in time the secretary of administration notifies a state agency as to the imposition of an allotment system on such agency's appropriations, such agency is to be regarded as subject to the allotment system, for purposes of K.S.A. 75-3723, and the director of the budget is thereby empowered under K.S.A. 75-3723(1) to require such agency to furnish information regarding its estimated revenues and expenses. **Cities and Municipalities—Code of Procedure for Municipal Courts—Costs; Home Rule Powers. David H. Heilman, Council Grove City Attorney, Council Grove, July 28, 1982.**

A city may, through the adoption of a valid charter ordinance, exempt itself from the provisions of K.S.A. 12-4112, and provide for the assessment of court costs in municipal court cases. Cited herein: K.S.A. 12-4101,

**OPINION NO. 82-162**

**Public Health—Examination and Registration of Pharmacists—Private, Not-For-Profit Family Planning Clinics; Distribution and Control of Prescription Medications. Senator Roy M. Ehrlich, Thirty-Fifth District, Hoisington, July 28, 1982.**

The provisions of K.S.A. 65-1648 (as amended by L. 1982, ch. 262, § 5), which authorize registered nurses to distribute (under certain prescribed circumstances) prescription medications at private, not-for-profit family planning clinics, are valid and constitutional. A prescription-only drug may be distributed at such a clinic only where there has been compliance with the provisions of subsection (q) of K.S.A. 65-669. However, whether competent medical practice necessitates a physical examination prior to receiving prescription medications can be determined only by consideration of the facts of each specific case. **OPINION NO. 82-163**

**Counties and County Officers—Ambulance Service—Discretion to Provide. Steven W. Rogers, City Attorney, Fredonia, July 28, 1982.**

K.S.A. 19-261 allows boards of county commissioners to provide ambulance services as a county function. K.S.A. 19-261 also allows boards of county commissioners to contract with any city, person, firm, or corporation for the furnishing of ambulance services. However, boards of county commissioners are not required to provide ambulance services either as a county function or by contract. Cited herein: K.S.A. 19-261, 19-262. RVE.
