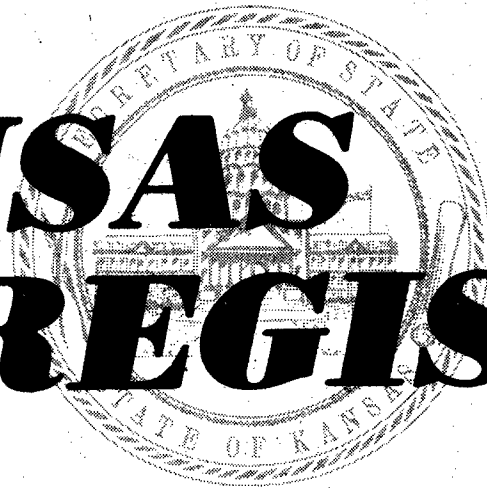

OPINION NO. 83-8

Automobiles and Other Vehicles—Serious Traffic Offenses—Driving While Under Influence of Alcohol. Charles V. Hamm, General Counsel, Department of Social and Rehabilitation Services, Topeka, January 21, 1983.

Section 10 of L. 1982, Ch. 144 requires the secretary of social and rehabilitation services to establish a state alcohol and drug safety action program (ADSAP). The state ADSAP is funded through an assessment of \$85 upon each person who is convicted of, pleads *nolo contendere* to, or participates in a diversion program as a result of, a violation of K.S.A. 1981 Supp. 8-1567. Moneys in the fund may be expended for a variety of services specified by statute, including pre-sentence evaluations, and supervision and monitoring subsequent to sentencing, of persons convicted of or pleading *nolo contendere* to a violation. As a person participating in a diversion program does not fall into either of the above categories, the secretary is without authority to expend moneys from the fund on evaluations for such individuals who have not actually been convicted or pled *nolo contendere*. However, assessment funds can be used to pay, in full or in part, the cost of any alcohol treatment and/or education program required by the diversion agreement. Cities of the First Class—City of Kansas City—Councilman Simultaneously Holding Other Office.

Schools—Community Colleges—Trustee Simultaneously Holding Other Office. Nick A. Tomasic, Wyandotte County District Attorney, Kansas City, January 21, 1983.

The common law doctrine of incompatibility of offices precludes one person from simultaneously holding the offices of member of the Board of Trustees of Kansas City, Kansas Community College and city councilman for the city of Kansas City, Kansas. WRA

Elections—City Elections—One Person's Simultaneous Candidacies for Two City Offices. Jack H. Brier, Secretary of State, Topeka, January 24, 1983.

Description of the Bonds

The Bonds will consist of negotiable coupon bonds in the denomination of \$5,000 each, dated March 1, 1983, and becoming due serially on March 1 in the years without option of prior payment as follows:

The Bonds will bear interest from the date thereof at rates to be determined when the Bonds are sold as hereinafter provided, and said interest will be payable semiannually on March 1 and September 1 in each year, beginning on March 1, 1984.

Place of Payment

Both principal and interest on the Bonds will be payable in lawful money of the United States of America at the Office of the State Treasurer in the City of Topeka, Kansas.

Security for the Bonds

The Bonds will be general obligations of the City, payable as to both principal and interest in part from special assessments levied upon the property benefited by such improvements and, if not so paid, from ad valorem taxes which may be levied without limitation as to rate or amount on all the taxable tangible property within the City, the balance payable from ad valorem taxes which may be levied without limitation as to rate or amount on all taxable tangible property within the City.

Conditions of Bids

Bids will be received on the Bonds bearing such rate or rates of interest as may be specified by the bidders, subject to the following conditions: The Bonds will be sold in one block on an "all or none" basis. The same rate shall apply to all Bonds maturing in the same year. Not more than five different interest rates shall be specified, but a rate may be repeated. Each interest rate specified shall be a multiple of 1/8 or 1/20 of 1%. No interest rate shall exceed a rate equal to the 20 bond index of tax exempt municipal bonds published by *The Weekly Bond Buyer*, in New York, New York, on the Monday next preceding the day on which the Bonds are sold, plus 2%, and the difference between the highest and lowest interest rates specified in any bid shall not exceed 2%. Basis of Award

Each bid shall specify the total interest cost to the City during the life of the Bonds on the basis of such bid, the premium, if any, offered by the bidder, the net interest cost to the City on the basis of such bid, and the average annual net interest rate on the basis of such bid. The net interest cost to the City shall be determined by subtracting the amount of the premium, if any, from the total interest cost to the City and shall be stated as a dollar amount in the bid. The City shall be entitled to rely upon such dollar amount as stated in the bid as the basis for determining the lowest net interest cost bid. If there is any discrepancy between said net interest cost and the average annual net interest rate specified, the specified net interest cost shall govern and the coupon rates specified in the bid shall be adjusted accordingly.

Delivery of and Payment for the Bonds

The City will pay for printing and registering the Bonds and will deliver the same properly executed and registered to the successful bidder within 45 days from the date of sale at such bank or trust company located in Kansas or Missouri, as may be specified by the successful bidder, without cost to the successful bidder, or elsewhere at the expense of the successful bidder. Payment for the Bonds shall be made in federal funds or other funds which shall be available to the City on the same day the Bonds are delivered to the successful bidder. The successful bidder will be furnished with a certified transcript evidencing the authorization and issuance of the Bonds and the usual closing proofs, which will include a certificate that there is no litigation pending or threatened at the time of the delivery of the Bonds affecting their validity.

Legal Opinion

The Bonds will be sold subject to the legal opinion of the City's Bond Counsel, GAAR & BELL, Overland Park, Kansas, whose unqualified approving opinion will be furnished and paid for by the City and will be printed on the Bonds.

CUSIP Numbers

At the request of the successful bidder, CUSIP

identification numbers will be printed on the Bonds, but neither the failure to print such number on any bond nor any error with respect thereto shall constitute cause for failure or refusal by the purchaser thereof to accept delivery of and pay for the Bonds in accordance with the terms of the successful bid and this Notice of Bond Sale. All expenses in relation to the printing of CUSIP numbers on the Bonds will be paid for by the City. The CUSIP Service Bureau's charge for assignment of said numbers will be paid for by the successful purchaser.

Good Faith Deposit

Each bid must be accompanied by a good faith deposit in the form of a cashier's or certified check in the amount of \$24,400, made payable to the order of the Treasurer of the City of Lawrence, Kansas. Such check, or the proceeds thereof, will be held by the Treasurer pending payment for and delivery of the Bonds to the successful bidder. In the event the successful bidder shall fail to carry out its contract of purchase, the amount of said deposit shall be retained by the City as liquidated damages. SENATE BILL No. 27

AN ACT relating to the county and city revenue sharing fund; concerning the allocation and distribution of moneys therefrom; amending K.S.A. 1982 Supp. 79-2964 and 79-2966 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 1982 Supp. 79-2964 is hereby amended to read as follows: 79-2964. There is hereby created the county and city revenue sharing fund. All moneys transferred or credited to such fund under the provisions of this act or any other law shall be allocated and distributed in the manner provided herein. The director of accounts and reports in each year on ~~March 15, June 15, September July 15 and December 15~~, shall make transfers in equal amounts which in the aggregate equal ~~three and one-half percent (3½%)~~ 3½% of the total retail sales and compensating taxes deposited in credited to the state treasury general fund pursuant to articles 36 and 37 of chapter 79 of the Kansas Statutes Annotated and acts amendatory thereof and supplemental thereto during the preceding calendar year from the state general fund to the county and city revenue sharing fund.

Sec. 2. K.S.A. 1982 Supp. 79-2966 is hereby amended to read as follows: 79-2966. Fifty percent of a county's entitlement from the county and city revenue sharing fund shall be the county government's share of such fund and the remaining 50% shall be allocated to each city in such county in the proportion that the population of each such city bears to the population of all such cities in the county. Persons residing within the Fort Riley military reservation shall not be included or considered in determining the population of any city located in Riley county or Geary county. The state treasurer shall make distributions from the county and city revenue sharing fund in accordance with the allocation formulas prescribed in the foregoing provisions of this act in quarterly installments on the dates prescribed in K.S.A. 1982 Supp. 79-2964. The director of accounts and reports shall draw warrants on the state treasurer in favor of the several county treasurers and city treasurers on the dates and in the amounts determined as provided. The distributions shall be paid directly by mail to the several county treasurers and city treasurers who shall upon receipt of the moneys deposit the same in their respective county or city general funds.

SENATE BILL No. 35

AN ACT amending the Kansas withholding and declaration of estimated tax act; amending K.S.A. 1982 Supp. 79-3298 and 79-32,107 and repealing the existing sections.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 1982 Supp. 79-3298 is hereby amended to read as follows: 79-3298. (a) *With respect to any taxes withheld before April 1, 1983, every employer, under this act other than employers who have received the prior approval of the director to file an annual return, shall file a withholding return on or before the last day of the first month following the end of the calendar quarter in which withholding was required. Whenever the total amounts withheld by an employer do not exceed the sum of \$200 in any calendar year, such employer, upon the prior approval of the director of taxation and upon such conditions as the director may prescribe, may file an annual return on or before January 31 in lieu of filing quarterly returns.* Such return shall be on a form prescribed by the director of taxation and shall be accompanied by payment in full of any amounts withheld by the employer. *Employers who have received the approval of the director to file an annual return before the effective date of this act shall comply with the applicable provisions of subsection (b).*

(b) *With respect to any taxes withheld after March 31, 1983, every employer shall remit the taxes and file returns in accordance with the following provisions. Whenever the total amount withheld exceeds \$8,000 in any calendar year, the employer shall remit the taxes withheld for wages paid during the first 15 days of any month on or before the 25th day of that month. The employer shall remit the taxes withheld for wages paid during the remainder of that month on or before the 10th day of the following month. Whenever the total amount withheld exceeds \$1,200 but does not exceed \$8,000 in any calendar year, the employer shall remit the taxes withheld during any month on or before the 15th day of the following month. Whenever the total amount withheld exceeds \$200 but does not exceed \$1,200 in any calendar year, the employer shall remit the taxes withheld in any calendar quarter on or before the 15th day of the first month following the end of that calendar quarter. Whenever the total amount withheld does not exceed \$200 in any calendar year, the employer shall remit the taxes withheld during that year on or before January 15 of the following year.*

(c) *Each remittance required under the provisions of subsection (b) shall be accompanied by a Kansas withholding tax remittance form prescribed and furnished by the director.*

(d) *Every employer making remittances pursuant to subsection (b) shall file a return on a form prescribed and furnished by the director for each calendar year on or before January 31 of the following year.*

(e) *The excess of any remittance over the actual taxes withheld in any withholding period shall be credited against the liability for following withholding periods until exhausted. A refund shall be allowed in accordance with K.S.A. 79-32,105, and amendments thereto, where an overpayment cannot be adjusted by an offset against the liability for a subsequent withholding period.*

(f) *Determinations of amounts withheld during a calendar year by employers for purposes of determining filing requirements shall be made by the director upon the basis of amounts withheld by those employers during the preceding calendar year or by estimates in cases of employers having no previous withholding histories. The director is hereby authorized to modify the filing schedule for any employer when it is apparent that the original determination was inaccurate.*

(g) *Whenever the director has cause to believe that money withheld by an employer pursuant to this act may be converted, diverted, lost, or otherwise not timely paid in accordance with this section, the director shall have the power to require returns and payment from any such employer at any time at more frequent intervals than prescribed by this section in order to secure full payment to the state of all amounts withheld by such employer in accordance with this act.*

Sec. 2. K.S.A. 1982 Supp. 79-32,107 is hereby amended to read as follows: 79-32,107. (a) All penalties and interest pre-

scribed by K.S.A. 1982 Supp. 79-3228, and amendments thereto, for noncompliance with the income tax laws of Kansas shall be applicable for noncompliance with the provisions of the Kansas withholding and declaration of estimated tax act relating to withholding tax which shall be enforced in the same manner as the "Kansas income tax act." A penalty at the same rate per annum prescribed by subsection (b) of K.S.A. 1982 Supp. 79-2968(b) 79-2968, and amendments thereto, for interest upon delinquent or unpaid taxes shall be applied and added to a taxpayer's amount of underpayment of estimated tax due from the date the estimated tax payment was due until the same is paid or until the 15th day of the fourth month following the close of the taxable year for which such estimated tax is a credit, whichever date is earlier, but such penalty shall not be added if the total amount thereof does not exceed \$1. For purposes of this subsection, the amount of underpayment of estimated tax shall be the excess of the amount of the installment which would be required to be paid if the estimated tax were equal to 80% of the tax shown on the return for the taxable year or, if no return was filed, 80% of the tax for such year, over the amount, if any, of the installment paid on or before the last date prescribed for payment. Amounts due from any employer on account of withholding or from any individual for estimated tax may be collected by the director in the manner provided for the collection of state income tax in K.S.A. 79-3235.

(b) No penalty or interest shall be imposed upon any individual with respect to any underpayment of any installment if the total amount of all payments of estimated tax made on or before the last date prescribed for the payment of such installment equals or exceeds the amount which would have been required to be paid on or before such date if the estimated tax were whichever of the following is the least:

(1) The tax shown on the return of the individual for the preceding taxable year, if a return showing a liability for tax was filed by the individual for the preceding taxable year and such preceding year was a taxable year of 12 months;

(2) an amount equal to 66 $\frac{2}{3}$ %, in the case of individuals referred to in K.S.A. 79-32,102(b), and amendments thereto, and 80%, in the case of all other individuals, of the tax for the taxable year computed by placing on an annualized basis, pursuant to rules and regulations adopted by the secretary of revenue, the taxable income for the months in the taxable year ending before the month in which the installment is required to be made;

(3) an amount equal to 90% of the tax computed, at the rates applicable to the taxable year, on the basis of the actual taxable income for the months in the taxable year ending before the month in which the installment is required to be paid as if such months constituted the taxable year; or

(4) an amount equal to the tax computed, at the rates applicable to the taxable year, on the basis of the taxpayer's status with respect to personal exemptions under K.S.A. 1982 Supp. 79-32,121, and amendments thereto, for the taxable year, but otherwise on the basis of the facts shown on the return for, and the law applicable to, the preceding taxable year.

(c) No penalty or interest shall be imposed upon any corporation with respect to any underpayment of any installment of estimated tax if the total amount of all payments of estimated tax made on or before the last date prescribed for the payment of such installment equals or exceeds the amount which would have been required to be paid on or before such date if the estimated tax were whichever of the following is lesser:

(1) The tax shown on the return of the corporation for the preceding taxable year, if a return showing a liability for tax was filed by the corporation for the preceding taxable year and such preceding year was a taxable year of 12 months;

(2) an amount equal to the tax computed at the rates applicable to the taxable year but otherwise on the basis of the facts shown on the return of the corporation for, and the law applicable to, the preceding taxable year; or

(3) (A) an amount equal to 80% of the tax for the taxable year computed by placing on an annualized basis the taxable income: (i) For the first three months of the taxable year, in the case of the installment required to be paid in the fourth month; (ii) for the first three months or for the first five months of the taxable year, in the case of the installment required to be paid in the sixth

month; (iii) for the first six months or for the first eight months of the taxable year in the case of the installment required to be paid in the ninth month; and (iv) for the first nine months or for the first 11 months of the taxable year, in the case of the installment required to be paid in the 12th month of the taxable year.

(B) For purposes of this subsection (3), the taxable income shall be placed on an annualized basis by (i) multiplying by 12 the taxable income referred to in subsection (3)(A), and (ii) dividing the resulting amount by the number of months in the taxable year (three, five, six, eight, nine, or 11, as the case may be) referred to in subsection (3)(A).

(d) If the employer, in violation of the provisions of this act, fails to deduct and withhold under this chapter, and thereafter the tax against which such withholding may be credited is paid, the amount otherwise required to be deducted and withheld shall not be collected from the employer; but this subsection shall in no case relieve the employer from liability for any penalties or additions to the tax otherwise applicable in respect of such failure to deduct and withhold.

(e) Any person required to collect, truthfully account for, and pay over any tax imposed by this act, who willfully fails to collect such tax, or truthfully account for and pay over such tax, or willfully attempts in any manner to evade or defeat any such tax or the payment thereof, shall in addition to the other penalties of this section be liable to a penalty equal to the total amount of the tax evaded, or not collected, or not accounted for and paid over.

(f) In case of failure by any employer required by subsection (b) of K.S.A. 79-3298, and amendments thereto, to remit any amount of withheld taxes by the date prescribed therefor, unless it is shown that such failure is due to reasonable cause and not due to willful neglect, there shall be imposed upon such person a penalty of 25% of the amount of the underpayment. For purposes of this subsection, the term "underpayment" means the excess of the amount of the tax required to be withheld and remitted over the amount, if any, remitted on or before the date prescribed therefor. The failure to remit for any withholding period shall be deemed not to continue beyond the last date prescribed for filing the annual return as required by subsection (d) of K.S.A. 79-3298, and amendments thereto. Penalty and interest as prescribed by K.S.A. 79-3228, and amendments thereto, shall not begin to accrue under subsection (a) of this section on the amount of any such underpayment until the due date of the annual return for the calendar year in which such failure to remit occurs.

SENATE BILL No. 36

AN ACT amending the Kansas retailers' sales tax and Kansas compensating tax acts; concerning the method and time of payment of the taxes; amending K.S.A. 1982 Supp. 79-3607 and 79-3706 and repealing the existing sections.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 1982 Supp. 79-3607 is hereby amended to read as follows: 79-3607. On or before the last day of each calendar month, every person engaged in the business of selling tangible personal property at retail, and furnishing services taxable under this act, in this state during the preceding calendar month; (a) Retailers shall make a return returns to the director of taxation at the times prescribed by this section upon forms prescribed and furnished by the director of taxation, stating: (a) (1) The name and address of the seller retailer; (b) (2) the total amount of gross sales of all tangible personal property and taxable services rendered by him or her during the preceding calendar month; (c) the retailer during the period for which the return is made; (3) the total amount received during the preceding calendar month period for which the return is made on charge and time sales of tangible personal property made by him or her; and taxable services rendered; prior to the month period for which the return is made; (d) (4) deductions allowed by law from such total amount of gross sales; and from total amount received during the preceding calendar month period for which the return is made on such charge and time sales; (e) (5) receipts during the preceding calendar month period for which the return is made from the total amount of sales of tangible personal property and taxable services rendered by him or her during such month period in the course of such business, after deductions allowed by law have been made; (f) (6) receipts during the preceding calendar month period for which the return is made from charge and time sales of tangible personal property made by him or her and taxable services rendered prior to such month period in the course of such business, after deductions allowed by law have been made; (g) (7) gross receipts during the preceding calendar month period for which the return is made from sales of tangible personal property and taxable services rendered by him or her in the course of such business upon the basis of which the tax is imposed. The return shall include such other pertinent information as the director of taxation may require. In making such return, the seller retailer shall determine the market value of any consideration, other than money, received by him or her in connection with the sale of any tangible personal property; in the course of his or her the business; and shall include such value in his or her the return; which. Such value shall be subject to review and revision by the director of taxation; as hereinafter provided. Refunds made by the seller retailer during the preceding calendar month period for which the return is made on account of tangible personal property returned to the seller retailer shall be allowed as a deduction under subdivision (d) (4) of this section in case the seller retailer has theretofore included the receipts from such sale in a return made by him or her; such retailer and paid taxes therein imposed by this act. The person making the return herein required; retailer shall, at the time of making such return, pay to the director of taxation the amount of tax herein imposed, except as otherwise provided in this section. The director of taxation may extend the time for making returns and paying the tax required by this act for any period not to exceed sixty (60) 60 days; under such rules and regulations as the secretary of revenue may prescribe. When the total tax for which any person retailer is liable under this act, does not exceed the sum of five dollars (\$5) in any month; or sixty dollars (\$60) for any annual reporting period; he or she may with the approval of the director of taxation and upon such conditions as the director of taxation may prescribe, file an annual return; on or before January 31; which return shall be accompanied by the tax disclosed thereby. When the total tax for which any person is liable under this act; does not exceed the sum of one hundred dollars (\$100) in any month; or twelve hundred dollars (\$1,200) for any annual reporting period; he or she may; with the approval of the director of taxation and upon such conditions as the director of taxation may prescribe; file a quarterly return; which return shall be accompanied by the tax disclosed thereby on or before the thirty-first day of January; the thirtieth day of April;

the thirty-first day of July; and the thirty-first day of October; in each year; for the period ending on the last day of the preceding month \$60 in any calendar year, the retailer shall file an annual return on or before January 25 of the following year. When the total tax liability does not exceed \$1,200 in any calendar year; the retailer shall file returns quarterly on or before the 25th day of the month following the end of each calendar quarter. When the total tax liability exceeds \$1,200 in any calendar year, the retailer shall file a return for each month on or before the 25th day of the following month. When the total tax liability exceeds \$24,000 in any calendar year, the retailer shall be required to pay the sales tax liability for the first 15 days of each month to the director on or before the 25th day of that month. Any such payment required to be made on or before April 25, 1983, shall be accompanied by a remittance form furnished by the director, and any such payment required to be made thereafter shall accompany the return filed for the preceding month. A retailer will be considered to have complied with the requirements to pay the first 15 days' liability for any month if, on or before the 25th day of that month, the retailer paid 90% of the liability for that fifteen-day period or 50% of such retailer's liability in the immediate preceding calendar year for the same month as the month in which the fifteen-day period occurs, and, in either case, paid any underpayment with the payment required on or before the 25th day of the following month. Such retailers shall pay their sales tax liabilities for the remainder of each such month at the time of filing the return for such month. Determinations of amounts of liability in a calendar year for purposes of determining filing requirements shall be made by the director upon the basis of amounts of liability by those retailers during the preceding calendar year or by estimates in cases of retailers having no previous sales tax histories. The director is hereby authorized to modify the filing schedule for any retailer when it is apparent that the original determination was inaccurate.

(b) Any sales tax liability incurred by a retailer before the effective date of this act shall be reported and paid to the director in the same manner and at the same time as required under the provisions of this section immediately prior to its amendment by this act.

Sec. 2. K.S.A. 1982 Supp. 79-3706 is hereby amended to read as follows: 79-3706. Each retailer or person subject to the provisions of this act shall; on or before the last day of every calendar month; file a return with the director showing make remittances of the tax imposed by K.S.A. 79-3703 and file returns in accordance with the provisions of K.S.A. 79-3607 and amendments thereto, except that the time schedule for remitting tax and filing returns shall be determined on the basis of calendar year compensating tax liability in lieu of calendar year sales tax liability. Returns shall show in detail the total quantity of tangible personal property sold by any retailer or used, stored or consumed by any person within the state during the preceding calendar month period for which the return is filed subject to the tax herein imposed, and such other information as the director may deem pertinent. Each retailer or person shall remit to the director with each such return the amount of tax shown thereon to be due. If any tax is not paid when the same is due, there shall be added thereto interest at the rate per month prescribed by subsection (a) of K.S.A. 1982 Supp. 79-2968(a) 79-2968 from the date the tax was due until paid, except that if such tax is unpaid due to fraud with intent to avoid the tax, there shall be added thereto a penalty of fifty percent 50% of the amount of such tax together with the interest as provided above. Whenever, in the judgment of the director, the failure of any person to comply with this section is due to reasonable cause, the director may in the director's discretion waive or reduce any of the interest or penalty herein provided for, upon making a record of the reason therefor. The director may, upon request and a proper showing of the necessity therefor, grant an extension of time not to exceed sixty 60 days for making any return and payment. Returns shall be signed by the retailer or such retailer's duly authorized agent, and must be certified by such retailer to be correct.
