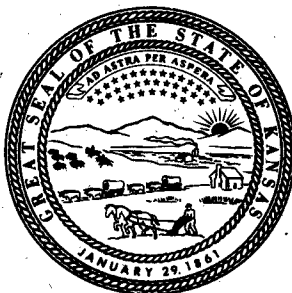

You are hereby notified that the Secretary of Social and Rehabilitation Services is offering the following described property located in the County of Stafford, State of Kansas, for an oil and gas lease pursuant to the provisions of K.A.R. 30-27-1 through K.A.R. 30-27-5, which regulations are made a part of this offer:

The Southwest Quarter (SW ¼) of Section 24, Township 22 South, Range 13 West. The above contains 160 acres, more or less.

The successful bidder shall be required to pay the costs of this publication before execution of the awarded lease.

The lease will be executed on a standard Kansas lease form with necessary modifications to comply with K.A.R. 30-27-1 through K.A.R. 30-27-5, and shall be for a period not to exceed three (3) years and so long thereafter as oil and gas is being produced therefrom in paying quantities.

The successful bidder shall file an indemnity bond in the amount of fifty thousand dollars (\$50,000) before the execution of the lease, which bond shall remain in effect for six (6) months after the term of the lease and for six (6) months after the plugging of any well.

The lessee shall erect a fence at least eight (8) feet high around any drilling or production devices within one thousand three hundred twenty (1,320) feet of any areas normally used by Winfield State Hospital and Training Center patients.

Bids will be considered on the basis of a cash bonus, annual delay rental, and the amount of royalty to be paid, which shall not be less than twelve and one-half percent (12½%) of the gross proceeds at the prevailing market rate.

Bids shall be submitted upon forms supplied by the Division of Purchases. The bid forms may be obtained from the Winfield State Hospital and Training Center Business Office or the State Division of Purchases, State Office Building, Topeka, Kansas 66612. All bids shall be sealed and accompanied by a certified check or bank draft in the amount of the cash bonus bid payable to the Secretary of Social and Rehabilitation Services, State Office Building, Topeka, Kansas, and

ATTORNEY GENERAL**OPINION NO. 84-46**

Public Health—Local Boards of Health—Joint Board by Cities and Counties; Agreement. Robert E. Davis, Leavenworth County Attorney, Leavenworth, June 1, 1984.

The city of Leavenworth and Leavenworth county may, through the exercise of their respective home rule powers and amendment of the agreement establishing the Leavenworth city-county board of health, exert control over the expenditure of moneys paid to the credit of the board. However, subsequent to approval of the budget of the joint board of health, and the levy and collection of a tax to fund the budget operations, the city and county are required, under the provisions of K.S.A. 65-206, to pay over all such moneys (but not exceeding the amount budgeted by each municipality for health, mental health and sanitation purposes) to the city-county board of health. Cited herein: K.S.A. 65-205, 65-206. TRH

OPINION NO. 84-47

Corporations — Agricultural Corporations — Limitations. Senator Gerald Karr, Seventeenth District, Emporia, June 1, 1984.

Pursuant to the restrictions of K.S.A. 17-5904, and subject to exemptions prescribed therein, corporations (other than family farm corporations and authorized farm corporations) may not own agricultural land in this state. An investment plan whereby a corporation (other than a family farm corporation or authorized farm corporation) would own agricultural land, subject to a "buy-back option," would violate the restrictions of the aforesaid statute. Cited herein: K.S.A. 1983 Supp. 17-5903, K.S.A. 17-5904. TRH

OPINION NO. 84-48

Personal and Real Property—Conveyances of Land—Recordation of Instruments Affecting Real Estate. David Belling, Miami County Attorney, Paola, June 5, 1984.

A register of deeds is required to file of record a written instrument whereby real estate may be affected. Such filing can properly be refused only if the instrument contains apparent errors, or is not proved or acknowledged and certified in the manner prescribed by law, or the register of deeds has been directed by a court not to file the instrument. A register of deeds also may refuse to file instruments that clearly do not affect real estate, or where the law requires some act, such as payment of the mortgage registration fee, before the instrument may be received and filed of record. Cited herein: K.S.A. 58-2211, 58-2221; Affirming Attorney General Opinion No. 82-164. MFC

The Series 1984-A Bonds will be dated as of July 1, 1984, and shall mature on September 1 in each of the years and in the amounts set forth below. Such Bonds shall be fully registered certificated bonds, each in the denomination of \$5,000.00 or integral multiples thereof not exceeding the principal amount of Bonds maturing in each year. * **OPTIONAL REDEMPTION:** Bonds due September 1, 1992 to September 1, 1994, inclusive, are callable for redemption on September 1, 1991, or any interest payment date thereafter, in inverse numerical order at par and accrued interest to date of redemption plus a premium (expressed as a percentage of principal amount) of 2%.

Notice of any call for redemption will be mailed to the registered owners of such Bonds to be redeemed at the address shown on the registration books maintained by the Bond Registrar not less than 30 days prior to the date fixed for such redemption and payment. Interest on the Bonds so called for redemption and payment will cease to accrue after the redemption date, provided notice has been given and funds are then available to pay the full redemption price thereof.

Interest will be payable semiannually, commencing March 1, 1985, and each September 1 and March 1 thereafter. The principal of, and premium, if any, on the Bonds shall be payable in lawful money of the United States of America, at the principal office of the Treasurer of the State of Kansas, in the City of Topeka, Kansas, (the Paying Agent and Bond Registrar) to the registered owners thereof upon presentation of the

Bonds for payment and cancellation. Interest on the Bonds shall be payable in lawful money of the United States of America, by check or draft of the Paying Agent to the registered owners appearing on the books maintained by the Bond Registrar as of the 15th day of the month next preceding the Interest Payment Dates (the "Record Dates"). The fees of the Bond Registrar for registration and transfer of the Bonds shall be paid by the City.

Types of Bids and Interest Rates

Proposals will be received on the Bonds bearing such rate or rates of interest, not exceeding five (5) different interest rates or four (4) interest rate changes, as may be specified by the bidder. The same rate shall apply to all Bonds of the same maturity. Each interest rate specified shall be in an even multiple of one-eighth (1/8th) or one-twentieth (1/20th) of one percent (1%). The difference between the highest and lowest interest rates specified in any bid shall not exceed three percent (3%). No interest rate shall exceed the maximum rate allowed by Kansas law; said maximum rate being two percent (2%) above the "Bond Buyer's 20 Bond Index" of tax exempt municipal bonds, published in New York, New York on the Monday next preceding the day on which the Bonds are sold, and no bid of less than par and accrued interest will be considered. Bids involving the use of extra or supplemental interest rates will not be considered. Bids for less than the entire issue of Bonds will not be considered.

Bids shall be submitted on the OFFICIAL BID FORM furnished by the City, and shall be addressed to the City at the CITY HALL, CHETOPA, KANSAS 67336, ATTENTION: BETSY J. SANDERS, CITY CLERK, and shall be plainly marked BOND BID. All bids must state the total interest cost of the bid, the premium, if any, the net interest cost of the bid, and the average annual interest rate, all certified by the bidder to be correct; and the City will be entitled to rely on the certificate of correctness of the bidder. Each bid must be accompanied by a certified or cashier's check equal to two percent (2%) of the total amount of the bid, and shall be payable to TREASURER, CITY OF CHETOPA, KANSAS. In the event a bidder whose bid is accepted shall fail to carry out his Contract of Purchase, said deposit shall be retained by the City as liquidated damages. The checks of unsuccessful bidders will be returned promptly.

Basis for Award

The sealed bids for the Bonds shall be opened publicly and only at the time and place specified in this Notice; and the Bonds will be sold to the best bidder. The City reserves the right to reject any and/or all of the bids, and to waive any irregularities. Unless all bids are rejected, the Bonds will be awarded to the bidder whose proposal results in the lowest net interest cost to the City; and the net interest cost will be determined by deducting the amount of any premium paid from the aggregate amount of interest upon all of the Bonds from their date until their respective maturities.
