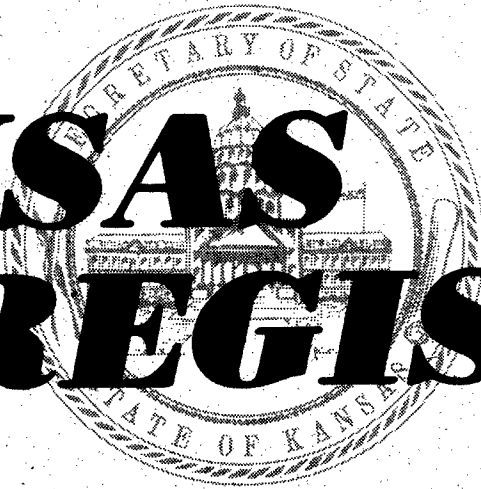

OFFER OF REWARD

ATTORNEY GENERAL**OPINION NO. 84-65**

Corporations—Agricultural Corporations—Corporate Ownership of Agricultural Land; Prohibited Practices. Senator Leroy A. Hayden, Thirty-Ninth District, Satanta, July 9, 1984.

Corporate ownership of agricultural land in Kansas is prohibited except as allowed by the provisions of K.S.A. 17-5904. Any arrangement whereby a landowner transfers title to his property to a new corporation or partnership made up of the landowner and a foreign corporation would be outside any of the permitted exceptions contained in the statute, and would accordingly be illegal. OPINION NO. 84-66

Mentally Ill, Incapacitated and Dependent Persons—Adult Care Homes—Foreign Corporations as Operators; What Constitutes Doing Business. Emily E. Cameron, Attorney for the Kansas Department of Health and Environment, Topeka, July 9, 1984.

A foreign corporation which: (1) is licensed by the Kansas Department of Health and Environment to operate and manage an adult care home and (2) has entered into a management contract with a care home owner for the purpose of managing and operating the home, is doing business within this state and is therefore subject to the foreign corporation registration requirements of K.S.A. 17-7301 *et seq.* Cited herein: K.S.A. 17-7301, 17-7303, K.S.A. 1983 Supp. 39-923, 39-927, K.S.A. 39-937, 39-954, 39-956, 39-958, 60-304. OPINION NO. 84-67

State Boards, Commissions and Authorities—Public Employees Retirement System—Compulsory Retirement Age for School Employees.

Schools—Teachers' Contracts—Mandatorily-Negotiable Items; Unilateral Changes by Board Not Authorized. Senator Norman E. Gaar, Seventh District, Overland Park, July 9, 1984.

No state statute prescribes a mandatory retirement age for current employees of unified school districts or community colleges. Thus, it is improper for a board of education or board of trustees to rely upon the mandatory retirement age provisions of K.S.A. 72-5512 or 74-4937 (Weeks, 1980, now repealed) as the basis for not renewing the employment contract of a faculty member.

Additionally, during the term of a negotiated agreement reached under the Teachers' Professional Negotiations Law, a board of education or board of trustees, acting unilaterally, may not make changes in any item which is mandatorily-negotiable, such as the matter of retirement. Moreover, this is true even though the item was not noticed for negotiation and was neither discussed during negotiations nor included in the resulting agreement. Cited herein: K.S.A. 72-

OPINION NO. 84-68

Intoxicating Liquors and Beverages—Prohibited Acts and Penalties—Sale of Intoxicating Liquors on Credit. Honorable Vernon L. Williams, Representative, 91st District, 2402 Coolidge, Wichita, July 9, 1984.

Kansas statutes prohibit the sale of alcoholic liquor at retail through the extension of credit. This is true even where the licensed retail seller in Kansas is not the entity which extends the credit, in that any pattern of sale that involves the use of credit cards is illegal. Further, any sale of alcoholic liquor by a licensed Kansas retailer through an unlicensed out-of-state promoter is illegal. Finally, the placing of brochures on a retailer's counter which advertise alcoholic liquor, whether one brand or several brands, is likewise prohibited. You are hereby notified that the Kansas State Board of Education will have a public hearing in the first floor conference room of the Kansas State Board of Education, Kansas State Education Building, 120 E. 10th St., Topeka, KS 66612, August 14, 1984, at 1:30 p.m., to consider in substance the proposed changes in the Kansas State Plan for Nutrition Education and Training Program for Fiscal Year 1985, effective July 1, 1984.

The proposed revised Kansas State Plan for Nutrition Education and Training Program for Fiscal Year 1985 relates generally to the following: Nutrition education needs, goals and objectives, activity plans, and budget for the 1985 fiscal year. Chapter one describes the needs assessment conducted in FY 1980 and the ongoing needs assessment for the current year. Chapter two specifies program goals and objectives and activities designed to meet objectives. The budget is outlined in chapter three, and activities for FY 1980 through FY 1985 are summarized in chapter four.

Copies of this public hearing notice (along with the state board's public hearing procedures) are being

mailed to all chief school administrators in the state and may be reviewed in their offices by interested persons. They are also being mailed to the clerks of local school boards for the attention of school board members. Copies of said plan may be obtained by contacting the secretary of the state board of education, Kansas State Education Building, 120 E. 10th St., Topeka, KS 66612, prior to August 3, 1984.

On the date of said hearing all interested persons shall be given reasonable opportunity to be heard and to present their views or arguments, orally or in writing, on said plan. Individuals or organizations that cannot appear at the hearing may submit to the secretary of the state board of education, at least five (5) days before the hearing, their reactions in favor of or in opposition to said plan, and any other matters, suggestions, or proposals that relate thereto. They may do this by letter form, regular audio cassette tape, or by one-half inch (1/2") VHS video cassette tape. The letter reactions will be entered into the record and considered by the state board of education. The video cassette tape or audio cassette tape shall not exceed three (3) minutes in length and shall also be considered by the state board of education. Persons using tapes shall first identify themselves in the tapes and state whether they represent themselves individually or represent a group as other presenters do that appear in person at the hearing; such presentations shall be accompanied by a signed transcript. Said hearing shall be conducted in compliance with the public hearing procedures of the state board of education.

Article 4.—COMMERCIAL FISHING

23-4-1. Issuance of warning citations. Game protectors and deputy game protectors shall be authorized to issue warning citations or tickets, which may be issued at their discretion. An officer may decide to warn or arrest based upon the officer's assessment of the circumstances surrounding a particular incident. The officer shall take into account applicable statutes and rules and regulations, degree of intent and culpability, gravity of the violation, age of the violator, and other relevant factors. (Authorized by K.S.A. 1983 Supp. 74-3302 and implementing K.S.A. 32-164 and 82a-815, effective, T-85-17, June 20, 1984.)

Article 18.—FEES

23-18-2. Hatchery stamp fee and stamp. (a) On and after January 1, 1985, the following fees shall be in effect:

- Resident/non-resident fishing license—Hatchery fee \$3.00
Non-resident 5-day trip fishing license—Hatchery fee \$3.00
Lifetime fishing license—Hatchery fee—as follows:
A "lifetime hatchery stamp" may be obtained by making a one-time payment according to the following schedule:

(b) The "lifetime hatchery stamp" shall consist of an adhesive seal to be affixed to the back of the lifetime fishing license. All other hatchery stamps shall consist of a punched hole that appears on the face of the authorized license in a location specifically marked "hatchery fee." Lifetime license holders may purchase either the lifetime hatchery stamp or annually purchase a hatchery "punch." TEMPORARY ADMINISTRATIVE REGULATIONS

(Approved by the State Rules and Regulations Board July 2, 1984. Will expire May 1, 1985.)

Article 17.—FUTURES CONTRACTS

17-17-1. Limitation on engaging in futures. A bank's authority to engage in financial future contracts, pursuant to K.S.A. 1983 Supp. 9-1101 as amended by 1984 Senate Bill No. 524, is limited to using such contracts as a hedge. This regulation shall take effect on and after July 1, 1984 and its approval by the state rules and regulations board. (Authorized by K.S.A. 9-1713; implementing K.S.A. 1983 Supp. 9-1101 as amended by L. 1984, ch. 48; effective, T-85-20, July 2, 1984.)

17-17-2. Hedging. Hedging is defined as an action taken to protect assets or liabilities against unforeseen changes in prices or value, i.e., an action taken to reduce risk. This regulation shall take effect on and after July 1, 1984 and its approval by the state rules and regulations board. (Authorized by K.S.A. 9-1713; implementing K.S.A. 1983 Supp. 9-1101 as amended by L. 1984, ch. 48; effective, T-85-20, July 2, 1984.)

17-17-3. Adoption of policy by bank. The board of directors shall establish a written policy to engage in financial future contracts. Policy objectives and limitations shall be specific enough to outline permissible contract strategies and their relationship to other banking activities. Record keeping systems shall be sufficiently detailed to permit internal auditors and examiners to determine whether operating personnel have acted in accordance with authorized objectives. This regulation shall take effect on and after July 1, 1984 and its approval by the state rules and regulations board. (Authorized by K.S.A. 9-1713; implementing K.S.A. 1983 Supp. 9-1101 as amended by L. 1984, ch. 48; effective, T-85-20, July 2, 1984.)

17-17-4. Notice to commissioner. A bank shall notify the state bank commissioner of the bank's intention to engage in financial future contracts prior to commencement of such activity. The following information shall be included in such notice:

- (a) A copy of the written policy of the bank, established by the board of directors, pursuant to K.A.R. 17-17-3;
(b) The background and experience of all persons authorized to buy and sell futures contracts (traders);
(c) The trading limits to be imposed upon traders;
(d) The conditions, if any, which permit deviations from those limits;
(e) The bank personnel responsible for authorizing such deviations;
(f) The procedures developed to prevent unauthorized trading;
(g) Copies of forms, in blank, which inform management of the daily futures contracts activity; and
(h) Copies of internal record-keeping forms, in

blank, which reflect the bank's daily futures contracts activity with regard to:

- (1) The maturity of each outstanding futures contract and the type and value of the corresponding cash transaction;
- (2) The maturity date of each futures contract;
- (3) The current market price and value of each futures contract;
- (4) The outstanding gross futures position;
- (5) The open position;
- (6) The amount of money held in margin accounts;
- (7) Any maturity gaps existing between the maturity date of the futures contract and the completion dates of the corresponding cash transaction;
- (8) The profit or loss for each corresponding cash and futures transaction;
- (9) The aggregate profit or loss for all relevant cash and futures transactions; and
- (10) The type and amount of each expected cash transaction that did not materialize.

This regulation shall take effect on and after July 1, 1984 and its approval by the state rules and regulations board. (Authorized by K.S.A. 9-1713; implementing K.S.A. 1983 Supp. 9-1101 as amended by L. 1984, ch. 48; effective, T-85-20, July 2, 1984.)

17-17-5. Monthly review of contracts. The board of directors, a duly authorized committee or the bank's internal auditors shall review contract positions on a monthly basis to ascertain conformance with the bank's written policy. This regulation shall take effect on and after July 1, 1984 and its approval by the state rules and regulations board. (Authorized by K.S.A. 9-1713; implementing K.S.A. 1983 Supp. 9-1101 as amended by L. 1984, ch. 48; effective, T-85-20, July 2, 1984.)

17-17-6. Maintenance of ledger accounts or registers. The bank shall maintain general ledger memorandum accounts or commitment registers to adequately identify and control all commitments to make or take delivery of securities. Such registers and supporting journals shall at a minimum include:

- (a) The type, nature of position (long or short) and amount of each contract;
- (b) The maturity date of each contract;
- (c) The current market price and cost of each contract;
- (d) The amount of money held in margin accounts; and
- (e) An identification of the asset or liability being hedged.

This regulation shall take effect on and after July 1, 1984 and its approval by the state rules and regulations board. (Authorized by K.S.A. 9-1713; implementing K.S.A. 1983 Supp. 9-1101 as amended by L. 1984, ch. 48; effective, T-85-20, July 2, 1984.)

17-17-7. Review of contracts; market valuation. With the exception of contracts described in K.A.R. 17-17-8, all open positions shall be reviewed and market values determined at least monthly (or more often, depending on volume and magnitude of positions), regardless of whether the bank is required to

deposit margin in connection with a given contract. All futures contracts shall be valued on the basis of either market or the lower of cost or market, at the option of the bank. All losses resulting from monthly contract valuation shall be recognized as a current expense item; those banks that value contracts on a market basis shall recognize gains as current income items. In the event the above described futures contracts result in the acquisition of securities, such securities shall be recorded on a basis consistent with that applied to the contracts (market or the lower of cost or market). This regulation shall take effect on and after July 1, 1984 and its approval by the state rules and regulations board. (Authorized by K.S.A. 9-1713; implementing K.S.A. 1983 Supp. 9-1101 as amended by L. 1984, ch. 48; effective, T-85-20, July 2, 1984.)

17-17-8. Hedging of mortgage banking operations. Futures contracts associated with bonafide hedging of mortgage banking operations, i.e., the origination and purchase of mortgage loans for resale to investors or the issuance of mortgage-backed securities, shall be accounted for in accordance with generally accepted accounting principles applicable to such activity. This regulation shall take effect on and after July 1, 1984 and its approval by the state rules and regulations board. (Authorized by K.S.A. 9-1713; implementing K.S.A. 1983 Supp. 9-1101 as amended by L. 1984, ch. 48; effective, T-85-20, July 2, 1984.)

17-17-9. Effect on bank's financial condition. Bank financial reports shall disclose in an explanatory note any futures contract activity that materially affects the bank's financial condition. This regulation shall take effect on and after July 1, 1984 and its approval by the state rules and regulations board. (Authorized by K.S.A. 9-1713; implementing K.S.A. 1983 Supp. 9-1101 as amended by L. 1984, ch. 48; effective, T-85-20, July 2, 1984.)

17-17-10. Internal controls; reporting. To assure adherence to bank policy and prevent unauthorized trading and other abuses, a bank engaging in financial future contracts shall establish other internal controls including monthly reports to management, segregation of duties, and internal audit programs. This regulation shall take effect on and after July 1, 1984 and its approval by the state rules and regulations board. (Authorized by K.S.A. 9-1713; implementing K.S.A. 1983 Supp. 9-1101 as amended by L. 1984, ch. 48; effective, T-85-20, July 2, 1984.)
