ATTORNEY GENERAL**OPINION NO. 84-78**

Public Health—Emergency Medical Services—Attendants Certificates; Temporary Certificates. E. P. Moomau, Assistant Superintendent, Kansas Highway Patrol, Topeka, August 3, 1984.

K.S.A. 65-4321, as amended by L. 1984, Ch. 244, prohibits the renewal of a temporary certificate issued pursuant to its terms. The statute does not prohibit the issuance of temporary certificates to persons who have held temporary certificates in the past but who do not presently hold such certificates. The absence of such a prohibition and the overriding public interest in the adequacy of emergency medical services in a certain area of Doniphan County compels the conclusion that temporary certificates may be issued to certain ambulance attendants who have held such certificates in the past but who do not presently hold such a certificate. The issuance of temporary certificates must be in compliance with the requirements of K.S.A. 65-4321, as amended, and no such certificate may be issued to a person who is not enrolled in or who will not be enrolled in the course of instruction necessary to become a certified attendant under Kansas law. OPINION NO. 84-79

State Boards, Commissions and Authorities—Law Enforcement Training Center; Advisory Commission—Certification of State and Local Law Enforcement Training Schools.

Schools-Community Colleges—Organization, Powers and Finances of Board of Trustees; Power of Boards of Contract.

State Departments; Public Officers and Employees—Agreements with Educational Institutions—Contracts with State Agencies. Maynard L. Brazeal, Director, Kansas Law Enforcement Training Center, Hutchinson, August 6, 1984.

The law enforcement training schools that are to be certified annually under K.S.A. 1983 Supp. 74-5604a(a), are those training schools of state or local law enforcement agencies only. A law enforcement training program which is offered solely as an approved course of a community college and which is not provided on behalf of a law enforcement agency pursuant to a duly authorized contract, is not eligible for certification as a state or local law enforcement agency training school.

Any state law enforcement agency and any community college are granted authority by K.S.A. 1983 Supp. 75-3099 to enter into an agreement for the community college to provide instruction on behalf of the state law enforcement agency. A law enforcement training program which is provided by a community college pursuant to such an agreement would be eligible for certification under K.S.A. 1983 Supp. 74-5604a(a). However, boards of trustees of the state's community colleges have not been granted the authority to contract with local law enforcement agencies to provide instruction on behalf of such agencies. Consequently, a local law enforcement agency training school cannot be conducted by a community college. SOCIAL AND REHABILITATION SERVICES**

Notice is hereby given to all interested parties that the Department of Social and Rehabilitation Services will meet September 4, 1984, at 9:00 a.m., in the Staff Development Training Center, Topeka State Hospital.

The scheduled agenda for the open meeting includes:

- Adoption of the State Plan of the Low Income Energy Assistance Program for Kansas.
- Preliminary announcement soliciting public input in regard to proposals concerning permanent administrative regulations.
- Ideas related to possible needed legislation during the 1985 session.
- Public hearing concerning the adoption on a temporary basis of certain proposed administrative regulations. A summary of the proposed regulations is set forth below. The proposed changes are scheduled to become effective October 1, 1984.

1. **30-2-16. Permanency planning goals for title IV-E of the federal social security act.** This regulation is being amended to (1) reflect that the agency's permanency planning goal for the federal fiscal year commencing October 1, 1984 shall be to have no more than 450 children who have been in foster care placements in excess of 24 consecutive months receive federal funding during the course of the year, and (2) delete the material related to case monitoring.

2. **30-5-81. Scope of hospital services.** This regulation is being amended to allow one therapeutic home visit if the absence occurs during the final three days of the stay, the absence extends overnight and the patient returns to the hospital for at least eight hours prior to discharge.

3. **30-5-81b. The basis of reimbursement for hospital services.** This regulation is being amended to limit reimbursement for hospital outpatient laboratory services rendered on or after July 1, 1984 to the same reimbursement schedule used for independent laboratories.

4. **30-5-87. Scope of early and periodic screening, diagnosis, and treatment (EPSDT).** This regulation is being amended to increase the maximum age for participation in the EPSDT program from 18 to 21 years.

5. **30-5-151. Scope of hospital services for adult medikan program recipients.** This regulation is being amended to allow one therapeutic home visit if the absence occurs during the final three days of the stay, the absence extends overnight and the patient returns to the hospital for at least eight hours prior to discharge.

A copy of the proposed regulations and fiscal impact statement may be obtained prior to September 4, 1984 by contacting Mary Slaybaugh, Legal Division, State Department of Social and Rehabilitation Services, 6th Floor, State Office Building, Topeka, KS 66612, (913) 296-3969. Written comments may be submitted prior to such date. Such comments should be forwarded to Dr. Harder, Secretary of Social and Rehabilitation Services, 6th Floor, State Office Building, Topeka, KS 66612.

Interested persons will be given reasonable opportunity at the hearing to present their views and arguments on the adoption of the proposed regulations. Presentations should be in writing whenever possible. Depending on the number of persons wanting to speak, the department may require that each participant limit his or her oral presentation to no more than three minutes.

- Adoption of proposed temporary administrative regulations.

The NW ¼ of Section 11, Township 11 South, Range 32 West of the 6th P.M., Logan County, Kansas, more particularly described as follows: A tract of land beginning at the Northwest corner of the Northwest Quarter (NW ¼) of Section Eleven (11), Township Eleven (11) South, Range Thirty-Two (32) West of the 6th P.M., thence East 505.2 feet; thence South 33 feet; thence East 181.8 feet; thence South 544.8 feet; thence West 687 feet to the West line of said NE ¼ to the point of beginning, subject to existing rights of way and/or easements over and across said land; less the Right of Way of any and all laid out and established roads, through, over, upon and across said land.

KANSAS FACTS

KANSAS NICKNAMES

Kansas is popularly known as the "Sunflower" state, as that flower grows profusely in the fields and along the roads in Kansas, and has been officially named the state flower. Another nickname frequently heard is the "Jayhawker" state, and Kansans are popularly known as "Jayhawkers."

There is some question about the origin of the word "Jayhawker." William E. Connelly, author of "History of Kansas" (1928), in volume two, on page 636, gives the following explanation: "The term Jayhawker was applied along the border at the beginning of the (Civil) war to irregular troops and pillaging bands on both sides. It was accepted by some of the Kansas soldiers, and soon came to be the name by which all of them were known. It now includes all Kansas people. The origin of the name is unknown, that given by Wilder and Ingalls being erroneous. The name was in use in Texas and the West many years before Kansas was a territory."

James Hanaway, in an article on "Osawatomie" in the "Kansas Magazine," June, 1873, volume 3, on page 553, is the authority for the version given by D. W. Wilder, in his "Annals of Kansas" (1866) on page 133, referred to by Connelly as being erroneous; Wilder says: "One morning, in this year (1856) Pat Devlin, a Free-State Irishman, rode into Osawatomie on a horse heavily laden with many kinds of goods. 'Have you

been foraging, Pat?' 'Yes, I've been out jayhawking. We have a bird in Ireland we call the jayhawk. It worries its prey before devouring it; and jayhawking is a good name for the business I've been in.' This is the only known origin of his word. Colonel Jennison, early in war, called himself and his soldiers Jayhawkers, and the name soon came to be applied to all Kansans."

Professor Frank W. Blackmar, of Kansas University is quoted as giving the following version in "Kansas Facts," volume 3 (1931), on page 140. He says in part: "The Jayhawker is a myth. . . . The myth had its rise in the character of two birds that frequent the Missouri Valley, namely, the blue jay, a noisy, quarrelsome robber, . . . and the sparrow hawk, a genteel killer of birds, rats, mice, rabbits and, when necessary, a courageous and cautious fighter. Just when, where and by whom the names of the two birds were joined in 'Jayhawk,' and applied to human beings, no one knows. However, it is known that the term 'Jayhawk' originated in the home territory of these birds somewhere between Texas and Nebraska. It is known that it was applied to an overland company of gold seekers on their way through Nebraska to California. It was applied to Jennison's band of freebooters, to Montgomery's rangers, to Missouri guerilla bands of border ruffians, and finally, in a general way, to the free-soilers of Kansas. . . . It is not known how the name gradually became applied to all residents of Kansas.

"The jayhawk myth has become a spirit of progress and power. . . . Only the spirit of comradeship and the courageous fighting qualities to make and keep free, remain. . . ."

STATE SONG

The popular "Home on the Range" is the Kansas State Song, designated by the Legislature in 1947. The words to the song, originally titled "My Western Home," were written by Dr. Brewster Higley, a pioneer Kansas physician. Dr. Higley did his writing in his cabin on Beaver Creek near Smith Center in 1871 or 1872.

Dan Kelly, a local druggist and friend of Dr. Higley, composed the music to "My Western Home."

Although the phrase "Home on the Range" did not appear in the original lyrics, there are few differences in the song as first written and as it is commonly sung today.

"My Western Home" as written contained six verses; those most often used are the first and the fifth. The second verse mentions the "banks of the Beaver," which refers to the Beaver Creek, and the "gale of the Solomon vale," referring to the Solomon River valley.

The official words to the state song are:

Oh, give me a home where the buffalo roam,
Where the deer and the antelope play,
Where seldom is heard a discouraging word
And the sky is not clouded all day.

(continued)

Chorus:

A home, a home where the deer and the antelope play,
Where seldom is heard a discouraging word
And the sky is not clouded all day.

Oh, give me the gale of the Solomon vale,
Where life streams with buoyancy flow,
On the banks of the Beaver, where seldom if ever
Any poisonous herbage doth grow.

Oh, give me a land where the bright diamond sand
Throws its lights from the glittering stream
Where glideth along the graceful white swan,
Like a maid in a heavenly dream.

I love the wild flowers in the bright land of ours;
I love too the wild curlew's scream,
The bluffs and white rocks and antelope flocks
That graze on the hillside so green.

How often at night, when the heavens are bright
With the light of the glittering stars,
Have I stood here amazed and asked as I gazed
If their glory exceeds this of ours.

The air is so pure, the breezes so free
The zephyrs so balmy and light,
I would not exchange my home here to range
Forever in azure so bright.

STATE ANIMAL: AMERICAN BUFFALO

The American Buffalo (*Bos* or *Bison Americanus*) was designated in 1955 as the official state animal. In making the selection, the Legislature noted that, ". . . Said animals ranged over the Kansas prairies in countless thousands during the days of the Kansas territory and early statehood; . . . It seems appropriate to give recognition to the lowly but heavily fronted and stoutly built buffalo."

The grassland area of the Great Plains, including Kansas, was a natural habitat for the buffalo, whose numbers in early historic times may have been as high as 60 million. The buffalo served many purposes for the Indians of the Great Plains, who followed buffalo herds for their livelihood. Food, shelter, clothing, fuel and some war materials could be fashioned from a buffalo carcass.

STATE TREE: COTTONWOOD

The official state tree of Kansas is the Cottonwood. Adopting it in 1937, the Legislature called it "the pioneer tree of Kansas." The lawmakers noted that the successful growth of cottonwood groves on early homesteads was often a big factor in the homesteader's perseverance until he could make his claim to the land.

STATE BIRD: WESTERN MEADOW LARK

In 1937 the Legislature named the Western Meadow Lark (*Sturnella-Neglecta*) the state bird. That action followed a statewide vote by school children, who in 1925 had selected that bird as their favorite. The election, in which over 120,000 votes were cast, was sponsored by the Audubon Society of Kansas. That group was working at the time towards more appreciation of birds in the state. The closest competitors to the Western Meadow Lark in the voting were the Quail, Cardinal and Robin.

A Kansas naturalist has this to say about the state bird: "Kansas is primarily a prairie state, and the meadow lark is a prairie bird, typical of Kansas. So many of our birds range only in parts of the state, while the meadow lark is extremely abundant in every county. Those traveling the state by auto or train could scarcely fail to encounter these birds in every mile of the journey, since they have the habit of perching along the fence lines in the open. It is strikingly beautiful, and every child is familiar with its notes."

A state fish and game warden comments on the meadow lark as follows: "Not only is he the friend of all mankind by cheering them with his liquid songs; but he is a helpful ally in beating back the encroachment of noxious weeds and destructive insects, and above all, he is with us in all seasons, through drought and blizzard, sunshine and rain, plenty and poverty."

STATE INSECT: HONEYBEE

The strong, industrious honeybee was adopted as the official state insect in 1976. In designating the honeybee, the Legislature said that insect ". . . is proud; . . . a friendly bundle of energy; is always helping others throughout its lifetime; is a strong, hard worker with limitless abilities; . . . the honeybee, by making its honey, gives not only to Kansans but also to all the world's peoples a gift which is sweet and wholesome, something which all Kansans strive to emulate in other ways . . ."

STATE FLOWER: WILD NATIVE SUNFLOWER

Kansas is often known as the "Sunflower State," and the official state flower is the wild native sunflower or *Helianthus*. In adopting the state flower in 1903, the Legislature noted the sunflower is ". . . hardy and conspicuous of definite, unvarying and striking shape, easily sketched, moulded, or carved, and having armorial capacities, ideally adapted for artistic reproduction, with its strong distinct disk and its golden circle of clear growing rays—a flower that a child can draw on a slate, a woman can work in silk, or a man can carve on stone or fashion in clay; and . . . This flower has to all Kansans a historic symbolism which speaks of frontier days, winding trails, pathless prairies, and is full of the life and glory of the past, the pride of the present, and richly emblematic of the majesty of the golden future, and is a flower which has given Kansas the world-wide name, 'The Sunflower State.'"

Following enactment of the law, its author, Senator George P. Morehouse, spoke at a state encampment of the National Guard at Fort Riley, and said of the sunflower:

"This native wild flower is common throughout our borders, and is always hardy and conspicuous. It lifts its head in triumph along our most beautiful and classic valleys and mingles its cheerful light with the verdure of expanding prairies. The seasons have little effect on its coming, for it flourishes in time of flood and the drought of arid summer adds to the multitude of its blossoms. It is of definite, unvarying and striking shape, ever faithful, whether gracing the beautiful gardens of the rich or lingering near the humble habitation of the poor. Wherever reproduced, whether in color or canvas, worked on iron or chiseled in stone or marble, its identity is ever

present. I am pleased to see it has been wrought in bronze, and, as a badge, decorates the new uniforms of the Kansas National Guard. It has marked the position of Kansas in many an imposing pageant. This flower has to every Kansan a historic symbolism. It speaks eloquently of frontier days, when buds and blossoms of civilization were not numerous and when we were deprived of many of the refinements we now enjoy. The sunflower recalls paths and winding trails, and we are reminded of its golden lines of beauty, at times making their graceful turns over hill and vale, and breaking the dull monotony of many a prairie scene. It is not a blossom lingering a few brief hours, but lasts for a season. It gracefully nods to the caresses of the earliest morning zephyrs. Its bright face greets the rising orb of day and faithfully follows him in his onward course through the blazing noontime, till the pink-tinted afterglow of sunset decorates the western sky and marks the quiet hour of eventide. Few can recall all the state favorites, but the entire nation knows that Kansas has the sunflower and is the 'Sunflower State.'

STATE SEAL

The Great Seal of the State of Kansas, adopted by the Legislature in 1861, is described in the enacting law as follows:

"The east is represented by a rising sun, in the right-hand corner of the seal; to the left of it, commerce is represented by a river and a steamboat; in the foreground, agriculture is represented as the basis of the future prosperity of the state, by a settler's cabin and a man plowing with a pair of horses; beyond this is a train of ox-wagons, going west; in the background is seen a herd of buffalo, retreating, pursued by two Indians on horseback; around the top is the motto: "Ad aspera per aspera," beneath a cluster of thirty-four stars. The circle is surrounded by the words: Great Seal of the State of Kansas. January 29, 1861."

The motto which appears on the seal, "Ad astra per aspera," is Latin for "To the stars through difficulties."

STATE MARCH

The official state march, adopted by the Legislature in 1935, is "The Kansas March," composed by Duff E. Middleton.

KANSAS STATE BANNER

In 1925, the state legislature passed a law providing for the adoption of an official state banner. The description and form of the state banner as changed by the legislature of 1953:

"The official banner of the state of Kansas shall be solid blue and shall be of the same tint as the color of the field of the United States flag, whose width shall be three-fourths of its length, with a sunflower in the center having a diameter of two-thirds of the space of the banner, enclosing and surrounding with its petals of gold, a brown center having a diameter of two-fifths the size of the sunflower. Service banners may be made of bunting or other material of such size as required on conforming to the proportionate specifications."

STATE FLAG

The Kansas State Flag was created by the Legislature in 1927, and modified in 1961. The flag consists of a dark blue rectangle with the state seal in the middle. Above the seal is the crest, a sunflower (the state flower) on a bar of twisted gold and blue. Beneath the seal is the word "KANSAS" in gold block letters.

STATE BUILDINGS

THE KANSAS CAPITOL

On January 29, 1861, Kansas became the 34th state. Topeka was selected as the capital in an election held in November, 1861. In that election Topeka received 7,996 votes, Lawrence 5,291, and 1,184 votes were cast for other cities. This selection followed a time of bitter struggle over location of the capital. The territorial capital had been Fort Leavenworth, Shawnee Mission, Pawnee, Shawnee Mission, again, Leecompton and Lawrence.

The State Capitol stands on 20 acres of ground donated to the state by Cyrus K. Holliday. The Legislature accepted the block of land by joint resolution approved February 7, 1862.

The Board of Statehouse Commissioners approved, in 1866, the construction of the east wing of the Capitol. On October 17, 1866, cornerstone ceremonies were held. The sandstone foundation was erected, but because of both a severe winter and the fact that sandstone is a form of shale, it had crumbled to a mass of mud by 1867. A new foundation was constructed of limestone from Geary County.

When the east wing of the statehouse was completed, it was necessary for both the Senate and House of Representatives to meet in the hall now used as the Senate Chamber. The first legislative session was held in the building in 1870. The Board of Statehouse Commissioners was recreated in 1879 and work was started on the west wing. The Legislature appropriated \$60,000 and provided a one-half mill levy for west wing construction. By 1880, this wing was enclosed and the House of Representatives met in the new, although unfinished hall in 1881. A covered wood bridge, referred to as "Cave of the Winds," was built from the Senate to the House for messages to be taken from one to the other. The cost of the west wing was about \$300,000 compared to \$500,000 for the east wing. The difference in the cost of the two wings, which were substantially the same size and design, was attributed to the depreciation of the currency after the great rebellion.

The 1881 Legislature authorized the construction of the central portion of the Capitol. The excavations for the foundation which support the dome extend more than 25 feet into the ground to a bearing strata of natural bedrock. Workmen doing the excavation work

discovered a spring which still flows in the rock beneath the Capitol.

The Capitol is one of which every Kansan can be proud. While there are a number of capitols in the United States that are more costly and ornamental, there are few that present a grander view. The building is 399 feet north and south, 386 feet east and west, and 304 feet to the top of the dome. The interior consists of a basement and five floors in the central portion of the building and a basement and four floors in the east and west wings.

STATE OFFICE BUILDING

The 12-story building of steel frame construction with basement and sub-basement has exterior walls of red granite on the first floor and Kansas limestone and Virginia greenstone on upper floors. Floors are of cellular steel covered with concrete to provide for underfloor electric and telephone wiring. Ceilings are of aluminum panels backed by sound absorbing pads and office and corridor partitions are of movable steel. The building has numerous windows, but is air-conditioned throughout. There are six passenger elevators and one freight elevator.

Bernard Frazier is the sculptor of the three high relief panels on the east, south and west sides of the building. They depict various phases of the history of this section of the country—the fur trappers and the French influence, the Spanish explorers from Mexico, and the pioneers' westward movement.

The building contains about 540,000 square feet of space, approximately 300,000 of which is rentable office space. Among the special features and facilities in use by the nearly 3,000 employees housed in the building are a cafeteria, mailing room, post office, banktype security vault and a central telephone exchange.

There also are an auditorium with approximately 5,600 square feet having accordion folding partitions to provide for smaller meeting rooms; conference rooms; refreshment areas; and storage space.

Total construction cost of the building was approximately \$8,600,000. The legislature appropriated some funds for the building and parking facilities, but the major portion of the cost was raised by the issuance of bonds in the amount of \$7,500,000. Because of the heavy traffic on Harrison street—the street between the state capitol and the office building—a walking tunnel connects the two buildings. The 500 foot long tunnel is 7½ feet wide and 8 feet high, is lighted and ventilated, and is built of concrete and lined with glazed tile. The office building is located in the center of a square block of land adjoining the state capitol on the west. Although the office building is tall, it does not overshadow the statehouse across the street. The capitol dome rises 304 feet above the lawn; the office building is 180 feet tall.

KANSAS STATE PRINTING PLANT

The Kansas State printing plant was established by an act of the 1905 legislature following an amendment to the constitution in 1904 providing for the election of

the state printer. An appropriation of \$68,000 provided for building and equipping a plant. This was supplemented in 1913 with an additional \$135,000 to enlarge the facility and improve the equipment. The 1919 legislature appropriated further funds for plant expansion. The building now has over 60,000 square feet of floor space. On June 8, 1966, the plant was heavily damaged by a devastating tornado. Restoration financed principally through federal funds from the Office of Emergency Planning was completed within 12 months at a cost of approximately \$131,000 for the building and \$42,000 for equipment and supplies.

Approximately \$3.8 million was appropriated by the 1984 legislature for construction of a new printing plant. Construction of the plant, which will be located at Second and Storey Streets in Topeka, is scheduled to begin this fall. The estimated completion date is December, 1985.

KANSAS STATE HISTORICAL SOCIETY

Organized in 1875, the Kansas State Historical Society is one of the largest state historical societies in America. It includes an unusually fine library of Western and Indian history, with a catalog of more than 300,000 separate card entries relating to Kansas subjects alone. It owns one of the largest newspaper collections in the country, consisting of approximately 82,000 bound volumes and more than 26,000 reels of microfilm. The society is an official depository for U.S. government documents. The total number of books, bound volumes of magazines and pamphlets in the library is approximately 400,000.

The society is the archives department of the state. The official correspondence of most governors and the records of other state departments are placed here for permanent preservation. The original constitution of the state, known as the Wyandotte Constitution, written in longhand in 1859 and signed by members of the convention, is on display in the Memorial Building.

The archives contains correspondence from the files of most Kansas governors since 1854, original census reports since the first enumeration of 1855, territorial election returns, territorial and state court records and thousands of other official documents which are irreplaceable and invaluable. There are more than 12,000 cubic feet of archival materials.

Few states possess so complete a history in the form of private letters, diaries and memoirs as Kansas. Among the more important collections are the correspondence books of William Clark, of the Lewis and Clark Expedition, superintendent of Indian Affairs at St. Louis in 1812 and later and account books of the Missouri Fur Company which he helped organize.

There are 27 document boxes of the letters of Isaac McCoy, pioneer missionary and surveyor; the journal of Jotham Meeker, Kansas' first printer; a large collection of John Brown letters; correspondence of Edward Everett Hale and the official correspondence of the New England Immigrant Aid Company; letters of John J. Ingalls, John R. Brinkley, Dwight Eisenhower and hundreds more; and many diaries of soldiers,

cowboys, homesteaders, missionaries and merchants—the men and women who made Kansas.

The society possesses more than 144,000 pictures, mostly of Kansas subjects, ranging from tintypes less than an inch in size to the more than life-size oil painting of territorial governor Andrew H. Reeder. The society also owns more than 13,000 maps, atlases and charts.

The historical society also administers the following historic sites:

Shawnee Indian Mission in Fairway, a suburb of Kansas City; Kaw Indian Mission at Council Grove; the First Territorial Capitol of Kansas on the Fort Riley Military Reservation; the Funston Memorial Home just north of Iola; Fort Hays Frontier Historical Park at Hays; the Iowa, Sac and Fox Indian Mission in Highland; John Brown Museum in Osawatomie; Marais des Cygnes Massacre Memorial Park in Linn County; Pawnee Rock in Barton County; Hollenberg Pony Express Station near Hanover; Pawnee Indian Village Museum in Republic County; Grinter Place near Muncie; Goodnow Memorial Home in Manhattan; Mine Creek Civil War Battlefield in Linn County; Pottawatomie Baptist Indian Mission in Topeka; Tobias Archeological Site near Lyons; Souders Historical Farm/Museum in Cheney; and the J. Fenton Pratt Ranch in Sheridan County.

In recent years the historical society has offered several outreach programs, including archival assistance to Kansas cities and counties, folklife coordination to any organized and interested group within the state, and lectures, slide talks, and traveling educational trunks from the museum.

The society is the Kansas State Historic Preservation office and as such administers properties placed on the National Register of Historic Places as well as those on the Register of Historic Kansas Places. This office offers counsel to owners of historic properties who wish to maintain them according to accepted preservation standards and also monitors activities for both the federal and state governments to protect cultural resources from destruction by government activated, financed or licensed projects.

The historical society is also engaged in an active publication program and issues "Kansas History, A Journal of the Central Plains" four times a year as well as a bimonthly newsletter and occasional book length publications. Publications are also issued in the form of microfilm, particularly of newspapers from its large collection.

MEMORIAL BUILDING

The Memorial Building at 120 W. 10th in Topeka was completed in 1914 at a cost of more than \$600,000, the bulk of the money coming from the federal government in settlement of Civil War claims. The building commemorates the services of soldiers and sailors of Kansas and serves as a monument to the pioneers of the state. Its four floors and basement are occupied by the Kansas State Historical Society as a Center for Historical Research.

KANSAS MUSEUM OF HISTORY

The Kansas Museum of History at 6425 W. 6th in Topeka was completed in 1983. The museum is scheduled to open on a limited basis on June 23, 1984, with a special exhibit on "Samples of Our Heritage." Beginning in the spring of 1985 permanent exhibits will be opened on a periodic basis until the entire museum is completed.

The Kansas Museum of History is one of the finest museum structures existing in the United States. Its collections and exhibit areas are environmentally controlled to preserve fragile historic artifacts. It includes three outstanding conservation laboratories, an excellent exhibit design and construction facility, as well as ample room for educational programs.

The "Great White Buffalo," a statue by the late Lumen Martin Winter, was dedicated at the entrance to the museum on October 18, 1983. The statue was obtained through a bequest from the late Clyde N. Degginger of Kansas City, MO.

KANSAS JUDICIAL CENTER

The Kansas Judicial Center, directly south of the Capitol, houses the Attorney General and the state courts. The modern three-story structure, with 162,000 square feet of space, was completed in 1978.

Constructed of native Kansas cottonwood limestone, the building has been called one of the finest examples of contemporary architecture in the state. The \$14 million structure, featuring contemporary columns and entablature, is done in a "modern monumental" style of architecture.

Building of the Judicial Center was authorized by the 1973 Legislature. Former Chief Justice of the Supreme Court Harold Fatzer played an active role in designing of courtroom space and other planning for the building.

HALL OF JUSTICE

The public area in the Judicial Center has been named the "Hall of Justice." The area, a 60-foot cube of space, is three stories high and features oak, Vermont marble and South Dakota granite: enduring materials which are intended to symbolize the permanence of justice. However, the most prominent item in the hall is a large sculpture titled "Justice." The sculpture is a half-kneeling woman holding aloft a prairie falcon, native to Kansas. A bronze plaque in front of the sculpture notes that the prairie falcon is the "swiftest creature on earth" and has vision power eight times that of the human eye. The sculpture was designed by the late Bernard E. "Poco" Frazier, sculptor-in-residence at the University of Kansas. Frazier selected marble for the project in Carrara, Italy, but he died soon after the rough carving was begun. His son, Malcolm Frazier, was selected to complete the work. The sculpture was financed by a gift from Mr. A. B. Hudson of Maple Hill.

A message on the north wall of the Hall of Justice

(continued)

reads, "Within these walls the balance of justice weighs equal." Those words were written by Beckie Godsey of Dodge City, and her phrase was selected from messages submitted in a statewide competition for high school students.

CEDAR CREST

Cedar Crest, the state-owned governor's residence, is in northwest Topeka on a hill overlooking the Kansas River. The residence has a beautiful natural setting, including 244 acres of timbered, sloping land.

Frank P. MacLennan, founder and former publisher of the Topeka State Journal, built Cedar Crest in 1928 for \$60,000. He died a short time later, but his wife, Madge, lived there until her death in 1955. At that time, her will bequeathed the mansion to the State of Kansas for use as the governor's residence. The Legislature accepted the property, and in 1961 appropriated funds for remodeling. Following renovation, the residence was occupied by the governor. The home replaced the previous governor's residence near downtown Topeka.

Cedar Crest is of light beige stucco with stone, and is of the French Norman design. The 12-room residence has three stories and a basement. It was designed by the late W. D. Wight of the architectural firm Wight and Wight of Kansas City, Mo.

A thistle and the name Cedar Crest are carved above the great door. The thistle is one of many Scottish motifs in wood, stone and plaster throughout the house. These are symbolic reminders of the builder's Scottish heritage.

The floors in the living room and entry hall are random width, walnut-pegged oak planks spaced with strips of walnut. In the dining room and sun room there are oak parquet floors laid in nine-inch squares. Area rugs for the various rooms were planned to enhance the furnishings. The color scheme is peach, light navy and ivory with rust accents.

An Indian oriental rug featuring colors of peach, light navy and ivory with wheat-colored accents was selected for an area of the living room. Two large ivory sofas flank the fireplace. The bay window on the north side of the living room provides a made-to-order framework for the antique Duncan Phyfe sofa done in mid-blue with peach doubleweave fabric. The blue strongly emphasizes the blue in the antique Tiffany lamp.

Matching loveseats covered in impressionistic tapestry and a Duncan Phyfe quartet pedestal table with four miniature Queen Anne wing-back chairs in light rust cut velvet complete the living room. Tables compatible with the decor have been used.

The area rug in the dining room has a field of peach with a thin border of rust, a wider border of ivory and a finishing border of peach. The 12 chairs are covered in ivory silk damask with backs of beautiful needlepoint featuring Kansas wildflowers. These fine examples of needlepoint art were done by 12 Kansans who signed their work with their name and hometown.

The sun room has an oriental rug and a small Victorian grouping done in peach velvet, as well as a

Steinway baby grand piano. The walls are peach, and the water lily print draperies are backed by sheer panels of off-white.

The library is carpeted in light navy. In addition to the massive antique desk, two large, old wing-back chairs covered in a dramatic flame stitch are used. The antique loveseat is covered in a tweed texture fabric of complementary tones. Roman shades are rust with a minute navy pattern.

The small powder room on the first floor is done entirely in blue and white. The lighting above the vanity is recessed, the fixtures are white, the floor is covered in blue and the walls are upholstered in blue on white Meissen print fabric. The wall treatment gives importance to the small room and is very effective.

The main stairway and second-floor hall are carpeted in peach with an inset border of light navy. Portraits of all the first ladies of Kansas hang on the east wall of the stair landing and are identified by their given, maiden and married names. The 200-year-old French tapestry on the west wall faces the portrait grouping.

The second and third floors of the executive residence are left to the discretion of the first lady. The master bedroom at the west end of the second floor is a large room and accommodates bedroom furniture as well as two sitting areas. Three other bedrooms are on the second floor.

The third floor houses the residence office and the guest room. Some personal furniture is used on the second floor, but the majority of the furnishings for all three floors at Cedar Crest belong to the house, much of it having been moved from the old governor's mansion.

The Friends of Cedar Crest Association, a not-for-profit publicly-supported organization, has a walnut secretary-bookcase which was built in St. Louis for Thomas Carney, a Leavenworth businessman and the second governor of Kansas. It was built in 1860 and shipped to Leavenworth by steamboat. The association also purchased a glass-fronted cabinet that was the property of Ben Paulen, Fredonia, the 23rd governor of Kansas. It is in the dining room at Cedar Crest and holds much of the silver from the Battleship Kansas.

The entire third floor was once a ballroom, but it has been converted in recent years to a bedroom and an office for handling the official duties of the first lady and for managing the residence.

The basement features a recreation room with an antique pool table, a green leather sofa that had been in Senator Capper's office and a green leather wing chair which was a gift from Virginia Docking Rice. Murals representing Kansas were painted on the walls of the room some years ago by an inmate of the Kansas State Penitentiary.
