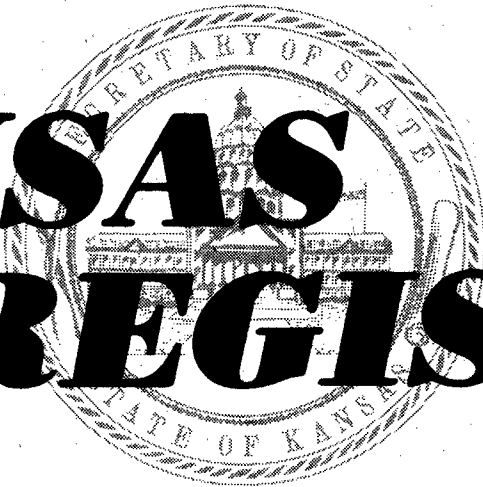

Written September 19, 1984 to Brian Moline, Kansas Corporation Commission—General Counsel, 4th Floor, State Office Bldg., Topeka, Kansas 66612.

This opinion is in response to your letter of August 20, 1984, in which you request an opinion from the Kansas Public Disclosure Commission.

We understand you request this opinion on behalf of "Pete" Loux, a member of the Kansas Corporation Commission, in your capacity as the Commission's General Counsel.

You advise us that a new corporation may be formed shortly within the State of Kansas known as the Economy Gas Foundation. The Economy Gas Foundation is a non-profit corporation formed for the purposes of purchasing, transporting, and distributing natural gas for the benefit of low income, elderly and disabled citizens in Kansas, and secondly to cooperate with and jointly negotiate with state agencies for purchase and sale of natural gas on behalf of Kansans that are eligible to various federal and state programs for energy assistance and institutions under the jurisdiction of the Board of Regents and Secretary of Social and Rehabilitation Services. All officers and directors of the company at the present time will serve without compensation or remuneration for their services. Mr. Loux has been approached about action as a non-paid, non-voting consultant to this organization. Your questions to us are as follows:

1. In the Public Disclosure Commission's opinion, would Mr. Loux's action as a non-paid advisor to this company violate the governmental ethics laws?
2. In the event that Mr. Loux became a non-paid director of this organization, would Opinion No. 83-19 apply?

In your letter, you indicate that Mr. Loux would excuse himself from any deliberations affecting this company and otherwise abstain from actions relating thereto. Under those circumstances, it is our opinion that his service as a non-paid advisor does not violate any of the provisions of K.S.A. 46-215 *et seq.* In addition, we have reviewed Opinion No. 83-19 as applied to this factual situation and the law as set forth therein would be applied in the same manner under these circumstances.

In closing we note that our opinion is limited to the application of K.S.A. 46-215 *et seq.* Thus, whether some other common law, statutory system or rule and regulation applies to the issue you have raised is not covered by this opinion.

OPINION NO. 84-92A

Automobiles and Other Vehicles—Act Regulating Traffic; Equipment of Vehicles—One-Way Glass or Glazing on Windows Prohibited. David H. Heilman, Council Grove City Attorney, Council Grove, September 20, 1984.

In *State v. Rose*, 234 Kan. 1044 (1984), the Kansas Supreme Court ruled that K.S.A. 8-1749a (amended by L. 1984, ch. 39, § 20, effective January 1, 1985), is not unconstitutionally vague and indefinite under the Due Process Clause of the Fourteenth Amendment to the United States Constitution. The court said the term "substantially" means less than totally or the whole, but more than imaginary. The term defines a standard between the extremes of total and complete impairment and slight impairment.

Since the conclusion reached in Attorney General Opinion No. 84-92 is contrary to the decision of the court in *State v. Rose*, *supra*, the opinion is withdrawn. Cited herein: K.S.A. 8-1749a, (amended by L. 1984, ch. 39, § 20, effective January 1, 1985); U.S. Const., 14th Amendment. RJB

OPINION NO. 84-97

Public Health—Solid Waste—Collection and Disposal by County; Schedule of Fees. H. Scott Beims, Rawlins County Attorney, Atwood, September 20, 1984.

Pursuant to K.S.A. 65-3410, a county may adopt a resolution establishing a schedule of fees imposed on real estate, with such revenues applied toward the acquisition and operation of county waste disposal sites or for the financing of waste collection and disposal services. While a resolution establishing such fees may not be adopted after July 1, once such a resolution is in place it does not need to be reaffirmed each year, unless amendments are made to the fee schedule. Although not based upon a value of real property, as are *ad valorem* taxes, solid waste disposal fees are billed and collected in the same manner as such taxes. Fees of this type are based upon the use to which real property is put, and a classification system which divides businesses into small, medium and large represents a valid attempt to draw lines based upon the volume of waste generated. Any property owner or business which is aggrieved by the classification system may protest the assessed fee as provided by K.S.A. 65-3410(a)(3). OPINION NO. 84-98

Personal and Real Property—Uniform Land Sales Practices Act—Land Sales Subject to the Act. Larry V. Christ, General Counsel, Office of Securities Commissioner, Topeka, September 20, 1984.

Interests in land subject to administration by the

securities commissioner pursuant to the Uniform Land Sales Practices Act, which qualify as a "subdivision" or "subdivided lands" under K.S.A. 58-3301, include "time share" and "undivided fractional ownership" interests so long as they are not exempted by the provisions of K.S.A. 58-3303. OPINION NO. 84-99

Elections—Voting Procedure—Write-In Candidates; Use of Stickers Bearing Name of Candidate. Jack H. Brier, Secretary of State, Topeka, September 21, 1984.

Although two Kansas statutes contained in the chapter dealing with elections provide that electors wishing to vote for a write-in candidate shall "write" the vote in the provided space (K.S.A. 25-213, 25-2903), other statutes in the same chapter allow electors to "insert" (K.S.A. 25-612, 25-2021, 25-2116) or "affix" such votes. (K.S.A. 25-1330). No statute specifically prohibits the use of prepared stickers or labels which contain the name of a candidate who is conducting a write-in campaign. Where such a sticker or label is attached to a ballot in such a manner as to make the intent of the voter clear, a valid vote has been cast and the expression of the voter's will should be given effect. OPINION NO. 84-100

Elections—Sufficiency of Petitions—County-Wide Initiative; No Basis In Constitution or Statutes. Senator Leroy A. Hayden, Satanta, September 21, 1984.

Before a petition requesting that a question be submitted to the voters can be approved, the requirements of K.S.A. 25-3601 *et seq.* must be met. Among these requirements is the need for the petition to "clearly state the question which petitioners seek to bring to an election." K.S.A. 25-3602(b)(1). By implication, if no constitutional or statutory basis exists for the submission of the question set out in the petition, it should not be accepted by the county election officer when it is presented for filing. As neither the Kansas Constitution nor any Kansas statute authorizes the use of an initiative procedure to place county legislative matters on the ballot at a general election, a petition which calls for an election to establish a county health office is without effect in the absence of a statute specifically authorizing the same. ON PROPOSED PERMANENT
ADMINISTRATIVE REGULATIONS**

A public hearing will be held Thursday, October 25, at 8:30 a.m., in Room 313-S of the State Capitol, (Old Supreme Court Room), Topeka, KS, to consider the adoption of proposed changes in existing rules and regulations and of proposed new rules and regulations of the Department of Administration.

All interested parties may submit written comments at any time prior to the hearing by addressing them to the Secretary of Administration, Second Floor, Statehouse, Topeka, KS 66612. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to not more than five minutes.

A summary of the proposed regulations follow:

Division of Accounts and Reports

K.A.R. 1-16-2e. This regulation currently provides that state agencies obtain fixed bids for moving household belongings and personal effects of eligible employees. The primary change is to vest the responsibility for obtaining fixed rate bids for such moves and for entering into contractual obligations with the employee being transferred. The quantity of bids required and items that are not eligible for reimbursement are also incorporated therein.

K.A.R. 1-16-2g. This regulation is revoked and the requirements for bids and the responsibilities of the employee being transferred are incorporated into proposed amendments to K.A.R. 1-16-2e.

K.A.R. 1-16-2h. This regulation is revoked and the requirements for bids and the responsibilities of the employee being transferred are incorporated into proposed amendments to K.A.R. 1-16-2e.

K.A.R. 1-16-2j. Amendments to this regulation delete language that duplicates provisions in 1-16-2e and make minor technical changes.

K.A.R. 1-16-18. This regulation prescribes the subsistence allowance rates for overnight travel expenses incurred by state employees while on official business. The primary change is to increase the maximum limit for reimbursement of lodging expenses incurred on travels to designated high cost geographic areas to \$98 per night.

K.A.R. 1-16-18a. This regulation prescribes those areas designated as high cost geographic areas for purposes of subsistence reimbursement in accordance with K.A.R. 1-16-18. The changes identify newly determined high cost areas, remove some areas since determined to be ineligible for such reimbursement rates from the regulation and clarify the boundaries of some areas previously authorized.

K.A.R. 1-18-1a. This regulation prescribes reimbursement rates for the authorized use of private conveyances by employees while engaged in official busi-

ness. An amendment to this regulation would allow such employees to be reimbursed for parking fees at commercial transportation terminals whereas current provisions limit reimbursement for such parking expenses to extended trips.

These regulations will be adopted on a permanent and temporary basis. Copies of the fiscal impact statement may be obtained from Division of Accounts and Reports, State Office Building, Topeka, KS 66612, (913) 296-2311 (KANS-A-N 561-2311).

Division of Personnel Services

K.A.R. 1-2-46. Amendments to this regulation define length of service to exclude time spent on a temporary appointment in the unclassified service pursuant to K.S.A. 75-2935(1)(i) and to deny credit for time spent on leave while receiving workers' compensation benefits for total disability prior to May 1, 1983.

K.A.R. 1-2-79. This new regulation defines "official roster."

K.A.R. 1-2-84. This new regulation defines "supervisor."

K.A.R. 1-5-11. The amendment to this regulation allows the appointing authority to grant a merit pay increase to an employee upon the employee's return from military leave.

K.A.R. 1-5-26. Amendments to this regulation change the meaning of standby so that the employee may no longer be required to remain close to home if available to the agency; provide for disciplinary action if the employee is not available; and specify that law enforcement exempt employees are exempt from stand-by pay provisions.

K.A.R. 1-5-28. Amendments to this regulation clarify the type of positions employees must be in to be paid a shift differential, and exclude KUMC nursing personnel in the Department of Nursing Services from the regulation.

K.A.R. 1-6-21. Amendments to this regulation allow the director to add additional names to the certification and provide that agencies are not required to interview every person on the eligible list.

K.A.R. 1-7-4. Amendments to this regulation expand the provisions for extending the probationary period for original appointments and specify the employment status of a person appointed from a reemployment list.

K.A.R. 1-8-6. The amendment to this regulation provides for the extension of the time required for an employee to complete supervisory training.

K.A.R. 1-9-2. Amendments to this regulation specify the number of holidays and the maximum amount of holiday credit an employee receives for a holiday; provide that the appointing authority will determine the form of compensation for holiday work; and specify additional parameters for receiving holiday credit.

K.A.R. 1-9-4. The amendment to this regulation clarifies provisions regarding vacation leave for school employees.

K.A.R. 1-9-5. Amendments to this regulation redefine the accounting period used for tracking the 40 hours of "family sick leave" available to employees and allow the appointing authority to request a written

release by a physician prior to allowing an employee to return to work. Finally, employees who have accumulated at least 300 hours of sick leave would be allowed to convert up to 3 days of sick leave to "personal leave" credit, subject to approval of the appointing authority.

K.A.R. 1-9-7. This regulation is revoked and replaced by 1-9-7a.

K.A.R. 1-9-7a. This new regulation establishes requirements and guidelines for granting military leave to an employee who enlists or is drafted into the armed forces of the United States, or is a member of a military reserve component who is called to active duty for purposes other than for training.

K.A.R. 1-9-7b. This new regulation establishes requirements and guidelines for granting military leave for purposes of training to a member of a military reserve component.

K.A.R. 1-9-7c. This new regulation establishes requirements and guidelines for granting military leave to a member of the Kansas national guard or state guard who is called to state duty.

K.A.R. 1-9-9. The amendment to this regulation excludes an employee on an emergency or temporary appointment.

K.A.R. 1-9-10. This regulation is revoked.

K.A.R. 1-9-11. This regulation is revoked.

K.A.R. 1-9-13. The amendment to this regulation allows a retiring employee to choose between receiving pay for accumulated vacation leave and compensatory time credits on the basis of either the last day worked or the last day in pay status.

K.A.R. 1-11-1. The amendment to this regulation stipulates that a condition for presumed resignation is the unavailability of the employee to provide explanation.

Article 1.—ELIGIBILITY

108-1-1. Eligibility. (Approved by the State Rules and Regulations Board August 15, 1984. Will expire May 1, 1985.)

Article 12.—SPECIAL EDUCATION

91-12-68. Hearing officer qualifications and approved training programs. (a) The state board and each local education agency shall compile and maintain a list of hearing officers who:

(1) Have completed a state education agency conducted or approved training program;

(2) demonstrate general knowledge of special education;

(3) demonstrate knowledge of the laws, rules and regulations, requirements, guidelines related to conducting a due process hearing; and

(4) demonstrate ability to conduct an orderly hearing.

(b) Any person or institution wishing to offer an approved training program shall make application to the state board.

(c) Applications for approved training programs shall include:

(1) A description of the content of the training program;

(2) qualifications of instructional staff members;

(3) a proposed training schedule including the number of clock hours to be provided; and

(4) procedures used to verify that participants have acquired the required competencies and to notify the state board of the names of successful participants.

(d) The state board shall notify applicants as to the approval or disapproval of proposed training programs. (Authorized by K.S.A. 1983 Supp. 72-963b; implementing K.S.A. 1983 Supp. 72-973a; effective T-85-23, Aug. 15, 1984.)

91-12-69. Appointment of a hearing officer. (a) Not more than three days after a hearing has been requested under the provisions of K.S.A. 72-972 and any amendment thereto, the agency providing for the hearing shall furnish the lawful custodian of the involved child:

(1) A list of the agency's prospective hearing officers;

(2) written notification that the lawful custodian has the right to request disqualification of any or all of the hearing officers on the list and to request the state board to appoint a hearing officer under the procedures prescribed in K.S.A. 1983 Supp. 72-973a, and any amendments thereto, and this rule and regulation; and

(3) written notification that the lawful custodian has five days from the date of receiving the list of hearing officer to advise the agency of any officer whom the lawful custodian wishes to disqualify.

(b) If the lawful custodian desires to disqualify any or all of the hearing officers on the list provided by the agency, the lawful custodian shall notify the agency,

not more than five days after receiving the list, of the person or persons who are disqualified. The agency may appoint from its list any hearing officer who has not been disqualified by the lawful custodian.

(c) Not more than three days after receiving notification that all of its hearing officers have been disqualified by a lawful custodian, an agency shall submit a written request to the state board for a list of the names and qualifications of five hearing officers. This request shall state the names of the hearing officers of the agency who were disqualified by the lawful custodian.

(d) Not more than three days after the state board receives a written request from an agency for a list of hearing officers, the state board shall provide both the agency and the lawful custodian a list of five prospective hearing officers and the qualifications of each such officer. The list provided by the state board shall not include the name of any hearing officer disqualified by the lawful custodian.

(e) When the agency receives the list of prospective hearing officers provided by the state board, the agency shall arrange a meeting or phone call with the lawful custodian to establish which name or names each party wants removed from the list. Each party may request the removal of two names. Not more than seven days after receiving the state board list, the agency shall submit to the state board the name of any hearing officer or hearing officers not removed from the list by either party.

(f) The state board shall appoint a hearing officer from the list determined as prescribed in subsection (e). Such appointment shall be made by the state board not more than three days after receiving the list from the agency.

(g) The computation of any period of time prescribed in this rule and regulation shall be determined in accordance with the provisions of K.S.A. 60-206 and any amendments thereto. (Authorized by K.S.A. 1983 Supp. 72-963b; implementing K.S.A. 1983 Supp. 72-973a; effective, T-85-23, Aug. 15, 1984.)

Article 31.—LAND SURVEYS

7-31-1. Surveys originating from public land survey corners. (a) Whenever a survey originates from a United States public land survey corner or any related accessory, the land surveyor shall file a copy of a reference report, as described in K.A.R. 7-31-3. Accessory means any object positioned above, upon, or near a United States public land survey corner for the purpose of facilitating locations when the actual United States public land survey is not accessible.

(b) If a survey originates from more than one corner, multiple reference reports may be filed. (Authorized by K.S.A. 58-2009; implementing K.S.A. 58-2011, as amended by L. 1984, Ch. 205, Sec. 1; effective May 1, 1984; amended, T-85-25, Sept. 18, 1984.)

7-31-3. Reference reports. (a) Reference reports shall be filed on forms provided by the secretary of state. A single reference report may refer to as many as 12 corners within the same township. A separate reference report shall be filed for each township affected. The reference reports shall include:

- (1) The name, license number and business address of the surveyor responsible for the survey;
(2) The phone number of the surveyor;
(3) The name or job number reference of the survey;
(4) The date of the survey;
(5) The county, township, range, and section where the corner is located;
(6) The approximate location of the corner within the section, by standard identification;
(7) If known, the datum and the north and east coordinates of the marker; and
(8) Descriptions of and measurements to witness corners.

(b) If an original marker is being restored or reestablished, the following information shall be provided:

- (1) A description of the corner evidence found or a concise statement of the method used to reestablish the corner; and
(2) A brief sketch and description of the monument and accessories used to perpetuate the location of the corner. This information shall be attached to the reference report. (Authorized by K.S.A. 58-2009; implementing K.S.A. 58-2011, as amended by L. 1984, Ch. 205, Sec. 1; effective May 1, 1984; amended, T-85-25, Sept. 18, 1984.)

7-31-4. Filing fees. (a) The fees for filing reference reports in the office of the secretary of state pursuant to K.A.R. 7-30-1 or 7-30-2 shall be \$20.00 for each reference report.

pursuant to K.S.A. 58-2011, and any amendments thereof, shall be as follows:

- (1) For each page copied \$1.00
(2) For any copy to be certified \$5.00

KANSAS FACTS

KANSAS: THE NATION'S LEADER IN AGRIBUSINESS

*"We have made the State of Kansas,
And to-day she stands complete—
First in freedom, first in wheat;"*
—from "Quivera—Kansas" by Eugene F. Ware.

Kansas is one of the leading agricultural states in the country. Known as the "Wheat State" and the "Breadbasket of the Nation," Kansas produces more wheat and milo than any other state, as well as a number of other agricultural products.

Early explorers travelling through Kansas disagreed over the agricultural possibilities of Kansas resources. Some referred to the area as the "Great American Desert," while others immediately recognized the value of Kansas soil and other natural resources. During the last half of the 19th century there were three important developments which helped to establish Kansas as an agricultural state: the windmill, barbed wire and the mechanical combine.

Today, farming is part of a multi-billion dollar industry known as agribusiness, which includes farming and related businesses such as manufacturing of farm equipment and fertilizer, and processing of farm products. Kansas ranks third among the states in production of agricultural equipment.

Nearly 50 million acres of Kansas land are devoted to farming. Leading crops and livestock products are:

Wheat

"Win the War with Wheat!"

That was a popular slogan in Kansas during both world wars. Times of war have been boom times for wheat farmers, but Kansas wheat plays an important part in feeding the world in times of peace also.

Kansas produces 20 to 25 percent of all wheat grown in the United States, making Kansas the leading state in wheat production. Only seven countries, including China and Russia, produce more wheat than does Kansas. Heavy wheat exports help to make Kansas the number one state in exports per capita of all products.

An important development for wheat farming was the introduction into Kansas of Hard Red Winter Wheat, or "Turkey Red Wheat," brought from Russia by the Mennonites in 1874.

While modern wheat farmers have produced record crops, the market prices for wheat have fluctuated drastically in recent years. Large grain sales to Russia and China in the early 1970's have helped, but throughout this decade the prices received by farmers for their wheat have rarely exceeded the cost of production.

The Kansas Wheat Commission, financed by an excise tax on first sales of wheat, assists wheat farmers and promotes use of wheat products.

Cattle

Cattle were very important to the early develop-

ment of Kansas. Cattle raised in Texas were driven to Kansas railroad towns to be loaded for shipment to eastern markets. The most important "cowtowns" were Abilene, Wichita, Ellsworth, Newton, Dodge City and Caldwell. All of these flourished as cowboys drove their cattle up the various cattle trails to the railroads and brought business to the towns. There were some problems with the cattle drives; Texas cattle brought Texas and Spanish Fever into the state, so quarantines had to be enacted against Texas cattle during warm weather to protect Kansas cattle.

Production of cattle in Kansas is significant, with cattle being raised in all counties of the state. Kansas is the third ranking state in production of beef cattle, and the cattle feedyards in western Kansas are some of the largest in the country.

Problems and Solutions

Over the years, Kansas farmers have been plagued with various types of problems ranging from droughts to floods and from grasshopper plagues to low market prices. The agricultural history of the state reveals cycles of boom and bust which resulted in expansion of agricultural holdings, only to be followed by thousands of foreclosures on Kansas farms. The frustrations of the farmers often spilled over into politics, as can be seen in the Populist and AAM movements of the 19th and 20th centuries.

One of the roughest times for Kansas farmers was the 1930's. General problems of the Great Depression were compounded by dust storms and drought. The dry soil of the Great Plains combined with strong winds to create massive clouds of dust which were thousands of feet high and miles across, and which obscured the sun for hours. Shelter belts (rows of trees) built with federal funds to diminish soil erosion are still in evidence throughout central Kansas.

Despite the hard times in the 1930's, most farmers stayed on their farms, hoping for better times. President Roosevelt's "New Deal" programs brought some relief, and the next decade brought a boom time during World War II.

The soil erosion of the 1930's has yielded to scientific farming methods, and today thousands of acres of Kansas farmland are irrigated by modern irrigation systems supported by wells, federal reservoirs, farm ponds and local reservoirs.

While the great grasshopper plagues of the 19th century no longer exist, grasshoppers and other pests periodically continue to invade crops. Modern chemical pesticides have helped to control and eradicate them.

This use of pesticides, along with herbicides and chemical fertilizers, has greatly increased farm production costs. Despite high costs, prices for many farm products have remained low in recent years, and some unhappy farmers have expressed their discontent through farm "strikes," parades and demonstrations.

Research and Other Support Services

Better agricultural methods are constantly being sought by researchers in Kansas.

Kansas State University is recognized as one of the outstanding agricultural research institutions in the nation. Researchers on campus and at agricultural experiment stations throughout the state are especially noted for their outstanding work in the eradication of plant and animal diseases, and for their development of new hybrids of wheat and other grains.

Farmers also receive various types of support from organizations such as 4-H clubs, Future Farmers of America, Grange, Farm Bureau, Farmers Union, National Farmers Organization, Livestock Association and local farm cooperatives.

KANSAS: MIDWAY, U.S.A. FOR BUSINESS AND INDUSTRY

"Kansas is a slice from the juiciest side of the earth. A few years ago it was a wilderness; today it is the garden of the world, redolent with the fragrance of the orchard and vintage, teeming with the homes of thrifty people, pulsing with the vim and vigor of progress, and mellow with the bloom of an almost perennial harvest."

—from the *Chicago Journal*, May 14, 1889

Commerce and industry in Kansas are varied, but are dominated by the aircraft industry and agriculture-related enterprises.

Products manufactured in the state range from airplanes to pizza, from camping equipment to greeting cards, and from tires to sewing patterns. Other major industries include meat packing, mining, flour milling and petroleum refining.

The variety of commerce and industry creates a healthy state economy and a good job market. Unemployment in Kansas is consistently among the lowest in the nation.

The state's location in the center of the country makes Kansas an ideal site for many businesses. Walter Beach, the founder of Beech Aircraft Corporation, once said, "No matter where you deliver an airplane from Wichita, you're already halfway there."

In recent years Kansas has sought and attracted dozens of new industries. Much of the credit for this accomplishment goes to the Kansas Department of Economic Development (KDED), a state agency, and the Kansas Cavalry. The Cavalry is a group of about 300 Kansas business leaders who volunteer their time and expertise to meet with business leaders from other states who might be interested in locating in Kansas. Delegations of Cavalry members have traveled, at their own expense, all over the United States and even to some foreign countries.

Strong "selling points" for Kansas used by KDED and the Cavalry include the state's central location, high worker productivity rate and an excellent system of air, rail and ground transportation. Kansas is the fifth ranked state in total railroad miles, and third in the number of highway miles.

Kansas is the world leader in production of general aviation aircraft. Three Kansas companies manufacture two-thirds of all the general aviation aircraft produced in the entire world.

The major Kansas aircraft firms are located in Wichita, the "Air Capital of the World." Over 50,000 people are employed by Kansas aircraft firms and firms supplying aircraft components and parts.

Hutchinson is a major salt production center, with

one of the world's largest salt mines and three of the largest salt evaporation plants. There are also two salt mines and a salt processing plant at Lyons.

The Pittsburg area in southeast Kansas is a center of large strip coal mining operations. Located at Pittsburg are the nation's largest plant devoted mainly to the production of coal preparation equipment, and one of the country's largest ammonium nitrate plants.

Kansas ranks in the top ten states in production of popcorn, railroad cars, cattle and rubber tires, as well as wheat, milo and aircraft. The state is the country's leading producer of helium.

A noteworthy item in regard to Kansas business is the fact that two of the nation's top female business leaders are Mrs. Olive Ann Beech and Mrs. Olive Ann Garvey, who both reside in and operate their businesses from Wichita.

The following companies are several of the larger and several of the more unique in Kansas:

Atchison, Topeka and Santa Fe Railway Company: Santa Fe has a major office in Topeka, where over 1,000 persons are employed. Santa Fe owns over 2,500 miles of railroad track in Kansas, and is the largest railroad company in the state.

Beech Aircraft Corporation: Beech Aircraft in Wichita employs over 8,000 people in its three Kansas plants. The company produces commercial, private and defense aircraft of all sizes.

Boeing Wichita Co.: Boeing Wichita, in operation since 1927, handles military and commercial aircraft assignments, including modifications. The facility does support work for the entire commercial jetliner series delivered at Seattle. Boeing Wichita employs 12,000 people.

Cessna Aircraft Co.: Cessna, located in Wichita, produces 51.8% of all general aviation aircraft. The Cessna Skyhawk (172) is the largest selling general aviation aircraft in history.

The Coleman Company, Inc.: Coleman, Wichita, produces camping products, recreational vehicle equipment, and heating and air conditioning units. Coleman products are marketed internationally.

Evans Products, Inc.: Evans Products, Dodge City, is one of only three companies in the U.S. which manufacture plastic drum heads for musical instruments. The company, which has been in business since 1958, sells drum heads to customers all over the world, including some of the top rock groups. Among the Evans drum heads are some which are unique, and made by no other company in the world. One such product is the "hydraulic head," an oil-filled head.

Gates Learjet Corporation: Gates Learjet in Wichita is the world's leading producer of business jet aircraft. Many entertainers, foreign dignitaries and other well-known people have visited Wichita to take possession of their new Learjets.

Goodyear Tire and Rubber Company: The Goodyear factory in Topeka is the world's largest producer of giant earthmover tires. About 4,000 people are employed at the facility, which manufactures approximately 900 different types and sizes of tires.

Hallmark Cards, Inc.: Hallmark, the world's leading publisher of greeting cards, has three major production centers in Kansas. Over 2,000 people are employed in those facilities at Topeka, Lawrence and Leavenworth. Items produced at those centers include greeting cards, stationery, paper party goods, candles, writing instruments, key chains and Springbok jigsaw puzzles.

Hesston Corporation: In 1947, a Hesston farmer became frustrated by the lost hours of productivity while his crew unloaded wheat out of combine grain tanks into trucks. Searching for a better way, the farmer and another Hesston man developed an unloading auger for the combine. Their product was marketed and the Hesston Corporation was born. Today Hesston is a major international producer of farm equipment, and also manufactures wood office furniture. About 1,500 people are employed at the corporation's plant in Hesston.

Harold Hillman—Sphere-maker: In a small shop in Ellis, attractive but rough rocks are turned into decorative spheres that look like large, beautiful marbles. The sphere-maker, Harold Hillman, invented, built and patented all the machinery in his shop. He is, as far as he knows, the only person in the world who produces spheres for public sale. Hillman's special equipment shapes and polishes spheres which are usually three or four inches in diameter, although they can be smaller or larger.

Josten's American Yearbook Co.: American Yearbook Co., a division of Josten's of Minnesota, publishes high school and college yearbooks. Over 1,000 people are employed at the Topeka facility.

King Radio Corporation: King Radio, Olathe, is one of the world's leading producers of aircraft avionics equipment. The company manufactures navigation and communication radios, radar and radar altimeters, auto pilots and similar items. King Radio employs over 2,800 people at its plants in Olathe, Paola, Ottawa and Lawrence, and has an office in Geneva, Switzerland. King equipment is used in 97 airplane models, ranging from a small Cessna model to the Concorde SST.

McCall Pattern Company: McCall's only manufacturing and distribution facility in the United States is located at Manhattan. Nearly 100 million sewing patterns are produced there each year, and the patterns are distributed in 86 countries. The plant employs 600 people.

Olathe Boot Company: Olathe Boot Company is the only manufacturer of western boots in Kansas. The Olathe facility, which also has an outlet store, produces over 12,000 pairs of boots each year, and they are marketed all over the United States.

Pizza Hut: Pizza Hut, the international restaurant chain, is based in Wichita, where it was founded in 1958, beginning with a single Pizza Hut. There are now Pizza Huts in all 50 states and 15 foreign countries, and at last count there were a total of 3,970 Pizza Huts worldwide.

Player Piano Company, Inc.: Player Piano Co., Wichita, has the largest selection of player piano parts

and accessories in the world. The company offers music rolls and supplies by mail and in the store.

Shepler's Inc.: Shepler's in Wichita is the world's largest western store, offering western wear, equestrian supplies and accessories. The Wichita facility includes a retail store, a mail order center and a plant which manufactures saddles, harnesses and similar equipment.

Tony's Pizza Co., Inc.: Over 1,000 people are employed at Tony's Pizza, Salina. The company produces frozen pizza and frozen Mexican food.

Underground Vaults and Storage, Inc.: The Carey Salt Company noticed some years ago that files stored in the company's salt mines near Hutchinson were unusually well preserved. So, when Carey completed mining the area a Wichita lawyer founded Underground Vaults and Storage (UVS) in 1959, signing a 99-year lease for all 350 acres of underground space in the old mines. At 68 degrees fahrenheit and approximately 55 percent relative humidity, the space is perfect for storage. One of the many clients of UVS is Metro Goldwyn Mayer, which stores all of its fine grain masters in the old mine, including "Gone With the Wind." Other clients include hospitals, cities, major oil companies and large corporations. UVS has 15,000 depositors from all 50 states and 32 foreign countries.

Western Insurance Companies, The: Founded in 1910, the Western Insurance Companies, Fort Scott, recently affirmed a sense of Kansas pride and a commitment to remain in this state by completion of a \$5 million communications center south of town. Western employs nearly 1,000 Fort Scott area residents in its home office, and has 52 branch offices all over the country and about 3,500 independent agents.
