66-6-1: The amendment to this regulation requires that the corporate officer responsible for the technical profession for a corporation must seal projects for the corporation.

66-6-4: The amendments to this regulation include the definition of "professional" and deletion of language which has been re-established in statute.

66-6-9: The amendments to this regulation clarify reinstatement procedures.

66-8-2: The amendments to this regulation clarify architectural examination requirements.

66-10-3: The amendment to this regulation simply deletes unneeded formatting.

66-10-4: The amendments to this regulation specify that an applicant for Landscape Architectural license who is the graduate of an accredited master level curriculum in landscape architecture shall be considered by the board to be equivalent to a graduate of a five-year curriculum and shall be required to meet the experience requirements of that curriculum as specified in K.S.A. 74-7020(b).

66-10-6: The amendment to this regulation clarifies the experience requirement for a graduate of a four-year curriculum other than engineering.

The following is a brief summary of the proposed

permanent regulations:

K.A.R. 36-11-6. Regulates the construction, reconstruction and maintenance of public and private utilities on highway right of way. Proposed amendments would require approval from the Secretary of Transportation and a highway permit agreement prior to engaging in such work.

K.A.R. 36-13-32. School bus driver qualifications and duties. Proposed amendments would expand the offenses prohibited of school bus drivers to include

reckless driving and Class C misdemeanors.

K.A.R. 36-17-5. Disposition of outdoor advertising fees collected by a city. Proposed amendments delete reference to the State Highway Commission.

K.A.R. 36-30-5. Establishes confidentiality of bid proposals submitted to the Kansas Department of Transportation. The regulation has been temporarily revoked. The proposed amendment would permanently revoke the regulation.

OPINION NO. 84-107

State Boards, Commissions and Authorities—Department of Economic Development—Establishment of Incubator Facilities for Small Business Concerns. Charles J. Schwartz, Secretary, Kansas Department of Economic Development, Topeka, October 18, 1984.

The authority of the Kansas Department of Economic Development to make grants pursuant to Chapter 276 of the 1984 Session Laws of Kansas (to establish incubator facilities for small business concerns) is subject to the condition that only qualified nonprofit corporations shall be eligible to receive a grant. A city or county is not such a nonprofit corporation, and is not eligible to receive a grant, even under circumstances where the city or county agrees to "pass the funds through" to an eligible nonprofit corporation. OPINION NO. 84-108

Cities and Municipalities—General Improvement and Assessment Law—Special Assessments; Work or Improvements Authorized. Phillip L. Harris, City Attorney, Overland Park, October 18, 1984.

An extension of water lines owned and maintained by a water district organized pursuant to K.S.A. 19-3501 et seq. does not constitute a "municipal work or improvement" within the meaning and intent of K.S.A. 12-6a01 et seq. Cited herein: K.S.A. 12-6a01, 12-6a02, 19-3501, 19-3502, 19-3509. TRH

OPINION NO. 84-109

Alcoholic Liquors and Beverages—Prohibited Acts and Practices—Sale of Liquor to Intoxicated Persons. John A. Lamb, Director, Alcoholic Beverage Control Division, Department of Revenue, Topeka, October 18, 1984.

K.S.A. 41-715 prohibits the dispensing, whether through sale or gift, of alcoholic liquor to persons who are incapacitated or who are physically or mentally incapacitated through the consumption of liquor, and makes a violation of the statute a misdemeanor. As a criminal statute, the language of K.S.A. 41-715 must be strictly construed, and cannot be read so as to include the sale of liquor to a person who is not intoxicated at the time of sale, even if such person is known to have a history of alcohol abuse. OPINION NO. 84-110

Corporations—Securities—Registration; Submission of Notice.

Attorneys at Law—Attorneys From Other States—Appearances Before Administrative Agencies; Local

Counsel. John R. Wurth, Securities Commissioner, Topeka, October 19, 1984.

Both K.S.A. 7-104 and Rule No. 116 of the Kansas Supreme Court (K.S.A. 60-2702a) require that an attorney who is licensed to practice in another jurisdiction associate with local counsel prior to transacting professional business before an administrative agency of the state. The submission of securities registration statements to the Kansas Securities Commissioner pursuant to K.S.A. 17-1256 does not involve any personal appearance unless and until the commissioner denies registration under K.S.A. 17-1260, and so does not constitute professional business before an administrative agency sufficient to invoke the provisions of the local counsel statute and rule. Accordingly, the local counsel requirements of K.S.A. 7-104 and Rule No. 116 do not apply to the filing of such statements. OPINION NO. 84-111

Counties and County Officers—Planning and Zoning—Regulations Governing Subdivision of Lands; Approval of Plats. William A. Taylor III, Cowley County Counselor, Winfield, October 19, 1984.

Pursuant to K.S.A. 19-2918c, a county planning board has no authority to review subdivision plats before they are filed with the register of deeds unless the planning board has enacted subdivision regulations pursuant to K.S.A. 19-2918. Under these statutes, a board of county commissioners has the authority to approve subdivision regulations, but has no authority to approve or review a final plat which has been approved by the county planning board. Regardless of the existence of subdivision regulations, however, K.S.A. 19-2633 requires that subdivision plats of land located more than one mile from the limits of an incorporated city be approved by the board of county commissioners before such plats may be filed with the register of deeds. The provisions of this statute are applicable in Cowley County, which has a county planning board (appointed pursuant to K.S.A. 1983 Supp. 19-2915) that has not adopted subdivision regulations.

The filing and recording of a plat vests title to property designated for public use in the county, and such property is to be held in trust for the purposes of the dedication. A decision as to when a road or public way dedicated to public use is opened or put in condition for public use is within the discretion of the governing body charged with the responsibility of maintenance. Subdivided land which has been platted pursuant to K.S.A. 19-2633 is subject to the restrictions stated in the plats. Advisory Opinion No. 84-18

Written October 17, 1984 to George M. Parsons, Chairman of Sedgwick County Republican Central Committee, P.O. Box 47626, Wichita, Kansas 67201.

This opinion is in response to your letter of October 1, 1984, concerning a donation of funds by the Republican National Committee to the Sedgwick County Republican Central Committee for the sole purpose of funding a get out the vote drive.

You ask whether the Republican National Committee is required to file a verified statement pursuant to K.S.A. 25-4172 when the transfer of funds takes place.

By rule and regulations, the Kansas Public Disclosure Commission has determined that funds used for voter registration drives and get out the vote drives do not constitute "contributions" under the Campaign Finance Act. Since K.S.A. 25-4172 applies only to "contributions," that section does not apply and a verified statement is not required under the circumstances you have described.

Advisory Opinion No. 84-19

Written to Garry L. Kemp, Director, Planning, Research, Evaluation and Accreditation Department of Corrections, Jayhawk Tower, 700 Jackson, Topeka, Kansas 66603.

This opinion is in response to your letter of August

10, 1984, in which you request an opinion from the Kansas Public Disclosure Commission.

We understand you request this opinion in your capacity as Director of Planning, Research, Evaluation and Accreditation for the Kansas Department of Cor-

You advise us that in 1980 the Department of Corrections made a policy decision to take steps necessary to have its institutions accredited by the Commission on Accreditation for Corrections. With respect to one institution, Kansas State Penitentiary, the State agreed as part of a consent decree to obtain accreditation for that institution. You were hired to manage this process. The process involves the agency contracting with the Commission on Accreditation. The contract is a form contract designed by the Commission on Accreditation. The terms are not negotiable. The cost to the State is also not negotiable. The State pays a specific fee to the Commission on Accreditation for the accreditation service. It is your understanding that the Commission on Accreditation is a sole source provider in the accreditation process for correctional institutions.

You also state that in your role in managing the accreditation process, you contact the Commission on Accreditation each time you are ready to begin accreditation efforts at a specific institution. At that time. the Department enters into the agreement which is attached. You are then involved in working with the Commission on Accreditation throughout the entire process.

We also understand that you have been accepted by the Commission on Accreditation to be trained as an auditor in the accreditation process. In this capacity you would be involved in going to other states, to audit their institutions.

We understand that this training and auditing would be extremely useful to the State of Kansas since you would be in a position to better understand the process and prepare for audits of our institutions. We understand that during your time auditing institutions outside of the state you would be on loan to the Commission on Accreditation, receiving your state salary with no reimbursement for your service from the Commission.

You ask whether you may do auditing for the Commission of institutions outside Kansas during your tenure with the Kansas Department of Corrections.

We have reviewed K.S.A. 46-215 et seq. in its entirety and it is our opinion, based on this specific factual situation, that the situation you have described is permissible.

Place of Payment

Bonded Indebtedness

The total bonded indebtedness of the City of Wichita, Kansas, as of December 1, 1984, is \$255,438,000, which amount excludes all revenue and refunding bonds, but includes temporary notes in the amount of \$27,420,000 (including the \$24,690,000 of temporary notes to be sold on November 20, 1984) and the Series of Bonds described in this Notice of Bond Sale in the amount of \$14,030,000. THE NUMBER, DENOMINATION OF BONDS, AND NAMES OF THE INITIAL REG-ISTERED OWNERS TO BE INITIALLY PRINTED ON THE BONDS SHALL BE SUBMITTED IN WRITING BY THE SUCCESSFUL BIDDER TO THE BOND REGISTRAR NOT LATER THAN NO-VEMBER 21, 1984. The purchaser will be furnished with a complete Transcript of Proceedings evidencing the authorization and issuance of the Bonds, and the usual closing proofs, which will include a Certificate that there is no litigation pending or threatened at the time of delivery of the Bonds affecting their validity. Payment for the Bonds shall be made in immediately available funds. Delivery of the Bonds will be made to the successful bidder on November 28, 1984, at any bank or trust company in the cities of WICHITA, KANSAS, TOPEKA, KANSAS or KANSAS CITY, MISSOURI, at the expense of the Board.

Legal Opinion

Bids shall be conditioned upon the unqualified approving opinion of Gaar & Bell, Bond Counsel, Wichita, Kansas, a copy of which opinion will be printed on the reverse side of each Bond and a manually signed original will be furnished without expense to the purchaser of the Bonds at the delivery thereof. The cost of this legal opinion and the expense of printing the Bonds and legal opinion will be paid by the Board. Said legal opinion will state in part that under existing law, the interest on said Bonds is exempt from present federal income taxation and the Bonds and all income derived therefrom are and shall be exempt from all state, county and municipal taxation in the State of Kansas, except inheritance taxes of the State of Kansas.

Purpose of Issue

The Bonds are being issued for the purpose of providing funds to refund prior to maturity the outstanding Board of Regents of the State of Kansas, Academic and Service Building Revenue Bonds (Wichita State University) Series 1971, dated June 1. 1971 in the original principal amount of \$3,400,000, \$2,225,000 of which remain outstanding (the Series 1971 Bonds). The proceeds of the Series 1971 Bonds were used to provide a portion of the funds to construct and equip a Science Building containing classrooms, laboratories and offices, and a Power Plant to provide a central heating and air conditioning facility and necessary appurtenances thereto on the campus of Wichita State University (the Project). Certain funds currently held in accounts created in conjunction with the issuance of the Series 1971 Bonds will be used together with proceeds of the Series 1984 Bonds to establish an irrevocable escrow trust account of United States Government Securities and cash, the proceeds of which will be sufficient to retire the principal of and interest on the Series 1971 Bonds as the same become due for payment.

Sufficiency of Protest

The Board has adopted a Resolution declaring the intent to issue the Series 1984 Bonds and provided for notice of same to be published in accordance with K.S.A. 76-6a25. Such notice was published in the Kansas Register on October 25, 1984. Within thirty days of such publication an action may be filed in a court of competent jurisdiction to challenge the validity of the proceedings taken by the Board or the legality of the Series 1984 Bonds. The Series 1984 Bonds will be awarded subject to the rights created by such statute. In the event adverse litigation is filed and not favorably resolved prior to October 28, 1984, the Series 1984 Bonds will not be issued and delivered. The Board shall not be liable to the successful bidder for any failure to deliver the Series 1984 Bonds resulting from action taken pursuant to K.S.A. 76-6a25.

Security

The Series 1984 Bonds are secured by a pledge of the gross revenues to be derived from the Project and from a Student Building Fee levied against each regularly enrolled student at Wichita State University, which together with any other available funds, will be sufficient to meet all debt service and reserve requirements on the Series 1984 Bonds. A bond reserve account in the amount of \$300,000 will be created from available funds currently held in accounts established in conjunction with issuance of the Series 1971 Bonds. The Series 1984 Bonds do not constitute general obligations of the Board of Regents of the State of Kansas, Wichita State University, the State of Kansas or the United States of America and cannot be paid from any general property tax levied by the State of Kansas. The Board is immune from liability and suit on an implied contract, or for negligence, or any other tort, except as is otherwise specifically provided by statute.

CUSIP Identification Numbers

CUSIP identification numbers will be printed on said Bonds. All expenses in relation to printing of CUSIP numbers on said Bonds and the expenses of CUSIP Service Bureau for the assignment of said numbers shall be the responsibility of and shall be paid for by the Board.

KANSAS FACTS

VOTER QUALIFICATIONS AND REGISTRATION

A Kansas voter must be:

- * A United States citizen;
- * At least 18 years of age;
- * A resident of Kansas and the voting area; and
- * Registered to vote.

Voter registration:

- 1. Registration is required for all voters in Kansas.
- 2. Qualified persons may register at the office of their county election officer or at other places designated by that officer.
- 3. Citizens may register by mail by contacting their county election officer by letter or telephone to request an application.
- 4. Registration closes 20 days prior to any election, and re-opens the day after the election.
 - 5. A voter must re-register if:
 - a. Voter changes place of residence. (This includes moving from one unit to another in the same apartment building.)
 - b. Voter changes name.
- 6. A voter should contact the county election officer to determine if it is necessary to re-register whenever a voter fails to vote in any November general election.

Party affiliation:

1. Voters may declare their party affiliations at the time of registration or may sign a declaration at the

voting place the first time they vote in a primary election; or a voter may choose not to be affiliated with any political party.

2. A voter may file a declaration changing party affiliation with the county election officer at any time

Federal Officials

President and Vice-president—4 year term.

U.S. Senator-6 year term.

U.S. Representative (all 5 Kansas positions)—2 year terms.

State Officials

State Senators (all 40)—4 year terms.

State Representatives (all 125)—2 year terms.

Supreme Court Justices (retained by nonpartisan ballot; 3 of the 7 Justices on the ballot in 1984)—6 year terms.

Court of Appeals Judges (retained by separate non-partisan ballot; 4 of the 7 Judges on the ballot in 1984)—4 year terms.

State Board of Education Members, Districts 2, 4, 6, 8 and 10—4 year terms.

District Judges, Associate District Judges and District Magistrate Judges (certain positions throughout the state as provided by law; by election or by retention on nonpartisan ballot, at local option)—4 year terms (except those elected to fill unexpired terms).

District Attorneys (in 3rd, 7th, 10th, 18th and 29th Judicial Districts)—4 year terms.

Local Officers

County officers: clerk; treasurer; register of deeds; attorney; sheriff; surveyor (in certain counties); commissioners (in most of the 105 counties, commissioners for districts 2 and 3 are to be elected in 1984)—4 year terms.

Township officers: trustee; clerk; treasurer—4 year terms.

SPECIAL PRESIDENTIAL BALLOT FOR NEW RESIDENTS

A person who moves to Kansas a short time before a Presidential election and does not register to vote in this state before registration closes may vote a special ballot for President and Vice President only.

To be eligible, such voter must:

- 1) Be a citizen of the United States and a qualified elector of the state of previous residency;
- 2) Be a resident of Kansas for 30 days before the election; and
- 3) Make application to their county election officer not earlier than 25 days before the election, and not later than noon on the day before the election.

SPECIAL PROVISIONS FOR VOTING

Absentee Voting:

Registered voters who will be absent from their home counties on election day, or any voter who is prevented by religious belief or practice from going to the polls on election day, may apply for an absentee ballot by one of two procedures:

- 1. The voter may:
 - (a) File an affidavit with the county election officer for an absentee ballot; or
 - (b) Have an elector living in the same county file an affidavit in his or her behalf.

An absentee ballot will be mailed to the address designated; the ballot must be voted in secrecy and returned to the county election officer of the home county by the time the polls close on election day.

2. An absent voter may go to the office of his or her home county election officer from the Tuesday noon preceding the election until Monday noon preceding the election, make application and vote in the office.

Sick, Physically Disabled or Illiterate Voters:

Special voting procedures are available for any voter having a permanent or temporary illness or disability which would make it difficult or impossible for that voter to vote at a polling place.

1. All registration and voting procedures may be

handled by mail.

2. A sick, disabled or illiterate voter may make application for a ballot prior to the election, but no later than noon on election day; or such voter may have application made on his or her behalf by another.

- 3. Sick, physically disabled or illiterate voters who are unable to mark or transmit an absentee ballot may receive assistance from another person. The person rendering assistance must sign an affidavit and return both the affidavit and the absentee ballot to the county election officer by the time the polls close election day.
- 4. Registered voters having permanent physical disabilities or illnesses are permitted to automatically receive absentee ballots before every election. Applications for this special permanent absentee ballot status are available from local county election officers.
- 5. If an elderly or disabled voter is able to go to the voting place but finds it inaccessible by reason of stairs or steps, such voter may request that his or her ballot be brought to the entrance of the polling place.

Federal Service absentee voting:

Persons qualified to vote under Federal Service voting provisions are:

- a. Members of the armed forces and their spouses and dependents.
- b. Members of the Merchant Marine and their spouses and dependents.
- c. Citizens of the United States temporarily residing outside the territorial limits of the United States and their spouses and dependents residing with or accompanying them.

Such persons are not required to be registered to vote. However, such persons must be eligible to register in Kansas.

Postcard applications (Standard Form 76) must be mailed to the home county election officer or home state secretary of state. (If postcard application is not available at military installation, the voter should contact the Secretary of State for an application.)

Ballots will be mailed by the county election officer, and the marked ballots must be returned to that office by the time the polls close on election day.

All Federal Service ballot material is transmitted air mail free of charge (except items mailed by other than

Federal Service absentee ballots shall be issued to qualified appliants for the following elections:

- 1. Any primary or general election held in his or her district or precinct.
- 2. All candidates (other than precinct committeemen and committeewomen) for whom the voter would otherwise be qualified to vote.
- 3. Proposed amendments to the Kansas Constitution.
- 4. Any other statewide proposition or question.
- NOTE: Those persons entitled to vote the Federal Service absentee ballot and who have been discharged or have terminated employment too late to register in their home precinct will be allowed to sign an affidavit in the office of the county election officer which will permit them to vote at the next ensuing election. A voter's home county election officer should be consulted for details.

AT THE POLLS

Voting Hours:

The polls are open from 7:00 a.m. until 7:00 p.m. unless different hours are set and publicly announced by the county election officer. The polls must be open at least 12 continuous hours, not close before 7:00 p.m., and close no later than 8:00 p.m.

Paper Ballots:

When paper ballots are used, the voter will be given the official ballots and should then proceed to the voting booth to mark them. The voter must not place any marks on a ballot which would in any way identify it.

If a ballot is torn, soiled, defaced or erroneously marked, it may be refolded and returned to the election officer. A second set of ballots will be provided, but no more than three sets of ballots may be obtained.

A voter may be limited to five minutes in the voting booth if other voters are waiting to use it.

Voting Machines:

If voting machines are used, a small model of the machine must be available at each polling place to demonstrate to voters how to use the machines.

Each voter is limited to three minutes in the voting machine booth.

Write-in Voting:

Write-in votes are allowed only if a blank line is provided under the specific office. A name must be written clearly and a proper cross or check mark placed in the box at the right. Voting machines also provide spaces for write-in votes, where allowed.

Assistance in Voting:

A voter may request assistance if unable to vote unassisted by reason of:

1. Physical disability;

2. Visual handicap;

3. Lack of proficiency in reading the English language; or

4. Sixty-five or more years of age.

Challenges:

A person offering to vote may be challenged as unqualified on any of the following grounds:

1. Not a citizen of the United States.

2. Not 18 years of age.

3. Not a resident of the precinct.

4. Not registered to vote.

5. If a former resident, such person has moved before 30 days prior to the election.

6. At primary election: not a member of the political

party announced by the voter.

A challenged voter must be allowed to vote a "Challenged" ballot, which must be sealed and held by poll officials pending a determination, as provided by law, of the voter's qualifications to vote.

Persons who move within 30 days of an election:

If a registered voter changes his or her name, or moves within the precinct, during the 30 days immediately preceding an election, the voter may sign an affidavit at the polling place and vote in that election. A voter who moves to another precinct in Kansas during the 30 days just prior to an election may vote in his or her former precinct in person or by absentee ballot. In either case, re-registration is required before the next election.

Poll Agents:

Authorized poll agents are permitted to be present as observers at original, intermediate and final canvasses of elections and at polling places.
