OPINION NO. 84-118

Intoxicating Liquors and Beverages—Licensing and Related Provisions—Persons Ineligible for Licenses; Conviction of Crimes Opposed to Decency and Morality. John A. Lamb, Director of the Alcoholic Beverage Control Division of the Department of Revenue, December 11, 1984.

K.S.A. 1983 Supp. 41-311(a)(7) provides that no person shall be eligible to obtain an intoxicating liquor license from the Alcoholic Beverage Control Division if he or she has been convicted of "being a proprietor of a gambling house, pandering or any other crime opposed to decency and morality." When first used in 1949 (the year the statute was enacted), the reference to crimes opposed to decency and morality identified those offenses set forth in Chapter 21, Article 9 of the General Statutes of Kansas. Although the statutes detailing these offenses were redistributed in 1970 when the Kansas Criminal Code became effective, for any offense existing in 1949 it is possible to determine whether such crime was then considered to be against decency and morality. If so, the intent of the legislature in including such language in the provisions of K.S.A. 1983 Supp. 41-311(a)(7) should continue to be controlling. Advisory Opinion No. 84-20

Written November 29, 1984 to W. H. Sachs, Jr., City Manager, City of Atchison, 515 Kansas Avenue, Atchison, Kansas 66002.

This opinion is in response to your letter of October 10, 1984, which was directed to this office for reply. We understand you ask this opinion in your capacity

as City Manager of the City of Atchison, Kansas.

You advise us that there are four principal entities involved in this discussion: the City of Atchison, the Atchison Area Chamber of Commerce, the Industrial Development Board, and the Atchison Area Economic Development Corporation. For the purpose of abbreviated reference the entities will be referred to respectively, as the City, the Chamber, the Board, and the A.A.E.D.C.

You state that the City, through the Board, has contracted by municipal resolution with the Chamber to advance the City's industrial development. The A.A.E.D.C. is an independent not for profit corporation with similar interests.

You also advise us that the Executive Director of the Chamber receives her salary in part from funds granted to the Chamber by the City and in part from Chamber funds, and from funds provided by the A.A.E.D.C.

Your concern is the situation where the A.A.E.D.C. and the Chamber or the City may have differing interests. You ask what conflicts of interest might exist

for the Executive Director of the Chamber in such situations.

We note at the outset that we understand that the Executive Director of the Chamber does not receive her salary from the city; rather she is paid by the Chamber itself from funds granted to the Chamber by the City. Secondly, the Chamber of Commerce is an independent entity, not established by the City, but rather an entity with which the City has selected to contract to provide certain services.

Under these circumstances, it is our opinion that the Executive Director of the Chamber of Commerce is not a "public officer" or "public employee." Thus, K.S.A. 75-4301 et seq. does not apply to the Executive

Director of the Chamber of Commerce.

Since our jurisdiction is limited in this case to the application of those statutory sections to the situation you have described, we find no conflict of interest in the situation described.

We would suggest that the issue you raise is probably governed by common-law principles of master-servant relationships; but since this field is outside our jurisdiction, we cannot give our opinion on that issue.'

Advisory Opinion No. 84-21

Written November 29, 1984 to Joan Anderson, 319 West 5th, Ottawa, Kansas 66067.

This opinion is in response to your letter received in this office on November 5, 1984, in which you request an opinion from the Kansas Public Disclosure Commission.

We note at the outset that the Commission's jurisdiction is limited in this case to the application of K.S.A. 75-4301 et seq. and K.S.A. 46-215 et seq. Thus, whether some other common law, statutory system or rule and regulation applies to your question is not covered by this opinion.

We understand you request this opinion in your capacity as a part-time intermittent social worker with the Department of Social and Rehabilitation Services. You advise us that your primary duty is the case management of persons receiving alternate care in their homes.

You also advise us that you are interested in a position with Southridge Home Health Care, a nursing home facility located in Louisburg, Kansas. You indicate that Southridge may be expanding its services to include provisions of services to persons in a non-nursing home environment.

You advise us that you have not participated as a state employee in the making of any contracts with Southridge. Further your job does not normally entail making recommendations concerning contracts nor licensing, regulating or inspecting Southridge. You indicate, however, that it is possible that you might be assigned some of these tasks.

Based on this factual situation you ask whether you may accept a position with Southridge during your tenure as a state employee.

It is our opinion so long as you do not participate as a state employee in the making of contracts with

Southridge and do not participate on behalf of the state in licensing, regulating or inspecting Southridge, that you could legally accept the position under the conflict of interest laws we have set out above.

The more difficult issue is how the requirement that you not participate in any manner on behalf of the state in contracting, licensing, regulating or inspecting Southridge will affect your ability to properly do the job assigned to you by the state. This issue is outside our jurisdiction and we suggest you discuss this issue with your supervisor and perhaps the Department of Administration to receive their input.

Advisory Opinion No. 84-22

Written to The Honorable Thomas R. Docking, Lieutenant Governor, State of Kansas, State Capitol Building, Topeka, Kansas 66612.

This opinion is in response to your letter of November 6, 1984, in which you request an opinion from the Kansas Public Disclosure Commission.

We understand you request this opinion in your capacity as Lieutenant Governor of the State of Kan-

You ask whether this gift is permissible under K.S.A. 46-215 et seq.

We have reviewed K.S.A. 46-215 et seq. in its en-

tirety and it is our opinion since the gifts are to the state and the agency receiving the gifts does not license, regulate or inspect the donor, that the gifts are permissible.
