ORDER

The above captioned matter comes on for consideration and determination by the State Corporation Commission (hereinafter Commission), on its own motion. The Commission, having examined its files and records, and being fully advised in the premises, finds and concludes as follows:

1. By order dated December 3, 1982, the Commission established the minimum interest rate to be paid on security deposits pursuant to K.S.A. 12-822 at a level of 8% per annum. The Commission further directed its staff to conduct an annual review during the month of November to determine whether the currently effective interest rate properly reflected current economic conditions and the respective interest of customers and utilities. Additionally, the Commission directed interested parties to submit any recommendation for retaining or changing the interest rate to the Commission no later than November 30th annually.

2. Joint Comments of the Kansas Power and Light Company and the Gas Service Company (hereinafter KPL/GSC) requesting that the 8% annum rate currently being paid on customer deposits remain intact during

1985, were filed with the Commission on November 28, 1984. In support of its request, KPL/GSC contend the following:

A. There has been slight upward and downward pressures on interest rates in the last 24 months, with no significant change to occur in the near future.

B. Currently, prime interest rates are within one-half of one percent of the levels during the last three months prior to the Commission's December 3, 1982 Order.

C. The current rate of 8% per annum paid on deposits continues to closely represent the opportunity cost that security deposits represent to customers.

D. Stability in the rate is desirable in terms of ratemaking treatment.

3. Based upon the comments of KPL/GSC and the recommendations of the Commission's staff, the Commission finds that interest rates have generally remained stable over the past 24 months. Furthermore, it is unforeseeable that the rates will change substantially through the calendar year 1985. Maintaining the rates paid on customer deposits at 8% per annum would be reasonable under the economic conditions that are expected to exist during 1985.

IT IS, THEREFORE, ORDERED BY THE COMMISSION THAT:

The minimum interest paid on security deposits pursuant to K.S.A. 12-822, shall be 8% per annum. This rate properly reflects current economic conditions and the respective interest of customers and utilities.

Interested parties are reminded that annually during the month of November the interest rate paid on security deposits will be reviewed by the Commission staff, and any recommendation for retaining or changing the interest rate shall be submitted to the Commission no later than November 30th annually.

The Commission retains jurisdiction over the parties and the subject matter to enter such order or orders as it shall from time to time deem appropriate.

EXECUTIVE ORDER NO. 84-77

**ALLOCATING A STATE CEILING FOR
 CERTAIN PRIVATE ACTIVITY BONDS**

WHEREAS, Section 103(n) of the Internal Revenue Code of 1954, as amended ("Code"), imposes a State Ceiling on the aggregate amount of Private Activity Bonds issued in a State during any calendar year, the interest on which is exempt from federal income taxation pursuant to Section 103(a) of the Code; and

WHEREAS, Private Activity Bonds included in the State Ceiling are:

(A) "Industrial Development Bonds," as that term is defined in Section 103(b)(2) of the Code, the interest on which is exempt from federal income taxation solely by virtue of the application of paragraphs (4), (5), (6), or (7) of Section 103(b) of the Code, other than bonds:

(1) to which Section 103(b)(4)(A) of the Code applies;

(2) to which Sections 103(b)(4)(C) or 103(b)(4)(D) of the Code apply, but only if the property described in such unit (determined as if Section 103(b)(4)(D) of the Code did not refer to "parking facilities"); and

(b) "Student Loan Bonds," the interest on which is exempt from federal income taxation, and all or a major portion of the proceeds of which are to be used directly or indirectly to finance loans to individuals for educational expenses; and

WHEREAS, for purposes of this Order, Private Activity Bonds shall not include any obligation which is issued to refund another obligation to the extent that the amount of such obligation does not exceed the amount of the refunded obligation; however, in the case of any Student Loan Bonds, refunding obligations shall be excluded from the definition of Private Activity Bonds only if the maturity date of the refunding obligation is not later than the later of:

(1) the maturity date of the obligation to be refunded, or

(2) the date 17 years after the date on which the refunded obligation was issued (or in the case of a series of refundings, the date on which the original obligation was issued); and

WHEREAS, Section 103(n)(6)(B)(i) of the Code authorizes the Governor of a State to proclaim a formula for allocating the State Ceiling among the governmental units in such State having authority to issue Private Activity Bonds; and

WHEREAS, Section 103(n)(6)(B)(ii) of the Code provides that the authority of the Governor to proclaim an allocation formula shall not apply after the earlier of:

(A) the first day of the first calendar year beginning after the Legislature has met in regular session for more than 60 days after the date of enactment of Section 103(n) of the Code, or

(B) the effective date of any State legislation with respect to the allocation of the State Ceiling; and

(continued)

WHEREAS, for the State of Kansas, the first day of the first calendar year beginning after the Legislature has met in regular session for more than 60 days after the date of enactment of Section 103(n) of the Code will be January 1, 1986.

WHEREAS, the State Ceiling for Private Activity Bonds to be issued in the State of Kansas pursuant to Section 103(n) of the Code during calendar year 1984 was calculated to be at least \$354,000,000; and

WHEREAS, the State Ceiling for Private Activity Bonds for calendar year 1984 was allocated among the governmental units and other entities authorized to issue such bonds by Executive Order No. 84-74, which was effective July 25, 1984; and

WHEREAS, a portion of the State Ceiling for Private Activity Bonds for calendar year 1984 will be unused at the expiration of calendar year 1984.

NOW, THEREFORE, pursuant to the authority vested in me as Governor and chief executive of the State of Kansas, I hereby establish the following system for allocating the State Ceiling of Private Activity Bonds for calendar years after 1984 among the governmental units and other entities authorized to issue such Bonds:

(A) *Definitions.* In addition to those words and phrases defined elsewhere in this Order, the following words and phrases shall have the following meanings:

(1) "Historic Issuers" means those Issuers which have issued Private Activity Bonds averaging \$100,000 or more during the three calendar years next preceding the calendar year of allocation which issues would have been or were subject to the State Ceiling; except that issues the interest of which was exempt from federal income taxation pursuant to Section 103(b)(4)(F) of the Code shall not be taken into account.

(2) "Historic Issuers Allocation" means the amount set aside for Historic Issuers.

(3) "Local Issuers Pool" means all authorized amounts within the State Ceiling not set aside for the Statewide Concern Issues Allocation.

(4) "Potential Issuers" means those Issuers other than Historic Issuer.

(5) "Potential Issuers Allocation" means either that portion of the Local Issuers Pool not credited to the Historic Issuers Allocation or those amounts not used from either the Statewide Concern Issues Allocation or the Historic Issuers Allocation, as of the specific dates established, and credited to the Potential Issuers Allocation.

(6) "State Ceiling" means the maximum aggregate amount of Private Activity Bonds that may be issued by Issuers within the State during a single calendar year.

(7) "Statewide Concern Issues Allocation" means the allocation for issues of Private Activity Bonds to finance student loans, pollution control projects and agricultural projects involving loans to farmers.

(B) *Distribution of State Ceiling.*

(1) The Statewide Concern Issues Allocation shall be an amount equal to ten percent (10%) of the State Ceiling for each calendar year after 1984.

(2) The Local Issuers Pool shall be an amount equal to ninety percent (90%) of the State Ceiling for calendar years after 1984. Such allocation shall be sub-allocated as follows:

(a) The Historic Issuers Allocation shall be an amount not to exceed seventy-five percent (75%) of the average of the total of all Private Activity Bonds issued by Historic Issuers during the preceding three calendar years; except that it shall not exceed seventy-five percent (75%) of the total allocation to the Local Issuers Pool.

(b) The Potential Issuers Allocation shall be the amount not sub-allocated to the Historic Issuers Allocation; except that it shall not be less than twenty-five percent (25%) of the total allocation to the Local Issuers Pool.

(C) *Apportionment of Authority to Allocations and Pool.*

(1) *Sub-Allocation of Statewide Concern Issues Allocation.* That portion of the Statewide Ceiling allocated to the Statewide Concern Issues Allocation shall be sub-allocated by the Secretary to the Issuer or Issuers proposing to use a portion of the State Ceiling to issue obligations for the purposes set forth for the Statewide Concern Issues Allocation. Any portion of the Statewide Concern Issues Allocation not sub-allocated to Issuers by July 1 of any calendar year or carried forward in accordance with Section 103(n)(10) of the Code and regulations relating thereto to a calendar year subsequent to the calendar year of sub-allocation shall be transferred to the Potential Issuers Allocation of the Local Issuers Pool. Any sub-allocation to an Issuer from the Statewide Concern Issues Allocation shall be in addition to any other issuing authority allocated to such Issuer and shall not be considered in determining an Issuer's status as an Historic Issuer.

(2) *Credit to Account of Issuers from Historic Issuers Allocation.* By December 31, 1984, and each December 31 thereafter, each Historic Issuer will be advised as to the amount credited to its account for the next succeeding calendar year. Each Historic Issuer, to the extent of its credit balance in the Historic Issuers Allocation, shall have the exclusive authority to issue Private Activity Bonds subject to the State Ceiling. Amounts credited to Historic Issuers for which Private Activity Bonds are not issued by September 1 of the year of sub-allocation shall be credited to the Potential Issuers Allocation. Upon the exhaustion of its credit balance in the Historic Issuers Allocation, an Historic Issuer shall be eligible to apply for authority from the Potential Issuers Allocation.

(3) *Apportionment to Issuers from Potential Issuers Allocation.* The Potential Issuers Allocation shall be apportioned to Issuers on a first come, first served basis in accordance with the Issuer's application to the Secretary. Applications for the apportionment of the Potential Issuers Allocation for any calendar year may not be made prior to December 15 of the immediately preceding calendar year; except that Historic Issuers will have access to the Potential Issuers Allocation only after exhausting their individual credit balance in the Historic Issuers Allocation.

(D) *Administration.*

(1) Prior to the issuance of any Private Activity Bonds, the Issuer shall notify the Secretary of Economic Development or his designee ("Secretary") of its present intent to deliver such issue of Bonds by filing an application with the Secretary. Such application shall be in writing, signed by a duly elected or appointed officer or member of the governing body of the Issuer which proposes to issue such Bonds, shall be delivered in original duplicates to the Kansas Department of Economic Development ("KDED"), 503 Kansas Avenue, 6th Floor, Topeka, Kansas 66603, Attention: PAB Allocation, during normal business hours, and shall contain the following information:

(a) a copy of the resolution or letter of intent to issue as adopted or approved by the governing body of the Issuer;

(b) the name and address of the Issuer;

(c) the proposed principal amount of such Bonds;

(d) in the case of Industrial Development Bonds, the paragraph of section 103(b) of the Code applicable to such bonds;

(e) the principal beneficiary of the facility or activity to be financed with the proceeds of such Bonds; and

(f) the location and type of project (e.g. commercial, manufacturing, pollution control, student loans, etc.).

(2) With respect to an issue of Private Activity Bonds involving the sub-allocation of the Statewide Concern Issues Allocation or any issue of Private Activity Bonds involving the apportionment of the Potential Issuers Allocation under Section (C)(3) in a principal amount exceeding \$10,000,000, the Secretary shall have the authority to request additional information concerning the facility or activity and to prescribe and promulgate any rules and procedures necessary for the review of each application. In reviewing the application, the Secretary shall evaluate the economic benefits of the project or activity, including the manner in which the project or activity shall stimulate and develop the general welfare and economic prosperity of the State. The Secretary shall evaluate the extent to which such project or activity will assist in and encourage: the location of new business and industry in the State; the expansion, relocation and retention of existing business, industry and health development; the development of greater employment opportunities; and the diversification of industry within the State. Not less than 21 days after the Secretary has received all of the information necessary to consider the application, the Secretary shall inform the applicant of his decision by returning one original of the application to the Issuer making the filing with the endorsement "Approved for Issuance" or "Denied" and the date of the approval ("Approval Date") or denial thereof.

(3) With respect to an issue of Private Activity Bonds to be issued by an Historic Issuer pursuant to its credit balance in the Historic Issuers Allocation, the Secretary shall, within five (5) business days after receipt of the Issuer's application, to the extent such

application together with all other applications received from such Issuer does not exceed such Issuer's credit balance in the Historic Issuers Allocation, endorse on each original of the application "Approved for Issuance" and the date of such approval. One original shall be filed with KDED and the other original shall be returned to the applicant.

(4) With respect to an issue of Private Activity Bonds involving the apportionment of the Potential Issuers Allocation, and to the extent that a portion of the State Ceiling remains available, the Secretary shall, within five (5) business days after receipt of the Issuer's application, apportion the amount requested to the Issuer by endorsing on each original of the application "Approved for Issuance" and the Approval Date. One original shall be filed with KDED and the other original shall be returned to the applicant. Applications shall be approved in the order of receipt by KDED.

(5) Within 5 days after the date that any Private Activity Bonds have been issued, the Issuer shall notify KDED in writing, at the address set forth in paragraph (D)(1) above, of the date of issuance of such Private Activity Bonds and the actual principal amount of Private Activity Bonds which have been issued. The Issuer shall also provide KDED with a copy of IRS Form 8038 (or successor form required by the Internal Revenue Service) as filed by the Issuer with the Internal Revenue Service within 30 days following the date of issuance of such Private Activity Bonds.

(6) Except as provided in Section (E), the approval of the issuance of an issue of Private Activity Bonds shall expire on the date 60 calendar days after the Approval Date unless the issue has been delivered prior to such date. In the event of the expiration of approval, an Issuer may reapply for approval of the issuance of such Bonds in the same manner as described above for an original application. In such event, the approval of the Secretary will only be effective for a period of 30 days from the new Approval Date. At the expiration of such 30-day period, if such Bonds have not been delivered, the Issuer shall be required to wait 30 days before reapplying for approval for such issue of Bonds unless such waiting period is waived in writing by the Secretary. Upon expiration of the 30-day waiting period, such application shall be treated as a new application.

(7) Notwithstanding the provisions of paragraph (6) of this Section (D):

(a) if the Approval Date for an issue of Private Activity Bonds is after November 15, 1985, such Private Activity Bonds must be issued on, or within 30 calendar days after, the Approval Date; and

(b) if the Approval Date for an issue is after December 1, 1985, such Private Activity Bonds must be issued on, or within 15 calendar days after, the Approval date.

(8) The Secretary shall maintain records with respect to the total principal amount of all issues approved for purposes of determining compliance with the State Ceiling and the portion of the State Ceiling

(continued)

available for Private Activity Bonds in the State, and shall make such information available to Issuers requesting it on a reasonable basis.

(E) Notwithstanding the provisions of Sections (D)(6), (D)(7) and (F), on December 16, 1984, and December 16 of each calendar year thereafter, an Issuer which has received approval to issue Private Activity Bonds pursuant to this Order or Executive Order No. 84-74 may elect to carry forward its unused issuing authority by means of a statement, signed by a duly authorized official of such Issuer and the Secretary. Such statement shall be filed with the Internal Revenue Service in the manner prescribed by regulations promulgated under Section 103(n) of the Code and with the Secretary. An Issuer may elect to carry forward such issuing authority only for Student Loan Bonds or a project described in Section 103(b)(4) of (b)(5) of the Code. In no event shall such carryforward be effective for a period longer than permitted by Section 103(n) of the Code and the regulations promulgated thereunder.

(F) This Executive Order shall continue in full force and effect until the earlier of:

(1) the effective date of any act of the Legislature of the State of Kansas with respect to the subject matter hereof; or

(2) the date a subsequent Executive Order with respect to the subject hereof is promulgated.

(G) Sections (C)(2) and (E) of this Executive Order shall become effective immediately. On January 1, 1985, the remaining Sections of this Executive Order shall become effective. On January 1, 1985, Executive Order No. 84-74 is hereby superseded by this Order and the force and effect of said Executive Order is hereby rescinded.

This document shall be filed with the Secretary of State as Executive Order No. 84-77.
