Opinion No. 85-21

Insurance—Health Care Provider Insurance—Health Care Provider Insurance Availability Plan; Governing Board.

State Departments; Public Officers, Employees—Kansas Tort Claims Act—Advisory Committees. Fletcher Bell, Commissioner of Insurance, Topeka, February 21, 1985.

Pursuant to K.S.A. 1984 Supp. 40-3413, the Kansas Health Care Provider Insurance Availability Plan is created to insure the availability of professional liability insurance to those providers who are in good faith entitled to insurance but who are unable to procure it through ordinary methods. K.S.A. 1984 Supp. 40-3423(e) establishes a governing board which reviews and prescribes operating rules for the plan on at least an annual basis. The board is appointed by the commissioner of insurance, and acts on behalf of the insurance department in overseeing the plan. Accordingly, for purposes of the Kansas Tort Claims Act, K.S.A. 75-6101 *et seq.*, the members of the board are employees of a governmental entity, and so are covered by the provisions of the act. Public Health—Healing Arts—Restrictions on Prescribing Controlled Substances.

Public Health—Uniform Controlled Substances Act—Registration Requirements. Lynn E. Ebel, Attorney for the Kansas State Board of Pharmacy, Shawnee, February 21, 1985.

K.S.A. 1984 Supp. 65-2837a provides that persons licensed to practice medicine and surgery must follow prescribed procedures in the issuance of prescriptions for certain controlled substances. By virtue of being licensed by the state board of healing arts, practitioners are exempted from the registration requirements of K.S.A. 1984 Supp. 65-4116, which must otherwise be met before controlled substances may be prescribed. An out-of-state practitioner must therefore either be licensed by the state board or meet the registration requirements. If this is done, a pharmacist may fill a prescription for controlled substances described in K.S.A. 1984 Supp. 65-2837a for an out-of-state practitioner, using the same procedures as for a practitioner licensed in Kansas. Taxation—Mortgage Registration—Mortgage Registration Fee. Jim Pringle, Sumner County Attorney, Wellington, February 25, 1985.

The mortgage registration fee is based upon the amount of the debt or obligation involved in the transaction. It is not based upon the value of the property given to secure the debt or obligation. Cited herein: K.S.A. 79-3102. RJB

Elections—City Elections—Filing Deadlines for Candidates; Filling Vacancy

(continued)

Cities, Second Class—The Board of Commissioners—Vacancy in the Office of Commissioners. David E. Retter, City Attorney, Concordia, February 26, 1985.

In a city of the second class with the commission manager form of government which is governed by K.S.A. 14-1305, a person appointed to fill a vacancy in the office of commissioner holds office only until the "next city election," at which time someone shall be elected to fill the unexpired term if any portion of the term remains. Under Kansas case law, "next city election" is the next ensuing election at which city officers are elected. This conclusion is not altered even though a vacancy occurs after the filing deadline for a candidate seeking city office. The unexpired term should appear on the ballot of the next ensuing city election regardless of the fact no one was able to file as a candidate for the office according to the regular procedures governing the conduct of city elections. Opinion No. 85-25

Cities of the Third Class—Election, Appointment and Removal of Officers—Qualifications of Officers; Qualified Elector; Provision Non-Uniform. Nanette L. Kemmerly-Weber, Allen County Attorney, Iola, February 26, 1985.

K.S.A. 15-209 applies to cities of the third class having the mayor-council form of government, and provides that all elected officers shall be qualified electors of the city. In order to be a qualified elector under state law, a person must have attained the age of 18. Therefore, the statute on its face would prohibit a person under the age of 18 from taking office as a city council member. However, as K.S.A. 15-209 is contained in an act which has non-uniform provisions, a city to which the statute applies may use home rule authority to charter out from any or all of the provisions contained therein, including the requirement that council members be 18 or older. Opinion No. 85-26

Infants—Kansas Code for Care of Children—Filing of Petition on Referral by SRS or Other Person; Filing by Individual—Authority of SRS to File Child in Need of Care Petitions. Peter Rinn, Chief Counsel, Kansas Department of Social and Rehabilitation Services, February 27, 1985.

The Kansas Code for Care of Children allows an individual to initiate a petition alleging a child is in need of care, and provides that said individual may retain legal counsel to present the case to a court of competent jurisdiction. The Secretary of SRS or his representative, as an individual, may file such a petition and use the agency legal staff to present the case. Such authority fulfills the federal statutory mandates. The definition of abused and neglected child as set

out in the code substantially complies with the parameters of federal law. Cited herein: K.S.A. 1984 Supp. 38-1501; 38-1503; 38-1510; 38-1529; K.S.A. 77-201 *Second, Thirteenth*; 42 U.S.C.A. § 5101, § 5102, § 5103, as amended by P.L. 98-457. MWB

SENATE BILL No. 124

AN ACT establishing the state council on vocational education; abolishing the state advisory council for vocational education; amending K.S.A. 72-4410 and K.S.A. 1984 Supp. 72-4409, and repealing the existing sections:

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 1984 Supp. 72-4409 is hereby amended to read as follows: 72-4409. (a) *There is hereby established the state council on vocational education. The state advisory council for on vocational education shall consist be composed of not less than 20 members and not more than 24 13 members as determined by the state board of education. The members of such advisory council who shall be appointed by the state board of education, and every such appointment shall be for a fixed term of not to exceed three years. The terms of persons appointed to such advisory the state council shall be staggered so that approximately an equal number of members are appointed each year. Members appointed under this section shall be so qualified as to comply with the requirements of the federal Carl Perkins vocational education act of 1963 1984, or of acts amendatory thereof or supplemental thereto.*

(b) The state advisory council for on vocational education shall have such powers and perform such acts as are specified in the federal Carl Perkins vocational education act of 1963 1984, or of acts amendatory thereof or supplemental thereto, to be exercised and performed by state advisory councils, and, in addition thereto, such powers, functions and duties as are specified by law.

(c) Members of the state advisory council for on vocational education shall receive compensation, subsistence allowances, mileage and other expenses as provided in K.S.A. 75-3223, and amendments thereto, except that members of the advisory state council on vocational education shall also receive such compensation, subsistence allowances, mileage and other expenses for attendance at meetings of other bodies and organizations when authorized by such council and in performance of duties and functions of such council.

(d) The state advisory council for on vocational education is

authorized to employ such persons as may be necessary to carry out its functions, and all such employees shall be in the classified service under the Kansas civil service act. The state advisory council may contract for such professional services as are necessary to carry out its functions.

Sec. 2. K.S.A. 72-4410 is hereby amended to read as follows: 72-4410. The state advisory council for vocational education may expend any funds heretofore or hereafter appropriated for its operating expenses.

New Sec. 3. (a) On the effective date of this act:

(1) The state advisory council for vocational education shall be and is hereby abolished.

(2) Except as otherwise provided in this act, all of the powers, duties and functions of the state advisory council for vocational education shall be and are hereby transferred to and conferred and imposed upon the state council on vocational education established by this act.

(3) All of the records, memoranda, writings and property of the state advisory council for vocational education shall be and are hereby transferred to the state council on vocational education and such council shall have legal custody of the same.

(b) On and after the effective date of this act:

(2) Whenever the state advisory council for vocational education is referred to or designated by a statute, contract or other document, such reference or designation shall be deemed to apply to the state council on vocational education established by this act.

(3) The state council on vocational education established by this act shall be a continuation of the state advisory council for vocational education.

(c) Terms of members of the state advisory council for vocational education in office on the effective date of this act shall expire on such date. Any such members may be appointed by the state board of education to the state council on vocational education. Appointments made under authority of this subsection are subject to the provisions of K.S.A. 72-4409, and amendments thereto.

AN ACT relating to the joint committee on special claims against the state; concerning the membership thereof; amending K.S.A. 46-912 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 46-912 is hereby amended to read as follows: 46-912. There is hereby established the joint committee on special claims against the state which shall have ~~twelve (12)~~ 13 members consisting of five (5) members of the senate and ~~seven (7)~~ eight (8) members of the house of representatives. The representative members shall be appointed by the speaker, and the senator members shall be appointed by the senate committee on organization, calendar and rules. Not less than ~~three (3)~~ two representative members and two (2) senator members shall be attorneys licensed to practice law in the state of Kansas. Not less than one representative member shall be a member of the house committee on ways and means and not less than one senator member shall be a member of the senate committee on ways and means. ~~Upon the effective date of this act and until the convening of the regular session in 1979 a senator member, designated by the senate committee on organization, calendar and rules to be chairperson of the joint committee.~~ In the biennium commencing with the convening of the regular session of the legislature in 1979, and in the biennium commencing with the convening of the regular session of the legislature each four years thereafter, the chairperson of the joint committee shall be a representative member designated by the speaker of the house of representatives. In the biennium commencing with the convening of the regular session of the legislature each four years thereafter, the senate committee on organization, calendar and rules shall designate a senator member to be the chairperson of the joint committee. If a chairperson shall die, resign or otherwise be incapable of serving as chairperson for the full two-year period, a successor shall be designated to fill the unexpired portion of such period in the same manner as the original chairperson was selected. The members appointed from each house shall include minority party representation thereon. The joint committee shall meet in the interim between legislative sessions on the call of the chairperson as authorized by the legislative coordinating council. Any seven (7) members of the joint committee shall constitute a quorum. Any action of such joint committee may be taken by an affirmative vote of a majority of the members present, if a quorum is present.

The provisions of article 12 of chapter 46 of the Kansas Statutes Annotated, and amendments thereto, applicable to special committees shall apply to the joint committee on special claims against the state to the extent the same do not conflict with the specific provisions of this act applicable to such committee.

HOUSE BILL No. 2027

AN ACT concerning telecommunications services for state agencies; relating to procedures for the acquisition thereof; disposition of fees and charges collected therefor; amending K.S.A. 75-4710 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

New Section 1. (a) The telecommunications negotiating committee is a three-person committee composed of (1) the secretary of administration, or a person designated by the secretary of administration, (2) the director of purchases, or a person designated by the director of purchases, and (3) the director of the division of information systems and communications, or a person appointed by the director of information systems and communications. The telecommunications negotiating committee may negotiate contracts for telecommunications services to be entered into by the secretary of administration for state agencies and other entities as provided in K.S.A. 75-4709 and amendments thereto.

(b) Prior to negotiating for telecommunications services, the committee shall advertise for sealed proposals. The committee then may negotiate with one or more firms submitting proposals and select from among those submitting such proposals the party to contract with for the purpose of providing telecommunications services.

(c) Contracts entered into pursuant to this section for telecommunications services shall not be subject to the provisions of K.S.A. 75-3738 to 75-3740a, inclusive, and amendments thereto.

New Sec. 2. Except as otherwise provided by law and subject to the provisions of appropriations acts relating thereto, all fees and charges imposed by the secretary of administration for telecommunications services provided or contracted for by the secretary shall be deposited in the state treasury and credited to the state communications services fund.

Sec. 3. K.S.A. 75-4710 is hereby amended to read as follows: 75-4710: As used in sections 1 and 2 and K.S.A. 75-4709 and 75-4712, and amendments to those sections, telecommunications services include, but shall not be limited to, any transmission, emission or reception of signals of any kind containing communications of any nature, by wire, radio, optical or other electromagnetic means, and includes all facilities, equipment, supplies and services for such transmission, emission or reception. Telecommunications services shall include data transmission services and equipment but shall not include data processing services otherwise provided or authorized by the division of information systems and communications, or the acquisition, retention or use of any data processing equipment otherwise authorized by the division of information systems and communications.

The difference between the highest and lowest interest rates specified in any bid shall not exceed three percent (3.00%). No interest rate shall exceed the maximum interest rate allowed by Kansas Law; said rate being the 20 bond index of tax exempt municipal bonds published by the Weekly Bond Buyer in New York, New York on the Monday next preceding the day on which the Bonds are sold (March 11, 1985), plus 2%, and no bid of less than par and accrued interest will be considered. Bids for less than the entire issue of bonds will not be considered.

Bid Form and Good Faith Deposit

Bids shall be submitted on the OFFICIAL BID FORM furnished by the Board, and shall be addressed to the Board of Regents of the State of Kansas, Suite 609, Capitol Tower Building, Eighth and Harrison Streets, Topeka, Kansas 66603, ATTENTION: Executive Officer, and shall be plainly marked BOND BID. All bids must state the total interest cost of the bid, the premium, if any, the net interest cost of the bid, and the average annual interest rate, all certified by the bidder to be correct; and the Board will be entitled to rely on the certificate of correctness of the bidder. Each bid must be accompanied by a certified or cashier's check equal to two percent (2%) of the total amount of the bid, and shall be payable to Board of Regents of the State of Kansas. In the event a bidder whose bid is accepted shall fail to carry out his contract of purchase, said deposit shall be retained by the Board as liquidated damages. The checks of unsuccessful bidders will be returned promptly.

Award of Bids

The sealed bids for the Bonds shall be opened publicly and only at the time and place specified in this Notice. The Board reserves the right to reject any and/or all of the bids, and to waive any irregularities. Unless all bids are rejected, the Bonds will be awarded at the Board's meeting commencing at 1:30 P.M. on March 15, 1985 in the City of Topeka, Kansas, to the bidder whose proposal results in the lowest net interest cost to the Board. The lowest net interest cost will be determined by deducting the amount of any premium paid from the aggregate amount of interest upon all of the Bonds from their date until their respective maturities as determined on the basis of the principal amount and maturity schedule set forth in this Notice of Bond Sale prior to modification of same in accordance with the foregoing.

Delivery of the Bonds

The Bonds, duly printed, executed and registered,

will be furnished and paid for by the Board; and the Bonds will be sold subject to the unqualified approving opinion of GAAR & BELL, Bond counsel, of Wichita, Kansas. THE NUMBER, DENOMINATION OF BONDS, AND NAMES OF THE INITIAL REGISTERED OWNERS TO BE INITIALLY PRINTED ON THE BONDS SHALL BE SUBMITTED IN WRITING BY THE SUCCESSFUL BIDDER TO THE BOND REGISTRAR NOT LATER THAN APRIL 1, 1985. The purchaser will be furnished with a complete Transcript of Proceedings evidencing the authorization and issuance of the Bonds; and the usual closing proofs, which will include a Certificate that there is no litigation pending or threatened at the time of delivery of the Bonds affecting their validity. Payment for the Bonds shall be made in immediately available funds. Delivery of the Bonds will be made to the successful bidder on April 10, 1985, at any bank or trust company in the cities of WICHITA, KANSAS, TOPEKA, KANSAS, or KANSAS CITY, MISSOURI, at the expense of the Board.

Legal Opinion

Bids shall be conditioned upon the unqualified approving opinion of Gaar & Bell, Bond Counsel, Wichita, Kansas, a copy of which opinion will be printed on the reverse side of each bond and a manually signed original will be furnished without expense to the purchaser of the Bonds at the delivery thereof. The cost of this legal opinion and the expense of printing the Bonds and legal opinion will be paid by the Board. Said legal opinion will state in part that the under existing law, the interest on said Bonds is exempt from present Federal income taxation and the Bonds and all income derived therefrom are and shall be exempt from all state, county and municipal taxation in the State of Kansas, except inheritance taxes of the State of Kansas.

Purpose of Issue

The Bonds are being issued for the purpose of providing funds to refund prior to maturity the outstanding University of Wichita, Library Revenue Bonds of 1960, dated June 4, 1960 in the original principal amount of \$1,650,000, \$1,475,000 of which remain outstanding (the Series B, 1960 Bonds). The proceeds of the Series B, 1960 Bonds were used to provide funds to construct and equip a library building on the campus of Wichita State University (the Project). Certain funds currently held in accounts created in conjunction with the issuance of the Series B, 1960 Bonds will be used together with proceeds of the Series A, 1985 Bonds to establish an irrevocable escrow trust account of United States Government Securities and cash, the proceeds of which will be sufficient to retire the principal of and interest on the Series B, 1960 Bonds as the same become due for payment.

Sufficiency of Protest

The Board has adopted a Resolution declaring the intent to issue the Series A, 1985 Bonds and provided for notice of same to be published in accordance with K.S.A. 76-6a25. Such notice was published in the *Kansas Register* on February 21, 1985. Within thirty

days of such publication an action may be filed in a court of competent jurisdiction to challenge the validity of the proceedings taken by the Board or the legality of the Series A, 1985 Bonds. The Series A, 1985 Bonds will be awarded subject to the rights created by such statute. In the event adverse litigation is filed and not favorably resolved prior to April 10, 1985, the Series A, 1985 Bonds will not be issued and delivered. The Board shall not be liable to the successful bidder for any failure to deliver the Series A, 1985 Bonds resulting from action taken pursuant to K.S.A. 76-6a25.

Security

The Series A, 1985 Bonds are secured by a pledge of the net revenues to be derived from the operation of all library facilities and student library fees to be charged to each regularly-enrolled student at Wichita State University (the University), as well as the net revenues derived from the operation of the Colorado Derby Building owned by the Board of Trustees of the University. The Board of Regents covenants that it will levy student library fees and make charges for the use of the library and the Colorado Derby Building, which together with any other revenues, will be sufficient to meet all debt service and reserve requirements on the Series A, 1985 Bonds. The Issuer has applied for a municipal bond insurance policy to AMBAC Indemnity Corporation (AMBAC). In the event AMBAC does not issue such policy, A bond Reserve Account in the amount of \$100,000 will be funded from other funds on hand. The series A, 1985 Bonds do not constitute general obligations of the Board of Regents of the State of Kansas, Wichita State University, the State of Kansas or the United States of America and cannot be paid from any general property tax levied by the State of Kansas. The Board is immune from liability and suit on an implied contract, or for negligence, or any other tort, except as is otherwise specifically provided by statute.

CUSIP Identification Numbers

CUSIP identification numbers will be printed on said Bonds. All expenses in relation to printing of CUSIP numbers on said Bonds and the expenses of CUSIP Service Bureau for the assignment of said numbers shall be the responsibility of and shall be paid for by the Board.

STATE FIRE MARSHAL

PERMANENT ADMINISTRATIVE REGULATIONS

(Effective May 1, 1985)

Article 1.—KANSAS FIRE PREVENTION CODE

22-1-1. Kansas fire prevention code. (a) When a municipality adopts one of the nationally recognized fire codes or the fire protection segment of a nationally-recognized building code and modifies a section of that code, a summary of such modifications shall be submitted to the state fire marshal office. The state fire marshal shall review and either approve or reject such modifications. Notification of the action shall be sent to the municipality within 30 days from receipt of the summary.

(b) Any building code package shall reference the 1975 edition of the national electric code or a subsequent edition.

(c) Any alternate method of fire protection which has been approved by a local board of appeals as a substitute for strict compliance with code requirements shall be deemed to be in compliance with the Kansas fire prevention code.

(d) Whenever a question arises as to whether another state statute or an enactment of a municipality is inconsistent with the provisions of the fire prevention code, the state fire marshal shall make a determination after a hearing thereon with all interested parties. Any decisions of the state fire marshal made under authority of this section shall be appealable in accordance with the provisions of K.S.A. 31-142. (Authorized by and implementing K.S.A. 1983 Supp. 31-133; effective May 1, 1981; amended May 1, 1985.)

22-1-2. Compliance with certain building codes. If a building conforms to one of the following updated editions of nationally recognized building codes, it shall be deemed to comply with the Kansas fire prevention code pursuant to K.S.A. 31-134a:

- (a) the 1982 edition of the uniform building code;
- (b) the 1981 and 1984 editions of the basic building code (B.O.C.A.); or
- (c) the 1982 edition of the standard building code (also known as the southern standard building code). (Authorized by and implementing K.S.A. 31-134a; effective May 1, 1985.)

Article 3.—LIFE SAFETY CODE

22-3-1. Life safety code. National fire protection association pamphlet no. 101, chapters 1 through 31,
(continued)

including appendices a, b, and c, 1981 edition, is hereby adopted by reference, except chapter 22, sections 10.7.1.1.1 and 11.7.1.1.1 and the first sentences of sections 11.8.1.1.1 and 11.9.1.1.1. Upon application by a person aggrieved by the requirements of this regulation, the fire marshal may grant a variance from these requirements or allow additional time for the person to comply with the requirements. The requested variance shall be granted only if, after an opportunity to investigate, the fire marshal finds that the condition, structure, or activity in noncompliance does not pose an immediate life safety hazard. This finding shall be made in writing to the applicant for a variance. (Authorized by and implementing K.S.A. 31-133; effective May 1, 1980; amended May 1, 1982; amended May 1, 1985.)

Article 4.—EXPLOSIVE MATERIALS

22-4-1. Explosive materials. National fire protection association pamphlet no. 495, chapters 1 through 9, including appendices a, b, c and d, 1982 edition, is hereby adopted by reference. Upon application by a person aggrieved by the requirements of this regulation, the fire marshal may grant a variance from such requirements or allow additional time for such person to comply with such requirements. The variance shall be granted only if, after an opportunity to investigate, the fire marshal finds that the condition, structure or activity in noncompliance poses no immediate life safety hazard. This finding shall be made in writing to the applicant for a variance. (Authorized by and implementing K.S.A. 31-133; effective May 1, 1980; amended May 1, 1985.)

Article 6.—FIREWORKS

22-6-5. Sale; days permitted. No person, firm or corporation shall offer fireworks for sale to individuals at temporary retail stands or other locations before the 27th day of June and after the 5th day of July. (Authorized by and implementing K.S.A. 31-133; effective Jan. 1, 1973; amended May 1, 1985.)

Article 10.—INSTALLATION AND CERTIFICATION STANDARDS FOR EXTINGUISHING DEVICES

22-10-13. Commercial cooking equipment duct system. National fire protection association pamphlet no. 96, 1984 edition, chapters one through 10, including appendix a, is hereby adopted by reference with the exception that existing systems with electrically heated equipment, other than deep fat fryers, need not be automatically shut off upon activation of the extinguishing system. (Authorized by and implementing K.S.A. 1983 Supp. 31-133, 31-133a; effective, E-82-3, Jan. 21, 1981; effective May 1, 1981; amended May 1, 1982; amended, T-83-31, Oct. 25, 1982; amended May 1, 1983; amended May 1, 1985.)

22-10-15. Fire extinguishers. Approved portable fire extinguishers shall be maintained in a fully charged and operable condition, and kept in their designated places at all times when not in use. (Au-

thorized by and implementing K.S.A. 31-133; effective May 1, 1985.)

22-10-16. Automatic extinguishing systems. In addition to the provisions of K.A.R. 22-10-15, each facility maintaining commercial cooking equipment shall have approved automatic extinguishers mounted in the ventilation canopies or directly above such equipment. All equipment shall bear the label of a nationally-recognized testing laboratory and shall contain an approved extinguishing agent which has saponification characteristics. The state fire marshal may exempt a facility from the requirements of this section, if, in the marshal's opinion, the exemption from this requirement would not present an immediate life safety hazard. (Authorized by and implementing K.S.A. 31-133; effective May 1, 1985.)

Article 11.—ADULT CARE HOMES, HOSPITALS, RESIDENTIAL CARE FACILITIES AND MATERNITY CENTERS

22-11-1 and 22-11-2. (Authorized by and implementing K.S.A. 31-133, 31-147; effective Jan. 1, 1973; amended May 1, 1983; revoked May 1, 1985.)

22-11-5. Health care facilities; fire protection. (a) Each health care facility shall have fire protection available from an organized, publicly-owned fire department.

(b) Each health care facility which is located outside of the corporate limits of a city or outside of a township having a fire department may establish a contract with the city fire department or township to furnish fire protection.

(c) Telephone service to the city or town furnishing fire protection shall be provided. (Authorized by and implementing K.S.A. 31-133, 31-147; effective Jan. 1, 1973; amended May 1, 1985.)

22-11-6. Maternity centers. (a) Definitions. (1) "Code" means the 1981 edition of the national fire protection association pamphlet no. 101, the life safety code.

(2) "Maternity center" means a facility licensed as a maternity hospital which provides delivery services for normal, uncomplicated pregnancies for not more than three women at any one time.

(3) "Grade level" means a floor which is level with the surrounding ground and from which it is not necessary to traverse over stairs to exit.

(b) Location. (1) The labor and delivery room or rooms of a maternity center shall be located on the grade level floor of the building.

(2) If the state fire marshal determines that sufficient additional precautions have been taken, the marshal may permit labor and delivery rooms to be located on floors above grade level. Such additional precautions shall include: (A) Fire-resistive or protected, noncombustible building construction;

(B) A properly installed and maintained sprinkler system;

(C) Properly designed ramp access from the floor on which labor and delivery rooms are located to grade level;

(D) When located in a building with mixed occupants, a one-hour fire-rated wall separating the maternity center from the other occupants; and

(E) Any other precautions deemed necessary to provide a reasonable degree of life safety.

(c) Interior finish. The interior finish of the maternity center shall have a flame spread of 75 or less (class B).

(d) Fire extinguishers. The maternity center shall provide fire extinguishers in accordance with K.A.R. 22-10-12.

(e) Fire alarm system. The maternity center shall have a supervised manual and automatic fire alarm system. Properly installed smoke detectors which are interconnected to the fire alarm system shall be strategically placed throughout the maternity center.

(f) Emergency lighting. The maternity center shall have an emergency lighting system which automatically provides illumination in the event of an interruption of electrical service.

(g) Minimum number of exits. The maternity center shall have at least two approved exits from each floor. Each exit that is not obvious shall be provided with an approved, lighted exit sign.

(h) Evacuation plan. Each maternity center shall have a written evacuation plan. Each staff member shall be informed of and shall have access to the plan. (Authorized by and implementing K.S.A. 31-133; effective May 1, 1981; amended May 1, 1985.)

22-11-7. (Authorized by and implementing K.S.A. 1983 Supp. 31-133, 31-147; effective May 1, 1983; revoked May 1, 1985.)

22-11-8. Life safety code adopted; one- and two-bed adult care homes, one- and two-bed adult family homes, and three- and four-bed boarding care adult care homes. (a) National fire protection association, life safety code, pamphlet no. 101, 1981 edition, chapter 20, pertaining to lodging and rooming houses, is hereby adopted by reference. The provisions of chapter 20 shall apply to one- and two-bed adult care homes, one- and two-bed adult family homes, and three- and four-bed boarding care adult care homes.

(b) A life safety code inspection of a home shall be performed by the state fire marshal or an authorized representative under K.S.A. 31-137 upon request from the Kansas department of health and environment.

(c) (1) Ambulatory residents who are able to walk without the aid of another person but are unable to move from place to place without the use of a device such as a walker, crutches, wheel chair or wheeled platform shall only be housed on the ground level of a home, provided handicap accommodations for exiting are present.

(2) Fully ambulatory residents who do not require the use of a device such as a walker, crutches, wheel chair or wheeled platform may be housed on any level of a home. Non-ambulatory persons shall not be allowed as residents.

(3) As used in this paragraph, "ambulatory" means physically and mentally capable of getting in and out of bed and walking in a normal path to safety in a reasonable period of time without the aid of another

person. "Non-ambulatory" means physically or mentally incapable of getting in and out of bed and walking a normal path to safety without the aid of another person.

(d) The following fundamental fire and life safety requirements shall be imposed in all one- and two-bed adult care homes, one- and two-bed adult family homes, and three- and four-bed boarding care adult care homes, in addition to chapter 20 of the life safety code:

(1) Emergency lighting shall be provided to insure illumination for evacuation in case of a power failure.

(2) Fire alarms, smoke detectors and fire extinguishers shall be maintained in an operable condition at all times.

(3) Fire drills shall be conducted as frequently as is necessary, and at least as often as once every three months, to insure orderly egress in case of an emergency.

(4) All exits, and routes to all exits, shall be clearly marked so that all residents will readily know the direction of egress from any point within the building.

(5) All exits shall be arranged and maintained to provide free, unobstructed egress. No locks or fastening devices shall be installed to prevent free escape from inside of the building.

(6) All buildings shall be constructed, arranged, equipped, maintained and operated as to avoid undue danger to the lives and safety of its residents from fire, smoke, fumes and panic during emergency situations. (Authorized by and implementing K.S.A. 31-133 and 31-147; effective May 1, 1983, amended May 1, 1984; amended May 1, 1985.)

Article 13.—PLACES OF ASSEMBLY

22-13-2 through 22-13-33. (Authorized by and implementing K.S.A. 1972 Supp. 31-133; effective Jan. 1, 1973; revoked May 1, 1985.)

22-13-35. Assembly seating, tents and air-supported structures. National fire protection association pamphlet no. 102, 1978 edition, is hereby adopted by reference. (Authorized by and implementing K.S.A. 1983 Supp. 31-133; effective May 1, 1985.)

Article 20.—NATURAL GAS AS MOTOR FUEL

22-20-1. Natural gas as motor fuel. National fire protection association pamphlet no. 52, 1984 edition, is hereby adopted by reference. (Authorized by and implementing K.S.A. 1983 Supp. 31-133; effective May 1, 1985.)
