Notice is hereby given of the commencement of negotiations for engineering services for the study of the Oklahoma Territorial Jail and surrounding subsidence areas at Kansas State Penitentiary, Lansing, Kansas.

A structural evaluation will be made of the building to determine its soundness for continued use as a storage location for flammable liquids.

Said borings will be taken around the building to determine if the 1959 subsidence corrective measures did in fact stabilize the soils in and around the building.

An architectural code review will be made to determine the exact measures necessary to bring the building into code compliance for flammable liquid storage.

It is the desire of the Kansas Correctional Industries to have an engineering firm complete the study with support from a geological and architectural firm or its own staff. Mechanical and electrical code evaluation will be provided by state personnel.

Intoxicating Liquors and Beverages—Licensing and Related Provisions—Classes of Persons to Whom Licenses Not Issued; Conviction of Violation of Intoxicating Liquor Laws. John A. Lamb, Director, Alcoholic Beverage Control Division, Department of Revenue, Topeka, May 8, 1985

K.S.A. 1984 Supp. 41-311 provides that no liquor license of any kind shall be issued to a person who has been convicted of a violation of the intoxicating liquor laws of a state, such as driving under the influence of alcohol or selling liquor to a minor. For the purposes of this statute, a conviction under a city ordinance for offenses involving intoxicating liquor should be considered as a violation of the liquor laws of the state, and so precludes a person from obtaining a license of the types set forth at K.S.A. 1984 Supp. 41-304. Aircraft and Airfields—Municipal Airports and Fields—Municipal Airfields and Airports; Issuance of Bonds Following Election. Fred W. Rausch, Jr., Bond Counsel for the City of Hays, Topeka, May 8, 1985.

A city may, through the adoption of a valid charter ordinance, exempt itself from that part of K.S.A. 3-113 which requires an election prior to the issuance of airport improvement bonds. Cited herein: K.S.A. 3-

Cities and Municipalities—Franchises—Granting Franchises; Elections on Ordinance. Stan Martin, Herington City Attorney, Abilene, May 8, 1985.

A popular election, held pursuant to K.S.A. 12-2001, at which the voters disapprove a city ordinance renewing a franchise with a natural gas company renders the ordinance in question void and without effect. The company in question, however, may continue to provide services and the city may continue to accept services according to the terms of the expired franchise under a theory of implied contract. Popular disapproval of an ordinance granting a franchise to a company does not prevent a city governing body from approving a new ordinance which grants a somewhat different franchise to the same company. Waters and Watercourses—Groundwater Management Districts—Annual Meetings of Eligible Voters; Affidavits of Eligibility to Vote.

Laws, Journals and Public Information—Records Open to Public—Certain Records Not Required to be Open; Information of a Personal Nature.

Waters and Watercourses—Groundwater Management Districts—Board of Directors; Qualifications. Randall J. Pankratz, Attorney for the Equus Beds Groundwater Management District No. 2, Newton, May 8, 1985.

A groundwater management district organized pursuant to K.S.A. 82a-1020 *et seq.* is required, pursuant to K.S.A. 82a-1026, to hold annual meetings for the purpose of electing members of the board of directors. Only persons who are defined as eligible voters by K.S.A. 82a-1021(e) may vote or serve as directors, and the district may if it chooses require voters to complete affidavits attesting to their eligibility. Such affidavits showing that the person is an eligible voter are subject to the Kansas Open Records Act, K.S.A. 1984 Supp. 45-215 *et seq.*, and are not included under any of the provisions of K.S.A. 1984 Supp. 45-221 which allow certain records to be closed. They should therefore be disclosed, subject to the other provisions of the act. SUBSTATE RESOURCE DISTRIBUTION
FOR PROGRAM YEAR 1985

The State of Kansas, Department of Human Resources, Job Service has received preliminary planning estimates of resources for operation of its Program Year 1985. The preliminary figures given to Kansas by the Secretary of Labor total \$6,259,203. In compliance with federal regulations, Job Service is announcing the substate resource distribution plan. Resources will be distributed to the five service delivery areas (SDA) for field utilization by a resource allocation formula which includes demographic and productivity factors.

The formula utilizes five basic criteria:

- 1) Total population by Service Delivery Area (1980 census).
- 2) New applications and renewals by SDA.
- 3) Placements 150 days and over by SDA.
- 4) Placements under 150 days by SDA.
- 5) Obtained employment by SDA.

Items 2, 3, and 4 will be obtained from ESARS (Employment Security Automated Reporting System) Table A-22, and item 5 will be taken from the ESARS 22-B report. The formula will be computed each year in January and the data will be drawn only from the months of February, May, August and November of the preceding calendar year. For example, the formula that is computed in January, 1985 will be based on calendar year 1984 statistics and will be used in Program Year 1985.

The formula is divided into two parts. The first part is weighted as two-thirds (2/3) of the total formula, and is composed of the first two criteria; total population represents two-thirds of this part and new applications and renewals is weighted as one-third.

The second part of the formula is weighted as one-third (1/3) of the total formula, and is composed of the third, fourth and fifth criteria; placements 150 and over will be 70 percent of this part of the formula,

while placements under 150 days and obtained employment are each weighted 15 percent.

After computation is completed on each of the two parts the results will be combined utilizing the 2/3 and 1/3 weight of each of the two parts. This formula can be utilized to allocate or distribute any resources deemed necessary, such as positions or funding amounts.

Program Year 1985 preliminary distributions are as follows:

Equivalent Staff Positions

SDA II	33.75
SDA III	31.02
SDA IV	29.01
SDA V	20.51

Plans for the utilization of these resources are being developed in conjunction with the five service delivery area Private Industry Councils. These plans and the resource allocation formula criteria will be available for public review and comment after May 15, 1985.

Complaints on resource distribution will be reviewed by the area supervisor in the respective service delivery area within five working days of receipt. If the complaint cannot be resolved within the five day period, it will be forwarded to the Secretary of Human Resources. The Secretary of Human Resources will resolve the complaint within 10 working days of receipt. His decision will be final and not subject to appeal.

The following is a brief summary of the proposed amended regulation:

MOTOR CARRIER REGULATION

82-4-3. Amendment proposed to adopt 49 CFR 390.1 which defines the term "motor vehicle." The adoption of this section is proposed to clarify, for purposes of enforcement, the above mentioned term. The proposed amendment is a substantive change.

All amendments published in the *Federal Register* between September 28, 1984 and May 13, 1985, related to the federal regulations adopted by reference, effective May 1, 1985, and published in the *Kansas Register* April 18, 1985, are also being adopted as amended on the federal level.

- Public hearing regarding budget matters for FY 1986
- Present proposed community services block grant plan (60 day comment period)
- Present final social services block grant plan
- Public hearing concerning proposed temporary administrative regulations. A summary of the proposed regulations is set forth below. The proposed changes are scheduled to become effective on July 1, 1985.

A. Public Assistance.

1. **30-4-100. Payment standards for budgetary requirements in the ADC, ADC-FC, APW, GA and GA-FC programs.** This regulation is being amended to reflect that the \$6.00 increase for each person in the assistance plan set forth in K.A.R. 30-4-101 is not subject to being further reduced by 20% for the purpose of budgeting TGA and GAU cases.
2. **30-4-101. Standards for persons in own or other family home.** This regulation is being amended to reflect a \$6.00 increase for each person in the assistance plan in the public assistance standards for the purpose of being an energy supplement.
3. **30-4-102. Standards for persons in room, board, specialized living or care.** This regulation is being amended to:
 - a. Reflect a \$6.00 increase in the maximum amounts allowed for persons living in room only, board and room, or specialized living arrangements for the purpose of being an energy supplement; and
 - b. reflect a 15% increase in the foster family care standards.

B. Medicaid/Medikan Program—Provider Participation, Scope of Services, Reimbursement.

1. **30-5-81b. The basis for reimbursement for hospital services.** This regulation is being amended to add a premium to the reimbursement rate for inpatient general hospitals.

C. Medicaid/Medikan Program—Client Eligibility.

1. **30-6-55. Cooperation.** This regulation is being amended to require the applicant or recipient to cooperate with the agency in establishing the paternity of a child for whom assistance is claimed, and in obtaining medical support for

the applicant or recipient, and for the child for whom assistance is claimed. Failure to cooperate shall render the applicant or recipient ineligible for assistance unless the individual demonstrates good cause for the failure.

2. **30-6-63. Assignment of rights to medical support or other third party payments.** The Secretary is promulgating a new regulation to require that an applicant or recipient assign to the Secretary any accrued, present, or future rights to medical support or other third party payments the individual may have in his or her own behalf or in behalf of any other person for whom the applicant or recipient is applying for or receiving assistance.
3. **30-6-65. Automatic eligibles.** This regulation is being amended to require that in order to continue to be automatically eligible for medical assistance, an applicant or recipient must cooperate in obtaining any medical support for the applicant or recipient and for the child for whom assistance is claimed. Failure to cooperate shall render the applicant or recipient ineligible for medical assistance unless the individual demonstrates good cause for the failure. In addition, the applicant or recipient must assign to the Secretary any accrued, present, or future rights to medical support or other third party payments the individual may have in his or her own behalf or in behalf of any other person for whom the applicant or recipient is applying for or receiving assistance. Such assignment shall automatically become effective upon the date of approval for medical assistance.
4. **30-6-103. Determined eligibles; protected income levels.** This regulation is being amended to require that the protected income level for four or more persons be the sum of the basic standard (which includes the energy supplement) plus the maximum state shelter standard.

Presentations should be in writing whenever possible. Depending on the number of persons wanting to speak, the department may require that each participant limit his or her oral presentation to no more than three minutes.

HOUSE BILL No. 2622

AN ACT concerning educational institutions under the control and supervision of the state board of regents; relating to the organization and management of such institutions and the personnel policies thereof; amending K.S.A. 76-712 and 76-746 and repealing the existing sections.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 76-712 is hereby amended to read as follows: 76-712. *Except as otherwise provided by act of the legislature*, the state educational institutions are *separate* state agencies and state institutions and shall be controlled by, and operated and managed under the supervision of the board of regents. For such control, operation, management or supervision, the board of regents may make contracts and adopt orders, policies or rules and regulations and do or perform such other acts as are authorized by law or are appropriate for such purposes, *except that no state educational institution shall be combined or merged with any other state educational institution, for administrative or management or other purposes, except as specifically authorized by appropriations or other act of the legislature.*

Sec. 2. K.S.A. 76-746 is hereby amended to read as follows: 76-746. The state board of regents is hereby authorized to develop and implement a reduced-service program for faculty members of educational institutions under the control and supervision of the board in accordance with the provisions of this act. Subject to ~~policies and procedures~~ *rules and regulations* adopted by the state board of regents therefor, each educational institution may enter into reduced-service agreements under this section with officers and employees of the institution who are faculty members in the unclassified service under the Kansas civil service act and who are at least 60 years of age but who are under 65 years of age. *Such faculty members shall be eligible for participation in a reduced-service program during the academic year in which the faculty member becomes 60 years of age and until the end of the academic year in which the faculty member becomes 65 years of age.* Reduced-service agreements shall provide that the faculty member shall accept an appointment in a position which is less than the faculty member's current appointment but which is at least 1/4 time, and the educational institution shall pay on behalf of the faculty member (a) the amount specified by the Kansas state employees health care commission under K.S.A. 75-6508 *and amendments thereto* as if the faculty member is serving under a full-time appointment as an employee of the educational institution and participating in the state health care benefits program to provide for such participation of the faculty member, and (b) the amount required to assist in the purchase of retirement annuities under K.S.A. 74-4925 and amendments thereto as if the faculty member is serving under a full-time appointment as an employee of the educational institution, and (c) *the amount required as contributions under subsection (2) of K.S.A. 74-4927a and amendments thereto as if the faculty member is serving under a full-time appointment as an employee of the educational institution at the full-time equivalent salary. For each faculty member who has entered into a reduced-service agreement with an educational institution under this section and who is at least 60 years of age but who is under 65 years of age, the full-time equivalent salary, calculated as if the faculty member is serving under a full-time appointment as an employee of the educational institution, shall be utilized for the purposes of calculating all employer provided benefits, including but not limited to, compensation for accumulated sick leave, the insured death benefit and the insured disability benefit under K.S.A. 74-4927 and amendments thereto and calculating final average salary as defined in subsection (17) of K.S.A. 74-4902 and amendments thereto.*

Sec. 3. K.S.A. 76-712 and 76-746 are hereby repealed.

Sec. 4. This act shall take effect and be in force from and after its publication in the Kansas register.

HOUSE BILL No. 2133

AN ACT concerning the Kansas civil service act; relating to performance ratings of persons in the classified service thereunder; amending K.S.A. 75-2943 and 75-2949e and repealing the existing sections.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 75-2943 is hereby amended to read as follows: 75-2943. (1) (a) Appointing authorities shall give written notice to the director of personnel services of their intention to establish new positions and of the existence of any vacancy to be filled in any office or employment in the classified service; and the director shall certify from the list of ~~eligibles~~ *eligible persons* which is appropriate for the class of the position, the five (5) names at the head thereof and all names of ~~eligibles~~ *eligible persons* who have a score equal to that of the fifth eligible person. If fewer than five (5) names appear thereon, the appointing authority is not required to appoint from the eligible list, may assume joint recruiting authority, and may demand certification of a maximum of five (5) names. Examinations shall be conducted until such designated number of names are certified.

(2) (b) The appointing authority shall appoint on probation, with sole reference to merit and fitness, one of the said candidates, whose name is certified in the manner above set forth, to fill such vacancy. The provisions of this section shall not apply when the office or employment is among those ~~listed~~ *which are described* in K.S.A. 75-2945, and amendments thereto and for which competitive examinations are not required.

(3) (c) After consultation with appointing authorities and other supervising officials, the director shall establish, and from time to time amend, a system of ~~service~~ *performance* ratings which shall provide for general categories of performance levels and such other criteria as the director may prescribe for each class of positions in the classified service or for groups of classes. ~~Subject to~~ *In accordance with* K.S.A. 75-3706 and amendments thereto, the secretary of administration shall adopt rules and regulations in respect to such ~~service~~ *performance* ratings, and such ~~service~~ *performance* ratings shall be considered in determining the advisability of transfers, the promotion of an employee to a higher class, the questions of reduction or dismissal of any employee, increases and decreases in salary of an employee within the salary range established under this act, and in all other decisions relating to the status of employees. ~~Subject to~~ *In accordance with* K.S.A. 75-3706 and amendments thereto, the secretary of administration shall adopt rules and regulations prescribing the extent to which such ratings and the reports upon

which they are based shall be open to public inspection by the public and by the affected employees.

Sec. 2. K.S.A. 75-2949e is hereby amended to read as follows: 75-2949e. (a) Grounds for dismissal, demotion or suspension of a permanent employee for deficiencies in work performance include, but are not limited to, the following:

- (1) Inefficiency or incompetency in the performance of duties, or inability to perform the duties;
- (2) negligence in the performance of duties;
- (3) careless, negligent or improper use of state property;
- (4) failure to maintain satisfactory and harmonious relationships with the public and fellow employees;
- (5) habitual or ~~flagrant~~ *flagrantly* improper use of leave privileges;
- (6) a habitual pattern of failure to report for duty at the assigned time and place or to remain on duty; and
- (7) failure to obtain or maintain a current license or certificate or other authorization required to practice a trade, conduct a business or practice a profession.

(b) Unless the appointing authority determines that the good of the service will best be served by proceeding directly to the procedure prescribed in K.S.A. 75-2949, and amendments thereto, the appointing authority may propose dismissal, demotion or suspension of a permanent employee for deficiencies in work performance only after the employee has received two performance evaluations in the 90 180 calendar days immediately preceding the effective date of the proposed dismissal, demotion or suspension. These performance evaluations shall be spaced at least 30 calendar days apart. ~~The appointing authority may propose dismissal if the two evaluations were "unsatisfactory." The appointing authority may propose suspension or demotion if the two evaluations were "unsatisfactory" or "below standard."~~

(c) If the appointing authority proposes to dismiss, demote or suspend a permanent employee for deficiencies in work performance without the two evaluations described by subsection (b) and if the employee appeals the action to the state civil service board, the board shall require the appointing authority to show that the employee was adequately counseled concerning the nature of the deficiencies in work performance and concerning what was expected of the employee in correcting the deficiencies.

AN ACT concerning taxation of motor-vehicle fuels, special fuels and LP-gas fuels; amending K.S.A. 79-34,141 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 79-34,141 is hereby amended to read as follows: 79-34,141. (a) The director of taxation shall compute tax rates to the nearest cent per gallon on motor-vehicle fuels as provided in this section. ~~For the six-month period which begins at 12:01 a.m. on July 1, 1983, such rates shall be \$.01 less than each of the rates specified in subsection (d). For the eighteen-month period which begins at 12:01 a.m. on January 1, 1984, such rates shall be the rates specified in subsection (d). For the twelve-month periods commencing at 12:01 a.m. on July 1, 1985, and at 12:01 a.m. on July 1 of each year thereafter, the director shall compute such rate by multiplying 10% 10.5% times the unweighted average retail price per gallon of premium, regular and unleaded motor-vehicle fuels sold during the month of November of the calendar year preceding the July 1 that such period commences as reported in the monthly petroleum products price marketing monthly report as published by the energy information administration of the United States department of energy.~~

(b) The tax rate per gallon on special fuels shall be an amount equal to the then current tax rate per gallon computed for motor-vehicle fuels under the provisions of subsection (a) plus \$.02 per gallon.

(c) The tax rate per gallon on LP-gas motor-fuels shall be an amount equal to the then current tax rate per gallon computed for motor-vehicle fuels under the provisions of subsection (a) minus \$.01 per gallon.

(d) Notwithstanding the provisions of subsections (a) and (e), on and after January 1, 1984, the tax rates imposed under this act shall be not less than:

(1) On motor-vehicle fuels, \$.11 per gallon, or fraction thereof;

(2) on special fuels, \$.13 per gallon, or fraction thereof; and

(3) on LP-gas, \$.10 per gallon, or fraction thereof.

(e) The tax rate per gallon on motor-vehicle fuels for the twelve-month periods which begin on July 1, 1985, and on each July 1 thereafter shall not be more than \$.01 above nor less than \$.01 below the tax rate computed for the immediately preceding twelve-month period.

SENATE BILL No. 48

AN ACT concerning municipalities; authorizing governing bodies thereof to issue bonds for payment of the costs of removal or encapsulation of friable asbestos-containing material in public buildings and any remodeling, replacement or restoration costs thereof; conditions.

Be it enacted by the Legislature of the State of Kansas:

Section 1. (a) When the governing body of any municipality determines that friable asbestos-containing material exists in any of its buildings and that it is necessary to provide for the removal or encapsulation of such material, the governing body may issue and sell general obligation bonds of the municipality for payment of the costs of such removal or encapsulation and the costs of any remodeling, replacement or other restoration necessitated by such removal or encapsulation.

(b) No bonds shall be issued or sold under authority of this section until a resolution authorizing the issuance and sale of such bonds is adopted by the governing body and published once a week for two consecutive weeks in a newspaper having general circulation in the municipality. The resolution shall specify the purpose for which bonds are to be issued and the estimated amount thereof. After adoption of the resolution, the bonds may be issued and sold unless, within 30 days following the last publication of the resolution, a petition in opposition to issuance of the bonds, signed by not less than 10% of the qualified electors of the municipality, is filed with the governing body of the municipality. If a petition is filed, the bonds shall not be issued without the question of issuing the same having been submitted to and approved by a majority of the qualified electors of the municipality voting at an election which shall be called for that purpose or at the next general election. If a special election is called, the governing body shall give notice thereof in the manner prescribed in K.S.A. 10-120, and amendments thereto, and the election shall be held in accordance with the provisions of the general bond law. No action shall be brought in any court to contest the validity of any election held under this section, nor to contest any of the proceedings preliminary thereto, except within 90 days immediately following the certification of the results of the election.

(c) Bonds issued under authority of this section shall not be subject to any bonded indebtedness limitations nor shall the bonds be considered in determining the bonded indebtedness of any municipality. In lieu of bonds, temporary notes may be issued under K.S.A. 10-123, and amendments thereto, and the notes may, at the option of the governing body, be retired by tax levies made under K.S.A. 10-113, and amendments thereto.

(d) Prior to January 1, 1986, a municipality may request technical assistance from the secretary of health and environment in reviewing persons or business entities bidding on asbestos projects as defined by section 1 of 1985 Senate Bill No. 113 to determine if they are capable of complying with all applicable state or federal standards relating to asbestos projects.

(e) After January 1, 1986, no municipality shall accept a bid for the removal or encapsulation of friable asbestos-containing material from any person or business entity which does not hold a certificate or license issued by the secretary of health and environment and authorizing the person or business entity to engage in the removal or encapsulation of such material as provided by 1985 Senate Bill No. 113.

(f) The secretary of health and environment shall provide, upon request, technical assistance to municipalities in performing asbestos exposure assessments and in selecting appropriate asbestos abatement actions.

(g) When used in this act:

(1) "Municipality" means a municipality as defined by K.S.A. 10-1101, and amendments thereto;

(2) "governing body" means a governing body as defined by K.S.A. 10-1101, and amendments thereto; and

(3) "friable asbestos-containing material" means any material containing more than 1% asbestos by weight which is applied to ceilings, walls, structural members, piping, ductwork or any other part of a building and which, when dry, may be crumbled, pulverized or reduced to powder by hand pressure.

AN ACT concerning taxation of motor-vehicle fuels; amending K.S.A. 79-3408 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 79-3408 is hereby amended to read as follows: 79-3408. (a) From and after 12:01 a.m. July 1, 1984, a tax per gallon or fraction thereof, at the rate computed as prescribed in K.S.A. 79-34,141 and amendments thereto is hereby imposed on the use, sale, or delivery of all motor-vehicle fuels containing less than 10% agricultural ethyl alcohol by volume which is used, sold or delivered in this state for any purpose whatsoever.

(b) *Notwithstanding the provisions of subsection (d) of K.S.A. 79-34,141 and amendments thereto, from and after 12:01 a.m. on the effective date of this act a tax at the rate of \$.05 per gallon, or fraction thereof, less than that prescribed for motor-vehicle fuels under subsection (a) until July 1, 1985, and from and after July 1, 1984 1985, a tax of \$.06 at the rate of \$.04 per gallon, or fraction thereof, less than that prescribed for motor-vehicle fuels under subsection (a) until July 1, 1986, and from and after July 1, 1986, a tax at the rate of \$.03 per gallon, or fraction thereof, less than that prescribed for motor-vehicle fuels under subsection (a), until July 1, 1987, and from and after July 1, 1987, a tax at the rate of \$.02 per gallon, or fraction thereof, less than that prescribed for motor-vehicle fuels under subsection (a), is hereby imposed on the sale, use or delivery of all motor-vehicle fuels containing 10% or more of agricultural ethyl alcohol by volume, which is used, sold or delivered in this state for any purpose whatsoever. When the gross tax revenue generated under the motor fuels tax law from the sale in Kansas of motor-fuels containing agricultural ethyl alcohol equals \$5,000,000 less than the amount of revenue which would have been derived from the taxation of such motor fuel at the rate per gallon, or fraction thereof, prescribed for motor-vehicle fuels under subsection (a), commencing on the first day of the month next following 30 days thereafter, there shall be imposed a tax at the rate of \$.05 per gallon, or fraction thereof, less than that prescribed for motor-vehicle fuels under subsection (a).*

(continued)

(c) Every retail pump for motor-vehicle fuels shall be conspicuously labeled to show the content and percentage of any ethyl alcohol or other alcohol combined or alone in excess of 1% by volume.

(d) Such taxes shall be paid but once. Such tax shall be computed on all motor-vehicle fuels received by each distributor, manufacturer or importer in this state and paid in the manner provided for herein, except that an allowance of 2.5% of the first 1,000,000 gallons received during each calendar year and 2% of the total gallonage in excess of 1,000,000 gallons received during each calendar year shall be made and deducted by the distributor to cover all ordinary losses in handling such motor-vehicle fuels. No such allowance shall be made on any motor-vehicle fuel exported from the state or sold to the United States of America or any of its agencies or instrumentalities as are now or hereinafter exempt by law from liability to state taxation. A distributor shall not be entitled to such allowance unless the principal business in which such distributor is engaged is the business of marketing motor-vehicle fuels or petroleum products. No such allowance shall be made for any motor-vehicle fuel sold or disposed of to a consumer in tank car, transport or pipeline lots.

(e) No tax is hereby imposed upon or with respect to the following transactions:

(1) The sale or delivery of motor-vehicle fuel by a duly licensed distributor, manufacturer or importer to another duly licensed distributor, manufacturer or importer.

(2) The sale or delivery of motor-vehicle fuel for export from the state of Kansas to any other state or territory or to any foreign country.

(3) The sale or delivery of motor-vehicle fuel to the United States of America and such of its agencies as are now or hereafter exempt by law from liability to state taxation.

(4) The sale or delivery of motor-vehicle fuel to a contractor for use in performing work for the United States or those agencies of the United States above mentioned, provided such contractor has in effect with the United States or any such agency a cost-plus-a-fixed-fee contract covering the work.

(5) The sale or delivery of motor-vehicle fuel which is aviation fuel.

(f) Each distributor, manufacturer or importer shall make full reports and furnish such further information as the director may require with reference to all transactions upon which no tax is to be paid.

AN ACT concerning regulation of traffic; relating to the procedure for enforcement of municipal traffic laws; relating to ordinance traffic infractions; concerning sentencing for certain misdemeanor violations of traffic laws; amending K.S.A. 12-4516, as amended by section 13 of 1985 Senate Bill No. 127, and K.S.A. 1984 Supp. 8-2110, 12-4212, 12-4305, as amended by section 10 of 1985 Senate Bill No. 127, and K.S.A. 1984 Supp. 8-262, as amended by section 1 of 1985 Senate Bill No. 127, and repealing the existing sections.

Be it enacted by the Legislature of the State of Kansas:

New Section 1. (a) When a person is charged with an ordinance traffic infraction, the notice to appear shall provide a place where the person may make a written entry of appearance, waive the right to a trial and plead guilty or no contest. The notice to appear shall provide a space in which the law enforcement officer, except as provided in subsection (b), shall enter the appropriate fine specified in the fine schedule established by the municipal judge in accordance with K.S.A. 12-4305 and amendments thereto. Either the notice to appear or a separate form provided to the person by the law enforcement officer shall provide an explanation of the person's right to appear and right to trial, the person's right to pay the appropriate fine prior to the appearance date, and that failure to either pay such fine or appear at the specified time may result in the suspension of the person's driver's license or issuance of a warrant for the person's arrest. The law enforcement officer shall provide the person with the telephone number and address of the municipal court to which the written entry of appearance, waiver of trial, plea of guilty or no contest and payment of fine shall be mailed.

(b) In lieu of the law enforcement officer entering the appropriate fine for an ordinance traffic infraction, the officer may direct the person charged with an ordinance traffic infraction to contact the clerk of the municipal court to determine the applicable fine or provide the person with a copy of the fine schedule established by the municipal judge in accordance with K.S.A. 12-4305 and amendments thereto.

(c) This section shall be a part of and supplemental to the provisions of article 42 of chapter 12 of the Kansas Statutes Annotated and acts amendatory thereof or supplemental thereto.

Sec. 2. K.S.A. 1984 Supp. 8-2110 is hereby amended to read as follows: 8-2110. (a) Failure to comply with a traffic citation means failure either to (1) appear at before any district or municipal court in response to a traffic citation and pay in full any fine and court costs imposed or (2) otherwise comply with a traffic citation as provided in K.S.A. 1984 Supp. 8-2118 and amendments thereto. Failure to comply with a traffic citation is a misdemeanor, regardless of the disposition of the charge for which such citation was originally issued.

(b) In addition to penalties of law applicable under subsection (a), when a person fails to comply with a traffic citation, except for illegal parking, standing or stopping, the district or municipal court in which the person should have complied with the citation shall inform the division of vehicles of the failure to comply and mail notice to the person that if the person does not appear in district or municipal court or pay all fines, court costs and any penalties within 30 days from the date of mailing, the division of vehicles will be notified to suspend the person's driving privileges. Upon the person's failure to comply within such 30 days, the district or municipal court shall notify the division of vehicles. Upon receipt of a report of a failure to comply with a traffic citation under this subsection, pursuant to K.S.A. 8-255, and amendments thereto, the division of vehicles shall notify the violator and suspend the license of the violator until satisfactory evidence of compliance with the terms of the traffic citation has been furnished the informing court. Upon such compliance the informing court shall notify the division of vehicles and the suspension or suspension action shall be terminated.

(c) When the district or municipal court notifies the division of vehicles of a failure to comply with a traffic citation pursuant to subsection (b), the court shall assess a reinstatement fee of \$25 for each charge on which the person failed to make satisfaction regardless of the disposition of the charge for which such citation was originally issued. Such reinstatement fee shall be in addition to any fine, district or municipal court costs and other penalties. The court shall, at least monthly, remit all reinstatement fees to the state treasurer who shall credit such moneys to the motor vehicle operating fund.

Sec. 3. K.S.A. 1984 Supp. 12-4212 is hereby amended to read as follows: 12-4212. (a) Except as provided in subsection (b), a law enforcement officer may arrest a person under any of the following circumstances:

(1) The officer has a warrant commanding that the person be arrested.

(2) A warrant for the person's arrest has been issued by a municipal court in this state.

(3) The officer has probable cause to believe that the person is committing or has committed a violation of an ordinance and that the person has intentionally inflicted bodily harm to another person.

(4) The law enforcement officer detained the person pursuant to subsection (c) or (d) of K.S.A. 12-4211 and amendments thereto and:

(A) The person refuses to give a written promise to appear in court when served with a notice to appear;

(B) the person is unable to provide identification of self by presenting a valid driver's license or other identification giving equivalent information to the law enforcement officer;

(C) the person is not a resident of the state of Kansas; or

(D) the law enforcement officer has probable cause to believe that the person may cause injury to self or others or may damage property unless immediately arrested.

(b) A law enforcement officer may not arrest a person who is charged only with committing an ordinance traffic infraction unless the person charged has received service of a notice to appear and has failed to appear for the ordinance traffic infraction.

Sec. 4. K.S.A. 1984 Supp. 12-4305, as amended by section 10 of 1985 Senate Bill No. 127, is hereby amended to read as follows: 12-4305. The municipal judge shall establish a schedule of fines which shall be imposed for municipal ordinance violations that are classified as ordinance traffic infractions. Also, the municipal judge may establish a schedule of fines which shall be imposed for the violation of certain other ordinances. Such fines shall be imposed upon a voluntary entry of appearance and upon a plea of guilty or no contest to a complaint alleging such violation. Any fine so established shall be within the minimum and maximum allowable fines established by ordinance for such offenses by the governing body. The following traffic violations are specifically excluded from any schedule of fines:

(a) Reckless driving;

(b) driving while under the influence of alcohol or drugs, or both, or driving with a blood or breath alcohol concentration of .10 or more;

(c) driving without a valid license issued or on a canceled, suspended or revoked license; or

(d) offenses arising from a motor vehicle collision or accident fleeing or attempting to elude a police officer; or

(e) offense comparable to those prescribed by K.S.A. 8-1602, 8-1603 and 8-1604 and amendments thereto.

The municipal judge may authorize the clerk of the municipal court or some other person to accept such voluntary appearance by mail or in person, plea of guilty or no contest and payment of the fine imposed by the schedule. Payment may be made by mail or in person and may be by personal check. The complaint shall not have been complied with if a check is not honored for any reason, or the fine is not paid in full prior to the time specified in the notice to appear. When a person charged with an ordinance traffic infraction or other ordinance violation on a schedule of fines makes payment by mail without executing a written waiver of right to trial and plea of guilty or no contest, the payment shall

be deemed such an appearance, waiver of right to trial and plea of no contest.

The schedule of fines and persons authorized to accept such pleas shall be conspicuously displayed in the office where such voluntary appearance, plea of guilty and payment of fine occurs.

Sec. 5. K.S.A. 12-4516, as amended by section 13 of 1985 Senate Bill No. 127, is hereby amended to read as follows: 12-4516. (a) Except as provided in subsection (b), any person who has been convicted of a violation of a city ordinance of this state may petition the convicting court for the expungement of such conviction if three or more years have elapsed since the person:

(1) Satisfied the sentence imposed; or

(2) was discharged from probation, parole or a suspended sentence.

(b) No person may petition for expungement until five or more years have elapsed since the person satisfied the sentence imposed or was discharged from probation, parole, conditional release or a suspended sentence, if such person was convicted of the violation of a city ordinance which would also constitute:

(1) Vehicular homicide, as defined by K.S.A. 21-3405 and amendments thereto;

(2) a violation of K.S.A. 8-1567 and amendments thereto;

(3) driving while the privilege to operate a motor vehicle on the public highways of this state has been cancelled, suspended or revoked, as prohibited by K.S.A. 8-262 and amendments thereto;

(4) perjury resulting from a violation of K.S.A. 8-261a and amendments thereto;

(5) a violation of the provisions of the fifth clause of K.S.A. 8-142 and amendments thereto, relating to fraudulent applications;

(6) any crime punishable as a felony wherein a motor vehicle was used in the perpetration of such crime;

(7) failing to stop at the scene of an accident and perform the duties required by K.S.A. 8-1602, 8-1603 or 8-1604 and amendments thereto; or

(8) a violation of the provisions of K.S.A. 40-3104 and amendments thereto, relating to motor vehicle liability insurance coverage.

(c) When a petition for expungement is filed, the court shall set a date for a hearing thereon and shall give notice thereof to the prosecuting attorney. The petition shall state: (1) The defendant's full name; (2) the full name of the defendant at the time of arrest and conviction, if different than the defendant's current name; (3) the defendant's sex, race, and date of birth; (4) the crime for which the defendant was convicted; (5) the date of the defendant's conviction; and (6) the identity of the convicting court. A municipal court may prescribe a fee to be charged as costs for a person petitioning for an order of expungement pursuant to this section. Any person who may have relevant information about the petitioner may testify at the hearing. The court may inquire into the background of the petitioner and shall have access to any reports or records relating to the petitioner that are on file with the secretary of corrections or the Kansas adult authority.

(d) At the hearing on the petition, the court shall order the petitioner's conviction expunged if the court finds:

(1) That the petitioner has not been convicted of a felony in the past two years and no proceeding involving any such crime is presently pending or being instituted against the petitioner;

(2) that the circumstances and behavior of the petitioner warrant the expungement; and

(3) that the expungement is consistent with the public welfare.

(e) When the court has ordered a conviction expunged, the order of expungement shall state the information required to be contained in the petition. The clerk of the court shall send a certified copy of the order of expungement to the federal bureau of investigation, the Kansas bureau of investigation, the secretary of corrections and any other criminal justice agency which may have a record of the conviction. After the order of expungement is entered, the petitioner shall be treated as not having been convicted of the crime, except that:

(continued)

(1) Upon conviction for any subsequent crime, the conviction that was expunged may be considered as a prior conviction in determining the sentence to be imposed;

(2) the petitioner shall disclose that the conviction occurred if asked about previous convictions (A) in any application for employment as a detective with a private detective agency, as defined by K.S.A. 75-7b01 and amendments thereto; as security personnel with a private patrol operator, as defined by K.S.A. 75-7b01 and amendments thereto; with a criminal justice agency, as defined by K.S.A. 22-4701 and amendments thereto; or with an institution, as defined in K.S.A. 76-12a01 and amendments thereto, of the department of social and rehabilitation services; or (B) in any application for admission, or for an order of reinstatement, to the practice of law in this state;

(3) the court, in the order of expungement, may specify other circumstances under which the conviction is to be disclosed; and

(4) the conviction may be disclosed in a subsequent prosecution for an offense which requires as an element of such offense a prior conviction of the type expunged.

(f) Whenever a person is convicted of an ordinance violation, pleads guilty and pays a fine for such a violation or is placed on parole or probation or is given a suspended sentence for such a violation, the person shall be informed of the ability to expunge the conviction.

(g) Subject to the disclosures required pursuant to subsection (e), in any application for employment, license or other civil right or privilege, or any appearance as a witness, a person whose conviction of an offense has been expunged under this statute may state that such person has never been convicted of such offense.

(h) Whenever the record of any conviction has been expunged under the provisions of this section or under the provisions of any other existing or former statute, the custodian of the records of arrest, conviction and incarceration relating to that crime shall not disclose the existence of such records, except when requested by:

(1) The person whose record was expunged;

(2) a criminal justice agency, private detective agency or a private patrol operator, and the request is accompanied by a statement that the request is being made in conjunction with an application for employment with such agency or operator by the person whose record has been expunged;

(3) a court, upon a showing of a subsequent conviction of the person whose record has been expunged;

(4) the secretary of social and rehabilitation services, or a designee of the secretary, for the purpose of obtaining information relating to employment in an institution, as defined in K.S.A. 76-12a01 and amendments thereto, of the department of social and rehabilitation services of any person whose record has been expunged;

(5) a person entitled to such information pursuant to the terms of the expungement order;

(6) a prosecuting attorney, and such request is accompanied by a statement that the request is being made in conjunction with a prosecution of an offense that requires a prior conviction as one of the elements of such offense; or

(7) the supreme court, the clerk or disciplinary administrator thereof, the state board for admission of attorneys or the state board for discipline of attorneys, and the request is accompanied by a statement that the request is being made in conjunction with an application for admission, or for an order of reinstatement, to the practice of law in this state by the person whose record has been expunged.

Sec. 6. K.S.A. 1984 Supp. 8-262, as amended by section 1 of 1985 Senate Bill No. 127, is hereby amended to read as follows: 8-262. (a) (1) Any person who drives a motor vehicle on any highway of this state at a time when such person's privilege so to do is canceled, suspended or revoked shall be guilty of a class B misdemeanor on the first conviction, a class A misdemeanor on the second conviction and for third and subsequent convictions shall be guilty of a class E felony.

(2) No person shall be convicted under this section if such person was entitled at the time of arrest under K.S.A. 8-257 and amendments thereto, to the return of such person's driver's

license or was, at the time of arrest, eligible under K.S.A. 8-256 and amendments thereto, to apply for a new license to operate a motor vehicle.

(3) Except as otherwise provided by subsection (a)(4), every person convicted under this section shall be sentenced to at least five days' imprisonment and fined at least \$100 and upon a second or subsequent conviction shall not be eligible for parole until completion of five days' imprisonment.

(4) If a person (A) is convicted of a violation of this section, committed while the person's privilege to drive was suspended or revoked for a violation of K.S.A. 8-1567 and amendments thereto or under a municipal ordinance or any ordinance of any city or a law of another state, which ordinance or law prohibits the acts prohibited by that statute, and (B) is or has been also convicted of a violation of K.S.A. 8-1567 and amendments thereto or of a municipal ordinance or law of another state, which ordinance or law prohibits the acts prohibited by that statute, committed while the person's privilege to drive was so suspended or revoked, the person shall not be eligible for suspension of sentence, probation or parole until the person has served at least 90 days' imprisonment, and any fine imposed on such person shall be in addition to such a term of imprisonment.

(b) The division upon receiving a record of the conviction of any person under this section or any ordinance of any city or a law of another state which is in substantial conformity with this section, upon a charge of driving a vehicle while the license of such person is suspended for a specifically designated period, shall extend the period of such suspension for an additional like period, and if the conviction is upon a charge of driving while a license is revoked the division shall not issue a new license for an additional period of six months from and after the date such person would otherwise have been entitled to apply for a new license.

(c) For the purposes of determining whether a conviction is a first, second, third or subsequent conviction in sentencing under this section, "conviction" includes a conviction of a violation of any ordinance of any city or a law of another state which is in substantial conformity with this section.

Sec. 7. K.S.A. 12-4516, as amended by section 13 of 1985 Senate Bill No. 127, and K.S.A. 1984 Supp. 8-2110, 12-4212, 12-4305, as amended by section 10 of 1985 Senate Bill No. 127, and K.S.A. 1984 Supp. 8-262, as amended by section 1 of 1985 Senate Bill No. 127, are hereby repealed.

Sec. 8. This act shall take effect and be in force from and after its publication in the Kansas register.

SENATE BILL No. 379

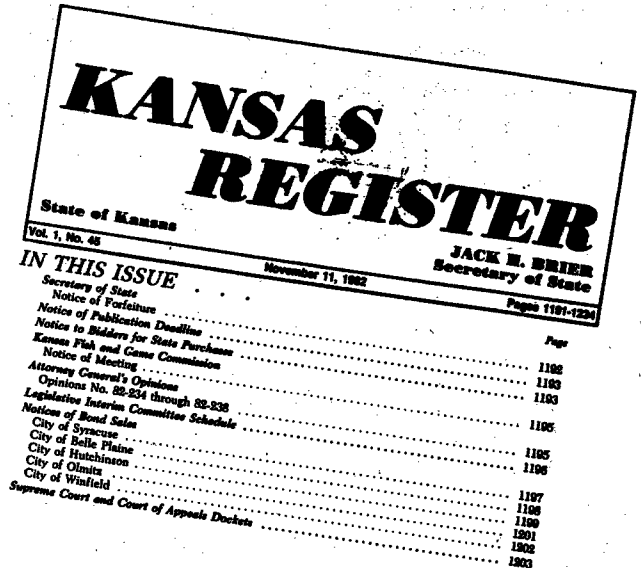
