Opinion No. 85-68

Automobiles and Other Vehicles—Driving Under Influence of Alcohol and Other Drugs—Alcohol and Drug Safety Action Fund; Under Control of Municipal Court. Robert A. Thiessen, Administrative Judge for the Municipal Court, City of Wichita, Wichita, June 24, 1985.

K.S.A. 1984 Supp. 8-1008, as amended by 1985 House Bill No. 2614, creates an alcohol and drug safety action fund in each court which enforces the provisions of K.S.A. 1984 Supp. 8-1567 or a municipal ordinance which is patterned after that statute. In the case of a municipal court, the fund is not subject to the provisions of the Cash Basis Law, K.S.A. 10-1101 *et seq.*, or the Budget Law, K.S.A. 79-2925 *et seq.*, even though the court is a department of a city which is subject to the two acts. Further, in that K.S.A. 1984 Supp. 8-1009(e), as amended, gives the administrative judge of the municipal court control of the fund in making the limited expenditures allowed by the statute, a city may not impose additional limits or requirements in regard to such fund. Opinion No. 85-69

Cities and Municipalities—Public Utilities—Waterworks, Fuel, Power and Lighting Plants; Use, Dispo-

sition and Investment of Revenues. Richard F. Hrdlicka, Hesston City Attorney, Newton, June 24, 1985.

The provisions of K.S.A. 12-825g and subsection (b) of K.S.A. 12-825d prescribe procedures for establishing a community and utility promotion fund in certain cities of the second class, and limit transfers of surplus utility revenues to such a fund. Although subsection (a) of K.S.A. 12-825d authorizes the transfer of surplus utility revenues to the city general fund or any other city fund, second class cities which have established a community and utility promotion fund under the provisions of subsection (b) of the statute must, in the absence of a charter ordinance providing otherwise, comply with the restrictions prescribed therein when making transfers of surplus utility revenues to the community and utility promotion fund. Cited herein: K.S.A. 12-825d, 12-825g. TRH

Opinion No. 85-70

Counties and County Officers—Hospitals—County Hospitals; Hospital Moneys; Lease and Management of Hospital Facility. Edward J. Gaschler, Scott County Attorney, Scott City, June 24, 1985.

Pursuant to K.S.A. 1984 Supp. 19-4611(a) and (d), the board of trustees of a county hospital may contract with a corporation for the lease and management of the facility. Under the terms of an agreement between the Scott County Hospital Board of Trustees and the Great Plains Health Alliance, Inc., an operating fund is maintained through the use of tax money derived from a county mill levy. Accordingly, such a fund contains "hospital moneys," as that term is defined by K.S.A. 1984 Supp. 19-4601(d). Under K.S.A. 1984 Supp. 19-4608(c), as amended, "hospital moneys" are deemed to be public moneys, and are subject to the pledging requirements of K.S.A. 1984 Supp. 9-1402, as amended. Therefore, moneys contained in the operating fund of Scott County Hospital are subject to the provisions of K.S.A. 1984 Supp. 9-1402 as amended. Article 7.—INSPECTIONS

67-7-4. Calibration of audiometric equipment. (a) Any audiometric equipment which is used in connection with the sale or fitting of hearing aids in this state shall be calibrated on or before December 31, 1985. Any audiometric equipment which is acquired, leased, or first used by a licensee after December 31, 1985 shall be calibrated within 30 days after the equipment is acquired, leased, or first used.

(b) Any audiometric equipment which is used in connection with the sale or fitting of hearing aids in this state shall be calibrated at intervals not exceeding two years.

(c) Each licensee shall submit to the board written proof of calibrations required in subsections (a) and (b) of this rule and regulation within 30 days of the required dates of calibration. Written proof of calibration shall include the name of the owner, the make, model and serial number of the equipment, the date of calibration, the printed name of the person and company calibrating the equipment, the signature of the person calibrating the equipment, and the signature of the licensee submitting proof of calibration.

(d) The board may suspend the license of any person or deny the license renewal or license application of any person if that person: (1) provides false or misleading information under this rule and regulation; (2) uses audiometric equipment which has not been calibrated as required by this rule and regulation; or

(3) uses audiometric equipment the calibration of which has not been reported as required by this rule and regulation.

(e) This rule and regulation shall take effect on and after July 1, 1985. (Authorized by and implementing K.S.A. 74-5806; effective, T-86-16, July 1, 1985.)

Article 6.—DEFINITIONS

20-6-1. Definitions. (a) "Advocacy" means acting, speaking, or writing on behalf of a victim or victims of domestic violence.

(b) "Crisis intervention" means to provide assistance to a person who is in danger of or experiencing domestic violence.

(c) "The board" means the crime victims reparations board.

(d) "Domestic violence" means all acts of emotional, physical, and sexual violence between spouses, parents, children, siblings, and other related persons; present and former cohabitants, ex-spouses, other members of the same household, including elderly and physically handicapped persons.

(e) "Education" means to provide information about domestic violence programs, services, or issues to specific groups or the public at large.

(f) "Emergency shelter" means residential care and protection for persons 18 years or older, children under 18 who are in the care or custody of adult victims; and emancipated minors.

(g) "Domestic violence program" means an agency, board or other administrative entity that provides or proposes to provide 24 hour crisis intervention services, shelter or safe house facilities, advocacy and referral services, and emergency transportation.

(h) "Fiscal year (FY)" means a 12 month period that begins on July 1, and ends on June 30.

(i) "Grantee agency" means a program or service that is available to victims of domestic violence and that is receiving funds from the board under K.S.A. 1984 Supp. 74-7325.

(j) "Grantor" means the board.

(k) "Referral" means directing a victim or victims of domestic violence to available resources for aid or information.

(l) "Safehouse" means a private residence, motel, or hotel used to provide 24-hour care to victims of domestic violence.

(m) "Service" means a specific activity providing assistance to victims of domestic violence.

(n) "Shelter" means a facility which provides 24-hour care for more than seven victims of domestic violence, including dependent children.

(o) "Therapeutic counseling" means professional guidance provided towards the goal of reducing the incidence of domestic violence and diminishing its impact on victims.

(p) "Victim" means a person in danger of or experiencing domestic violence. (Authorized by and implementing K.S.A. 1984 Supp. 74-7325; effective, T-85-27, Nov. 14, 1984; effective May 1, 1985; amended, T-86-14, June 17, 1985.)

Article 7.—FUNDING PRIORITIES

20-7-1. Domestic violence programs. The first funding priority shall be the administration and operation of the following services within domestic violence programs:

- (a) 24-hour crisis intervention;
- (b) shelter or safehouse facilities;
- (c) advocacy and referral for victims; and
- (d) emergency transportation. (Authorized by and implementing K.S.A. 1984 Supp. 74-7325; effective, T-85-27, Nov. 14, 1984; effective, May 1, 1985; amended, T-86-14, June 17, 1985.)

Article 8.—ELIGIBILITY REQUIREMENTS

20-8-3. Requirements for domestic violence programs. Each applicant agency that is a domestic violence program as defined by K.A.R. 20-7-1 shall have and make available to the board:

- (a) A document which defines organizational structure;
- (b) A statement of purpose;
- (c) A statement of client rights;
- (d) An affirmative action policy;
- (e) A governing authority that is representative of the community served and that oversees policy, finance, and general management decisions;
- (f) A policy and procedures manual; and
- (g) Liability and casualty insurance. (Authorized by and implementing K.S.A. 1984 Supp. 74-7325; effective, T-85-27, Nov. 14, 1984; effective May 1, 1985; amended, T-86-14, June 17, 1985.)

Article 9.—ALLOCATION OF FUNDING

20-9-1. Identification of program and service needs. A statewide domestic violence services needs assessment shall be conducted biennially to provide a basis for funding allocations in each priority area as defined in K.A.R. 20-7-1, 20-7-2, 20-7-3, and 20-7-4. This needs assessment shall provide a data base and analysis of reported incidents of domestic violence, requests for services, and a survey of available resources. (Authorized by and implementing K.S.A. 1984 Supp. 74-7325; effective, T-85-27, Nov. 14, 1984; effective May 1, 1985; amended, T-86-14, June 17, 1985.)

20-9-3. Funding allocations for FY 1985 and FY 1986. For FY 1985 and FY 1986, funds shall be available only to domestic violence programs, as defined in K.A.R. 20-7-1, that meet eligibility requirements specified in K.A.R. 20-8-1, 20-8-2, and 20-8-3. (Authorized by and implementing K.S.A. 1984 Supp. 74-

7325; effective, T-85-27, Nov. 14, 1985; effective May 1, 1985; amended, T-86-14, June 17, 1985.)

Article 11.—GRANT REVIEW AND APPEALS

20-11-1. Proposal review. Each grant proposal shall be evaluated using the following criteria:

- (a) The degree to which the proposal focuses on the problems of victims of domestic violence;
- (b) The adequacy of the needs documentation;
- (c) Past performance record, if available, relative to stated goals and objectives;
- (d) Adequacy of documentation of community support;
- (e) Adequacy of budget information;
- (f) Adequacy of the monitoring and evaluation component; and
- (g) Ability to utilize community resources. (Authorized by and implementing K.S.A. 1984 Supp. 74-7325; effective, T-85-27, Nov. 14, 1984; effective May 1, 1985; amended, T-86-14, June 17, 1985.)

Article 14.—GRANTOR MONITORING RESPONSIBILITIES

20-14-1. Program review. (a) The director of the board or the director's designee shall conduct an on-site visit to each grantee agency at least once biennially.

(b) The board shall review quarterly reports and onsite visit reports and make recommendations as needed.

(c) Technical assistance shall be provided to grantees as needed. (Authorized by and implementing K.S.A. 1984 Supp. 74-7325; effective, T-85-27, Nov. 14, 1984; effective May 1, 1985; amended, T-86-14, June 17, 1985.)

Article 3.—PILOT PROGRAM FOR EMT—DEFIBRILLATION

109-3-1. Application for certificate of authority to provide manual cardiac defibrillation or authorization to provide electrocardiographic monitoring. Each operator shall provide: (a) the name and address of the medical advisor and a letter from the medical advisor accepting the responsibilities prescribed by the university of Kansas school of medicine and K.A.R. 109-3-4;

(b) a listing of all personnel who have successfully completed the training program prescribed in K.A.R. 109-3-3 or 109-3-4;

(c) a description of the monitor or monitor/defibrillator prescribed in K.A.R. 109-3-2 or 109-3-4; and

(d) such other information as the director may determine is necessary to carry out the provisions of 1985 S.B. 81. This information shall be submitted on forms provided by the director. (Authorized by and implementing 1985 S.B. 81; effective, T-86-15, June 17, 1985.)

109-3-2. Certificate of authority to provide manual cardiac defibrillation. Each operator holding a certificate of authority shall: (a) have at least one licensed type II vehicle equipped with a monitor/defibrillator with two-channel cassette recording capability. Until expiration of the certificate of authority, the vehicle shall be staffed by qualified personnel as defined in K.A.R. 109-3-3 on a daily basis, 24 hours per day;

(b) use a cardiac arrest protocol prescribed by the university of Kansas school of medicine for each cardiac arrest patient;

(c) notify the director by telephone within 48 hours of each cardiac arrest event;

(d) submit a cardiac arrest report on forms provided by the director to the university of Kansas school of medicine within 14 days of each cardiac arrest event;

(e) submit a cassette recording of each cardiac arrest event to the university of Kansas school of medicine within 14 days of each cardiac arrest event;

(f) review and critique each cassette recording within 14 days of each cardiac arrest event for compliance with the protocol prescribed by the university of Kansas school of medicine;

(g) accept responsibility for sponsoring the training program and the monthly drills prescribed by K.A.R. 109-3-3. (Authorized by and implementing 1985 S.B. 81; effective, T-86-15, June 17, 1985.)

109-3-3. Qualified personnel. (a) An emergency medical technician or emergency medical technician-intermediate shall be considered "qualified personnel" as defined in 1985 S.B. 81 after successful completion of a 26-hour training program prescribed and

approved by the university of Kansas school of medicine and a written and practical examination prescribed and approved by the director. All "qualified personnel" shall participate in a monthly drill supervised by the medical advisor or the advisor's authorized representative. Any "qualified personnel" designation may be withdrawn at any time by the director. Such a designation shall automatically expire upon completion of the demonstration program.

(b) Only individuals listed on the staff roster of a service holding a certificate of authority as defined in 1985 S.B. 81 shall be designated as "qualified personnel." (Authorized by and implementing 1985 S.B. 81; effective, T-86-15, June 17, 1985.)

109-3-4. Authorization to perform electrocardiographic monitoring. Each operator authorized to provide electrocardiographic monitoring shall: (a) have at least one licensed type II vehicle equipped with a monitor with a strip recording capability. Until the expiration of the demonstration program, the vehicle shall be staffed on a daily basis, 24 hours per day, by emergency medical technicians or emergency medical technicians-intermediate who have completed a 5-hour program in cardiac monitoring prescribed and approved by the university of Kansas school of medicine;

(b) use a cardiac arrest protocol prescribed by the university of Kansas school of medicine for each cardiac arrest event;

(c) notify the director by telephone within 48 hours of each cardiac arrest event;

(d) submit a cardiac arrest report on forms provided by the director to the university of Kansas school of medicine within 14 days of each cardiac arrest event;

(e) submit a strip recording of each cardiac arrest event to the university of Kansas school of medicine within 14 days of each cardiac arrest event;

(f) accept responsibility for sponsoring the training program prescribed in this regulation. (Authorized by and implementing 1985 S.B. 81; effective, T-86-15, June 17, 1985.)

KANSAS PEOPLE ARE PROUD, STRONG AND INDUSTRIOUS

"The Kansas spirit is . . . one that finds something exhilarating in the challenge of an extreme difficulty."

—From "Kansas," an essay by Carl Becker, 1910.

The people of Kansas are one of the state's greatest assets. Kansas people are good, strong, industrious, and dedicated to the support of their beliefs. Kansas is in the section of the country which was once known as the "Great American Desert." The pioneers who came to Kansas and stayed were strong, hardy and persistent—necessary qualities for survival here in those days. Those characteristics are continued in the present population.

Since before Kansas became a state, Kansans have been humanitarians—good people, devoted to helping others. The very birth of the state was surrounded by controversy over Kansans' pursuit of a humanistic goal: the abolition of slavery. The territorial period of Kansas was characterized by constant struggle between abolitionists and pro-slavery forces. (Many of the latter were from out of state.) In the 1850's and 1860's an "underground railroad" existed in Kansas—the "railroad" consisted of groups of people who hid and aided escaped slaves.

The various abolitionist activities in Kansas made the state somewhat of a haven for Black Americans after the Civil War. A number of Blacks settled in the "Black" town of Nicodemus in western Kansas which in 1976 was designated a National Historic Landmark.

Kansas also led the nation in granting suffrage to women—the 1861 Legislature gave them the right to vote in school elections. In 1887 that right was extended to city and bond elections. In that same year a Kansas town, Argonia, chose as its mayor 27-year-old Susanna Madora Salter. She was the first woman mayor in the country.

The rights of women were recognized in the original Kansas Constitution, which guarantees women equal privileges with men in ownership of property and "control of children." This was a tremendous advance over the rights allowed women in the eastern states at that time. Universal suffrage in Kansas was granted by constitutional amendment in 1912. In 1972 Kansas was one of the first states to ratify the Equal Rights Amendment to the U.S. Constitution.

Over the years, many Kansans have gained national fame and made significant contributions to our society.

During the "cattle town" days in Kansas, several lawmen in the state gained national fame. James Butler "Wild Bill" Hickok was active in Kansas in the 1860's and 1870's, serving part of that time as city marshal in the cattle town of Abilene. Wyatt Earp served as a lawman in Wichita and Dodge City during the 1870's. "Bat" Masterson served during the same era as Sheriff of Ford County, where Dodge City is located. Tremendously popular in Dodge City, Masterson was often called back there to help settle disputes after he had left the area. He spent his last years as a sports writer for a New York City newspaper.

Among early Kansans to gain national attention was

Edmund G. Ross, a U.S. Senator from 1866-1871. Ross is remembered for his part in the impeachment trial of President Andrew Johnson. Ross, voting against the wishes of most other Republicans, cast his vote for Johnson's acquittal. The popular story that Ross' vote alone saved Johnson is said by historians to be exaggerated, since some other Republicans did vote for acquittal and some others might have done so if necessary. However, Ross' vote did occur at the right time in the roll call to provide the needed number of votes for acquittal. It is acknowledged that Ross acted with great personal courage in voting for Johnson. Ross was accused of being a traitor, and the incident virtually ended his political career in Kansas. Ross is one of the persons profiled in President John F. Kennedy's book *Profiles in Courage*.

U.S. Senator John J. Ingalls gained nationwide acclaim in the 1860's as an orator, though Kansans apparently found him to be a person they could not relate to—history records that he was not a "common" sort of man. This is illustrated by a verse written about Ingalls by Eugene F. Ware, a Kansas lawyer, newspaperman and poet who was known as "Ironquill," just after Ingalls lost his Senate seat to William A. Peffer, a Populist.

"Up was he stuck
and in the upness of his stuckitude
He fell."

Around the turn of the century, Mrs. Carry Nation became nationally known as a symbol of the temperance movement. She is best known for destroying illegal saloons with her famous hatchets.

William Allen White, editor and publisher of the *Emporia Gazette*, is the most famous of the many journalists who helped to shape the future in Kansas. More newspapers were published in Kansas between 1854 and 1936 than in any other state. Kansas journalists have always been highly opinionated, serving as champions for that in which they believe. Early-day Kansas newspaper editors were dubbed "Pistol-Packin' Pencil Pushers."

Kansan Ben Hibbs was editor of the *Saturday Evening Post* from 1942-1961, during which time he modernized the magazine's style and broadened its scope. He was Senior Editor of *Reader's Digest* from 1962-1972.

Well-known artists from Kansas include Henry Worrall of Topeka who did portraits and Kansas landscapes during the 1860's. He was known for his contributions to popular magazines of the day. John Steuart Curry of Jefferson County was another well-known Kansas artist. He was a leader in the movement for "realistic regionalism" along with Grant Wood and Thomas Hart Benton. Among Curry's works are several murals in the Kansas Capitol. Artist Sven Birger Sandzen came to the United States from Sweden in 1894 to teach at Bethany College in Lindsborg. A museum there honors him. A contemporary artist, Rudolph Wendelin, is a native of Rawlins County. He is best known as the "caretaker" of the Smokey Bear image—as a U.S. Forest Service artist, Wendelin has drawn Smokey numerous times and approves com-

mercial versions of Smokey. Wendelin, now retired, has numerous artistic talents and has done a historical mural for Rawlins County.

Kansas has produced a President of the United States, a Vice President, and unsuccessful major party nominees for both positions. **Dwight D. Eisenhower**, who was raised in Abilene, was Commander-in-Chief of the Allied Armies in Europe during World War II and President of the U.S. from 1953-61. He is buried in Abilene. **Charles Curtis** of Topeka, a U.S. Senator from Kansas for many years, was Vice-President of the U.S. under Herbert Hoover.

Alf Landon, Governor of Kansas from 1933-1937, was the Republican Presidential nominee in 1936. **Senator Bob Dole** was the Republican candidate for Vice-President in 1976.

Industrialist **Walter P. Chrysler**, who established the Chrysler Corporation in 1925, was born at Wamego and grew up in Ellis.

Clyde Tombaugh, Burdette, discovered the planet Pluto in 1930.

Noted black American **George Washington Carver**, called the "foremost agricultural scientist of the age," lived in Kansas during his youth and homesteaded in Ness County for a time.

Aviatrix **Amelia Earhart** of Atchison was the first woman granted a pilot's license by the National Aeronautics Association and the first woman to fly solo across the Atlantic Ocean. She disappeared during her 1937 attempt to fly around the world.

Several other Kansas women have achieved important "firsts." **Lucy Hobbs Taylor**, the first fully-trained woman dentist in the world, practiced dentistry in Lawrence from 1867 to 1907. **Lutie Lytle**, Topeka, was the first black woman to be admitted to the practice of law in the U.S. (1897). **Nellie Cline** of Larned was the first woman lawyer to appear before the U.S. Supreme Court, April 4, 1918. Novelist **Margaret Hill McCarter** was the first woman to address a Republican National Convention (1920). A Topeka banker and business woman, **Mrs. Georgia Neese Clark Gray**, was the first woman appointed as Treasurer of the U.S. She served in that position from 1949-53. In 1978 Kansas elected its first woman U.S. Senator: **Nancy Landon Kassebaum**. She is the first woman from any state to be elected in her own right to a full term in the Senate. Other women have served in the Senate, but all were either appointed to succeed their husbands, or were elected following their appointments to fill unexpired terms. Senator Kassebaum is the daughter of Presidential nominee Alf Landon.

Two Kansas women have been named Miss America. **Deborah Bryant** of Overland Park was selected in 1966, and **Debra Barnes**, Moran, was Miss America 1968.

A number of fine athletes have come from this state, and Kansas is particularly noted for its excellent runners. In the 1930's **Glenn Cunningham** of Elkhart held the world record in the mile run. Another Kansan, **Archie San Romani**, was Cunningham's teammate in the 1936 Olympics. Romani beat Cunningham in the 1937 and 1938 Kansas Relays. **Jim Ryun** of Wichita held the world record in the mile run during the

1960's. In boxing, **Jess Willard** of Emmett was the world heavyweight champion during the World War I era. One of major league baseball's greatest right-handed pitchers and a member of the Baseball Hall of Fame, **Walter "Big Train" Johnson**, was a native of Humboldt.

Earl Sutherland, who was born in Burlingame, won the Nobel Prize for physiology and medicine in 1971.

Four individual Pulitzer Prize winners have been Kansans. In 1923, famed Kansas journalist **William Allen White** was awarded a Pulitzer for his editorial "To an Anxious Friend." **William Inge**, a native of Independence, was a Pulitzer winning playwright. He wrote "Picnic," "Bus Stop," and "Come Back, Little Sheba." **Gordon Parks**, born at Fort Scott, is a world-renowned photographer, writer and motion picture producer, and won the 1973 Pulitzer Prize in photography. Parks wrote the books *The Learning Tree* and *A Choice of Weapons*, and he directed the movie "Shaft." **Brian Lanker**, a photographer for the *Topeka Capital-Journal*, also won a Pulitzer Prize for photography in 1973. As an organization, the *Hutchinson News* received a Pulitzer Prize in 1965 for its role in getting reapportionment of state legislative districts in Kansas.

Astronaut **Ron Evans**, commander of the pilot ship during the flight of Apollo 17 to the moon, was born in St. Francis and is a graduate of Topeka public schools and the University of Kansas.

Emmett Kelly, who became famous as the clown "Weary Willie," was born in Sedan. There is a museum there named in his honor.

General Bernard W. Rogers of Fairview is now serving as commander of the NATO forces in Europe. Another military leader from Kansas was **General Lewis Walt** of Wabaunsee County, former assistant commandant of the U.S. Marine Corps. **Col. Frank E. Petersen**, a native of Topeka, recently became the first black brigadier general in the history of the Marine Corps.

Actor **Edward Asner** ("Lou Grant") is from the Kansas City, Kansas, area, and actress **Vera Miles** spent her childhood in Wichita. **Milburn Stone**, who played Doc on "Gunsmoke," grew up in Kansas. Stone's characterization of "Doc" was patterned after his own country-doctor grandfather.

The **Menninger** family of Topeka founded and operates the world-famous Menninger Foundation mental health facility.

Lefthanders International, an association of lefthanded people, was founded by a Kansan and has its headquarters in Topeka.

Author **Alex Haley** of *Roots* fame has indirect ties to Kansas. His brother, George, lived in Kansas City and was a Kansas State Senator from 1965-1968. Haley's cousin, **Georgia Anderson**, lived in Kansas City for several years until her death. She was instrumental in Haley's research for *Roots*, filling in details of the family story which had been handed down. Mrs. Anderson's assistance is acknowledged by Haley in *Roots*.
