**NOTICE OF MEETING
AND HEARING ON PROPOSED
ADMINISTRATIVE REGULATIONS**

The Department of Social and Rehabilitation Services will conduct an open meeting at 9 a.m., August 6, 1985, in the Staff Development Training Center, 2700 W. 6th, Topeka.

The scheduled agenda for the meeting includes:

- Report of general conclusions related to FY 1986 and 1987 budget.
- Adopt community services block grant plan.
- Public hearing concerning proposed temporary administrative regulations. A summary of the proposed regulations is set forth below. The secretary intends to adopt the proposed regulations to become effective on a temporary basis when approved by the State Rules and Regulations Board.

A. Licensing of Psychiatric Hospitals and Community Mental Health Centers; Funding of Community Mental Health Centers and Facilities for the Mentally Retarded and Facilities for Handicapped Persons.

1. 30-22-10. Application for state financing. This regulation is being amended to enable the secretary to distribute state aid to the centers based on audited eligible income reported for the second preceding fiscal year. The audits used for this purpose shall be those conducted by auditors of the department.

B. Support Enforcement.

1. 30-44-1. Fees for support enforcement and establishment services rendered to persons not receiv-

ing aid to families with dependent children. This regulation is being revoked.

A copy of the proposed regulations and fiscal impact statement may be obtained prior to August 6, 1985 by contacting Mary Slaybaugh, Legal Division, State Department of Social and Rehabilitation Services, 6th Floor, State Office Building, Topeka, KS 66612, (913) 296-3969. Written comments may be submitted prior to such date. Such comments should be forwarded to Dr. Harder, Secretary of Social and Rehabilitation Services, 6th Floor, State Office Building, Topeka, KS 66612.

Interested persons will be given reasonable opportunity at the hearing to present their views and arguments on the adoption of the proposed temporary regulations. Presentations should be in writing whenever possible. Depending on the number of persons wanting to speak, the department may require that each participant limit his or her oral presentation to no more than three minutes.

—Adoption of proposed temporary administrative regulations.

The public is invited to this meeting. Opinion No. 85-76

Automobiles and Other Vehicles—Act Regulating Traffic; Arrest and Issuance of Citations—Failure to Comply With Citation; Suspension of License; Reinstatement Fee. Howard Schwartz, Judicial Administrator, Topeka, July 5, 1985.

As amended by chapter 78 of the 1985 *Session Laws*, K.S.A. 1984 Supp. 8-2110 provides that a district or a municipal court shall inform the division of vehicles of the Kansas Department of Revenue of any person who fails to appear following the issuance of a traffic citation. Upon receipt of such a report, the division shall suspend the license of the violator until notified of compliance by the court. The court shall also assess a reinstatement fee of \$25 for each charge on which the person failed to make satisfaction, with such fee in addition to any fine, costs or penalties which may be imposed. If a traffic citation contains more than one charge, the \$25 fee should be assessed on each of the charges, with the word "charge" being equivalent to "count." Cited herein: K.S.A. 1984 Supp. 8-2110, as amended by L. 1985, ch. 78. JSS

Opinion No. 85-77

Corporations—Foreign Corporations—"Doing Business" in Kansas; Actions Sufficient to Constitute; Corporation as Member of Partnership. Jack H. Brier, Secretary of State, Topeka, July 8, 1985.

A corporation which is a partner in a general or limited partnership is not, in the absence of any further action, "doing business" in this state so as to require compliance with the provisions of K.S.A. 17-7301 *et seq.*, even though the partnership itself is authorized to do business in Kansas. However, if the corporation uses the partnership as a means of conducting its own business, it may be "doing business" as defined in K.S.A. 17-7303 and so be required to comply. Cited herein: K.S.A. 17-1703, 60-308. JSS

Opinion No. 85-78

State Departments; Public Officers, Employees—De-

partment of Social and Rehabilitation Services—Licensing of Social Workers; Limitations on Private Practice of Social Work. Representative Dale M. Sprague, Seventy-third District, McPherson, July 8, 1985.

K.S.A. 75-5353 prohibits a person from engaging in the private practice of social work [as that term is defined by K.A.R. 1984 Supp. 102-2-1(b)] unless he or she is a licensed master social worker and has had two years experience. As adoption assessments under K.S.A. 59-2278(c) as amended are to be performed by a "licensed" social worker, such assessments could be made either by a social worker in private practice under K.S.A. 75-5353, or by a social worker employed by the court or another employer. If the latter situation exists, the social worker is not self-employed and does not have to meet the requirements of K.S.A. 75-5353. Cited herein: K.S.A. 59-2278, as amended by 1985 Senate Bill No. 69; 75-5347; 75-5351; 75-5353; K.A.R. 1984 Supp. 102-2-1. JSS

Opinion No. 85-79

Cities and Municipalities—General Provisions—Tax Upon Gross Earnings Derived from Money, Notes and Other Evidence of Debt. Michael A. Ireland, Jackson County Attorney, Holton, July 8, 1985.

Where voters approve elimination of intangibles tax at a referendum held pursuant to subsection (e) of K.S.A. 1984 Supp. 12-1,101, as amended, a city governing body must enact an ordinance eliminating the tax. However, under the provisions of the statute, the governing body may subsequently overturn the results of the referendum and reimpose the tax through the passage of a new ordinance. Cited herein: K.S.A. 1984 Supp. 12-1,101 (as amended by 1985 House Bill No. 2347), K.S.A. 60-802. TRH

Opinion No. 85-80

Elections—Conduct of Elections; Mail Ballot Election Act—Voting by Electors; Statute Prohibiting Electioneering Inapplicable. Jack H. Brier, Secretary of State, Topeka, July 8, 1985.

Elections conducted pursuant to the Mail Ballot Election Act, K.S.A. 1984 Supp. 25-431 *et seq.*, are subject to general election laws to the extent that such laws are applicable. In that there are no designated polling or voting places in a mail ballot election, K.S.A. 25-2430, which prohibits electioneering at such locations, does not apply to mail ballot elections. Accordingly, advertising of views in support of or in opposition to the Sedgwick County sales tax proposal does not have to be discontinued for the 20 day period in which mail ballots are in circulation. Cited herein: K.S.A. 1984 Supp. 25-432; 25-433; 25-438; 25-439; K.S.A. 25-2430; 25-2703; 25-2810. JSS

Kansas Small Cities Community Development Block
Grant Program
July, 1985

Purpose

This Final Statement of Community Development Objectives and Projected Use of Funds concerns the 1985 distribution of approximately \$16.9 million in Community Development Block Grant (CDBG) funds from the U.S. Department of Housing and Urban Development (HUD) as authorized under the Housing and Community Development Act of 1974, as amended through the Housing and Urban-Rural Recovery Act of 1984 (amended 1974 HCD Act). As the designated state administering agency in Kansas, the Kansas Department of Economic Development (KDED) will distribute the CDBG funds to units of general local government (cities and counties) in non-entitlement areas of Kansas.

Use of Funds—1984 Program

In 1984, the first year KDED administered the CDBG program, a total of 435 grant applications were received. Approximately \$16.5 million was distributed among 82 grants awarded to 79 local governments and leveraged approximately \$40 million of non-CDBG funding.

In the 1984 state program, 62% of the funding was for public facility projects, 10% for housing rehabilitation projects, 27% for economic development projects, and 1% for projects to meet urgent community development needs.

In the Community Improvement portion of the 1984 Kansas program, 267 applications which met threshold

requirements were received of which 43 or 16.1% were funded. Applications were received from 213 cities with populations under 5,000; 34 or 15.9% were successful. Thirty-one applications were received from cities of over 5,000 population; 6 or 19.4% were successful. The remaining 23 applications were from counties; three or 13% were successful.

The Community Improvement grant projects included 42% water, 7% sewer, 7% street improvement, 4% housing rehabilitation, 28% combined projects and 12% miscellaneous (drainage, public building rehabilitation, etc.) projects.

The 13 Economic Development grant projects totaling \$4,476,000 in CDBG funds were awarded to create and/or retain 1744 jobs primarily for low and moderate income persons.

The State Discretionary category provided funding for planning, hazardous waste investigation, imminent threat, and other projects which were selected for contingency funding. Twenty-six project awards were made within this category totaling approximately \$1.6 million.

In relationship to the three broad national CDBG objectives for use of CDBG funds, the 1984 Kansas program fund distribution was 97.4% for LMI Benefit and 2.6% for urgent need.

Citizen Participation

Charles J. Schwartz, Secretary of the Kansas Department of Economic Development, appointed the Community Development Block Grant Advisory Task Force to advise the Department in the development of the 1985 CDBG Program. The 19 individuals appointed represented a balance between elected and appointed local and state officials and community development professionals who had worked with the CDBG Program under HUD administration. A broad range of Kansas community development interests and needs were represented. The task force held two public meetings on October 24 and 25, 1984 and November 15, 1984.

In addition to oral and written testimony presented at the Task Force meetings, KDED has considered all written comments received in preparation of this statement. The 1985 Small Cities CDBG Program reflects the recommendations of the task force for the objectives of the program and the administrative framework and procedures to allocate CDBG funds to Kansas communities.

A public hearing on the *amended* final statement will be held on *Wednesday, July 31, 1985 at 1:30 p.m.* Comments in response to the *amended* final statement will be considered in developing the Final Statement of Community Development Objectives and Projected Use of Funds 1985.

Kansas Community Development Goals
and Objectives

A. National Purpose

The state confirms and endorses the national purpose of the program which is to develop viable com-

munities by funding activities which serve to achieve one or more of the three national objectives.

1. Activities Which Benefit Low and Moderate Income Persons

Activities will meet this objective if 51% of the persons benefiting from the activity are of low and moderate income. The term "low-and-moderate income persons" has the same meaning as "lower income families" in Section 8 HUD assisted housing programs.

2. Activities Which Aid in the Prevention or Elimination of Slums or Blight

An activity will meet this objective if it occurs in and is designed to upgrade an area or community which:

- a. meets the state statutory definition of blight; and
- b. occurs where there is a substantial number of deteriorated or dilapidated buildings or improvements throughout the area; and
- c. displays characteristics of physical distress which, if relieved, would prevent further deterioration into slum or blighted conditions.

3. Activities Designed to Meet Community Development Needs Having a Particular Urgency

Activities will meet this objective if they:

- a. address needs having a particular urgency because existing conditions pose a serious and immediate threat to the health or welfare of the community which conditions are of recent origin or which became urgent within 18 months of certification; and
- b. no other financial resources are available within the appropriate time frame to meet the need.

B. Kansas Goals and Objectives

The state has identified the following goals and objectives for the 1985 Kansas Small Cities (CDBG) Program:

GOAL 1. To improve local economies and the economic well-being of the people of Kansas.

Objectives:

- a. To encourage private investment which will result in 1) creation of new jobs and income generation and 2) the expansion of the tax base.
- b. To encourage the creation and retention of viable businesses which employ and serve the local population.
- c. To promote a strong local government role in maintaining and improving the basic community infrastructure which is essential to the well-being of the community and its economy.

GOAL 2. To provide funding for community improvements that 1) eliminate conditions which are detrimental to the public health and safety, or 2) meet other essential community development needs.

Objectives:

- a. To improve existing public facilities.
- b. To provide new facilities when warranted by recent documented population growth, or when essential needs exist.

- c. To improve housing conditions and ensure fair housing opportunities, especially for persons of low and moderate income.

GOAL 3. To provide funding for projects that may need an immediate state response or that address specific state priorities.

Objectives:

- a. To help local communities recover from natural disasters or alleviate a major threat to public health or safety.
- b. To fund priority projects that address critical community needs for which no other funds are available, some of which may not have been adequately addressed by the rating system.
- c. To assist the efforts of local government in providing funds for technical assistance, comprehensive planning and capital improvements planning, so that development strategies ensure efficient and equitable use of resources.

Kansas will require that for each program year at least 51% of the state allocation be used to support activities which benefit low and moderate income persons.

Projected Use of Funds—1985 Programs

The total amount of Small Cities CDBG funds allocated to Kansas for FY 1985 is approximately \$16,973,000.00, of which the state will use no more than \$100,000 plus 2% of the total amount for state administration of the program. Any uncommitted administration funds may be reallocated to another fund. No more than 20% of the total grant will be used for administrative, planning and/or technical assistance costs at both the state and local levels.

Grant funds may be used only for activities which are eligible under the Kansas Community Development Block Grant Program as defined by Title 1, Section 105 of the Housing and Community Development Act of 1974, as amended. A project will consist of activities that directly relate to each grant type.

The Grant Types coincide with the state goals and objectives, therefore, funding will be consistent with allocation goals as follows:

A formal system will be used to evaluate, select, and fund applications for grants. The selection criteria are designed to facilitate an objective assessment of the community and economic development needs of the area and the applicant's ability to provide an effective and timely response.

The funding ceiling Economic Development and Community Improvement grant is established at \$400,000.

State Discretionary Allocation

Due to the uniqueness and immediacy of the needs to be met under the State Discretionary set-aside, awards will be made within the parameters of the program description by the Governor and his designee, the Secretary of Economic Development.

There will be a formal system to evaluate, select and fund applications for State Discretionary Planning and Technical Assistance Grants as well as a \$20,000 grant limitation and a 25% local match requirement.

Multi-Purpose Small Lakes Program

The 1985 Kansas Legislature through House Bill 2619 provides that not less than 5% of the funds allotted to the state of Kansas for grants under the Small Cities Community Development Block Grant Program be made available to implement House Bill 2578 the Multi-purpose Small Lakes Program. The expenditures from the amount available for implementation shall be matched equally on a dollar for dollar basis from any other funding source.

Due to the unique requirements of this legislation grant awards under this category will be made within the parameter of the CDBG program Final Statement. A competitive process will be utilized. Points will be awarded with the use of the following predetermined selection criteria.

Selection Criteria Small Lakes

1. Threshold Requirements
2. State Conservation Commission Program Requirements

- A. Eligible applicants must meet the same requirements for threshold under the regular community improvement category.
- B. The State Conservation Commission requirements will constitute the third part of the ranking process.
- C. Applications must first be submitted to the Small Cities Program for threshold review. Applications which are accepted for ranking will be submitted to the Conservation Commission for rating and ranking.
- D. Application deadline will be established by the State Conservation Commission. Award announcements: On or before January 29, 1986.
- E. Total amount available: \$800,000 and maximum grant award \$400,000.

General Administration

1. Specific details of each grant category are published in the General Program Requirements.
2. Project Administrative Cost. Due to the wide disparity in project administrative cost, such costs will be individually negotiated at the time of contract signing.
3. The three national objectives are incorporated into the applicant selection criteria for the community development programs to be funded through CDBG and only eligible activities will be approved for funding by the Kansas Department of Economic Development.
4. Program income, miscellaneous income, unobligated administrative set-aside funds, or other unanticipated CDBG balances will be distributed by KDED in a manner which is consistent with the overall goals and objectives of the program. The state reserves the right to negotiate with applicants and to deny partial or total funding of any application in a given funding period depending on the quality of the project.
5. In the event that undistributed project funds remain on January 31, 1986, those funds will be pooled. The highest ranked community improvements applicant(s) will receive a grant offer if pooled funds equal or exceed the amount(s) requested. If pooled funds do not equal the amount(s) requested, the state may elect to negotiate with the top ranked applicant(s) or to carry the funds into the next program year.
6. The state of Kansas plans to minimize residential and commercial relocation by requiring the applicant to explain within its application its plans for minimizing relocation. The effectiveness of the local strategy will be reviewed in all applications.
7. Applicant Appeals

Applicants may meet with state staff to review their application and program scores. When an applicant appeals a program score the following procedures will be observed:

 - a. Appeals will be granted only on the basis of miscalculation of numerical factors.
 - b. An unsuccessful applicant has ten (10) days after receipt of denial to submit a written re-

quest to the KDED, 503 Kansas Ave., Second Floor, Topeka, KS 66603, for a numerical review of their application.

c. The state must respond to request for appeals within ten days.

Eligible Applicants

Eligible applicants under the Small Cities Program are defined as general purpose units of government—all counties and all cities which are not participants in the entitlement program. An eligible applicant may submit an application that includes subcontracting with other entities, either public or private, to perform any service, activity or undertaking which the contracting city or county is authorized by law to perform.

For projects proposed to resolve problems which exist in unincorporated areas of a county, the county governing body is the eligible applicant. Counties are encouraged to work with townships. A county may apply for a project which will include activities within an incorporated city if the proposed activity will significantly benefit county residents located in the unincorporated area of the county, as well as those within the city. A county may submit an application on behalf of a township as well as an application for its own jurisdiction.

For projects proposed to resolve problems which exist in a city, the city governing body is the eligible applicant. A municipality may apply for a project which would include activities to be located outside city limits if the proposed activity will benefit residents of the city.

Special purpose bodies such as local housing authorities, water or sewer districts, regional planning commissions, or local development corporations are not eligible to apply directly, although they may be involved in implementing and administering a program if an eligible applicant agrees to such an arrangement. Applicants for economic development grants may make grants or loans to other legal entities including for-profit organizations. The eligible applicant will be responsible for such grants, therefore, should assure through contractual arrangement that all appropriate requirements are understood by participating entities.

88-12-1. Eligibility. Such faculty member shall remain eligible for participation until the end of the academic year in which the faculty member becomes 65 years of age. 88-12-2. Voluntariness. Entry into a reduced service agreement is voluntary on the part of the regents institutions and the individual faculty member, except that the institution shall only refuse to enter into a reduced service agreement when entry into the agreement is not in the best interests of the institution. (Authorized by and implementing K.S.A. 76-746, as amended by 1985 HB 2622, Sec. 2; effective, T-86-22, July 1, 1985.)

88-12-3. Procedure for application and approval. Each eligible faculty member requesting participation in the program shall submit a written request for participation to the appropriate department or unit chairperson and dean for review and transmittal to the chief academic officer of the institution. The chief academic officer shall ascertain whether entry into the requested agreement is in the best interest of the institution. If so, the chief academic officer shall make the final decision on the terms of the agreement and shall then recommend approval of the agreement to the chief executive officer of the institution. (Authorized by and implementing K.S.A. 76-746, as amended by 1985 HB 2622, Sec. 2; effective, T-86-22, July 1, 1985.)

88-12-4. Revocability. Each reduced service agreement shall be irrevocable, except that the agreement may be rescinded within 48 hours of signature at the option of the employee. (Authorized by and implementing K.S.A. 76-746, as amended by 1985 HB 2622, Sec. 2; effective, T-86-22, July 1, 1985.)

88-12-5. Provisions of agreement. (a) Every reduced service agreement shall specify:

(1) the fractional time appointment to be served. Fractional time appointments shall be calculated on the total academic or fiscal year depending on the term of the appointment at the time of entry into the program, and shall carry with them a proportionate reduction in salary;

(2) the initial salary to be paid for reduced service;

(3) the full-time benefits to be enjoyed by the faculty member; and

(4) the duration of the agreement, including the date of retirement.

(b) The final agreement shall contain the signatures of both parties. (Authorized by and implementing K.S.A. 76-746, as amended by 1985 HB 2622, Sec. 2; effective, T-86-22, July 1, 1985.)

88-12-6. Full-time benefits. Participating faculty members shall receive the following benefits: (a) retention of full-time health care benefits until the end of the academic year in which the faculty member becomes 65 or until total retirement, whichever occurs first;

(b) retention of death and disability coverage until the end of the academic year in which the faculty member becomes 65 or until full retirement, whichever occurs first;

(c) retention of full-time employer-paid retirement benefits until the end of the academic year in which the faculty member becomes 65 or until total retirement, whichever occurs first;

(d) retention of tenure, except at Kansas technical institute, for duration of program at fractional time for which appointed;

(e) continued full use of university facilities; and

(f) continued eligibility for annual merit increases.

The full-time equivalent salary shall be used for the calculation of all state-provided benefits. (Authorized by and implementing K.S.A. 76-746, as amended by 1985 HB 2622, Sec. 2; effective, T-86-22, July 1, 1985.)

88-12-7. Modification of Agreement. The participating faculty member and the institution may, by mutual consent, modify the agreement by further reducing the participant's fractional time appointment prior to the specified date of retirement. (Authorized by and implementing K.S.A. 76-746, as amended by 1985 HB 2622, Sec. 2; effective, T-86-22, July 1, 1985.)

88-12-8. Full retirement. Full retirement shall occur not later than the end of the academic year following the attainment of age 70. Retirement from an institution under this program shall not preclude post-retirement term appointments. (Authorized by and implementing K.S.A. 76-746, as amended by 1985 HB 2622, Sec. 2; effective, T-86-22, July 1, 1985.)

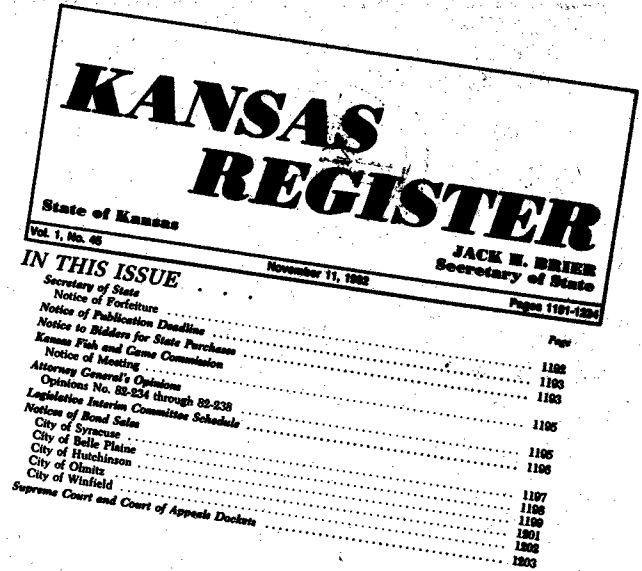
