**Taxation—Collection and Cancellation of Taxes—
Collection of Delinquent Personal Property Taxes;
Authority of County to Defer Payment.** Victor W.
Miller, Director of the Division of Property Valuation
for the Department of Revenue, Topeka, August 15,
1985.

Pursuant to K.S.A. 79-1411a, Shawnee County is the primary governmental unit responsible for the collection of personal property taxes within the county. While K.S.A. 79-1703 prohibits a board of county commissioners from releasing, discharging, remitting or commuting personal property taxes, no express prohibition exists against the deferral of such taxes. Further, while K.S.A. 79-2017 provides express provision for the collection of delinquent personal property taxes in Shawnee County, in addition to these express powers the board of county commissioners also possesses the implied power to take such reasonable means as may be necessary for the effective exercise of the powers conferred and the duties imposed. In a situation where delinquent personal property taxes are owed by a taxpayer who was in bankruptcy before the taxes were assessed, the Shawnee County Board of Commissioners may defer payment of such taxes and accrued interest for a reasonable period of time, but is without the power to release, discharge, remit, or commute such taxes in the absence of specific statutory authority. Organizations. Colonel Bert Cantwell, Superintendent, Kansas Highway Patrol, Topeka, August 15, 1985.

Uniformed members of the Kansas Highway Patrol are not precluded from joining the Kansas Association of Public Employees by K.S.A. 75-4327(f) (2), because the association is not a "recognized employee organization" within the meaning of K.S.A. 75-4322(j). Cited herein: K.S.A. 75-4322, 75-4327. JSS

Counties and County Officers—Mental Health Centers—Tax Levy; Buildings and Facilities. Philip S. Harness, Johnson County Counselor, Olathe, August 15, 1985.

K.S.A. 19-4004 authorizes a county to levy an annual tax, which may not exceed the limitations prescribed by K.S.A. 79-1947, for the purpose of acquiring and equipping facilities for community mental health programs and/or mental retardation services. K.S.A. 79-1947 provides that the levy for buildings and facilities authorized by K.S.A. 19-4004 shall be limited to .25 mills. Thus, the maximum authorized levy is .25 mills, and the fact that the county maintains separate mental health and mental retardation programs does not permit the county to make separate levies for the buildings and facilities used by each program. Cities and Municipalities—Public Recreation and Playgrounds—Recreation Commission; Incompatibility of Offices. Michael G. Barricklow, Superintendent of Unified School District No. 393, Solomon, August 16, 1985.

As a condition precedent to making the additional tax levy authorized by subsection (c) of K.S.A. 1984 Supp. 12-1908, as amended by L. 1985, ch. 76, § 1, a joint recreation commission established by a city and a school district must be reorganized to provide for the appointment of two members of the board of education of the school district. (K.S.A. 1984 Supp. 12-1908(d), as amended.) This requirement prevails over the common law doctrine of incompatibility of offices, and accordingly a member of a board of education may simultaneously serve as a member of a joint recreation commission. Cited herein: K.S.A. 12-1907, K.S.A. 1984 Supp. 12-1908, as amended by L. 1985, ch. 76, § 1. TRH

No oral or auction bids will be considered.

The Series C, 1985 Bonds initially issued will be dated as of September 1, 1985 and shall mature on December 1 in each of the years and in the amounts set forth below. Such bonds shall consist of fully registered certificated bonds, each in the denomination of \$5,000 or integral multiples thereof, except bond no. 1 in the amount of \$6,735.87, not exceeding the principal amount of bonds maturing in each year. Interest will be payable semiannually, commencing June 1, 1986, and each December 1 and June 1 thereafter. Redemption

Bonds maturing September 1, 1993 and thereafter, are subject to call for redemption and payment prior to their respective maturities at the option of the city on and after September 1, 1992, in whole at any time or in part in inverse order of maturity, and by lot within maturities, on any interest payment date, at a redemption price of 100 percent of the par value of the principal amount thereof plus accrued interest to the redemption date.

Notice of any call for redemption will be mailed to the registered owners of such bonds to be redeemed at the address shown on the registration books maintained by the bond registrar not less than 30 days prior to the date fixed for such redemption and payment. Interest on the bonds so called for redemption and payment will cease to accrue after the redemption date, provided notice has been given and funds are then available to pay the full redemption price thereof.

Interest Rate

Delivery of the Bonds

The bonds, duly printed, executed and registered, will be furnished and paid for by the city, and the bonds will be sold subject to the unqualified approving opinion of Gaar & Bell, Bond Counsel, of Wichita, Kansas. The number, denomination of bonds, and names of the initial registered owners shall be submitted in writing by the successful bidder to the bond registrar not later than September 12, 1985. The purchaser will be furnished with a complete transcript of proceedings evidencing the authorization and issuance of the bonds, and the usual closing proofs, which will include a certificate that there is no litigation pending or threatened at the time of delivery of the bonds affecting their validity. Payment for the bonds shall be made in immediately available funds.
