#### **ATTORNEY GENERAL**

Opinion No. 85-147

Counties and County Officers—General Provisions— Transaction of County Business. Thomas R. Oglevie, Special Counsel for the Board of County Commissioners of Sherman County, Goodland, November 6, 1985.

A board of county commissioners may reduce the salary of the county attorney under the broad home rule powers granted such board by K.S.A. 1984 Supp. 19-101a, as amended by L. 1985, ch. 208, § 1, provided the publication, notice and hearing requirements of K.S.A. 79-2929a are followed in amending the current budget. Cited herein: K.S.A. 1984 Supp. 19-101a, as amended by L. 1985, ch. 208, § 1; K.S.A. 1984 Supp. 19-247; K.S.A. 79-2929a; L. 1974, chs. 110, 361. JSS

#### **Opinion No. 85-148**

Banks and Banking—Banking Code; Crimes and Punishments—Unlawful Banking. Eugene T. Barrett, Jr., State Bank Commissioner, Topeka, November 6, 1985.

K.S.A. 9-2011 prohibits individuals, firms or corporations from advertising that they are engaged in the banking business without obtaining authority from the bank commissioner, and is applicable only to those institutions which engage in "banking" as defined by K.S.A. 9-702. Accordingly, K.S.A. 9-2011 is not applicable to an institution such as a federal land bank which is not empowered to "receive money on deposit" or issue checks, drafts or "other evidence of indebtedness" for which it charges a fee, pursuant to K.S.A. 9-702. #### **Opinion No. 85-149**

Criminal Procedure—Code of Criminal Procedure; Costs in Criminal Cases—Liability for Costs. Charles E. Simmons, Chief Legal Counsel, Department of Corrections, Topeka, November 6, 1985.

K.S.A. 1984 Supp. 22-3801(c) requires the Department of Corrections to reimburse a county for jury fees paid by the county for prosecutions resulting from crimes committed while a defendant is on parole or conditional release status from a state correctional institution. Cited herein: K.S.A. 1984 Supp. 22-3801; K.S.A. 28-150; 21-4204; K.S.A. 1984 Supp. 22-3717, as amended by L. 1985, ch. 111, § 2; K.S.A. 60-1501. JSS

#### Opinion No. 85-150

Infants—Kansas Code for Care of Children—Investigation of Reports of Suspected Child Abuse or Neglect. M. Moran Tomson, Stanton County Attorney, Johnson, November 6, 1985.

The Department of Social and Rehabilitation Services has authority, pursuant to K.S.A. 1984 Supp. 38-1523, to conduct an investigation on school premises upon receiving a report of suspected child abuse or neglect. Such a report may be oral or written and may be made by anyone, including personnel within the department. A 16-year-old boy who is living by himself may fit within the definition of a neglected child in the Kansas Code for Care of Children, and therefore may be the subject of such an investigation. A public hearing will be conducted from 9:30 a.m. to 10 a.m. Sunday, December 1, at the Office of the Securities Commissioner of Kansas, Suite 212, 503 Kansas Ave., Topeka, to consider the adoption of proposed amendments and revocations of permanent and

temporary regulations of the Commissioner.

All interested parties may submit written comments prior to the hearing to the Commissioner at the address above. All interested parties will be given a reasonable opportunity at the hearing to express their views, orally, in regard to adoption of the proposed amendments and revocations. Following the hearing, all written and oral comments submitted by interested parties will be considered by the Commissioner as a basis for making any changes to the proposed amendments or revocations.

The following is a brief summary of the proposed

amendments and revocations:

K.A.R. 81-2-1. Filing, fees and forms. The proposed amendment updates the regulation to be consistent with statutorily amended fee schedules, clarifies the language, corrects the address for the filing of applications, and corrects the list of approved forms.

K.A.R. 81-5-2. Non-profit religious organization ex-

emption. The proposed amendment conforms the regulation to approved forms and requires exempted issuers of church bonds to file annual and final reports.

K.A.R. 81-11-2. Scope of administrative procedures regulations. The proposed amendment supplements administrative procedures given in the Kansas Administrative Procedures Act and the Kansas Securities Act.

K.A.R. 81-11-3. Form of pleadings. The proposed amendment establishes regularity in the form of

pleadings in administrative procedures.

K.A.R. 81-11-4. Summary adjudicative proceedings. The proposed amendment implements L. 1984, Ch. 313, Sec. 37 by establishing criteria for employing summary adjudicative proceedings.

K.A.R. 81-11-5. Request for hearing. The proposed amendment establishes time limits for filing requests for hearings and delineates the contents required in

the requests.

K.A.R. 81-11-6. Conference adjudicative proceedings. The proposed amendment implements L. 1984, Ch. 313, Sec. 33 by establishing criteria for employing conference adjudicative proceedings.

K.A.R. 81-11-7. Appearances. The proposed amendment establishes who shall appear in adjudicatory

proceedings.

K.A.R. 81-11-8. Formal adjudicative proceedings. The proposed amendment establishes the format for conducting formal adjudicative proceedings.

K.A.R. 81-11-9. Subpoenas. The proposed amendment establishes criteria for service of subpoenas upon parties and for administrative sanctions for failure of parties to obey subpoenas.

K.A.R. 81-11-10. Evidence. The proposed amendment establishes criteria for the relaxation of the rules

of evidence in adjudicative proceedings.

K.A.R. 81-11-11. Hearing officers. The proposed amendment provides for the appointment of hearing officers in matters which the commissioner is required to finally determine.

K.A.R. 81-11-12. Immunity. The proposed amendment clarifies how immunity may be granted by the

commissioner in investigative proceedings.

K.A.R. 81-36-1. This regulation is to be revoked because jurisdiction over the subject matter was transferred to another agency by the legislature.

K.A.R. 81-36-2. This regulation is to be revoked because jurisdiction over the subject matter was transferred to another agency by the legislature.

#### NOTICE OF MEETING AND HEARING ON PROPOSED ADMINISTRATIVE REGULATIONS

The Department of Social and Rehabilitation Services will conduct an open meeting at 9 a.m. Tuesday, December 3, in the Staff Development Training Center, 2700 W. 6th, Topeka.

The scheduled agenda includes:

Adoption of proposed permanent administrative regulations.

—Solicit input concerning legislation.

—Public hearing concerning proposed temporary administrative regulations. A summary of the proposed regulations is set forth below. The proposed changes are scheduled to become effective January 1, 1986.

A. Public Assistance Program

1. 30-4-101. Standards for persons in own or other family home. This regulation is being amended to increase the amount of the energy supplement that is contained in the basic standard from \$6 to \$7 per person.

2. 30-4-102. Standards for persons in room, board, specialized living or care. This regulation is being amended to increase the amount of the energy sup-

plement from \$6 to \$7 per person.

B. Medicaid/Medikan Program-Client Eligibility.

1. 30-6-103. Determined eligibles; protected income levels. This regulation is being amended to increase the protected income levels from: \$325 to \$341 for one person; \$425 to \$442 for two persons; \$435 to \$450 for three persons; and \$446 to \$460 for four persons. The protected income level for additional persons shall be the sum of the basic standard for a like public assistance family plus the maximum state shelter standard.

—Adoption of proposed temporary administrative regulations.

These regulations are being amended to incorporate a citation to the statutory section or sections being implemented or interpreted as required by K.S.A.

77-416. Any other amendments are editorial in nature and result from changes required by the Secretary of Administration to meet current standards of organization, style, orthography and grammar. In some cases, the amendments are numerous and give the appearance of a significant revision but no change in substance is intended.

40-2-17. This regulation adopts the N.A.I.C. model regulation permitting smoker/nonsmoker mortality tables for use in determining minimum reserve liabil-

ities and nonforfeiture benefits.

40-2-18. This regulation adopts the N.A.I.C. model regulation for recognizing a new annuity mortality table for use in determining reserve liabilities for annuities.

40-4-1. This regulation adopts the N.A.I.C. guidelines for filing of rates for individual health insurance forms. This is not considered to be a substantive change inasmuch as the current regulation closely parallels the N.A.I.C. guidelines.

40-4-21. This regulation adopts the N.A.I.C. reserve standards for individual health insurance policies. This is not considered to be a substantive change inasmuch as the current regulation essentially dupli-

cates the N.A.I.C. provisions.

40-4-34. This regulation adopts as a permanent regulation the N.A.I.C. coordination of benefits guidelines that are currently in effect on a temporary basis.

If any bond is called for redemption and payment as aforesaid, all interest on such bond will cease from and after the date for which such call is made, provided funds are available for its payment at the price hereinbefore specified.

#### **Conditions of Bids**

Proposals will be received on the bonds bearing such rate of interest as may be specified by the bidders, subject to the following conditions: The interest rate specified shall be a multiple of ½ or ½ of 1 percent. No supplemental interest payments will be authorized. No bid of less than 100 percent of the principal amount of the bonds and accrued interest will be considered. An underwriting fee may be specified by the bidders on the bid form and will be paid from bond proceeds to the successful bidder at the time of closing. No underwriting fee in excess of 5 percent of the principal amount of the bonds will be

considered. Each bid shall specify the total interest cost, after adding the cost of any underwriting fee, to the Secretary during the life of the bond issue, the premium, if any, specified by the bidder, and the net interest cost to the Secretary on the basis of such bid. Each bid shall also specify the average annual net interest rate to the Secretary on the basis of such bid. The principal amount of bonds maturing on July 1, 1998 is subject to adjustment upward or downward in order to adjust the amount of proceeds received in order to meet adequately the refunding requirements for the outstanding Kansas Highway Refunding Bonds, Series 1985. The determination of net interest cost and average annual interest cost shall be made based upon the principal maturity set forth above, and not upon the principal maturity as finally determined. The amount of the adjustment in the July 1, 1998 maturity shall be communicated to the successful bidder not later than 10 a.m., C.S.T., November 27, 1985.

#### **Basis of Award**

The award of the bonds will be made on the basis of the lowest net interest cost to the Department, which will be determined by subtracting the amount of the premium bid, if any, from the total interest cost on the bonds or by adding the amount of the underwriting fee, if any, to the total interest cost on the bonds. If there is any discrepancy between the net interest cost and the average annual net interest rate specified, the specified net interest cost shall govern and the interest rates specified in the bid must be adjusted accordingly. If two or more proper bids providing for identical amounts for the lowest net interest cost are received, the Secretary will determine which bid, if any, shall be accepted, and his determination will be final.

Authorization, Purpose and Security for the Bonds The bonds are being issued pursuant to Kansas Statutes Annotated Sections 68-2301 to 68-2313, inclusive, as amended, for the purpose of providing funds to refund in advance of their maturities the bonds of an issue of outstanding Kansas Highway

bonds of an issue of outstanding Kansas Highway Refunding Bonds, Series 1985. The bonds and the interest thereon are secured by and payable from a valid lien on money's accruing to the State Freeway Fund and pledged to their payment, such moneys consisting of a portion of the taxes collected by the state on motor fuels, subordinate only to the lien of six series of outstanding bonds described in a Resolution of the Secretary adopted January 25, 1985, for which the payment of the principal of and the interest on has been provided for by the state of Kansas pursuant to an Escrow Trust Agreement dated as of January 15, 1985, by and between the state of Kansas and First National Bank of Topeka, in the city of Topeka, Kansas. The bonds do not constitute a debt or a pledge of the faith and credit of the state of Kansas or of any political subdivision thereof.

**Legal Opinion** 

The Bonds will be sold subject to the approving legal opinion of Gaar & Bell, Overland Park, Kansas, Bond Counsel, which opinion will be furnished and

paid for by the Secretary, printed on the bonds and delivered to the successful bidder when the bonds are delivered.

**Delivery and Payment** 

The Secretary will pay for printing the bonds and will deliver the bonds, properly prepared, executed and registered, on or about December 19, 1985, at such bank or trust company, as may be suggested by the successful bidder and is acceptable to the Secretary, at least seven days prior to the date of closing, without cost to the successful bidder. Said bidder will also be furnished with a certified transcript of the proceedings evidencing the authorization and issuance of the bonds and the usual closing documents, including a certificate that there is no litigation pending or threatened at the time of delivery of the bonds affecting their validity and a certificate attesting to the completeness and accuracy of the official statement. Payment for the bonds shall be made in federal reserve or other funds, immediately available for use by the Secretary. The type and denominations of the bonds and the names, addresses and social security or taxpayer identification numbers of the registered owners shall be submitted in writing by the successful bidder to the Secretary and bond registrar at least 10 days prior to the date of delivery of the bonds. In the absence of such information, the Secretary will deliver bonds in the form of one bond registered in the name of the successful bidder.

#### **CUSIP** Numbers

CUSIP identification numbers will be printed on certificated bonds or assigned to uncertificated bonds, but neither the failure to print such number on or assign such number to any bond nor any error with respect thereto shall constitute cause for a failure or refusal by the successful bidder thereof to accept delivery of and pay for the bonds in accordance with the terms of this notice. All expenses in relation to the printing and assigning of CUSIP numbers on the bonds will be paid by the Secretary.

Good Faith Deposit

Each bid shall be accompanied by a cashier's or certified check drawn on a bank located in the United States of America in the amount of \$2,862,000, payable to the order of the Secretary, to secure the Secretary from any loss resulting from the failure of the bidder to comply with the terms of its bid. No interest will be paid upon the deposit made by any bidder. Said check will be returned to the bidder if its bid is not accepted by registered mail to the address of the bidder shown on the bid form. If a bid is accepted, said check will be held by the Secretary until the bidder has complied with all of the terms and conditions of its bid at which time said check will be returned to the successful bidder or deducted from the purchase price at the option of the Secretary. If a bid is accepted but the Secretary fails to deliver the bonds to the bidder in accordance with the terms and conditions of its bid, said check will be returned to the bidder. If a bid is accepted but the bidder defaults in the performance of any of the terms and conditions of its bid, the proceeds

of such check will be retained by the Secretary as and for liquidated damages.

#### **Bid Forms**

All bids must be made on forms which may be procured from the Secretary or Stern Brothers & Co., the financial advisor. No additions or alterations in such forms shall be made and any erasures may cause rejection of any bid. The Secretary reserves the right to waive irregularities and to reject any or all bids.

#### Submission of Bids

Bids must be submitted in sealed envelopes addressed to the Secretary of Transportation and marked "Proposal for the Purchase of Highway Refunding Bonds, Series 1985A." Bids may be mailed or delivered in person and must be received by the undersigned by 10 a.m., C.S.T., Tuesday, November 26, 1985.

#### **Bond Insurance**

The Secretary has applied to the Municipal Bond Insurance Association for a bond insurance policy, which policy will unconditionally guarantee the payment of principal and interest on the bonds. The premium for such policy will be paid from the proceeds of the sale of the bonds. Details of the policy

and information regarding bond ratings will be communicated prior to the sale date by "Munifacts."

#### Official Statement

The Secretary has prepared a preliminary official statement dated November 13, 1985, copies of which may be obtained from the Secretary or from Stern Brothers & Co., the financial advisor. Upon the sale of the bonds the Secretary will adopt the final official statement and, at the request of the successful bidder, will furnish the successful bidder with a reasonable number of copies thereof without additional cost. Additional copies may be ordered by the successful bidder at its expense.
