ON PROPOSED
ADMINISTRATIVE REGULATIONS

A public hearing will be conducted at 9:30 a.m. Friday, June 13, in the Old Supreme Court Room, third floor, State Capitol, Topeka, to consider the adoption of proposed changes in existing rules and regulations of the Department of Administration. These regulations are being adopted on a temporary or permanent basis.

All interested parties may submit written comments prior to the hearing to the Secretary of Administration, 2nd Floor, State Capitol, Topeka 66612. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

A summary of proposed regulations follows:

Division of General Services

K.A.R. 1-45-7: This regulation establishes the fee charged for parking permits where required by regulation. The proposed amendment to this regulation would raise the parking permit fee from \$5 to \$10 per month.

Copies of this regulation and of the fiscal impact statement may be obtained from the Division of General Services, Room 152-W, State Office Building, Topeka 66612, (913) 296-2147, (KANS-A-N 561-2147).

Division of Accounts and Reports

K.A.R. 1-16-3: Amendments to this regulation permit subsistence to be paid for up to nine months to

employees who are temporarily assigned to a duty station other than their official duty station. Approval of the Secretary of Administration must be obtained to pay subsistence allowance for a period longer than three months.

K.A.R. 1-16-15: This regulation establishes conditions under which a reduced subsistence allowance may be paid. Amendments to the regulation reflect proposed amendments to K.A.R. 1-16-18 and are therefore technical in nature.

K.A.R. 1-16-18: The proposed amendments to this regulation would provide for reimbursement of meal and lodging expenses incurred while traveling within the state on official business in the same manner currently prescribed for traveling out-of-state. Meal expense allowances for travel within the state would be on a quarter day basis at a prescribed rate of \$3.50 per quarter. The regulation sets lodging expense limitations of \$40 per night for in-state travel except that locations designated as high cost geographic areas would have a limitation of \$50 per night. The maximum lodging expense limitations for travel out-of-state would be increased from \$50 to \$60 per night for destinations not designated as high cost areas while the prescribed maximum rates for designated high cost geographic areas and certain other identified areas would remain at the rates prescribed under the current regulation.

K.A.R. 1-16-18a: Amendments to the regulation adjust the list of high cost geographic areas to reflect current information about the costs of travel to those locations and the changes in reimbursement rates established by K.A.R. 1-16-18.

K.A.R. 1-17-2a: The regulation establishes the conditions under which employees may drive state vehicles to their residence overnight. Amendments to this regulation allow employees to drive a state vehicle home the night before a trip if driving the vehicle home will not increase the total one-way trip mileage between the official work station and the destination by more than 10 miles.

Division of Personnel Services

K.A.R. 1-9-8: Amendments to this regulation that took effect May 1, 1986 stated that an employee is not entitled to leave with pay when the employee voluntarily seeks to testify as a witness. Proposed amendments to this provision would clarify that leave with pay is not available to an employee who voluntarily seeks to testify as a witness against a state agency.

The bill is subject to change, and if it becomes law may contain requirements which differ from those contained in the bill in its present form. Pending Federal Tax Legislation

The United States House of Representatives on December 17, 1985 passed H.R. 3838, the Tax Reform Bill of 1985. H.R. 3838 includes amendments to Internal Revenue Code provisions applicable to tax-exempt bonds such as the bonds. These amendments are stated to be effective for bonds delivered after December 31, 1985, and therefore would apply to the bonds, if enacted.

However, on March 14, 1986, a joint statement was issued by House Ways and Means Chairman Dan Rostenkowski (D., Ill.); Senate Finance Chairman Bob Packwood (R., Ore.); Rep. John J. Duncan, ranking member of the Ways and Means Committee; Senator Russell Long, ranking member of the Finance Committee; and Secretary of the Treasury James A. Baker, III, with respect to the effective dates of certain provisions of the comprehensive tax reform legislation (H.R. 3838) being considered by Congress. The joint statement endorses postponement until September 1, 1986 (or the enactment of tax reform legislation, if earlier) of the effective dates of certain of the provisions of H.R. 3838 for certain types of bonds.

The joint statement does not address the provision in H.R. 3838 providing for a possible minimum tax on interest on the bonds to property and casualty insurers in taxable years of such taxpayers beginning after December 31, 1987. It also does not address the provision in H.R. 3838 disallowing the deduction of interest paid by financial institutions which own tax-exempt obligations.

The district will comply with those provisions of H.R. 3838 that were not addressed in the joint statement. The district will covenant to comply with all applicable future laws, regulations, published rulings and court decisions which relate to the exemption from income tax of the interest on the bonds, to the extent any actions can be taken by the district to comply with such laws, regulations, published rulings and court decisions or otherwise to preserve such exemption. In the event the district is unable to comply with such laws, regulations, published rulings or court decisions, interest on the bonds may become taxable, retroactively to the date of issuance. In the event that interest on the bonds becomes taxable, the district is not required to redeem or otherwise prepay the bonds.

The district will designate the bonds as "qualified tax-exempt obligations" as defined in Section 802(e)(3) of H.R. 3838, as passed by the United States House of Representatives on December 17, 1985. The district is a political subdivision that was in existence prior to October 23, 1985, and reasonably anticipates to issue qualified tax-exempt obligations during calendar year 1986 in an amount not exceeding \$10 million. The district will not with the issuance of the bonds issue in excess of \$10 million qualified tax-exempt obligations during calendar year 1986. The bonds are "qualified project bonds" pursuant to Section 802(e)(3) in that the obligations issued to finance the project shall not exceed \$3 million.

The Finance Committee of the United States Senate on May 7, 1986 approved and ordered reported certain revisions in H.R. 3838. The Finance Committee proposal includes amendments to the code provisions applicable to tax-exempt bonds such as the bonds. The drafting of the actual text of the proposal has not been completed but certain statements concerning the proposal have been released by the Senate Finance Committee. Such statements indicate that the amendments to the code set forth in the proposal, except as stated in the next succeeding paragraph, would be effective on the date of enactment and therefore would not apply to the bonds.

A provision of the Finance Committee proposal treats as an item of tax preference for purposes of the alternative minimum tax on corporations 50 percent of the excess of book income (which includes tax-exempt interest) over taxable income (which does not include tax-exempt interest) for years beginning after December 31, 1986. Thus, if the proposal is adopted in its proposed form, a portion of the interest on the bonds could indirectly be subject to the alternative minimum tax on corporations.

Purpose

The city of Ellsworth, Kansas will receive sealed bids at the office of the City Clerk, City Hall, Ellsworth, Kansas, until 7 p.m. C.D.T. on Monday, June 9, 1986, for \$275,000 par value general obligation bonds, series 1986-A of the city, at which time and place such bids will be publicly opened. No oral or auction bids will be considered.

The series 1986-A bonds will be dated as of July 1, 1986, and shall mature on December 1 in each of the years and in the amounts set forth below. Such bonds shall be fully registered certificated bonds, each in the denomination of \$5,000 or integral multiples thereof, not exceeding the principal amount of bonds maturing in each year. The bonds will mature serially in accordance with the following schedule:

* OPTIONAL REDEMPTION: Bonds due December 1, 1995 and thereafter, are callable for redemption on December 1, 1994, or any interest payment date thereafter, in inverse numerical order at par and accrued interest to date of redemption.

Notice of any call for redemption will be mailed to the registered owners of such bonds to be redeemed at the address shown on the registration books maintained by the bond registrar not less than 30 days prior to the date fixed for such redemption and payment. Interest on the bonds so called for redemption and payment will cease to accrue after the redemption date, provided notice has been given and funds are then available to pay the full redemption price thereof.

Interest will be payable semiannually, commencing June 1, 1987, and each December 1 and June 1 thereafter. The principal of, and premium, if any, on the bonds shall be payable in lawful money of the United States of America, at the Citizens State Bank and Trust Company, Ellsworth, Kansas (the paying agent and the bond registrar) to the registered owners thereof upon presentation of the bonds for payment and can-

cellation. Interest on the bonds shall be payable in lawful money of the United States of America by check or draft of the paying agent to the registered owners appearing on the books maintained by the bond registrar as of the 15th day of the month next preceding the interest payment dates (the record dates). The fees of the bond registrar for registration and transfer of the bonds shall be paid by the city.

Types of Bids and Interest Rates

Proposals will be received on the bonds bearing such rate or rates of interest as may be specified by the bidder. The same rate shall apply to all bonds of the same maturity. Each interest rate specified shall be in an even multiple of 1/8 or 1/20 of 1 percent. The difference between the highest and lowest interest rates specified in any bid shall not exceed 3 percent. No interest rate shall exceed the maximum interest rate allowed by Kansas law, said rate being 2 percent above the Weekly Credit Market's 20 Bond Index of tax exempt municipal bonds published in New York, New York on the Monday next preceding the day on which the bonds are sold, and no bid of less than par and accrued interest will be considered. Bids involving the use of extra or supplemental interest rates will not be considered. Bids for less than the entire issue of bonds will not be considered.

Bids shall be submitted on the official bid form furnished by the city, and shall be addressed to the city at the City Hall, Attention: Gladys Toman Wagner, City Clerk, and shall be plainly marked BOND BID. All bids must state the total interest cost of the bid, the premium, if any, the net interest cost of the bid, and the average annual interest rate, all certified by the bidder to be correct, and the city will be entitled to rely on the certificate of correctness of the bidder. Each bid must be accompanied by a certified or cashier's check equal to 2 percent of the total amount of the bid, and shall be payable to Treasurer, City of Ellsworth, Kansas. In the event a bidder whose bid is accepted shall fail to carry out his contract of purchase, said deposit shall be retained by the city as liquidated damages. The checks of unsuccessful bidders will be returned promptly.

Basis for Award

The sealed bids for the bonds shall be opened publicly and only at the time and place specified in this notice, and the bonds will be sold to the best bidder. The city reserves the right to reject any and all of the bids, and to waive any irregularities. Unless all bids are rejected, the bonds will be awarded to the bidder whose proposal results in the lowest net interest cost to the city, and the net interest cost will be determined by deducting the amount of any premium paid from the aggregate amount of interest upon all of the bonds from their date until their respective maturities. If there is any discrepancy between the net interest cost and the average annual net interest rate specified, the specified net interest cost shall govern. If two or more proper bids providing for identical amounts for the lowest net interest cost are received, the city shall determine which bid, if any, shall be accepted, and its determination shall be final.

Delivery

The bonds, duly printed, executed and registered, will be furnished and paid for by the city, and the bonds will be sold subject to the approving opinion of Gaar & Bell, bond counsel, of Wichita, Kansas, whose opinion will be paid for by the city. The number, type and denomination of bonds, and names of the initial registered owners to be initially printed on the bonds and their social security or taxpayer identification numbers shall be submitted in writing by the successful bidder to the bond registrar and the city not later than seven business days preceding delivery of the bonds. The purchaser will be furnished with a complete transcript of proceedings evidencing the authorization and issuance of the bonds, and the usual closing proofs, which will include a certificate that there is no litigation pending or threatened at the time of delivery of the bonds affecting their validity. Payment for the bonds shall be made in immediately available funds. Delivery of the bonds will be made to the successful bidder on or about July 9, 1986, at any bank in the state of Kansas or Kansas City, Missouri, at the expense of the city. Delivery elsewhere will be made at the expense of the purchaser.

It is anticipated that CUSIP identification numbers will be printed on the bonds, but neither the failure to print such numbers on any bond nor any error with respect thereto shall constitute cause for a failure by the successful bidder to accept delivery of and pay for the bonds in accordance with the terms of his contract and this notice of bond sale. All expenses in connection with the printing of CUSIP numbers on the bonds shall be paid for by the city.

Security

Bids shall be conditioned upon the approving opinion of Gaar & Bell, bond counsel, Wichita, Kansas, a copy of which opinion will be printed on the reverse side of each bond and a manually signed original will be furnished without expense to the purchaser of the bonds at the delivery thereof. The cost of this legal opinion and the expense of printing the bonds and legal opinion will be paid by the city. Said legal opinion will state in part substantially that the bonds will constitute general obligations of the city, payable as to both principal and interest from ad valorem taxes which may be levied without limitation as to rate or amount upon all of the taxable, tangible property within the territorial limits of the city and that, under existing law, the interest on said bonds is exempt from present federal income taxation and the bonds are exempt from intangible personal property taxes levied by Kansas cities, counties or townships. The bonds are being issued for the purpose of financing the purchase of fire fighting equipment for the City of Ellsworth Fire Department.

Pending Federal Legislation Concerning Tax Exempt Obligations

On December 17, 1985, the U.S. House of Representatives passed H.R. 3838, the Tax Reform Act of 1985. The bill presently is pending in the Senate. The bill in its present form imposes additional require-

(continued)

ments which must be satisfied in order for interest on obligations issued by or on behalf of state and local governments to be exempt from federal income taxation. Such requirements generally are effective for all obligations issued after December 31, 1985, and thus, if the bill becomes law in its present form, would be applicable to the bonds.

The bill is subject to change, and if it becomes law may contain requirements which differ from those contained in the bill in its present form. Therefore, there can be no assurance that the city will be able to comply with such requirements. The failure or inability of the city to comply with the requirements of the bill could jeopardize the tax exempt status of the bonds from their date of issuance. Bondholders should be aware that in such event, the bonds are not callable, nor will the interest rate on the bonds be adjusted to reflect the loss of the tax exemption.

On March 14, 1986, a joint statement was issued by key congressional leadership and the Secretary of the Treasury of the United States concerning a delay in the effective date of certain provisions of the bill. The city has relied on the joint statement in issuance of the bonds.

In reliance upon the joint statement, if the bonds are issued prior to September 1, 1986, or the date of enactment of tax reform legislation, if earlier, the city does not intend to comply with the provision of the bill for which the effective date was postponed.

The total general obligation bonded indebtedness of the city of Ellsworth, including this issue of bonds, is \$458,600. The city presently has no temporary notes outstanding.

Article 2.—GENERAL

30-2-16. Permanency planning goals for title IV-E of the federal social security act. (a) The agency's permanency planning goal for the federal fiscal year commencing on October 1, 1985 shall be to have no more than 450 children who have been in foster care placements in excess of 24 consecutive months receive federal funding during the course of the year.

(b) The agency shall take the following steps to achieve the above stated goal. The agency shall:

(1) Make a reasonable effort to make adoption assistance available on behalf of eligible children; and

(2) initiate a case review and develop a plan for each child in the custody of the agency. The effective date of this regulation shall be May 1, 1986. (Authorized by and implementing K.S.A. 1985 Supp. 39-708c; effective, T-83-26, Sept. 22, 1982; effective May 1, 1983; amended, T-85-24, Sept. 18, 1984; amended May 1, 1985; amended, T-87-5, May 1, 1986.)

Article 4.—PUBLIC ASSISTANCE PROGRAM

30-4-85a. Eligibility factors specific to the EA program. Each applicant or recipient shall meet the following eligibility requirements to be eligible for EA. (a) General eligibility requirements. Each applicant or recipient shall meet the general eligibility requirements set forth in K.A.R. 30-4-52, 30-4-54 and 30-4-55(a).

(b) Living in the state. Each applicant or recipient shall be physically living in the state.

(c) Emergency situation. A bona fide emergency situation shall exist. Emergency situations shall be limited to disasters, including fires, floods, and tornadoes, or evictions or potential evictions. An application shall be made within 30 days of the disaster, eviction or potential eviction.

(d) Financial eligibility. The household of each applicant or recipient shall not have applicable income in the calendar month of application in excess of 200% of the budgetary requirements as established for ADC.

(e) Household eligibility. A household shall consist

of all persons living together as an economic unit and shall include at least one child who is:

(1) Under the age of 18, or under the age of 19 and a full-time student in a secondary school or the equivalent level of vocational or technical training if the child may reasonably be expected to complete the program before attaining age 19;

(2) living, or who was living within six months before the month in which assistance is requested, in that household. That household shall be maintained by any of the relatives set forth in K.A.R. 30-4-72(c) as the child's home;

(3) without resources immediately accessible to meet the emergency situation. The assistance shall be necessary to avoid destitution of the child or to provide living arrangements for the child;

(4) not in destitution or need because the child or the caretaker relative refused, without good cause, to accept potential employment or training for employment; and

(5) not in destitution or need because the child or the caretaker relative is unemployed because of a strike.

(f) Nonsubstitution. The EA program shall not be used as a substitute for normal assistance grants of an ongoing program and shall not be used in lieu of existing programs for which the individual is eligible. Current assistance recipients may receive EA, if they meet the qualifications and requirements for EA.

(g) Authorization period. Authorization for EA shall be limited to one period of 30 consecutive days, following the date of approval, in any 12 consecutive months. All payments shall be made within the authorization period.

(h) Assistance provided. The assistance provided may include needs covering a two-month period which may be incurred prior or subsequent to the authorization period. The need shall be directly related to the immediate emergency and shall be met in order to resolve the emergency. The assistance provided shall be given promptly and pursuant to K.A.R. 30-4-122a. The effective date of this regulation shall be May 1, 1986. (Authorized by K.S.A. 1985 Supp. 39-708c; implementing K.S.A. 1985 Supp. 39-708c, 39-709; effective, T-84-9, March 29, 1983; effective May 1, 1984; amended May 1, 1985; amended May 1, 1986; amended, T-87-5, May 1, 1986.)

30-4-122a. Special allowances for EA. Subject to available funding for EA program purposes, recipients of EA shall be issued the following allowances as necessary and only if otherwise not available from other sources. (a) Emergency shelter. Emergency shelter allowances shall include rent to obtain housing or prevent eviction on an as-paid basis, up to the maximum shelter standard used in the state, for a period not to exceed two months.

(b) Emergency utilities. Emergency utility allowances shall include an amount necessary to turn on utilities (excluding telephone).

(c) Emergency house repairs. Allowances for repairs needed to resolve the emergency shall be au-

thorized up to the maximum amount of \$1,000.00 for a client-owned home.

(d) Household effects. Allowances for necessary household furniture, appliances and supplies shall include an amount for repair or purchase of used furniture, appliances and other household supplies up to the maximum amount of \$500.00.

(e) Emergency clothing. An allowance for the replacement of clothing shall be allowed on an as needed basis, to the maximum amount of \$150.00 per person. The effective date of this regulation shall be May 1, 1986. (Authorized by K.S.A. 1985 Supp. 39-708c; implementing K.S.A. 1985 Supp. 39-708c, 39-709; effective, T-84-9, March 29, 1983; effective May 1, 1984; amended May 1, 1985; amended May 1, 1986; amended, T-87-5, May 1, 1986.)

Article 5.—PROVIDER PARTICIPATION, SCOPE OF SERVICES, AND REIMBURSEMENT FOR THE MEDICAID (MEDICAL ASSISTANCE) PROGRAM

30-5-101. Scope of chiropractic services. Chiropractic services shall be covered for medicaid recipients. (a) Office visits for diagnosis and treatment of EPSDT program participants shall be covered up to 24 per calendar year.

(b) Office visits for diagnosis and treatment of non-EPSDT program participants shall be covered up to 12 per calendar year.

(c) The recipient shall be limited to one practitioner's care for a given diagnosis.

(d) Spinal manipulations shall be limited to neuromuscular skeletal conditions.

(e) A progress report shall be submitted to the agency after the first 60 days following the date of the first visit, and every 60 days thereafter. This report shall contain the history of the present illness, the diagnosis, the type or mode of treatment, the treatment program, and the prognosis. The effective date of this regulation shall be May 1, 1986. (Authorized by and implementing K.S.A. 1985 Supp. 39-708c; effective May 1, 1981; amended May 1, 1983; amended, T-84-11, July 1, 1983; amended May 1, 1984; amended, T-85-9, April 11, 1984; amended May 1, 1985; amended May 1, 1986; amended, T-87-5, May 1, 1986.)

30-5-101a. Reimbursement for chiropractic services. Reimbursement for chiropractic services shall be made on the basis of reasonable charges, except no fee shall be paid in excess of the range maximum. The range of charges shall provide the base for computations. The effective date of this regulation shall be May 1, 1986. (Authorized by and implementing K.S.A. 1985 Supp. 39-708c; effective May 1, 1981; amended May 1, 1983; amended May 1, 1986; amended, T-87-5, May 1, 1986.)

30-5-102. Scope of optometric and optical services. Optometric and optical services shall be covered for medicaid recipients. (a) Services include:

(1) Optometric examinations;

(continued)

(2) grinding and edging lenses, assembling and dispensing eyeglasses; and

(3) optical materials. Optical materials include:

(A) Frames. Materials covered shall be only first quality frames showing the manufacturer's name on either the front or temple; and

(B) lenses. Only first quality American made lenses meeting designated standards shall be acceptable. For single lens replacement, the replacement lens shall be made of similar quality to the remaining usable lens.

(b) Limitations. Optometric examinations and optical materials shall be limited as specified by the secretary. The effective date of this regulation shall be May 1, 1986. (Authorized by and implementing K.S.A. 1985 Supp. 39-708c; effective May 1, 1981; amended May 1, 1983; amended May 1, 1986; amended, T-87-5, May 1, 1986.)

30-5-103. Scope of podiatric services. Podiatric services shall be covered for medicaid recipients. (a) Covered services shall be diagnosis, and the manual, medical, surgical or pharmaceutical treatment of those parts of the body below the ankle. Diagnosis and treatment of tendons and muscles of the lower leg as they relate to conditions of the foot shall also be covered.

(b) Surgery shall be limited to that performed on an outpatient basis.

(c) Routine foot care shall not be covered. The effective date of this regulation shall be May 1, 1986. (Authorized by and implementing K.S.A. 1985 Supp. 39-708c; effective May 1, 1981; amended May 1, 1985; amended May 1, 1986; amended, T-87-5, May 1, 1986.)

30-5-104. Scope of psychological services. Psychological services shall be covered for medicaid recipients when provided by psychologists who are certified by the behavioral sciences regulatory board. (a) Office visits for EPSDT program participants shall be covered up to 36 hours per calendar year.

(b) Office visits for non-EPSDT program participants shall be covered up to 24 hours per calendar year.

(c) Special psychological services for EPSDT program participants shall be rendered pursuant to a plan approved by the agency. The plan shall require prior authorization, and shall not exceed a two-year period. Quarterly progress reports shall be submitted to the division of medical programs upon request. The plan shall be subject to a reimbursement limit established by the secretary.

(d) Inpatient hospital visits shall be limited to those ordered by the recipient's physician, and shall not exceed those allowable days for which the hospital is paid or would be paid if there were no spenddown requirements.

(e) Visits to intermediate care facilities by the psychologist shall be ordered by the recipient's physician as part of the plan of care. Visits to intermediate care facilities for mental retardation shall be limited to psychological testing and evaluation. Visits to intermediate care facilities for mental health shall be lim-

ited to psychological testing, evaluation, consultation and therapy.

(f) Psychological testing and evaluation shall not exceed six hours in any two consecutive calendar years, and may require prior authorization. The effective date of this regulation shall be May 1, 1986. (Authorized by and implementing K.S.A. 1985 Supp. 39-708c; effective May 1, 1981; amended May 1, 1982; modified, L. 1983 ch. 361, May 1, 1983; amended May 1, 1984; amended May 1, 1986; amended, T-87-5, May 1, 1986.)

30-5-105. Scope of hearing services. Hearing services shall be covered for medicaid recipients. (a) Medical diagnosis, audiological testing, and the fitting and dispensing of hearing aids and appropriate accessories shall be covered.

(b) A medical diagnosis shall be made by an ear specialist or by a general practitioner when an ear specialist is not easily available.

(c) Audiological testing shall be performed by a physician, audiologist, or a hearing aid dealer.

(d) Fitting, dispensing, and follow-up shall be performed by a hearing aid dealer.

(e) A hearing aid shall not be covered if the physician states that a medical condition contraindicates the effectiveness of an aid. The effective date of this regulation shall be May 1, 1986. (Authorized by and implementing K.S.A. 1985 Supp. 39-708c; effective May 1, 1981; amended May 1, 1986; amended, T-87-5, May 1, 1986.)

30-5-160. Scope of chiropractic services for adult medikan program recipients. Chiropractic services for adult medikan recipients shall be covered up to 12 office visits per calendar year. The effective date of this regulation shall be May 1, 1986. (Authorized by and implementing K.S.A. 1985 Supp. 39-708c; effective, T-84-8, March 29, 1983; effective May 1, 1984; amended May 1, 1985; amended May 1, 1986; amended, T-87-5, May 1, 1986.)

30-5-161. Scope of podiatric services for adult medikan program recipients. Podiatric services shall be covered up to 12 office visits per calendar year, and for nonelective surgery which is performed on an outpatient basis. The effective date of this regulation shall be May 1, 1986. (Authorized by and implementing K.S.A. 1985 Supp. 39-708c; effective, T-84-8, March 29, 1983; effective May 1, 1984; amended May 1, 1985; amended May 1, 1986; amended, T-87-5, May 1, 1986.)

30-5-162. Scope of psychological services for adult medikan program recipients. The scope of psychological services for adult medicaid program recipients shall be identical to the psychological services covered for adult medikan program recipients, except that psychological testing and evaluation shall be limited to six hours per three consecutive calendar years. The effective date of this regulation shall be May 1, 1986. (Authorized by and implementing K.S.A. 1985 Supp. 39-708c; effective, T-84-8, April 1, 1983; effective May 1, 1984; amended May 1, 1986; amended, T-87-5, May 1, 1986.)

Article 6.—MEDICAL ASSISTANCE PROGRAM— CLIENTS' ELIGIBILITY FOR PARTICIPATION

30-6-65. Automatic eligibles. To be automatically eligible for medical assistance, each person shall meet the general eligibility requirement of K.A.R. 30-6-63 and shall be: (a) Legally entitled to and receiving SSI benefits and shall meet the general eligibility requirements of residence;

(b) legally entitled to and receiving state (Kansas) supplemental payments related to SSI;

(c) determined by SSA to retain recipient status, although not currently receiving an SSI benefit;

(d) receiving public assistance (excepting emergency assistance) pursuant to article 4 of this chapter. Such recipients shall meet the general eligibility requirement of K.A.R. 30-6-55(d);

(e) not receiving public assistance for one of the following reasons:

(1) The person is eligible for less than \$10.00;

(2) the amount of recovery of an overpayment is greater than the budget deficit; or

(3) the person is eligible using prospective budgeting, but ineligible due to retrospective accounting of income;

(f) included in the assistance plan of a family which was receiving ADC, ADC-FC, or APW in at least three of the six months immediately preceding the month in which the family became ineligible for ADC, ADC-FC, or APW and which became ineligible solely because of increased earned income or increased hours of employment. Such recipients shall meet the general eligibility requirement of K.A.R. 30-6-55(d). Automatic eligibility for the medical assistance program shall continue for the four months immediately subsequent to the last month in which the family was eligible (legally entitled) to receive ADC, ADC-FC, or APW as long as a family member is employed and the family and the person remains ineligible for ADC, ADC-FC, or APW solely because of increased earned income or increased hours of employment. The receipt of an extra pay check due to an additional pay period within a calendar month shall not constitute an increase in earnings;

(g) included in the assistance plan of a family which was receiving ADC, ADC-FC, or APW in at least three of the six months immediately preceding the month in which the family became ineligible for ADC, ADC-FC, or APW as a result (in whole or in part) of collection or increased collection of support. Such recipients shall meet the general eligibility requirement of K.A.R. 30-6-55(d). Automatic eligibility for the medical assistance program shall continue for the four months immediately subsequent to the last month in which the family was eligible (legally entitled) to receive ADC, ADC-FC, or APW as long as the family remains ineligible for ADC, ADC-FC, or APW due to such collection or increased collection of support;

(h) mandated to receive inpatient treatment for tuberculosis;

(i) one who is not a public assistance recipient but

is receiving maintenance payments from youth services;

(j) included in the assistance plan of a family which became ineligible for ADC, ADC-FC, or APW solely because of the termination of the earned income disregards as provided in K.A.R. 30-4-111(e). Automatic eligibility for the medical assistance program shall continue for the nine months immediately subsequent to the last month in which the family was eligible (legally entitled) to receive ADC, ADC-FC, or APW;

(k) a non-ADC eligible child born on or after October 1, 1983 who is under five years of age and who meets the ADC income and resource requirements pursuant to article 4 of this chapter; or

(l) a child born to a mother eligible for and receiving medicaid at the time of birth for a period of up to one year. The child shall remain eligible so long as such mother remains eligible for medicaid and the child remains in the same household with the mother. The effective date of this regulation shall be May 1, 1986. (Authorized by and implementing K.S.A. 1985 Supp. 39-708c, 39-709; effective May 1, 1981; amended, E-82-19, Oct. 21, 1981; amended May 1, 1982; amended, T-84-8, March 29, 1983; amended May 1, 1983; amended, T-84-9, March 29, 1983; amended May 1, 1984; amended, T-85-26, Oct. 15, 1984; amended, T-85-34, Dec. 19, 1984; amended May 1, 1985; amended, T-86-19, July 1, 1985; amended May 1, 1986; amended, T-87-5, May 1, 1986.)

30-6-74. Persons whose needs are to be considered with the needs of the ADC child. The needs of the parents and all siblings who meet the criteria contained in K.A.R. 30-6-72 and 30-6-73, excluding step-siblings and SSI recipients, shall be included in determining the needs of the ADC child if the parents or siblings are living with the ADC child. An otherwise eligible caretaker relative other than a parent who is living with an eligible child shall not be excluded from participation in the medical assistance program on the basis that the individual is not incapacitated, or solely because the individual has a spouse. The effective date of this regulation shall be May 1, 1986. (Authorized by and implementing K.S.A. 1985 Supp. 39-708c, 39-709; effective May 1, 1981; amended, T-85-26, Oct. 15, 1984; amended May 1, 1985; amended May 1, 1986; amended, T-87-5, May 1, 1986.)

Article 10.—ADULT CARE HOME PROGRAM OF THE MEDICAID (MEDICAL ASSISTANCE) PROGRAM

30-10-29. Reimbursement for 24-hour nursing care. Adult care homes participating in the medicaid/medikan program shall be reimbursed for providing 24-hour nursing care subject to the following limitations: (a) Adult care homes which are currently providing 24-hour nursing care, whose costs are included in such home's rate but whose costs exceed the health care cost center limitation or the total cost center limitation shall be entitled to the difference in cost between a licensed nurse and a medication aide.

(continued)

(b) Adult care homes which are currently providing 24-hour nursing care, whose costs are included in such home's rate and which do not exceed the health care cost center limitations or the total cost center limitation shall not be entitled to any further reimbursement under this regulation.

(c) Adult care homes which are providing 24-hour nursing care but who do not have these costs included in the home's rate shall be reimbursed the difference in cost between a licensed nurse and a medication aide.

(d) Adult care homes shall be limited to an additional 16 hours of reimbursement per facility per day

for the difference in cost between a licensed nurse and a medication aide.

(e) Twenty-four hour nursing care reimbursement shall be provided in addition to an adult care home's current medicaid/medikan rate. The effective date of this regulation shall be May 1, 1986. (Authorized by and implementing K.S.A. 1985 Supp. 39-708c; effective, T-86-42, Dec. 18, 1985; effective, T-87-5, May 1, 1986.)
