#### Opinion No. 86-86

Drainage and Levees—Watershed Districts—Use of Absentee Ballots or Voter Proxy in Election of Directors.

Elections—Absentee Voting—Application to Watershed District Elections. Charles R. Rayl, Attorney for South Fork Watershed Joint District No. 76, Cottonwood Falls, June 5, 1986.

K.S.A. 1985 Supp. 24-1211, which provides for the election of directors of a watershed district at an annual meeting, states that elections shall be by ballot and that qualified voters shall be entitled to vote at any such meeting. Said statutory language does not authorize absentee ballots to be voted at said meeting, nor does it authorize the use of proxy voting. Cited herein: K.S.A. 1985 Supp. 24-1211; G.S. 1961 Supp. 25-1102, Repealed, L. 1967, ch. 208, § 19; K.S.A. 1985 Supp. 25-1115; K.S.A. 25-1117; 25-1119. BPA

#### Opinion No. 86-87

Crimes and Punishments—Code; Crimes Against The Public Safety—Confiscation and Disposition of Weapons. Ed E. Ritchie, Shawnee County Sheriff, Topeka, June 5, 1986.

A county may keep weapons seized under K.S.A. 21-4206 if they are usable in their current state to the law enforcement agency. If weapons are kept as county property, they may be traded only in limited circumstances. In all other circumstances the weapons must be destroyed or sold with the proceeds going to the state treasurer. Cited herein: K.S.A. 21-4206, 22-2512. BLB

#### NOTICE OF HEARING ON THE KANSAS STATE PLAN FOR THE NUTRITION EDUCATION AND TRAINING PROGRAM

The Kansas State Board of Education will conduct a public hearing at 1:30 p.m. Tuesday, July 8, in Room 121 of the Kansas State Education Building, 120 E. 10th, Topeka, to consider the proposed Kansas State Plan for the Nutrition Education and Training Pro-

gram for fiscal year 1987.

The proposed plan relates generally to the nutrition education needs, goals and objectives, activity plans, and budget for the 1987 fiscal year. Chapter one describes the needs assessment conducted in fiscal year 1980 and the ongoing needs assessment for the current year. It also includes a chart which summarizes problems identified in the needs assessment and the activities undertaken to address those problems. Chapter two specifies program goals and objectives, and activities designed to meet objectives. The budget is outlined in chapter three, and activities for fiscal year 1982 through fiscal year 1987 are summarized in chapter four.

A copy of the plan may be obtained by contacting the secretary of the State Board of Education, Kansas State Education Building, 120 E. 10th, Topeka 66612,

prior to the date of the hearing.

On the date of the hearing, all interested persons will be given a reasonable opportunity to present their views, either orally or in writing, in regard to the proposed plan. Individuals or organizations that cannot appear at the hearing may submit to the secretary, at least five days before the hearing, their views regarding the proposed plan by letter, regular audio cassette tape, or one-half inch VHS video cassette tape. Audio or video cassette tapes shall not exceed three minutes in length and shall be accompanied by a signed transcript. Persons using tapes shall first identify themselves in the tapes and state whether they represent only themselves or whether they represent a group. All comments received will be considered by the board. The hearing shall be conducted in compliance with the public hearing procedures of the board.

#### Sealed Bids

Sealed bids will be received by the undersigned, City Clerk of the City of Kansas City, Kansas, on behalf of the council at the Municipal Building, One Civic Center Plaza, 701 N. 7th, Kansas City, Kansas, until 10 a.m. C.D.T., on Tuesday, June 24, 1986, for the purchase of \$50,700,000 principal amount of internal improvement bonds, series 1986, of the city hereinafter described. All bids will be publicly opened and read at said time and place and will be acted upon by the governing body immediately thereafter.

#### **Bond Details**

The bonds will consist of fully registered bonds in the denomination of \$5,000 or any integral multiple thereof, dated June 16, 1986, and becoming due serially on April 1 and October 1 in the years as follows:

The bonds will bear interest from the date thereof at rates to be determined when the bonds are sold as hereinafter provided, which interest will be payable semiannually on April 1 and October 1 in each year, beginning on April 1, 1987.

#### Place of Payment and Bond Registration

The principal of and interest on the bonds will be payable in lawful money of the United States of America by check or draft of the Treasurer of the State of Kansas, Topeka, Kansas (the paying agent and bond registrar), to the registered owners thereof whose names are on the registration books of the bond registrar as of the 15th day of the month preceding each interest payment date. The bonds will be registered pursuant to a plan of registration approved by the city and the Attorney General of the State of Kansas. The bonds may be registered as fully registered certificated bonds or uncertificated (book entry) bonds at the option of each registered owner.

The city will pay for the fees of the bond registrar for registration and transfer of the bonds and will also pay for printing a reasonable supply of registered bond blanks. Any additional costs or fees that might be incurred in the secondary market, other than fees of the bond registrar, will be the responsibility of the bondholders

The type and denomination of the bonds and the names, addresses and social security or taxpayer identification numbers of the registered owners shall be submitted in writing by the successful bidder to the city and bond registrar not later than July 16, 1986. In the absence of such information, the city will deliver bonds in the denomination of each maturity registered in the name of the successful bidder.

#### **Redemption of Bonds Prior to Maturity**

Bonds maturing in the years 1992 to 1994, inclusive, shall become due without option of prior payment. At the option of the city, bonds maturing in the years 1995 and thereafter, may be called for redemption and payment prior to maturity in whole or in part in inverse order of maturity (selection of bonds within the same maturity to be by lot by the city in such equitable manner as it may determine) on October 1, 1994, or on any interest payment date thereafter at par.

Whenever the city is to select the bonds for the purpose of redemption, it shall, in the case of bonds in denominations greater than \$5,000, if less than all of the bonds then outstanding are to be called for redemption, treat each \$5,000 of face value of each such fully registered bond as though it were a separate bond of the denomination of \$5,000.

If the city shall elect to call any bonds for redemption and payment prior to the maturity thereof, the city shall publish once in a financial journal published in the city of New York, New York, a notice of the intention of the city to call and pay said bonds, the same being described by number and maturity, said notice to be published not less than 30 days prior to the date on which said bonds are called for payment. The city shall also give written notice of its intention to call and pay said bonds on a specified date, the same being described by number and maturity, said notice to be mailed by United States registered or certified mail addressed to the registered owners of said bonds to the State Treasurer of Kansas, and to the manager or managers of the underwriting account making the successful bid, each of said notices to be mailed not less than 30 days prior to the date fixed for redemption. If any bond be called for redemption and payment as aforesaid, all interest on such bond shall cease from and after the date for which such call is made, provided funds are available for its payment at the price hereinbefore specified.

#### **Conditions of Bids**

Proposals will be received on the bonds bearing such rate or rates of interest as may be specified by the bidders, subject to the following conditions: The same rate shall apply to all bonds of the same maturity. Each interest rate specified shall be a multiple of 1/8 or 1/20 of 1 percent. No interest rate shall exceed a rate equal to the 20 bond index of tax exempt municipal bonds published by Credit Markets in New York, New York, on the Monday next preceding the day on which the bonds are sold, plus 2 percent. The difference between the highest rate specified and the lowest rate

specified shall not exceed 2 percent. No bid of less than the par value of the bonds and accrued interest thereon to the date of delivery will be considered and no supplemental interest payments will be authorized. Each bid shall specify the total interest cost to the city during the life of the bonds on the basis of such bid, the premium, if any, offered by the bidder, and the net interest cost to the city on the basis of such bid. Each bid shall also specify the average annual net interest rate to the city on the basis of such bid.

#### **Basis of Award**

The award of the bonds will be made on the basis of the lowest net interest cost to the city, which will be determined by subtracting the amount of the premium bid, if any, from the total interest cost to the city. If there is any discrepancy between the net interest cost and the average annual net interest rate specified, the specified net interest cost shall govern and the interest rates specified in the bid shall be adjusted accordingly. If two or more proper bids providing for identical amounts for the lowest net interest cost are received, the governing body shall determine which bid, if any, shall be accepted, and its determination shall be final. The city reserves the right to reject all bids and to waive any irregularities in a submitted bid.

Authority, Purpose and Security

The bonds are being issued pursuant to K.S.A. 12-635 to 12-646a, inclusive; 12-685 to 12-690, inclusive; 13-1026; 13-1055a to 13-1055b, inclusive, all as may be amended; Home Rule Ordinance 64825, Home Rule Ordinance No. 63761, and Charter Ordinance No. 69 of the city, for the purpose of paying the cost of certain street lighting, bridge repairs, main trafficway and main trafficway connection improvements and certain other internal improvements within the city. The bonds and the interest thereon will constitute general obligations of the city, payable from ad valorem taxes which may be levied without limitation as to rate or amount upon all the taxable tangible property, real and personal, within the territorial limits of the city.

**Legal Opinion** 

The bonds will be sold subject to the unqualified approving opinion of Gaar & Bell, bond counsel, Overland Park, Kansas, a copy of which opinion will be printed on the reverse side of each bond. The cost of this legal opinion and the expenses of printing the bonds and legal opinion will be paid by the city. The legal opinion will state that the bonds will be payable from ad valorem taxes which may be levied without limitation as to rate or amount upon all of the taxable tangible property within the territorial limits of the city, and that, under existing law, the interest on said bonds is exempt from present federal income taxation. A manually signed original of each such opinion will be furnished without expense to the purchaser of the bonds at the delivery thereof.

**Delivery and Payment** 

The city will pay for printing the bonds and will deliver the same properly prepared, executed and registered without cost to the successful bidder within 40 days after the date of sale at such bank or trust

company in the contiguous United States of America as may be specified by the successful bidder. The successful bidder will also be furnished with a certified transcript of the proceedings evidencing the authorization and issuance of the bonds and the usual closing proofs, which will include a certificate that there is no litigation pending or threatened at the time of delivery of the bonds affecting their validity and a certificate relating to the completeness and accuracy of the official statement and notice of bond sale. Payment for the bonds shall be made in federal reserve funds, immediately subject to use by the city.

Refunding Issue Planned

On or about July 8, 1986, the city plans to offer for sale on a negotiated basis another series of general obligation bonds in the approximate principal amount of \$30,245,000 (the proposed refunding bonds). The proceeds from the sale of the proposed refunding bonds will be used to refund in advance of their maturities \$31,195,000 principal amount of the city's outstanding general obligation bonds. None of the proceeds from the sale of the proposed refunding bonds will be used to refund the bonds offered pursuant to this notice of bond sale. For further information concerning the city's plan to issue the proposed refunding bonds, see the information set forth in the preliminary official statement under the caption "Plan of Financing—Proposed Refunding Bonds."

**Pending Federal Legislation Concerning** 

**Tax-Exempt Obligations** 

On December 17, 1985, the U.S. House of Representatives passed H.R. 3838, the Tax Reform Act of 1985. The bill presently is pending in the Senate. The bill in its present form imposes additional requirements which must be satisfied in order for interest on obligations issued by or on behalf of state and local governments to be exempt from federal income taxation. Such requirements generally are effective for all obligations issued after December 31, 1985, and thus, if the bill becomes law in its present form, would be applicable to the bonds.

The bill is subject to change, and, if it becomes law, may contain requirements which differ from those contained in the bill in its present form. Therefore, there can be no assurance that the city will be able to comply with such requirements. The failure or inability of the city to comply with the requirements of the bill could jeopardize the tax-exempt status of the bonds from their date of issuance. Holders should be aware that in such event, the bonds are not callable, nor will the interest rate on the bonds be adjusted to

reflect the less of the tax exemption.

On March 14, 1986, a joint statement was issued by key congressional leadership and the Secretary of the Treasury with respect to the postponement, until September 1, 1986 (or the date of enactment of tax reform legislation, if earlier) of certain provisions of the bill. In reliance upon the joint statement, if the bonds are issued prior to September 1, 1986, or the date of enactment of tax reform legislation, if earlier,

the city does not intend to comply with the provisions of the bill for which the effective date was postponed.

On May 6, 1986, the Senate Finance Committee reported an amendment to the bill. According to a "Summary of Tax Reform Provisions and H.R. 3838," as ordered reported by the Senate Finance Committee and prepared by the Joint Committee on Taxation, the amendment will contain a provision under which "one-half of the reported proceeds of a corporation not otherwise included in the minimum tax base would be (treated as) as preference." The effect of such provision may be to subject the interest on the bonds held by corporations to the alternative minimum tax provisions of the bill for taxable years commencing after December 31, 1986.

#### Good Faith Deposit

Each bid shall be accompanied by a cashier's or certified check drawn on a bank located in the United States of America in the amount of \$1,014,000, payable to the order of the city to secure the city from any loss resulting from the failure of the successful bidder to comply with the terms of his bid. No interest will be paid upon the successful bidder's good faith check. Said check shall be returned to the bidder if his bid is not accepted. If a bid is accepted, said check will be held by the city until the bidder shall have complied with all of the terms and conditions of this notice, at which time the check will be returned to the successful bidder or paid to his order at the option of the city. If a bid is accepted but the city shall fail to deliver the bonds to the bidder in accordance with the terms and conditions of this notice, said check will be returned to the bidder. If a bid is accepted but the bidder defaults in the performance of any of the terms and conditions of this notice, the proceeds of such check will be retained by the city as and for liquidated damages.

#### **CUSIP** Numbers

It is anticipated that CUSIP identification numbers will be printed on certificated bonds or assigned to uncertificated bonds, but neither the failure to print such number on or assign such number to any bond nor any error with respect thereto shall constitute cause for failure or refusal by the purchaser thereof to accept delivery of and pay for the bonds in accordance with the terms of the purchase contract. All expenses in relation to the assignment and printing of CUSIP numbers on the bonds will be paid by the city.

#### **Bond Rating**

The outstanding general obligation bonds of the city are rated "A-1" by Moody's Investor Service, Inc., and "AA" by Standard & Poor's Corporation, and the city has applied for rating on the bonds herein offered for sale.

#### **Bid Forms**

All bids must be made on forms which may be procured from the city clerk or the financial adviser. No additions or alterations in such forms shall be made and any erasures may cause rejection of any bid. The city reserves the right to waive irregularities and to reject any and all bids.

#### Submission of Bids

Bids must be submitted in sealed envelopes addressed to the undersigned city clerk and marked "Proposal for the Purchase of Internal Improvement Bonds." Bids may be submitted by mail or delivered in person to the undersigned at the Municipal Building and must be received by the undersigned prior to 10 a.m. C.D.T., on June 24, 1986.

#### Official Statement

The city has prepared a Preliminary Official Statement dated June 17, 1986, copies of which may be obtained from the city clerk or from the financial adviser. Upon the sale of the bonds, the city will adopt the final official statement and will furnish the successful bidder with a reasonable number of copies thereof without additional cost upon request. Additional copies may be ordered by the successful bidder at his expense.

#### **Assessed Valuation and Indebtedness**

The total assessed valuation of the taxable tangible property within the city for the year 1985 is \$425,236,056. The total general obligation indebtedness of the city, as of the date of the bonds, including the bonds being sold, is \$136,797,864. Temporary notes in the principal amount of \$45,477,300 will be retired out of proceeds of the bonds and other available funds. Of the above total amount of indebtedness, \$28,609,153 of outstanding bonds and \$11,965,100 of outstanding temporary notes are exempt from the statutory debt limits.

#### **DEPARTMENT OF HEALTH** AND ENVIRONMENT

TEMPORARY ADMINISTRATIVE REGULATIONS (Effective May 1, 1986. Expire May 1, 1987.)

#### Article 16.—WATER POLLUTION CONTROL

28-16-28c. General provisions. (a) Antidegradation.

(1) Levels of water quality necessary to protect existing and designated uses shall be maintained in

surface waters of the state.

(2) If existing surface water quality is better than applicable water quality criteria established in these regulations, water quality shall not be lowered unless it has been determined, in accordance with procedures in K.A.R. 28-16-28f(c)(3), that the change is justified as a result of important social and economic development.

(3)(A) Existing water quality shall not be lowered by artificial sources in "outstanding natural resource waters of unique significance" listed in Table 1 of this

regulation.

(B) Except as provided in K.A.R. 28-16-28f(c)(3), no degradation of water quality by artificial sources shall be allowed that would result in harmful effects on populations of any threatened or endangered species of aquatic life or wildlife in a critical habitat as defined in the endangered species act of 1973 (PL 93-205) as amended, or in K.S.A. 32-501 through 510 and K.A.R. 23-17-1 and K.A.R. 23-17-2.

(C) Temporary sources of pollution complying with the provisions of K.A.R. 28-16-28c(d), and producing only ephemeral water quality degradation not harmful to existing and designated uses, may be allowed.

(4) Implementation of these antidegradation provisions for thermal discharges shall be consistent with Section 316 of the Clean Water Act.

(b) Mixing zones.

(1) The water quality criteria listed below shall apply beyond the mixing zone for each individual discharge, except that concentrations within the mixing zone area shall be maintained below acute toxicity levels for any parameter or combination of parameters. The total area, or volume, or both, of a receiving surface water which is assigned to mixing zones shall be limited to that which will:

(A) not interfere with biological communities or populations of important species to a degree which is damaging to the ecosystem; and

(B) not disproportionately diminish other beneficial uses.

(2) Zones of passage shall be provided wherever mixing zones are allowed. Such zones shall be continuous water routes of the volume, area, and quality necessary to allow passage of free-swimming and drifting organisms with no harmful effects on their populations.

(3) In streams where the ratio of stream flow to discharge is greater than 3:1 (flow:discharge), mixing zones shall be limited to no more than ¼ of the cross-sectional area, or volume of the stream, or both,

leaving at least ¾ free as a zone of passage.

(4) In streams in which the ratio of stream flow to discharge is equal to or less than 3:1 (flow:discharge), mixing zones shall be established on a case-by-case basis. More stringent treatment technology may be required, when necessary, to protect the designated uses of the surface water segment and to otherwise meet the requirements of these regulations.

(c) Special conditions. The following special conditions shall not remove the obligation to design, build, or use the required or recommended pollution control structures or methods to control point and nonpoint sources of pollution as defined in K.A.R. 28-16-28b(28), (30), and (31).

(1) Low flow. Classified surface waters shall be excluded from the application of K.A.R. 28-16-28e(c) when the receiving stream flow is less than the greater of the 7-day, 10-year low flow, or 1.0 cfs. The low flow exclusion shall also include consideration of the minimum desirable stream flow established pursuant to K.S.A. 82a-703(a).

(2) High flow. Classified surface waters shall be excluded from application of the numeric criteria for fecal coliform bacteria in K.A.R. 28-16-28e(c) when

stream flow exceeds 50% of the estimated two-year flood flow as determined by the department.

(3) Natural pollution. The criteria in K.A.R. 28-16-28d and K.A.R. 28-16-28e shall not apply to surface waters when the criteria for protection of designated uses are exceeded due to natural sources of pollution. Users of waters with natural pollution who subsequently discharge such water back to the same waters shall not be required to treat the effluent to pollutant concentrations below concentrations present at the point of diversion. However, such dischargers shall be required to meet treatment requirements of K.A.R. 28-16-28c(d).

(4) Effluent-created flows. When continuous stream flow is created primarily through the discharge of treated effluent, the discharger shall not be required to provide treatment beyond that required in K.A.R. 28-16-28c(d), except that any such discharge shall not result in public health hazards or nuisance conditions, or violations of any general criteria listed in K.A.R. 28-16-28e(b)(1), and shall not result in violations of criteria in K.A.R. 28-16-28e in the next downstream classified surface water segment.

(d) Treatment requirements.

(1) All discharge of effluent shall receive appropriate minimum levels of treatment as required by the Clean Water Act.

(2) Application of a higher treatment technology on any treated effluent discharge, above that which is necessary to meet the applicable water quality criteria in the receiving water, may be required when the department determines that this treatment is necessary to protect the public health or existing instream water uses or otherwise achieve the purpose of these regulations.

(3) When the department finds that nonpoint sources cause or may cause a violation of these regulations, suitable pollution control measures shall be required

(4) When application of the treatment requirements in K.A.R. 28-16-28c(d)(1) and (3) are insufficient to meet water quality criteria in K.A.R. 28-16-28e in a particular surface water segment, the segment shall be classified as "water quality limited" pursuant to K.A.R. 28-16-28f(f).

(e) Analytical testing. All methods of sample collection, preservation, and analysis used in applying any of these rules and regulations shall be in accordance with those prescribed by the department. (Authorized by K.S.A. 65-171d; implementing K.S.A. 1984 Supp. 65-165 and 65-171d; effective May 1, 1986; amended, T-87-8, May 1, 1986.)

Table 1. Surface waters contained in the following areas shall be classified as outstanding natural resource waters:

> (1) Cheyenne Bottoms Wildlife Area (Barton County; Little Arkansas River Basin);

(2) Cimarron National Grassland (Morton County; Cimarron River Basin);

Flint Hills National Wildlife Refuge (Coffey and Lyon counties; Neosho River Basin);

Kirwin National Wildlife Refuge (Phillips County; Solomon

River Basin); and

Ouivera National Wildlife Refuge (Stafford County; Lower Arkansas River Basin).

28-16-28d. Surface water use designation and classification. (a) Designated uses of surface waters are defined as follows:

(1) "Agricultural water supply use" means the use of surface water for agricultural purposes including:

(A) "Irrigation," which means the withdrawal of

surface water for application onto land; and (B) "Livestock watering," which means the provi-

sion of water to livestock for consumption.

(2) "Aquatic life use" means the use of surface water for the maintenance of the ecological integrity of native aquatic communities, including the maintenance and propagation of indigenous species of aquatic life and indigenous or migratory semi-aquatic life or wildlife that depend on the surface waters or its biota for survival and well-being.

(A) "Special aquatic life use waters" means surface waters containing unique combinations of habitat types and biota not found commonly in the State or that contain representative populations of threatened

or endangered species.

(B) "Expected aquatic life use waters" means surface waters containing habitat types and biota com-

monly found or expected in the area.

(C) "Restricted aquatic life use waters" means surface waters containing biota limited in abundance or diversity by the physical quality of the habitat compared to more suitable habitats in adjacent waters. These waters are limited by lack of habitat due to natural deficiencies or artificial modifications including channelization and loss of riparian vegetation.

(3) "Domestic water supply use" means the use of surface water after appropriate treatment, by public or private water supplies, to produce potable water.

(4) "Groundwater recharge use" means the use of treated or untreated effluent for groundwater aquifer recharge, including accidental or incidental recharge as a means of disposal of sewage.

(5) "Industrial water supply use" means the use of surface water for non-consumptive purposes by industry, including withdrawals for cooling or process

(6) "Recreation use" means the use of surface water for contact recreation, noncontact recreation, and con-

sumptive recreation as defined below.

(A) "Contact recreation use" means recreation where the body may come into direct contact with water to the point that ingestion is possible. This use includes swimming, skin diving, and water skiing. This subcategory of use shall be in effect from May 1 to October 31 of each year.

(B) "Noncontact recreation use" means recreation

where ingestion of water is not probable. This includes wading, boating, fishing and hunting.

(C) "Consumptive recreation use" means recreation resulting in the human consumption of species of aquatic life and semi-aquatic or terrestrial wildlife that depend on the surface water or its organisms for survival and well-being.

(b) Surface water classification. Surface waters shall

be classified as follows:

- (1) Classified lakes shall be all impoundments (lakes or reservoirs) owned by federal, state, county or municipal authorities and all privately owned impoundments where facilities for public recreation are provided and maintained, including impoundments created by artificial dams or quarries and natural waterbodies formed in depressions of internal drainages regardless of ownership. Impoundments (lakes or reservoirs) exempted by K.S.A. 65-171d shall not be classified lakes.
- (2) Classified wetlands shall be areas of shallow standing water that exist for most of the growing season of most years, that are capable of supporting emergent aquatic vegetation, and that are listed in Table 2 of this regulation.

(3) Classified streams and rivers shall be streams and rivers with mean summer base flows of greater

than 0.1 cfs including:

(A) springs that discharge into streams;

(B) alluvial aquifers; and (C) riparian wetlands.

Regardless of flow, the stream shall be classified if it is listed in Table 3 or if pooling during periods of zero stream flow provides important refuges of aquatic life for downstream segments or recolonization of the dried segment.

(c) Assignment of uses to surface waters. All classified waters as defined in K.A.R. 28-16-28d(b) shall be designated for all uses defined in K.A.R 28-16-28d(a) except as indicated in this subsection:

(1) Classified streams shall be designated for contact recreation only when that use currently exists as

listed in Table 3 of this regulation.

(2) Classified lakes shall be designated for contact recreation only when facilities are provided and maintained for body contact uses.

(3) Classified wetlands and riparian wetlands shall be designated for only noncontact recreation, con-

sumptive recreation, and aquatic life uses.

(4) Classified streams shall be designated for the special aquatic life use only when listed in Table 3 of this regulation.

(5) Classified streams shall be designated for restricted aquatic life use by the department on a caseby-case basis. (Authorized by K.S.A. 65-171d; implementing K.S.A. 1984 Supp. 65-165 and 65-171d; effective May 1, 1986; amended, T-87-8, May 1, 1986.)

28-16-28e. Water quality criteria for water protection. (a) Criteria development guidance. The development of surface water quality criteria for substances not listed in these standards shall be guided by water quality criteria published by the environmental protection agency, including the primary and secondary drinking water regulations found at 40 CFR 141 promulgated pursuant to PL 93-523, the safe drinking water act, and the ambient water quality criteria promulgated pursuant to Section 304(a) of PL 92-500 (the Clean Water Act). When the department finds the criteria listed herein are underprotective or overprotective for a given surface water segment, the department may in accordance with K.A.R. 28-16-28f(g) develop and apply appropriate site-specific criteria using bioassessment methods and procedures or other related scientific data.

(b) General criteria for surface waters.

(1) All surface waters shall be free, at all times, from the harmful effects of substances that originate from artificial sources and that produce any public health hazards or nuisance conditions, or impairment of uses.

(A) The harmful effects may result from:

(i) color producing substances;

(ii) heat or acidic or caustic substances;

(iii) visible oil and grease and dissolved or emul-

sified grease concentrations;

- (iv) deposits of solids, either organic or inorganic; floating debris; scum; and other floating materials attributable to municipal, industrial, or other waste disposal practices;
- (v) Taste and odor-producing substances that interfere with the production of potable water by reasonable water treatment processes, or impart unpalatable flavor to fish, or result in noticeable offensive odors in the vicinity of the water;
- (vi) Any concentration of a substance that causes toxic effects, alone or in combination with other artificial or natural substances. Such substances shall be limited to concentrations in the receiving water that will not be harmful to human, animal, or plant life.
- (B) Turbidity. There shall be no increase, of other than natural origin, in the turbidity of waters of the state, that will cause substantial visible contrast with the natural appearance of the water.

(2) General criteria for all classified waters.

(A) Nutrients. Artificial sources of nutrients shall not be detrimental to the designated uses.

(B) pH. Artificial sources shall not cause the pH of surface waters to be below 6.5 nor above 8.5.

(C) Temperature. Artificial sources shall not elevate the temperature of the receiving water above 90°F. Heat of artificial origin shall not be added to a stream in excess of the amount that will raise the temperature of the water more than 5°F above natural conditions. The epilimnion of lakes shall not be raised more than 3°F above that temperature which existed before the addition of heat of artificial origin. The normal daily and seasonal temperature variations before the addition of heat due to other than natural causes shall be maintained. Occasional, natural thermal conditions may exceed the maximum allowable temperature requirements.

(c) Criteria for specific designated uses.

(1) Agricultural water supply use.

(A) Irrigation. The water quality criteria for irrigation set forth in Table 4 shall not be exceeded.

(B) Livestock watering. The water quality criteria for livestock watering set forth in Table 4 shall not be exceeded. In the absence of specific livestock watering criteria, domestic water supply criteria or other available information on livestock requirements shall be used.

(2) Aquatic life use.

- (A) Dissolved oxygen. The concentration of dissolved oxygen shall not be lowered below 5.0 mg/l by the influence of artificial sources.
- (B) Nutrients. The discharge of concentrations or loadings of plant nutrients into surface waters from artificial sources shall be controlled to prevent water quality degradation that accelerates the natural succession or replacement of biota, or which produces undesirable quantities or kinds of aquatic life.
- (C) Suspended solids. Concentrations of suspended solids in surface waters by artificial sources shall not interfere with the behavior, reproduction, physical habitat, or other factors related to the survival and propagation of aquatic life, semi-aquatic life and wildlife.
- (D) Total residual chlorine. There shall be no detectable concentrations of total residual chlorine in surface waters as detected by method 408C (Amperometric) or 408D (DPD-FAS), which are hereby adopted by reference, and are found in the 16th edition of "Standard Methods for the Examination of Water and Wastewater" (American Public Health Association, 1985).

(E) Toxic substances.

(i) The concentrations of substances found in Table 4 and 5 shall not be exceeded at any time.

(ii) The waters of the state shall not be toxic as a result of the effects of substances originating from artificial sources, whether alone or in combination with other artificial or natural substances.

(iii) Criteria for the protection of predators, in terms of toxic levels in fish, published in "Water Quality Criteria" (National Academy of Sciences, National Academy of Engineering, 1973), which is hereby adopted by reference, shall be used as guidelines in assessing toxicity due to bioaccumulation.

(iv) When criteria for single compounds have not been published or are incomplete, or when complex mixtures can result in interactions among substances, the department shall utilize laboratory and field bioassessment methods and procedures to establish site-specific water quality criteria.

(F) Un-ionized Ammonia. Artificial sources shall not cause the un-ionized ammonia concentrations of surface waters to exceed 0.07 mg/l as NH<sub>3</sub>-N.

(3) Domestic water supply use. The criteria for the domestic water supply use shall apply at the point of domestic water supply diversion.

(A) The concentrations of substances in Table 4 shall not be exceeded. For pollutants not listed in Table 4, surface water quality shall be such that

drinking water standards for finished drinking water in K.A.R. 28-15-13 will not be violated.

- (B) Any concentration of a substance from artificial sources that, alone or in combination with other artificial or natural substances, causes toxic effects on humans shall be limited to non-harmful concentrations. Such substances include those known to be carcinogenic, mutagenic, or teratogenic.
- (C) Concentrations of carcinogenic substances shall be limited to levels that do not exceed a 0.000001 risk level (10<sup>6</sup>).
- (4) Groundwater recharge use. Water quality criteria for groundwater recharge shall be the criteria in paragraph (3) of this subsection for domestic water supply use. If background concentrations of substances inherent to the recharged aquifer are present and result from natural sources, water quality, at a minimum, shall be such that further degradation does not occur.
- (5) Industrial water supply use. Water quality criteria for industrial water supplies shall be determined on a case-by-case basis.
  - (6) Recreation use.
- (A) General. The discharge of concentrations or loadings of plant nutrients from artificial sources shall be controlled to prevent water quality degradation. Such degradation shall include objectionable algal

densities or algal byproducts, and nuisance growths of submersed, floating, or emergent aquatic vegetation,

(B) Contact recreation. The fecal coliform content due to artificial sources shall not exceed a geometric mean of 200 per 100 ml sample. The calculation shall be based on not less than five samples taken during separate 24-hour periods over not more than a 30-day period. No more than 10 percent of total samples taken during any 30-day period shall exceed 400 per 100 ml sample.

(C) Noncontact recreation. The fecal coliform content due to artificial sources shall not exceed 2,000 per

100 ml sample.

- (D) Consumptive recreation. Substances that can bioaccumulate through bioconcentration or biomagnification to toxic levels in aquatic life, semi-aquatic life or wildlife consumed by humans shall be limited in surface waters to concentrations that will result in no harm to humans upon consumption. FDA action levels defined in K.A.R. 28-16-28b(b)(19) for toxic substances in fish flesh, which are hereby adopted by reference, shall be used as guidelines to determine protection of this use.
- (d) Multiple uses. When more than one use and associated criteria applies to an individual classified surface water segment, the most stringent criteria shall be applied. (Authorized by K.S.A. 65-171d; implementing K.S.A. 1984 Supp. 65-165 and 65-171d; effective May 1, 1986; amended, T-87-8, May 1, 1986.)
