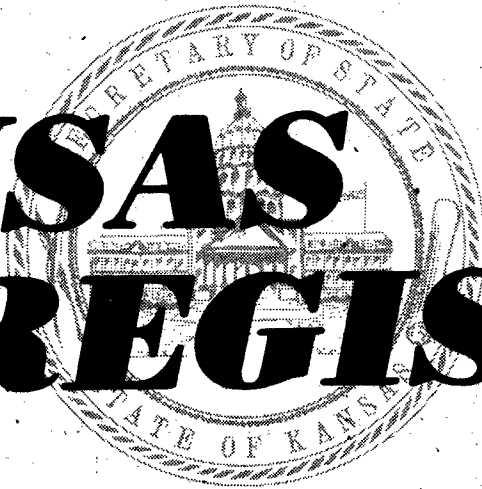

A public hearing will be conducted at 10 a.m. Monday, July 21, at the Kansas Department of Health and Environment, conference room, Building 321, Forbes Field, Topeka, to consider the adoption of the following proposed temporary and permanent regulations of the department.

K.A.R. 28-4-92 concerning licensing fees is amended to set a fee for license of \$15 for facilities licensed for 12 or fewer children, \$75 for facilities licensed for 13 or more children, and \$75 for child placing agencies, maternity centers, and day care referral agencies. The amended fees reflect the legislative mandate included in 1986 Senate Bill 672.

All interested parties may submit written comments prior to the hearing to the Director, Bureau of Adult and Child Care Facilities, Forbes Field, Topeka 66620. All interested parties will be given a reasonable time at the hearing to present their views orally in regard to the adoption of the proposed regulation. In order to give all parties an opportunity to present their views it may be necessary to limit each participant's presentation to five minutes. Following the hearing, all written and oral comments submitted by interested parties will be considered by the Secretary of Health and Environment as the basis for adopting the proposed regulation.

## Opinion No. 86-93

**Intoxicating Liquors and Beverages—Cereal Malt Beverages—License Application.** E. Edward Johnson, City Attorney, Topeka, June 24, 1986.

It would be improper for the governing body of a city to designate the city clerk or other administrative person to issue cereal malt beverage licenses. K.S.A. 41-2703, case law and opinions of this office provide that the issuance of a license requires some discretion and mandate that the governing body of a city must be the license grantor. The city of Medicine Lodge, Barber County, Kansas will receive sealed bids at City Hall, Medicine Lodge, Kansas, until 7 p.m. C.D.T., on Monday, July 14, 1986, for \$148,000 par value general obligation bonds, series 1986A, of the city, at which time and place such bids will be publicly opened. No oral or auction bids will be considered by the governing body.

**Terms of the Bonds**

The bonds will be dated August 1, 1986 and will mature serially on September 1 in the years and in the amounts set forth below. The bonds will consist of fully registered certificated bonds, each in the denomination of \$5,000 or integral multiples thereof not exceeding the principal amount of bonds maturing in the same year, except one bond which shall be in the denomination of \$8,000. Interest will be payable March 1, 1987 and thereafter semiannually on March 1 and September 1 of each year until their respective maturities.

The principal of the bonds will be payable at the office of the Treasurer of the State of Kansas (the paying agent and bond registrar) to the registered owners thereof upon presentation of the bonds for payment and cancellation. Interest on the bonds will be payable by check or draft of the paying agent to the registered owners appearing on the books maintained by the bond registrar as of the 15th day of the month preceding each interest payment date (the record dates). The fees of the bond registrar for registration and transfer of the bonds will be paid by the city.

The bonds will not be subject to redemption prior to their maturity and will mature serially as follows:

**Conditions of Bids**

Bids will be received for the bonds bearing such rate or rates of interest as may be specified by the bidder. The same rate will apply to all bonds of the same maturity. Each interest rate specified will be a multiple of 1/8 or 1/20 of 1 percent. The difference between the highest and lowest rates specified in any bid will not exceed 2.5 percent. No interest rate will exceed the maximum interest rate allowed by Kansas law, said rate being the 20 bond index of tax exempt municipal bonds published in the weekly Credit Markets in New York, New York, on the Monday next preceding the day on which the bonds are sold, plus 2

percent. No bid of less than par and accrued interest will be considered. Bids for less than the entire issue of bonds will not be considered.

**Bid Form and Good Faith Deposit**

Bids will be submitted on the official bid form furnished by the city and will be addressed to the city at City Hall, Medicine Lodge, KS 67104, Attention: Judy Miller, City Clerk, and will be plainly marked "Bond Bid." No changes to said form are authorized; changes or erasures thereon may cause rejection of any bid. Each bid will specify the total interest cost to the city on the basis of such bid and the average annual net interest rate on the basis of such bid. The net interest cost to the city will be determined by subtracting the amount of the premium, if any, from the total interest cost and will be stated as a dollar amount in the bid. The city will be entitled to rely on such dollar amount as stated in the bid as the basis of determining the lowest net interest cost. If there is any discrepancy between the said net interest cost and the average annual net interest rate specified, the specified net interest cost will govern and the rates specified in the bid will be adjusted accordingly.

All bids must state: (a) the total interest cost of the bid; (b) the premium, if any; (c) the net interest cost of the bid; and (d) the average annual interest rate. All of said information shall be certified by the bidder to be correct, and the city will be entitled to rely on the certification of correctness by the bidder. Each bid must be accompanied by a certified or cashier's check equal to 2 percent of the total amount of the bid, and shall be payable to Treasurer, City of Medicine Lodge, Kansas. In the event a bidder whose bid is accepted shall fail to perform under his contract for the purchase of the bonds from the city, said deposit shall be retained as liquidated damages. All checks of unsuccessful bidders shall be returned promptly.

**Award of Bids**

The sealed bids for the bonds will be opened publicly and only at the time and place specified in this notice. The city reserves the right to reject any and all of the bids, and to waive any irregularities. Unless all bids are rejected, the bonds will be awarded to the bidder whose proposal results in the lowest net interest cost to the city.

**Delivery of the Bonds**

The bonds, duly printed, executed and registered, will be furnished and paid for by the city. The bonds will be sold subject to the unqualified approving opinion of Jonathan P. Small, Chartered, bond counsel, of Topeka, Kansas, a copy of whose opinion will be printed on the reverse side of each bond. Manually signed originals of the opinion will be furnished without expense to the purchaser of the bonds at the delivery thereof. The cost of this legal opinion and the expense of printing the bonds will be paid by the city. Said legal opinion will contain a statement to the effect that the bonds constitute a general obligation of the city payable as to both principal and interest from ad valorem taxes which may be levied without limitation as to rate or amount upon all of the taxable tangible property within the territorial limits of the city and that, under existing law, the interest on the bonds will be exempt from present federal income taxation.

The number and denomination of bonds and names of the registered owners to be shown on the bonds initially delivered will be submitted in writing by the successful bidder to the bond registrar not later than seven days prior to the closing date.

The purchaser will be furnished with a complete transcript of proceedings evidencing the authorization and issuance of the bonds and the usual closing proofs, which will include a certificate that there is no litigation pending or threatened at the time of delivery of the bonds affecting their validity. Payment for the bonds will be made in immediately available funds. Delivery of the bonds will be made to the successful bidder on or before 30 days from the date of sale at any bank in the state of Kansas or Kansas City, Missouri, at the expense of the city. Delivery elsewhere will be made at the expense of the purchaser. The purchase price, together with any premium and accrued interest from the date of the bonds to the date of delivery, will be paid at delivery or the good faith deposit will be forfeited.

#### Pending Federal Tax Legislation

The United States House of Representatives on December 17, 1985 passed H.R. 3838, which contains amendments to Internal Revenue Code provisions applicable to tax exempt municipal bonds such as the bonds. These amendments are stated to be effective generally for bonds delivered after December 31, 1985, and therefore would apply to the bonds, if enacted.

However, on March 14, 1986, a joint statement was issued by House Ways and Means Chairman Representative Dan Rostenkowski; Senate Finance Chairman Senator Bob Packwood; Representative John J. Duncan, ranking member of the Ways and Means Committee; Senator Russell Long, ranking member of the Finance Committee; and Secretary of the Treasury James A. Baker, III, with respect to the effective dates of certain provisions of the comprehensive tax reform legislation (H.R. 3838) being considered by Congress. The joint statement endorses postponement until September 1, 1986 (or the enactment of tax reform legislation, if earlier) of the effective dates of certain provisions of H.R. 3838 for certain types of bonds.

The joint statement does not address the provision in H.R. 3838 providing for a possible minimum tax on interest on the bonds to property and casualty insurers in taxable years of such taxpayers beginning after December 31, 1987. It also does not address the provision in H.R. 3838 disallowing the deduction of interest paid by financial institutions which own tax exempt obligations.

The bill is subject to change, and if it becomes law could provide requirements differing from those contained in the bill in its present form. Therefore, there can be no assurance that the city will be able to comply with such requirements. The failure or inability of the city to comply with the requirements of the bill in final form could jeopardize the tax exempt status of the bonds. The bonds are not callable, nor will the interest rate on the bonds be adjusted to reflect the loss of the tax exemption.

The city will comply with those provisions of H.R. 3838 that were not addressed in the joint statement. The city will covenant to comply with all applicable

future laws, regulations, published rulings and court decisions which relate to the exemption from income tax of the interest on the bonds, to the extent any actions can be taken by the city to comply with such laws, regulations, published rulings and court decisions or otherwise to preserve such exemption. In the event the city is unable to comply with such laws, regulations, published rulings or court decisions, interest on the bonds may become taxable retroactively to the date of issuance. In the event that interest on the bonds becomes taxable, the city is not required to redeem or otherwise prepay the bonds.

The city will designate the bond as "qualified tax-exempt obligations" as defined in Section 802(a) of H.R. 3838, as passed by the United States House of Representatives on December 17, 1985. The city is a political subdivision that was in existence prior to October 23, 1985, and does not intend to issue qualified tax exempt obligations during calendar year 1986 in an amount exceeding \$10 million.

#### Purpose

These bonds are being issued pursuant to K.S.A. 12-631t *et seq.* for the purpose of financing a portion of the cost of certain improvements to the city's sanitary sewage disposal works serving the city at large.

#### CUSIP Identification Numbers

It is anticipated that CUSIP identification numbers will be printed on said bonds. All expenses in relation to printing of CUSIP numbers on said bonds and the expenses of CUSIP Service Bureau for the assignment of said numbers shall be the responsibility of and shall be paid for by the city. However, the failure to print such numbers or assign such number to any bond or an error occurring regarding the same shall not constitute cause for failure or refusal by the purchaser of the bonds to accept delivery of and pay for the bonds pursuant to the contract for purchase of the bonds.

#### Assessed Valuation and Bonded Indebtedness

The total assessed valuation of the taxable tangible property within the city for the year 1986 for the computation of limits upon bonded indebtedness is \$4,799,015. The total general obligation bonded indebtedness of the city as of this date, including this \$148,000 proposed issue of bonds, is \$1,280,042.57. Temporary notes in the principal amount of \$196,042.57 will be retired out of the proceeds of the bonds and other available funds.

**GENERAL OBLIGATION SCHOOL BONDS  
SERIES 1986**

Unified School District 278, Jewell County, Kansas will receive sealed bids at the office of the district clerk, 301 N. West St., Mankato, Kansas, until 3 p.m. C.D.T., on July 14, 1986, for the purchase of \$250,000 par value general obligation school bonds of the district, at which time, and place such bids will be publicly opened. No oral or auction bids will be considered.

The series 1986 bonds initially issued will be dated as of August 1, 1986, and shall mature on September 1 in each of the years and in the amounts set forth below. Such bonds shall consist of fully registered certificated bonds, each in the denomination of \$5,000 or integral multiples thereof not exceeding the principal amount of bonds maturing in each year. Interest will be payable semiannually, commencing September 1, 1987, and each March 1 and September 1 thereafter. The principal of, and premium, if any, on the bonds shall be payable in lawful money of the United States of America at the principal office of the Treasurer of the State of Kansas (the paying agent and bond registrar) to the registered owners thereof upon presentation of the bonds for payment and cancellation. Interest on the bonds shall be payable in lawful money of the United States of America, by check or draft of the paying agent to the registered owners appearing on the books maintained by the bond registrar as of the 15th day of the month next preceding the interest payment dates (the record dates). The fees of the bond registrar for registration and transfer of the bonds shall be paid by the district.

The bonds will mature serially in accordance with the following schedule:

At the option of the district, bonds maturing on and after September 1, 1992 will be subject to redemption and payment prior to maturity on September 1, 1991 and thereafter in whole or in part on any interest payment date thereafter at the redemption price of 101.5 percent plus accrued interest to the redemption date.

If the district shall elect to call any bond for redemption and payment prior to the maturity thereof, the district shall give written notice of its intention to redeem and pay said bonds on a specified date, the

same being described by number and maturity, said notice to be mailed by United States registered or certified mail addressed to the registered owners of said bonds to the State Treasurer of Kansas and to the manager or managers of the underwriting account making the successful bid, each of said notices to be mailed at least 30 days prior to the redemption date. If any bond be called for redemption and payment as aforesaid, all interest on such bonds shall cease.

Whenever bonds of less than a single maturity are to be redeemed, the paying agent and bond registrar shall select bonds by lot in multiples of \$5,000 principal amount in such equitable manner as it shall designate and shall, in the case of bonds in denominations greater than \$5,000, treat each \$5,000 of face value of each bond as though it were a separate bond of the denomination of \$5,000.

Proposals will be received on the bonds bearing such rate or rates of interest, not exceeding eight different interest rates, as may be specified by the bidder. The repetition of a rate will not constitute one of said maximum number of rates. The same rate shall apply to all bonds of the same maturity. Each interest rate specified shall be in an even multiple of 1/8 or 1/20 of 1 percent. The difference between the highest and lowest rates specified in any bid shall not exceed 2 percent. No interest rate shall exceed the maximum interest rate allowed by Kansas law, said rate being 2 percent above the 20 bond index published in Credit Markets on Monday, July 7, 1986, and no bid of less than par and accrued interest will be considered. Bids for less than the entire issue of bonds will not be considered.

Bids shall be submitted on the official bid form furnished by the district, and shall be addressed to the district at 301 N. West St., Mankato, Kansas, plainly marked "Bond Bid." All bids must state the total interest cost of the bid, the premium, if any, the net interest cost of the bid, and the average annual interest rate, all certified by the bidder to be correct, and the district will be entitled to rely on the certificate of correctness of the bidder. Each bid must be accompanied by a certified or cashier's check equal to 2 percent of the total amount of the bid, and shall be payable to Unified School District 278. In the event a bidder whose bid is accepted shall fail to carry out his contract of purchase, said deposit shall be retained by the district as liquidated damages. The checks of unsuccessful bidders will be returned promptly.

The bonds, duly printed, executed and registered, will be furnished and paid for by the district and sold subject to the unqualified approving opinion of Nichols and Wolfe Chartered, Topeka, Kansas, bond counsel, whose opinion will be paid for by the district.

On December 17, 1985, the U.S. House of Representatives passed H.R. 3838, the Tax Reform Act of 1985. The bill, which presently is pending in the United States Senate, contains a number of requirements which generally are effective for all state and local obligations issued after December 31, 1985, and, if the bill becomes law in its present form, would be applicable to the bonds.

The bill is subject to change, and if it becomes law



may contain requirements which differ from those contained in the bill in its present form. Therefore, there can be no assurance that the issuer will be able to comply with such requirements. The failure or inability of the issuer to comply with the requirements of the bill could jeopardize the tax exempt status of the bonds from their issuance date. Bondowners should be aware that in such event, the bonds are not callable, nor will the interest rate on the bonds be adjusted to reflect the loss of the tax exemption.

On March 14, 1986, a joint statement was issued by key congressional leadership and the Secretary of the Treasury with respect to the postponement, until September 1, 1986 (or the date of enactment of tax reform legislation, if earlier), of certain provisions of the bill. In reliance upon the joint statement, the district does not intend to comply with the provisions of the bill for which the effective date was postponed.

With respect to Section 802 of the bill, relating to interest incurred by financial institutions to carry tax exempt bonds, the district intends to designate the bonds as qualified project bonds for purposes of Section 802(e) of the bill.

The number, denomination of bonds and names of the initial registered owners shall be submitted in writing by the successful bidder to the bond registrar not later than August 1, 1987.

The purchaser will be furnished with a complete transcript of proceedings evidencing authorization and issuance of the bonds, and the usual closing proofs, which will include a certificate that there is no litigation pending or threatened at the time of delivery of the bonds affecting their validity. Payment for the bonds shall be made in immediately available funds. Delivery of the bonds will be made to the successful bidder on or before August 15, 1986 at any bank in the state of Kansas or Kansas City, Missouri, at the expense of the district. Delivery elsewhere will be made at the expense of the purchaser.

The bonds will constitute general obligations of the district and will be payable from ad valorem taxes which may be levied without limitation as to rate or amount upon all of the taxable, tangible property within the territorial limits of the district. The series 1986 bonds are being issued for the purpose of paying the cost of removal or encapsulation of friable asbestos-containing material and the costs of any remodeling, replacement or other restoration necessitated by such removal or encapsulation.

The sealed bids for the bonds shall be opened publicly and only at the time and place specified in this notice. The district reserves the right to reject any and all of the bids, and to waive any irregularities. Unless all bids are rejected, the bonds will be awarded to the bidder whose proposal results in the lowest net interest cost to the district, and the net interest cost will be determined by deducting the amount of any premium paid from the aggregate amount of interest upon all of the bonds from their date until their respective maturities.

The total assessed valuation of the taxable tangible property within the district (including estimated motor vehicle valuation and motor vehicle dealers'

inventory valuation) for the year 1985 is \$7,596,303. The total general obligation bonded indebtedness of the district, at the date hereof, including this proposed issue of bonds, is \$250,000.

It is anticipated that CUSIP identification numbers will be printed on the bonds, but neither the failure to print such number or assign a number to any bond nor any error with respect thereto shall constitute cause for failure or refusal by the purchaser thereof to accept delivery of and pay for the bonds. All expenses incurred in connection with the printing of CUSIP numbers on the bonds and the expenses of the CUSIP Service Bureau for the assignment of said numbers shall be paid for by the district.
