A public hearing will be conducted at 11 a.m. Friday, August 8, in Conference Room B of the Kansas State Board of Agriculture, 109 S.W. 9th, Topeka, at which time all interested persons will have the opportunity to be heard regarding the adoption of a proposed amendment to K.A.R. 4-7-213. This amendment will become effective May 1, 1986 as a permament rule and regulation and as a temporary rule and regulation upon approval by the Rules and Regulations Board.

The proposed amendment adopts by reference federal changes in standards and procedures regarding milk for manufacturing purposes which include reducing the allowable number of somatic cells in producer milk from 1,500,000 per ml. to 1,000,000 per ml.

All interested persons may attend the hearing and will be given an opportunity to express comments either orally or in writing, or both. Those persons unable to attend may submit comments in writing to the Division of Inspections of the Kansas State Board of Agriculture at or before the time of the hearing. Prior notice is requested for those who wish to present testimony in person at the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

Opinion No. 86-99

Intoxicating Liquors and Beverages—Licensing and Related Provisions; City Option—Ability of a Retail Liquor Licensee to be a Riley County Commissioner. John A. Lamb, Director, Alcoholic Beverage Control, Department of Revenue, Topeka, July 14, 1986.

Though K.S.A. 1985 Supp. 41-311(a)(7) provides that no license for the retail sale of alcoholic liquor shall be issued to a person who appoints or is a law enforcement official, the prohibitive mandates and layers of procedure found in Kansas statutory law create an attenuation sufficient to allow a retail liquor licensee to hold the office of Riley County Commissioner under specified circumstances. As a commissioner/licensee, the person should not serve on the county law enforcement agency established pursuant to K.S.A. 19-4427 et seq., nor vote in selecting the commissioner and county resident who are to serve upon the agency. These actions, coupled with existing law, would remove the person from the prohibition of K.S.A. 1985 Supp. 41-311(a)(7), thus allowing the person to serve as a commissioner while holding a retail liquor license. Elections—Conduct of Elections—Procedure for Filling Vacancy in Office of Judge of the District Court. Jack H. Brier, Secretary of State, Topeka, July 15, 1986.

K.S.A. 1985 Supp. 25-312a provides that a vacancy in the office of judge of the district court shall be filled at the next general election that occurs more than 30 days after such vacancy. Where such vacancy occurs in the office of district judge, which office was not subject to election at the next general election, and the vacancy occurs after the filing deadline but prior to the primary, a party candidacy is created as provided in K.S.A. 25-3906. Pursuant to that statute, such vacancy in a party candidacy shall be filled by district convention held as provided in K.S.A. 25-3904. Since in this instance, the office of district judge was not subject to election at the next general election, no party had a candidate running for the position of district judge. Consequently, each party may place a candidate on the ballot pursuant to the district convention procedure. The person elected at the general election to the position of district judge will commence his or her official duties on the second Monday in January, 1987, and will serve for the remainder of the unexpired term. Laws, Journals and Public Information—Records Open to Public—Records Subject to Disclo-

sure. Peter E. Rinn, Chief Counsel, Department of Social and Rehabilitation Services, Topeka, July 15, 1986.

It is the public policy of this state that public records must be open for inspection by any person unless otherwise provided by law. In that the exceptions listed in the KORA are not applicable to the information in question and disclosure of the information is not prohibited by statute, we must conclude that the financial information contained in reports submitted by an adult care home to SRS is subject to disclosure under the Kansas Open Records Act. EXECUTIVE ORDER NO. 86-86 ESTABLISHING THE STATE TASK FORCE ON PARIMUTUEL

WHEREAS, parimutuel wagering operations on dog races have been held by the Supreme Court of Kansas to be prohibited by Article 15, Section 3 of the Constitution of the State of Kansas [State, ex rel. v. Bissing, 178 Kan. 111]; and

WHEREAS, the 1986 Session of the Legislature of Kansas adopted House Concurrent Resolution No. 5024, which allows the people of Kansas to vote in November of 1986 as to whether or not the Legislature would be permitted to provide for county option in parimutuel wagering on horse and dog races in Kansas; and

WHEREAS, detailed study and recommendations should be conducted as to the implementation of parimutuel wagering on horse and dog races in Kansas and recommendations should be submitted to the Governor and the 1987 Session of the Legislature as to appropriate statutory changes necessary if the amendment to the Constitution is approved by the people.

NOW, THEREFORE, pursuant to the authority vested in me as Governor and chief executive of the

State of Kansas, I hereby create and establish the State Task Force on Parimutuel, composed of the following nine (9) members:

(1) Five (5) members of the general public appointed by the Governor, who shall have general expertise in business, real estate development, promotion or the care or breeding of

horses or dogs; and

(2) Four (4) members of the Legislature selected by the Legislative Coordinating Council and appointed by the Governor, so that two (2) are members of the Senate and two (2) are members of the House of Representatives and not more than two (2) are members of the same political party.

The Governor shall designate one of the members of the general public as Chairperson. The Task Force shall meet on call of the Chairperson. The Task Force

shall have as a general charge to:

(1) Conduct a comprehensive study and review of the parimutuel wagering statutes enacted by

other states;

(2) Identify the areas that need to be adressed in the 1987 Session of the Legislature regarding the regulation, licensing and taxation of horse and dog races and parimutuel wagering operations in Kansas; and

(3) Recommend implementing legislation to be considered by the Legislature should the amendment to the Constitution be approved.

General public members of the Task Force shall serve with no compensation at the pleasure of the Governor. Legislative members of the Task Force may receive compensation and shall serve at the pleasure of the Governor. Staff support shall be provided by the Department of Revenue or other agencies designated by the Governor. Other expenses of the Task Force may be paid by the Department of Revenue upon vouchers approved by the Secretary of Revenue or designee, the Legislative Coordinating Council upon vouchers approved by the Chairman of the Council or designee, or other agencies designated by the Governor upon vouchers approved by the head of such agency or designee and the Governor or designee.

The Study, Report and Recommendations of the Task Force shall be compiled and presented to the Governor not later than November 5, 1986.

From and after March 1, 1987, the State Task Force on Parimutuel created and established by this Executive Order is hereby abolished; and the force and effect of this Executive Order is thereafter rescinded.

This document shall be filed with the Secretary of State as Executive Order No. 86-86 and shall become effective immediately.

The KDHE has received final authorization to administer all portions of the RCRA permit program except for the Hazardous and Solid Waste Amendments of 1984 (HSWA), which EPA retains authority. The EPA portion of the joint permit addresses HSWA requirements. The joint permit would allow for operation of an incinerator, container storage area, and an underground injection well disposal facility. The wastes handled at these facilities are generated on site by chemical manufacturing operations.

The repetition of a rate will not constitute one of said maximum number of rates. The same rate shall apply to all bonds of the same maturity. In the event a bidder whose bid is accepted shall fail to carry out his contract of purchase, said deposit shall be retained by the city as liquidated damages. The checks of unsuccessful bidders will be returned promptly.

The bonds, duly printed, executed and registered, will be furnished and paid for by the city, and the bonds will be sold subject to the unqualified approving opinion of Nichols and Wolfe Chartered, Topeka, Kansas, bond counsel, whose opinion will be paid for by the city, printed on the bonds and delivered to the successful bidder as and when the bonds are deliv-

ered.

On December 17, 1985, the United States House of Representatives passed H.R. 3838, the Tax Reform Act of 1985. The bill contains a number of requirements which generally are effective for all state and local obligations issued after December 31, 1985, and if the bill becomes law in its present form would be applicable to the bonds. On June 24, 1986, the U.S. Senate passed an amendment in the nature of a substitute to the bill which would provide among other things that one-half of the reported proceeds of a corporation not otherwise included in its minimum tax base would be treated as a preference item. The effect of such provision may be to subject interest on the bonds, if held by a corporation, to alternative minimum taxation for taxable years commencing after December 31, 1986. It is anticipated that the House and Senate versions of the bill will next be considered by a House-Senate conference committee.

The bill is subject to change, and if it becomes law may contain requirements which differ from those contained in the bill in its present form. Therefore, there can be no assurance that the city will be able to comply with such requirements. The failure or inability of the city to comply with the requirements of the bill could jeopardize the tax exempt status of the bonds from their issuance date. Bondowners should be aware that in such event, the bonds are not callable, nor will the interest rate on the bonds be adjusted to reflect the loss of the tax exemption.

On March 14, 1986, a joint statement was issued by key congressional leadership and the Secretary of the Treasury with respect to the postponement, until September 1, 1986 (or the date of enactment of tax reform legislation, if earlier) of certain provisions of

the bill. In reliance upon the joint statement, the city does not intend to comply with the provisions of the bill for which the effective date was postponed.

With respect to Section 802 of the bill, relating to interest incurred by financial institutions to carry tax exempt bonds, the city intends to designate the bonds as "qualified project bonds" for purposes of Section 802 of the bill.

The number, denomination of bonds and names of the initial registered owners shall be submitted in writing by the successful bidder to the bond registrar not later than August 19, 1986. In the absence of such information, the city will deliver bonds in the denomination of each maturity registered in the name of the successful bidder.

The purchaser will be furnished with a complete transcript of the proceedings evidencing authorization and issuance of the bonds, and the usual closing proofs, which will include a certificate that there is no litigation pending or threatened at the time of delivery of the bonds affecting their validity. The bonds will bear interest at rates to be determined when the bonds are sold as hereinafter provided, which interest will be payable semiannually on April 1 and October 1 in each year, beginning on April 1, 1987.

Place of Payment and Bond Registration

The principal of and interest on the bonds will be payable in lawful money of the United States of America by check or draft of the Treasurer of the State of Kansas, Topeka, Kansas (the paying agent and bond registrar). Conditions of Bids

Proposals will be received on the bonds bearing such rate or rates of interest as may be specified by the bidders, subject to the following conditions: The same rate shall apply to all bonds of the same maturity. Each interest rate specified shall be a multiple of 1/8 or 1/20 of 1 percent. No interest rate shall exceed a rate equal to the 20 bond index of tax exempt municipal bonds

published by Credit Markets in New York, New York, on the Monday next preceding the day on which the bonds are sold, plus 2 percent. The difference between the highest rate specified and the lowest rate specified shall not exceed 1.5 percent. No supplemental interest payments will be authorized. No bid of less than the principal amount of the bonds and accrued interest will be considered. Each bid shall specify the total interest cost to the city during the life of the bond issue on the basis of such bid, the premium, if any, offered by the bidder, and the net interest cost to the city on the basis of such bid. Each bid shall also specify the average annual net interest rate to the city on the basis of such bid.

Basis of Award

The award of the bonds will be made on the basis of the lowest net interest cost to the city, which will be determined by subtracting the amount of the premium bid, if any, from the total interest cost to the city. If there is any discrepancy between the net interest cost and the average annual net interest rate specified, the specified net interest cost shall govern and the interest rates specified in the bid shall be adjusted accordingly. Authorization, Purpose and Security for the Bonds The bonds are being authorized and issued to provide funds to permanently finance various internal improvements to the city. Pending Federal Tax Legislation

On December 17, 1985, the U.S. House of Representatives passed H.R. 3838, the Tax Reform Act of 1985. The bill in its present form would impose additional requirements which must be satisfied in order for interest on obligations issued by or on behalf of state and local governments to be exempt from federal income taxation. Such requirements generally are effective for all obligations issued after December 31, 1985, and thus, if the bill becomes law in its present form, would be applicable to the bonds.

(continued)

On March 14, 1986, a joint statement was issued by key congressional leadership and the Secretary of the Treasury of the United States concerning a delay in the effective date of certain provisions of the bill. The city has relied on the joint statement in issuance of the bonds.

On June 24, 1986, the U.S. Senate passed an amendment in the nature of a substitute to the bill which would provide, among other things, that one half of the reported proceeds of a corporation not otherwise included in its minimum tax base would be treated as a preference item. The effect of such provision may be to subject interest on the bonds, if held by a corporaton, to alternative minimum taxation for taxable years commencing after December 31, 1986. It is anticipated that the House and Senate versions of the bill will next be considered by a House-Senate conference committee. The bill is subject to change, and if it becomes law may contain requirements which differ from those contained in the bill as passed by the U.S. House of Representatives or as amended by the U.S. Senate. Therefore, there can be no assurance that the city will be able to comply with such requirements. The failure or inability of the city to comply with the requirements of the bill could jeopardize the tax exempt status of the bonds from its issuance date. The owners of the bonds should be aware that in such event, the bonds are not callable, nor will the interest rate on the bonds be adjusted to reflect the loss of the tax exemption.

Delivery and Payment

The city will pay for printing the bonds and will deliver the bonds, without cost to the successful bidder, properly prepared, executed and registered, on or prior to August 15, 1986, at such bank or trust company in the contiguous United States of America as may be specified by the successful bidder. Said bidder will also be furnished with a certified transcript of the proceedings evidencing the authorization and issuance of the bonds and the usual closing documents, including a certificate that there is no litigation pending or threatened at the time of delivery of the bonds affecting their validity and a certificate regarding the completeness and accuracy of the official statement. Payment for the bonds shall be made in federal reserve funds, immediately subject to use by the city. The denominations of the bonds and the names, addresses and social security or taxpayer identification numbers of the registered owners shall be submitted in writing by the successful bidder to the city and bond registrar at least 10 days prior to the date of delivery of the bonds. In the absence of such information, the city will deliver bonds in the denomination of each maturity registered in the name of the successful bidder.

Good Faith Deposit

Each bid shall be accompanied by a cashier's or certified check drawn on a bank located in the United States of America in the amount of \$184,500 payable to the order of the city to secure the city from any loss resulting from the failure of the bidder to comply with the terms of his bid. No interest will be paid upon the

deposit made by the successful bidder. Said check shall be returned to the bidder if his bid is not accepted. If a bid is accepted, said check shall be held by the city until the bidder shall have complied with all of the terms and conditions of this notice, at which time said check shall be returned to the successful bidder or deducted from the purchase price at the option of the city. If a bid is accepted but the city shall fail to deliver the bonds to the bidder in accordance with the terms and conditions of this notice, said check shall be returned to the bidder. If a bid is accepted but the bidder shall default in the performance of any of the terms and conditions of this notice, the proceeds of such check will be retained by the city as and for liquidated damages.

CUSIP Numbers

CUSIP identification numbers will be printed on the bonds, but neither the failure to print such number on any bond nor any error with respect thereto shall constitute cause for failure or refusal by the purchaser thereof to accept delivery of and pay for the bonds in accordance with the terms of this notice. All expenses in relation to the assignment and printing of CUSIP numbers on the bonds will be paid by the city.

Bond Ratings

The outstanding general obligation bonds of the city are rated "Aal+" by Moody's Investor Service, Inc., and the city has applied for rating on the bonds herein offered for sale.

Bid Forms

All bids must be made on forms which may be procured from the city clerk. No additions or alterations in such forms shall be made and any erasures may cause rejection of any bid. The city reserves the right to waive irregularities and to reject any and all bids.

Submission of Bids

Bids must be submitted in sealed envelopes addressed to the undersigned city clerk and marked "Proposal for the Purchase of General Obligation Bonds." Bids may be submitted by mail or delivered in person to the undersigned at the City Hall and must be received by the undersigned prior to noon C.D.T. on Tuesday, July 29, 1986.

Official Statement

Upon the sale of the bonds, the city will adopt an official statement in substantially the form as the preliminary official statement subject to minor amendments and supplementation. Copies of the city's preliminary official statement relating to the bonds may be obtained from the city clerk or the city's financial adviser, Shearson Lehman Brothers Inc., 2345 Grand Ave., Suite 1600, Kansas City, MO 64112, (816) 346-6114. Upon request, a reasonable number of copies of the official statement will be made available to the successful bidder without charge. Additional copies may be obtained at the expense of such bidder.

Assessed Valuation and Indebtedness

The total assessed valuation of the taxable tangible property within the city for the year 1985 is

\$420,864,108. The total general obligation bonded indebtedness of the city as of the date of the bonds, including the bonds, is \$75,561,000, including, as of the date of the bonds, temporary notes outstanding in the principal amount of \$10,500,000, of which \$9,220,000 will be retired out of the proceeds of the bonds herein offered for sale. The city has also authorized the sale of \$6,500,000 principal amount of its temporary notes, series 1986-B, dated August 1, 1986, as described in the city's preliminary official statement relating to said notes, copies of which may be obtained from the city clerk or the financial adviser. In accordance with the financial adviser's agreement

with the city, the financial adviser will not be submitting a bid or participating in a group submitting a bid for the purchase of the bonds.
