Opinion No. 87-88

Cities and Municipalities—Parks, Public Squares, and Market Squares—Land for Park Purposes; Acquisition by Lease. Gerald E. Williams, Lenexa City Attorney, Overland Park, June 9, 1987.

K.S.A. 12-1301 empowers a city to acquire by lease land to be used as a public park for the use and benefit of the people of the city. As long as the lease specifies that the city's obligation is limited to periodic payments made from funds budgeted and appropriated for that purpose, the cash-basis law is not a barrier to such an agreement. In the absence of contrary legislation, the home rule powers conferred upon cities by Article XII, § 5 of the Kansas Constitution empower a city to sublease public park land to an individual for the purpose of constructing and maintaining a public golf course. A public hearing will be conducted at 1:30 p.m. Monday, June 29, in the Kansas Insurance Department, 420 S.W. 9th, Topeka, to consider the adoption of proposed temporary regulations of the Insurance Department.

Copies of the full text of the regulations and the fiscal impact statements may be obtained by writing to the Commissioner of Insurance, 420 S.W. 9th, Topeka 66612. The following is a summary of the regulations:

K.A.R. 40-1-36. This regulation is necessary to prevent unfair discrimination among applicants for life and health insurance who may be suspected of having AIDS or AIDS Related Complex.

K.A.R. 40-10-15. This regulation is intended to clarify House Bill 2377 as enacted by the 1987 session of the Kansas Legislature. Section 1, subsection (5) of this bill includes a formula to be used to calculate the way firefighters relief taxes are to be apportioned to so-called nonreceiving firefighters relief associations. It is possible to read this formula in such a way that one of the calculations included in the legislative enactment would never be used. Thus, the proposed regulation will simply assure that the formula will be applied in a correct manner.

All interested parties may submit written comments prior to the hearing to the Commissioner of Insurance. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed temporary regulations during the hearing.

K.A.R. 109-1-1 is amended to define "unprofessional conduct" for attendants.

K.A.R. 109-2-5 is amended to require that "every person subject to this act" be in compliance with certain requirements for operating an ambulance service.

K.A.R. 109-2-6 is amended to create a new level of service, Type II-D (defibrillator).

K.A.R. 109-2-7 is amended to create a new type of vehicle, Type II-D (defibrillator).

K.A.R. 109-2-8 is amended to require a Type II-D vehicle to carry a monitor/defibrillator.

K.A.R. 109-3-1 "grandfathers" current EMT-D's.

K.A.R. 109-5-1 is amended to require annual supplemental instruction for First Responders and EMT-D's.

K.A.R. 109-5-3 is amended to permit the director to attend supplemental instruction programs to monitor and evaluate classes.

K.A.R. 109-6-1 creates two levels of temporary attendants and establishes criteria for the director to issue temporary certifications.

K.A.R. 38-10-4. Rights of non-Kansas associations to establish branches in Kansas in order to assist the Federal Savings and Loan Corporation in protecting Kansas savings and loan depositors.

K.A.R. 38-10-5. Branching rights of non-Kansas associations with branches in Kansas.

K.A.R. 38-10-6. Supervisory fees to be paid to Kansas by non-Kansas associations with branches in Kansas are subject to examination by the Savings and Loan Department.

K.A.R. 38-10-7. Non-Kansas associations with branches in Kansas are subject to examination by the Savings and Loan Department.

92-24-11 concerning the application of sales tax is amended to delete the term "club" and replace it with the term "licensee." Other amendments update the language. There is no fiscal impact associated with the implementation of this regulation.

92-24-13 concerning the prohibition of a licensee assuming the tax is amended to delete the term "club" and update the language. There is no fiscal impact associated with the implementation of this regulation.

92-24-14 concerning the filing of returns and payment of tax is amended to delete the term "club." Other amendments also update the language. There is no fiscal impact associated with the implementation of this regulation.

92-25-15 concerning record requirements is amended to delete the term "club." Amendments also delete the paragraph referring to complimentary drinks containing alcoholic liquor. There is no fiscal impact associated with the implementation of this regulation.

92-24-16 concerning the source of the licensee's records is amended to delete the term "club" and changes 3 a.m. to 2 a.m. Other amendments update the language. There is no fiscal impact associated with the implementation of this regulation.

92-24-17 concerning daily summaries is amended to delete the term "club." Amendments also delete the sentence concerning complimentary drinks containing alcoholic liquor. There is no fiscal impact associated with the implementation of this regulation.

92-24-18 concerning the licensee's inventory is amended to delete the term "club." Amendments also require that a licensee keep sales slips provided by a wholesaler. Other amendments update the language. There is no fiscal impact associated with the implementation of this regulation.

Redemption of Bonds Prior to Maturity

The city reserves the right to reject any and all of the bids and to waive any irregularities. Delivery the Bonds

The bonds, duly printed, executed and registered, will be furnished and paid for by the city. The bonds will be sold subject to the unqualified approving opinion of Jonathan P. Small, Chartered, bond counsel, of Topeka, Kansas, a copy of whose opinion will be printed on the reverse side of each bond. Manually signed originals of the opinion will be furnished without expense to the purchaser of the bonds at the delivery thereof. The cost of this legal opinion and the expense of printing the bonds will be paid by the city. Said legal opinion will contain a statement to the effect that the bonds constitute a general obligation of the city payable as to both principal and interest from ad valorem taxes which may be levied without limitation as to rate or amount upon all of the taxable tangible property within the territorial limits of the city and that, under existing law, the interest on the bonds will be exempt from present federal income taxation.

The number and denominations of bonds and names of the registered owners to be shown on the bonds initially delivered will be submitted in writing by the successful bidder to the bond registrar not later than seven days prior to the closing date.

The purchaser will be furnished with a complete transcript of proceedings evidencing the authorization and issuance of the bonds and the usual closing proofs, which will include a certificate that there is no litigation pending or threatened at the time of delivery of the bonds affecting their validity. Delivery of the bonds will be made to the successful bidder on or before 30 days from the date of sale at any bank in the state of Kansas or Kansas City, Missouri, at the expense of the city. Internal Revenue Code of 1986

The President of the United States on October 22. 1986 signed into law what is referred to as the Internal Revenue Code of 1986. The code generally affects obligations of state and local governments issued after August 15, 1986, which imposes requirements to be satisfied subsequent to the issuance and delivery of such obligations, including the bonds, to ensure that the interest on such obligations remains exempt from federal income taxation. The city will covenant to satisfy code requirements and all other applicable federal laws, regulations, published rulings and court decisions to preserve the tax-exempt status of the bonds to the extent the city's governing body may take such action. The city's failure to perform such covenants could adversely affect the bonds' tax-exempt status. A purchaser of the bonds should be aware that in such event the bonds are not callable and the interest rate on the bonds will not be adjusted to reflect the loss of exemption from federal income taxation.

The code includes interest on certain obligations, such as the bonds, in the adjusted net book income of certain corporations for taxable years after 1987 and includes in the computation for alternative minimum taxable income (determined without regard to this adjustment and pior to reduction for certain net operating losses). The code further provides that banks and thrift institutions would be unable to deduct any portion of the interest cost of purchasing or carrying tax-exempt obligations (with certain exceptions described below) if such interest costs are incurred in taxable years ending after December 31, 1986, with respect to bonds acquired subsequent to August 7, 1986. The code requires certain "qualified tax-exempt obligations" as defined in Section 265(b)(3) thereof to be treated as having been acquired on August 7, 1986. The city will covenant to take such actions as are necessary to designate the bonds as 'qualified tax-exempt obligations" as described above.

The code further provides that property and casualty insurance companies are required for taxable (continued) years beginning on or after January 1, 1986 to reduce the amount of their deductible underwriting losses by a percentage of the amount of tax-exempt interest received or accrued on obligations acquired after August 7, 1986. If the amount of this reduction exceeds the amount otherwise deductible as losses incurred, such excess may be includable in income.

Superfund Amendments and Reauthorization Act of 1986

H.R. 2005, the Superfund Amendments and Reauthorization Act of 1986, enacted on October 17, 1986, includes among its provisions the imposition of a new environmental tax. Calculation of the tax is to be based generally on a percentage of the corporate alternative minimum taxable income as defined in the 1986 code which would include interest on tax-exempt obligations, including the bonds. The amount of tax is equal to 0.12 percent of the excess of the alternative minimum taxable income (without regard to net operating losses and the deduction for the environmental tax) over \$2 million. The environmental tax is imposed whether or not the taxpayer is subject to the alternative minimum tax, but is deductible from gross income. The environmental tax is effective for taxable years beginning after 1991. The imposition of this environmental tax could result in additional taxation of interest on the bonds for certain bondowners.

Purpose

These bonds are being issued pursuant to K.S.A. 12-631t et seq. and K.S.A. 12-836 et seq., and for the purpose of financing a portion of the cost of certain improvements to the city's sewer lines, sanitary sewer disposal treatment facilities and the water system serving the city at large.

Assessed Valuation and Bonded Indebtedness

The total assessed valuation of the taxable tangible property within the city for the year 1987 for the computation of limits upon bonded indebtedness is \$4,799,025. The total general obligation bonded indebtedness of the city as of this date, including this \$171,640 proposed issue of bonds, is \$1,379,035.24. Temporary notes in the principal amount of \$25,000 will be retired out of the proceeds of the bonds and other available funds.

amount upon all the taxable tangible property, real and personal, within the territorial limits of the city.

Legal Opinion and Tax Exemption

All matters incidental to the authorization and issuance of the bonds are subject to the approval of Gaar

& Bell, Wichita, Kansas, bond counsel.

In the opinion of bond counsel, assuming continued compliance by the city with the terms of the bond ordinance, under existing law, the interest on the bonds (a) is excludable from gross income for federal income tax purposes and (b) is not an item of tax preference for purposes of the federal alternative minimum tax imposed on individuals and corporations; however, it should be noted that with respect to corporations (as defined for federal income tax purposes), such interest is taken into account in determining adjusted net book income (adjusted current earnings for taxable years ending after December 31, 1989) for the purpose of computing the alternative minimum tax imposed on such corporations. The opinion set forth in clause (a) above is subject to the condition that the city comply with all requirements of the Internal Revenue Code of 1986, as amended, that must be satisfied subsequent to the issuance of the bonds in order that interest thereon be excluded from gross income for federal income tax purposes. Failure to comply with certain of such requirements could cause the interest on the bonds to be so included in gross income retroactive to the date of issuance of the bonds. The city has covenanted to comply with all such requirements. Bond counsel expresses no opinion regarding other federal tax consequences arising with respect to the bonds.

Prospective purchasers of the bonds should be aware that (i) Section 265 of the code denies a deduction for interest on indebtedness incurred or continued to purchase or carry the bonds, except with respect to certain financial institutions (within the meaning of Section 265 (b)(5) of the code); (ii) with respect to insurance companies subject to the tax imposed by Section 831 of the code, for taxable years beginning after December 31, 1986, Section 832(b)(5)(B)(i) reduces the deduction for loss reserves by 15 percent of the sum of certain items, including interest on the bonds; (iii) for taxable years beginning after December 31, 1986 and before January 1, 1992, interest on the bonds earned by some corporations could be subject to the environmental tax imposed by Section 59A of the code; (iv) for taxable years beginning after December 31, 1986, interest on the bonds earned by certain foreign corporations doing business in the United States could be subject to a branch profits tax imposed by Section 884 of the code; (v) passive investment income, including interest on the bonds, may be subject to federal income taxation under Section 1375 of the code for Subchapter S corporations that have Subchapter C earnings and profits at the close of the taxable year if greater than 25 percent of the gross receipts of such Subchapter S corporation is passive investment income; and (vi) Section 86 of the code requires recipients of certain

Social Security and certain railroad retirement benefits to take into account in determining gross income, receipts or accruals of interest on the bonds. These categories of bondowners should consult their own tax advisers as to the applicability of these consequences.

The bonds are exempt from intangible personal property taxes levied by Kansas counties, cities or townships.

Qualified Tax-Exempt Obligations

The bonds are "qualified tax-exempt obligations" within the meaning of Section 265(b)(3) of the code, and, in the case of certain financial institutions (within the meaning of Section 265(b)(5) of the code), a deduction is allowed for 80 percent of that portion of such financial institution's interest expense allocable to interest on the bonds.
