NOTICE CONCERNING LOW-INCOME
HOUSING TAX CREDIT PROGRAM

The State Department of Commerce will begin implementation of a Low-Income Housing Tax Credit Program. The program will administer a quality housing program to assist those in need, the elderly and those who live on a low income. Rental property owners and developers are invited to submit requests for preliminary reservations of the tax credits. The state of Kansas has approximately \$2 million in tax credits available for allocation in 1987. There is a set aside of 10 percent for nonprofit organizations.

The U.S. Congress included the tax credit for low-income rental housing as part of the Tax Reform Act of 1986. The purpose of the three-year program is to provide a sufficient incentive to create a supply of low-income housing. Three areas of development may qualify for tax credits: new construction (9%); rehabilitation, substantial (9%) or moderate (4%); and acquisition (4%).

A residential rental project providing low-income housing qualifies for the credit only if 20 percent or more of the aggregate residential rental units are occupied by individuals with incomes of 50 percent or less of median income, or 40 percent or more of the aggregate residential rental units are occupied by individuals with incomes of 60 percent or less of area median income. There is a 15-year compliance period for the program.

Application by property owners and developers for participation in the program will be accepted by contacting Frances Squyres, Kansas Department of Commerce, 400 W. 8th, 5th Floor, Topeka 66603-3957, (913) 296-3485. Program application forms can be obtained between 8 a.m. and 5 p.m. An application fee of \$50 per unit must accompany each application submitted. No final awards of tax credits will be made until after the U.S. Treasury publishes regulations.

Applications will be considered on a first-come, first-serve basis. If competition is required, the KDOC will make a public announcement.

No requests for reservations of tax credits for 1988 or 1989 projects will be considered at this time. Another notice will be issued later in the year.

Bond Details

The bonds will bear interest from the date thereof at rates to be determined when the bonds are sold as hereinafter provided, which interest will be payable semiannually on June 1 and December 1 in each year, beginning on June 1, 1988.

Place of Payment and Bond Registration

The principal of and interest on the bonds will be payable in lawful money of the United States of America by check or draft of the Kansas State Treasurer, Topeka, Kansas (the paying agent and bond registrar), to the registered owners thereof whose names are on the registration books of the bond registrar as of the 15th day of the month preceding each interest payment date. The bonds will be registered pursuant to a plan of registration approved by the city and the Kansas Attorney General.

The city will pay for the fees of the bond registrar for registration and transfer of the bonds and will also pay for printing a reasonable supply of registered bond blanks. Any additional costs or fees that might be incurred in the secondary market, other than fees of the bond registrar, will be the responsibility of the bondowners.

The number, denominations of the bonds and the names, addresses and social security or taxpayer identification numbers of the registered owners shall be submitted in writing by the successful bidder to the city and bond registrar at least two weeks prior to the closing date. In the absence of such information, the

city will deliver one bond per maturity registered in the name of the manager of the successful bidder. The initial reoffering price to the public by the original purchaser shall be furnished to the city at least one week prior to the closing date. A certificate setting forth such initial reoffering price to the public shall be furnished to the city by the original purchaser at closing.

Redemption of Bonds Prior to Maturity

Bonds maturing in the years 1988 to 1991, inclusive, shall become due without option of prior payment. At the option of the city, bonds maturing in the years 1992 and thereafter may be called for redemption and payment prior to maturity in whole or in part in inverse order of maturity (selection of bonds within the same maturity to be by lot by the city in such equitable manner as it may determine) on December 1, 1991, or on any interest payment date thereafter at the redemption price of 101 percent (expressed as a percentage of the principal amount), plus accrued interest to the redemption date.

Whenever the city is to select the bonds for the purpose of redemption, it shall, in the case of bonds in denominations greater than \$5,000, if less than all of the bonds then outstanding are to be called for redemption, treat each \$5,000 of face value of each such fully registered bond as though it were a separate bond of the denomination of \$5,000.

If the city shall elect to call any bonds for redemption and payment prior to the maturity thereof, the city shall give written notice of its intention to call and pay said bonds on a specified date, said notice to be mailed by United States registered or certified mail addressed to the registered owners of said bonds, to the Kansas State Treasurer, Topeka, Kansas, and to the manager or managers of the underwriting account making the successful bid, each of said notices to be mailed not less than 30 days prior to the date fixed for redemption. If any bond be called for redemption and payment as aforesaid, all interest on such bond shall cease from and after the date for which such call is made, provided funds are available for its payment at the price hereinbefore specified.

Conditions of Bids

Proposals will be received on the bonds bearing such rate or rates of interest as may be specified by the bidders, subject to the following conditions: The same rate shall apply to all bonds of the same maturity. Each interest rate specified shall be a multiple of 1/8 or 1/20 of 1 percent. No interest rate shall exceed a rate equal to the index of treasury bonds published by Credit Markets in New York, New York, on the Monday next preceding the day on which the bonds are sold, plus 2 percent. The difference between the highest rate specified and the lowest rate specified shall not exceed 3 percent. No bid of less than the entire par value of the bonds and accrued interest thereon to the date of delivery will be considered and no supplemental interest payments will be authorized. Each bid shall specify the total interest cost to the city during the life of the bonds on the basis of such bid, the premium, if any, offered by the bidder, and the net interest cost to

the city on the basis of such bid, all certified by the bidder to be correct, and the city will be entitled to rely on the certificate of correctness of the bidder. Each bid shall also specify the average annual net interest rate to the city on the basis of such bid.

Basis of Award

The award of the bonds will be made on the basis of the lowest net interest cost to the city, which will be determined by subtracting the amount of the premium bid, if any, from the total interest cost to the city. If there is any discrepancy between the net interest cost and the average annual net interest rate specified, the specified net interest cost shall govern and the interest rates specified in the bid shall be adjusted accordingly. If two or more proper bids providing for identical amounts for the lowest net interest cost are received, the governing body shall determine which bid, if any, shall be accepted, and its determination shall be final. The city reserves the right to reject any and all bids and to waive any irregularities in a submitted bid.

Authority, Purpose and Security

The bonds are being issued pursuant to K.S.A. 12-631a and K.S.A. 12-631t *et seq.*, as amended, for the purpose of paying the cost of certain sewer improvements. The bonds and the interest thereon will constitute general obligations of the city, payable from ad valorem taxes which may be levied without limitation as to rate or amount upon all the taxable tangible property, real and personal, within the territorial limits of the city.

Legal Opinion and Tax Exemption

All matters incidental to the authorization and issuance of the bonds are subject to the approval of Gaar & Bell, Wichita, Kansas, bond counsel.

In the opinion of bond counsel, assuming continued compliance by the city with the terms of the bond ordinance, under existing law, the interest on the bonds (a) is excludable from gross income for federal income tax purposes and (b) is not an item of tax preference for purposes of the federal alternative minimum tax imposed on individuals and corporations; however, it should be noted that with respect to corporations (as defined for federal income tax purposes), such interest is taken into account in determining adjusted net book income (adjusted current earnings for taxable years ending after December 31, 1989) for the purpose of computing the alternative minimum tax imposed on such corporations. The opinion set forth in clause (a) above is subject to the condition that the city comply with all requirements of the Internal Revenue Code of 1986, as amended, that must be satisfied subsequent to the issuance of the bonds in order that interest thereon be excluded from gross income for federal income tax purposes. Failure to comply with certain of such requirements could cause the interest on the bonds to be so included in gross income retroactive to the date of issuance of the bonds. The city has covenanted to comply with all such requirements. Bond counsel expresses no opinion

ion regarding other federal tax consequences arising with respect to the bonds.

Prospective purchasers of the bonds should be aware that (i) Section 265 of the code denies a deduction for interest on indebtedness incurred or continued to purchase or carry the bonds, except with respect to certain financial institutions (within the meaning of Section 265(b)(5) of the code); (ii) with respect to insurance companies subject to the tax imposed by Section 831 of the code, for taxable years beginning after December 31, 1986, Section 832(b)(5)(B)(i) reduces the deduction for loss reserves by 15 percent of the sum of certain items, including interest on the bonds; (iii) for taxable years beginning after December 31, 1986 and before January 1, 1992, interest on the bonds earned by some corporations could be subject to the environmental tax imposed by Section 59A of the code; (iv) for taxable years beginning after December 31, 1986, interest on the bonds earned by certain foreign corporations doing business in the United States could be subject to a branch profits tax imposed by Section 884 of the code; (v) passive investment income, including interest on the bonds, may be subject to federal income taxation under Section 1375 of the code for Subchapter S corporations that have Subchapter C earnings and profits at the close of the taxable year if greater than 25 percent of the gross receipts of such Subchapter S corporation is passive investment income; and (vi) Section 86 of the code requires recipients of certain Social Security and certain railroad retirement benefits to take into account in determining gross income, receipts or accruals of interest on the bonds. These categories of bondowners should consult their own tax advisers as to the applicability of these consequences.

The bonds are exempt from intangible personal property taxes levied by Kansas counties, cities or townships.

Qualified Tax-Exempt Obligations

The city will covenant to take such actions as are necessary to designate the bonds as "qualified tax-exempt obligations" within the meaning of Section 265(b)(3) of the code, and, in the case of certain financial institutions (within the meaning of Section 265(b)(5) of the code), a deduction is allowed for 80 percent of that portion of such financial institution's interest expense allocable to interest on the bonds.

A form of bond counsel's opinion is contained in the official statement of the city with respect to the bonds.

Delivery and Payment

The city will pay for printing the bonds and will deliver the same properly prepared, executed and registered without cost to the successful bidder within 45 days after the date of sale at such bank or trust company in the state of Kansas or Kansas City, Missouri, as may be specified by the successful bidder. The successful bidder will also be furnished with a certified transcript of the proceedings evidencing the authorization and issuance of the bonds and the usual closing proofs, which will include a certificate that there is no litigation pending or threatened at the time of delivery of the bonds affecting their validity. Pay-

ment for the bonds shall be made in federal reserve funds, immediately subject to use by the city.

Good Faith Deposit

Each bid shall be accompanied by a cashier's or certified check drawn on a bank located in the United States of America equal to 2 percent of the total amount of the bid payable to the order of the city. If a bid is accepted, said check or the proceeds thereof will be held by the city until the bidder shall have complied with all of the terms and conditions of this notice. If a bid is accepted but the city shall fail to deliver the bonds to the bidder in accordance with the terms and condition of this notice, said check or the proceeds thereof will be returned to the bidder. If a bid is accepted but the bidder defaults in the performance of any of the terms and conditions of this notice, the proceeds of such check will be retained by the city as and for liquidated damages. FISH AND GAME COMMISSION

PERMANENT ADMINISTRATIVE REGULATIONS

(Effective May 1, 1987)

Article 1.—GAME BIRDS

23-1-10. Turkey, season restrictions. (a) Legal hunting equipment.

(1) Archery equipment for archery and firearm seasons shall be long bows or compound bows of at least 45 pounds pull up to or at full draw. All arrows shall be equipped with broadhead points. A crossbow shall not be considered to be a long bow or a compound bow.

(2) Firearm equipment for firearm seasons shall be shotguns and muzzleloading shotguns. Shotguns shall be 20 gauge or larger and shall use shot only.

(3) Decoys and non-electronic turkey calls shall be legal for taking turkeys during the established open seasons.

(b) Carcass tag. Each permittee shall have in possession a carcass tag while hunting turkey. Removal of the carcass tag from the permit shall invalidate the permit for hunting. The permittee shall sign and date the tag and attach it to the carcass immediately following the kill and before moving carcass from the site of the kill. Legally acquired turkey meat may be given to and possessed by another, provided a written notice which includes the donor's name, address and permit number accompanies the meat.

(c) Informational cards. Each permittee receiving an informational card shall report the results of their hunt within 48 hours after the close of the season.

(d) Turkeys shall be shot only while on the ground or in flight.

(e) An archery turkey hunter shall not have a firearm in possession while hunting turkey.

(f) A permit, once issued, shall not be transferable and a refund shall not be granted. However, a refund may be granted if the permittee dies prior to the opening date of the season.

(g) In addition to other penalties prescribed by law, a permit application may be rejected by the director when a false representation or misrepresentation is made upon the application. Any permit obtained through false representation or misrepresentation shall be invalid from date of issuance.

(h) A person shall not submit more than one application for a spring turkey permit in a calendar year. A person shall not submit more than one application for a fall turkey permit in a calendar year. In addition to other penalties prescribed by law, a person applying for more than one application for a spring turkey hunt or more than one application for a fall turkey hunt shall be ineligible to receive any permit for the hunt in which multiple applications were made. Any permit issued to a person who made multiple applications for a hunt shall be invalid from the date of issuance. Any applicant unsuccessful in obtaining a permit in a drawing for limited permits shall be eligible to apply for any permits remaining after the drawing or any permits available on an unlimited basis. An applicant shall not obtain more than one spring turkey permit in a calendar year or more than one fall turkey permit in a calendar year. (Authorized by K.S.A. 32-215; implementing K.S.A. 32-177 and 32-178; effective, T-81-32, Oct. 8, 1980; effective May 1, 1981; amended May 1, 1984; amended May 1, 1985; amended May 1, 1986; amended May 1, 1987.)

23-1-12. Turkey; spring open season; bag limit, and permits. (a) The open season for hunting, killing, and taking of turkey in Kansas shall be April 15, 1987 through May 3, 1987 in all units.

(b) The legal limit for permit holders shall be one bearded turkey per permit.

(c) The areas to be open and the number of permits to be authorized are as follows:

(1) Unit 1. The following described area shall be open for the taking of turkey during the established season: that area bounded by Colorado on the west, Nebraska on the north, and a line from the Colorado-Kansas boundary east on federal highway US-50 to its junction with federal highway US-156; then east on federal highway US-156 to its junction with federal highway US-183; then north on federal highway US-183 to its junction with the Nebraska-Kansas boundary, except federal and state sanctuaries. Nine hundred permits are authorized for the unit.

(2) Unit 2. The following described area shall be open for the taking of turkey during the established season: that area bounded by Nebraska on the north and a line from the Nebraska-Kansas boundary south on federal highway US-183 to its junction with federal highway US-56; then southwest on federal highway US-56 to its junction with federal highway US-50;

then east on federal highway US-50 to its junction with state highway K-14; then north on state highway K-14 to its junction with federal highway US-56; then east on federal highway US-56 to its junction with federal highway US-81; then north on federal highway US-81 to the Nebraska-Kansas boundary, except federal and state sanctuaries. Five hundred permits are authorized for the unit.

(3) Unit 3. The following described area shall be open for the taking of turkey during the established open season: that area bounded by Nebraska on the north and a line from the Nebraska-Kansas boundary south on federal highway US-81 to its junction with federal highway US-56; then east on federal highway US-56 to its junction with state highway K-150; then east on state highway K-150 to its junction with federal highway US-50; then east on federal highway US-50 to its junction with state highway K-99; then north on state highway K-99 to the Nebraska-Kansas boundary, except federal and state sanctuaries. Four hundred fifty permits are authorized for the unit.

(4) Unit 4. The following described area shall be open for the taking of turkey during the established open season: that area bounded by Nebraska on the north and a line from the Nebraska-Kansas boundary south on state highway K-99 to its junction with interstate highway I-70; then east on interstate highway I-70 to its junction with federal highway US-75; then north on federal highway US-75 to its junction with the Nebraska-Kansas boundary, except federal and state sanctuaries. Fifty permits are authorized for the unit.

(5) Unit 5. The following described area shall be open for the taking of turkey during the established open season: that area bounded by Colorado on the west and Oklahoma on the south and a line from the Colorado-Kansas boundary east on federal highway US-50 to its junction with federal highway US-156; then east on federal highway US-156 to its junction with federal highway US-183; then south on federal highway US-183 to its junction with federal highway US-56; then southwest on federal highway US-56 to its junction with federal highway US-50; then east on federal highway US-50 to its junction with state highway K-14; then north on state highway K-14 to its junction with federal highway US-56; then east on US-56 to its junction with state highway K-150; then east on state highway K-150 to its junction with federal highway US-50; then east on federal highway US-50 to its junction with state highway US-99; then south on state highway K-99 to state highway K-96; then east on state highway K-96 to its junction with state highway K-39; then south on state highway K-39 to its junction with federal highway US-160; then east on federal highway US-160 to its junction with federal highway US-169 then south on federal highway US-169 to the Kansas-Oklahoma boundary, except federal and state sanctuaries. Unlimited permits are authorized for the unit.

(6) Unit 6. The following described area shall be open for the taking of turkey during the established seasons: that area bounded by Nebraska on the north and a line from the Nebraska-Kansas boundary south

on federal highway US-75 to its junction with interstate highway I-70; then east on interstate highway I-70 to its junction with the Kansas-Missouri boundary line, except federal and state sanctuaries. Four hundred permits are authorized for the unit.

(7) Unit 7. The following described area shall be open for the taking of turkey during the established open season: that area bounded by Missouri on the east and a line from the Missouri-Kansas boundary west on interstate highway I-70 to its junction with state highway K-99; then south on state highway K-99 to its junction with federal highway US-50; then east on federal highway US-50 to its junction with interstate highway I-35; then east on federal highway I-35 to its junction with state highway K-68; then east on state highway K-68 to its junction with the Missouri-Kansas boundary, except federal and state sanctuaries. Two hundred fifty permits are authorized for the unit.

(8) Unit 8. The following described area shall be open for the taking of turkey during the established open season: that area bounded by Missouri on the east and a line from the Missouri-Kansas boundary west on federal highway US-54 to its junction with federal highway US-59; then north on federal highway US-59 to its junction with interstate highway I-35; then west on interstate highway I-35 to its junction with federal highway US-50; then west on federal highway US-50 to its junction with state highway K-99; then south on state highway K-99 to its junction with state highway K-96; then east on state highway K-96 to its junction with state highway K-39; then south on state highway K-39 to its junction with federal highway US-160; then east on federal highway US-160 to its junction with federal highway US-169; then south on federal highway US-169 to the Kansas-Oklahoma boundary, except federal and state sanctuaries. Two hundred twenty-five permits are authorized for the unit.

(9) Unit 9. The following described area shall be open for the taking of turkey during the established open season: that area bounded by Missouri on the east and a line from the Missouri-Kansas boundary west on state highway K-68 to its junction with interstate highway I-35; then west on interstate highway I-35 to its junction with federal highway US-59; then south on federal highway US-59 to its junction with federal highway US-54; then east on federal highway US-54 to the Kansas-Missouri boundary line, except federal and state sanctuaries. Two hundred fifty permits are authorized for the unit.

(d) Applications will be accepted in the Pratt office from January 11, 1987, until 5:00 p.m., January 30, 1987. If there are any unfilled permits after all timely applications have been considered, the commission may extend the application period.

(e) This regulation shall be effective as of November 30, 1986, but shall have no force and effect on and after October 30, 1987. (Authorized by K.S.A. 32-164 and 32-178; implementing K.S.A. 32-178; effective November 30, 1986.)

Article 2.—GAME ANIMALS

23-2-1. (Authorized by K.S.A. 32-157, K.S.A. 1970

Supp. 32-152, 32-164; effective Jan. 1, 1966; amended Jan. 1, 1968; amended Jan. 1, 1971; revoked May 1, 1987.)

23-2-3. (Authorized by K.S.A. 32-167, K.S.A. 1970 Supp. 32-164; effective Jan. 1, 1966; amended Jan. 1, 1971; revoked May 1, 1987.)

23-2-14. Antelope and deer; season restrictions. (a) Legal hunting equipment.

(1) Archery equipment for the archery and firearm seasons shall be long bows or compound bows of at least 45 pounds pull up to or at full draw. All arrows shall be equipped with broadhead points. A crossbow shall not be considered a long bow or compound bow.

(2) Firearm equipment for firearm seasons shall be:

(A) Centerfire rifles that fire a bullet greater than .23 inch in diameter;

(B) Muzzleloading rifles that fire a bullet of .40 inch in diameter or larger and that can only be loaded through the front of the firing chamber with separate components;

(C) Shotguns, 20 gauge or larger, using only rifled slugs; and

(D) Centerfire handguns, using a cartridge case 1.280 inches or greater in length and a bullet greater than .23 inches in diameter.

(3) Fully automatic rifles and handguns are prohibited for taking of deer and antelope. Only soft point, hollow point or other expanding bullets shall be used in handguns or rifles.

(b) Carcass tag. Each permittee shall have in possession an appropriate carcass tag while hunting antelope or deer. Removal of the carcass tag from the permit shall invalidate the permit for hunting. The permittee shall sign and date the tag and attach it to the carcass immediately following the kill and before moving carcass from the site of the kill. Legally acquired antelope or deer meat may be given to and possessed by another, provided a written notice which includes the donor's name, address and permit number accompanies the meat.

(c) Informational cards. Each permittee receiving an informational card shall report the results of their hunt within 48 hours after the close of the season.

(d) An archery deer permittee shall not have a firearm in possession while hunting deer. An archery antelope permittee shall not have a firearm in possession while hunting antelope.

(e) A muzzleloader deer permittee shall not have a rimfire or centerfire firearm in possession while hunting deer. A muzzleloader antelope permittee shall not have a rimfire or centerfire firearm in possession while hunting antelope.

(f) A permit, once issued, shall not be transferable and a refund shall not be granted. However, a refund may be granted if the permittee dies prior to the opening date of the season.

(g) In addition to other penalties prescribed by law, a permit application may be rejected by the director when a false representation or misrepresentation is made upon the application. Any permits obtained through false representation or misrepresentation shall be invalid from the date of issuance.

(h) A person shall not submit more than one application for an antelope permit or apply for an archery antelope and a firearm antelope permit in the same calendar year. In addition to other penalties prescribed by law, a person applying for more than one antelope permit in a calendar year shall be ineligible to receive any antelope permit for that year. Any applicant unsuccessful in obtaining a permit in a drawing for limited permits shall be eligible to apply for any permits remaining after the drawing or any permits available on an unlimited basis. Any permit issued to a person who applied for more than one permit shall be invalid from the date of issuance.

(i) A person shall not submit more than one application for a deer permit or apply for an archery deer and a firearm deer permit in the same calendar year. In addition to other penalties prescribed by law, a person who applies for more than one deer permit in a calendar year shall be ineligible to receive any deer permit for that year. Any permit issued to an applicant who applied for more than one permit shall be invalid from the date of issuance. Any applicants unsuccessful in obtaining a permit in a drawing for limited permits shall be eligible to apply for any permits remaining after the drawing or any permits available on an unlimited basis. An applicant shall not obtain more than one regular season deer permit in any calendar year.

(j) Persons who are not landowners, tenants or members of their immediate family who reside with the landowners or tenants as described in K.S.A. 32-179 shall be ineligible to apply for landowner-tenant permits.

(k) Landowner-tenants unsuccessful in a regular season drawing for a firearms deer hunting permit may apply during that year for a special permit to hunt deer on their own property in those units where such permits are authorized.

(l) Priorities for receiving firearms deer permits are as follows:

(1) those persons who applied for and were unsuccessful in obtaining a firearms deer permit for each of the four previous years;

(2) those applicants who did not receive a firearms deer permit the previous year. Landowner-tenants receiving a special firearms permit to hunt their own property or permittees receiving a firearms "antlerless only" permit during the previous regular firearms season shall be considered as not having a firearms deer permit during the previous year; and

(3) all other applicants.

(m) Priorities for receiving antelope permits are as follows:

(1) those persons who have not obtained an antelope permit in any of the three previous years; and

(2) all other applicants. (Authorized by K.S.A. 32-215; implementing K.S.A. 32-178 and 32-179; effective May 1, 1981; amended May 1, 1983; amended May 1, 1985; amended May 1, 1986; amended May 1, 1987.)

23-2-15. Elk; season restrictions. (a) Legal hunting equipment.

(1) Archery equipment for archery and firearms seasons shall be long bows or compound bows of at

(continued)

least 50 pounds pull up to or at full draw. All arrows shall be equipped with broadhead points. A crossbow shall not be considered a long bow or compound bow.

(2) Firearm equipment for firearms seasons shall be:

(A) Centerfire rifles that fire a bullet which is greater than .23 inch in diameter and that use a cartridge (case and bullet) greater than two inches in length.

(B) Muzzleloading rifles are those rifles that fire a bullet of .49 inch in diameter or larger and that can only be loaded through the front of the firing chamber with separate components.

(C) Fully automatic rifles are prohibited for taking of elk. Only soft point, hollow point or other expanding bullets shall be used.

(b) Carcass tag. Each permittee shall have in possession a carcass tag while hunting elk. Removal of the carcass tag from the permit shall invalidate the permit for hunting. The permittee shall sign and date the tag and attach it to the carcass immediately following the kill and before moving carcass from the site of the kill. Legally acquired elk meat may be given to and processed by another, provided a written notice which includes the donor's name, address and permit number accompanies the meat.

(c) Informational cards. Each permittee receiving an informational card shall report the results of their hunt within 48 hours after the close of the season.

(d) An archery elk permittee shall not have a firearm in possession while hunting elk.

(e) A muzzleloader elk permittee shall not have a rimfire or centerfire firearm in possession while hunting elk.

(f) A permit, once issued, shall not be transferable and a refund shall not be granted. However, a refund may be granted if the permittee dies prior to the opening date of the season.

(g) In addition to other penalties prescribed by law, a permit application may be rejected by the director when a false representation or misrepresentation is made upon the application. Any permit obtained through false representation or misrepresentation shall be invalid from date of issuance.

(h) A person shall not submit more than one application for an elk permit or apply for an archery elk and a firearm elk permit in the same calendar year. In addition to other penalties prescribed by law, a person applying for more than one elk permit in a calendar year shall be ineligible to receive any elk permit for that year. Any permit issued to a person who applied for more than one permit shall be invalid from date of issuance.

(i) Persons who are not landowners, tenants, or members of their immediate family who reside with the landowners or tenants as described in K.S.A. 32-179 shall be ineligible to apply for landowner-tenant permits. Non-residents shall be ineligible to apply for elk permits.

(j) All persons who receive an elk hunting permit shall not be eligible to receive an elk hunting permit in subsequent seasons. (Authorized by and imple-

menting K.S.A. 32-164, 32-178, and 32-179; effective May 1, 1985; amended May 1, 1987.)

23-2-17. Big game; possession of a salvaged carcass. A person may possess a salvaged big game carcass provided a salvage tag issued through the director is attached to the carcass which contains a specified date by which the carcass shall have been consumed. The meat of such big game may be given to another, provided a written notice which includes the donor's name, address and salvage tag number accompanies the meat. (Authorized by and implementing K.S.A. 1986 Supp. 32-110a; effective May 1, 1987.)

Article 3.—FISH

23-3-13. Taking of bait fish or minnows. (a) Bait fish may be taken for noncommercial purposes by the following methods:

(1) seine not longer than 15 feet and 4 feet deep with mesh not larger than ¼ inch;

(2) fish trap with mesh not larger than ¼ inch and throat not larger than 1 inch in diameter; or

(3) a dip or cast net with mesh no larger than ¾ inch.

(b) Bait fishes taken shall not exceed 12 inches in total length, except crappie the length of which shall not exceed 5 inches, and all shall be restricted to a possession limit of 500 per person.

(c) The taking of bait fishes shall be allowed statewide except on state fishing lakes or where prohibited pursuant to K.A.R. 23-8-2. (Authorized by K.S.A. 32-215; implementing K.S.A. 32-189; effective, T-83-3, Jan. 7, 1982; effective May 1, 1987.)

Article 6.—FURBEARERS

23-6-1. (Authorized by K.S.A. 1967 Supp. 32-158, 32-164; effective January 1, 1966; amended January 1, 1968; revoked T-87-31, Oct. 22, 1986; revoked May 1, 1987.)

23-6-4. (Authorized by K.S.A. 1979 Supp. 32-158, 32-164, 32-215; effective May 1, 1980; revoked May 1, 1987.)

23-6-6. Furbearers; season restrictions. (a) Definitions.

(1) "Running" means the pursuing or chasing of furbearers with hounds but not taking or killing the furbearers.

(2) "Dryland set" means any trapping device which is placed or set on land or that is not in contact with water.

(3) "Water set" means any trapping device which has the gripping portion placed or set in, and which remains in contact with, flowing or impounded water.

(b) Any conibear type body gripping trap with a jawsread of eight inches or greater shall be used only in a water set.

(c) Setting, operating, or using any slide-locking wire or snare type cable trap shall be prohibited in dryland sets located within 50 feet of the outside edge of the traveled portion of a public road. No such set shall be closer than five feet from a fence bordering a traveled public road. Possession of the fur, pelt, skin

or carcass of any fur-bearing animal removed from these devices within these locations shall be prohibited.

(d) The provisions of subsection (c) shall not apply to landowners or tenants of the land immediately adjacent to the right-of-way, or to the landowner's or tenant's immediate family or agent.

(e) A person may take furbearing animals during legally established hunting seasons using archery equipment.

(f) Possession of fur-bearing animals:

(1) Raw furs, pelts or skins of furbearers may be possessed no more than 30 days following the closing of the season in which that species of furbearer may legally be taken or one day prior to the beginning of the running season in which that species of furbearer may legally be run, whichever time period is less. However, legally acquired raw furs, pelts or skins may be possessed beyond the specified period with written approval by the director of the fish and game commission. Such approval may be obtained by making a written request to the director specifying the number of each species of fur-bearing animal possessed and the owner's name, address and furharvester license number.

(2) Live furbearers legally taken during the trapping or hunting season may be possessed only through the last day of the season in which taken.

(3) Unskinned carcasses of furbearers may be possessed no more than 48 hours following the closing of the season in which that species of furbearer may legally be taken. Skinned carcasses and meat of furbearers may be possessed without limit in time. Legally acquired furbearing meat may be given to and possessed by another, provided a written notice which includes the donors name, address and furharvester license number, unless the donor was exempt by law from such license requirement, accompanies the meat.

(g) No bobcat pelt taken in Kansas shall be sold to any resident or nonresident fur dealer, or shipped from the state for the purpose of selling, unless an export tag provided by the fish and game commission has been affixed to the pelt. The pelt of any bobcat taken in Kansas shall be presented to the fish and game commission for tagging within 48 hours following closure of the bobcat hunting and trapping season or as specified upon conditional wildlife permits. A pelt presented for tagging must be accompanied by the furharvester license number or conditional wildlife permit under which such pelts were taken.

(h) Bobcat pelts tagged by fish and game personnel may be possessed without limit in time.

(i) No individual shall have in possession any firearm or other weapon while pursuing or chasing furbearers with hounds during the running season.

(j) Licensed furharvesters or persons exempt by law from having such license may legally salvage furbearing animals found dead during the established open seasons for hunting or trapping of furbearers. Such furbearing animals may be possessed as authorized by this regulation. (Authorized by K.S.A. 1982 Supp. 32-158, 32-164, 32-215; implementing K.S.A. 32-158; ef-

fective May 1, 1981; amended May 1, 1984; amended May 1, 1987.)

Article 8.—WILDLIFE AREAS

23-8-11. Wildlife areas; use restrictions. (a) Hunting, shooting, killing, taking, trapping, injuring, pursuing, molesting, or disturbing in any way any bird or animal on or within wildlife areas shall be prohibited, except areas or portions of areas as may be opened, during the legal open season or some part of it, to any of these activities by commission regulation or by posted notice. The director may restrict public use of or specified types of hunting equipment on any wildlife areas by posted notice if in the opinion of the director such restriction is consistent with the purpose for which the wildlife area is maintained.

(b) Portable blinds or temporary blinds constructed of natural materials available at the blind site are authorized to be used on any wildlife area unless prohibited by the director through posted notice. Blinds violating the director's notice may be removed by commission personnel at any time.

(c) The digging of holes or pits on any wildlife area is prohibited. (Authorized by and implementing K.S.A. 32-224; effective Jan. 1, 1966; amended May 1, 1980; amended May 1, 1983; amended May 1, 1987.)

23-8-34. Wildlife areas; steel shot. (a) Each person hunting with a shotgun on Marais des Cygnes wildlife area, Neosho wildlife area, Cheyenne Bottoms wildlife area, Jamestown wildlife area, and Texas Lake wildlife area shall possess only steel shot.

(b) Each person hunting with a shotgun for waterfowl on any land designated by the commission as a wildlife area shall possess only steel shot. (Authorized by and implementing K.S.A. 32-215, 32-224, and 1985 Supp. 74-3302; effective May 1, 1987.)

Article 12.—TRAINING DOGS AND FIELD TRIAL EVENTS

23-12-11. Furbearing animals and coyotes; field trials, water races and drag events. (a) Definitions.

(1) A "sanctioned or licensed furbearer field trial" means a competitive event in which dogs pursue unrestrained furbearers and which is sanctioned or licensed by any of the national kennel or field dog organizations for the express purpose of improving the quality of the breed through the awarding of points or credits toward specific class championships or other national recognition.

(2) A "sanctioned or licensed coyote field trial" means a competitive event involving only scent or trail hounds, which has been advertised in one of the national fox hound journals at least 30 days before the event.

(3) A "water race" is a competitive event where dogs pursue a caged furbearing animal or scent device through water. No wild animals are used. The furbearing animals used are pen-raised and are not released during the event.

(4) A "drag event" is a competitive event where

(continued)

dogs pursue a scent trail to a caged furbearing animal. No wild animals are used. The furbearing animals used are pen-raised and are not released during the event.

(b) Field trials.

(1) Any person or organization desiring to conduct a field trial event shall secure a field trial permit from the director at least 15 days prior to an event.

(A) The application for the permit shall include a copy of the sanction authorization or license and a map of each area in which an event will occur. The map and all features on the map shall be to scale and the scale shall be at least ¼ inch to one mile, the map shall contain all township roads, stream drainages and the specific area to be used for the event.

(B) The applicant shall include as part of the application the following statement: "Applicant fully understands that a permit to sponsor or hold a furbearing animal or coyote field trial does not give the permittee or participants in the field trial event the right or privilege of entering on private property without first having obtained permission from the landowner or tenant."

(C) The application authorized by the director shall give additional information as required.

(D) The application for a field trial permit may include all sanctioned or licensed events the applicant will conduct for the calendar year. For each sanctioned or licensed event identified, the application may also include up to three non-sanctioned or unlicensed events to occur on the area permitted for the sanctioned or licensed event.

(2) The director may refuse to issue a permit for a furbearer or coyote field trial if:

(A) the size of the area is insufficient or excessive;

(B) there is a lack of clarity in information stated; or

(C) the applicant has been convicted of violations of the wildlife statutes or regulations.

(3) The director may revoke a furbearer or coyote field trial permit when there is reason to believe the participants of the field trial event have committed or are about to commit a violation of wildlife statutes and regulations.

(4) All field trial events shall comply with the following requirements.

(A) The events shall be no more than seven days in duration and shall be conducted only on the area defined in the permit.

(B) No less than six dogs shall participate in an event.

(C) The permittee shall keep a register of the names and addresses of all participants in the field trial event. The register shall be subject to inspection by any state wildlife conservation officer.

(D) A field trial shall not be held on lands managed by the fish and game commission, except as permitted in accordance with K.A.R. 23-8-24.

(E) Wild or pen-raised red or gray fox, raccoon, opossum and coyotes may be used by participants in permitted field trial events, except that no wild furbearer shall be shot, captured or taken by a permittee or participants in a field trial event.

(F) No person participating in a field trial event shall possess a firearm.

(G) A furbearer field trial event shall not be held between the close of the fall running season and the opening of raccoon, fox or opossum hunting season as established by K.A.R. 23-6-1.

(H) A coyote field trial event shall not be held during the closed season for coyote hunting established by K.S.A. 32-158a, except that portion opened by K.A.R. 23-1-16.

(c) Water races and drag events.

(A) No permit is required.

(B) Water races and drag events may be held during any time of the year and shall be restricted to a single tract of land containing no more than 640 acres. The individual or organization holding the event shall notify the local wildlife conservation officer at least 10 days before the event and specify the location, time, size and type of event being conducted. Wild furbearers may be used only during the open season for that furbearer. (Authorized by and implementing K.S.A. 32-173, 32-174 and 32-145; effective Jan. 1, 1970; amended, E-76-16, March 27, 1975; amended May 1, 1976; amended, E-79-32, Nov. 21, 1978; amended May 1, 1979; amended, E-80-20, Nov. 7, 1979; amended May 1, 1980; amended May 1, 1981; amended May 1, 1987.)

(c) It shall be unlawful to take, attempt to take, possess, transport, export, deliver, carry, process, sell or offer for sale, or ship, alive or dead, any threatened or endangered species of wildlife except:

(1) as may be provided by permit issued by the commission; or

(2) any threatened or endangered species taken during legal trapping seasons, legal commercial fishing operations, commercial mussel collecting operations, by hook and line, or when legally seining for bait fish shall not be unlawfully taken if immediately released or returned to the water.

(d) Any of the listed threatened or endangered species in possession prior to February 1, 1987 and not prohibited by previous regulation of the commission or national listings may be retained in possession if an application or affidavit to that effect has been filed with the director of the commission prior to July 1, 1987 that states the circumstances whereby such species came into possession. (Authorized by K.S.A. 32-504 and 32-507; effective May 1, 1978; amended May 1, 1980; amended May 1, 1987.)

23-17-2. Endangered and threatened wildlife; special permits. (a) Definitions: (1) The definitions of terms in K.S.A. 32-502 shall apply to this regulation.

(2) "Action" means any activity resulting in a physical alteration or disturbance of aquatic or terrestrial wildlife or their habitats.

(3) "Habitat" means the place of abode of an animal where it may generally be found and where all essentials for its survival and growth are present.

(4) "Critical habitat" means the specific areas within Kansas that:

(A) are documented as currently providing the essential physical and biological features supporting a self-sustaining population of any wildlife species listed as threatened or endangered; and

(B) are specific areas not documented as currently supporting a listed species but are determined by the director of the fish and game commission to be essential for the conservation of the species.

(5) "Publicly funded" means any action wherein planning and implementation are wholly funded with monies from either federal, state, or local units of government.

(6) "State or federally assisted" means any action receiving technical help or partial funding from any state or federal governmental agency.

(b) Persons undertaking or sponsoring publicly funded or state or federally assisted action or any action requiring a state or federal permit, which is likely to destroy individuals of an endangered or threatened wildlife species or their critical habitats, shall obtain a permit from the director of the fish and game commission prior to initiation of such action. It is the responsibility of the action sponsor to determine potential impacts of the proposed action on endangered or threatened species and their critical habitats.

(1) Application for a permit shall be submitted ninety (90) days prior to the proposed starting date of the action and in accordance with forms and guidelines provided by the director.

(2) The director may refuse a permit when in the director's judgment there is unacceptable resource loss or insufficient information provided.

(3) A permit for a proposed action likely to destroy endangered or threatened species or their critical habitats shall be issued if the proposed action is in compliance with the following conditions:

(A) The sponsor incorporates within action plans sufficient mitigating and compensating measures to assure no unacceptable loss of animals or their critical habitats.

(B) The proposed action is not in violation of any federal law protecting endangered or threatened species.

(c) Persons undertaking or sponsoring action not covered by subsection (b) of this regulation which will destroy endangered or threatened species shall obtain a permit from the director before initiating such action. It is the responsibility of the action sponsor to determine potential impacts of the proposed action on endangered or threatened species.

(1) Application for a permit shall be submitted 30

days prior to the proposed starting date of the action and in accordance with forms and guidelines provided by the director.

(2) The director may refuse a permit when in the director's judgment there is unacceptable resource loss or insufficient information provided.

(3) A permit for a proposed action likely to destroy endangered or threatened species shall be issued if the proposed action is in compliance with the following conditions:

(A) The sponsor incorporates within action plans sufficient mitigating and compensating measures to assure no unacceptable loss of animals.

(B) The proposed action is not in violation of any federal law protecting endangered or threatened species. (Authorized by K.S.A. 32-504, 32-507; effective May 1, 1981; amended May 1, 1987.)

Study the duties and responsibilities of the Wheat, Corn, Grain Sorghum, and Soybean Commissions, including the manner in which the commissions collect and expend the moneys collected by them; review the operations of commodity groups in other states; and consider the possible restructuring of the Kansas commodity commissions.

Proposal No. 5—Corporate Farming Law

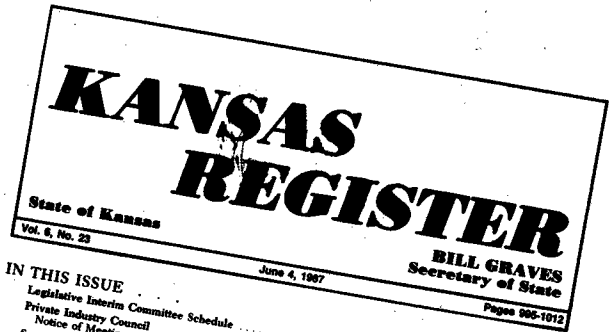
