NOTICE OF HEARING ON PROPOSED ADMINISTRATIVE REGULATIONS

A public hearing will be conducted at 11 a.m. Friday, January 15, in the Racing Commission's training room, second floor, 128 N. Kansas Ave., Topeka, to consider the adoption of proposed temporary regulations of the Kansas Racing Commission.

A copy of the full text of the regulations and the fiscal impact statement may be reviewed or obtained at the commission's office. The following is a summary of the regulations:

K.A.R. 112-3-1 through K.A.R. 112-3-14: These are new regulations implementing L. 1987, Chapter 112, the Kansas parimutuel racing act. The regulations define the form, procedure and content of applications to be filed by organization applicants, facility owner applicants and facility manager applicants to conduct horse races or dog races, or both, and parimutuel wagering or to construct or own or manage a racetrack facility.

The following are also new regulations implementing L. 1987, Chapter 112:

K.A.R. 112-3-15 requires an annual certified financial audit of an organization licensee. K.A.R. 112-3-16 states the commission may draft modified license application forms for fair associations, the state of Kansas or political subdivisions thereof. K.A.R. 112-3-17 states the commission may require additional information of any license applicant.

K.A.R. 112-3-18 requires approval of the commission if control of a facility owner or facility manager licensee is to be conveyed. K.A.R. 112-3-19 states an individual or entity identified in the regulations or found to be material to the racing program shall submit to a background investigation.

K.A.R. 112-3-20 identifies those individuals who may be required by the commission to submit to tests for controlled substances. K.A.R. 112-3-21 states the regu-

lations of the Kansas Racing Commission shall be effective upon approval by the State Rules and Regulations Board.

Violations of the cereal malt beverage act are violations of the intoxicating liquor laws for purposes of issuing a license for retail sale of cereal malt beverages. These limitations are not affected by an interpretation of federal law which allows federally chartered banks to branch in the same manner as state chartered savings associations. Roads and Bridges—General Provisions; Acquisition of Real Property for Highway, Road or Street Purposes—Direct Payment to Seller for Certain Lands or Interests Therein; Use of seismographic equipment on county roads. Robert Arnold, County Counselor, Wichita, December 21, 1987.

When a county obtains an easement to create a county road thereby facilitating public travel, the extent of county interest in and authority over the land is defined by the purpose and character of the easement. When the county possesses an easement granted for a

specific purpose and use, the county has no authority to grant permission for other uses outside the scope of the easement. Use of seismographic equipment to promote another public purpose that does not advance the purpose of public travel is beyond the scope of the use for which the easement was granted. Persons who may supervise registered masters level psychologists (RMLPs) must meet two requirements: (1) They must be licensed to provide mental health services and (2) their licensure must allow them to diagnose and treat psychological disorders. It is our opinion that licensed psychologists meet these requirements, but social workers and psychiatrists do not.
