#### Opinion No. 88-57

State Departments; Public Officers and Employees—Department of Corrections; Miscellaneous Provisions—Ellsworth Correctional Work Facility. Representative Kerry Patrick, 28th District, Leawood, April 22, 1988.

The secretary of corrections may not expend money appropriated pursuant to L. 1987, ch. 335, § 8 to lease a facility having a structural capacity of less than 352 inmates. The secretary is not precluded, however, from making a policy determination to use the facility to house less than its maximum capacity. Such a policy decision would not require approval of the legislature under the current statutes, nor would such a decision require approval of the Ellsworth Public Building Commission or the holders of the Ellsworth Public Building Commission Revenue Bonds, Series 1986. #### Opinion No. 88-58

Cities and Municipalities—Ordinances of Cities—Subject and Title of Ordinance. Representative Theo Cribbs, 89th District, Wichita, April 25, 1988.

K.S.A. 12-3004 prescribes that the subject of an ordinance shall be clearly expressed in its title. Pursuant to this requirement, the title of an ordinance is sufficient if it is broad enough to indicate in general terms the provisions of the ordinance, and it need not include all the

details of the ordinance. Under this standard, the subject of charter ordinance no. 93 of the city of Wichita is clearly expressed in its title, and the proposition to adopt said charter ordinance (which referred to the ordinance both by number and title) was properly presented to voters pursuant to Article 12, Section 5 of the Kansas Constitution. #### Opinion No. 88-59

Schools—Transportation of Students—Transportation of Pupils; Required Under Certain Conditions.

Roads and Bridges; Roads—County and Township Roads; General Provisions—Duties of County Engineer; Repair of Roads. Daniel D. Metz, Attorney at Law, Lincoln, April 26, 1988.

A school district is obligated to furnish or provide transportation to students who reside in the district, and who reside more than 2.5 miles from the schoolhouse, with some exceptions for those students who live and attend school in a city. The district's obligation is fulfilled when it provides bus transportation, reimburses persons who furnish transportation in privately-owned vehicles, or utilizes a combination of both. A county has a duty to keep county roads in repair. Whether repairing a road necessarily involves graveling is a question of fact for the courts. While a family that lives on a county dirt road is obligated to require their children to attend school, that obligation does not encompass graveling the county dirt road. In the absence of a tax levy or establishment of a road benefit district, other adjoining property owners also do not appear to have an obligation to involuntarily share in the repair expense which would be incurred should the county dirt road be graveled. #### Opinion No. 88-60

Taxation—Mortgage Registration and Intangibles; Mortgage Registration—Entities Subject Thereto; Bank for Cooperatives. William R. Halvorsen, Marshall County Attorney, Marysville, May 2, 1988.

Banks for cooperatives are not so closely connected to the federal government to entitle them to constitutional immunity from state taxation, nor are they exempt from payment of mortgage registration tax by virtue of 12 U.S.C.A. § 2134 (West Supp. 1988). Language in Attorney General Opinion No. 87-190 indicating a contrary conclusion for production credit associations is hereby withdrawn. **NOTICE OF JOB SERVICE SUBSTATE  
 RESOURCE DISTRIBUTION**

The State of Kansas, Department of Human Resources, Job Service, has received the final allotment of resources for operation of program year 1988. The allotment figures given to Kansas by the Secretary of Labor total \$6,271,755. In compliance with federal regulations, Job Service is announcing the substate resource distribution plan. Resources will be distributed to the five service delivery areas for field utilization by a resource allocation formula which includes demographic and productivity factors.

The formula utilizes five basic criteria:

1. Total population by service delivery area (1980 Census);
2. New applications and renewals by SDA;
3. Placements 150 days and over by SDA;
4. Placements under 150 days by SDA;
5. Obtained employment by SDA.

Items 2, 3, and 4 are obtained from ESARS (Employment Security Automated Reporting System) Table A-22, and Item 5 is taken from the ESARS 22-B report. The formula is computed each year after January and the data is drawn only from the months of February, May, August and November of the preceding calendar year. For example, the formula computed for use in 1988 is based on the calendar 1987 statistics.

The formula is divided into two parts. The first part is weighted as two-thirds of the total formula, and is composed of the first two criteria; total population represents two-thirds of this part and new applications and renewals is weighted as one-third.

The second part of the formula is weighted as one-third of the total formula, and is composed of the third, fourth and fifth criteria; placements 150 days and over is 70 percent of this part of the formula, while placements under 150 days and obtained employment are each weighted 15 percent.

After computation is completed on each of the two parts, the results are combined utilizing the two-thirds and one-third weight of each of the two parts.

Written comments should be sent to the area supervisor in the respective service delivery area within 30 days of May 25.

Complaints on resource distribution will be reviewed by the area supervisor in the respective service delivery area within five working days of receipt. If the complaint cannot be resolved within the five-day period, it will be forwarded to the Secretary of Human Resources, who will resolve the complaint within 10 working days of receipt. That decision will be final and not subject to appeal.

## Article 3.—INSTANT GAME RULES

**111-3-32. Invalidation of Tickets.** No instant ticket remains valid after the 180th day following the start of the game it represents. For a non-winning ticket to provide the holder of the ticket the opportunity to win a prize, the ticket must be drawn before the day on which the ticket becomes invalid. (Authorized by and implementing K.S.A. 1987 Supp. 74-8710(c) and (i); effective T-89-11, April 12, 1988.)

## Article 4.—INDIVIDUAL GAME RULES

**111-4-68. Bonus Prizes.** One or more numbered spaces on the wheel may be visibly marked as bonus space(s), or if bonus spaces are preselected, the bonus squares on each player's grid path shall be designated by the auditor with the knowledge of the designated Kansas lottery security person, draw show coordinator, draw show manager, assistant draw show manager, a studio technician and the television master control booth.

(a) The first player to land directly on a bonus square or space marked with a prize valued at \$5000 or over during the draw show will have the option of accepting the bonus prize or continuing in the game.

(b) The first player to land directly on a bonus square or space marked with a prize valued less than \$5000 may accept the prize and remain in the game but not move the specified number of spaces up the board, or refuse the prize and move the specified number of spaces up the board.

(c) Acceptance of a bonus prize in subparagraph (a) removes the player from further participation in that day's draw show.

(d) Any bonus prize which is not accepted shall be removed from the wheel. (Authorized by and implementing K.S.A. 1987 Supp. 74-8710(b); effective T-89-4, Jan. 21, 1988; amended T-89-7, March 2, 1988; amended T-89-11, April 12, 1988.)

**111-4-69. Curfew Procedures.** If no player has won the grand prize at the conclusion of a spin by the last player in a round by approximately twenty-two (22) minutes into the show, or at a time determined by a lottery official, a bell will sound. After the bell has sounded, the players will continue to spin until the beginning of the next sequence or a player wins the grand prize, whichever comes first. At this point each player receives one final spin to determine the winner, unless one reaches the grand prize space in his or her final spin. All players shall progress or regress on their grid paths the appropriate number of spaces as determined by the wheel spin. If no one reaches the grand prize space, the one in the highest space is declared the winner. In the event of a tie, only the players tied continue to spin the wheel until one either reaches the grand prize space or is ahead of the other(s) at the end of the round, whichever comes first.

(Authorized by and implementing K.S.A. 1987 Supp. 74-8710(b); effective T-89-4, Jan. 21, 1988; amended T-89-10, April 6, 1988.)

**111-4-74. Infractions.** The following occurrences shall be known as infractions. Determinations regarding what, if any, infraction has occurred shall be made by the designated Kansas lottery security person or the auditor, and the appropriate remedy shall be made by the auditor.

(a) The wheel must spin at least one full revolution to be deemed a valid spin. If the wheel does not travel at least one full revolution, the player shall be allowed to respin the wheel. A player cannot move the wheel counterclockwise.

(b) A player who purposefully stops or alters the free travel of the wheel shall forfeit his or her turn.

(c) A player who accidentally stops or alters the full travel of the wheel shall be allowed to respin.

(d) A competing player who purposefully stops or alters the full travel of the wheel during another player's spin shall forfeit his or her turn and the player spinning the wheel shall be allowed, but not required, to respin.

(e) A competing player who accidentally stops or alters the free travel of the wheel shall suffer no penalty, and the player spinning the wheel shall be allowed, but not required, to respin.

(f) Any other questions concerning participation by the players, or action or inaction on the part of the production staff which could have an effect on the determination of a winner or winners shall be decided by the auditor.

(g) The designated lottery security person or the auditor shall have the authority to stop the show to correct infractions or resolve questions when required. (Authorized by and implementing K.S.A. 1987 Supp. 74-8710; effective T-89-4, Jan. 21, 1988, amended T-89-10, April 6, 1988.)

**111-4-77a. Watch 'N Win Drawing.** (a) In addition to the 14 entries selected pursuant to K.A.R. 111-3-22, as well as special drawings in other instant games, there shall be an additional ten envelopes drawn at the "weekly selection of participants" for the Watch 'n Win segments of Kansas Lottery Live. The first of these drawings shall take place on April 14, 1988.

(b) Of the ten additional names, five shall be announced during the early part of the show. The first person among the five announced who calls in on the toll free number (1-800-232-PLAY) shall win \$200 and the remaining four persons shall win \$100, providing that each calls in by noon the following Monday with his or her name, address and social security number.

(c) During the latter part of Kansas Lottery Live, the remaining five names shall be announced and prizes awarded according to rules set forth in subsection (b).

(d) A claim form will be sent to the winners and will be verified upon receipt by the lottery. (Authorized by and implementing K.S.A. 1987 Supp. 74-8710(b); effective T-89-11, April 12, 1988.)

The successor fiscal agent is providing the following information regarding the current status of the above-referenced bond issue:

1. By written request to the successor fiscal agent, bondholders may obtain a copy of a notice from Bank IV Wichita, N.A. (formerly Fourth National Bank of Wichita) informing the holders of the Series 1980 bonds that it has resigned as fiscal agent.
2. Bondholders have previously been notified that George C. Christopher Steel, Inc. (the "tenant") defaulted under the lease dated as of July 1, 1980, entered into in connection with the issuance of the Series 1980 bonds, on December 21, 1987. Such default has not been cured as of the date hereof. The tenant is involved in liquidation proceedings under the United States Bankruptcy Code. Substantially all of the assets of the tenant (including the tenant's leasehold interest under the lease) has been foreclosed upon by Bank IV in its capacity as commercial lender. The District Court of Sedgwick County, Kansas has confirmed the sale of substantially all of the tenant's assets (including the tenant's leasehold interest under the lease) to a wholly-owned operating subsidiary of Bank IV.
3. Pursuant to Section 22 of the bond ordinance, the holders of not less than 25 percent in aggregate principal amount of Series 1980 bonds outstanding may, by written notice given to the city and the tenant, declare the principal of all Series 1980 bonds then outstanding and the interest accrued thereon immediately due and payable. Bondholders electing to declare an acceleration of the Series 1980 bonds may request a form of letter to that effect from the successor fiscal agent. Please note that such letter *must* be notarized.
4. The principal amount of Series 1980 bonds outstanding as of the date hereof is \$1,055,000.
5. As of the date hereof there is on deposit in the principal and interest account established under the bond ordinance the sum of \$84,048.72.
6. Until such time as the successor fiscal agent determines that amounts in the principal and interest account are not needed to pay administrative expenses, the amounts being held in the principal and interest account will remain on deposit with the successor fiscal agent for use in paying any administrative costs and expenses incidental to the

default, acceleration and subsequent liquidation of collateral.

7. As previously discussed, Bank IV, as commercial lender, has foreclosed upon substantially all of the real estate, buildings, machinery and equipment formerly owned by the tenant. Bank IV is currently in possession of the entire steel fabrication plant. Portions of such plant are owned by the city under the lease which secures the Series 1980 bonds. Bank IV is currently operating the entire steel fabrication plant on a limited basis. The successor fiscal agent is negotiating with Bank IV on how to proceed with respect to the custody and disposition of the property, machinery and equipment pledged as security for the Series 1980 bonds. New appraisals which appraise separately the property pledged to the Series 1980 bonds and the property owned by Bank IV, as commercial lender, have been requested by Bank IV. These appraisals will be made available for inspection by the bondholders as soon as they are provided to the successor fiscal agent.
8. Any proposals or recommendations with regard to the final disposition of the property, machinery and equipment pledged as security for the Series 1980 bonds will be submitted to the bondholders for their consent and approval.
9. Set forth below is an excerpt from the bond ordinance regarding the rights of bondholders.  

"Section 21. *Enforcement.* The provisions of this Ordinance shall constitute a contract between the City of Wichita, Kansas, and the holders of the Bonds herein authorized, and the holder of any one or more of said Bonds may sue to recover interest or principal which has not been paid according to the terms of said Bond. Notwithstanding any provisions of this Ordinance to the contrary, nothing in this Ordinance shall be so construed as to authorize or permit the City to make any contract or to incur any obligation of any kind or nature except such as shall be payable solely out of the rentals from the leased facilities. The holders of Twenty-Five percent (25%) of the principal amount of Bonds then outstanding may sue in any action, in mandamus, injunction or other proceedings, either at law or in equity, to enforce or compel performance of all duties and obligations required by this Ordinance to be done or performed by the City or by the Tenant. Nothing contained in this Ordinance shall, however, be construed to impose on said City any duty or obligation to levy any taxes either to meet any contractual obligation contained herein or to pay any judgment for damages or to pay the principal of or interest on the Bonds of the City herein authorized."

**Substitute for SENATE BILL No. 491**

AN ACT relating to property taxation; concerning the exemption of certain property therefrom and providing a procedure therefor.

*Be it enacted by the Legislature of the State of Kansas:*

Section 1. Any group, association, corporation or individual who has not been assessed or levied a tax on its personal or real property prior to July 1, 1985, and who has applied for exemption from ad valorem taxation on such property premised upon use for purposes described in K.S.A. 79-201 *Second* between July 1, 1986, and January 1, 1990, shall not be liable for any taxes prior to January 1, 1987, if such group, association, corporation or individual had a reasonable basis to believe that it would not be assessed or taxed under the laws of the state of Kansas, and did not deceive or otherwise mislead, by affirmative misrepresentation, the county appraiser or other taxing authority in relationship to the use or ownership of such property. The burden of proof shall rest with the party claiming exemption. Relief may be granted under this section by a court in any pending tax appeal, by remand to the state board of tax appeals or upon the filing of an initial application pursuant to K.S.A. 79-213, and amendments thereto.

Sec. 2. This act shall take effect and be in force from and after its publication in the Kansas register.

## SENATE BILL No. 722

AN ACT relating to the division of the budget; amending K.S.A. 75-1251 and 75-3714a and K.S.A. 1987 Supp. 75-3721 and repealing the existing sections.

*Be it enacted by the Legislature of the State of Kansas:*

Section 1. K.S.A. 75-1251 is hereby amended to read as follows: 75-1251. As used in K.S.A. 75-1250 to 75-1267, inclusive, and amendments thereto, unless the context otherwise requires: (a) "Firm" means such individual, firm, partnership, corporation, association, or other legal entity which is: (1) permitted by law to practice the profession of architecture; and (2) maintaining an office in Kansas staffed by one or more architects who are licensed by the board of technical professions; or (3) not maintaining an office in Kansas but which is qualified to perform special architectural services that are required in special cases where in the judgment of the secretary of administration it is necessary to go outside the state to obtain such services.

(b) "Negotiating committee" means a committee to negotiate as provided in this act, and consisting of (1) the head of the state agency for which the proposed project is planned or of the state agency which controls and supervises the operation and management of the institution for which the proposed project is planned, if such is the case, or a person designated by the head of the agency, (2) the head of the institution for which the proposed project is planned, or a person designated by the head of the institution, and (3) the director of the ~~budget division of architectural services~~, or a person designated by the director of the ~~budget~~, who shall act as chairperson of the committee. When the proposed project is not planned for an institution, the state agency head shall designate a second person in lieu of the head of an institution.

(c) "Architectural services" means those professional services of an architectural nature as well as basic structural, mechanical and electrical engineering services and incidental services that members of the architectural profession and those in their employ may logically or justifiably perform concerning state buildings and grounds, including inspections of air conditioning, ventilating, heating and other building systems.

(d) "Project architect" means a firm employed under this act for a particular project.

(e) "State building advisory commission" means the state building advisory commission created by K.S.A. 75-3780, and amendments thereto, or any duly authorized officer or employee of such commission.

(f) "State agency" includes any state institution.

Sec. 2. K.S.A. 75-3714a is hereby amended to read as follows: 75-3714a. There is hereby established, within and as a part of the department of administration, a division of the budget, the head of which shall be the director of the budget. Under the supervision of the ~~secretary of administration~~ governor, the director of the budget shall administer the division of the budget. The director of the budget shall be in the unclassified service under the Kansas civil service act and shall be appointed by the ~~secretary of administration~~ governor.

Sec. 3. K.S.A. 1987 Supp. 75-3721 is hereby amended to read as follows: 75-3721. (a) On or before the eighth calendar day of each regular legislative session, the governor shall submit the budget report to the legislature, except that in the case of the regular legislative session immediately following the election of a governor who was elected to the office of governor for the first time, that governor shall submit the budget report to the legislature on or before the 21st calendar day of that regular legislative session.

(b) The budget report of the governor shall be set up in three parts, the nature and contents of which shall include the following:

(1) Part one shall consist of a budget message by such governor, including the governor's recommendations with reference to the fiscal policy of the state government for the ensuing budget period, describing the important features of the budget plan, embracing a general budget summary setting forth the aggregate figures of the budget so as to show the balanced relation between the total proposed expenditures and the total

anticipated income, with the basis and factors upon which the estimates were made, and the means of financing the budget for the ensuing budget period, compared with the corresponding figures for at least the last completed fiscal year and the current year, and the director of the budget; ~~under the supervision of the secretary of administration~~, shall prepare the figures for the governor for such comparisons. *The budget plan shall not include any proposed expenditures of anticipated income attributable to proposed legislation that would provide additional revenues from either current or new sources of revenue.* The general budget summary may be supported by explanatory schedules or statements, classifying the expenditures contained therein by state agencies, objects, and funds, and the income by state agencies, funds, sources and types. The general budget summary shall include all special or fee funds as well as the state general fund, and shall include the estimated amounts of federal aids, for whatever purpose provided, together with estimated expenditures therefrom.

(2) Part two shall embrace the detailed budget estimates, both of expenditures and revenues, showing the requests of the state agencies, if any, and the incoming governor's recommendations thereon. It shall also include statements of the bonded indebtedness of the state, showing the actual amount of the debt service for at least the last completed fiscal year, and the estimated amount for the current fiscal year and for the next budget period, the debt authorized and unissued, and the condition of the sinking funds.

(3) Part three shall consist of a draft of a legislative measure or measures reflecting the incoming governor's budget.

(c) The division of the budget shall, upon request, shall furnish the governor or the legislature with any further information required concerning the budget.

(d) *Nothing in this section shall be construed to restrict or limit the privilege of the governor to present supplemental budget messages or amendments to previous budget messages, which may include proposals for expenditure of new or increased sources of revenue derived from proposed legislation.*

Sec. 4. K.S.A. 75-1251 and 75-3714a and K.S.A. 1987 Supp. 75-3721 are hereby repealed.

Sec. 5. This act shall take effect and be in force from and after its publication in the Kansas register.

HOUSE BILL No. 3116

AN ACT concerning the mental health technician's licensure act; relating to the practice of mental health technology; amending K.S.A. 65-4202 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 65-4202 is hereby amended to read as follows: 65-4202. As used in this act: (a) "Board" means the Kansas state board of nursing.

(b) The "practice of mental health technology" means the performance, under the direction of a physician licensed to practice medicine and surgery or registered professional nurse, of services in caring for and treatment of the mentally ill, emotionally disturbed, or mentally retarded for compensation or personal profit, which services:

(1) Involve responsible nursing and therapeutic procedures for such mentally ill or mentally retarded patients requiring interpersonal and technical skills in the observations and recognition of symptoms and reactions of such patients, and the accurate recording of the same, and the carrying out of treatments and medications as prescribed by a licensed physician; and

(2) require an application of such techniques and procedures as involve understanding of cause and effect and the safeguarding of life and health of the patient and others, including all gastro feeding procedures except connecting the feeding tube, controlling the flow of formula through the feeding tube, tube aspiration of the feeding tube, administering medication through the feeding tube, disconnecting the feeding tube and clamping off the feeding tube; and

(3) require the performance of such other duties as are necessary to facilitate rehabilitation of the patient or are necessary in the physical, therapeutic and psychiatric care of the patient and to require close work with persons licensed to practice medicine and surgery, psychiatrists, psychologists, rehabilitation therapists, social workers, registered nurses, and other professional personnel.

(c) A "licensed mental health technician" means a person who lawfully practices mental health technology as defined in this act.

(d) An "approved course in mental health technology" means a program of training and study including a basic curriculum which shall be prescribed and approved by the board in accordance with the standards prescribed herein, the successful completion of which shall be required prior to licensure as a mental health technician, except as hereinafter provided.

Sec. 2. K.S.A. 65-4202 is hereby repealed.

Sec. 3. This act shall take effect and be in force from and after its publication in the Kansas register.

SENATE BILL No. 769

AN ACT relating to the Kansas state fair; establishing the state fair capital improvements fund; providing for transfers of money thereto; prescribing the uses thereof; making and concerning appropriations for the fiscal years ending June 30, 1988, and June 30, 1989.

Be it enacted by the Legislature of the State of Kansas:

Section 1. (a) There is hereby established in the state treasury the state fair capital improvements fund. All expenditures of moneys in the state fair capital improvements fund shall be used for the payment of capital improvements and maintenance for the state fairgrounds and the payment of capital improvement obligations that have been financed. Capital improvement projects for the Kansas state fair grounds are hereby approved for the purposes of subsection (b) of K.S.A. 1987 Supp. 74-8905 and amendments thereto and the authorization of the issuance of bonds by the Kansas development finance authority in accordance with that statute.

(b) On June 30, 1989, and on each June 30 thereafter, the state fair board shall certify to the director of accounts and reports an amount to be transferred to the state fair capital improvements fund, which amount shall be not less than the amount equal to 5% of the total gross receipts during the current fiscal year from state fair activities and non-fair days activities. Such certification also shall specify what portion of the amount certified is to be transferred from the state fair fee fund and what portion is to be transferred from the non-fair days activities fee fund. Upon receipt of such certification, the director of accounts and reports shall transfer moneys to the state fair capital improvements fund in the amounts and from the funds specified in such certification.

(c) On July 1, 1989, and on each July 1 thereafter, the director of accounts and reports shall transfer from the state general fund to the state fair capital improvements fund, an amount equal to the amount certified by the state fair board pursuant to subsection (b), except that no transfer from the state general fund under this subsection shall exceed \$300,000 in any fiscal year.

(a) There is appropriated for the above agency from the following special revenue fund for the fiscal years specified, all moneys now or hereafter lawfully credited to and available in such fund, except that expenditures other than refunds authorized by law shall not exceed the following:

Provided, That no expenditures for any capital improvement project or maintenance project for the state fairgrounds shall be made from this fund, from moneys appropriated for fiscal year 1988 or fiscal year 1989, unless the proposed capital improvement project or maintenance project has been presented to the joint committee on state building construction: Provided further, That no expenditures for the payment of any capital improvement obligations that have been financed shall be made from this fund, from moneys appropriated for fiscal year 1988 or fiscal year 1989, unless the capital improvements that are financed have been presented to the joint committee on state building construction prior to being financed.

(b) On the effective date of this act, the director of accounts and reports shall transfer \$575,000 from the state general fund to the state fair capital improvements fund.

(c) On July 1, 1988, the expenditure limitation established by section 5(a) of 1988 House Bill No. 2733 on the state fair fee fund is hereby increased from \$1,654,309 to no limit.

SENATE BILL No. 543

AN ACT making and concerning appropriations for the fiscal years ending June 30, 1988, and June 30, 1989, for the department of transportation and Kansas highway patrol; authorizing certain transfers, imposing certain restrictions and limitations, and directing or authorizing certain receipts and disbursements and acts incidental to the foregoing.

Be it enacted by the Legislature of the State of Kansas:

Section 1. For the fiscal years ending June 30, 1988, and June 30, 1989, appropriations are hereby made, restrictions and limitations are hereby imposed, and transfers, receipts, disbursements and acts incidental to the foregoing are hereby directed or authorized as provided in this act.

Sec. 2.

DEPARTMENT OF TRANSPORTATION

(a) There is appropriated for the above agency from the following special revenue funds for the fiscal year ending June 30, 1989, all moneys now or hereafter lawfully credited to and available in such funds, except that expenditures shall not exceed the following:

State highway fund . . . . . No limit

Provided, That no expenditures may be made from the state highway fund other than for the following specified purposes: Provided, however, That expenditures from the state highway fund may be made for engineering services furnished to counties for road and bridge projects under K.S.A. 68-402e and amendments thereto: Provided further, That expenditures from the state highway fund other than refunds authorized by law for the following specified purposes shall not exceed the limitations prescribed therefor as follows:

Administration . . . . . \$9,249,482

Provided, That expenditures from this account for official hospitality for the annual convention of the American association of highway and transportation officials in Wichita, Kansas by the secretary of transportation shall not exceed \$4,000: Provided further, That other expenditures from this account for official hospitality by the secretary of transportation shall not exceed \$1,000: And provided further, That expenditures may be made from this account for awards for employee suggestions through a work improvement program: And provided further, That expenditures for such awards shall not exceed \$1,000: And provided further, That expenditures may be made from this account

Intergency motor vehicle fuel sales fund . . . . . No limit

Provided, That expenditures may be made from this fund to provide and sell motor vehicle fuel to the Kansas highway patrol: Provided further, That the secretary of transportation is hereby authorized to fix, charge and collect fees for motor vehicle fuel sold to the Kansas highway patrol: And provided further, That such fees shall be fixed in order to recover all or part of the expenses incurred in providing motor vehicle fuel to the Kansas highway patrol: And provided further, That all fees received for such sales of motor vehicle fuel shall be credited to this fund.

(b) On April 1, 1989, the director of accounts and reports shall transfer from the motor pool service fund of the department of administration to the state highway fund of the department of transportation an amount determined to be equal to the sum of the annual vehicle registration fees for each vehicle owned or leased by the state or any state agencies in accordance with K.S.A. 75-4611 and amendments thereto.

(c) The above agency shall contract for maintenance during fiscal year 1989 in an amount adjusted for inflation of not less than the amount contracted for maintenance by such agency during fiscal year 1988.

(d) On July 1, 1988, the director of accounts and reports shall transfer \$1,200,000 from the energy grants management fund of the state corporation commission to the oil overcharge-KDOT projects fund of the department of transportation.

(a) There is appropriated for the above agency from the state general fund for the fiscal year ending June 30, 1989, the following:

Sec. 5. *Appeals to exceed limitations*. Upon written applica-

tion to the governor and approval of the state finance council, expenditures from special revenue funds may exceed the amounts specified in this act.

Sec. 6. *Savings*. Any unencumbered balance in any special revenue fund, or account thereof, which is not otherwise specifically appropriated or limited by this or other appropriation act of the 1988 regular session of the legislature, is hereby appropriated for the same use and purpose as the same was heretofore appropriated.

Sec. 7. *Federal grants*. Each federal grant or other federal receipt which is received for the fiscal year ending June 30, 1989, by a state agency named in this act and which is not otherwise appropriated to that state agency by this or other appropriation act of the 1988 regular session of the legislature, is hereby appropriated for that state agency for the purpose set forth in such federal grant or receipt, except that no expenditure shall be made from and no obligation shall be incurred against any such federal grant or other federal receipt, which has not been previously appropriated or reappropriated or approved for expenditure by the governor, until the governor has authorized the state agency to make expenditures therefrom.

Sec. 8. Any transfers of money during the fiscal year ending June 30, 1989, from any special revenue fund of any state agency named in this act to the audit services fund of the division of post audit under K.S.A. 46-1121 and amendments thereto shall be in addition to any expenditure limitation imposed on any such fund for the fiscal year ending June 30, 1989.

Sec. 9. *Effective date*. This act shall take effect and be in force from and after its publication in the Kansas register.
