## NOTICE OF REVIEW OF SURFACE WATER QUALITY STANDARDS

The Kansas Department of Health and Environment (KDHE) will conduct a triennial review of its surface water quality standards (K.A.R. 28-16-28b through 28-16-28f). Section 303 of the federal Clean Water Act requires states to adopt water quality standards and also to review and revise them, if necessary, every three years.

Additionally, these regulations are authorized under K.S.A. 65-171d. The regulations address the classification and the designated uses of surface waters. The most recent Kansas revision was in 1985. The review was extensive, involving the work of a public participation task force, six public meetings and two public hearings. The revised standards were adopted as K.A.R. 28-16-28b through K.A.R. 28-16-28f to be effective on May 1, 1986.

Persons desiring to comment on or suggest changes to the standards and be placed on a mailing list to receive a draft copy of proposed revisions should contact Linda Vandevord at Water Quality Assessment Section, KDHE, Forbes Field, Building 740, Topeka 66620, (913) 296-5565. Technical questions may be directed to Don Snethen at the same address, (913) 296-5567.

Initial issues identified by KDHE include: antidegradation, development of two-tier aquatic life criteria, criteria for the special/restricted aquatic life use, criteria for pesticides, drinking water criteria, and contact recreation. Comments received prior to August 15 will be acknowledged.

# NOTICE OF HEARING ON PROPOSED ADMINISTRATIVE REGULATIONS

The office of the Consumer Credit Commissioner will conduct a public hearing at 10 a.m. Tuesday, August 23, in Room 352, Landon State Office Building, 900 S.W. Jackson, Topeka, on the proposed revocation of regulations 75-6-12, 75-6-13, 75-6-27 and 75-6-28. All interested parties may present oral or written comments and shall be given reasonable opportunity to present their views or arguments on the revocation of these regulations at the hearing.

The regulations proposed for revocation are in conflict with statutes as amended July 1, 1988. Regulations 75-6-12 and 75-6-13 refer to deferral charges and rebates by the rule of 78ths method. Computations by the rule of 78ths were deleted from the Uniform Consumer Credit Code effective July 1, 1988. Regulation 75-6-27 refers to K.S.A. 16a-2-510(4), which was deleted from the Uniform Consumer Credit Code effective July 1, 1988. Regulation 75-6-28 refers to K.S.A. 16a-2-401(10), which was amended in the Uniform Consumer Credit Code effective July 1, 1988.

The deletion of the rule of 78ths from the Uniform Consumer Credit Code will have a negative economic impact on the industry, a positive economic impact on the consumer, and no economic impact on this agency. There will be no economic impact on the consumer, industry or agency due to the deletion of 75-6-28.

Copies of the regulations proposed for revocation and the economic impact statements can be obtained from the Consumer Credit Commissioner at the address above.

This 30-day notice constitutes a public comment period for the purpose of receiving written public comments on the proposed revocations. Written comments may be submitted to the Consumer Credit Commissioner.

# NOTICE OF HEARING ON PROPOSED ADMINISTRATIVE REGULATIONS

The Kansas State Board of Education will conduct a public hearing at 1:30 p.m. Tuesday, September 13, in Room 121 of the Kansas State Education Building, 120 E. 10th, Topeka, to consider proposed changes in Kansas Administrative Regulations 91-12-24, 91-12-24a, 91-12-26, 91-12-28, and 91-12-61.

The following is a summary of the substance of each proposed regulation and a summary of its anticipated economic impact.

- 1. K.A.R. 91-12-24 concerns the provision of hospital/homebound services for identified special education students. This regulation is being replaced by K.A.R. 91-12-24a. There will be no financial impact upon the State Department of Education, other governmental agencies, private business or individuals.
- 2. K.A.R. 91-12-24a concerns the provision of hospital/homebound services for identified special education students. Local education agency administrators requested a reduction in the number of reports required by the state department. The provision of hospital/homebound services for handicapped children is mandated by federal law. There will be a slight reduction in staff time and agency printing costs, as well as a slight reduction in local education agency staff time for processing forms. This regulation replaces K.A.R. 91-12-24.
- 3. K.A.R. 91-12-26 concerns the accreditation of special purpose schools. This regulation is being revoked because it is a duplication of agency accreditation regulations. There will be no financial impact upon the State Department of Education, other governmental agencies, private business or individuals.
- 4. K.A.R. 91-12-28 concerns on-site compliance monitoring and is being amended to change the timeline from six weeks to 12 weeks for preparation of the final compliance report. On-site compliance monitoring is mandated by federal law. There will be no financial impact upon the State Department of Education, other governmental agencies, private business or individuals.
- 5. K.A.R. 91-12-61 concerns paraprofessionals in special education. This regulation is being amended because of changes in the Nurse Practice Act that will allow a paraprofessional to give students medication under the supervision of a licensed nurse. There will be no financial impact upon the State Department of Education, other governmental agencies, private business or individuals.

A copy of the proposed regulations is being mailed to chief school administrators in the state and may be reviewed in their offices by interested persons. Also, a copy of the proposed regulations and complete economic impact statements may be obtained by contacting the secretary of the State Board of Education prior to the date of the hearing.

On the date of the hearing, all interested persons will be given a reasonable opportunity to present their views or arguments, either orally or in writing, in regard to the proposed regulations. Counties and County Officers—General Provisions—Home Rule Powers.

Constitution of the State of Kansas—Corporations—Cities' Powers of Home Rule. Stephan J. Smith, Burlington City Attorney, Emporia, July 7, 1988.

Pursuant to Article 12, § 5 of the Kansas Constitution and K.S.A. 1987 Supp. 19-101a, Kansas cities and counties may use home rule power to issue general obligation bonds. The proceeds from sale of those bonds may be used to finance what the legislative body rationally believes would promote a valid public purpose. In specific instances, such purposes may include encouraging, assisting and promoting private economic development. A member of a redevelopment committee of a city is an "employee" of the city, as that term is defined in subsection (d) of K.S.A. 75-6102. Accordingly, a member of such a committee is covered by the provisions of the Kansas tort claims act, including complete immunity for the functions set out at K.S.A. 75-6104, and is entitled to a legal defense in the event he or she is sued for acts or omissions in the scope of his or her employment. In the further event that a judgment is rendered against a committee member for such acts or omissions, he or she may look to the city for indemnification. The misnomer in L. 1988, c. 47, § 19 is not a defect which renders the section void. The intent of the legislature is sufficiently clear to allow substitution of the correct language, so that reference to K.S.A. 40-277(7)(c), which does not exist, becomes K.S.A. 40-277(4)(a). Pursuant to section 19, blood-alcohol tests refusals or failures are not open records. Insurers may not consider such refusals or failures in determining automobile liability rates or in determining whether to cancel a policy. However, if a driving privilege is suspended by the department of revenue, the suspension is part of an open record, which may be obtained by insurers to process an application, renewal, or cancellation of a motor vehicle liability insurance policy. ## TEMPORARY ADMINISTRATIVE REGULATIONS

#### Article 3.—INSTANT GAME RULES

111-3-14. Payment of Prizes. The procedures for payment of instant prizes to the winners of the instant games are as follows:

(a) The executive director or his designee shall award the designated prize to the appropriate person as soon as it is determined that all laws, regulations, and rules have been adhered to.

(b) Low-tier instant game prizes of \$25.00 or less shall be paid as follows:

(1) Present the ticket to the same retailer from whom the ticket was purchased. Upon validation of the ticket, the retailer shall immediately make payment for the prize to the claimant. If the retailer cannot validate the claim, the claimant shall fill out a claim form provided by the retailer and personally present or mail the completed form together with the ticket to Kansas lottery headquarters. If the claim is validated, then payment shall be made to the claimant by mail.

(2) Bring the ticket to any Regional office of the Kansas lottery during the hours that such office is open to the public for business. Upon verification of the claim, payment for such claim shall be made to the winner in the following manner:

(A) The prize for a validated free ticket winner redeemed in this manner shall be \$1.00 to be paid by the Kansas lottery.

(B) The prize for other validated low-tier winners redeemed in this manner shall be paid out of the lottery prize payment fund. Upon verification of the claim, the payment for the prize shall be mailed to the claimant.

(3) Mail the ticket with a completed claim form in any envelope other than an official "Grand Prize Draw" envelope to any office of the Kansas lottery. Claim forms can be obtained from any lottery instant game retailer or any office of the Kansas lottery. Upon verification of the claim, the payment for such claim shall be made to the winner in the following manner:

(A) The prize for a validated free ticket winner redeemed in this manner shall be \$1.00 which shall be paid by the Kansas lottery. Upon verification of the claim, the payment for the prize shall be mailed to the claimant.

(B) The prizes for other validated low-tier winners redeemed in this manner shall be paid out of the lottery prize payment fund. Upon verification of the claim, the payment for the prize shall be mailed to the claimant.

(c) Mid-tier game prizes in excess of \$25.00 but not exceeding \$100.00 shall be paid by any one of the following methods:

(1) Present the ticket to any authorized Kansas lottery retailer. Upon validation of the ticket the retailer may immediately make payment of prize to the claim-

ant. If the retailer chooses not to make the payment, the claimant shall claim the prize in another manner prescribed in these rules.

(2) Bring the ticket to any office of the Kansas lottery during the hours that such office is open to the public for business. Upon verification of the claim, the payment for the prize shall be mailed to the claimant.

(3) Mail the ticket with a completed claim form in any envelope other than an official "Grand Prize Draw" envelope to the Kansas lottery headquarters. Claim forms can be obtained from any lottery instant game retailer or any office of the Kansas lottery. Upon verification of the claim, the payment for the prize shall be mailed to the claimant.

(d) High-tier instant game prizes in excess of \$100.00 shall be paid by any one of the following

methods:

(1) Bring the ticket to any office of the Kansas lottery during the hours that such office is open to the public for business. Upon verification of the claim, the payment shall be made to the claimant by the executive director by any means deemed appropriate.

- (2) Mail the ticket with a completed claim form in any envelope other than a "Grand Prize Draw" envelope to any office of the Kansas lottery. Claim forms may be obtained from any lottery instant game retailer or any office of the Kansas lottery. Upon verification of the claim, the payment shall be made to the claimant by the executive director by any means deemed appropriate. In the event of a dispute between a ticket bearer and the Kansas lottery concerning any instant winner lottery game, and the drawings associated with any instant game, the executive director has the authority to determine the facts underlying the dispute and to pay a prize to the holder of a valid winning lottery ticket. If the investigation of the dispute is inconclusive, the executive director may, solely at his or her option, reimburse the ticket bearer for the cost of the disputed ticket. If the investigation of the dispute determines facts in favor of the Kansas lottery, the executive director shall deny any claim relating to the dispute. 111-3-17. Governing Laws, Regulations, and Rules. In purchasing a ticket or entering any drawing, the player agrees to comply with and abide by the Kansas lottery act; and all rules and regulations of the Kansas lottery. (Authorized by and implementing K.S.A. 1987 Supp. 74-8710, as amended by L. 1988, ch. 366, § 23; effective T-89-4, Jan. 22, 1988; amended T-89-25, May 24, 1988; amended T-111-7-7-88.)

111-3-19. Grand Prize Drawing and Other Drawings. The Kansas lottery shall conduct one grand prize drawing in connection with each instant ticket game up to and including game 4, "Kansas Treasures." Players for the grand prize drawing or other drawings shall be selected by the Kansas lottery during the established weekly drawing. (Authorized by and implementing K.S.A. 1987 Supp. 74-8710; as amended by L. 1988, ch. 366, § 23; effective T-89-4, Jan. 21, 1988; amended T-111-7-7-88.)

111-3-20. Method of Entry. Entry into the "Grand Prize Drawing," and other drawings is accomplished by the following steps:

(a) Obtain a valid Kansas instant game lottery ticket; (b) Determine if the ticket is a winning ticket in accordance with any instant game rules. If the ticket is a winning ticket, it is not eligible for the "Grand Prize Drawing" or other drawings and shall be redeemed in accordance with the appropriate game rules;

(c) If the ticket is a non-winning ticket, the ticket is eligible for winning the drawing, and the holder of the ticket may enter the "Grand Prize Drawing" or other drawings once the holder accumulates five (5) non-

winning tickets:

(d) The holder of the five (5) non-winning tickets must complete the information form on the back of at least one (1) ticket in a legible manner and sign all five (5) tickets:

- (e) The holder of the tickets must obtain an official entry envelope entitled "Grand Prize Draw" or 'Kansas Lottery Entry Label" from any Kansas lottery retailer: and
- (f) Place the five (5) tickets into the envelope or a 3% by 6½ inch envelope with an official Kansas Lottery Entry Label affixed and mail them to the address printed on the envelope or label.
- (g) There is no limit on the number of entries a person may make. (Authorized by and implementing K.S.A. 1987 Supp. 74-8710, as amended by L. 1988, ch. 366, § 23; effective T-89-4, Jan. 21, 1988; amended T-111-7-7-88.)
- 111-3-21. Certification of Weekly "Grand Prize Drawing" and Other Drawings. (a) All preliminary and final "Grand Prize Drawing" and other drawings shall be personally observed by a member of the Kansas lottery division of security designated by the executive director and by an auditor.

(b) Upon completion of the drawings, the designated lottery security person and the auditor shall issue a report certifying that the name of the participant selected is correct and that to the best of their knowledge the procedures required by these rules

were followed in selecting the participant.

(c) The affidavit shall be placed in an envelope, sealed, and given to the director of security to hold in a secured file until the time designated by the executive director for the "Grand Prize Drawing" or other drawings. (Authorized by and implementing K.S.A. 1987 Supp. 74-8710, as amended by L. 1988, ch. 366, § 23; effective T-89-4, Jan. 21, 1988; amended T-111-7-7-88.)

111-3-22. Weekly Selection of Participants. The following process shall be used for the selection of participants in the weekly "Grand Prize Drawing" and other drawings:

(a) Kansas Lottery mail room personnel shall pick up all mail trays containing "Grand Prize Draw" envelopes at the Topeka United States Post Office on a

daily basis.

(b) The mail room and security personnel shall transport the mail trays to a secure area where they will be held until the time designated by the executive director for the selection of participants in the "Grand Prize Drawing" and other drawings.

(c) The selection process shall be held weekly. All drawings shall be held in a place accessible to the public and be open for public attendance and with lottery security personnel present. All drawings shall

be video taped.

(d) An individual designated by the executive director shall pick at random two (2) sealed envelopes from each tray using the bare-arm technique. Should the designated individual draw an envelope with tickets belonging to that designated individual, the envelope shall be disqualified.

(e) The designated individual shall place the en-

velopes in a drum.

(f) Once the individual has selected two (2) envelopes from each tray, the drum shall be sealed and the contents mixed by shaking or rotating.

(g) The designated individual shall then unseal the drum, and using the bare-arm technique, remove one "Crond Prize Dray" envelope from the drum

"Grand Prize Draw" envelope from the drum.

(h) The designated Kansas lottery security official shall unseal the "Grand Prize Draw" envelope removed from the drum and review the tickets inside to determine if they are eligible for the "Grand Prize Drawing" and other drawings in accordance with this regulation.

(i) If the tickets contained in the envelope are determined to be ineligible, the envelope removed shall be discarded, the drum resealed, and another envelope removed. This procedure will be repeated until all valid selections are obtained from the drum.

(j) Each valid entry, as it is obtained, shall be clearly marked in a permanent manner with a number. The number one (1) shall be placed on the first valid entry, the number two on the second valid entry, and

so on until all valid entries are marked.

(k) As long as there is a "Grand Prize Drawing" the first entry drawn shall be entered into the "Grand Prize Drawing." The next six entries drawn shall be entered into the televised draw show. Thereafter, the next six entries drawn shall be home partners for televised draw show participants. The identities of the last six participants drawn will be disclosed on the appropriate draw show.

(l) All "Grand Prize Draw" envelopes remaining in the drum and the mail trays after valid entries have

been selected shall be destroyed.

(m) The valid entry envelopes shall be certified and secured in accordance with K.A.R. 111-3-21. (Authorized by and implementing K.S.A. 1987, Supp. 74-8710(b), as amended by L. 1988, ch. 366, § 23; effec-

tive T-89-4, Jan. 21, 1988; amended T-89-25, May 24, 1988; amended T-111-7-7-88.)

111-3-25. Winner Validation. The following validation requirements shall apply to the "Grand Prize Drawing" and other drawings:

(a) Each "Grand Prize Draw" envelope must contain five (5) valid non-winning Kansas instant game

lottery tickets from any game;

(b) Each ticket must be signed by the same person, and the information form on the back of at least one ticket must be filled out in a legible manner.

(c) Each ticket must have been issued by the Kansas lottery in an authorized manner and must not be

counterfeit in whole or in part;

(d) Each ticket must be complete and intact and not mutilated, altered, unreadable, reconstructed, or tampered with in any way;

(e) Each ticket must not be blank or partially blank, misregistered, defective, or printed or produced in

error;

(f) The display printing on each ticket must be regular in every respect and correspond precisely with the artwork on file at the Kansas lottery;

(g) Each ticket must not be stolen nor appear on any list of omitted tickets on file at the Kansas lottery;

- (h) Each ticket must have exactly one ticket validation number, one book-ticket number, and two retailer validation codes, each of which must be present in its entirety, be fully legible, be exactly as described in paragraph (d) above, and correspond precisely to the artwork on file at the Kansas Lottery. Each ticket validation number shall correspond to the play symbols on the ticket:
- (i) The ticket validation number of the tickets shall not appear on the Kansas lottery's official list of ticket validation numbers of winning tickets.
- (j) Any ticket not passing all the validation checks in this section is void and is not eligible for the "Grand Prize Drawing" or other drawings. (Authorized by and implementing K.S.A. 1987 Supp. 74-8710(b), as amended by L. 1988, ch. 366, § 23; effective T-111-7-7-88.)
- 111-3-27. Rights of Participants. Any Kansas instant game lottery ticket entered into the "Grand Prize Drawing," or other Lottery drawings, is disqualified from any other Kansas lottery prize or eligibility that ticket may have been redeemable for. (Authorized by and implementing K.S.A. 1987 Supp. 74-8710(d), as amended by L. 1988, ch. 366, § 23; T-111-7-7-88.)

#### Article 4.—INDIVIDUAL GAME RULES

111-4-77a. Watch'N Win Drawing. (a) In addition to the entries selected pursuant to K.A.R. 111-3-22, as well as special drawings in other instant games, there shall be an additional ten envelopes drawn at the "weekly selection of participants" for the Watch 'N Win segments of Kansas Lottery Live. The first of these drawings shall take place on April 14, 1988.

(b) Of the ten additional names, five shall be announced during the early part of the show. The first person among the five announced who calls in on the toll free number (1-800-232-PLAY) shall win \$200 and the remaining four persons shall win \$100, providing that each calls in by noon the following Monday with his or her name, address and social security number.

(c) During the latter part of Kansas Lottery Live, the remaining five names shall be announced and prizes awarded according to rules set forth in subsection (b).

(d) A claim form will be sent to the winners and will be verified upon receipt by the lottery. (Authorized by and implementing K.S.A. 1987 Supp. 74-8710(b), as amended by L. 1988, ch. 366, § 23; effective T-89-11, April 13, 1988; amended T-111-7-7-88.)
