NOTICE OF HEARING  
ON PROPOSED  
ADMINISTRATIVE REGULATIONS

A public hearing will be conducted from 9:30-10:30 a.m. Tuesday, October 11, in the boardroom of the State Board of Regents, Suite 609, Capitol Tower, Topeka, to consider the adoption of proposed rules and regulations 88-16-1, 88-16-1a, 88-16-2 and 88-16-5 of the Board of Regents on a temporary and permanent basis. These regulations are revisions of existing regulations.

All interested parties may submit written comments prior to the hearing to the general counsel of the Board of Regents, 400 S.W. 8th, Suite 609, Topeka 66603. All interested parties will be given a reasonable opportunity at the hearing to present their views orally on the adoption of the proposed regulations. In order to give all parties an opportunity to express their views, it may be necessary to request each participant to limit oral presentation to five minutes.

This 30-day notice constitutes a public comment period for the purpose of receiving written public comments on the proposed regulations.

A summary of K.A.R. 88-16-1, 88-16-1a, 88-16-2 and 88-16-5 follows:

88-16-1. Sets forth the general requirement that no foreign institution of postsecondary education and no private institution of postsecondary education shall confer or award any degree in the state of Kansas without the advance approval of the Board of Regents.

88-16-1a. Defines terms used in the regulations relating

to the review of academic degree programs by such institutions.

88-16-2. Establishes the minimum standards required for institutions to be approved to confer or award degrees in the state of Kansas.

88-16-5. Establishes the procedures for obtaining approval to award or confer degrees in the state of Kansas.

The regulations provide for review and approval by the Board of Regents for foreign institutions of postsecondary education and certain private institutions of postsecondary education to confer or award an academic degree in the state of Kansas. There will be additional administrative costs imposed on the Board of Regents for administration of these rules and regulations, but no reasonable estimate of the costs involved can be made at this time. Likewise, no reasonable estimate can be made of the number of institutions that might wish to confer or award degrees in the state of Kansas.

There will be a required expenditure of time and money by those institutions who seek such authority. While these costs are not reasonably capable of estimation, they could be expected to be of some magnitude dependent upon the efforts necessary to gain approval by the Board of Regents. There should be no direct costs imposed on the general public, nor additional costs imposed on the state as a result of these regulations.

These regulations are revisions of existing regulations.

All interested parties may submit written comments prior to the hearing to the general counsel of the Board of Regents, 400 S.W. 8th, Suite 609, Topeka 66603. All interested parties will be given a reasonable opportunity at the hearing to present their views orally on the adoption of the proposed regulations. In order to give all parties an opportunity to express their views, it may be necessary to request each participant to limit oral presentation to five minutes.

This 30-day notice constitutes a public comment period for the purpose of receiving written public comments on the proposed regulations.

A summary of K.A.R. 88-15-1 and 88-15-2 follows:

88-15-1. Establishes general requirements for foreign institutions of postsecondary education to offer academic courses or programs in the state of Kansas.

88-15-2. Sets forth the detailed registration procedures to be followed by foreign institutions of postsecondary education prior to offering academic coursework in the state of Kansas.

The regulations provide for the registration of academic courses and programs with the Board of Regents by foreign institutions of postsecondary education who wish to offer or conduct those courses or programs in the state of Kansas. There will be minimal costs to the Board of Regents for administration of the program, but there should be no other costs to the general public. There will be some required expenditure of time and money by those foreign institutions of postsecondary education which wish to offer courses or programs in the state of Kansas and which are required to register them pursuant to these regulations. It is not possible to reasonably estimate those costs, but they would not be expected to be burdensome to any such institution.

## Opinion No. 88-116

**State Boards, Commissions and Authorities—Parimutuel Racing; Kansas Parimutuel Racing Act—Electronic Wagering or Simulcasting Between Licensed Kansas Parimutuel Race Tracks.** Senator Ben E. Vidricksen, 24th District, Salina, August 19, 1988.

It is our opinion that the Kansas parimutuel racing act does not permit simulcasting between licensed racetrack facilities. Cited herein: K.S.A. 1987 Supp. 74-8819(a) and (b); 77-201; Kan. Const., Art. 15, Sec. 3b. JAC

## Opinion No. 88-119

**Militia, Defense and Public Safety—Armories—Insurance Required.** Jonathan P. Small, Judge Advocate, Kansas Military Board, Topeka, August 24, 1988.

Pursuant to the provisions of K.S.A. 48-323, the Kansas Military Board is to procure and keep in force fire and extended coverage insurance on armories under its control. Although the term "armory" is not defined in the statute, such term would include storage buildings (constructed upon property generally managed and cared for by the Kansas Military Board pursuant to K.S.A. 48-301 *et seq.*) designed and used principally for military equipment storage. ## Opinion No. 88-120

**State Boards, Commissions and Authorities—Parimutuel Racing; Kansas Parimutuel Racing Act—Organization Licenses to Conduct Races; Facility Owner License and Facility Manager License.** Alfred G. Schroeder, Chairperson, Kansas Racing Commission, Topeka, August 24, 1988.

When a conditional license is granted to an applicant, competing applications are denied. At such time, the unsuccessful applicants are eligible for the process of refunding the deposit to commence. The refund is subject to set-off for administrative and investigative expenses incurred after April 7, 1988. The statutes and regulations do not preclude the applicant from refileing an application when the competing applicant's conditional license expires for lack of a financial commitment. ## Opinion No. 88-121

**Constitution of the State of Kansas—Miscellaneous—Membership or Non-Membership in Labor Organizations.** Harold T. Walker, Kansas City City Attorney, Kansas City, August 24, 1988.

In our opinion, adoption of the Kansas City Plan, Inc. as an affirmative action program for the city of Kansas City would not violate Article 15, Section 12 of the Kansas Constitution (commonly known as the "right to work amendment") or the Equal Protection Clause of the United States Constitution. ## Opinion No. 88-122

**Constitution of the State of Kansas—Corporations—Cities' Powers of Home Rule.** Elsbeth D. Schafer, Assistant City Attorney, Topeka, August 29, 1988.

The city of Topeka may, pursuant to home rule powers granted by article 12, section 5 of the Kansas Constitution, establish a program whereby cash grants would be awarded to new or expanding businesses which invest private capital and create new jobs in the city's economy. ## Opinion No. 88-123

**Constitution of the State of Kansas—Finance and Taxation—Exemption of Property for Economic Development Purposes; Requirement of "Exclusive Use."** Senator Dan Thiessen, 15th District, Independence, August 29, 1988.

Property which is leased for profit to a business for use for purposes enumerated in article 11, section 13 of the Kansas Constitution is not property used exclusively for those purposes and thus is not qualified for the tax exemption authorized by that provision. The legislature may, however, statutorily authorize such an exemption. Cited herein: K.S.A. 79-201 (1973); 79-201b (1979); Kan. Const., Art. 11, §§ 1, 13. JLM

## Opinion No. 88-124

**Schools—School Unification Acts—Board Member District Boundaries; Adjustments.** Representative Rick Bowden, 93rd District, Goddard, August 31, 1988.

It is our opinion that school districts using the member district system may make amendments to member district boundaries to correct errors or to make the boundaries more practicable. School boards are required to make changes in member district boundaries by adopting a resolution at the October meeting preceding the general election if such changes are appropriate. Appropriateness of redistricting is to be determined on the basis of an equal protection analysis, so that an elector's vote is not diluted in comparison to other electors. Cited herein: K.S.A. 19-204, 72-6769, 72-8127; L. 1965, ch. 420, sec. 6. MWS

**NOTICE OF INTENT TO DENY**  
**A HAZARDOUS WASTE PERMIT**

The Kansas Department of Health and Environment (KDHE), Forbes Field, Topeka, is providing public notice that it proposes to deny a hazardous waste storage facility permit for R. O. Corporation, 550 East Highway 56, Olathe.

R. O. Corporation has requested that the interim status for its hazardous waste storage facility be terminated. Kansas Administrative Regulation 28-31-9 requires that KDHE either issue or deny a permit in order to terminate a facility's interim status. Therefore, KDHE intends to deny R. O. Corporation's hazardous waste facility permit in order to terminate their interim status.

R. O. Corporation, EPA I.D. Number KSD007171176, has been operating a hazardous waste container storage facility. On November 5, 1984, R. O. Corporation requested declassification as a hazardous waste storage facility and submitted a closure plan. Approval to implement a modified closure plan was granted on November 6, 1986. On October 9, 1987, R. O. Corporation submitted certification of closure. An independent registered professional engineer submitted certification of closure on behalf of R. O. Corporation on November 9, 1987.

A "Notice of Intent to Deny a Permit" is a type of draft permit subject to procedures applicable to draft permits as set forth in K.A.R. 28-31-9, incorporating by reference 40 CFR Part 124, and is based upon the administrative record. The administrative record consists of the notice of intent to deny a hazardous waste permit, the statement of basis, which describes the reasons supporting the decision, the closure procedures, and data submitted by the facility.

Copies of the administrative record are available for public review at the EPA Region VII Headquarters, 726 Minnesota Ave., Kansas City, Kansas, from 7:30 a.m. to 4:30 p.m. weekdays; and at the KDHE, Building 730, Forbes Field, Topeka, and the KDHE district office, 808 W. 24th, Lawrence, from 8 a.m. to 4:30 p.m. weekdays.

Comments or requests for additional information may be directed to John Paul Goetz, Bureau of Waste Management, KDHE, Forbes Field, Topeka 66620. Additional information may also be requested by phone at (913) 296-1607. All comments must be submitted in writing by October 23.

A public hearing has not been scheduled; however, if requests are received which indicate a significant degree of public interest, a public hearing will be scheduled. Requests for a public hearing shall be in writing to the address listed for submittal of comments and shall state the nature of issues proposed to be raised at the hearing. Such requests shall be submitted prior to October 8. The public notice and public hearing procedures may be found in K.A.R. 28-31-9, incorporating by reference 40 CFR Sections 124.11 and 124.12.

After considering all comments received, KDHE will make a final permit decision. If the determination is substantially unchanged from that announced by this notice, KDHE will notify all persons submitting written comments or requesting notice of final permit determination. If the determination is substantially changed from that announced by this notice, a new public notice will be issued and the public participation process will be reopened.

**NOTICE CONCERNING KANSAS WATER POLLUTION CONTROL PERMIT**

In accordance with state regulations 28-16-57 through 63 and 28-18-1 through 4, and the authority vested with the state by the administrator of the U.S. Environmental Protection Agency, tentative permits have been prepared for water pollution abatement facilities for the feedlots described below.

The tentative determinations for permit content are based on preliminary staff review, applying the appropriate standards and regulations of the state of Kansas and the EPA. The permit requires control of any existing or potential discharges to achieve the goal of "no discharge" whenever possible. PERMANENT ADMINISTRATIVE REGULATIONS**

**Article 2.—FILING, FEES, FORMS**

**81-3-2. Broker-dealer, investment adviser and agents; fees.** (a) The fee for original registration of each broker-dealer and each investment adviser, other than an individual investment adviser who does not have custody of customers' moneys, securities or other property, shall be \$100 and the fee for renewal of each broker-dealer registration and each such investment adviser shall be \$100.

(b) The fee for original registration shall be \$20 and the fee for renewal shall be \$20 for:

(1) an individual investment adviser who does not have custody of customers' moneys, securities or other property; and

(2) an agent. (Authorized by K.S.A. 1987 Supp. 17-1270(f); implementing K.S.A. 1987 Supp. 17-1254, as amended by L. 1988, ch. 90, § 1; effective, E-82-24, Dec. 9, 1981; effective May 1, 1982; amended T-87-41, Dec. 8, 1986; amended May 1, 1987; amended T-\_\_\_\_\_, \_\_\_\_\_; amended Oct. 25, 1988.)

**Article 7.—POLICY RELATING TO REGISTRATION**

**81-7-1. Statements of policy relating to registration of securities.** Applications for registration shall meet the following requirements unless good cause is shown for an exception:

(a) Financial statements.

(1) Historical financial statements as required in a registration application, prospectus, or as required under K.A.R. 81-7-1(e)(3)(C) and (j)(2) shall be in conformity with generally accepted accounting principles applied on a consistent basis. These statements shall have been examined and reported on by an independent certified public accountant in accordance with generally accepted auditing standards.

(2) Prospective financial statements may be used in connection with a registered offering only if all of the following conditions exist:

(A) The prospective financial statements shall be financial forecasts in conformity with guidelines established by the American institute of certified public



accountants and shall be the subject of a report prepared by an independent certified public accountant in accordance with standards for an examination of a forecast established by the American institute of certified public accountants; and

(B) Each forecast shall be included within or accompanied by a complete prospectus.

(3) Pro forma financial presentations based on historical financial statements adjusted to demonstrate the effects of proposed transactions shall not be considered prospective financial statements subject to the conditions of K.A.R. 81-7-1(a)(2).

(b) Commissions and expenses.

(1) Commissions and expenses to be paid in connection with the sale of securities proposed to be registered shall not exceed 15% of the aggregate offering price.

(2) Such expenses may include the following:

(A) Salaries;

(B) advertising and printing;

(C) attorneys fees and legal expenses in connection with registration;

(D) fees of accountants, engineers, appraisers and other technical experts;

(E) costs of authorizing, preparing and printing the securities and documents relating thereto, including revenue stamps and taxes; and

(F) all other expenses incurred directly or indirectly in connection with the sale and promotion of the offering except as hereinafter provided.

(3) Commissions in this regulation shall include the difference between the consideration paid for the shares and the proposed net offering price when securities have been acquired by an underwriter in connection with the sale of securities. Commissions shall also include any other thing of value accruing to such dealer or underwriter. Options, warrants and other acquisition or conversion rights permitted under K.A.R. 81-71-(d) shall not be commissions under this regulation.

(4) The limitations provided in K.A.R. 81-7-1(b)(1) may be waived by the commissioner for good cause shown in applications for registration of securities in which the maximum aggregate offering price is not greater than \$3,000,000.

(c) Cheap stock.

(1) Definition. Cheap stock means shares of a corporation issued, or shares to be issued, to underwriters, officers, directors, or control persons for less than the public offering price or for consideration other than cash. Cheap stock shall not include any shares issued more than two years before the date of filing an application for registration. Also, cheap stock shall not include shares issued or to be issued for consideration other than cash if it can be conclusively established that the value of the consideration is greater than or equal to the public offering price.

(2) Escrow requirements. Cheap stock shall be placed in escrow unless exempt under K.A.R. 81-7-1(c)(4).

(A) The escrow agent shall be any bank or trust company or other depository approved by the commissioner.

(B) in the event of dissolution or liquidation, escrowed shares shall not be entitled to participate in the distribution of corporate assets until holders of shares not escrowed have been paid an amount equal to the purchase price per share in the public offering.

(C) holders of escrowed shares shall not sell or contract to sell escrowed shares during the term of escrow. However, such shares may be transferred by will or pursuant to the laws of descent and distribution, or upon death of the holder may be pledged as security to pay expenses of the estate. In all cases, such shares shall remain in escrow and be subject to the terms of the escrow.

(D) Each application for approval of the escrow arrangement shall be made to the commissioner. The application shall contain the following:

(i) A list of all owners of the cheap stock and the respective amount held;

(ii) a copy of the resolution of the board of directors or the letter of authorization appointing the escrow agent, and the written consent of the agent to act as such;

(iii) a waiver of rights as required by K.A.R. 81-7-1(c)(2)(B) of this regulation;

(iv) copies of the escrow agreements, instruments, and instructions; and

(v) any other information required by the commissioner.

(3) The escrow shall remain in effect until an application for release of escrowed shares is filed with and approved in writing by the commissioner, and any one of the following conditions are met:

(A) Two years have elapsed since the termination of the registered offering;

(B) if the shares registered have been quoted at a bid price of at least 125% of the original offering price for 45 consecutive trading days at any time after one year since the termination of the registered offering;

(C) the issuer has earned net income, exclusive of extraordinary items and gains on disposal of property and equipment or discontinued operations, of at least 6% of total capital contribution by all shareholders as reported in financial statements for one fiscal year ending after the termination of the registered offering; or

(D) a tender offer has been made by an unaffiliated person to all shareholders on an equal basis.

(4) Exemption from escrow requirements. The escrow requirements imposed by this regulation shall be waived if:

(A) The cheap stock will dilute the value of securities to be registered by 50% or less based on the registered offering price;

(B) the cheap stock is held by a Kansas venture capital company certified by the secretary of the department of commerce pursuant to K.S.A. 74-8301 and amendments thereto; or

(C) the cheap stock is held by an institutional or professional investor who has provided venture capital funds to the issuer, provided good cause has been demonstrated and the escrow requirement has been waived by the commissioner.

(continued)

(d) Options and warrants. Options, warrants and other acquisition or conversion rights granted to or reserved for underwriters, officers, directors, and control persons shall meet the following requirements:

(1) The total number of underlying shares subject to such options shall not exceed 25% of the shares that would be outstanding if all shares being offered are sold;

(2) such rights shall not be exercisable during the effective period of the public offering nor for a period of one year from date issued. The exercise price thereafter shall not be less than 120% of the public offering price.

(3) Options or warrants issued to all shareholders pro rata, or in connection with qualified stock options to employees which meet the requirements of the U.S. internal revenue code, or other employees' options pursuant to a stock purchase or profit sharing plan shall not be subject to the restrictions provided in this regulation, if they are justified and reasonable.

(e) Impoundment of proceeds.

(1) As a condition to registration, all proceeds from sales of securities shall be impounded in escrow until a sufficient amount has been impounded to accomplish the purposes of the offering when:

(A) the registration is sought by a new company, financing an initial or proposed enterprise;

(B) the registration is sought by a company in poor financial condition, intending to raise additional working capital to continue its operations; or

(C) the commissioner determines that impoundment is in the public interest.

(2) Any funds impounded shall be deposited in a separate trust account with a depository approved by the commissioner.

(3) Each application to the commissioner naming such depository shall contain the following:

(A) A copy of the resolution of the board of directors designating the depository;

(B) written consent of depository to act as such; and

(C) copies of any escrow agreements, instruments and instructions.

(4) The following provisions shall govern the impoundment of funds:

(A) If the applicant fails to obtain the minimum proposed offering amount, all proceeds shall be returned to investors;

(B) the applicant shall satisfy the commissioner that it has arranged a sales organization or program with a reasonable expectation that the amount raised will be sufficient to accomplish the purposes of the offering;

(C) no certificates evidencing securities sold, other than subscription agreements, shall be issued until after release of funds from impoundments;

(D) all checks, drafts and money orders shall be made payable to the depository, and all moneys received from the sale of securities shall be promptly deposited in trust. If an instrument is inadvertently made payable to another payee, the payee shall not cash or deposit it in its own account, but shall endorse and deliver it to the depository. The depository shall collect the face amount and disburse to the registrant the amount to which the registrant is entitled;

(E) if a broker-dealer is acting as underwriter or selling agent for the issuer, payments may be made directly to the dealer, who shall promptly, after collection, transmit to the depository the net proceeds required to be impounded;

(F) each application shall state that upon request of the commissioner the issuer will file reports containing a list of names and addresses of subscribers, the number of shares or units subscribed for, amounts paid, and the accumulative total of funds derived from the offering subject to impoundment;

(G) the escrow agreements shall contain an acknowledgement that no funds are to be released from impoundment without written consent of the commissioner; and

(H) if any payments are to be made to the investor in the event of failure to obtain the minimum prescribed proceeds from the offering, the payments shall be made directly to the investor by the escrow holder, and not through the issuer.

(5) If the terms of the escrow conditions have not been met, the applicant shall advise the commissioner upon expiration of the time limit provided and request an order directing the depository to return the funds to the subscribers.

(6) A request for a modification of the escrow arrangements or for partial release of the funds shall be granted only upon good cause shown, and by application containing the following information:

(A) A certified statement from the depository setting forth the total amount of subscriptions and the character of each deposit; and

(B) a written waiver and consent executed by each purchaser or subscriber whose funds are sought to be released, or a written acknowledgement signed by such persons that an offer for return of investment has been made and rejected. The offer, or solicitation for waiver and consent shall state:

(i) That the company has failed to meet the impoundment conditions required to provide the necessary financing proposed;

(ii) the asserted reason for requesting a partial release of funds or modification of the escrow arrangements; and

(iii) a statement that the subscriber realizes that by acknowledgement the subscriber waives all rights by contract or otherwise, which accrue by virtue of the impoundment conditions.

(7) Each application for release of funds impounded shall be in writing and shall contain the following:

(A) A statement that all required subscriptions for the sale of securities have been taken and the proceeds therefrom impounded in accordance with the terms and conditions of the escrow arrangements;

(B) a certified statement from the depository verifying the amount of funds held in escrow and the character of each deposit;

(C) a statement that there has been no change in the circumstances requiring the impoundment, or the adequacy of the amount required to accomplish the objectives of the issuer; and

(D) any additional information as the commissioner requires.

(f) Promoters equity investment. When an issuer is in a promotional, exploratory or development state, the ratio of equity investment by promoters or insiders shall be determined as reasonable and equitable in light of the facts and circumstances presented in each particular case, but shall be considered objectionable when the fair value of the investment is less than 5% of the aggregate offering price of the securities to be registered, unless deemed otherwise by the commissioner.

The fair value of equity investment means the total of all sums conveyed to the issuer in the form of contributed cash or other contributions with an established or determinable value.

(g) Real estate investment trusts. Each application to register securities issued or to be issued by a real estate investment trust shall comply with the NASAA Statement of Policy, Real Estate Investment Trusts, adopted October 2, 1985, effective January 1, 1986, which is hereby adopted by reference.

(h) "Package" or combination offering. Securities registered for distribution in this state shall not be sold or offered for sale in conjunction with other securities of any issuer unless each type or class of security is clearly and separately identified and an offering price specified as to each unit.

(i) Voting rights. Securities of an issuer having more than one class of common stock shall provide equal voting rights upon all matters, including the election of members to the board of directors.

(j) Offering price. If an issuer which has been actually engaged in business or operation, the amount for which a security is being offered to the public should bear some reasonable relationship to:

(1) Market value, if any; or

(2) the price-earnings ratio, as reflected by its financial statements covering an average of the preceding three year period, or such a shorter duration of experience or operation as may be applied.

(3) In the absence of an established or determinable market value or price-earnings ratio, the book value of the issuer may be taken into consideration in justifying or substantiating the reasonableness of the offering price.

(k) Periodic payment plans. All periodic payment plans shall be registered with the SEC prior to being registered with the securities commissioner. (Authorized by K.S.A. 1987 Supp. 17-1270(f); implementing K.S.A. 1987 Supp. 17-1260; K.S.A. 1987 Supp. 17-1259; effective Jan. 1, 1966; amended, E-70-15, Feb. 4, 1970; amended Jan. 1, 1971; amended Jan. 1, 1972; amended, T-88-65; amended May 1, 1988; amended Oct. 25, 1988.)

#### Basis for Award

The sealed bids for the bonds shall be opened publicly and only at the time and place specified in this notice, and the bonds will be sold to the best bidder. The district reserves the right to reject and all of the bids and to waive any irregularities. Unless all bids are rejected, the bonds will be awarded to the bidder whose proposal results in the lowest net interest cost to the district. The net interest cost will be determined by deducting the amount of any premium paid from the aggregate amount of interest upon all of the bonds from their date until their respective maturities. If there is any discrepancy between the net interest cost and the average annual net interest rate specified, the specified net interest cost shall govern. If two or more proper bids providing for identical amounts for the lowest net interest cost are received, the district shall determine which bid, if any, shall be accepted, and its determination shall be final. Any bid received after 11 a.m. on the date of the sale will be returned to the bidder unopened.

#### Delivery

The bonds, duly printed, executed and registered, will be furnished and paid for by the district, and the bonds will be sold subject to the approving opinion of Gilmore & Bell, bond counsel, of Overland Park, Kansas, whose opinion will be paid for by the district. The number, type and denomination of bonds, and names of the initial registered owners to be initially printed on the bonds and their Social Security or taxpayer identification numbers shall be submitted in writing by the successful bidder to the bond registrar not later than seven business days preceding delivery of the bonds. The purchaser will be furnished with a complete transcript of proceedings evi-

dencing the authorization and issuance of the bonds and the usual closing proofs, which will include a certificate that there is no litigation pending or threatened at the time of delivery of the bonds affecting their validity. Payment for the bonds shall be made in Federal Reserve funds, immediately subject to use by the district. Delivery of the bonds will be made to the successful bidder on or about October 25, 1988, at any bank in the state of Kansas or Kansas City, Missouri, at the expense of the district. #### Bond Rating

The outstanding general obligation bonds of the district are rated Aa1 by Moody's Investors Service, Inc., and the district has applied for a rating on the bonds herein offered for sale.

#### Authority, Security and Purpose

The bonds will constitute general obligations of the district, payable as to both principal and interest from ad valorem taxes which may be levied without limitation as to rate or amount upon all of the taxable, tangible property within the territorial limits of the district. The bonds are being issued pursuant to K.S.A. 71-502 for the purpose of providing financing for the construction of a Cultural Education Center and the remodeling of other buildings on the college campus.

#### Official Statement

The district has prepared a preliminary official statement dated August 8, 1988, copies of which may be obtained from the president of the district or the financial adviser at the addresses given below.

#### Legal Matters

The bonds will be sold subject to the legal opinion of Gilmore & Bell, Overland Park, Kansas, bond counsel, whose approving legal opinion as to the validity of the bonds will be furnished and paid for by the district, printed on the bonds and delivered to the successful bidder as and when the bonds are delivered.

In the opinion of bond counsel, assuming continued compliance by the district with the terms of the bond resolution, under existing law, the interest on the bonds: (a) is excludable from gross income for federal income tax purposes, and (b) is not an item of tax preference for purposes of the federal alternative minimum tax imposed

on individuals and corporations; however, it should be noted that with respect to corporations (as defined for federal income tax purposes), such interest is taken into account in determining adjusted net book income (adjusted current earnings for taxable years ending after December 31, 1989) for the purpose of computing the alternative minimum tax imposed on such corporations. The opinion set forth in clause (a) above is subject to the condition that the district comply with all requirements of the Internal Revenue Code of 1986, as amended, that must be satisfied subsequent to the issuance of the bonds in order that interest thereon be excluded from gross income for federal income tax purposes. Failure to comply with certain of such requirements could cause the interest on the bonds to be so included in federal gross income retroactive to the date of issuance of the bonds. The district will covenant to comply with all such requirements.

Bond counsel expresses no opinion regarding other federal tax consequences arising with respect to the bonds.

Under existing law, the interest on the bonds is exempt from computation of Kansas adjusted gross income, and the bonds are exempt from intangible personal property taxes levied by Kansas cities, counties or townships.

**Related Federal Tax Matters**

Prospective purchasers of the bonds should be aware that: (i) Section 265 of the code denies a deduction for interest on indebtedness incurred or continued to purchase or carry the bonds, or in the case of a financial institution (within the meaning of Section 265(b)(5) of the code), that portion of a holder's interest expense allocable to interest on the bonds; (ii) with respect to insurance companies subject to the tax imposed by Section 831 of the code, for taxable years beginning after December 31, 1986, Section 832(b)(5)(B)(i) reduces the deduction for loss reserves by 15 percent of the sum of certain items, including interest on the bonds; (iii) for taxable years beginning after December 31, 1986, and before January 1, 1992, interest on the bonds earned by some corporations could be subject to the environmental tax imposed by Section 59A of the code; (iv) for taxable years beginning after December 31, 1986, interest on the bonds earned by certain foreign corporations doing business in the United States could be subject to a branch profits tax imposed by Section 884 of the code; (v) passive investment income, including interest on the bonds, may be subject to federal income taxation under Section 1375 of the code for Subchapter S corporations that have Subchapter C earnings and profits at the close of the taxable year if greater than 25 percent of the gross receipts of such Subchapter S corporation is passive investment income; and (vi) Section 86 of the code requires recipients of certain Social Security and certain railroad retirement benefits to take into account in determining gross income, receipts or accruals of interest on the bonds. These categories of bondowners should consult their own tax advisers as to the applicability of these consequences.

The bonds will bear interest from the date thereof, said rates to be determined when the bonds are sold as hereinafter provided, which interest will be payable semiannually on March 1 and September 1 in each year beginning on March 1, 1989.

#### Place of Payment and Bond Registration

In the opinion of bond counsel, assuming continued compliance by the improvement district with the terms of the bond resolution, under existing law, the interest on the bonds: (a) is excludable from gross income for federal income tax purposes, and (b) is not an item of tax preference for purposes of the federal alternative minimum tax imposed on individuals and corporations; however, it should be noted that with respect to corporations (as defined for federal income tax purposes), such interest is taken into account in determining adjusted net book income (adjusted current earnings for taxable years ending after December 31, 1989) for the purpose of computing the alternative minimum tax imposed on such corporations. The opinion set forth in clause (a) above is subject to the condition that the improvement district comply with all requirements of the Internal Revenue Code of 1986, as amended, that must be satisfied subsequent to the issuance of the bonds in order that interest thereon be excluded from gross income for federal income tax purposes. Failure to comply with certain of such requirements could cause the interest on the bonds to be included in federal gross income retroactive to the date of issuance of the bonds. The improvement district has covenanted to comply with all such requirements.

In regard to said Series A, 1988 bonds, and with respect to the Tax Reform Act of 1986 (H.R. 3838), which act became effective on October 22, 1986, and with respect to Section 902 of said act relating to interest incurred by financial institutions which carry tax-exempt bonds, the improvement district hereby designates the bonds as qualified project bonds (qualified tax exemptions) for the purpose of Section 902(b)(3) of the act. The improvement district further covenants to comply with all of the provisions of the act and all other applicable federal laws, regulations, published rulings and court decisions in order to preserve the tax-exempt status of the bonds, to the extent such actions can be taken by the governing body of the improvement district.

The bonds are "qualified tax-exempt obligations" within the meaning of Section 265(b)(3) of the code, and, in the case of certain financial institutions (within the meaning of Section 265(b)(5) of the code), a deduction is allowed for 80 percent of that portion of such financial institution's interest expense allocable to interest on the bonds. The district does not anticipate issuing bonds in excess of \$10,000,000 during calendar year 1988.
