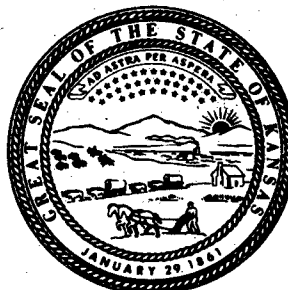

Notice of Hearing on Migrant
Education State Plan

The State Board of Education will conduct a public hearing at 1:30 p.m. Tuesday, March 13, in Room 121 of the State Education Building, 120 E. 10th, Topeka, to consider the proposed Kansas Migrant Education State Plan for fiscal year 1991.

The Migrant Education Program is identified as a state-operated program under Public Law 100-297, specifically designed to provide special educational services for migratory children of migratory agricultural workers or migratory fishers.

Approximately \$3.7 million was appropriated to Kansas migrant education for fiscal year 1990. Based on an annual needs assessment, the plan includes objectives that relate to identification and recruitment of migrant students; student instruction; staff development; migrant student record transfer system; parent involvement; interstate, intrastate, and interagency cooperation; support services; early childhood education; and summer school programs. The plan will be implemented to serve approximately 5,500 students participating in 35 regular programs and 12 summer educational programs.

A copy of the plan may be obtained by contacting the secretary of the State Board of Education, State Education Building, 120 E. 10th, Topeka 66612, prior to the date of the hearing.

All interested persons will be given a reasonable opportunity at the hearing to present their views or arguments, either orally or in writing, in regard to the proposed plan. In addition, the period of public notice hereby provided constitutes a public comment period for the purpose of receiving written public comments on the proposed plan. Written comments may be submitted to the secretary of the State Board of Education at the address above. The hearing shall be conducted in compliance with the public hearing procedures of the board.

Public Records, Documents and Information—Records Open to Public—Access to Memoranda from School Superintendent to School Board. Barbara Lawrence, State Representative, 84th District, Wichita, February 6, 1990.

Memoranda written by school board staff wherein opinions are expressed or policies and actions are proposed are not public records that must mandatorily be disclosed unless such memoranda are publicly cited or identified in an open meeting or in an agenda to an open meeting. Such citation or identification subjects the memoranda to mandatory disclosure, unless otherwise specifically prohibited by law. However, even if such citation or identification does not occur, unless information contained in the memoranda is specifically prohibited or restricted from disclosure by federal law, state statute or rule of the Kansas Supreme Court, it may nevertheless be discretionarily disclosed by the public agency. Public Notice

Geary County, Kansas, and Riley County, Kansas, hereby announce their sponsorship of a program to reduce home loan financing costs. The counties have established a mortgage credit certificate program that will entitle first-time homebuyers and borrowers of qualifying home improvement loans to a federal income tax credit. A tax credit is a direct reduction of taxes due.

Under the program, a homebuyer would receive a mortgage credit certificate entitling the homebuyer to reduce their federal income taxes by 25 percent of the amount of interest paid on their home loan. The tax credit is available each year that the borrower continues to live in the home financed under the program.

In order to qualify for the program, federal law requires that a homebuyer satisfy each of the following guidelines:

1. First-time homebuyer. Each homebuyer must be a first-time homebuyer. Any person who has not owned their principal residence at any time during the three years prior to closing a loan under the program is considered a first-time homebuyer. This requirement does not apply to qualifying home improvement loans.

2. Income. Because the program is intended to benefit low and moderate income persons, federal law imposes limitations on the gross income of homebuyers. In most areas of the state of Kansas the current limit on gross income is \$32,500 for a household of one or two persons and \$37,375 for a family of three or more persons. Higher income limits apply in the following areas: Kansas City metropolitan area - \$37,000 for a household of one or two persons and \$42,550 for a family of three or more; Topeka metropolitan area - \$35,600 for a household of one or two persons and \$40,940 for a family of three or more; Wichita metropolitan area - \$38,000 for a household of one or two persons and \$43,700 for a family of three or more; and in Lyon, Seward and Sumner counties - \$33,400 for a household of one or two persons and \$38,410 for a family of three or more. The income limitations will be adjusted as required to comply with federal law. Gross income includes salary and wages, including overtime, as well as dividends, alimony, public assistance, social security, unemployment compensation and investment income and profits.

3. Purchase price. In addition to income, federal law also imposes limitations on the purchase price of homes financed under the program. In most areas of the state of Kansas, the maximum purchase price for a new home is \$59,040 and for an existing home is \$53,370. Different purchase price limits apply in the following areas: Kansas City metropolitan area - \$98,640 for a new home and \$69,750 for an existing home; Lawrence metropolitan area - \$59,040 for a new home and \$71,280 for an existing residence; Topeka metropolitan area - \$59,040 for a new home and \$59,310 for an existing residence; and Wichita

metropolitan area - \$109,890 for a new home and \$74,430 for an existing residence. The purchase price limits will be adjusted as required to comply with federal law. The purchase price limitation does not apply to qualifying home improvement loans.

4. Principal residence. The homebuyer must occupy the home financed under the program as their principal residence within 60 days after the financing is provided. A principal residence is a home occupied primarily for residential purposes. A principal residence does not include a home used as an investment property, as a recreation home or a home 15 percent or more of the total area of which is used in a trade or business.

5. New mortgage. The mortgage loan financed in connection with issuance of a mortgage credit certificate is required to be a new mortgage and may not replace a prior mortgage on the home (whether or not previously repaid).

6. Program area. In order to be eligible for a certificate, the home financed under the program must be located in (i) the unincorporated areas of Geary or Riley counties, (ii) a city that has entered into an agreement with the counties allowing the program in the city, or (iii) the unincorporated areas of a county that has entered into such an agreement with the counties. A list of participating cities and counties will be available by April 10 and will be updated thereafter as necessary.

Under the program, mortgage credit certificates will be issued to eligible borrowers on a first-come first-served basis. In order to be eligible for the program, the borrower must have received approval of eligibility to participate in the program *before* closing on their loan. The certificates are available in connection with any type of mortgage loan (other than proceeds of tax-exempt bonds), including fixed rate and adjustable rate mortgages. Any lending institution is eligible to provide loans under this program. If you desire that your community make this program available to its citizens, advise your city or county clerk of your wishes.

Notice Concerning Kansas
Water Pollution Control Permit

In accordance with state regulations 28-16-57 through 28-16-63 and the authority vested with the state by the administrator of the U.S. Environmental Protection Agency, a tentative permit has been prepared for discharges to the waters of the United States and the state of Kansas for the applicant described below. The tentative determinations for permit content are based on preliminary limitations of the state of Kansas and the EPA, and when issued will result in a state water pollution control permit and national pollutant discharge elimination system authorization to discharge subject to certain effluent limitations and special conditions.

Article 13.—TEMPORARY PERMITS

74-13-1. Eligibility. A temporary permit to practice will only be issued to individual out-of-state certified public accountants, and not to out-of-state firms. Each out-of-state certified partner, member, shareholder or employee coming into Kansas to practice public accounting, not incident to the certified public accountant's practice in the other state, and who is not otherwise eligible for a Kansas certificate and permit, shall be required to obtain a temporary permit to practice. (Authorized by and implementing K.S.A. 1-317 as amended by L. 1989, Ch. 1, Sec. 1, effective April 2, 1990.)

74-13-2. Definition of incident to regular practice in another state. For purposes of determining the need for a temporary permit to practice in Kansas the board will rely on the following definition of what is incident to an out-of-state certified public accountant's practice in another state: That practice which is a continuance or extension of an engagement for a client located in another state, which extends into this state through common ownership or existence of a subsidiary, assets, or other operations, located within the state of Kansas. SENATE BILL No. 413

AN ACT making and concerning appropriations for the fiscal years ending June 30, 1990, and June 30, 1991, for the department of social and rehabilitation services and department of corrections; authorizing certain transfers, imposing certain restrictions and limitations, and directing or authorizing certain receipts and disbursements and acts incidental to the foregoing.

Be it enacted by the Legislature of the State of Kansas:

Section 1. For the fiscal years ending June 30, 1990, and June 30, 1991, appropriations are hereby made, restrictions and limitations are hereby imposed, and transfers, receipts, disbursements and acts incidental to the foregoing are hereby directed or authorized as provided in this act.

Sec. 2.

DEPARTMENT OF SOCIAL AND REHABILITATION SERVICES

(a) There is appropriated for the above agency from the state general fund for the fiscal year ending June 30, 1990, the following:

MediKan and general assistance programs \$8,246,708

Provided, That expenditures from this account shall be used to continue the mediKan program and general assistance programs through April 30, 1990, at the level in effect on December 1, 1989.

~~Aid to dependent children 1,273,771~~

Provided, That expenditures from this account shall be used to maintain through April 30, 1990, the level of grants effective on December 1, 1989.

Foster care services 1,458,652

Provided, That expenditures from this account shall be made for a 10% increase in foster care rates effective January 1, 1990.

~~Attendant care for independent living 371,448~~

Provided, That expenditures from this account shall be used to maintain through April 30, 1990, the level of assistance effective on December 1, 1989.

Total \$11,350,579

(b) The secretary of social and rehabilitation services shall make expenditures for fiscal year 1990 from the social service clearing fund, social welfare fund and social services block grant — federal fund for a 10% increase in foster care rates effective January 1, 1990.

(c) The secretary of social and rehabilitation services shall make expenditures from the social services clearing fund, social welfare fund and social services block grant — federal fund to be used to maintain the level of aid to dependent children grants through April 30, 1990, which were in effect on December 1, 1989.

(d) The secretary of social and rehabilitation services shall make expenditures from the social services clearing fund, social welfare fund and social services block grant — federal fund to be used to maintain the attendant care for independent living program through April 30, 1990, at the level of assistance effective on December 1, 1989.

Sec. 3.

DEPARTMENT OF CORRECTIONS

(a) On the effective date of this act, the appropriation of \$9,500,000 made for the above agency for the fiscal year ending June 30, 1990, by section 2(c) of chapter 31 of the 1989 Session Laws of Kansas from the state general fund in the acquire, construct

and equip a new, operationally efficient, correctional facility and a mental health facility or facilities account is hereby lapsed.

(b) On the effective date of this act, of the amount reappropriated for the above agency for the fiscal year ending June 30, 1990, by section 2(c) of chapter 31 of the 1989 Session Laws of Kansas from the state general fund in the planning for new correctional facility and a mental health facility or facilities account, any unencumbered balance is hereby lapsed.

(c) On and after the effective date of this act, expenditures may be made during the fiscal year ending June 30, 1990, and the fiscal year ending June 30, 1991, from the debt service for new correctional facility and a mental health facility or facilities account of the state general fund in accordance with agreements entered into by the secretary of corrections to provide bond financing over a period of not more than 15 years for capital improvement projects to plan, acquire, construct and equip a new, operationally efficient state correctional facility and a mental health facility or facilities in an amount of not more than the total for such capital improvement projects of \$68,800,000, including reimbursement of amounts expended from the state general fund for such planning, plus all amounts required for costs of bond issuance, costs of interest on the bonds during construction of the projects and required reserves for payment of principal and interest on the bonds: *Provided*, That such bond financing shall be obtained through public sale of bonds therefor: *And provided further*, That such projects are hereby approved for the department of corrections for the purposes of subsection (b) of K.S.A. 1989 Supp. 74-8905 and amendments thereto.

Sec. 4. This act shall take effect and be in force from and after its publication in the Kansas register.

Message to the Senate

Pursuant to Article 2, Section 14 of the Constitution of the State of Kansas, I hereby return Senate Bill 413 with my signature approving the bill except for the items enumerated below.

The portion of Section 2 that reads as follows has been vetoed:

Aid to dependent children 1,273,771

I am vetoing the restoration of the \$9 reduction for AFDC. Kansas' benefits are above those of over half the states and are the highest in the region. The welfare budget has increased over \$100 million in the past year, and nearly the same amount the prior year. We must start toward solving this rapidly escalating budget.

The portion of Section 2 that reads as follows has been vetoed:

Attendant care for independent living 371,448

I am also vetoing the addition of \$371,448 because the people served under this program are being care for. Beginning in December, the Secretary of Social and Rehabilitation Services made home and community based services available to 70 of the 73 individuals formerly served under the ACIL program. The individuals are receiving the same care in their homes as before and in many cases from the same care providers. The amount vetoed is the difference between the very adequate home and community based services program which was funded in my budget recommendations and the more expensive ACIL program. Adequacy of care is not being sacrificed.

The remaining three individuals are eligible for the home and community based services program and for adult care home services.

I reluctantly sign the remainder of Senate Bill 413 to extend the MediKan and General Assistance program benefits to April 30, 1990, and increase payments for foster care by an additional 10 percent above the five percent increase put in place July 1. The bill, as it was sent to me, does not lower the state's balances, or jeopardize my pledge to not increase general taxes. While it increases expenditures above my budget, it provides funds for those expenditures.

My reluctance is based on the fact that the Legislature has not developed a solution to the rapidly escalating welfare budget. The legislative leadership has asked that I sign the bill to allow them time to review the problem. The fact that the benefits are not extended permanently is in keeping with that pledge to arrive at resolution of this issue that does not violate the state's fiscal integrity.

HOUSE BILL No. 2628

AN ACT relating to banks and banking; concerning branch banks; amending K.S.A. 1989 Supp. 9-1111 and repealing the existing section; also repealing K.S.A. 1989 Supp. 9-1111a and 9-1111c.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 1989 Supp. 9-1111 is hereby amended to read as follows: 9-1111. The general business of every bank shall be transacted at the place of business specified in its certificate of authority; and at one or more branch banks established and operated as provided in this section. It shall be unlawful for any bank to establish and operate any branch bank except as hereinafter provided.

(a) Any bank domiciled in this state may have an attached auxiliary teller facility located on the premises specified in its certificate of authority;

(b) in addition to an attached auxiliary teller facility, any bank domiciled in this state may, subject to the requirements and limitations prescribed in subsections (c) and (d), establish and maintain not more than three branch banks, except that any branch bank which was established by a bank within 2,600 feet of the premises specified as such bank's principal place of business in its certificate of authority, prior to July 1, 1986, shall not be included in the maximum number of branch banks allowed under this subsection;

(c) a branch bank may be established and operated by a state bank incorporated under the laws of this state, with the approval of the state banking board, and by a national banking association, with the approval of the appropriate federal supervisory agency, granted upon the basis of findings by the state banking board or such federal agency that such service will serve the public convenience or need;

(d) branch banks authorized under subsection (b) shall be located:

(1) Within the corporate limits of the same city within which the premises specified by the bank as its place of business in its certificate of authority is located, if the same is located within an incorporated city;

(2) within the boundaries of the township in which the premises specified by the bank as its place of business in its certificate of authority is located, if such premises are located outside of the corporate limits of an incorporated city;

(3) more than 50 feet from any other nonparticipating bank or branch bank;

(4) more than 2,600 feet from the premises maintained as the principal place of business of any bank, the articles of incorporation or charter of which was approved by the state board or federal agency less than five years prior to location of any such branch bank, unless the state board in the case of a state bank or the appropriate federal supervisory agency in the case of a national banking association, shall specifically find and determine after careful examination and investigation that the location of such branch bank within such restricted area will not have a materially adverse effect upon the capital structure, deposits and general financial position of such existing bank;

(5) within the corporate limits of a city located in Johnson county which has no bank and which is contiguous to a city located in Johnson county where the premises specified by the bank as its place of business in its certificate of authority is located;

(e) in addition to establishment and maintenance of branch banks as authorized by subsection (b), one or more branch banks may be established and maintained in this state by any bank domiciled in this state subject to the following requirements and limitations:

(1) A branch bank may be located at the site of a bank domiciled in Kansas which has been merged into or consolidated with the branching bank, except that if such bank was chartered after January 1, 1987, it shall have been in existence and actively engaged in business for five or more years;

(2) a branch bank may be located at the site of a bank

domiciled in Kansas the assets of which have been purchased and the liabilities of which have been assumed by the branching bank from a receiver in liquidation of the bank;

(3) branch banks which have been established and maintained pursuant to subsection (b) by a bank merged into or consolidated with the branching bank, or the assets of which have been purchased and the liabilities of which have been assumed by the branching bank, may continue to be maintained by the branching bank; and nothing in this act shall be deemed to require any service to be provided at any such existing branch bank which was not being provided at the time of such merger, consolidation or purchase and assumption;

(4) the establishment and maintenance of a branch established pursuant to this subsection by a state bank incorporated under the laws of this state or by a national banking association shall be subject to approval by the state banking board or by the appropriate federal supervisory agency, respectively, upon the basis of findings that such service will serve the public convenience and need, except that such approval may be given by the state bank commissioner in emergency situations under rules and regulations adopted pursuant to K.S.A. 9-1713, and amendments thereto;

(5) a branching bank establishing and maintaining a branch bank pursuant to any provision of this subsection (c) shall operate the branch bank for a period of at least two years before selling or otherwise disposing of such branch bank, except that such branching bank may sell or dispose of the branch bank for the purpose of establishing a new bank charter in the city or township in which such branch bank is located;

(6) any branching bank establishing and maintaining a branch bank pursuant to any provisions of this subsection (c), shall provide for an advisory board of directors made up of not less than five members from the city or county where the branch bank is located;

(7) any branching bank establishing and maintaining a branch bank pursuant to any provisions of this subsection (c), shall provide checking, savings and loan services at such branch bank;

(8) any branching bank establishing and maintaining a branch bank pursuant to any provisions of this subsection (c), shall have such branch bank open for business not less than 20 hours per week legal holidays excluded;

(f) any branch bank established and operated by a bank prior to January 1, 1987, may continue to be operated by the bank which established the branch;

(a) For the purposes of this section, the term "branch bank" means any office, agency or other place of business located within this state, other than the place of business specified in the bank's certificate of authority, at which deposits are received, or checks paid, or money lent;

(b) after first applying for and obtaining the approval of the state banking board, one or more branch banks may be established and operated anywhere within this state by a bank incorporated under the laws of this state;

(c) an application to establish and operate a branch bank shall be in such form and contain such information as the rules and regulations of the state bank commissioner, adopted pursuant to K.S.A. 9-1713, and amendments thereto, shall provide;

(d) the application shall include estimates of the annual income and expenses of the proposed branch bank, the annual volume of business to be transacted by it, the nature of the banking business to be conducted at the proposed branch bank, the primary geographical area to be served by it and the personnel and office facilities to be provided at the proposed branch bank;

(e) the application shall include the name selected for the proposed branch bank. The name selected for the proposed branch bank shall not be the name of any other bank or branch bank doing business in the same city or town nor shall the name selected be required to contain the name of the applicant bank. If the name selected for the proposed bank does not contain the name of the applicant bank, the branch bank shall provide in the public lobby of such branch bank, a public notice that it is a branch bank of the applicant bank;

(f) upon receipt of an application meeting the above require-

ments, within 60 days after receipt of the application the state banking board shall hold a hearing in the county in which the applicant bank seeks to establish and operate a branch bank. Notice of the time, date and place of such hearing shall be published in a newspaper of general circulation in such county by the bank seeking to establish and operate the branch bank not less than 10 or more than 30 days prior to the date of the hearing and proof of publication shall be filed with the commissioner. Not less than 10 days or more than 30 days prior to the date of the hearing, the commissioner shall give notice of the time, date and place of such hearing by registered or certified mail to all banks and national banking associations having their principal places of business or branch banks in the county wherein the applicant bank seeks to locate a branch bank. At the hearing, all interested persons shall be allowed to present written and oral evidence to the board in support of or in opposition to the application. Upon completion of a transcript of the testimony given at the hearing, the transcript shall be filed in the office of the commissioner and copies shall be furnished to the members of the state banking board not less than 14 days prior to the meeting of the board at which the application will be considered;

(g) the state banking board shall approve or disapprove the application, after consideration of the application and the evidence received at the hearing; at the next regular meeting of the board held after each member has been furnished a transcript of the hearing. If the board finds, on the basis of the application and the evidence received at the hearing, that:

(1) There is or will be at the time the branch bank is opened the need for the same in the community to be served by it;

(2) there is a reasonable probability of usefulness and success of the proposed branch bank; and

(3) the proposed branch bank can be established without undue injury to properly conducted existing banks and national banking associations, the application shall be granted, otherwise, the application shall be denied;

(h) any final action of the board approving or disapproving an application shall be subject to review in accordance with the act for judicial review and civil enforcement of agency actions upon the petition of any adversely affected or aggrieved person who appeared and offered evidence at the hearing upon the application;

(i) any branch bank lawfully established and operating on the effective date of this act may continue to be operated by the bank then operating the branch bank and by any successor bank;

(j) branch banks which have been established and are being maintained by a bank at the time of its merger into or consolidation with another bank or at the time its assets are purchased and its liabilities are assumed by another bank from a receiver in liquidation of the bank may continue to be operated by the surviving, resulting or purchasing and assuming bank, with approval of the state bank commissioner, may establish and operate a branch bank or banks at the site or sites of the merged, constituent or liquidated bank or banks;

(k) any state bank or national banking association having its principal office and main banking house in this state may provide and engage in banking transactions by means of remote service units wherever located, which remote service units shall not be considered to be branch banks authorized herein. Any banking transaction effected by use of a remote service unit shall be deemed to be transacted at a bank and not at a remote service unit;

(l) as a condition to the operation and use of any remote service unit in this state, a state bank or national banking association, each hereinafter referred to as a bank, which desires to operate or enable its customers to utilize a remote service unit must agree that such remote service unit will be available for use by customers of any other bank or banks upon the request of such bank or banks to share its use and the agreement of such bank or banks to share all costs, including a reasonable return on capital expenditures incurred in connection with its development, installation and operation. The owner of the remote service unit, whether a bank or any other person, shall make the remote service unit available for use by other banks and their customers on a nondiscriminatory basis, conditioned upon payment of a reasonable proportion of all costs, including a reasonable return on capital expenditures incurred in connection with the development, installation and operation of the remote service unit. Notwithstanding the foregoing provisions of this subsection, a

remote service unit located on the property owned or leased by the bank where the principal place of business of a bank, or an attached auxiliary teller facility or branch bank of a bank, is located need not be made available for use by any other bank or banks or customers of any other bank or banks;

(m) for purposes of this section, "remote service unit" means an electronic information processing device, including associated equipment, structures and systems, through or by means of which information relating to financial services rendered to the public is stored and transmitted, whether instantaneously or otherwise, to a bank and which, for activation and account access, is dependent upon the use of a machine-readable instrument in the possession and control of the holder of an account with a bank. The term shall include "online" computer terminals and "offline" automated cash dispensing machines and automated teller machines, but shall not include computer terminals or automated teller machines or automated cash dispensing machines using systems in which account numbers are not machine read and verified. Withdrawals by means of "offline" systems shall not exceed \$300 per transaction and shall be restricted to individual not corporate or commercial accounts;

(n) any bank located in this state may establish and maintain one or more branch banks in any city located in the same county in which the branching bank is located which city does not have a main bank, specified in the certificate of authority, located within the corporate limits of such city; or if there is no application pending for approval of a branch bank in any such city filed by a bank located in the same county as such city is located, in any such city located in any county adjoining the county in which such bank is located.

Upon receiving an application for approval of a branch bank to be established in a city located in a county adjoining the county in which the branching bank is located as authorized under this subsection (n), the chairperson of the banking board shall cause a hearing to be conducted in the city in which the branch bank is proposed to be located within 60 days following receipt of such application. Notice of such hearing shall be published by the branching bank in the official newspaper in such city, or if there be no such official newspaper, in an official newspaper in the county in which such city is located. Such notice shall be published not less than 10 or more than 30 days prior to the date of such hearing, and proof of publication shall be given to the bank commissioner. In addition the bank commissioner shall give notice of such hearing to the chief executive officer of any state or national bank whose main bank is located within the county in which such city is located. Any hearing scheduled or commenced under the provisions of this subsection (n) shall be stayed pending consideration of a new application for approval of a branch bank in such city by a bank located in the same county in which such city is located.

Upon completion of the transcript of any hearing hereunder, a copy thereof shall be filed in the office of the state bank commissioner, and one copy shall be furnished to each member of the state banking board not less than 14 days prior to the meeting at which such application is considered. At the next regular meeting of the banking board held after each member thereof has been furnished a transcript of the hearing for a period of not less than 14 days, or at any meeting thereafter as designated by the chairperson of the board, such application shall be considered by the board, and the board shall approve or disapprove such application. In either event, no action by the board shall be final until a statement of findings of fact in support of such action shall have been prepared by such person designated to do so by the chairperson thereof, circulated to and signed by those members voting thereon, and filed in the office of the state bank commissioner.

Sec. 2. K.S.A. 1989 Supp. 9-1111, 9-1111a and 9-1111c are hereby repealed.

Sec. 3. This act shall take effect and be in force from and after its publication in the Kansas register.

SENATE BILL No. 442

AN ACT making and concerning appropriations for the fiscal years ending June 30, 1990, and June 30, 1991, for department of revenue — homestead property tax refunds, state board of tax appeals, Fort Hays state university and the Kansas public broadcasting commission; authorizing the initiation and completion of certain capital improvement projects; authorizing certain transfers, imposing certain restrictions and limitations, and directing or authorizing certain receipts and disbursements and acts incidental to the foregoing; amending section 7 of chapter 27 of the 1989 Session Laws of Kansas and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. For the fiscal years ending June 30, 1990, and June 30, 1991, appropriations are hereby made, restrictions and limitations are hereby imposed, and transfers, receipts, disbursements and acts incidental to the foregoing are hereby directed or authorized as provided in this act.

Sec. 2.

DEPARTMENT OF REVENUE — HOMESTEAD PROPERTY TAX REFUNDS

(a) There is appropriated for the above agency from the state general fund for the fiscal year ending June 30, 1990, the following:

Provided, That expenditures may be made from the homestead tax refunds account for homestead tax refunds and for homestead property tax refunds pursuant to K.S.A. 79-4520 and amendments thereto: *Provided further*, That expenditures from the homestead tax refunds account for each such purpose shall continue to be tracked separately by program.

(b) On the effective date of this act, all moneys in the homestead property tax refunds pursuant to section 5 of 1989 Senate Bill No. 24 account of the state general fund are hereby transferred to the homestead tax refunds account of the state general fund.

STATE BOARD OF TAX APPEALS

(a) There is appropriated for the above agency from the state general fund for the fiscal year ending June 30, 1990, the following:

(b) The position limitation established by the state finance council for the state board of tax appeals for the fiscal year ending June 30, 1990, is hereby decreased from 39.0 to 37.0.

Sec. 4. On the effective date of this act, section 7 of chapter 27 of the 1989 Session Laws of Kansas is hereby amended to read as follows: Sec. 7.

FORT HAYS STATE UNIVERSITY

(a) On the effective date of this act, the appropriation of \$1,500,000 made for the above agency for the fiscal year ending June 30, 1989, by section 52(b) of chapter 33 of the 1988 Session Laws of Kansas from the Kansas educational building fund in the renovate Sheridan coliseum — phase II account is hereby lapsed.

(b) On the effective date of this act, the appropriation of \$2,162,000 made for the above agency for the fiscal year ending June 30, 1990, by section 52(b) of chapter 33 of the 1988 Session Laws of Kansas from the Kansas educational building fund in the renovate Sheridan coliseum — phase II account is hereby lapsed.

(c) There is appropriated for the above agency from the state general fund for the capital improvement project and for the fiscal years specified the following:

For the fiscal year ending June 30, 1989	\$3,900,000
For the fiscal year ending June 30, 1990	2,162,000

Provided, That any unencumbered balance in excess of \$100 as of June 30, 1990, is hereby reappropriated for fiscal year 1991: *Provided, however*, That expenditures from the renovate Sheridan coliseum account may be made only upon certification by the above agency to the director of accounts and reports that private gift moneys are available for expenditures for this project in the Sheridan coliseum gift fund in the amount of \$387,000 for FY 1989 and the amount of \$863,000 for FY 1990: *Provided further*, That expenditures from the renovate Sheridan coliseum account shall include expenditures for foundation work and completion of the performing arts center: *And provided further*, That such expenditures shall be made pursuant to contracts which are hereby authorized to be entered into by the above agency as part of the capital improvement project to renovate Sheridan coliseum: *And provided further*, That all expenditures for this project from the Sheridan coliseum gift fund during FY 1989 that are in addition to the required \$387,000 of expenditures from such fund, shall be construed to be available for expenditures for this project in the Sheridan coliseum gift fund for

FY 1990 for purposes of satisfying the requirement of having \$863,000 in such fund for FY 1990: *And provided further*, That any amounts paid to the Fort Hays state university endowment association from the Sheridan coliseum gift fund during FY 1989 or FY 1990, for amounts of interest pursuant to an agreement between the above agency and such association, shall not be construed to be available for expenditures for this project in the Sheridan coliseum gift fund for either FY 1989 or FY 1990 for purposes of the above requirements.

KANSAS PUBLIC BROADCASTING COMMISSION

(a) There is appropriated for the above agency from the state general fund for the fiscal years specified, the following:

Grant to station KOOD to expand public TV into northwest Kansas	
For the fiscal year ending June 30, 1990	\$100,000

Provided, That any unencumbered balance in excess of \$100 as of June 30, 1990, is hereby reappropriated for fiscal year 1991: *Provided, however*, That all expenditures from this account shall be matched with expenditures of moneys raised from nongovernmental sources: *Provided further*, That no expenditures may be made from this account unless moneys are received from the federal government for this project.

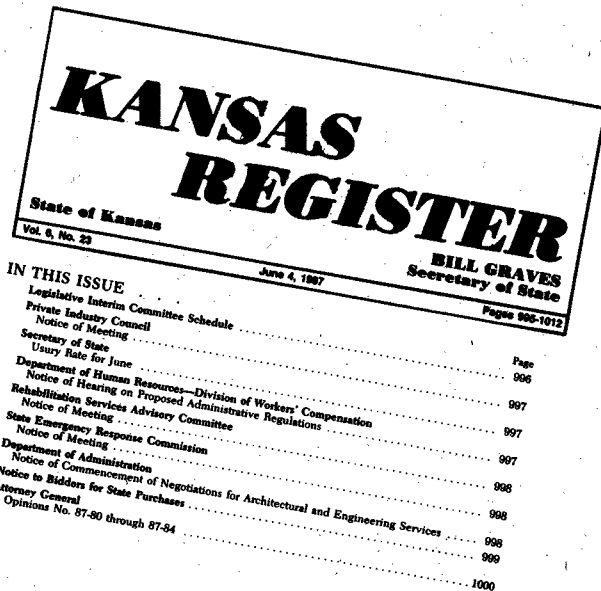
Sec. 6. On the effective date of this act, section 7 of chapter 27 of the 1989 Session Laws of Kansas is hereby repealed.

Sec. 7. *Appeals to exceed position limitations*. The limitations imposed by this act on the full-time equivalent number of full-time and regular part-time positions equated to full-time, excluding seasonal and temporary positions, paid from appropriations for fiscal year 1990 made in this act or in any appropriations act of the 1989 regular session of the legislature or in any other appropriations act of the 1990 regular session of the legislature, may be exceeded upon approval of the state finance council.

Sec. 8. This act shall take effect and be in force from and after its publication in the Kansas register.
