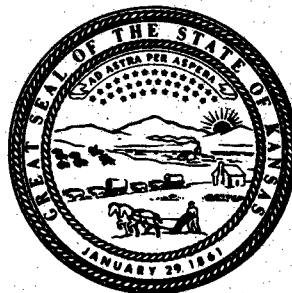

Notice of Public Comment Period on Proposed Administrative Regulations

After considering the oral and written comments presented in conjunction with its public hearing on January 18, the State Corporation Commission has determined that it will receive additional written public comment on its proposed permanent surface pond regulations that would be administered by the commission's Conservation Division in Wichita. The comment period will run 60 days—beginning March 1 and ending April 30.

Written comments may be submitted to the State Corporation Commission, Attn: Shari Feist Albrecht, Director, 200 Colorado Derby Building, 202 W. 1st, Wichita 67202.

Copies of the proposed regulations and the economic impact statements may be obtained at the Wichita address. Persons requesting a copy of the proposed regulations and economic impact statements, in accordance with K.S.A. 45-219, will be required to compensate the commission for the cost of reproduction. This additional public comment period provides an opportunity for all interested parties to present their views, in writing, in regard to the adoption of the proposed regulations.

All written comments submitted by interested parties on or before April 30 will be considered by the commission as a basis for making changes to these proposed permanent regulations.

The following is a brief summary of the proposed regulations and economic impact statements:

K.A.R. 82-3-600 (Permanent regulation). The amendment clarifies that use of surface ponds without commission approval is prohibited and establishes a \$500 penalty

for unauthorized use. The amendment requires the filing of an application with the Conservation Division and specifies application requirements. Chloride concentration and geohydrology are the criterion for assessing the risk that a particular surface pond poses to water resources. The amendment deletes construction requirements that have been placed in K.A.R. 82-3-601a.

Economic Impact: The operator shall bear any penalty expense.

K.A.R. 82-3-600b (Permanent regulation). This new regulation establishes a reauthorization process for existing surface ponds that are located in recently identified sensitive groundwater areas. The reauthorization involves the filing of an application with the Conservation Division on a form prescribed by the division. One year from the effective date of the regulation is the established reauthorization period. The regulation establishes a \$500 penalty for unauthorized operation of an existing surface pond after the expiration of the one-year period.

Economic Impact: The operator shall bear the expense of preparing and filing the application as well as any penalty expense.

K.A.R. 82-3-601 (Revocation). The revocation eliminates provisions duplicated within proposed K.A.R. 83-3-600.

Economic Impact: None

K.A.R. 82-3-601a (Permanent regulation). This new regulation specifies the construction requirements for surface ponds located in sensitive groundwater areas. The regulation establishes a minimum freeboard of 30" for all surface ponds except drilling pits and burn pits, which shall have a minimum freeboard of 12".

The regulation requires that reserve pits in sensitive groundwater areas underlain by the Hutchinson salt member of the Wellington formation and emergency pits in sensitive groundwater areas shall be constructed to limit hydraulic conductivity to no more than 1×10^{-7} cm/sec. The regulation lists a number of available options to meet this requirement.

The regulation prohibits the construction of surface ponds deeper than five feet above the water table in the area.

Economic Impact: Based on an estimate of 778 wells drilled per year in sensitive groundwater areas (derived from a five-year statistical average of total wells drilled in Kansas) and an incremental reserve pit cost per well ranging from \$10,152 to \$48,330 depending on the construction option selected, the total annual cost for industry ranges from \$7.9 to \$21.8 million.

Assuming that there are 28,051 producing leases in Kansas, 30 percent of which are located in sensitive groundwater areas, and assuming two-thirds of the leases have emergency pits, a total annual industry cost of \$93,505 to \$6 million is estimated. This cost range varies from \$566 for lining emergency pits with plastic liners to \$2100 for fiberglass or steel tanks in lieu of emergency pits to \$11,130 for lining the gunite liner.

Groundwater monitoring and leak detection costs are difficult to quantify generally since individual aquifer characteristics and monitor well construction criteria vary from location to location. The commission currently has authority to require monitoring and leak detection where

groundwater pollution is suspected. Any such installation costs would be borne by the legally responsible party.

The costs described above are for preventive measures against groundwater pollution from oil and gas activities. These costs are generally believed to be significantly less than actual groundwater cleanup costs after pollution has occurred. It is further believed that requiring more stringent construction of surface ponds will encourage development of new and more cost-effective alternatives and technology to ensure groundwater protection.

Enforcement of this regulation is expected to be handled by existing staff. Additional geologists were hired in fiscal year 1989 in anticipation of implementing more stringent construction requirements that have been under study for three years. At this time, no significant economic impact is anticipated with respect to the agency.

K.A.R. 82-3-601b (Permanent regulation). This new regulation provides for an exception to the construction and closure requirements for surface ponds. Exception requests must be made in writing to the director and submitted with the surface pond application. The request must contain supporting data to show why the exception should be granted. An on-site investigation may be conducted to determine the viability of the exception request.

Economic Impact: The applicant bears the expense of preparing and filing an exception request. The commission bears the cost of any on-site investigation, including travel and staff time.

K.A.R. 82-3-602 (Permanent regulation). The amendment clarifies pond closure requirements and restructures the contents of the regulation. The amendment imposes a new requirement that operators of reserve pits in sensitive groundwater areas report, to the appropriate district office, the chloride content of reserve pit fluids and a drilling fluid management plan within 48 hours after drilling operations cease. The drilling fluid management methods actually used shall be reported to the Conservation Division on the affidavit of completion.

Economic Impact: The operator shall bear the expense of reporting the required information to the Conservation Division.

K.A.R. 82-3-605 (Permanent regulation). This new regulation specifies that dikes do not require surface pond permits. The regulation requires operators to notify the appropriate district office of any discharge into diked areas within 24 hours of the discharge. The regulation further requires operators to remove fluids from within the diked area within 48 hours after discovery of the discharge. The regulation also establishes penalties of \$250, \$500 and \$1000 for an operator's failure to properly remove fluids within the diked area.

Economic Impact: The operator shall bear the cost of notification and removal of discharged fluids and any penalty expense.

A public hearing will be conducted at 9 a.m. Tuesday, March 27, in the SRS board room, sixth floor, Docking State Office Building, 915 Harrison, Topeka, to consider the adoption of proposed changes in existing rules and regulations on a temporary basis.

This 30-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments prior to the hearing to the Secretary of Social and Rehabilitation Services, Room 603-N, Docking State Office Building, 915 Harrison, Topeka 66612. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

The temporary regulations are proposed for adoption and are scheduled to become effective April 1. A summary of proposed regulations and their economic impact follows.

The phrase "Federal Mandate" following an item indicates that the change is required by federal policy. Optional changes in regulations related to federal programs are subject to approval by the U.S. Department of Health and Human Services.

Article 4.—Public Assistance Program

30-4-63. KanWork program requirements. This regulation is being amended to add an additional good cause criteria for a person who is the parent or other relative personally providing care for a child under age six and who refuses to accept employment if the employment required the person to work more than 20 hours per week. (Federal Mandate.)

Economic Impact: None.

30-4-64. Work program requirements. This regulation is being amended to add a provision for transitional services. Transitional services shall now be provided to each work program participant and to members of the participant's assistance family group who lose eligibility for ADC or APW due to the participant's employment. Transitional services shall include, but are not limited to, child care, as outlined in K.A.R. 30-4-120(a)(4), and medical assistance, as outlined in K.A.R. 30-6-65(p). (Federal Mandate.)

Economic Impact: See the economic impact statements for K.A.R. 30-4-120 and 30-6-65.

30-4-120. Special allowances and requirements for applicants and recipients of ADC, ADC-FC, APW, GAU and GA-FC. This regulation is being amended to allow for providing transitional services in the work program for any recipient who loses eligibility for ADC or APW due to becoming employed. (Federal Mandate.)

Economic Impact: Estimated increased expenditures of \$5,402,700 (\$2,389,073 state general funds).

**Article 6.—Medical Assistance Program—
Clients' Eligibility for Participation**

30-6-65. Automatic eligibles. This regulation is being amended to restrict the four-month automatic medical provision for persons who lose ADC, ADC-FC, or APW eligibility due to increased earned income or hours of employment to those who lose eligibility for any month prior to April 1990. This is being done to accommodate the expansion of the transitional medical provisions as described below. (Federal Mandate.)

Economic Impact: None.

This regulation is being further amended to restrict the nine-month automatic medical provision for persons who lose ADC, ADC-FC, or APW eligibility due to the termination of the earned income disregards to those who lose eligibility for any month prior to April 1990. This is being done to accommodate the expansion of the transitional medical provisions as described below. (Federal Mandate.)

Economic Impact: None.

This regulation is being further amended to expand the transitional medical provisions that permit up to 12 months of automatic medical benefits to certain families. The provisions shall now apply to all families who lose eligibility for ADC or APW beginning with the month of April 1990 due solely to increased earned income or hours of employment of the caretaker relative or termination of the earned income disregards. In addition, continued eligibility is contingent upon there being a child in the family. This provision replaces the four-month and nine-month automatic medical provisions described above. In addition, transitional medical benefits that had previously been available only to KanWork participants and their families shall now be available statewide. (Federal Mandate.)

Economic Impact: Estimated increased expenditures of \$1,682,232 (\$743,882.99 state general funds).

30-6-77. Poverty level pregnant women and young children; determined eligibles. This regulation is being amended to expand coverage of children up to age six. (Federal Mandate.)

Economic Impact: See the economic impact statement for K.A.R. 30-6-103.

This regulation is being further amended to modify the policy concerning continuation of eligibility for infants and children beyond the month in which they turn age one or age six if receiving inpatient care in the month they turn such age. Eligibility shall not exceed the month following the month of entrance. Previously, eligibility was extended for two months following the month of entrance. (Federal Mandate.)

Economic Impact: None.

30-6-103. Determined eligibles; protected income levels. This regulation is being amended to increase the poverty level standard for young children under the provisions of K.A.R. 30-6-77(c) to 133 percent of the federal poverty level. (Federal Mandate.)

Economic Impact: Estimated increased expenditures of \$2,905,809 (\$1,284,949 state general funds).

This regulation is being further amended to change the poverty level standard for pregnant women and for infants under age one from 100 to 150 percent of the official

federal poverty income guidelines. This change reflects current policy and was required because the regulation had been inadvertently modified to a lower standard and adopted on a temporary basis effective January 1, 1990. (Federal Mandate.)

Economic Impact: None.

Article 10.—Adult Care Home Program of the Medicaid (Medical Assistance) Program

30-10-21. Reserve days. This regulation is being amended to change the number of approved hospital reserve days from 15 days to 10 days.

Economic Impact: Estimated cost savings of \$300,000 (\$135,000 state general funds).

Article 10.—EXPERIENCE

66-10-9. Experience in engineering work of a character which is satisfactory to the board. (a) The required work experience shall be verified and shall expose the applicant to all phases of work normally considered to be integral to the discipline of engineering in which the applicant has indicated he or she is qualified to practice.

(b)(1) Engineering work experience shall be:

(A) work which falls within the definition of "the practice of engineering" as defined by K.S.A. 74-7003(i);

(B) under the direct supervision of a licensed professional engineer for work performed after May 1, 1988, except the direct supervision of a licensed professional engineer is not required of employees of any person, firm or corporation not offering to the public services in the technical professions as hereinafter defined; and

(C) verified by the employer or former employer and a licensed professional engineer.

(2) In assigning credit for work experience, the following guidelines shall be used:

(A) The education and experience evaluations by previous boards or other state boards may be accepted for work experience prior to the EIT examination. The applicant shall then show four years of acceptable experience after EIT certification.

(B) Engineering experience obtained concurrently with academic training may not be credited in full toward work experience requirements.

(C) When work experience is obtained through a co-op engineering program, approved by a school or university with an accredited engineering curriculum, credit shall be given for 50% of such verified experience. Credit for such work experience shall not exceed one year.

(D) A master's degree in engineering may be credited as one year of experience.

(c) If the applicant has only one engineering experience engagement which is verified by a licensed professional engineer, the applicant shall supply at least two additional references from licensed professional engineers who are familiar with the applicant's engineering experience. 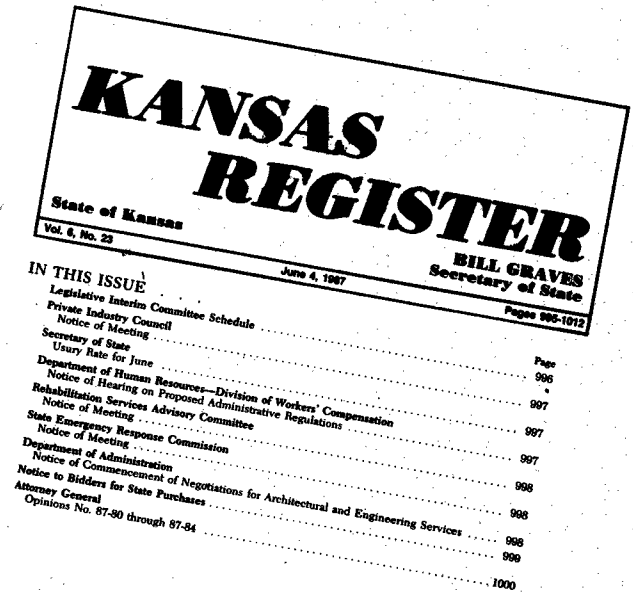
