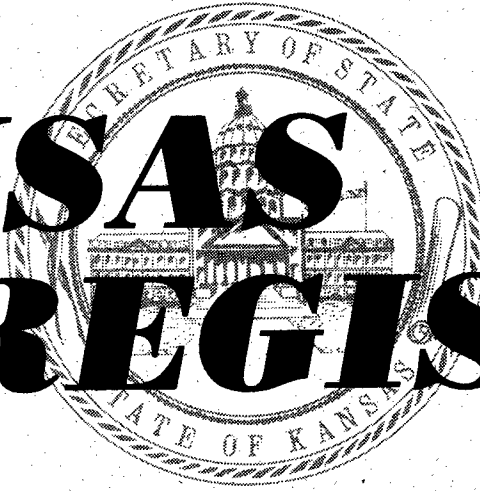

Irrigation—Districts—Payment for Property and Improvements—Additional Bonds, Election; Agreement with Federal Agencies; Water Rentals or Charges; Approval of Contract by Court Before Assessments Extended; Service of Process. Douglas G. Simms, Attorney for Kansas Bostwick Irrigation District No. 2, Belleville, August 9, 1990.

Pursuant to K.S.A. 42-711, an irrigation district created pursuant to K.S.A. 42-701 *et seq.* has the authority to change the operation and maintenance formula that determines the schedule of assessments that cover the district's cost of delivering water to its patrons. The change can be affected without seeking court approval. Cited herein: K.S.A. 42-701 *et seq.*; 42-711; 42-721. GE

Opinion No. 90-96

State Departments; Public Officers and Employees—Department of Corrections; Department of Corrections; Secretary—Transfer of Offender to the Topeka Correctional Facility-East. Julie McKenna, Saline County Attorney, Salina, August 9, 1990.

When a felon has been committed to the custody of the secretary of corrections, the clerk of the committing

court is required to so notify the secretary within three days of the commitment order. The secretary is then required to notify the sheriff within three days of receipt of the clerk's notice to transport the prisoner. If the secretary does not so notify the sheriff within this statutory time frame, the financial responsibility for maintaining the prisoner in the county jail until the sheriff is notified to transport the prisoner rests with the secretary of corrections. The Olathe Library Board's charter resolution exempting the board from K.S.A. 79-5021 to 79-5023 is not superseded or repealed by 1990 House Bill No. 2700, as that bill does not alter the authority exercised by the library board. of Voter Registration

In compliance with the provisions of K.S.A. 25-2310, K.S.A. 25-2313 and K.S.A. 1989 Supp. 25-2323, the books for registration of voters will be open at the following places at the time specified:

Office of the Kansas Secretary of State, second floor, State Capitol, Topeka, from 8 a.m. to 5 p.m. every business day.

Industrial Building, exhibit spaces IB-193 and IB-194, Kansas State Fairgrounds, Hutchinson, from 1 p.m. to 9 p.m. Friday, September 7; from 9 a.m. to 9 p.m. Saturday, September 8, through Saturday, September 15; and from 9 a.m. to 6 p.m. Sunday, September 16.

If you are a citizen of the United States and age 18 or older, or if you will be 18 by November 6, 1990, you must register before you can vote. Registration closes 15 days prior to every election.

When you are registered according to law, your registration will continue to be valid until one of the following occurs:

1. You change your name because of marriage, divorce or legal proceeding.
2. You change residence.
3. You fail to vote in two consecutive general elections. If you fail to vote in any general election, you should check with your county election officer on the status of your registration.

If any of the above occurs, you must re-register.

To register to vote, you may apply in person, by telephone, or by mail to the Secretary of State or your county election officer. Application forms will be provided by the county election officer upon request in person or in writing by an individual applicant. The application shall be signed by the applicant under penalty of perjury.

The State Corporation Commission has directed that an investigation be instituted and a hearing conducted to determine the reasonable market demand for natural gas produced from the fields and pools listed below for the period of October 1, 1990, through March 31, 1991; to determine the deliverability and acreage attributable to each of the wells therein; and to fix gas production percentages and quotas for the wells within those fields and pools.

Each bidder shall file a sworn statement executed by or on behalf of the person, firm, association or corporation submitting the bid, certifying that such person, firm, association or corporation has not, either directly or indirectly, entered into any agreement, participated in any collusion, or otherwise taken any action in restraint of free competitive bidding in connection with the submitted bid. This sworn statement shall be in the form of an affidavit executed and sworn to by the bidder before a person who is authorized by the laws of the state to administer oaths. The required form of the affidavit will be provided by the state to each prospective bidder. Failure to submit the sworn statement as part of the bid-approval package will make the bid nonresponsive and not eligible for award consideration.

Administrative Regulations

A public hearing will be conducted at 9 a.m. Wednesday, September 26, in Conference Room A, Building 740, Forbes Field, Topeka, to consider the adoption of a permanent rule and regulation (K.A.R. 28-33-11) of the Department of Health and Environment.

The proposed amendments exclude reference to serological tests for human immunodeficiency virus and define the risk evaluation test. Risk evaluation tests are not considered as tests for human immunodeficiency virus. Other proposed changes would allow results of some screening tests to be reported when a specimen is obtained from a cadaver being considered as a donor for organ transplantation; require reporting of HIV results as required by K.S.A. 1989 Supp. 65-6002 as amended by L. 1990, Ch. 234, Sec. 2; and clarify the language.

There is no economic impact as a result of the proposed amendments to the regulation governing the approval of

laboratories performing tests for human immunodeficiency virus.

The time period between the publication of this notice and the scheduled hearing constitutes a public comment period for the purpose of receiving written public comments on the proposed regulation. All interested parties may submit such comments prior to the hearing to the address above. All interested parties also will be given a reasonable opportunity at the hearing to present their views, orally or in writing, concerning the adoption of the proposed regulation. In order to give all persons an opportunity to present their views, it may be necessary to limit oral presentations to five minutes.

Following the hearing, all written and oral comments submitted by interested parties will be considered as the basis for making changes in these proposals.

Article 16.—TRAVEL REIMBURSEMENT

1-16-18. Subsistence allowance; rates. (a) General provisions.

(1) Except as otherwise specifically provided by law, subsistence allowances for in-state and out-of-state travel shall be paid on the basis of a quarter-day rate for meal expenses and the actual cost of lodging expenses incurred within the lodging expense limits set forth in this regulation. The subsistence rates for meal expenses shall be paid on a per diem basis at the appropriate rate for any fraction of a quarter-day in which the official travel begins and for each full quarter-day thereafter. For purposes of this regulation, a day shall commence at 12:01 a.m. No quarter-day allowance shall be paid for any fractional quarter-day in which the traveler returns to the traveler's official station or domicile. As used in this regulation, "international travel" means travel outside the fifty states and the District of Columbia.

(2) Reimbursement for lodging shall be made on the basis of actual single-rate lodging expenses incurred, including taxes, and shall be supported by the original official receipt of the lodging place or other suitable evidential matter. Reimbursement for lodging expenses shall be limited to the lodging place's lowest available rate for normal single occupancy on the day or days the lodging expense was incurred.

(3) Subject to the approval of the secretary of administration, the director of accounts and reports may designate any city in a state bordering or near Kansas as a "border city." All meals allowances and lodging expense limitations shall be at the appropriate in-state rate for travel by state personnel to a border city.

(2) Out-of-state	\$5.00
(3) Designated high cost geographic area— out-of-state	\$6.00

An exception to the quarter-day meal allowance for international travel may be made at the option of each agency, by claiming actual expenses subject to a daily limitation of \$66 for meals.

Article 5.—CODE OF PROFESSIONAL CONDUCT

74-5-406. Firm names. (a) A certified public accountant shall not practice public accountancy under a firm name that includes descriptive words relating to the quality of services offered or which is misleading in any way as to the legal form or as to the persons who are partners, officers or shareholders of the firm, or as to any matter with respect to which public communications are restricted by K.A.R. 74-5-403.

(b) A firm name shall not be considered to be misleading solely because it contains words describing the geographical area in which the services are offered or words describing the type of services actually being performed by certified public accountants who are owners, partners, officers, or shareholders of the firm.

(c) A firm name or designation shall be considered to be misleading if: (1) the name contains a misrepresentation of facts;

(2) the name is intended or likely to create false or unjustified expectations of favorable results;

(3) the name implies education or professional attainment or licensing recognition of its owners, partners or shareholders which are not supported in facts;

(4) the name of a firm that is Kansas incorporated does not include the full legal name, including "Chartered," "Professional Association," or "P.A." each time the firm name is used;

(5) use of the terms "& Company," "& Associate," or any similar terms, does not represent at least one other unnamed partner, shareholder, owner or staff accountant holding both a Kansas certificate and a permit to practice as a certified public accountant; use of the plural "& Associates" does not represent more than one other unnamed partner, shareholder, owner or staff accountant holding both Kansas certificates and permits to practice as certified public accountants;

(6) the name of a firm that is a partnership or professional association fails to contain the personal name or names of one or more individuals presently or previously a partner, officer, or shareholder thereof;

(7) it contains the name of one or more former partners, shareholders or owners without their written consent;

(8) the name of a firm that is a sole proprietorship fails to contain the name of the sole proprietor; or

(9) the name contains other representations or implications that in reasonable probability will cause a person of ordinary prudence to misunderstand or to be deceived.

(d) A partner or shareholder surviving the death or withdrawal of all other partners or shareholders may continue to practice under a partnership or professional association name for up to one year after becoming a sole practitioner. In this instance, "withdrawal" means leaving the practice of public accounting in the state of Kansas. Article 40.—KANSAS EXPORT FINANCE ACT

110-40-1. Definitions. (a) "Department" means the Kansas department of commerce.

(b) "Review committee" means the Kansas export loan guarantee review committee within the department.

(c) "Director's office" means the office of the export finance director, within the trade development division of the department.

(d) "Eximbank" means the Export-Import Bank of the United States.

(e) "Exporter" means a business concern, incorporated or unincorporated, which sells, leases, or proposes to sell or lease Kansas goods or services destined for shipment, resale, or use outside the United States.

(f) "Financial assistance" means insurance, co-insur-

ance, reinsurance, or guarantees for loans or credits extended to an exporter for pre-export credit needs or post-export credit needs or both.

(g) "Kansas goods or services" means goods or services manufactured, processed, or originated in Kansas or which contain substantial Kansas-source components, labor, or intellectual property. (Authorized by K.S.A. 1989 Supp. 74-5071; implementing K.S.A. 1989 Supp. 74-5071, effective Oct. 8, 1990.)

110-40-2. Availability and form of financial assistance from the Kansas department of commerce. (a) Financial assistance shall be available from the department to support the pre-export credit needs or post-export credit needs or both of exporters with respect to Kansas export transactions where:

- (1) credit or loans may otherwise not be made available;
- (2) there are reasonable risks; and
- (3) there is sufficient likelihood of repayment.

(b) Financial assistance may be in the form of insurance, co-insurance, reinsurance, or guarantee of a loan or the credit extended to exporters by Kansas financial institutions. (Authorized by K.S.A. 1989 Supp. 74-5071; implementing K.S.A. 1989 Supp. 74-5071 and 74-5073; effective Oct. 8, 1990.)

110-40-3. Application content. Application forms shall be available from the director's office for use by exporters or lenders in seeking financial assistance. The application forms shall set forth the information necessary for the determination of the eligibility of a Kansas export transaction for financial assistance and shall require, among other things: (a) with respect to the exporting company:

- (1) a description and history of the exporting company;
 - (2) a resume of management experience; and
 - (3) financial statements;
- (b) with respect to the underlying Kansas export transaction:

- (1) a description of the products to be manufactured or processed, or services to be supplied, or both;
- (2) a description of the Kansas content of the products or services;
- (3) an estimate of additional employment that will occur as a result of the transaction;
- (4) the destination of the products or services, or both;
- (5) income and expense projections;
- (6) a description of the foreign purchaser and the past experience of the exporter with the foreign purchaser; and

(7) an outline of the expected commercial terms of sale and proposed terms of payment; and

(c) with respect to the loan:

- (1) the dollar amount;
- (2) the term;
- (3) the interest rate;
- (4) the banking fees; and
- (5) a description of collateral and other security.

Any additional information necessary to make a determination and which is reasonably related to the criteria for approval in KAR 110-40-5 and KAR 110-40-6 may be required by the director's office. (Authorized by K.S.A. 1989 Supp. 74-5071; implementing K.S.A. 1989 Supp. 74-5071, 74-5072, and 74-5073; effective Oct. 8, 1990.)

110-40-4. Application procedure. (a) Application forms. The completed application forms with all required exhibits and attachments shall be submitted to the director's office.

(b) Application fee. An application fee as provided in K.S.A. 1989 Supp. 74-5072(c) shall be paid by certified check payable to the department. The certified check shall accompany the completed application form submitted to the director's office. The fee shall not be refundable.

(c) Initial review and consideration by the director's office. The application shall be reviewed by the director's office for completeness and the applicant shall be notified of any additional information required. When all required information has been received, the application shall be evaluated taking into account the purposes of the Kansas export finance act and the criteria and terms of KAR 110-40-5 and KAR 110-40-6. The application shall then be submitted by the director's office to the review committee together with the recommendation of the director's office for approval or denial.

(d) Denial of application. If the application is disapproved by the review committee, the applicant shall be notified by the director's office in writing of the reasons for denial.

(e) Approval of application. If the application is approved by the review committee, the applicant shall be notified by the director's office in writing.

(f) Misrepresentation by applicant. Any application may be rejected, any notice of approval may be revoked, or closure on the loan may be refused by the director's office if any information provided by the applicant contains a material misrepresentation or omission. Each applicant shall have an affirmative and continuing duty to update and correct all information provided to the director's office or to the lender. (Authorized by K.S.A. 1989 Supp. 74-5071; implementing K.S.A. 1989 Supp. 74-5071, 74-5072, and 74-5073; effective Oct. 8, 1990.)

110-40-5. General terms and conditions of financial assistance. (a) Permissible use of financial assistance. Guaranteed loan funds may be used by the exporter to satisfy credit needs with respect to Kansas export transactions. Eligible credit needs include the costs and expenses related to the acquisition or production, financing, and shipment of the goods and services.

(b) Participation. In providing financial assistance, participation from other private and governmental sources, including the United States small business administration, eximbank, the foreign credit insurance association, and private insurers may be sought by the department.

(c) Maximum amount of financial assistance. The department's net exposure for financial assistance to a Kansas export transaction may not, at any one time, exceed 30 percent of the export loan guarantee fund balance.

(d) Security. Loans may require collateralization of a type, amount, and value which, considered with the other criteria described in KAR 110-40-6, affords reasonable assurance of repayment.

(e) Reporting requirements.

(1) The lender shall report in writing to the director's office as provided in the guarantee agreement and as provided in KAR 110-40-7, Loan administration and servicing.

(continued)

(2) The exporter shall report to the director's office immediately upon making shipment of the goods and shall provide copies of documents evidencing shipment according to the terms of trade. In addition the exporter shall report immediately the receipt of payment of the Kansas export transaction receivable. If requested by the director's office, the exporter shall submit other reports or documentation reasonably related to an assessment of the exporter's compliance with the Kansas export finance act. (Authorized by K.S.A. 1989 Supp. 74-5071; implementing K.S.A. 1989 Supp. 74-5071, 74-5072, and 74-5074; effective Oct. 8, 1990.)

110-40-6. Criteria for approval of financial assistance. (a) Need for financial assistance. A need for financial assistance shall be deemed to exist where credit or loans are otherwise not available for Kansas export transactions. In evaluating the availability of credit or loans the following factors shall be taken into consideration by the department:

(1) Exporter's resources. Consideration shall be given to whether the desired financing appears available, in whole or in part, to the exporter on reasonable terms based upon its own resources, including the exporter's bank credit lines, issuance of new capital, sale of assets at a fair price, and the personal credit or other resources of the owners and principal shareholders of the exporter.

(2) Alternative sources of assistance. Consideration shall also be given to whether the requested financial assistance appears available, in whole or in part, through other governmental sources such as the United States small business administration or eximbank. The exporter may be directed to these sources or to seek coparticipation from these sources, as appropriate, prior to further consideration of the application.

(b) Reasonable risk and likelihood of repayment. Financial assistance shall only be available for loans which represent reasonable risks and which have a sufficient likelihood of repayment. In making these judgements, the following factors shall be considered by the department:

(1) the credit history and financial condition of the exporter;

(2) the collateral and other sources of guarantee or insurance securing the loan or credit;

(3) the terms of the sale and projected earnings from the Kansas export transaction;

(4) the capacity of the exporter to perform commercially, especially in accordance with the commercial terms and conditions of the Kansas export transaction;

(5) the security of the payment terms of the Kansas export transaction, to the extent that the exporter's loan repayment is dependent upon collection of the foreign receivable; and

(6) the lender's ability to evaluate, perform, and service the loan or credit, to make reports as required by these rules, and to collect the loan upon default.

(c) The limits in K.S.A. 1989 Supp. 74-5072(a). The criteria for approval of financial assistance shall include the percentage limitations in K.S.A. 1989 Supp. 74-5072 (a). (Authorized by K.S.A. 1989 Supp. 74-5071; implementing K.S.A. 1989 Supp. 74-5071, 74-5072, 74-5073, and 74-5074; effective Oct. 8, 1990.)

110-40-7. Loan administration and servicing. (a) The lender shall perform, administer, and service the loan in accordance with customary and prudent commercial banking practices and in accordance with the terms of all agreements between lender and exporter related to the loan.

(b) The lender shall maintain, and upon request, make available to the department all documents relating to the loan.

(c) The lender shall obtain from exporter the loan security and shall take all necessary action to perfect the security interests.

(d) The lender shall preserve and protect the interest of the lender and the department in the loan and loan security in accordance with customary and prudent commercial banking practices.

(e) The lender shall immediately notify the exporter of any past due payments. If the exporter fails to cure the nonpayment within 30 days, the lender shall notify the director's office and confer regarding action to be taken in servicing and collecting the export loan and pursuing the export loan security. (Authorized by K.S.A. 1989 Supp. 74-5071; implementing K.S.A. 1989 Supp. 74-5071 and 74-5074; effective Oct. 8, 1990.)

110-40-8. Guarantee agreement. (a) A guarantee agreement between the department and the lender shall be prepared by the director's office.

(b) The guarantee agreement shall contain two parts consisting of:

(1) a set of general terms and conditions which will be applicable to all Kansas export transactions; and

(2) an attachment to the general terms and conditions designed to identify the *specific* terms and conditions of each individual transaction.

(c) A guarantee fee as provided in K.S.A. 1989 Supp. 74-5072(c) shall be paid by the lender to the department. The fee shall not be refundable and shall be paid:

(1) not less than five business days from execution of the guarantee agreement by the secretary of commerce; or

(2) not later than the date of the first disbursement under the guaranteed loan, whichever is earlier. (Authorized by K.S.A. 1989 Supp. 74-5071; implementing K.S.A. 1989 Supp. 74-5071, 74-5072; effective Oct. 8, 1990.)
