Notice of Acceptance of Applications for Professional Development Grants

The Kańsas Arts Commission is accepting applications for professional development grants to be awarded during fiscal year 1991 to artists creating original works of art in any arts discipline or medium. Professional development grants are intended to encourage artists who are undertaking projects to advance their careers, but who need funding. Such projects may include mounting an exhibition, registering for specialized training, hiring musicians to record new original musical compositions, or hiring technical assistance.

To be eligible, an artist must have been a resident of Kansas since July 1, 1989, and should intend to remain a resident through June 30, 1991. The program is not open to individuals living out-of-state, to students pursuing undergraduate or graduate programs, or to interpretive artists who are not creating original work.

Professional development grants are awarded upon the availability of funds on a first come, first served basis. During fiscal year 1991, a total of \$5,000 is available. An applicant may request from \$100 to \$1,000 rounded to the nearest dollar. The applicant is required to match 50 percent of the projected budgeted costs in cash or a combination of cash and documented in-kind services.

Only one professional development grant application may be submitted per year by any individual. Applications for grants must be received no later than two months prior to the starting date of a project.

Recipients are required to complete the project by June 30, 1991. A final report form must be completed and submitted to the commission within 30 days of completion of the project.

The Kansas Arts Commission will conduct a quarterly business meeting from 9 a.m. to 3 p.m. Friday, September 28, at the Prairie Museum of Art & History in Colby. The primary business item for the commissioners will be to review and act upon the recommendations of the advisory panels for the funding of grants from the Planning Education in the Arts in Kansas and Design Arts/Capital Aid programs during fiscal year 1991.

Also on the agenda is an update on the fiscal year 1991 budget and review of the proposed fiscal year 1992 budget; approval of the proposed membership of advisory panels for fiscal year 1992; approval of commission grant applications to the National Endowment for the Arts (NEA); reports on fiscal year 1991 programs; and action on grants to Kansas State University Extension for the Rural Arts Circuit Rider and to the Kansas Alliance for Arts Education and Accessible Arts, Inc., from the Arts in Schools Basic Education Grant program.

State Boards, Commissions and Authorities—State Board of Technical Professions—Architecture; Exemptions from Requirements for Licensure or Certification; Definitions. Representative Larry F. Turnquist, 69th District, Salina, August 17, 1990.

K.S.A. 74-7031 does not per se require the assistance of an architect when installing a door in a precast concrete building. Whether these circumstances require the assistance of an architect depends on a factual determination made by the fact-finding body from whom a building permit is sought. Minors—Kansas Juvenile Offenders Code—Right to an Attorney; Docket Fee and Expenses; Recovery of Attorney Fees by County from Parents of Juvenile. J. Michael Grear, Kiowa County Attorney, Greensburg, August 17, 1990.

K.S.A. 38-160 et seq., the Kansas juvenile offenders code, permits a court to assess the expense of a courtappointed attorney against the parents of a juvenile charged under that code. However, such an assessment is discretionary and must be made by the court in accordance with due process and jurisdictional requirements, and should consider the financial resources of the parents. Taxation—Motor Vehicles—Taxes Levied Annually for Registration Period; Due Date. Representative Michael R. Brown, 27th District, Stanley, August 23, 1990.

The current practice under K.S.A. 79-5101 et seq. and K.A.R. 92-51-21 of taxing motor vehicles in such a way

as to cause taxpayers with surnames at the end of the alphabet to pay more in taxes than identically situated taxpayers with surnames at the beginning of the alphabet is violative of the equal protection clause of the United States Constitution. Monopolies and Unfair Trade—Fair Credit Reporting Act—Permissible Purposes of Reports; Legitimate Business Need. Mark A. Burghart, General Counsel, Department of Revenue, Topeka, August 28, 1990.

K.S.A. 50-703(c)(5) permits a consumer reporting agency to furnish a consumer report in circumstances involving a legitimate business need for the information in connection with a business transaction involving the consumer. A financial investigation into the assets of drug dealers by the criminal fraud unit of the Division of Alcoholic Beverage Control does not involve a consumer relationship or business transaction, thus, K.S.A. 50-703(c)(5) does not allow a consumer reporting agency to furnish a consumer report for that purpose. Counties and County Officers—County Commissioners; Powers and Duties—Sale of County Property. Michael W. Ryan, Attorney for Clay County Hospital, Clay Center; John F. Bosch, Clay County Attorney, Clay Center, August 30, 1990.

While a county hospital board has many powers relating to the supervision, care and custody of hospital property, it does not have the power to sell hospital property. This power is vested in the county that retains title to all hospital real property. The board of county commissioners may sell real property, essentially on behalf of the hospital, and may allow the hospital to retain the proceeds of such a sale. State Departments; Public Officers and Employees—State Engineering Services—State Policy; Negotiation of Contracts for Engineering Services. Leroy F. Fry, State Representative, 105th District, Little River, August 30, 1990.

A state agency may not utilize the state engineering services act as a mechanism to negotiate with firms for the performance of land survey work. Notice of Meeting and Hearing on Proposed Administrative Regulations

A public hearing will be conducted at 7 p.m. Monday, October 8, in the Holiday Inn Holidome, Brazilian Rooms A and B, 200 McDonald, Lawrence, to consider the adoption and revocation of several department regulations. If necessary, the public hearing will continue at 9 a.m. Tuesday, October 9, at the same location. A workshop meeting on upcoming business and future regulations will begin at 1:30 p.m. Monday, October 8, at the above location. If necessary, the workshop will continue following the conclusion of the public hearing. The public is also invited to attend the workshop.

This 30-day notice period prior to the hearing constitutes a public comment period for the purpose of receiving written public comments on the regulations.

All interested parties may submit written comments prior to the hearing to the chairman of the commission, Kansas Department of Wildlife and Parks, Suite 502, Landon State Office Building, 900 S.W. Jackson, Topeka 66612. All interested parties will be given a reasonable opportunity at the hearing to express their views orally in regard to the adoption of the proposed regulations and the proposed revocations. During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending or rejecting the proposed regulations and revocations.

The following is a brief summary of the regulations proposed for adoption and regulations proposed for revocation:

K.A.R. 115-2-1. Amount of fees. This permanent regulation would be amended to establish a fee for additional deer and turkey game tags—\$10, nonresident landowner turkey permits—\$30, nonresident deer (doe—\$50, any deer—\$150, and buck only—\$150) permits, resident and nonresident commercial mussel permits—\$25 and \$200 respectively, commercial and associate guide permits—\$50 and \$25 respectively, and commercial fish bait permits—\$20. Live rabbit and hare trapping and dealer permits and fees, and resident and nonresident amphibian and reptile harvest and dealer permits and fees are removed, as the permits are no longer a valid issue of the department.

Economic Impact Summary: Implementation of game tags and nonresident deer permits will require additional regulatory (and perhaps statutory) effort, thus no immediate impact will be noted. The combined effect of the other fees will result in revenue to the department of an estimated \$47,950 and an equal expenditure by those choosing to purchase such permits. No impact on other state agencies is anticipated and the impact on the general public is expected to be insignificant. No impact will occur to department revenues as a result of discontinuing the several mentioned permits and associated fees as those permits are no longer a valid issue of the department.

K.A.R. 115-17-6. Commercial mussel permit; permit application and requirements, authority, reports, general

provisions and permit revocation. This proposed permanent regulation establishes a commercial mussel permit requirement for the harvest, sale, purchase for resale, or export of mussels. Record keeping and quarterly reporting is required. Authorities and restrictions under the permit are established.

Economic Impact Summary: This regulation basically continues the same requirements as currently is contained in K.A.R. 23-3-17, which is proposed for revocation. Quarterly instead of annual reporting is required, thus some additional expense may accrue to permittees for report preparation and submittal and to the department

for administration of the permitting system.

K.A.R. 115-17-7. Commercial harvest of mussels; legal species, seasons, size restrictions, daily limits and possession limits. This proposed permanent regulation establishes the legal species, season for taking, size restrictions, daily limits and possession limits for the commercial taking of mussels. The minimum shell size limit is increased from 1³/₄ inches to 3 inches for all species of mussels, except all sizes of Asian clam may be harvested. The remaining provisions were previously established as conditions of permit issuance under K.A.R. 23-3-17, which is proposed for revocation.

Economic Impact Summary: The minimum size increase is expected to reduce the harvest of mussels by approximately 15 percent for permittees. No other im-

pacts are anticipated.

K.A.R. 115-17-8. Commercial harvest of mussels; legal equipment, taking methods and general provisions. This proposed permanent regulation establishes the legal equipment, taking methods, and general provisions for the commercial harvest of mussels. It continues provisions that were previously established as conditions of permit issuance under K.A.R. 23-3-17, which is proposed for revocation.

Economic Impact Summary: The same basic conditions would exist, thus no economic impact is anticipated.

K.A.R. 115-17-9. Commercial harvest of mussels; open areas. This proposed permanent regulation establishes the areas of the state open for the commercial harvest of mussels. It continues the same open areas that were previously established as conditions of permit issuance under K.A.R. 23-3-17, which is proposed for revocation.

Economic Impact Summary: The same basic open areas would continue, thus no economic impact is anticipated.

K.A.R. 115-25-10. Deer; special firearms season, bag limits, permits and applications. This proposed exempt regulation would establish a special deer season in January and early February of 1991 in a several county area of southeast Kansas. A total of 3,000 general permits and unlimited hunt-on-your-own-land permits is recommended as is a bag limit of three antierless deer.

Economic Impact Summary: Administrative costs of the season would be borne by the department. Issuance of all permits would result in revenue to the department of \$91,500. It is estimated that 1,000 hunt-on-your-own-land permits would be issued at \$10.50, resulting in revenue of \$10,500 to the department. Local businesses providing services to sportspersons would notice some benefit.

The following regulations are proposed for revocation:

(continued)

K.A.R. 23-3-17. Mussel fishing; license and regulation. This permanent regulation exists under the discontinued agency 23 number. Provisions of this regulation are contained in proposed regulations K.A.R. 115-17-6, 17-7, 17-8, and 17-9.

Economic Impact Summary: No economic impact will occur as a result of revocation.

K.A.R. 23-3-18. Restrictions on possession and transportation. This permanent regulation exists under the discontinued agency 23 number and pertains only to the possession of fish, amphibians, reptiles and shellfish for sale, exchange or other commercial purposes. Provisions authorizing shellfish (mussels) to be possessed for the purposes of sale, purchase, resale or export are contained in proposed regulation K.A.R. 115-17-6. Similar authorities for commercial fishing exist in K.A.R. 23-3-16. A regulation to allow possession of amphibians and reptiles for commercial purposes is unnecessary because regulations to allow wild amphibians and reptiles to be harvested and sold does not exist.

Economic Impact Summary: No economic impact will occur as a result of revocation.

K.A.R. 23-18-2. Hatchery stamp fee and stamp. This permanent regulation is proposed for revocation. It established hatchery fees for annual, 5-day, and 24-hour fishing licenses. Also established is a graduated hatchery fee schedule for lifetime fishing licenses. Sufficient funds have been generated to complete hatchery bond and interest payments, thus the hatchery fee is no longer needed.

Economic Impact Summary: The hatchery fee generated approximately \$860,000 annually from fishing license buyers. Revocation will result in an equal annual savings to those buyers. Projections indicated that 1990 would be the last year that the hatchery fee would be needed. Although further income to the department from the fee will not occur, the objective of the hatchery fee has been accomplished.

K.A.R. 23-20-1. Amphibians and reptiles; permit to commercially harvest. This permanent regulation is proposed for revocation. Commercial amphibian and reptile permits have not been issued since July 1, 1989. Regulations to authorize commercial harvest and sale of amphibians and reptiles were considered later in 1989 and were not approved. K.A.R. 23-20-1 is not needed as the activities authorized under that regulation have been publicly examined and discontinued.

Economic Impact Summary: Approximately 29 permittees were involved with commercial amphibian and reptile harvest and sale. Permit activity has not occurred since July 1, 1989. Revocation of this regulation will not have an economic impact, as the impact occurred when the new regulations were considered, but rejected.

Article 17.—DIVISION OF VITAL STATISTICS

- 28-17-1. Enforcement of uniform vital statistics act. Any violation of K.S.A. 65-2401 et seq., rules and regulations shall be immediately reported to the state registrar who shall immediately report such cases to the county attorney, or the official acting in that capacity, for prosecution, as provided in K.S.A. 65-2434. (Authorized by K.S.A. 65-2402, 65-2406, as amended by L. 1990, Chap. 226; implementing K.S.A. 65-2434; effective Jan. 1, 1966; amended Oct. 22, 1990.)
- 28-17-3. (Authorized by K.S.A. 65-2431; effective Jan. 1, 1966; revoked Oct. 22, 1990.)

If the birth occurs in a licensed hospital or maternity home, the hospital or maternity home shall prepare a birth certificate for every child born therein, obtain the attending physician's signature thereon and forward it to the state registrar within five days after the date of birth. - 28-17-15. State registrar to prepare blanks. All blanks and forms used in registering, recording and preserving the records shall be prescribed and printed by the department. Each local registration officer shall accept and use only blanks prepared and provided by the state registrar and shall issue out-of-state transit permits only when the proper blanks are used and are completely filled out. - 28-17-19. Unattended births. Additional information for each unattended birth shall be submitted to the office of vital statistics for inclusion on the original birth certificate within 90 days of the date the birth certificate is filed with the office of vital statistics. If an unattended birth is not registered within six months of the date of birth, a delayed birth certificate shall be filed in accordance with K.S.A. 65-2419 and K.S.A. 65-2420, K.A.R. 28-17-8, K.A.R. 28-17-9, K.A.R. 28-17-10, K.A.R. 28-17-11 and K.A.R. 28-17-12. (Authorized by K.S.A. 65-2402; implementing K.S.A. 65-2410, as amended by L. 1990, Chap. 226; effective Jan. 1, 1966; amended May 1, 1987; amended Oct. 22, 1990.)

28-17-20. Corrections to certificates and records. (a) Amendments within 90 days.

- (1) Within 90 days of receipt of an original vital record in the office of vital statistics, the following records in which an inaccuracy or incomplete item is apparent on the face of the certificate, may be changed to show the accurate and complete facts:
 - (A) birth certificates;
- (B) any part of a death certificate other than the portion describing the cause of death;
 - (C) stillbirth certificate; and
 - (D) divorce records.
 - (2) Such changes shall be made by:
- (A) drawing a single line through the incorrect information:
- (B) inserting the correct information in the appropriate space: and
- (C) placing the date of the amendment and the word "amended" on the record.
- (3) This process of amendment shall not be used more than one time for the same item.
- (4) An amendment fee shall not be required for changes made within the first 90 days after receipt of the vital record in the office of vital statistics.
- (b) Amendments after 90 days. After 90 days of receipt of the vital record in the office of vital statistics, amendments may be made only as follows:
 - (1) Certificates of birth.
- (A) Birth certificate items may be amended upon the applicant's submission of at least two documents which consistently substantiate the item or items to be amended

and that are executed and dated at least five years prior to the request for the amendment or prior to the seventh birthday anniversary of the registrant, except that items (i) through (vii) shall be corrected only as provided.

(i) The items recording the registrant's sex may be amended if the amendment is substantiated with the applicant's affidavit that the sex was incorrectly recorded or with a medical certificate substantiating that a physiological or anatomical change occurred.

(ii) If the registrant is a minor, any request by the parents to change an item by adding the name of a parent. correcting the name of either parent or of the child, or changing the child's last name to that of either parent shall be made only pursuant to K.S.A. 38-1130 and amendments thereto.

(iii) Any registrant who is of legal age may amend the order of the registrant's given names if the amendment is substantiated with one document specified in paragraph

(iv) A registrant who is of legal age may place one or two given names of the registrant on the record only if there is no given name on the original certificate and if the amendment is substantiated with one of the documents specified in paragraph (A) above.

(v) A registrant of legal age may correct a given name or names of the registrant if the amendment is substantiated with one document established prior to the seventh

birthday anniversary of the registrant.

(vi) If the registrant is of legal age, the maiden name of the mother and given name of the father or mother of the registrant, may be changed if one of the required documents specified in paragraph (A) above is the marriage or birth certificate of that parent.

(vii) The birthdate on the certificate may only be changed if both required documents were executed and dated prior to the seventh birthday anniversary, and if the change is not consistent with the recorded filing date.

(B) Any item that has been previously amended shall not be changed under authority of this regulation.

(C) The sufficiency of affidavits and supporting evidence shall be determined by the state registrar.

- (D) Requests for an amendment to a certificate of birth that do not require a court order shall be submitted by the parent or legal guardian of persons not of legal age. or by the person whose birth is recorded, if of legal age, and by none other. The person submitting such an application shall execute a notarized affidavit stating the true facts to be recorded.
- (E) When amendments to a birth certificate are made after 90 days of the date the certificate was received by the office of vital statistics, the original certificate shall remain unchanged and placed in a sealed file to be opened only by court order. A new certificate shall be prepared and shall be marked "amended." The date of the amendment shall be recorded on the certificate. In the sections where the original certificate contained a signature, the amended certificate shall contain the typed name of the person who signed. The original certificate and any affidavit required shall be permanently filed by the office of vital statistics.
 - (2) Certificates of death—personal data.
 - (A) "Personal" data may be amended if the request is

made within the first six months after the filing of the original certificate.

(B) Requests for amendments to "personal" data may be made only by the funeral director or person acting as such who submitted the original certificate.

- (C) When amendments to the "personal" data of a death certificate are made after 90 days of the date the certificate is received in the office of vital statistics, the original certificate shall remain on file unchanged and placed in a sealed file to be opened only by court order. A new certificate shall be prepared by the funeral director or person acting as such. The medical certification section shall again be completed and the required signatures shall be secured in all possible instances. The signatures may be typed if the required signatures are unattainable and a written statement of the reason therefore is attached to the certificate. The certificate shall not be accepted if the stated reason for the typed signature is inadequate. Upon acceptance by the office of vital statistics, the new certificate shall be marked "amended" and shall indicate the date of the amendment.
 - (c) Certificates of death—medical certification.

(1) An amendment may be made to the medical certification data at any time.

- (2) Requests for amendments to the medical certification data may be made only by the attending physician who signed the medical certification on the original certificate, or by the coroner in whose jurisdiction the death occurred.
- (3) When amendments to the medical certification section of the death certificate are made, the original certificate shall remain on file unchanged, and the written statement or affidavit of the certifying physician or coroner shall be appended to the certificate. However, a certifying physician or coroner may request the establishment of a new death certificate when erroneous data has been entered in the medical certification section. In such a case, the funeral director or person acting as such shall enter the personal data and refer the certificate to the certifying physician or coroner for the medical certification and signature. When all items have been completed, the new certificate shall be submitted to the office of vital statistics, and upon its acceptance, it shall be marked "amended" and shall indicate the date of the amendment. The original death record shall be placed in a sealed file only to be opened by court order. Article 4.—FEES AND CHARGES

25-4-1. Fees. (a) Definitions.

(1) "Regular hours" means 7:00 a.m. to 4:30 p.m., Monday through Friday. Regular hours for samplers may be adjusted to the elevator's hours of operation not to exceed eight hours per day.

Article 30.—BOATING

- 115-30-2. Certificate-of-number and registration; application, temporary permits and expiration date. (a) Applications for a certificate-of-number and registration shall be available at designated department offices.
- (b) Vendor agents shall be authorized to issue temporary and permanent certificates-of-number and registrations.
- (c) Issue of a temporary registration shall be authorized when application for and issuance of a permanent certificaite-of-number and registration is pending.
- (d) The certificate-of-number and registration decals shall be valid for a period of time ending three years from the date of issue.

- (e) An address change addendum issued by the department pursuant to K.S.A. 1989 Supp. 32-1111 to a certificate-of-number holder shall be a part of the certifcate-of-number and shall be retained by the holder with the certificate-of-number.
- (f) This regulation shall be effective January 1, 1991. (Authorized by and implementing K.S.A. 1989 Supp. 32-1111; effective Jan. 1, 1991.)
- 115-30-3. Personal flotation devices; requirements. (a) "PFD" means any type I, II, III, or IV personal flotation device approved by the United States coast guard for use on recreational vessels.
- (b) Each vessel less than 16 feet in length and all canoes and kayaks shall have at least one PFD on board for each individual in the vessel and at least one PFD on board for each individual being towed.
- (c) Each vessel 16 feet or greater in length, except canoes and kayaks, shall have at least one type I, II, or III PFD on board for each individual in the vessel and at least one type I, II or III PFD on board for each individual being towed.
- (d) In addition to the provisions of subsection (c), each vessel 16 feet or greater in length, except canoes and kayaks, shall have at least one type IV PFD on board.
- (e) A type V personal flotation device may be used to satisfy requirements of subsections (b), (c), or (d) if:
- (1) the device is United States coast guard approved; (2) the device is labeled for the activity for which the
- recreational vessel is being used;
- (3) the device is used in accordance with requirements on the label; and
- (4) the device is used in accordance with the requirements in its owner's manual if the label refers to the manual.
- (f) To meet the "readily accessible" requirement of K.S.A. 1989 Supp. 32-1119, each required PFD shall be in open view and shall not be stowed in locked or closed compartments or be inside plastic or other packaging material. (Authorized by and implementing K.S.A. 1989 Supp. 32-1119; effective Oct. 22, 1990.)
- 115-30-4. Fire extinguishers; requirements. (a) United States coast guard approved hand portable fire extinguishers of type B, size I or type B, size II or both shall be carried on board each motorboat as determined by the following classes:
- (1) Class A: at least one type B, size I fire extinguisher shall be carried if any one or more of the following conditions exist:
 - (A) an inboard engine;
- (B) closed compartments under thwarts and seats where portable fuel tanks may be stored;
- (C) double bottom construction not sealed to the hull or not completely filled with flotation materials:
- (D) closed compartments in which combustible or flammable materials are stored; or
- (E) permanently installed fuel tanks. Fuel tanks that cannot be moved in case of fire or other emergency or if the weight of the fuel tank precludes movement of the tank by an individual on board shall be considered permanently installed.
 - (2) The provisions of subsection (1) shall not apply if

the motorboat has a United States coast guard approved built-in or affixed fire extinguisher in the motor area.

- (3) Class 1: at least one type B, size I fire extinguisher shall be carried, except the provisions of this subsection shall not apply if the motorboat has a United States coast guard approved built-in or affixed fire extinguisher in the motor area.
- (4) Class 2: at least two type B, size I fire extinguishers or one type B, size II fire extinguisher shall be carried, except each motorboat that has a United States coast guard approved built-in or affixed fire extinguisher in the motor area shall only be required to carry at least one type B, size I fire extinguisher.

(5) Class 3: at least three type B, size I fire extinguishers or one type B, size I fire extinguisher and one type B, size II fire extinguisher shall be carried, except each motorboat that has a United States coast guard approved built-in or affixed fire extinguisher in the motor area shall only be required to carry at least two type B, size I fire extinguishers or one type B, size II fire extinguisher.

(b) Each vessel, including each motorboat having an approved built-in or affixed fire extinguisher in the motor area, that has enclosed living spaces or galleys shall carry at least one United States coast guard approved type B, size I or type B, size II fire extinguisher in the living space or galley. (Authorized by and implementing K.S.A. 1989 Supp. 32-1119; effective Jan. 1, 1991.)

115-30-5. Boating; capacity plate and operation. (a) A capacity plate, once installed on a vessel, shall not be removed, defaced, replaced, or altered.

- (b) A vessel shall not be operated with a motor which exceeds the maximum horsepower of the motor as specified on the capacity plate or as computed under K.A.R. 115-30-6. (Authorized by and implementing K.S.A. 1989 Supp. 32-1126; effective Oct. 22, 1990.)
- 115-30-6. Boating; adoption by reference of certain code of federal regulations. (a) The following parts and sections of the federal rules and regulations promulgated by the United States coast guard are hereby incorporated by reference as the rules and regulations of the department. The incorporation by reference shall cover the parts and sections of title 33 as they exist on July 1, 1990 and the parts and sections of title 46 as they exist on October 1, 1989:
- (1) Definitions: 33 C.F.R. section 183.3, except subsections (g) and (j).

(2) Applicability: 33 C.F.R. section 183.31.

- (3) Maximum weight capacity: inboard and inboard-out-drive boats: 33 C.F.R. section 183.33.
- (4) Maximum weight capacity: outboard boats: 33 C.F.R. section 183.35.
- (5) Maximum weight capacity: boats rated for manual propulsion and boats rated for motors of two horsepower or less: 33 C.F.R. section 183.37.
- (6) Persons capacity: inboard and inboard-outdrive boats: 33 C.F.R. section 183.39.
- (7) Persons capacity: outboard boats: 33 C.F.R. section 183.41.
- (8) Persons capacity: boats rated for manual propulsion and boats rated for motors of 2 horsepower or less: 33 C.F.R. section 183.43.
 - (9) Applicability: 33 C.F.R. section 183.51.

(10) Horsepower capacity: 33 C.F.R. section 183.53.

- (11) Requirements: 46 C.F.R. section 25.35-1.
- (12) Tanks and engine spaces: 46 C.F.R. section 25.40-1. (Authorized by and implementing K.S.A. 1989 Supp. 32-1119 and K.S.A. 1989 Supp. 32-1126; effective Oct. 22, 1990.)

115-30-7. Boating; pilot rules. (a) Each vessel shall keep to the right of the channel if safe and practicable.

- (b) When two vessels are approaching each other headon or nearly so, each shall pass the other on their own left side at a speed and distance so that the wake of each will not endanger the other.
- (c) When one vessel passes another traveling in the same direction, the passing vessel shall pass when it is safe to do so and at a speed and distance to not endanger the overtaken vessel. The overtaken vessel shall maintain its course and speed until the passing vessel has safely passed.

(d) When two vessels are approaching each other in a crossing situation where risk of collision is involved, the vessel on the right shall maintain its course and speed. The vessel on the left shall direct its course to the right to cross the stern of the other vessel, or stop and reverse if necessary to avoid collision.

(e) Any vessel propelled by machinery shall keep clear of any vessel under sail or being propelled by oars or paddles and shall maintain a speed and distance so that the wake will not endanger any vessel under sail or being propelled by oars or paddles. (Authorized by and implementing K.S.A. 1989 Supp. 32-1119; effective Oct. 22, 1990.)

115-30-8. Boating; accident reports. (a) Any accident report required under K.S.A. 1989 Supp. 32-1177 shall be filed on forms supplied by the department.

- (b) Each accident report shall be filed within five days from the time of the accident, except the accident report shall be filed within 48 hours from the time of the accident if:
 - (1) a death occurs as a result of the accident;
- (2) an injury occurs that requires medical treatment beyond first aid treatment; or

(3) an individual disappears from a vessel.

(c) Any individual with knowledge of the accident, including the reporting officer, may file the required accident report if the operator is unable to file due to injury or death. (Authorized by K.S.A. 1989 Supp. 32-1177; implementing K.S.A. 1989 Supp. 32-1119; effective Oct. 22, 1990.)

Article 15.—AWARD OF RESEARCH GRANTS

112-15-1. Definitions. (a) "Animal health officer" means the individual employed by the commission pursuant to K.S.A. 1989 Supp. 74-8806.

(b) "Commission" means the Kansas racing commission appointed by the governor pursuant to K.S.A. 1989 Supp.

74-8803.

(c) "Executive director" means the individual appointed by the governor pursuant to K.S.A. 1989 Supp. 74-8805.

(d) "Kansas greyhound breeding development fund" means the fund created by K.S.A. 1989 Supp. 74-8831.

(e) "Kansas horse breeding development fund" means the fund created by K.S.A. 1989 Supp. 74-8829.

(f) "Official registering agency" means:

(1) for horses, the agency designated by the commission pursuant to K.S.A. 1989 Supp. 74-8830 (b) and (c);

(2) for greyhounds, the agency designated by the commission pursuant to K.S.A. 1989 Supp. 74-8832 (b) and

(c).

- (g) "Program period" means the period for which each program is funded with monies from the Kansas horse breeding development fund or the Kansas greyhound breeding development fund, normally 12 months (one fiscal year) unless special consideration is requested and approved. (Authorized by K.S.A. 1989 Supp. 74-8804; implementing K.S.A. 1989 Supp. 74-8829 and 74-8831; effective Oct. 22, 1990.)
- 112-15-2. Application deadlines. (a) Applications for grants during the fiscal year ending June 30, 1991 shall be submitted to the executive director on or before November 1, 1990. Applicants demonstrating need to the satisfaction of the grant committee may be granted emergency funding before the November 1 deadline.

(b) Beginning with the fiscal year July 1, 1991 through June 30, 1992, each grant application shall be submitted to the executive director no later than 60 days before the

beginning of each fiscal year.

(c) Applications for receipt of unobligated grant monies remaining in the Kansas horse breeding development fund or the Kansas greyhound breeding development fund after the initial annual grant pursuant to subsections (a) or (b)

may be submitted at any time.

(d) The commission shall solicit grant proposals from interested applicants during the fiscal year ending June 30, 1991 by publishing notice of the application deadlines and procedures in the Kansas register on or before September 1, 1990. Beginning with the fiscal year July 1, 1991 through June 30, 1992, the commission shall solicit grant proposals from interested applicants by publishing notice of the application deadlines and procedures in the Kansas register on or before March 1 of each fiscal year. (Authorized by K.S.A. 1989 Supp. 74-8804; implementing K.S.A. 1989 Supp. 74-8829 and 74-8831; effective Oct. 22, 1990.)

- 112-15-3. Application requirements. (a) Each grant application shall include:
 - (1) a summary cover page;
 - (2) a program narrative;
 - (3) a budget summary;
 - (4) a budget narrative;
 - (5) certified assurances;
 - (6) an audit schedule; and
 - (7) a designation of the applicant's EEO contact.
- (b) Each summary cover page shall provide quick reference to important elements of the grant application.
 - (c) Each program narrative shall address:
 - (1) needs assessment and documentation;
 - (2) program expectations;
 - (3) program methodology;
 - (4) program monitoring and evaluations;
 - (5) audit concerns; and
 - (6) staffing patterns.
- (d) Each grant application shall relate to research conducted within the State of Kansas:

(1) for horses, through institutions of higher education

under the state board of regents; and

- (2) for greyhounds, preferably through institutions of higher education under the state board of regents or in association with such institutions. (Authorized by K.S.A. 1989 Supp. 74-8804; implementing K.S.A. 1989 Supp. 74-8829 and 74-8831; effective Oct. 22, 1990.)
- 112-15-4. Application review. (a) Each grant application shall be evaluated using the following criteria:

(1) the proposal's compliance with K.S.A. 1989 Supp. 74-8829(b)(5) or K.S.A. 1989 Supp. 74-8831(b)(2);

(2) the quality of the needs assessment and documentation in terms of proposed benefits to the horse and greyhound racing industries in Kansas;

(3) the record of successful implementation of research results in the breed industries by this or similar programs;

(4) the degree of breed industry support for the program;

(5) the adequacy of budget information;

- (6) the efficacy of evaluative components, both programmatic and fiscal;
 - (7) any receipt of other financial assistance; and

(8) any other criteria stated by the commission in the

notice published pursuant to K.A.R. 112-15-2(d).

- (b) The executive director may require an applicant to be present during the application review process to provide necessary clarification of the application. (Authorized by K.S.A. 1989 Supp. 74-8804; implementing K.S.A. 1989 Supp. 74-8829 and 74-8831; effective Oct. 22, 1990.)
- 112-15-5. Notification of decision. (a) Each applicant applying for grant funds before the fiscal year ending June 30, 1991 shall be notified in writing of the grant decision on or before December 1, 1990, except each applicant applying for grant funds pursuant to the emergency provisions of subsection (a) of K.A.R. 112-15-2 or pursuant to subsection (c) of K.A.R. 112-15-2 shall be notified not later than 15 days after the date on which the application is reviewed.
- (b) Beginning with the fiscal year July 1, 1991 through June 30, 1992, each applicant shall be notified in writing of the grant decision not later than 30 days after the date on which the application is reviewed, except applicants

applying for grant funds pursuant to subsection (c) of K.A.R. 112-15-2 shall be notified not later than 15 days after the date on which the application is reviewed. (Authorized by K.S.A. 1989 Supp. 74-8804; implementing K.S.A. 1989 Supp. 74-8829 and 74-8831; effective Oct. 22, 1990.)

112-15-6. Reporting requirements. (a) Each grant recipient shall submit to the executive director:

(1) quarterly expenditure reports providing fiscal information on expenditures during the previous three-month period; and

(2) a program narrative report providing a narrative description of program activities during the program period.

(b) Each grant recipient shall submit a quarterly expenditure report within 30 days after the close of each calendar quarter, on March 31, June 30, September 30 and December 31.

(c) Each grant recipient shall submit a program narrative report within 30 days after the close of the fiscal

year.

(d) Each grant recipient shall submit to the executive director a sound research paper summarizing the research program and the results within 90 days after the close of the program period. Each research paper shall be prepared in a form suitable for publication.

(e) Each grant recipient shall submit to the executive director, at least 30 days before actual need, cash draw down reports to request advancement of approved grant

funds.

- (f) Each grant recipient shall maintain program receipts for a period of three years after the close of the program period. (Authorized by K.S.A. 1989 Supp. 74-8804; implementing K.S.A. 1989 Supp. 74-8829 and 74-8831; effective Oct. 22, 1990.)
- 112-15-7. Grant committees. (a) One committee of five persons, designated by the executive director, may assist the commission in determining research awards from the Kansas horse breeding development fund. The grant committee shall have a membership as follows:

(1) One representative of the horse industry;

- (2) one representative of the official registering agency;
- (3) one representative identified by the commission;

(4) the animal health officer; and

- (5) the executive director, who shall chair the committee.
- (b) One committee of five persons, designated by the executive director, may assist the commission in determining research awards from the Kansas greyhound breeding development fund. The grant committee shall have a membership as follows:

(1) One representative of the greyhound industry;

(2) one representative of the official registering agency;

(3) one representative identified by the commission;

(4) the animal health officer; and

(5) the executive director, who shall chair the committee. (Authorized by K.S.A. 1989 Supp. 74-8804; implementing K.S.A. 1989 Supp. 74-8829 and 74-8831; effective Oct. 22, 1990.)

Article 16.—TRAVEL REIMBURSEMENT

1-16-18. Subsistence allowance; rates. (a) General

provisions.

- (1) Except as otherwise specifically provided by law, subsistence allowances for in-state and out-of-state travel shall be paid on the basis of a quarter-day rate for meal expenses and the actual cost of lodging expenses incurred within the lodging expense limits set forth in this regulation. The subsistence rates for meal expenses shall be paid on a per diem basis at the appropriate rate for any fraction of a quarter-day in which the official travel begins and for each full quarter-day thereafter. For purposes of this regulation, a day shall commence at 12:01 a.m. No quarter-day allowance shall be paid for any fractional quarter-day in which the traveler returns to the traveler's official station or domicile. As used in this regulation, "international travel" means travel outside the fifty states and the District of Columbia.
- (2) Reimbursement for lodging shall be made on the basis of actual single-rate lodging expenses incurred, including taxes, and shall be supported by the original official receipt of the lodging place or other suitable evidential matter. Reimbursement for lodging expenses shall be limited to the lodging place's lowest available rate for normal single occupancy on the day or days the lodging expense was incurred.

(3) Subject to the approval of the secretary of administration, the director of accounts and reports may designate any city in a state bordering or near Kansas as a "border city." All meals allowances and lodging expense limitations shall be at the appropriate in-state rate for travel by state personnel to a border city.

(b) Meals allowance. The quarter-day meals allowance

shall be:

The provisions of paragraph (4) and (5) shall take effect
