State Boards, Commissions and Authorities—State Lottery—Kansas Lottery Act; Kansas Lottery Commission, Powers. Gerald F. Simpson, Executive Director, Kansas Lottery, January 31, 1991.

The Kansas lottery act does not authorize the commission to enter into an agreement to form or participate in a corporation which controls the lottery games through rules and regulations promulgated by the corporation's board of directors. Cited herein: K.S.A. 1990 Supp. 74-8709(g). MWS

**Opinion No. 91-9**

Counties and County Officers—Public Improvements; Improvement and Service Districts—Improvement Districts; Powers; Commodity Program Facility; Public Park. David L. Hiebert, Counsel for Oaklawn Improvement District, Wichita, February 4, 1991.

Improvement districts created pursuant to K.S.A. 19-2753 *et seq.* have been authorized by K.S.A. 19-2765(a)(4) to "... plan and construct or purchase public works and improvements for public health, recreation, convenience or welfare within the limits of the improvement district..." and thus, may take such actions if the governing body determines that such a necessity exists. Construction and maintenance of a public commodity program distribution facility or a public recreation area may meet the definition of a public work or improvement in certain situations, and improvement district funds may be expended for such purposes if the levy utilized to obtain such funds does not otherwise limit or prohibit expenditures for such purposes. Cited herein: K.S.A. 19-2752a; 19-2753; 19-2765. TMN

## Advisory Opinion No. 91-1

Written January 16, 1991, to Thomas H. Hull, State Director, Kansas Small Business Development Centers, Wichita State University.

This opinion considers issues not addressed in Opinion No. 90-27. Here, we will take up the question of what law, if any, applies to Kansas Small Business Development Center agents who are not with Board of Regents' institutions. We understand there to be three types of these agents: employees of community colleges, employees of Washburn University, and employees of private colleges.

We first note that none of these employees are covered by K.S.A. 46-215 *et seq.* since they do not meet the definition of a "state officer or employee" contained in K.S.A. 46-221.

Thus, we turn to the applicability of the local level conflicts law set out in K.S.A. 75-4301 *et seq.* as amended by the 1990 Session Laws of Kansas, Chapter 306, Sections 14-19.

Under Section 14(f) of the Session Laws, the community colleges constitute "governmental subdivisions" since they are subdivisions of the state having authority to service public funds. Thus, employees of community colleges are covered by K.S.A. 75-4301 *et seq.*

Under Section 14(c) & (d), employees of Washburn University are included within the local conflicts act since Washburn is an agency of the city of Topeka.

We find no basis to include employees of private institutions within the local act and therefore none of the state's conflict of interests laws under our jurisdiction apply to such persons.

Turning then to your specific questions, the local law in K.S.A. 75-4304 also prohibits local officials from participating in the making of contracts with their own private businesses.

The local law does not, however, deal with the last three situations you raise, except that under appropriate circumstances a local official may be required to file a disclosure statement if he or she is going to take official action which might affect a private interest.

## Advisory Opinion No. 91-2

Written January 16, 1991, to all interested persons:

Effective July 1, 1989, the Campaign Finance Act applies to candidates for elected county and first class city office. The Campaign Finance Act requires a report on January 10, 1991, for the preceding calendar year.

The question we wish to address is whether first class city or county elected officials who have not announced or otherwise become a candidate since July 1, 1989, are required to file the January 10, 1991, report.

It is our opinion that only "candidates" are required to file the report. Thus, those elected county or city officials who have not sought office since July 1, 1989, need not file the January 10, 1991, Receipts and Expenditures Report.

## Advisory Opinion No. 91-3

Written January 16, 1991, to Claire K. McCurdy, Topeka.

This opinion is in response to your letter of January 7, 1991, in which you request an opinion from the Kansas Public Disclosure Commission concerning the conflict of interest law (K.S.A. 46-215 *et seq.*)

We understand you request this opinion in your capacity as an employee of the Kansas Department of Transportation.

You advise us that you are slated to become president of the board of directors of Sheltered Living, Inc. later this month at that organization's annual meeting. At the same time, you are employed as an attorney for the Kansas Department of Transportation. In looking through some papers and reviewing Sheltered Living's budget for the coming year, you realized that Sheltered Living periodically receives vans purchased from KDOT for use in its programs. For example, in 1990 Sheltered Living received 1.8 percent of its funding from KDOT in the form of two vehicles.

You also state that you are in no way involved in the decision making process within KDOT regarding which organizations receive vehicles. In fact, you do not even know who is involved. Moreover, Sheltered Living has been receiving such grants from KDOT long before you began serving on the organization's board of directors, and even longer before you began your employment with KDOT.

You ask whether it is permissible for you to be pres-

ident of the board of Sheltered Living, Inc. during your service as a state officer or employee.

Two sections of the act relate to your question—K.S.A. 46-233 and 46-286. Very simply put, so long as you do not participate in your capacity as a state officer or employee in the making of contracts with Sheltered Living, Inc., or in licensing, regulating or inspecting the entity, the situation you have described is permissible.

**Advisory Opinion No. 91-4**

Written January 16, 1991, to Elizabeth Baker, State Representative, Derby.

This opinion is in response to your letter of December 4, 1990, in which you request an opinion from the Kansas Public Disclosure Commission concerning the conflict of interest law (K.S.A. 46-215 *et seq.*).

We understand you request this opinion in your capacity as a state representative. You advise us that you have recently been appointed to the Wichita State University Board of Trustees and that each board member is provided season tickets for Shocker basketball games.

You ask whether you may serve on the board while you are a state legislator and whether you may accept the tickets.

We have reviewed K.S.A. 46-215 *et seq.* in its entirety and find no prohibitions restricting a legislator from also serving on the board. The ticket issue is a closer question.

K.S.A. 46-237(a) states:

“No state officer or employee or candidate for state office shall accept, or agree to accept any economic opportunity, gift, loan, gratuity, special discount, favor, hospitality, or service having an aggregate value of \$100 or more in any calendar year from any one person known to have a special interest, under circumstances where such person knows or should know that a major purpose of the donor is to influence such person in the performance of their official duties or prospective official duties.”

In this case, since all members of the Board of Trustees receive the tickets, we cannot assume they are being given to you to influence the performance of your official duties as a legislator. Thus, we cannot hold that the receipt of tickets under these special circumstances would violate K.S.A. 46-215 *et seq.*

We also note that your position as a member of the Wichita State University Board of Trustees is specifically exempted from the definition of state officer or employee since you do not receive compensation for serving in that position (see K.S.A. 46-221(a)(4)). Thus, K.S.A. 46-215 *et seq.* does not apply to the receipt of tickets in your capacity on the Board of Trustees.

HB 2085, by Representative O'Neal: An act relating to schools; concerning the participation of students in extracurricular activities.

HB 2086, by Committee on Appropriations: An act making and concerning appropriations for the fiscal year ending June 30, 1992, for Fort Hays state university, Kansas state university, Kansas state university veterinary medical center, Emporia state university, Pittsburg state university, university of Kansas, university of Kansas medical center, Wichita state university, state board of regents and Kansas state university — Salina, college of technology; authorizing certain transfers, imposing certain restrictions and limitations, and directing or authorizing certain receipts and disbursements and acts incidental to the foregoing.

HB 2087, by Committee on Labor and Industry: An act concerning workers compensation; relating to certain definitions; amending K.S.A. 1990 Supp. 44-508 and repealing the existing section.

HB 2088, by Committee on Energy and Natural Resources: An act concerning radioactive materials; relating to storage, treatment, recycling and disposal thereof.

HB 2089, by Representative Patrick: An act concerning social welfare; establishing a program of special financial assistance grants to certain public assistance recipients who implant certain long-lasting contraceptives; prescribing powers, duties and functions for the secretary of social and rehabilitation services.

HB 2090, by Representatives Everhart, Gomez, Hensley, McKechnie, Wagnon and Whitemann: An act relating to school transportation vehicles; requiring passenger safety restraining systems.

HB 2091, by Representatives King and Shallenburger: An act amending and supplementing the Kansas consumer protection act; providing for the regulation of health spas; establishing certain requirements and prohibitions; prescribing certain penalties; amending K.S.A. 50-624 and repealing the existing section.

HB 2092, by Committee on Pensions, Investments and Benefits: An act concerning the Kansas public employees retirement system; relating to participating service; amending K.S.A. 1990 Supp. 74-4915 and repealing the existing section.

HB 2093, by Committee on Pensions, Investments and Benefits: An act concerning the Kansas public employees retirement system; relating to postretirement benefit increase.

HB 2094, by Committee on Pensions, Investments and Benefits: An act concerning the Kansas public employees retirement system; relating to lump-sum death benefit; amending K.S.A. 1990 Supp. 74-4989 and repealing the existing section.

#### Notice to Consulting Engineers

The Kansas Department of Transportation is seeking qualified consulting engineering firms for the following three packages of projects. Responses must be received by February 28 for any or all projects for which the consultant engineering firm wishes to be considered. Seven signed copies of responses need to be mailed to Al Cathcart, P.E., Project Control Engineer, Office of Engineering Support, K.D.O.T., 7th Floor, Docking State Office Building, Topeka 66612.

All projects will require surveys to be completed by the consulting engineering firm. Items such as traffic control signing, seeding and erosion control, pavement marking, lighting, right of way procurement activities, geology, permit development, utility and railroad agreement efforts may require consultant firm involvement. Information on these as well as other activities that will be performed by either K.D.O.T. or the consultant will be established and furnished to the consulting engineering firms who are short listed by the K.D.O.T. selection committee prior to interview by the K.D.O.T. negotiating committee.

#### Package #1

**Rush**—96-83 K-4352-01 (FY 95)—Rehabilitate roadway from the end of the four lane section in Rush Center east to the Rush/Barton county line, a length of 15 miles. Rehabilitation includes cold milling, hot recycling, shoulder widening, adding acceleration/deceleration lanes at major crossroads, widening and guard fence on bridge 040, and replacement of bridges 037, 038, and 039 in the Walnut Creek basin. Estimated cost is \$13.8 million.

#### Package #2

**Jefferson**—2-44 K-437-01 (FY 95)—Reconstruct K-92 from 2.1 miles east of FAS-328 east to the curb and gutter section in Oskaloosa, a length of 4.3 miles. Reconstruction is based on a 40-foot roadway with 8-foot

shoulders, extension of culverts, and addition of acceleration/deceleration lanes at major crossroads. Bridge 027 over Big Slough Creek is to be replaced. Estimated cost is \$8.2 million.

#### Package #3

**Montgomery**—160-63 K-3316-01 (FY 95)—**Montgomery**—160-63 K-4372-01 (FY 95) and **Labette**—169-50 K-4353-01 (FY 95)—These projects are for roadway reconstruction from the south junction of U.S. 160/U.S. 169 north on U.S. 169 to the Labette/Neosho county line, a distance of approximately 12.5 miles. The reconstruction is based on a 44-foot roadway with 10-foot paved shoulders. From the south junction of U.S. 160/U.S. 169 to the north junction of U.S. 160/U.S. 169 the authorization allows for reconstruction of an offset alignment if necessary. A Cherryvale bypass also is to be studied and considered. Acceleration/deceleration lanes at major crossroads are to be included as warranted. Culverts are to be extended as required. Guard fence is to be updated. Replace bridges, 027, 028, 039 and add four new bridges as required to complete the project. Signing also is to be included in the project. Total cost for these three projects is approximately \$22 million.

Firms expressing interest in these projects must respond in writing and complete the Consulting Engineers Qualification Questionnaire (if not already prequalified) by February 28.

It is the policy of K.D.O.T. to use the following criteria as the basis for selection of engineering consulting firms:

1. Size and professional qualification of firm.
2. Experience of staff.
3. Location of firm with respect to proposed project.
4. Work load of firm.
5. Firm's performance record.

## Article 53.—CHARITABLE HEALTH CARE

**28-53-1. Definitions.** (a) "Agreement" means a written understanding between the department and a charitable health care provider regarding the rendering of professional services to medically indigent persons.

(b) "Department" means the Kansas department of health and environment.

(c) "Federally qualified health center" means a center which meets the requirements for federal funding under 42 USC section 1396d(1) of the public health service act, and which has been designated as a "federally qualified health center" by the federal government.

(d) "Indigent health care clinic" means an outpatient medical care clinic designed to provide care to the medically indigent under the medical direction of a qualified physician licensed by the Kansas board of healing arts.

(e) "Local health department" means county, city-county and multi-county public health units established under the authority of K.S.A. 65-201.

(f) "Secretary" means the secretary of the Kansas department of health and environment. (Authorized by and implementing L. 1990, Ch. 329, sec. 1; effective April 1, 1991.)

**28-53-2. Agreement.** (a) Each person applying for an agreement shall submit a completed application to the department on forms prescribed by the secretary.

(b) Each applicant for renewal of an agreement shall submit a completed application annually to the department on forms prescribed by the secretary.

(c) An agreement may be terminated by the secretary or the charitable provider with 30 days advanced written notice to the department. Failure of the provider to maintain proper licensure by the appropriate professional licensing agency shall constitute immediate cancellation of the agreement. (Authorized by and implementing L. 1990, Ch. 329, sec. 1; effective April 1, 1991.)

**28-53-3. Eligibility criteria for medically indigent.** Persons shall qualify as medically indigent if they are:

(a) determined to be a member of a family unit earning at or below 200% of poverty income guidelines based on the annual update of "poverty income guidelines" published in the federal register by the United States department of health and human services;

(b) not indemnified against costs arising from medical and hospital care by a policy of accident and sickness insurance, an employee health benefits plan, a program administered by the state or federal government, or any such coverage; and

(c) seek health care at:

(1) an indigent health care clinic;

(2) a federally qualified health center; or

(3) a participating local health department.

(Authorized by and implementing L. 1990, Ch. 329, sec. 1; effective April 1, 1991.)

**28-53-4. Records and Reports.** (a) Charitable health care providers shall ensure that the clinics through which they provide care shall:

(1) maintain completed forms prescribed by the secretary and signed by the patient which certify that the individual receiving care pursuant to an agreement is medically indigent; and

(2) submit completed quarterly activity reports to the department on forms prescribed by the secretary.

(b) Failure to comply with the requirements of this section shall be grounds for cancellation of the agreement. (Authorized by and implementing L. 1990, Ch. 329, sec. 1; effective April 1, 1991.)

**28-53-5. Referrals.** Medically indigent persons may receive professional services from health care providers in other locations upon referral from a federally qualified health center, an indigent health care clinic, or a participating local health department. Any such referrals shall be reflected in the records of the referring entity. (Authorized by and implementing L. 1990, Ch. 329, sec. 1; effective April 1, 1991.)

## Article 2.—LOTTERY RETAILERS

**111-2-16. KENO Dream Month Drawing Retailer Incentive.** (a) In addition to compensation provided for in K.A.R. 111-2-4, the Kansas lottery shall also offer the "KENO Dream Month Drawing" retailer incentive promotion. It will be held in conjunction with the Kansas Lottery's "KENO Dream Month Drawing" (K.A.R. 111-7-55 through 111-7-63) as follows:

(b) All 28 non-winning tickets drawn during the "KENO Dream Month Drawing" will be placed into the drum after the final drawing on February 28, 1991. One ticket will be drawn from the 28 non-winning tickets selected during the Keno Dream Month Drawing pursuant to K.A.R. 111-7-55 et seq. and K.A.R. 111-6-1. The retailer who sold the non-winning ticket selected shall win the grand prize consisting of a four-day vacation provided by WDAF-AM of Kansas City, MO, at Club Med on Paradise Island in the Caribbean.

(c) In addition, each retailer who sold any of the 28 tickets drawn shall receive a \$100 bonus from the Lottery. (Authorized and implementing K.S.A. 1989 Supp. 74-8710(h); effective T-111-2-1-91, Jan. 18, 1991.)

**Article 4.—INDIVIDUAL GAME RULES**

**RULES FOR INSTANT GAME NO. 30**

**"JACKPOT"**

**111-4-245. Name of Game.** The Kansas lottery shall conduct an instant winner lottery game entitled "Jackpot" commencing on February 21, 1991. The specific rules for the "Jackpot" instant game are contained in K.A.R. 111-3-1 *et seq.* and 111-4-245 through 111-4-248. (Authorized by and implementing K.S.A. 1989 Supp. 74-8710; effective, T-111-2-1-91, Jan. 18, 1991.)

**111-4-246. Definitions (Instant Tickets).** The following definitions shall apply to the "Jackpot" instant lottery game:

(a) "Game Symbols" are the numbers, letters, symbols or pictures printed in the play area of each instant game ticket which determine if the ticket bearer is entitled to a prize. In this instant game, the game symbols are printed in black ink in 15 pt. Archer. A game symbol appears in each of the nine play spots within the game area. Each game symbol in the play area for this instant game is a drawing of one of the following: a gold bar, a pot of gold, a bell, a star, a melon, and a bunch of cherries.

(b) "Game symbol captions" are the words, portions of words, letters or numbers printed beneath each game symbol in the play area and are used to repeat or explain the game symbol. The game symbol caption associated with each game symbol is as follows:

Game Symbol	Game Symbol Caption
cherries	CHER
melon	MELON
bell	BELL
gold bar	BAR
star	STAR
pot of gold	GOLD

(c) "Ticket validation number" means a unique number appearing on each ticket which is used to validate winning tickets. For this instant game, the ticket validation number is a 10-digit number which appears on the front of each instant ticket and will be covered by latex.

(d) "Book-ticket number" means the unique number appearing on each ticket which includes the number of the book from which it was removed and the serially assigned number of the ticket within that book. For this instant game, the book-ticket number is an 8-digit book number followed by a dash and then a 3-digit ticket number. The ticket numbers in each book start with 000 and end with 299. The book-ticket number is printed in black ink on the bottom right portion of the front of each instant game ticket.

(e) "Retailer validation code" means the small letters found under removable covering in the play area of each instant game ticket. The retailer uses this code to verify and validate winners which are to be paid by the retailer. In this instant game, the retailer validation code is a two letter code printed and appearing in two of six varying locations among the game symbols. The codes and their meanings are as follows: AA = free ticket; QQ = 2 free tickets; DD = \$2.00; JJ = \$4.00; MM = \$7.00; PP = \$9.00; LL = \$14.00; SS =

\$21.00. (Authorized by and implementing K.S.A. 1989 Supp. 74-8710; effective, T-111-2-1-91, Jan. 18, 1991.)

**111-4-247. Determination of Instant Prize Winners.** An instant prize winner is determined for this instant game when the player removes or "scratches off" the removable layer of material covering the play area to reveal the nine game symbols and captions. Prizes a player may win are as follows:

3—Melons	\$ 2.00
3—Melons (twice)	\$ 4.00

3—Gold	\$400.00

Each ticket will feature a play style of three (3) symbols in a row. Each ticket will contain three (3) games identified as Game 1, Game 2 and Game 3. If a player matches 3 like symbols in any horizontal row, the player wins the prize associated with that symbol. Symbols in one "game" relate to that "game" only and not to either of the other two "games." A player can win more than once on a single ticket but not more than twice. (Authorized by K.S.A. 1989 Supp. 74-8710(b)&(c); implementing K.S.A. 1989 Supp. 74-8710(b)&(c) and 74-8720; effective, T-111-2-1-91, Jan. 18, 1991.)

**111-4-248. Number and Value of Instant Prizes.**

(a) There will be approximately 3,600,000 tickets ordered for this instant game. The expected number and value of the instant prizes are as follows:

(b) The executive director may terminate the sale of tickets prior to the complete sale of all tickets. In this event, the number and value of prizes will be approximately proportional to the number of tickets actually sold.

(c) All prizes are subject to deductions provided by law. (Authorized by K.S.A. 1989 Supp. 74-8710(b), (c) & (f); implementing 74-8710(b), (c) & (f); and 74-8720; effective, T-111-2-1-91, Jan. 18, 1991.)

## Article 7.—CASH LOTTO GAME RULES

## KENO DREAM MONTH DRAWINGS

**111-7-55. Name of Drawing.** The Kansas lottery shall conduct a series of cash drawings entitled "KENO Dream Month Drawings." The drawings will commence on Friday, February 1, 1991, and end on Thursday, February 28, 1991. Drawings shall be held daily, Monday through Friday, at 2:00 p.m. at lottery headquarters. The specific rules for "KENO Dream Month Drawings" are contained in K.A.R. 111-7-55 through 111-7-63, and K.A.R. 111-6-1 *et seq.* (Authorized by and implementing K.S.A. 1989 Supp. 74-8710, effective, T-111-2-1-91, Jan. 18, 1991.)

**111-7-56. Method of Entry.** Entry into the "KENO Dream Month Drawing," is accomplished by the following steps:

(a) Obtain a valid Kansas KENO game lottery ticket purchased on or after January 16, 1991;

(b) Determine if the ticket is a winning ticket in accordance with KENO game rules. If the ticket is a winning ticket, it is not eligible for the "KENO Dream Month Drawing" and shall be redeemed in accordance with the appropriate game rules;

(c) If the ticket is a non-winning ticket, the ticket is eligible for winning the drawing, and the holder of the ticket may enter the "KENO Dream Month Drawing." If the ticket is a multi-draw ticket containing a non-winning set of numbers for any drawing on the ticket, the ticket is valid for the "KENO Dream Month Drawing" only;

(d) The holder of the non-winning ticket must complete the information form on the back of the ticket in a legible manner;

(e) Place the ticket(s) into an envelope and mail them to: KENO Dream Month, Kansas lottery; 128 N. Kansas Ave., Topeka, KS 66603, or tickets may be deposited in a collection box located in the Topeka regional office located at the same address.

(f) There is no limit on the number of entries a person may make.

(g) Any non-winning valid KENO game lottery tickets received at lottery headquarters after 1:00 p.m., February 28, 1991 will not be eligible for entry into the "KENO Dream Month Drawing." (Authorized by and implementing K.S.A. 1989 Supp. 74-8710; effective, T-111-2-1-91, Jan. 18, 1991.)

**111-7-57. Certification of Daily "KENO Dream Month Drawing."** (a) All drawings except as provided in K.A.R. 111-6-1, *et seq.*, shall be personally observed by a member of the Kansas lottery division of security designated by the executive director and by an auditor.

(b) The executive director or the senior lottery official present shall designate a lottery staff person to serve as an auditor to perform the necessary services.

(c) Upon completion of the drawing, the designated Kansas lottery security person and the auditor shall issue a report to the executive director, certifying that the name of the prize winner is correct, and that to the best of their knowledge the procedures required by these rules were followed in selecting the prize

winner. (Authorized by and implementing K.S.A. 1989 Supp. 74-8710(b); effective, T-111-2-1-91, Jan. 18, 1991.)

**111-7-58. Selection of KENO Dream Month Winners.** The following process shall be used for the selection of winners in the daily "KENO Dream Month Drawing":

(a) Kansas lottery mail room personnel shall pick up all mail containing "KENO Dream Month Drawing" envelopes at the Topeka United State Post Office on a daily basis.

(b) The mail room personnel shall transport the mail to the mail room where the envelopes will be opened and the tickets placed in a receptacle to be held until taken by lottery security personnel and deposited in the drum on a daily basis prior to 2:00 p.m. lottery security will transfer tickets from the receptacle located in the Topeka regional office to the warehouse before 2:00 p.m. Monday through Friday for the daily 2:00 p.m. drawing. Following each deposit of tickets in the drum, the security person making the deposit shall reseal the drum.

(c) The selection process shall be held at 2 p.m. daily, Monday through Friday. The first drawing will be held on Friday February 1, 1991, and the last on the Thursday February 28, 1991. All drawings shall be held in a place accessible to the public and be open for public attendance and with lottery security personnel present. All drawings shall be audio and videotaped.

(d) Drawings for the previous Saturday and Sunday will be held on the following Monday.

(e) Prior to the drawing the drum shall be sealed and the contents mixed by rotating the drum ten (10) times.

(f) The designated individual shall then unseal the drum, and using the bare-arm technique, remove one (1) "KENO" ticket from the drum.

(g) The designated Kansas lottery security official shall review the ticket to determine if it is eligible for the "KENO Dream Month Draw" in accordance with this regulation.

(h) If the ticket is determined to be ineligible, the ticket removed shall be discarded, the drum resealed, and another ticket removed. This procedure will be repeated until a valid selection is obtained from the drum.

(i) The person whose name appears on the back of the ticket drawn shall win \$1,000, subject to validation by the lottery as set forth in these rules.

(j) All "KENO Dream Month Drawing" tickets remained in the drum on February 28, 1991, after all valid winners have been selected shall be destroyed. (Authorized by and implementing K.S.A. 1989 Supp. 74-8710(b); effective, T-111-2-1-91, Jan. 18, 1991.)

**111-7-59. Winner Validation.** The following validation requirements shall apply to the "KENO Dream Month Drawing";

(a) Each "KENO Dream Month Drawing" envelope must contain valid non-winning Kansas KENO game lottery tickets;

(continued)

(b) The information form on the back of the ticket must be filled out in a legible manner.

(c) Each ticket must have been issued by the Kansas lottery in an authorized manner and must not be counterfeit in whole or in part;

(d) Each ticket must be complete and intact and not mutilated, altered, unreadable, reconstructed, or tampered with in any way;

(e) Each ticket must not be blank or partially blank, misregistered, defective, or printed or produced in error;

(f) Each ticket must not be stolen nor appear on any list of omitted tickets on file at the Kansas lottery;

(g) Each ticket must be fully legible, and be exactly as described in paragraph (d) above.

(h) The ticket validation number of the tickets shall not appear on the Kansas lottery's official list of ticket validation numbers of winning tickets.

(i) Any ticket not passing all the validation checks in this section is void and is not eligible for the "KENO Dream Month Drawing."

(Authorized by and implementing K.S.A. 1989 Supp. 74-8710(b); effective, T-111-2-1-91, Jan. 18, 1991.)

**111-7-60. Security of Equipment.** The drum shall be stored in a locked secure area at all times when not in use. Keys to the secure area shall be under the exclusive control of the Kansas lottery division of security. Prior to use, the drum shall be inspected by an auditor and by the Kansas lottery division of security to ensure it has not been tampered with and is in good working order. (Authorized by and implementing K.S.A. 1989 Supp. 74-8710(b)&(d); effective, T-111-21-91, Jan. 18, 1991.)

**111-7-61. Rights of Participants.** Any non-winning Kansas KENO game lottery ticket entered into the "KENO Dream Month Drawing" is disqualified from any other Kansas lottery prize or eligibility that ticket may have been redeemable for. (Authorized by and implementing K.S.A. 1989 Supp. 74-8710(d); effective, T-111-2-1-91, Jan. 18, 1991.)

**111-7-62. Awarding of Prizes.** The executive director or his designee shall award the designated prize to the appropriate person as soon as it is determined that all laws, regulations, and rules have been adhered to. (Authorized by and implementing K.S.A. 1989 Supp. 8710(c), and 74-8720(b); effective, T-111-2-1-91, Jan. 18, 1991.)

**111-7-63. Invalidation of Tickets.** No KENO ticket remains valid for this drawing after the drawing on February 28, 1991. (Authorized by and implementing K.S.A. 1989 Supp. 74-8710(c) and (i); effective, T-111-2-1-91, Jan. 18, 1991.)

SENATE BILL No. 36

AN ACT concerning the department of corrections; relating to certain capital improvement projects and financing therefor; making appropriations for such purposes for the fiscal year ending June 30, 1991; amending K.S.A. 75-52,130 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

HUTCHINSON CORRECTIONAL FACILITY

(a) On the effective date of this act, of the amount reappropriated for the above agency for the fiscal year ending June 30, 1991, by section 31 of chapter 23 of the 1990 Session Laws of Kansas from the correctional institutions building fund in the replace locking systems in A, B and C cellhouses account, the sum of \$600,000 is hereby lapsed.

Sec. 4. K.S.A. 75-52,130 is hereby amended to read as follows: 75-52,130. (a) To provide for any amounts required to be paid for all or part of the cost of the capital improvement projects for a new correctional facility and a mental health facility or facilities authorized by this act and expenses related thereto, the pooled money investment board is authorized and directed to loan to the secretary of corrections sufficient funds therefor in amounts which in the aggregate do not exceed ~~\$25,000,000~~ \$26,850,000. All such amounts of such loan shall be credited to the new correctional facility and mental health facility or facilities—construction fund which is hereby created in the state treasury. The pooled money investment board is authorized and directed to use any moneys in the active accounts, inactive accounts or time deposits, open accounts, of the state of Kansas to provide the funds for such loan.

(b) Such loan shall bear interest from the date of the loan transfer or transfers under this section at an annual rate of interest which shall be at a rate equal to the rate prescribed by K.S.A. 75-4210, and amendments thereto, for inactive accounts of the state effective on January 1 of such year. Such loan shall not be deemed to be an indebtedness or debt of the state of Kansas within the meaning of section 6 of article 11 of the constitution of the state of Kansas.

(c) The secretary of corrections may periodically certify to the pooled money investment board amounts to be transferred pursuant to this subsection. Upon certification to the pooled money investment board by the secretary of corrections of the amounts of the loan authorized by subsection (a), the pooled money investment board shall transfer amounts certified by the secretary of corrections from the state bank accounts described in subsection (a) to the new correctional facility and mental health facility or facilities—construction fund which in the aggregate do not exceed the amount specified in subsection (a).

(d) Subject to the limitations of this section, the secretary of corrections shall determine and certify to the pooled money investment board, on or before the date of the first certification pursuant to subsection (c), the terms and conditions of repayment of the principal and interest of such loan amounts. Commencing in calendar year 1990, the principal and interest of such loan amounts shall be repaid in payments payable at least annually for a period of not more than 25 years. The repayment amounts shall be recomputed each year to reflect the interest rate prescribed and shall be calculated each year on a substantially level payment basis based on a total original amortization period of 25 years.

(e) ~~The amount of the loan authorized under this section is subject to reduction by act of the legislature prior to February 1, 1990.~~

Sec. 5. K.S.A. 75-52,130 is hereby repealed.

Sec. 6. This act shall take effect and be in force from and after its publication in the Kansas register.

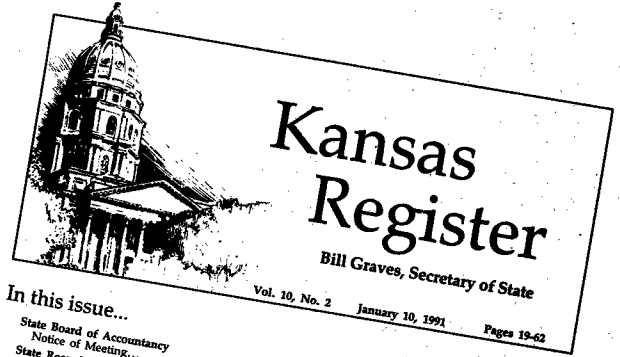
