Public Notice

This notice is given pursuant to the Memorandum and Order entered on December 31, 1990, and the Memorandum and Order entered on January 14, 1991, by the United States District Court for the District of Kansas in Case Number 90-4207-S and 42 CFR 447.205. By compulsion of those orders, changes in methods and standards for setting Medicaid nursing facility payment rates for Kansas Medicaid Services include the following provisions:

First, the rate freeze will be lifted, effective January 1, 1991. Cost reports will be used to determine new rates for the providers. Cost reports that were submitted and ordinarily would have been used to establish November 1 and December 1, 1990, rates will be used to establish rates effective January 1, 1991. Cost reports received that would determine a new payment rate on January 1, 1991, or after will be used to determine the new rates on the appropriate rate effective date.

Second, the estimated inflation factor will be increased from 4.8 percent to 6 percent. The 6 percent factor will be used to determine the revised upper limits for January 1, 1991, and the facility specific payment rates beginning January 1, 1991.

Third, the agency will pay the full cost of a registered nurse or licensed practical nurse who is hired to meet the 24-hour nursing requirement. If a provider has one shift covered and hires nurses to cover an additional shift, the agency will provide a pass-through reimbursement factor. In other words, a facility will not have to be in complete compliance (i.e., 24-hour coverage, seven days a week) to receive the additional pass-through factor.

Fourth, and last, a facility specific minimum wage pass-through will be implemented. This pass-through reimbursement will not be held to cost center limits. It will be available to providers who incur additional costs to meet the minimum wage requirements on April 1, 1990, and April 1, 1991. The pass-through factor will be effective on January 1, 1991. Providers will only receive the additional reimbursement after they have documented the costs incurred to meet minimum wage requirements.

Although the estimated inflation factor has increased from 4.8 percent to 6 percent, recognizing cost reports as they are submitted will reduce the length of time providers will receive payments based on their previous cost reports. Since inflation is calculated to the mid-point of a payment period, some providers may, initially, receive a lower rate. This rate decrease could be offset by the pass-through for 24-hour nursing, minimum wage and social workers (for affected facilities). Providers will receive increased rates on subsequent payment schedules if supported by their cost data.

The data used and to be used in establishing the rates is available from the General Services Commission, Nursing Facility Reimbursement, 6th Floor, Docking State Office Building, 915 S.W. Harrison, Topeka

66612-1570, in accordance with the open public records procedures of K.S.A. Chapter 45, Article 2.

The expected estimated total annual aggregate increase in expenditures is \$12.6 million.

The Kansas Department of Transportation is seeking qualified consulting engineering firms for the following three packages of projects. Responses must be received by February 28 for any or all projects for which the consultant engineering firm wishes to be considered. Seven signed copies of responses need to be mailed to Al Cathcart, P.E., Project Control Engineer, Office of Engineering Support, K.D.O.T., 7th Floor, Docking State Office Building, Topeka 66612.

All projects will require surveys to be completed by the consulting engineering firm. Items such as traffic control signing, seeding and erosion control, pavement marking, lighting, right of way procurement activities, geology, permit development, utility and railroad agreement efforts may require consultant firm involvement. Information on these as well as other activities that will be performed by either K.D.O.T. or the consultant will be established and furnished to the consulting engineering firms who are short listed by the

K.D.O.T. selection committee prior to interview by the K.D.O.T. negotiating committee.

**Package #1**

**Rush**—96-83 K-4352-01 (FY 95)—Rehabilitate roadway from the end of the four lane section in Rush Center east to the Rush/Barton county line, a length of 15 miles. Rehabilitation includes cold milling, hot recycling, shoulder widening, adding acceleration/deceleration lanes at major crossroads, widening and guard fence on bridge 040, and replacement of bridges 037, 038, and 039 in the Walnut Creek basin. Estimated cost is \$13.8 million.

**Package #2**

**Jefferson**—2-44 K-437-01 (FY 95)—Reconstruct K-92 from 2.1 miles east of FAS-328 east to the curb and gutter section in Oskaloosa, a length of 4.3 miles. Reconstruction is based on a 40-foot roadway with 8-foot shoulders, extension of culverts, and addition of acceleration/deceleration lanes at major crossroads. Bridge 027 over Big Slough Creek is to be replaced. Estimated cost is \$8.2 million.

**Package #3**

**Montgomery**—160-63 K-3316-01 (FY 95)—**Montgomery**—160-63 K-4372-01 (FY 95) and **Labette**—169-50 K-4353-01 (FY 95)—These projects are for roadway reconstruction from the south junction of U.S. 160/U.S. 169 north on U.S. 169 to the Labette/Neosho county line, a distance of approximately 12.5 miles. The reconstruction is based on a 44-foot roadway with 10-foot paved shoulders. From the south junction of U.S. 160/U.S. 169 to the north junction of U.S. 160/U.S. 169 the authorization allows for reconstruction of an offset alignment if necessary. A Cherryvale bypass also is to be studied and considered. Acceleration/deceleration lanes at major crossroads are to be included as warranted. Culverts are to be extended as required. Guard fence is to be updated. Replace bridges, 027, 028, 039 and add four new bridges as required to complete the project. Signing also is to be included in the project. Total cost for these three projects is approximately \$22 million.

Firms expressing interest in these projects must respond in writing and complete the Consulting Engineers Qualification Questionnaire (if not already prequalified) by February 28.

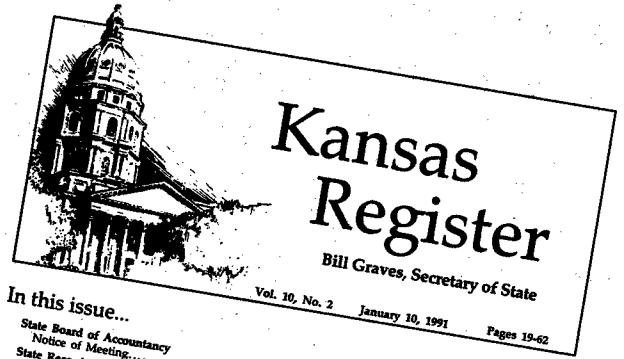
