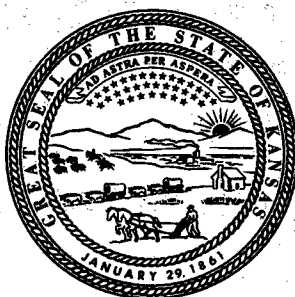

**Notice of Hearing on Proposed Traffic Regulations at Fort Hays State University**

Public hearings will be conducted at 2:30 p.m. Friday, April 5, and 1:30 p.m. Wednesday, April 10, in the Prairie Room of the Memorial Union, Fort Hays State University campus, Hays, concerning the adoption by the Board of Regents of regulations governing traffic and parking on the roads, streets, driveways, and parking facilities at Fort Hays State University.

The following is a summary of the major changes in the 1991-1992 traffic and parking rules:

- 1) All Zone-1 parking permits (both car and motorcycles) will cost \$20 annually. The main impact of this change is on the purchase of motorcycle permits. The cost of a motorcycle permit will increase from \$15 to \$20. The cost of an automobile permit remains the same. Justification for this change is based on location, not on type of vehicle.
- 2) Cost of replacement permits (for a lost or stolen permit) will increase from \$1 to \$5. Justification for increase is based on the administrative costs of issuing an increasing number of lost permits.
- 3) Item #7 under the category VIOLATIONS has been reworded and a new item, #11, has been added that reads: Motorcycles and mopeds parked in a stall other than a stall marked cycle. Justification is based on the need to add clarity to the user's understanding of campus traffic regulations.

Interested persons will be given a reasonable opportunity at the hearings to present their views regarding the adoption of the proposed changes to the existing regulations. Written comments or a request for a copy of the proposed regulations and a copy of the financial impact statement should be submitted to John Huber, Hearing Officer, Traffic and Parking Regulations, Room 238, Malloy Hall, Fort Hays State University, 600 Park St., Hays 67601.

## Notice of Hearing on Proposed Traffic Regulations at Pittsburg State University

A public hearing will be conducted at 4:30 p.m. Thursday, April 18, at the Overman Student Center, Pittsburg State University, Pittsburg, concerning the adoption by the Board of Regents of regulations governing traffic and parking on the roads, streets, driveways and parking facilities at Pittsburg State University. The following is a summary of the substance of the rules and proposed changes.

**I. Authority**—The University will establish limited access areas, create toll lots and metered areas,...

It is proposed the following changes be made:

In the second sentence of the paragraph it is proposed to delete "and metered areas"...

**II. Permits for Parking**—MOTORCYCLE PARKING AREAS:

Current motorcycle registration will allow parking in any of the authorized motorcycle parking areas day or night. Parking cycles in areas other than those designated for cycle parking will constitute a violation. Motorcycle registration stickers may be displayed on the rear fender.

It is proposed the following changes be made:

A current motorcycle *permit* will allow parking in any of the authorized motorcycle parking areas day or night. Parking cycles in areas other than those designated for cycle parking will constitute a violation. Motorcycle *permits* shall be displayed on the rear fender.

**Parking Permits, Other:**

Parking Permits may be issued to students, faculty members and other employees for reasons other than those set out in these regulations.

It is proposed the following changes be made:

In the first sentence of the paragraph it is proposed to delete "to students, faculty members and other employees"...

**Permit Fees**

The proposed amendments include the following fee changes: Blue zone from \$15 to \$19 academic year, from \$10 to \$16 spring semester, from \$5 to \$16 summer; Red zone from \$30 to \$38 academic year, from \$20 to \$31 spring semester, from \$10 to \$31 summer; Brown zone from \$9 to \$12 academic year, from \$6 to \$10 spring semester, from \$3 to \$10 summer; Gold zone from \$30 to \$38 academic year; from \$20 to \$31 spring semester, from \$10 to \$31 summer; Orange zone from \$10 to \$13 per semester.

To be added to the above: Motorcycle zone \$12 academic year, \$10 spring semester, \$10 summer.

**III. Visitor Parking**—Persons who are not employed by the university and who are not enrolled in the University are guests of or visitors to the university.

It is proposed the following changes be made:

It is proposed to delete the entire first sentence of the paragraph.

Parking for official visitors on the campus is pro-

vided in visitor zones located directly behind the Leonard H. Axe Library.

It is proposed the following changes be made:

Parking for official visitors and guests on the campus is provided in visitors zones located directly behind the Leonard H. Axe Library.

**IV. Enforcement of Parking Regulations**—During hours when an area is controlled, parking is restricted to vehicles with permits which authorize parking in that area or metered areas where the meter fee has been paid. Meter hours are 7:30 a.m. to 3:00 p.m. Monday through Friday.

It is proposed the following changes be made:

In the second sentence of the second paragraph it is proposed to delete "or metered areas where the meter fee has been paid. Meter hours are from 7:30 a.m. to 3:00 p.m. Monday through Friday."

**V. Prohibited Parking**—No amendments proposed.

**VI. Operation of All Motor Vehicles**—No amendments proposed.

**VII. Operation of Mopeds and Bicycles**—No amendments proposed.

**VIII. Removal of Vehicles**—Normally, violations for a continued infraction shall be issued in the following manner: (a) one violation in the morning, (b) second violation in the afternoon of the same day, (c) violations of the loading zones and meters at the discretion of the officer,...

It is proposed the following changes be made:

In the first sentence of the first paragraph it is proposed to delete "and meters"...

**IX. Parking Violation Penalties**—A charge of \$4.00 shall be made for all parking violations except \$1.00 for meter violations, and \$10.00 for handicapped space violations paid within seven (7) days of the date of issuance. Failure to pay a violation before the eighth (8) day after issuance shall result in a \$1.00 penalty for each week that the ticket is overdue with a maximum of \$8.00 per ticket. Handicapped violation tickets will accumulate to a maximum of \$20.00. A wheel-lock (boot) fee of \$5.00 will be charged where it has been necessary to use this device for flagrant violators who do not respond to citations.

It is proposed the following changes be made:

A charge of \$8.00 shall be made for all parking violations and \$25.00 for handicapped space violations paid within seven (7) days of the date of issuance. Failure to pay a violation before the eighth (8) day after issuance shall result in a \$2.00 penalty for each week that the ticket is overdue with a maximum of \$16.00 per ticket. Handicapped violation tickets will accumulate to a maximum of \$35.00. A wheel-lock (boot) fee of \$25.00 will be charged where it has been necessary to use this device for flagrant violators who do not respond to citations.

**X. Parking Appeals**—An appeal fee of \$1.00 per citation will be charged.

It is proposed the following change be made:

An appeal fee of \$2.00 per citation will be charged.

### XI. Disposition of Parking Violation Penalties and Parking Zone Fees—No amendments proposed.

Interested persons will be given reasonable opportunity at the hearing to present their views concerning the regulations. Written comments may also be submitted prior to the hearing. Written comments or a request for a copy of the regulations and a copy of the financial impact statement should be submitted to Wilma Minton, Vice President for Student Affairs, 115 Russ Hall, Pittsburg State University, Pittsburg 66762.

A public hearing will be conducted at 1 p.m. Monday, April 15, at the Rieke Auditorium, University of Kansas Medical Center, Olathe and Rainbow Blvd., Kansas City, concerning the adoption by the Board of Regents of regulations governing traffic and parking on the roads, streets, driveways and parking facilities at the University of Kansas Medical Center.

#### Current

(1) 2.13 Temporary Permit: Temporary permits are available to employees and students upon verification of their temporary status. These permits may be issued for the yellow or green zones, depending on the availability of space, for a 10-week period.

#### Proposed Change

2.13 Temporary Permit: Temporary permits are available to employees and students upon verification of their temporary status. The permits may be issued for the green zone, depending upon the availability of space, for an 11-week period.

#### Current

(2) 2.14 Emergency Medical permit: Issued to medical departments who have on call status for patient care needs. These permits are valid in any area during on call hours except fire lanes, handicapped stalls, Lot 27, and the parking facility.

#### Proposed Change

2.14 Emergency Medical permit: Issued to medical departments who have on call status for patient care needs. These permits are valid in any area during on call hours except fire lanes, handicapped stalls, Lot 27, Lot 151, and the Emergency Room parking area.

#### Current

(3) 4.5 Group III University violations: Fine \$25.

#### Proposed change

4.5A Group III University violations: Fine \$50—over 14 days \$60.

#17 Illegally parked in space designated for the handicapped.

(4) Regarding the Parking/Landscape Services map of the medical center and surrounding lots, several areas need to be identified.

(a) Blue Zone behind the dietary dock is not identified on current map.

(b) Blue Zone along the street of Olathe near the "G" Building is not identified on the current map.

(c) Red zone along the street of Olathe near the Kirmeyer Fitness Center is not identified on the current map.

(d) The lot behind the Rosedale Post Office, designated for free parking, is not identified on the current map.

(e) Currently, the new facility is identified as Francis Street Parking Facility. The current name for the facility should be the Olathe Parking Facility.

#### Current

(5) 5.0 Payment of fines: Violation fees are payable at the fine boxes located at all metered parking areas except lots 44 and 145, or at the Parking Services office either in person, or by mail. Make checks payable to the University of Kansas. Payment of violations must be received at least 14 days after the day on which the violation was dated. Meter violations shall be received 48 hours after the time the violation notice was issued. Violation notices shall accompany fine payments.

#### Proposed Change

5.0 Payment of fines: Violation fees are payable at the fine boxes located at all metered parking areas except lots 44 and 145, or at the Parking Services office either in person, or by mail. Make checks payable to the University of Kansas. Payment of violations must be received at least 14 days after the day on which the violation was dated.

#### Current

(6) 5.1 Late payment of fines: Late payment occurs if the fine is not received or postmarked by the fourteenth calendar day (meter violations by the second calendar day) after issuance of the violation notice. Late payment of violation fees shall result in the levy of an additional \$5 processing fee for each violation. Individuals with unpaid fines shall be sent a notice 15 days after the date on which the violation notice was issued.

#### Proposed Change

5.1 Late payment of fines: Late payment occurs if the fine is not received or postmarked by the fourteenth calendar day after issuance of the violation notice. Late payment of violation fees shall result in the levy of an additional \$5 processing fee for each violation. Individuals with unpaid fines shall be sent a notice 15 days after the date on which the violation notice was issued.

(7) 7.0 Rates for surface lots, Cambridge and Olathe Parking facilities.

The following is a summary of the substance of the rules and proposed changes.

## General

Revisions in wording and structure were made for the purpose of clarity and understanding. New annual permit fees were established to help reduce the debt obligations for borrowed monies and to collect sufficient revenue for future parking lot maintenance and new lot construction.

## Notice of Hearing on Proposed Traffic Regulations at the University of Kansas

A public hearing will be conducted at 3 p.m. Friday, April 12, in the Parking Department conference room, 1501 Irving Hill Road, University of Kansas, Lawrence, concerning the adoption by the Board of Regents of regulations governing traffic and parking on the roads, streets, driveways, and parking facilities at the University of Kansas. The following is a summary of the substance of the rules and proposed changes. While certain sections of the regulations have been renumbered and reorganized, the only substantive changes in the regulations are noted as follows:

1. **General Regulations.** The current regulations specify who is subject to these rules and regulations, that all vehicles must have a valid parking permit, and hours of access to the central campus. The proposed amendment will extend the hours the central campus is controlled to 7:45 a.m.-4:45 p.m.

2. **Definitions.** The current regulations specify, for the purpose of these regulations, the definitions of student, faculty, staff, visitors, dormitory visitor, medical parking needs, handicap parking, moped and motorcycle parking. The proposed amendment will encourage those with handicap designators to register such information with the Parking Office.

3. **Visitor Parking.** The current regulations specify conditions under which visitors may legally park at the University of Kansas. No amendments are proposed.

4. **Parking Permits.** The current regulations establish procedures pertaining to parking permits and the types of permits available. The proposed amendment would create a new medical permit that could be issued on a weekly basis.

5. **Student, Faculty, and Staff Parking.** The current regulations establish procedures by which parking permits for vehicles may be obtained and appealed, and procedures for new employees. The proposed amendment would drop the age plus service restriction on red permit purchases.

6. **Permit Fees.** The current regulations specify the fees charged for parking permits. The proposed amendment would raise the rate for temporary permits from \$11 to \$20 and would add a \$5 charge to parking facility cards. Medical permits will sell for \$2.50 per week.

7. **Control of Parking Lots and Zones.** The current regulations specify times and locations for parking restrictions at the University of Kansas. The proposed amendment will change the restrictions on yellow zones from 7 a.m.-5 p.m. to 8 a.m.-4 p.m. Meters rates would be increased from \$.25 to \$.35 per hour/20 minute/or 40 minute limit. The yellow section of lot 107 (Jolliffe) will be changed to red (12 stalls). Lot 51 yellow will be designated for KJHK staff. West Campus lots will have blue, red and yellow permit areas.



8. **Violations.** The current regulations specify violations for which a vehicle may be ticketed and the cost of such violations. No amendments are proposed.

9. **Payment of Fees for Violations.** The current regulations specify the method and procedure for payment of violation notices, late payment, what constitutes excessive violations and consequences of excessive violations and towing and impoundment procedures. No amendments are proposed.

10. **Appeal of Violation Notices.** The current regulations establish the procedures for appeals from a charge of misuse of parking area. No amendments are proposed.

11. **Statutory Authorization.** The current regulations establish the authorization of the Board of Regents to promulgate regulations for the control of parking and traffic on the University of Kansas campus and to establish misuse fees for violations of the regulations. No amendments are proposed.

Interested persons will be given reasonable opportunity at the hearing to present their views concerning the adoption of the proposed amendments to the existing regulations. Written comments also may be submitted prior to the hearing. Written comments or a request for a copy of the proposed regulations and a copy of the financial impact statement of such changes should be submitted to Edwyna Gilbert, Associate Dean, College Office, University of Kansas, Strong Hall, Room 206, Lawrence 66045.

#### Legislative Bills Introduced

The following numbers and titles of bills and resolutions have been recently introduced by the 1991 Kansas Legislature. Copies of bills and resolutions are available free of charge from the Legislative Document Room, 145-N, State Capitol, Topeka 66612, (913) 296-4096.

#### Bills Introduced February 21-27:

##### House Bills

HB 2417, by Committee on Agriculture, An act concerning veterinarians; relating to client privilege.

HB 2418, by Committee on Labor and Industry: An act enacting the state employee video display terminal health and safety act; prescribing minimum standards for video display terminal work stations and alternative work breaks; prohibiting certain acts; prescribing certain powers, duties and functions for the secretary of administration; providing for implementation and administration.

HB 2419, by Committee on Labor and Industry: An act concerning public employer-employee relations; amending K.S.A. 75-4321 and repealing the existing section.

HB 2420, by Committee on Insurance: An act amending the long-term care insurance act; authorizing policies thereof to establish certain eligibility criteria; amending K.S.A. 1990 Supp. 40-2228 and repealing the existing section.

HB 2421, by Committee on Governmental Organization: An act concerning health care financing in hospitals and adult care homes;

establishing the Kansas health care finance commission and providing for the powers, duties and functions thereof.

**Attorney General****Opinion No. 91-14**

**State Boards, Commissions and Authorities—Public Employees Retirement Systems; Kansas Public Employees Retirement System—Election by Elected Officials to Continue Membership After Service Terminates; Constitutionality. Marshall Crowther, Executive Secretary, Kansas Public Employees Retirement System, Topeka, February 21, 1991.**

Under the provisions of K.S.A. 1990 Supp. 74-4911e, a former elected official may elect to continue to participate in the Kansas public employees retirement system (KPERS) after leaving service as an elected official provided the former elected official: (1) was an elected official on or after January 1, 1985; (2) was a member of KPERS during service as an elected official; (3) does not immediately become an employee of another participating employer; and (4) files the proper notice of election in the office of the executive secretary of KPERS. No other elected officials or employees are permitted to make such an election. Because such a classification does not enable employees to accumulate reserves for themselves and their dependents for old age, death and termination of employment, and ensure a fiscally solvent retirement system, the purposes for which KPERS was established, the classification does not advance the objectives of the Kansas public employees retirement act. The classification does not meet the reasonable basis test and therefore violates the equal protection clauses of the United States and Kansas constitutions. As stated in Attorney General Opinion No. 79-108, no statute or common law doctrine exists which would preclude an individual employed by a unified school district as a teacher, substitute teacher, custodian, school bus driver, counselor, or referee of an athletic event from serving as a member of the board of education of the unified school district which employs the individual. Such individuals are permitted to vote on their contracts as a school board does not constitute a business or person under K.S.A. 1990 Supp. 75-4301a *et seq.* K.S.A. 72-8202e prohibits an individual from receiving compensation for work or duties performed as a member of the board of education. The individual,

A public hearing will be conducted at 1:30 p.m. Monday, April 8, in the Department of Revenue conference room, second floor, Docking State Office Building, 915 Harrison, to consider the adoption of a proposed regulation of the Department of Revenue.

This 30-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed regulation. All interested parties may submit written comments prior to the hearing to the general counsel, Department of Revenue, 2nd Floor, Docking State Office Building, Topeka 66612-1588. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulation during the hearing.

This regulation is proposed for adoption on a permanent basis. A summary of the proposed regulation and its economic impact follows.

K.A.R. 92-55-2a would change the method by which depreciation is computed for motor vehicles for property tax purposes. The regulation addresses a problem in the current system of valuing motor vehicles, which was identified by the Attorney General in Opinion No. 90-100. The Attorney General held that the current practice under K.S.A. 79-5101 *et seq.* and K.A.R. 92-51-2 of taxing motor vehicles in such a way as to provide disparate treatment between taxpayers with surnames at the beginning and end of the alphabet was unconstitutional. The regulation eliminates the perceived inequity by accelerating the recognition of depreciation to January 1 when the period for which an owner is seeking to register a motor vehicle spans a part of two calendar years.

The proposed regulation will reduce motor vehicle tax revenues by approximately \$23 million for calendar year 1991. Counties, school districts and other local units would be negatively affected by the reduction in revenue.

Administrative Regulations**

The Kansas Department of Health and Environment will conduct a public hearing at 7 p.m. Monday, April 8, in the third floor auditorium of the Kansas City-Wyandotte County Health Department, 619 Ann Ave., Kansas City, Kansas. The purpose of this hearing is to consider the adoption of the following:

1. Proposed amendments to two volatile organic compound emission regulations, K.A.R. 28-19-61 (definitions) and K.A.R. 28-19-62 (testing procedures);

2. Proposed adoption of three new volatile organic compound emission regulations, K.A.R. 28-19-76 (lithography printing operations), K.A.R. 28-19-77 (chemical processing facilities that operate alcohol plants or liquid detergent plants), and K.A.R. 28-19-78 (fuel volatility); and

3. Proposed revisions to the state implementation plan (SIP) for ozone related to the Kansas City metropolitan area (KCMA).

The three proposed new regulations and the proposed amendments to the two existing regulations are being promulgated in connection with the development and submittal of the Kansas City Metropolitan Area Ozone Maintenance Plan in compliance with the federal Clean Air Act. This act requires areas failing to meet the ambient ozone standard to develop state implementation plans with sufficient emission control requirements to expeditiously attain and maintain the standard. In response to evidence in the 1970s that five counties in the Kansas City region violated the ozone standard, the area was designated as "nonattainment" for ozone. These counties include Clay, Jackson and Platte in Missouri, and Johnson and Wyandotte in Kansas. These new regulations will apply only to the affected sources located in Johnson and Wyandotte counties in Kansas.

**K.A.R. 28-19-76. Lithography printing operations.** This new regulation will apply to two lithographic printing plants located in Kansas City, Kansas, and will require that volatile organic compound (VOC) emission control equipment and work practices be installed or used on certain printing processes. This regulation is mandated by the federal Clean Air Act, which requires the installation of reasonably available control technology (RACT) on all major sources of VOC emissions (greater than 100 tons per year) in ozone nonattainment areas. These industries were inadvertently excluded from the 1986 Kansas Ozone Implementation Plan. VOC emission reductions to be achieved by implementing this rule are estimated to be 318 kilograms per day. Estimates of the economic impact of this new regulation upon the affected industries developed in coordination with the affected industries, suggest that compliance costs will be between \$890 and \$1,700 per ton of VOC emissions reduced. These compliance costs are within the cost-

effectiveness criterion considered appropriate for control measures of this type.

This regulation will not have economic impact upon the general public except to the extent that compliance costs may be passed on to the customers of this industry. This impact is not expected to be significant. There will be no significant economic impact upon government agencies.

**K.A.R. 28-19-77. Chemical processing facilities that operate alcohol plants or liquid detergent plants.** This new regulation will apply to one chemical processing plant located in Kansas City, Kansas, and will require that VOC emission control equipment be installed on several sources of VOC emissions at the plant. As with the new lithography regulation (K.A.R. 28-19-76), this regulation is mandated by the federal Clean Air Act as a RACT requirement for a major source of VOC emissions in an ozone nonattainment area. VOC emissions to be achieved by implementing this rule are estimated to be 1950 kilograms per day.

Estimates of the economic impact of this new regulation upon the affected industry, completed in coordination with the single affected industry, indicate that compliance costs will be about \$135 per ton of VOC reduced, which is within the cost-effectiveness criterion considered appropriate for this type of source. This regulation is not expected to have significant economic impact upon the general public or upon any government agencies.

**K.A.R. 28-19-78. Fuel volatility.** This new regulation will apply to all facilities in Johnson and Wyandotte counties in Kansas that sell or dispense gasoline and will require that such fuels meet a specific vapor pressure requirement during the ozone season of 1991 (May 1 through September 15). The vapor pressure of fuel determines the rate at which VOC's are lost by evaporation into the air. Higher vapor pressures, therefore, increase emission rates. VOC emissions reductions to be achieved by implementing this rule are estimated to be 8,198 kilograms per day region-wide.

A voluntary gasoline vapor pressure reduction program was successfully implemented in the Kansas City area during the 1990 ozone season. Thus, this new rule will not result in significant change to current practice, but will mandate an otherwise voluntary action. In short, the gasoline vapor pressure control requirement has been determined to be the most cost-effective procedure for realizing additional VOC reductions in the Kansas City area among a number of alternatives that were evaluated. The estimated costs of compliance to gasoline refineries as reflected in pump prices are, at most, expected to be in the range of \$.003 to \$.005 per gallon. These price increases would be the equivalent of a total cost of \$1.25 to \$2.09 more for lower volatility gasoline to the Kansas City motorist during the entire ozone season. Therefore, the economic impact on the public from the state-required 1991 volatility controls is not expected to be significant.

The only costs to government agencies associated with this regulation are those that may be incurred in collecting and analyzing compliance samples. These costs are expected to be less than \$6,100 per year as-

suming that all analytical work is performed by contract.

**K.A.R. 28-19-61. Definitions.** Subsections (gg), (oo), (aa), (bbb), and (ooo), are proposed to be amended to provide clarification of new terms used in the new and amended regulations proposed for adoption in this rulemaking. Subsection (hhhh) is proposed to be amended to include several additional chlorofluoro-carbon compounds in the list of negligibly reactive volatile organic compounds in order to allow the substitution of these materials for more reactive compounds without regulation as reactive VOC's. This amendment will reduce compliance costs to affected sources that have a requirement to substitute these materials for more reactive VOC's. There will be no economic impact to government agencies or the general public as a result of this amendment. This amendment is not mandated, but is encouraged by the federal government.

**K.A.R. 28-19-62. Testing procedures.** Subsection (a) is proposed to be amended to include the gasoline Reid Vapor Pressure sampling and testing procedures required by the adoption of K.A.R. 28-19-78 (fuel volatility). There will be no economic impacts associated with this proposed amendment other than those described in association with K.A.R. 28-19-78. The procedures being adopted are already required for implementation of a similar federal regulation.

**HOUSE BILL No. 2460**

AN ACT concerning Wyandotte county; relating to Wyandotte county lake.

*Be it enacted by the Legislature of the State of Kansas:*

Section 1. 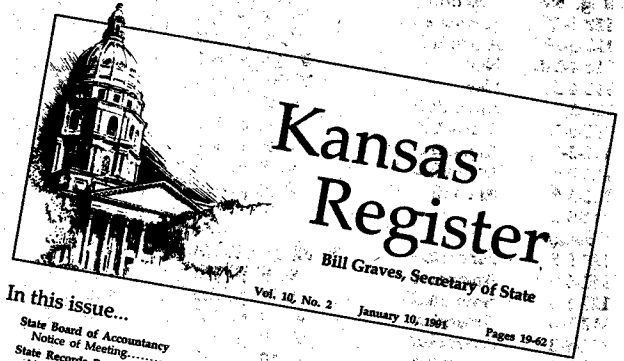
