Legislature—State Governmental Ethics—Individuals Required to File Written Statements of Substantial Interests. Professor Dennis D. Prater, General Counsel, Kansas Public Disclosure Commission, Topeka, March 13, 1991.

Enforcement of the governmental ethics act against the employees of interstate agencies by criminal prosecution is not favored by the law. The terms of the interstate compact or agreement take precedence over the unilateral actions of any single member state. Taxation—Property Exempt from Taxation—Property Exempt from Property and Ad Valorem Taxes; Property Dedicated to Public Use. David H. Anderson, Blue Rapids City Attorney, Frankfort, March 14, 1991.

Property which has been dedicated to public use, and which is held by a municipality in trust for such use, may lose its eligibility for property tax exemption under K.S.A. 79-201a *second* if it is allowed to be used for private purposes. Cities and Municipalities—Interlocal Cooperation; General—Interlocal Agreements by Public Agencies; Prosecution of Violation of City DUI Ordinance by County Attorney.

Counties and County Officers—County Attorney—Duties; Prosecution of City Ordinances; Interlocal Agreements.

Automobiles and Other Vehicles—Uniform Act Regulating Traffic; Rules of the Road; Serious Traffic Offenses—Driving Under Influence of Alcohol or Drugs; City Ordinance; Prosecution in Municipal Court; Jurisdiction. Current statutes concerning the powers and duties of county officials do not authorize boards of county commissioners to enter into interlocal agreements which unilaterally require county attorneys or their staff to prosecute in municipal court for violations of a municipal DUI ordinance. If a city has enacted a DUI ordinance, violations of that ordinance which fall within the city's jurisdiction may be prosecuted in municipal court. Such prosecutions may be undertaken by an attorney authorized by the city to appear in municipal court on behalf of the city. Likewise, defense costs for indigent defendants may be paid to attorneys

properly hired by the city for such purposes. Compensation paid by the city to such prosecutors or other attorneys may be contractually shared with or paid to a third party (such as a county) if that party provides contractual consideration for such payments and if the city is expending funds which may be utilized for such purposes. Attorneys involved in representation of two or more public entities must resolve potential statutory or ethical conflict of interest issues. K.A.R. 100-11-1 is being revised to increase the fees for FLEX I and II due to an increase in costs to the board in purchasing these examinations for administration commencing June 1991.

Article 4.—FEES AND CHARGES

25-4-1. Fees. (a) Definitions.

SENATE BILL No. 1

AN ACT concerning laboratory testing; relating to approval and regulation of laboratories; amending K.S.A. 1990 Supp. 65-1,108 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 1990 Supp. 65-1,108 is hereby amended to read as follows: 65-1,108. (a) It shall be unlawful for any person or laboratory to perform prenatal tests for syphilis; tests for human immunodeficiency virus or tests to evaluate biological specimens for controlled substances included in schedule I or II of the uniform controlled substances act unless the laboratory in which such tests are performed has been approved by the secretary of health and environment to perform such tests. Any person violating any of the provisions of this section shall be deemed guilty of a class B misdemeanor.

(b) As used in this section and in K.S.A. 65-1,107 and amendments thereto, "laboratory" shall not include: (1) The office or clinic of a person licensed to practice medicine and surgery in which laboratory tests are performed as part of and incidental to the examination or treatment of a patient of such person; (2) the Kansas bureau of investigation forensic laboratory; (3) urinalysis tests for controlled substances performed only for management purposes on inmates, parolees or probationers by personnel of the department of corrections or office of judicial administration and which shall not be used for revoking or denying parole or probation; (4) urinalysis tests approved by the secretary of corrections for controlled substances performed by the community corrections programs; (5) urinalysis tests approved by the secretary of corrections for controlled substances performed by personnel of the community correctional conservation camp in Labette county which is operated under agreements entered into by the secretary of corrections and the board of county commissioners of Labette county pursuant to K.S.A. 1990 Supp. 75-52,132 and amendments thereto; or (6) urinalysis tests performed for management purposes only by personnel of alcohol and drug treatment programs which are licensed or certified by the secretary of social and rehabilitation services.

Sec. 2. K.S.A. 1990 Supp. 65-1,108 is hereby repealed.

Sec. 3. This act shall take effect and be in force from and after its publication in the Kansas register.
