### **Private Industry Council**

### **Public Notice**

The Kansas Private Industry Council of Service Delivery Area (SDA) III is submitting a modification of its two-year Job Training Plan to the Governor of Kansas through the Department of Human Resources. Funding for this plan is through Title IIA of the Job Training Partnership Act (JTPA), designed to provide training to disadvantaged adults and youth. The respective program years are July 1, 1990 to June 30, 1991, and July 1, 1991 to June 30, 1992. The funding level for program year 1991 is expected to be \$2,676,694. The SDA plans to serve an estimated 770 eligible adults and youth during this program year. The plan modification will become effective January 1, 1992. The purpose of the program is to prepare unskilled adults and youth for entry into the labor force and to afford job training to economically disadvantaged individuals and other individuals having serious barriers to employment.

The council is also submitting to the Governor through the Department of Human Resources a Summer Youth Employment and Training Plan modification, as a sub-part of the Title IIA two-year plan. The respective program years are October 1, 1991 to September 30, 1992, and October 1, 1992 to September 30, 1993. The funding level for program year 1991 (the summer of 1992) is based on the previous year's allocation and is estimated to be \$953,000. The SDA

plans to serve an estimated 700 eligible youth during this program year. Funding for the Summer Youth Employment and Training program is through Title IIB of the Job Training Partnership Act (JTPA), which is designed to provide job training for economically disadvantaged youth, ages 14-21, facing serious barriers to employment.

The council will also submit to the Governor through the Department of Human Resources a modification to its Title III Economic Dislocation and Worker Adjustment Act (EDWAA) Plan, as a sub-part of the Title IIA two-year plan. The respective program years are July 1, 1990 to June 30, 1991, and July 1, 1991 to June 30, 1992. The funding level for program year 1991 is expected to be \$424,951. The SDA plans to serve approximately 210 eligible participants during this program year. The purpose of the program is to reassess and reconfigure service to meet the needs of workers who have been terminated, laid off or have received a notice of termination or layoff due to a permanent closure or substantial layoff at a plant or facility.

There is a 30-day review and comment period for the plan modification.

### Animal Health Department

### Notice of Hearings on Proposed Administrative Regulations

The Kansas Livestock Commissioner will conduct three public hearings on proposed administrative regulations of the Kansas Animal Health Department on Thursday, November 21, at the Animal Health Department, Anchor Savings Building, Suite 4B, 712 Kan-

sas Ave., Topeka.

The first hearing will begin at 10 a.m. and concerns the adoption of K.A.R. 9-19-1 through 9-19-11, which adopt specific rules and regulations for animal dealers. These rules and regulations are adopted from the U.S.D.A. 9 CFR 3.1 through 3.12 only if found to be applicable to animal dealers. Kansas animal dealers may have to bear costs to modify their existing kennels to comply with these standards. During the previous licensing year, out of 565 Kansas animal dealers, 525 are also licensed by the U.S.D.A. and are already subject to these specifications.

These regulations will provide standards and guidelines for the operation of facilities under the Animal Dealers Act. The Animal Health Department will experience minimal cost of the proposed regulations.

The second hearing will begin at 10:45 a.m. and concerns the adoption of K.A.R. 9-18-1, which will provide adequate fee funds to operate the Animal Facilities Inspection Program from the Animal Health Department. This regulation establishes new and increased registration and licensing fees for animal dealers, pet shops, pounds and shelters, research facilities, hobby kennel operators, and kennel operators. This will be a 100 to 300 percent increase in revenues.

The third hearing will begin at 1 p.m. and concerns the adoption of K.A.R. 9-20-1 through 9-20-3. These regulations will provide standards and guidelines for the operation of pet shops, research facilities, pounds

and shelters and hobby kennel operators.

These regulations are in content the same rules and regulations that these categories have previously been inspected under when they appeared as K.A.R. 9-13-1 through 9-13-11 (revoked) and have been rewritten for clarity and to be specifically appropriate to each category. Operators of any of the regulated categories should experience no additional costs.

Copies of the regulations may be obtained by writing the Animal Health Department at the address above. All interested parties may submit written comments prior to the hearing to the Animal Health Department.

This 35-day notice of the public hearings constitutes a public comment period. Interested parties may present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

### **Correction Notice Concerning Permanent** Administrative Regulation

Kansas Administrative Regulation 88-3-2, which was published in the Kansas Register October 3, 1991, contained several errors. The regulation is being republished in its entirety.

**88-3-2.** Definition of "residence" for fee purposes.

- (a) Except as otherwise provided in the rules and regulations of the state board of regents, "residence" means a person's place of habitation, to which, whenever the person is absent, the person has the intention of returning. A person shall not be considered a resident of Kansas unless that person is in continuous physical residence and intends to make Kansas a permanent home, not only while in attendance at an educational institution, but indefinitely thereafter as well.
- (b) The factors which, while not conclusive, will be given probative value in support of a claim for resident status include, but are not limited, to the following:
- (1) continuous presence in Kansas during periods when not enrolled as a student;

(2) employment in Kansas;

- (3) payment of Kansas state resident income taxes;
- (4) reliance on Kansas sources for financial support;
- (5) commitment to an education program which indicates an intent to remain permanently in Kansas;
- (6) acceptance of an offer of permanent employment in Kansas;
- (7) admission to a licensed practicing profession in
  - (8) ownership of a home in Kansas.

No factor shall be considered in support of a claim for resident status unless the factor has existed for at least one year prior to enrollment or re-enrollment.

(c) The following circumstances, standing alone, ordinarily will not constitute sufficient evidence of a

change to Kansas residence:

(1) voting or registration for voting in Kansas;

(2) employment in any position normally filled by a student;

(3) lease of living quarters in Kansas;

- (4) a statement of intention to acquire residence in
  - (5) residence in Kansas of the student's spouse;

(6) vehicle registration in Kansas;

- (7) acquisition of a Kansas driver's license;
- (8) payment of Kansas personal property taxes; or
- (9) continuous enrollment in a postsecondary educational institution in Kansas.
- (d) If a person is continuously enrolled for a full academic program as defined by the institution where enrolled, it will be presumed that the student is in Kansas for educational purposes and the burden will be on the student to prove otherwise.
- (e) Maintenance of ties with another state or country, including financial support, voting, payment of personal property taxes, registering a vehicle or se-

curing a driver's license in that state or country, may be considered sufficient evidence that residence in the other state or country has been retained. Public Health—Solid and Hazardous Waste—Kansas Storage Tank Act; Reimbursement from Trust Fund for Corrective Action Costs, When; Violation of Equal Protection Clause. To the extent discussed herein the statutory classifications for determining eligibility for and amounts of reimbursement from the underground petroleum storage tank trust fund as set forth in K.S.A. 1990 Supp. 65-34,119 violate the equal protection clause of the United States constitution. Other provisions of the Kansas storage tank act are severable and therefore not affected by this opinion. Volunteer members of the Kansas Department of Civil Air Patrol are covered by the provisions of the Kansas tort claims act, including complete immunity for the functions set out at K.S.A. 75-6104, and are entitled to a legal defense in the event they are sued for acts or omissions in the scope of their employment.

Volunteer members of the Kansas Department of Civil Air Patrol are covered by and subject to the provisions of the Kansas workers compensation act, but only to the extent and during such periods as they are officially engaged in the performance of functions specified in K.S.A. 1990 Supp. 48-3302. ### Disadvantaged Businesses Utilization Program Policy Statement

It is the policy of the Kansas Department of Transportation that disadvantaged businesses, as defined in 49 Code of Federal Regulations, Part 23, shall have the maximum opportunity to participate in the performance of KDOT contracts that are financed in whole or in part with federal funds. In this regard, KDOT is committed to provide all necessary and reasonable steps in accordance with 49 CFR, Part 23 to ensure that such businesses will be utilized to the maximum extent feasible.

To administer this program, a KDOT External EEO Officer shall be designated who will be responsible for developing, managing and implementing the DBE program on a daily basis. The program objective will be to meet or exceed the established DBE program goals.

Contract goals will be established monthly on individual projects having practical and feasible DBE subcontracting possibilities.

Overall goals will be established on an annual basis and will be based on the following factors:

- 1. A projection of the number of DBEs available to compete for subcontracts.
- 2. A projection of the number and type of federal aid contracts to be let for bid.
- 3. An analysis of the past year's performance and capabilities of the active DBEs.

The overall DBE goal for federal fiscal year 1992 (October 1, 1991, to September 30, 1992) shall be 10 percent for DBEs. Comments, for informational purposes only, will be accepted from the general public in relation to these goals for 45 days following the date of publication of this notice.

All interested parties may submit written comments prior to the hearing to the chairman of the Board of Emergency Medical Services, 109 S.W. 6th, Topeka 66603-3805. All interested parties will be given a reasonable opportunity at the hearing to present their views, orally, in regard to the adoption of the proposed regulations. In order to give all parties an opportunity to express their view, it may be necessary to request each participant to limit oral presentation to five minutes.

Following the hearing, all written and oral comments submitted by interested parties will be considered by the Board of Emergency Medical Services as the basis for making changes to the proposed regulations.

A summary of the regulations follows. Copies of the regulations and the economic impact statement may be obtained by writing the Board of Emergency Medical Services at the address above.

109-1-1. Establishes definitions of terms used in emergency medical services regulations; amended to clarify single-program providers, training officers, instructor-coordinators, and categories of continuing education.

109-2-7. Establishes a requirement for first responders as the minimum qualifications for the second attendant on a licensed ambulance; amended to postpone the implementation date.

109-5-1. Establishes annual continuing education requirements for first responders, attendants, and instructor-coordinators; amended to confer to regulations rather than to the board.

109-5-4. Establishes requirements for first responders and attendants to regain certification within two years of expiration of certification.

109-7-1. Establishes fees for ambulance services and attendants; amended to include fees for instructor-coordinators and attendants holding dual certification as an emergency medical technician-intermediate and emergency medical technician-defibrillator.

109-8-1. Establishes an examination for certification for first responders and attendants; amended to include a maximum number of attempts at the examination for these individuals and includes instructor-

coordinators.

109-9-1. Establishes requirements for instructor-coordinators; amended to include physicians and licensed professional nurses as eligible for instructorcoordinator certification and establishes new requirements for certification and continuing education requirements for regaining certification within two years of certification expiration.

109-9-4. Establishes training requirements to become an instructor-coordinator; amended to include physi-

cians and licensed professional nurses.

109-9-5. Establishes minimum standards instructor-coordinators shall maintain with their training

programs.

109-11-2. Establishes crash injury management technician course approval requirements; amended to delete this course approval and establish requirements for crash injury management technicians to certify as first responders or emergency medical technicians.

109-11-6. Establishes mobile intensive care technician course approval requirements; amended to modify the minimum number of hours required for clinical

training

109-11-9. Establishes minimum requirements instructor-coordinators and training officers shall use in selecting instructors for their training programs.

This economic impact statement is for the following proposed administrative regulations: K.A.R. 109-1-1, 109-2-7, 109-5-1, 109-5-4, 109-7-1, 109-8-1, 109-9-1, 109-9-4, 109-9-5, 109-11-2, 109-11-6, and 109-11-9.

With the exception of 109-5-4, 109-9-5, and 109-11-9, all the regulations are existing permanent regulations which are being amended. Each regulation will be discussed separately.

109-1-1. The amendments clarify single-program providers, training officers, and categories of continuing

education. There is no economic impact.

109-2-7. The amendments postpone the implementation date of the requirement of minimum staffing as the second attendant to be a certified first responder. The economic impact is to allow the local level to postpone the \$100 to \$300 cost per person of training and certifying the individual.

109-5-1. The amendments confer the annual continuing education requirements for first responders, attendant, and instructor-coordinators to regulations rather than to the board and modifies the continuing education requirements of instructor-coordinators.

There is no economic impact.

\_\_\_\_ Kansas Register \_\_\_

109-5-4. This regulation establishes requirements for first responders and attendants to regain certification within two years of expiration of certification. There is no economic impact.

109-7-1. The amendments establish certification and re-certification fees for instructor-coordinators and individuals who possess dual certification as an emergency medical technician-intermediate and emergency medical technician-defibrillator, and examination fees for instructor-coordinators. The amendments also eliminate fees for crash injury management technicians. The economic impact is \$15.00 per instructor-coordinator annually and \$65.00 initial fees for individuals seeking certification as an instructor-coordinator. Individuals holding dual certification as EMT-I and EMT-D will save \$15.00 per year.

109-8-1. Amendments adopt an examination for certification for instructor-coordinators and limit the number of times an individual may take the attendant and first responder examinations. There is no economic

impact.

109-9-1. Amendments allow physicians and licensed professional nurses to be eligible for instructor-coordinator certification and establishes new criteria to be met to achieve instructor-coordinator certification. The amendments also establish the continuing education requirements for instructor-coordinators to regain expired certification within a two year period. There is no economic impact.

109-9-4. Amendments allow physicians and licensed professional nurses to be considered as applicants for approved instructor-coordinator training. There is no

economic impact.

109-9-5. This regulation establishes minimum standards instructor-coordinators shall maintain with their training programs. There is no economic impact.

109-11-2. Amendments eliminate course approval of crash injury management technician courses and establishes criteria for crash injury management technicians to gain certification as a first responder or emergency medical technician. There is no economic impact.

109-11-6. Amendments restructure the required 1200 hours of training in a mobile intensive care technician course and clarifies that qualified instructors shall be

used. There is no economic impact.

109-11-9. This regulation establishes qualifications of instructors to be used in training programs. There is potential of an economic impact on training facilities to assure their students are supervised in a clinical facility by a physician or licensed professional nurse. It is anticipated this could be as much as \$5,000.00 per training program, but this regulation is required to implement the requirement established by Senate Bill 271.

Jackson, Topeka 66612. All interested parties will be given a reasonable opportunity at the hearing to express their views orally in regard to the adoption of the proposed regulations. During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending and approving, or rejecting the proposed regulations.

The following is a brief summary of the permanent and exempt regulations proposed for adoption:

K.A.R. 115-1-1. Definitions. This permanent regulation is proposed for amendment. It provides definitions which are used throughout other regulations of the department. There are 14 definitions which are changed or added to the regulation. Of these, six defined terms were previously found in K.A.R. 23-21-2, which has been revoked.

Economic Impact Summary: No economic impact is anticipated.

(continued)

**K.A.R.** 115-8-9. Camping. This permanent regulation is proposed for amendment. Currently, it provides that camping equipment, vehicles or other property cannot be left unattended in a campground for longer than 24 hours. The amended regulation would remove the unattended provision.

Economic Impact Summary: No economic impact is

anticipated.

K.A.R. 115-12-3. Game breeder permit requirement; other wildlife. This proposed new regulation would require a game breeder permit to raise and sell the following: species of reptiles and amphibians native to Kansas, mountain lion, wolf, black bear and grizzly bear.

Economic Impact Summary: It would be necessary for those individuals raising and selling the listed species to purchase a \$10 permit. The number of such individuals is unknown, but is not expected to be large. Costs to administer the permit system will be insignificant.

K.A.R. 115-20-3. Exotic wildlife; possession, sale and requirements. This permanent regulation is proposed for amendment. The provision which requires a game breeder permit to raise and sell any exotic wildlife would be removed.

Economic Impact Summary: Removal of the permit requirement will allow certain businesses and individuals to operate without a game breeder permit. The number of such businesses and individuals is unknown. The department will lose revenue from the \$10 permit, but will avoid costs associated with permit administration and field inspections by department personnel.

**K.A.R.** 115-20-4. Possession of certain wildlife. This proposed new regulation would require a possession permit of any person possessing a mountain lion, wolf, black bear or grizzly bear. Application procedures, reporting, exemptions and other requirements are specified in the regulation.

Economic Impact Summary: Costs associated with administration of the permit will be borne by the department. The affected public will incur some expense through permit application and reporting requirements. The regulation does not establish a permit cost.

K.A.R. 115-25-6. Turkey; spring season, bag limit, permits and game tags. This exempt regulation establishes the 1992 spring turkey hunting season.

Economic Impact Summary: It is estimated that 12,600 turkey permits and 2,000 game tags would be issued under the structure of the proposed regulation. This would provide an estimated revenue of \$275,300 to the department and represents an equal expenditure by those members of the public who choose to participate.

# Article 4.—INDIVIDUAL GAME RULES BIRTHDAY GAME SHOW

111-4-336. Birthday Game Show. The Kansas lottery shall conduct a televised "Birthday Game Show" at 6:30 p.m., Central Time, on November 20, 1991. The show shall be produced and taped by KSMO-TV of Kansas City, Kansas at a time and place determined

by the executive director. (Authorized by and implementing K.S.A. 1990 Supp. 74-8710; effective, T-111-10-3-91, Sept. 26, 1991.)

**111-4-337. Definitions.** (a) All definitions contained in the Kansas lottery act (K.S.A. 1990 Supp. 74-8701 *et seq.*) and lottery regulations are hereby incorporated by reference.

(b) "Birthday Game Show" means the televised show in which the participants have been selected at the "Birthday Game" drawing conducted by the Kansas lottery pursuant to K.A.R. 111-4-339 in Topeka, Kansas, in which participants are selected to win various prizes as described in K.A.R. 111-4-340.

- (c) "Non-winning ticket" means any valid "\$100,000 Birthday Game" instant lottery ticket not eligible to win a prize pursuant to K.A.R. 111-4-332 through 111-4-335. (Authorized by and implementing K.S.A. 1990 Supp. 74-8710; effective, T-111-10-3-91, Sept. 26, 1991.)
- 111-4-338. Entry Into Drawing. Entry into the "Birthday Game" drawing is accomplished by a player following the process detailed in these subparagraphs:

(a) Obtain five valid Kansas "\$100,000 Birthday Game" instant lottery tickets. Only "\$100,000 Birthday

Game" tickets will be eligible.

(b) Determine if the tickets are winning tickets in accordance with K.A.R. 111-4-334 instant game rules. If a ticket is a winning ticket, it is not eligible for the "Birthday Game" drawing and shall be redeemed in accordance with K.A.R. 111-4-334.

(c) If the tickets are valid non-winning "\$100,000 Birthday Game" tickets, the holder of five such tickets

may enter the "Birthday Game" drawing.

(d) Complete the information form on the back of at least one of the five tickets in a legible manner and sign all five tickets. Unsigned tickets shall not be considered valid entries in the "Birthday Game" drawing.

(e) Place the five tickets into a number 10 envelope (approximately 9½ by 4½) and mail them to "Kansas Lottery Birthday Game," P.O. Box 7777, Lawrence, KS 66044-7777. Entries may also be delivered during regular business hours and placed in the receptacle provided at any of the Kansas lottery's regional offices at the following locations: Cambridge Business Park, 1100 Cambridge Circle Drive, Kansas City, KS; 3112 West Central, Wichita, KS; 3007 West 10th, Great Bend, KS; and 128 N. Kansas, Topeka, KS.

(f) There is no limit on the number of entries a per-

son may make.

- (g) All non-winning valid instant game lottery tickets must be received by the lottery at locations identified in subsection (e) by 5:00 p.m., Wednesday, November 13, 1991, to be eligible for entry into the "Birthday Game" drawing. (Authorized by and implementing K.S.A. 1990 Supp. 74-8710(b); effective, T-111-10-3-91, Sept. 26, 1991.)
- 111-4-339. Birthday Game Drawing. (a) To determine those who will be eligible for prizes, the Kansas lottery shall conduct one "Birthday Game" drawing in connection with the televised "Birthday Game" show which will be broadcast at 6:30 p.m. on Wednesday, November 20, 1991.

(b) The "Birthday Game" drawing shall be conducted at the Kansas lottery headquarters at 128 N. Kansas, Topeka, Kansas, at 2:00 p.m. on November

14, 1991.

- (c) The drum or receptacle containing the non-winning tickets shall be sealed and rotated a minimum of 10 times or mixed thoroughly with a shovel for two minutes by lottery security personnel to ensure random selection.
- (d) The selection of "Birthday Game" drawing winners shall be accomplished by an individual designated by the executive director, using a bare arm technique, removing only one envelope from the drum or recep-

tacle in which all entries were placed. The person drawing the envelope shall open the envelope and show the name of the winner to the security person and the auditor present for verification. This process shall be repeated until 10 valid entries have been drawn. The first 10 valid entries selected will be the "finalists" eligible for participation in the "Birthday Game" television show.

(e) After the finalists have been selected and the drum or receptacle is again rotated or mixed as specified in (c), an additional 125 names will be drawn for home viewer prizes. (Authorized by and implementing K.S.A. 1990 Supp. 74-8710; effective, T-111-10-3-91, Sept. 26, 1991.)

111-4-340. Prizes. Prizes awarded on the televised "Birthday Game Show" shall include, but are not limited to, the following:

(a)	Grand prize winner	\$100,000
(b)	Second	\$ 20,000
(c)	Third	\$ 15,000
(d)	Fourth	\$ 10,000
(e)	Fifth	\$ 7,500
(f)	Sixth	\$ 5,000
(g)	Seventh	\$ 4,000
(h)	Eighth	\$ 3,000
(i)	Ninth	\$ 2,000
(j)	Tenth	\$ 1,000
(k)	Home Viewers \$50 or	\$100 each

- **111-4-341.** Televised Procedure. The following procedures shall be used to determine "Birthday Game Show" winners:
- (a) The 10 contestants who were finalists from the November 14, 1991, drawing shall be lined up in the television studio across from 10 oversized "Birthday Game" tickets. The covered area of each ticket will either have a dollar amount of the prize won or the words "Go to Round 2" printed underneath. In the order their tickets were selected in the drawing, the contestants choose one of the 10 tickets. Once all 10 tickets have been selected, the contestants will be instructed to remove the covering on the tickets. Five players will win dollar amounts of \$1,000, \$2,000, \$3,000, \$4,000 and \$5,000 appearing under the covering, and continue no further. The other five contestants who uncover tickets with the words "Go to Round 2" will move on to the second round.
- (b) In round two, the five remaining contestants shall be lined up opposite five sealed, oversized birthday cards. The contestants, in the order they were selected in the November 14, 1991, drawing, will pick a card. Three of the cards will award prizes of \$7,500, \$10,000 and \$15,000 to the contestants opening them. The other two cards will have the words "Go to Round 3."
- (c) The two final contestants will proceed to round three in which they will be asked to open two large birthday presents. The contestant whose name was the first of the two remaining finalists selected in the No-

vember 14, 1991 drawing shall choose which present he or she wants to open. The host will ask both contestants to open their presents simultaneously. Indicated underneath the lids of each present will be either the \$100,000 grand prize or the \$20,000 second prize.

(d) The lottery security person at the "Birthday Game Show" shall have a list identifying the 10 contestants and the order in which they were drawn at the November 14, 1991, drawing, and shall be responsible for determining the order in which the contestants make selections in each of the three rounds during the show. (Authorized by and implementing K.S.A. 1990 Supp. 74-8710; effective, T-111-10-3-91, Sept. 26, 1991.)

111-4-342. Proxy. (a) If a player is unable to participate for any reason or chooses not to participate in the televised "Birthday Game Show," that player may designate a person to participate as a proxy on his or her behalf in writing on a form provided by the lottery or in a form acceptable to the executive director.

(b) If a player is unable to participate for any reason or chooses not to participate in the televised show and does not designate a person to participate as proxy, the executive director shall designate a proxy to serve to act on the player's behalf. (Authorized by and implementing K.S.A. 1990 Supp. 74-8710; effective, T-111-10-3-91, Sept. 26, 1991.)

111-4-343. Player Rejection. The Kansas lottery retains the right to deny a selected player from appearing on the televised "Birthday Game Show." If appearance is denied by the executive director, or by the director of the show, a proxy will be designated pursuant to K.A.R. 111-4-342. (Authorized by and implementing K.S.A. 1990 Supp. 74-8710; effective, T-111-10-3-91, Sept. 26, 1991.)

111-4-344. Watch 'N Win Drawing. (a) In addition to the 10 entries selected pursuant to K.A.R. 111-4-338, there shall be an additional 125 tickets drawn at the drawings for the selection of participants for the "Watch 'N Win" segments of televised "Birthday Game Show." The drawing shall take place on November 14, 1991.

(b) The 125 additional names shall appear on the television screen during the show between 6:30 p.m. and 7:00 p.m. Any of those 125 winners calling the lottery at 913/296-5700 by 2:00 p.m. the following Monday shall win \$100. Those who do not call in by that time shall receive \$50.

(c) A claim form will be sent to the winners and will be verified upon receipt by the lottery.

(d) In the event the show or any portion of it is not televised due to unforeseen difficulties which render the televised broadcast impossible, entries of potential "Watch 'N Win" winners drawn for that particular episode but not broadcast on the show, shall receive \$100 each. (Authorized by and implementing K.S.A. 1990 Supp. 74-8710(b); effective, T-111-10-3-91, Sept.

111-4-345. Disposal of Tickets. Upon completion of the "Birthday Game" drawing, a lottery security official shall take possession of all tickets remaining in

the receptacle and arrange for their disposal. (Authorized by and implementing K.S.A. 1990 Supp. 74-8710(b); effective, T-111-10-3-91, Sept. 26, 1991.)

sition of control of a domestic insurer, file a letter with the commissioner of insurance indicating:

(A) the person's interest in the possible acquisition of control;

(B) the name of the domestic insurer to be acquired;

(C) that the person is aware of and will comply with the applicable provisions of the Kansas insurance holding companies act; and

(D) that all negotiations or agreements to acquire control of the domestic insurer will be conditioned upon the approval of the commissioner of insurance.

(2) A person required to file a statement pursuant to K.S.A. 40-3304 shall furnish the required information on form A, hereby made a part of this regulation."

(r) item 12(b) and (c) of form A is amended to read as follows: "(b) The financial statements shall include the annual financial statements of the persons identified in item 2(c) for the preceding five fiscal years or for such lesser period as such applicant and its affiliates and any predecessors thereof shall have been in existence, and similar information covering the period from the end of such person's last fiscal year, to a date not earlier than 90 days prior to the filing of the Form A. Such statements may be prepared on either an individual basis, or on a consolidated basis if such consolidated statements are prepared in the usual course of business.

Unless otherwise permitted by the commissioner, the annual financial statements of the applicant shall be accompanied by the certificate of an independent public accountant to the effect that such statements present fairly the financial position of the applicant and the results of its operations for the year then ended, in conformity with generally accepted accounting principles or with requirements of insurance or other accounting principles prescribed or permitted under law. If the applicant is an insurer which is actively engaged in the business of insurance, the financial statements need not be certified, if they are based on the annual statement of such person filed with the insurance department of the person's domiciliary state and are in accordance with the requirements of insurance or other accounting principles prescribed or permitted under the law and regulations of such state.

(c) File as exhibits copies of all tender offers for, requests or invitations for, tenders of, exchange offers for, and agreements to acquire or exchange any voting securities of the insurer, and if distributed, of additional soliciting material relating thereto, any proposed employment, consultation, advisory or management contracts concerning the insurer, annual reports to the stockholders of the insurer and the applicant for the last two fiscal years, and any additional documents or papers required by form A or K.S.A. 40-3304."

(s) item 13 is amended by substituting "K.S.A. 40-3304" for "Section 3 of the Act";

(t) the second sentence of item 2(c) of form A is not adopted;

(u) the second sentence of item 2 of form B is not adopted;

(v) item 5 of form B is amended by substituting "K.S.A. 40-3305" for "Section 4 of the Act";

(w) item 10 of form B is amended by substituting "K.S.A. 40-3305" for "Section 4 of the Act"; and

(x) the signature section of form C is amended by substituting "K.S.A. 40-3305" for "Section 4 of the Act." 40-1-38. Insurance companies; hazardous financial condition; standards; corrective actions. Sections 3 and 4 of the national association of insurance commissioner's "model regulation to define standards and commissioner's authority for companies deemed to be in hazardous financial condition," June 1985 edition, are hereby adopted by reference. (Authorized by K.S.A. 40-103; implementing K.S.A. 1990 Supp. 40-222b and K.S.A. 40-222d; effective, T-40-9-26-91, Sept. 26, 1991.)

### Article 2.—LIFE INSURANCE

40-2-21. Life insurance companies; reinsurance agreements; accounting requirements; limitations. (a) This regulation shall apply to all life insurers organized under the laws of this state, as well as to all other life insurers admitted to do business in this state who are not subject to substantially similar requirements in their domiciliary state.

(b) No life insurer subject to this regulation shall, for reinsurance ceded, reduce any liability or establish any asset in any financial statement filed with the commissioner if, by the terms of the reinsurance agreement, in substance or effect, any of the following

conditions exist:

- (1) The primary effect of the reinsurance agreement is to transfer deficiency reserves or excess interest reserves to the books of the reinsurer for a risk charge, and the agreement does not provide for significant participation by the reinsurer in one or more of the following risks:
  - (A) mortality;
  - (B) morbidity;
  - (C) investment; or
  - (D) surrender benefit;
- (2) the reserve credit taken by the ceding insurer is not in compliance with the laws of this state, administrative rules or regulations adopted by the commissioner:

(3) the reserve credit taken by the ceding insurer is greater than the underlying reserve of the ceding company supporting the policy obligations transferred un-

der the reinsurance agreement;

(4) the ceding insurer is required to reimburse the reinsurer for negative experience under the reinsurance agreement. However, neither the offsetting of experience refunds against the losses of previous years, nor payment by the ceding insurer of an amount equal to the losses of previous years upon voluntary termination of in-force reinsurance by that ceding insurer shall

be considered such a reimbursement to the reinsurer

for negative experience;

(5) the ceding insurer can be deprived of surplus at the reinsurer's option, or automatically upon the insolvency of the ceding insurer or the occurrence of some similar event except that termination of the reinsurance agreement by the reinsurer for non-payment of reinsurance premiums shall not be considered to be a deprivation of surplus;

(6) the ceding insurer must, at specific points in time scheduled in the agreement, terminate or automatically recapture all or part of the reinsurance ceded;

(7) no cash payment is due from the reinsurer throughout the lifetime of the reinsurance agreement, with all settlements prior to the termination date of the agreement made only in a designated reinsurance account and no funds in such account are available for the payment of benefits; or

(8) the reinsurance agreement involves the possible payment by the ceding insurer to the reinsurer of amounts other than from income reasonably expected

from the reinsured policies.

- (c)(1) No reinsurance agreement or amendment to any agreement may be used to reduce any liability or to establish any asset in any financial statement filed with the commissioner, unless the agreement, amendment or a letter of intent has been duly executed by both parties no later than the "as of date" of the financial statement.
- (2) In the case of a letter of intent, a reinsurance agreement or an amendment to a reinsurance agreement shall be executed within a reasonable period of time, not exceeding 90 days from the execution date of the letter of intent, in order for credit to be granted for the reinsurance ceded.

- (d) Any life insurance company subject to this regulation may continue to reduce liabilities or establish assets in financial statements filed with the department for reinsurance ceded if:
- (1) The reinsurance agreement produces significant surplus aid for the ceding insurer, while providing little or no indemnification of policy benefits by the reinsurer;
- (2) the agreements were executed and in force prior to the effective date of this regulation;
- (3) no new business is ceded under the agreements after the effective date of this regulation;
- (4) the reduction of the liability or the asset established for the reinsurance ceded is reduced to zero by December 31, 1994, or any later date approved by the commissioner as a result of an application made by the ceding insurer prior to December 31 of the year in which this regulation becomes effective;

(5) the reduction of the liability or the establishment of the asset is otherwise permissible under all other applicable provisions of the insurance laws of this state

and administrative rules or regulations; and

(6) the department is notified, within 90 days following the effective date of this regulation, of the existence of those reinsurance agreements and all corresponding credits taken in the ceding insurer's 1990 annual statement. (Authorized by K.S.A. 40-103; implementing K.S.A. 40-221a; effective, T-40-9-26-91, Sept. 26, 1991.)
