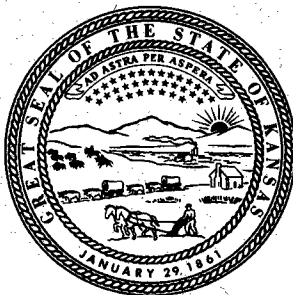

Executive Order No. 91-146

Creating a Governor's Policy for Regional
Cooperation on Waste Management

WHEREAS, regional cooperation on waste management is essential to protecting the environment of Kansas and the entire western region;

WHEREAS, the policies and procedures for waste management in neighboring states may affect Kansas and vice-versa;

WHEREAS, it is advantageous for the State to receive early notification and the opportunity to comment on our neighboring states' decisions regarding waste management that may impact Kansas;

WHEREAS, it is also incumbent upon the State of Kansas to provide our neighbors who may be impacted by our decisions regarding waste management with the opportunity to provide us with their comments on impending state decisions;

WHEREAS, federal cleanup wastes are often shipped from the cleanup site to another state for disposal without the receiving states' knowledge or approval;

WHEREAS, the sharing of this information will serve to protect the environment of Kansas and the western region;

NOW, THEREFORE, pursuant to the authority vested in me as Governor of Kansas, I hereby order that agencies in the State that are responsible for waste management shall cooperate with the Western Governors' Association and its member states on regional cooperation on waste management. Kansas' cooperation shall be achieved by the following actions:

1. Charles F. Jones, Director of Environment, Kansas Department of Health and Environment, is named as Kansas' Single Point of Contact for the Western Governors' Association's Waste Impact Network.
2. This individual's name will be forwarded to the Western Governors' Association along with a copy of this Executive Order.
3. The Regional Waste Protocol, which has been signed by my hand, will be distributed to staff of the State's agencies handling waste management issues.
4. State agencies and personnel regularly will review pending state decisions on new waste facilities, waste management taxes or fees, new regulations or legislation dealing with waste management, and federal wastes for potential impact on other states in the region as outlined in Principle 2 of the Regional Waste Protocol. When potential impacts on other states in the region are identified, agency staff will contact the State's Single Point of Contact named above.
5. It will be the Single Point of Contact's responsibility to inform the Western Governors' Association of the potential impacts. It will also be incumbent upon

the Single Point of Contact to ensure that all the relevant state agencies are notified when the Single Point of Contact is informed of other states' waste actions which might impact the state.

This document shall be filed with the Secretary of State as Executive Order 91-146 and shall be effective immediately.

Kansas Arts Commission

Notice of Planning and Funding Assistance for
Accessibility Projects in Arts Facilities

Arts organizations may apply to the Kansas Arts Commission for assistance in planning and funding accessibility projects for their facilities. The commission has reserved a limited amount of funds for grants to organizations to encourage improvement in accessibility to arts facilities. These grants will assist organizations in developing accessibility plans and making structural changes or additions that improve accessibility to persons with disabilities.

The deadline for accessibility grant applications is 5 p.m. Friday, January 10. Grants will be awarded by the commission in February. Applications must be for projects that can be completed before June 30, 1992. Applicants shall use the fiscal year 1992 Design Arts/Capital Aid Program guidelines and application forms.

Eligibility requirements remain the same, except accessibility grants are offered regardless of the amount of Design Arts/Capital Aid funding applicants might have received in the past.

Matching requirements remain the same. Planning grants require a 1:1 cash match, and capital aid grants require a 2:1 cash match (\$2 in local support for every \$1 requested). The revenue cannot be shown as match on any other commission grant.

The Kansas Act Against Discrimination went into effect on July 1, 1991. The federal Americans with Disabilities Act (ADA) will be implemented January 1, 1992. These laws mandate a minimum standard for accessibility, required in all public accommodations owned and operated by private entities. These accommodations include theatres, museums and arts centers.

Executive Order No. 91-147

Establishing the Task Force on
Public School Financing

WHEREAS, there have been challenges to the constitutionality of the current financing of public schools in Kansas;

WHEREAS, a number of court cases have been consolidated in the Shawnee County District Court, Consolidated Case No. 91-CV-1009;

WHEREAS, the judge in this consolidated case has issued an order dated October 14, 1991, which sets forth the governing rules of law applicable in the consolidated case;

WHEREAS, the Speaker of the Kansas House of Representatives, the President of the Senate and the minority party leaders in each chamber of the Kansas Legislature have agreed to each designate two legislators to serve on a task force, and the attorney general has agreed to provide legal counsel to the task force;

NOW, THEREFORE, pursuant to the authority vested in me as Governor of the State of Kansas, there is hereby established a Task Force on Public School Financing which shall be composed as follows:

1. The Governor shall appoint eight members of the Task Force and designate the chairperson. The members and chairperson will be designated by official commission of appointment of the Governor, certified by and filed with the Secretary of State.

2. Eight Kansas legislator members are hereby requested to be appointed, two each by the Speaker of the House, the President of the Senate, and the minority party leaders of the House and Senate.

The Task Force shall consider the governing rules of law set forth in the above-described judge's order dated October 14, 1991, and shall make recommendations concerning public school financing in Kansas. In order to facilitate the consideration of expenditure recommendations for inclusion in the Governor's budget recommendations to the 1992 Legislature, the Task Force is requested to file with the Governor and the Legislative Coordinating Council a preliminary report of its recommendations by December 9, 1991.

Members of the Task Force who are appointed by the Governor shall receive subsistence, mileage and expenses as provided in K.S.A. 75-3223. Those members employed by a state agency shall be paid for these items by their respective state agency. Members of the Task Force appointed by legislators shall receive such compensation, subsistence, mileage and expense items as may be authorized by the Legislative Coordinating Council.

This document shall be filed with the Secretary of State as Executive Order 91-147 and shall be effective immediately.

The 30-day notice period from the date of this publication to the date of the public hearing constitutes a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. Comments may be submitted to John McCannon, Assistant General Counsel, State Corporation Commission, 200 Colorado Derby Building, 202 W. 1st, Wichita 67202.

Copies of the proposed regulations and the economic impact statements may be obtained at the Wichita address. Persons requesting a copy of the proposed regulations and economic impact statements, in accordance with K.S.A. 45-219, will be required to compensate the commission for the cost of reproduction. All interested parties will be given a reasonable opportunity at the hearing to present their views orally or in writing in regard to the adoption of the proposed regulations.

All written or oral comments submitted by interested parties on or before December 5 will be considered by the commission as a basis for making changes to these proposed permanent regulations.

The following is a brief summary of the proposed regulations and economic impact statements:

K.A.R. 82-3-103. The amendment adds headings to the major sections of the regulation for ease of reference and rewords several sections for clarity. The amendment clarifies what is required to be shown on the plat map that accompanies the notice of intention to drill and allows a proposed drilling location to be described in footages from the nearest section corner rather than from the section's east and south lines as currently required.

Economic Impact: Since the amendment clarifies the requirements of the notice of intention to drill, there is no economic impact to the industry or the agency. The provision allowing drilling locations to be described from the nearest section corner may have a small economic savings for industry.

K.A.R. 82-3-106. The amendments change the date of the commission order in Docket No. 34,780-C (C-1825) which the regulation incorporates by reference. The new commission order in this docket amends Table I to require wells drilled deeper than 1500 feet and using Alternate I completion to have surface casing set a minimum of twenty feet (20') into the Heebner Shale in Range 17 East, Range 18 East and Range 19 East in Atchison County and a minimum of one hundred twenty-five feet (125') in Range 20 East and Range 21 East in Atchison County. Several minor wording changes were made for clarity.

Economic Impact: The cost of drilling a well that comes under the amended Table I requirements will be increased by \$2000 to \$3000. Historically, there have been only a few wells drilled that would fall under the requirements of the amended Table I. There will be no economic impact on the agency.

Kansas law does not currently prohibit licensed physicians from performing abortions and, under current court decisions, the state may not prohibit abortions at any stage when the woman's life or health is at risk. The state may suggest guidelines for determining, after viability, when the woman's health is at risk, but the decision in a particular case must be left to the woman's physician. 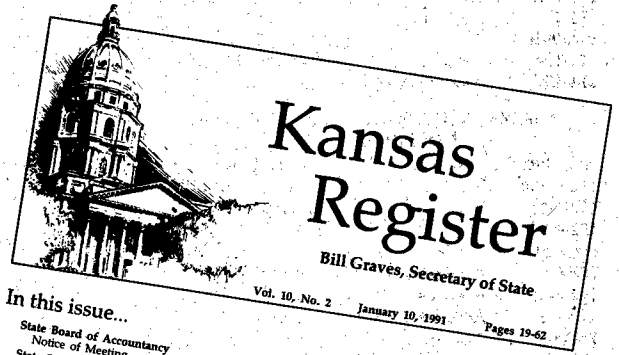
