The Kansas Department of Social and Rehabilitation Services has filed a welfare reform proposal with the U.S. Department of Health and Human Services, Administrations of Children and Families and Health Care Financing and with the U.S. Department of Agriculture, Food and Nutrition Services. The proposal seeks research and demonstration, or waiver, approval of the number of changes in the delivery of services. Kansas programs affected by these changes are Aid to Families with Dependent Children (AFDC), Food Stamps (FS), Medicaid and JOBS. The proposal includes a number of initiatives passed by the 1994 Kansas Legislature.

Notice to Out-of-State Vehicle Dealers
and Vehicle Lessors

Kansas law imposes local compensating (use) tax on vehicles leased from out-of-state dealers and lessors. Effective August 1, 1994, out-of-state vehicle dealers and lessors must charge and collect local compensating (use) tax on all vehicle lease payments when the leased vehicle is or will be registered in Kansas at an address where local sales tax is imposed. All lease payments billed on or after August 1, 1994, are subject to state and local compensating (use) tax. This notice does not affect in-state vehicle dealers and lessors who shall continue to collect the state and local retailers' sales tax that is imposed at the dealer's or lessor's place of business.

The local compensating (use) tax imposition is in addition to 4.9 percent Kansas state compensating (use) tax imposition. Local compensating (use) tax is imposed at a rate equal to the city and county retailer's sales tax in effect at the address where the vehicle is registered. Local retailers' sales tax rates currently range from .5 percent to 2.5 percent. Some jurisdictions do not impose local retailers' sales tax.

State and local compensating (use) tax is imposed on leases of vehicles that are required to be registered for highway use pursuant to K.S.A. 8-126 et seq. Such vehicles include automobiles, trucks, truck tractors, trailers and semi-trailers, motorcycles and various other vehicles.

Lessors and dealers administering leases of vehicles that are leased outside the state of Kansas and subsequently registered in Kansas must complete a "Supplemental Registration Application for Vehicle Lessors" form. The department will register a business for purposes of reporting the appropriate retailers' sales and retailers' compensating tax upon receipt of a completed registration application. Once registered, the department will periodically mail returns for reporting and remitting the tax.

This notice supersedes all previous Department of Revenue notices, revenue rulings, private letter rulings or other advice that concern vehicle leases entered into by Kansas and out-of-state dealers and lessors. It applies to lease payments billed on or after August 1, 1994.

A public hearing will be conducted from 9 to 9:30 a.m. Monday, August 29, at the Office of the Securities Commissioner of Kansas, 618 S. Kansas Ave., second floor, Topeka, to consider the amendment of K.A.R. 81-5-7.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulation and economic impact statement in an accessible format. Requests for accommodation to participate in the hearing should be made at least five working days in advance of the hearing by contacting Diane Cashman at (913) 296-3308 or the Kansas Relay Center at 1-800-766-3777.

The period of 30 days notice constitutes a public comment period for the purpose of receiving written public comments on the amended regulation. All interested parties may submit written comments prior to the hearing to the commissioner at the address above. All interested parties will be given a reasonable opportunity at the hearing to express their views orally in regard to adoption of the amended regulation. Following the hearing, all written and oral comments submitted by interested parties will be considered by the commissioner as a basis for making changes to the amended regulation.

The proposed amendments to K.A.R. 81-5-7 make securities listed or approved for listing on Tier I of the Philadelphia Stock Exchange and Tier I of the Pacific Stock Exchange exempt from registration.

There is no determinable economic impact of this proposed amendment on this agency, other governmental agencies or units, the general public or the persons or businesses regulated by this agency.

From Hazardous Waste Regulations

The Kansas Department of Health and Environment is providing public notice that on July 13, 1994, the Atchison, Topeka and Santa Fe Railway Company, 920 S.E. Quincy, Topeka, submitted a request for a renewal of a variance from specific hazardous waste regulations. The request for a variance was submitted in accordance with K.A.R. 28-31-13(a).

The variance is requested from K.A.R. 28-31-6(c), which requires minimum insurance requirements for transporters of hazardous waste. The Atchison, Topeka and Santa Fe Railway Company is currently registered under K.A.R. 28-31-6 to transport hazardous waste. Since the Atchison, Topeka and Santa Fe Railway Company is self-insured, KDHE considers this to be equal in protection to the minimum insurance requirements of K.A.R. 28-31-6(c).

KDHE has reviewed the variance request, and concluded that the variance is justified. In accordance with K.A.R. 28-31-13(b), public notice is being provided of the tentative decision to grant the variance. Copies of the variance request will be available for public review from 8 a.m. to 4:30 p.m. weekdays until August 27 at the KDHE, Building 740, Forbes Field, Topeka. Comments concerning this variance request may be directed to Candy Williamson, Hazardous Waste Section, KDHE, Building 740, Topeka 66620. Comments must be submitted in writing prior to August 27. Requests for additional information may be made by contacting KDHE at (913) 296-6898.

Upon the written request of any interested person, a public meeting may be held to consider comments on this tentative decision. The person requesting a meeting shall state the issues to be raised and shall explain why written comments would not suffice to communicate the person's views. If a decision is made to conduct a public meeting, a separate public notice detailing the date and location will be issued.

After evaluating all public comments, a final decision shall be made by the secretary and a notice of the final decision shall be published in the Kansas Register. If approved, any conditions or time limitations needed to comply with all applicable state or federal laws or to protect human health or safety or the environment shall be specified by the secretary. A date upon which the variance will no longer be valid shall be prescribed in the final decision.

Compliance Schedule:

1. A livestock waste management plan for the facility shall be developed. The plan shall cover, but not be limited to, the following items: handling and disposal equipment for both solid and liquid wastes, land application practices used to protect against runoff and leaching, waste application rates based on crop nutrient utilization, and identification of adequate land areas of application of all wastes. Detailed guidance and requirements will be provided by the department. A plan shall be submitted to the department within six months following receipt of detailed requirements. The approved plan will become part of this permit.
2. Dewatering equipment shall be obtained within six months after issuance of this permit through purchase, rental or custom application agreement. It shall be capable of pumping at least 500 gallons per minute and dispersing the wastewater over 22 acres of land suitable for waste application. Written verification of the acquisition of the equipment shall be submitted to the department.
3. An operation and maintenance manual shall be developed and a copy submitted to the department within six months after issuance of this permit. The manual shall describe operation and maintenance of the storage ponds to operate as an evaporite system and maintain the required storage capacity.

PROCEDURE

86-2-8. Examination of records. (a) All documents and records delineated in the Kansas real estate brokers' and salespersons' license act (act) and its accompanying regulations shall be examined by the commission or designated agents or employees of the commission at least once every five years, but no more than twice during any 12-month period beginning on July 1.

(b) Examination of records shall be made between the hours of 8:00 a.m. and 6:00 p.m., unless otherwise agreed by all interested persons or entities.

(c) Examinations shall be conducted by commission members, the director of the commission, or employees of the commission.

(d) Examination and inspection of a licensee's records or a group of licensee's records may be authorized by the commission or its director.

(e) The authorized examination may be conducted without notice to the licensee.

(f) This regulation shall not restrict the frequency of examinations which may be conducted to investigate a specific complaint filed with the commission. Such an examination may be authorized by the commission or its director at any time, but shall be limited as follows.

(1) Only those documents subject to the recordkeeping requirements of the act and its accompanying regulations shall be examined.

(2) Examinations shall be made only between the hours of 8:00 a.m. and 6:00 p.m., unless otherwise agreed by all interested persons or entities.

(3) Examinations may be conducted by commission members, the director of the commission, or employees of the commission.

(4) The authorization for such examination of records may be made by either the commission or its director. (Authorized by K.S.A. 74-4202(b); implementing K.S.A. 1993 Supp. 58-3061 and K.S.A. 74-4202(b); effective Sept. 12, 1994.)

A public hearing will be conducted at 9:30 a.m. Tuesday, August 30, in Room 108, Landon State Office Building, 900 S.W. Jackson, Topeka, to consider the adoption of proposed rules and regulations of the Division of Personnel Services.

This 30-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments prior to the hearing to the Secretary of Administration, Room 263-E, State Capitol, Topeka 66612. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation to participate in the hearing should be made at least five working days in advance of the hearing by contacting Faith Loretto at (913) 296-6000 or TTY (913) 296-4798. Handicapped parking is located at the south end of the Landon State Office Building and an accessible entrance is available at the north entrance.

Summaries of the proposed regulations and of their economic impact follow.

K.A.R. 1-5-15, Salary of employee upon demotion. Amendments to this regulation add two new instances in which employees may be demoted without a decrease in pay — (a) when employees return to work under the State Self-Insurance Fund "Return to Work Program"; and (b) when employees accept an accommodation in accordance with the Americans with Disabilities Act. State employees involved in these situations may have more options for employment without loss of income. No measurable economic impact on state agencies is anticipated, although the ability to return an injured employee to work at a similar income may reduce the cost of an associated workers' compensation claim. There is no economic impact on the general public anticipated.

K.A.R. 1-5-24, Overtime; and K.A.R. 1-9-3, Request and approval of leave; authorized leave; unauthorized leave; coordination with overtime provisions. These regulations are amended in order to implement the provisions of L. 1994, Chap. 352, §3 (1994 SB 824). That legislation provides that only hours actually worked may be counted in determining whether overtime is due and the amount of overtime due. K.A.R. 1-5-24, Overtime, is amended to remove existing provisions which count all time "in pay status" toward overtime. In addition, amendments provide that the number of hours of paid leave used in an employee's work week or work period which, when added to the number of hours actually worked in that employee's work week or work period,

exceeds the applicable overtime standard shall be (1) credited back to the employee; (2) given as equivalent time off; or (3) under exceptional circumstances, paid at the annualized hourly rate of pay, if submitted in writing to the director and approved by the Secretary of Administration. Amendments to K.A.R. 1-9-3, relating to request and approval of leave, provide an internal reference within the leave article to the new amendments to K.A.R. 1-5-24. The estimated savings to state agencies resulting from counting only hours actually worked toward the overtime standard are \$2.9 million, including fringe benefit costs and excluding Regents institutions. This estimate is based on paid overtime in calendar year 1993 and does not include the value of accrued overtime compensatory time credits or any leave credited back under amendments to this regulation. There is no economic impact on the general public anticipated.

K.A.R. 1-5-29, Longevity bonus pay. Amendments to this regulation implement L. 1994, Ch. 352, §4 (1994 SB 824). These amendments include: (a) changing the term "longevity pay" to "longevity bonus pay"; (b) exclusion of emergency and temporary employees from eligibility for longevity bonus pay; (c) elimination of unsatisfactory service as a factor in eligibility for longevity bonus pay; (d) and conversion of part-time years of service to their full-time equivalent. There will be a small cost savings associated with excluding emergency and temporary employees from longevity pay that cannot be estimated. The estimated additional cost to the state for crediting part-time employees with full years of service will be approximately \$45,760 annually. There also may be some minimal increase in longevity bonus payments resulting from deletion of the requirement regarding unsatisfactory service. No economic impact on the general public is anticipated. This regulation is proposed for amendment on both a temporary and a permanent basis.

K.A.R. 1-6-21, Certification to permanent positions. L. 1994, Ch. 185, §1 (1994 SB 791) amended K.S.A. 75-2943 to allow the Director of Personnel Services to certify the top five "scores" instead of the top five "names" of applicants on the register and to permit the Secretary of Administration to approve alterations in the certification process under certain conditions. Amendments to K.A.R. 1-6-21 implement these statutory amendments, and as a result, more applicants may be certified for each vacancy. There is no identifiable economic impact on state agencies, applicants or the general public. There will be a small cost associated with KIPPS programming changes of approximately \$1,440. This regulation is proposed for amendment on both a temporary and a permanent basis.

K.A.R. 1-6-22a, Training appointments. Currently, appointments to training classes must be made for a period of no less than six months. This regulation is amended to permit appointments to training classes to be completed in less than the six months if the employee completes statutory training requirements prior to that time. Therefore, the amendment would, in some instances, permit agencies to move employees more rapidly from training positions where they do not attain permanent status, to a permanent position on a proba-

tionary status, followed by permanent status after satisfactory completion of probation. As a result, these employees may realize some direct or indirect economic benefit of permanent positions sooner than is possible under current provisions. However, no direct economic impact on these employees or state agencies can be estimated. There is no economic impact on the general public.

K.A.R. 1-8-2, Orientation; K.A.R. 1-8-5, Management training programs; K.A.R. 1-8-6, Supervisory training programs. L. 1994, Ch. 91, (1994 SB 672) relating to state-wide quality management initiatives, is the basis for amendments to these regulations. Amendments to K.A.R. 1-8-2, Orientation, add state quality management principles and practices, and agency visions and goals to the required elements for state employee orientation programs. K.A.R. 1-8-5, Management training programs, is amended to require that management training programs include the same elements regarding state-wide quality management as required for supervisory training programs. Amendments to K.A.R. 1-8-6, Supervisory training programs, add a requirement that supervisors participate in refresher courses every three years. State agencies and employees may experience an indirect economic impact in the form of improved management and productivity as a result of these training initiatives. Costs associated with training and orientation, such as room rental, training fees, and cost of materials, are to be funded from within existing agency resources. There is no economic impact on the public, except to the extent that training initiatives result in greater efficiencies and higher quality services to the public. These regulations are proposed for amendment on both a temporary and a permanent basis.

K.A.R. 1-9-22, Job injury leave. This regulation is amended to add injuries sustained in confrontations with patients or clients in a mental health or mental retardation facility as a qualifying job injury and changes the length of time an employee can remain on job injury leave to a total of six months. Currently, qualifying employees may remain on job injury leave for no more than six months from the date of the injury. In addition, the regulation is amended to permit the Director of Personnel Services to waive or modify the requirements of this regulation under certain limited circumstances. As these amendments may slightly increase the availability of job injury leave, there may be a small economic impact on state agencies, and on mental health or mental retardation facilities in particular, in the form of continued wage payments for leave other than sick or annual leave. There is no economic impact on the public anticipated.

K.A.R. 1-9-23, Shared leave. Amendments to this regulation are proposed in response to L. 1994, Chap. 240 (1994 SB 609), which established a new definition of a qualifying illness or injury. Under the amendment, shared leave may be granted in connection with a "serious, extreme, or life-threatening illness, injury, impairment or physical or mental condition which has caused or is likely to cause the employee to take leave without pay or terminate employment." A further amendment to the regulation provides that shared leave is limited to six months, unless the employee does not

qualify for long-term disability payments, in which case shared leave may be extended for up to an additional six months. In addition, an existing provision which allows the Director of Personnel Services to waive or modify the requirements of the regulation is qualified by conditions for granting such waivers. The change in the definition of a qualifying illness or injury will broaden eligibility, and thereby increase the number of instances in which shared leave may be approved. Assuming the amendment increases shared leave usage by 25 percent, the cost of the increase is estimated to be \$161,824 annually, including fringe benefits. Affected employees would benefit by the continued wages and benefits. The amendment relating to duration of shared leave may result in the employee receiving long-term disability benefits, as opposed to a form of paid leave, after six months of shared leave. This would reduce the cost to the affected state agency, as long-term disability payments are funded through KPERS. There is no economic impact on the public anticipated. This regulation is proposed for amendment on both a temporary and a permanent basis.

K.A.R. 1-63-1, State quality management initiative; and K.A.R. 1-63-2, Quality initiative leadership. These are regulations which implement L. 1994, Chap. 91 (1994 SB 672). K.A.R. 1-63-1 establishes the state quality management initiative program and its guiding principles. It also requires each state agency to submit an implementation strategy, including proposed activities and quality goals, to the Secretary of Administration for approval. K.A.R. 1-63-2 provides that the Secretary of Administration is responsible for leading the state quality management initiative program and establishes a quality management advisory council, state quality management initiative administrative and training office, and a state quality program planning and guidance committee. There may be some administrative costs associated with training and other quality management activities, such as for training materials, that cannot be estimated. However, any costs associated with implementation of the state quality management initiative program and the associated administrative structure will be funded within existing state agency resources. State agencies and employees also may experience an indirect economic impact in the form of improved management, problem-solving skills and productivity as a result of these quality management initiatives. There is no economic impact on the public, except to the extent that training initiatives result in greater efficiencies and higher quality services to the public. These regulations are proposed on both a temporary and a permanent basis.

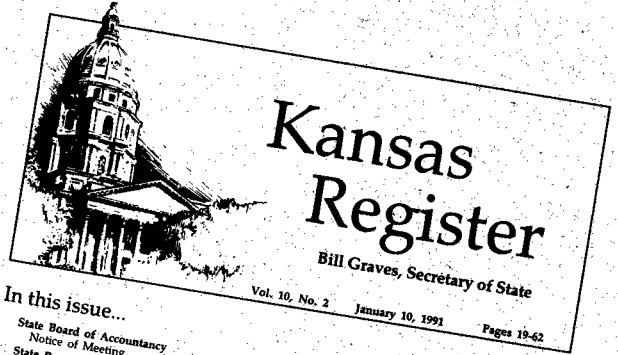
