Opinion No. 94-88

Intoxicating Liquors and Beverages—Licensing and Related Provisions; City Option—Qualifications for Licensure; Retailer's License Spousal Qualifications; Beneficial Interest in Another Retail Establishment. Representative Gary Haulmark, 30th District, Lenexa, July 12, 1994.

The Kansas Liquor Control Act prohibits the granting of a retail license to an individual whose spouse has a beneficial interest in another retail establishment licensed under the Liquor Control Act. This prohibition is not in conflict with or invalidated by the provisions of Article 15, Section 6 of the Kansas Constitution or K.S.A. 23-201 *et seq.* Cited herein: K.S.A. 23-201; 23-204; 41-311; 46-229; K.S.A. 1993 Supp. 75-4301a; Kan. Constitution of the State of Kansas—Legislative—Uniform Operation of Laws of a General Nature; 1994 Senate Bill No. 459. Representative Bob Grant, 2nd District, Cherokee, July 18, 1994.

The amnesty provisions of 1994 Senate Bill 459 do not violate the uniform and equal provisions of Article 11, Section 1 of the Kansas Constitution, nor does the bill violate Article 2, Sections 16 and 17 or Section 1 of the Kansas Bill of Rights. Opinion No. 94-91

Public Health—Healing Arts; Kansas Healing Arts Act—Expiration Date of Licenses; Continuing Education Requirements; Evidence Licensee Maintaining Professional Liability Insurance; Notice of Expiration; Fees; Cancellation of License; Reinstatement, When; Exempt Licensees. Lawrence T. Buening, Jr., Executive Director, Kansas Board of Healing Arts, Topeka, July 20, 1994.

Exempt licensure status under the Kansas Healing Arts Act permits a military physician licensed only in Kansas to practice outside of military service as a health care provider without obtaining professional liability insurance. However, exempt licensure does not require that the licensee maintain annual continuing medical education and thus does not fulfill the federal requirement that military physicians have an active state license that meets the most rigorous requirements imposed by the state statutes. Board of Regents**Notice of Hearing on Proposed
Administrative Regulations**

A public hearing will be conducted at 9 a.m. Friday, September 9, in the boardroom of the State Board of Regents, Suite 1410, Security Benefit Tower Building, 700 S.W. Harrison, Topeka, to consider the adoption of proposed changes in existing rules and regulations of the State Board of Regents.

This 30-day notice constitutes a public comment period for the purpose of receiving written public comments on the proposed regulations. All interested parties may submit written comments prior to the hearing to Ted D. Ayres, General Counsel and Director of Governmental Relations, State Board of Regents, 700 S.W. Harrison, Suite 1410, Topeka 66603. All interested parties will be given a reasonable opportunity at the hearing to present their views orally on the adoption of the proposed amendments to the regulations. In order to give all parties an opportunity to express their views, it may be necessary to request each participant to limit oral presentation to five minutes.

These regulations are proposed for adoption on a permanent basis and are intended to implement the requirements of 1994 Substitute for House Bill 2597, Section 30. A summary of the proposed regulations and their economic impact follows.

K.S.A. 76-746, as amended by 1994 Substitute for House Bill 2597, Section 30, authorizes the Board of Regents to implement a voluntary phased retirement program for unclassified employees at the Regents insti-

tutions, pursuant to rules and regulations adopted by the board. The following is a summary of the substance of the proposed regulations:

K.A.R. 88-12-1. Any unclassified employee at a Regents university with 10 or more years of full-time service is eligible to participate in the program upon reaching 55 years of age.

K.A.R. 88-12-2. Entry into a phased retirement agreement is voluntary as to both parties, except that the institution may refuse to enter into such an agreement when it is not in the best interest of the state institution to do so.

K.A.R. 88-12-3. Any eligible unclassified employee shall submit a written request for participation to the appropriate officer of the institution, who shall determine whether entry into the agreement is in the institution's best interest and what terms are appropriate, and shall then recommend approval of the agreement to the chief executive officer of the institution.

K.A.R. 88-12-4. Each phased retirement agreement shall be irrevocable, except that the unclassified employee may rescind the agreement within 48 hours of signature.

K.A.R. 88-12-5. Each phased retirement agreement shall specify the fractional time appointment to be served; the initial salary for reduced service; the full-time benefits to be received by the unclassified employee; the duration of the agreement, which shall not exceed five years, including the retirement date; and shall be signed by the unclassified employee and the institution.

K.A.R. 88-12-6. Participating unclassified employees shall retain full-time health care benefits, death and disability coverage and employer-paid retirement benefits until the end of the agreement or full retirement, whichever occurs first, and shall continue to have full use of the institution's facilities, retain eligibility for merit increases, and, in case of tenured faculty, hold tenure proportionate to the fractional time appointment for the duration of the program.

K.A.R. 88-12-7. Upon mutual consent, an agreement may be modified by further reducing a fractional time appointment or taking full retirement prior to the specified date of retirement.

K.A.R. 88-12-8. Full retirement must occur no later than the end of the agreement. Retirement under this program does not preclude post-retirement term appointments.

There should be no negative economic impact on the Regents universities, as it is anticipated that any costs associated with the program will be covered by institution salary savings. Employees subject to the amended rules and regulations will be impacted, as the rules and regulations are intended to facilitate employees' transition into full retirement. There should be no additional costs or negative economic impact on the general public.

A public hearing will be conducted at 10 a.m. Tuesday, September 6, in Room C, KNEA Building, 715 W. 10th, Topeka, to consider the adoption of proposed changes in existing rules and regulations of the Department on Aging.

This 30-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments prior to the hearing to the Secretary of Aging, Department on Aging, Room 122-S, Docking State Office Building, 915 S.W. Harrison, Topeka 66612. All interested parties will be given a reasonable opportunity to present their views orally in the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

These regulations are proposed for adoption on a permanent basis. A summary of proposed regulations and their economic impact follows.

These amended regulations are proposed for adoption on a permanent basis and are intended to regulate aging service providers of the Senior Care Act program authorized under K.S.A. 75-5928 et seq. These proposed amended regulations will result in a positive effect upon the service providers and the recipients of Senior Care Act (SCA) program services.

The department does not have a less costly or intensive method for achieving the stated purpose of the regulations. It is estimated that these regulations will have the following economic impact:

1. Addition of new service (K.A.R. 26-8-1 [b]). The new service, adult day care, could increase demand for SCA services and result in increased requests for state funding. However, prior evaluations of the SCA conducted by Kansas State University and filed with the Legislature have shown the Senior Care Act to save money in state expenditures for Medicaid for long-term care.

The funding of the new service may also spur the development of additional providers, who will use the combination of Senior Care Act funded clients and clients funded privately or with other resources to bring services previously unavailable into an area.

2. Clarification of supervision for attendant care (K.A.R. 26-8-1 [e, n]). Requiring that attendant care be delivered under the direction of a licensed health professional, and defining this category, should not affect current providers, and should guarantee quality of delivery of service that can deter more expensive institutional care. The clarification should also assist in differentiating Senior Care Act services from more costly Medicare regulated programs.

3. Adding adult day care to the services that can use transportation for care (26-8-1 [w]). Allowing clients of adult day care to access this service will increase the like-

lihood of family caregivers continuing to provide services in the home to delay more costly institutionalization which may become Medicaid supported.

4. Adjustment and expansion of the sliding fee scale (K.A.R. 26-8-4 [b]). The sliding fee scale of the Senior Care Act is adjusted on an annual basis to correspond with changes in the income cap for the SRS Income Eligible Homecare Program.

5. Adjustment to allow the secretary to designate any appropriate instrument for screening and assessment (K.A.R. 27-8-5). This change will allow the secretary the flexibility to designate a uniform assessment instrument which is being designed in cooperation with the Kansas Department of Social and Rehabilitation Services, and Kansas Department of Health and Environment so that clients assessed by one agency will not need to be reassessed by another should they be found eligible for the other agency's services. This should result in savings to the state and better service to recipients of the programs.

6. Adjustment of the cap on the amount of services which can be used in a month (K.A.R. 26-8-7). The cap on services was raised from \$1,324 to \$1,445 to reflect the change in SRS's HCBS and Income Eligible programs. This could mean a greater expenditure of funds without any growth in clients. However, clients who receive services approaching the level of the cap are at extreme risk of not being able to remain at home or in a similar setting, and would most likely be institutionalized in a higher cost setting without this level of service.

A summary of the proposed regulations follows:

K.A.R. 26-8-1. Contains definitions of terms used in the Senior Care Act program. Amendments contain definitions of a new service and modifications in existing definitions.

K.A.R. 26-8-3. Contains a listing of those services that are priority services. Amendments add a service not previously designated to the list.

K.A.R. 26-8-4. Contains the fee schedule for services set by the program. Amendments adjust for the change in the 150 percent of poverty level.

K.A.R. 26-8-5. Deletes the name of a specific screening and assessment instrument to allow the secretary to select any appropriate instrument.

K.A.R. 26-8-7. Contains the maximum expenditure limit for total monthly service to a specific client. Amendments adjust the cap to parallel the cap used by SRS for its in-home services.

Article 40.—KANSAS EXPORT FINANCE ACT

110-40-5. General terms and conditions of financial assistance. (a) Permissible use of financial assistance. Guaranteed loan funds may be used by the exporter to satisfy credit needs with respect to Kansas export transactions. Eligible credit needs include the costs and expenses related to the acquisition or production, financing, and shipment of the goods and services.

(b) Participation. In providing financial assistance, participation from other private and governmental sources, including the United States small business administration, eximbank, the foreign credit insurance association, and private insurers may be sought by the department.

(c) Maximum amount of financial assistance. The department's net exposure for financial assistance to a Kansas export transaction shall not, at any one time, exceed 50 percent of the export loan guarantee fund balance.

(d) Security. Loans may require collateralization of a type, amount, and value which, considered with the other criteria described in K.A.R. 110-40-6, affords reasonable assurance of repayment.

(e) Reporting requirements:

(1) The lender shall report in writing to the director's office as provided in the guarantee agreement and as provided in K.A.R. 110-40-7, loan administration and servicing.

(2) The exporter shall report to the director's office immediately upon making shipment of the goods and shall provide copies of documents evidencing shipment according to the terms of trade. In addition the exporter shall report immediately the receipt of payment of the Kansas export transaction receivable. If requested by the director's office, the exporter shall submit other reports or documentation reasonably related to an assessment of the exporter's compliance with the Kansas export finance act. (Authorized by K.S.A. 74-5071, K.S.A. 74-5072, as amended by 1994 HB 2971; implementing K.S.A. 74-5071, 74-5072 and K.S.A. 74-5074; effective Oct. 8, 1990; amended Sept. 19, 1994.)

Article 11.—INVESTMENT SECURITIES

17-11-21. Appraisal. (a) An accurate appraisal of all real estate mortgaged securing principal debt in excess of \$15,000, but less than \$250,000, to a bank or trust company, shall be made by two officers or directors of the bank or trust company or by an appraiser who is independent of the bank. The individual or individuals who conduct the appraisal shall view the premises and make a written statement of value and sign and file the same with the bank or trust company. The land and the improvements shall be appraised separately.

(b) An accurate appraisal of all real estate mortgaged securing principal debt of \$250,000 or more to a bank or trust company, shall be made by an appraiser licensed or certified by the state in which the property is located, and who is independent of the transaction. The appraiser shall view the premises, make written statement of value and sign and file the same with the bank or trust company. The land and improvements shall be appraised separately. 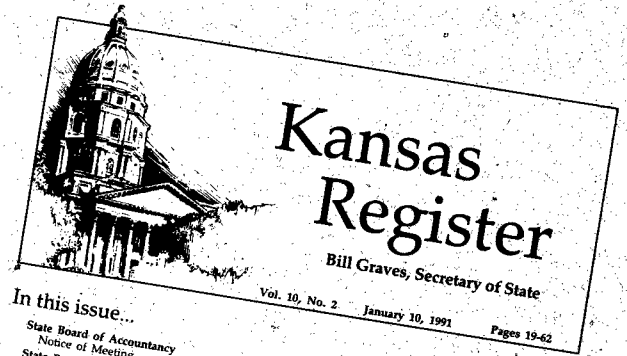
