Administrative Regulations

A public hearing will be conducted at 2 p.m. Friday, January 6, in the conference room at 3601 S.W. 29th, Topeka, to consider the revocation of an existing regulation of the Kansas Dental Board.

The period prior to the public hearing will permit time for written public comments on the proposed revocation of the regulation. All interested parties may submit written comments prior to the hearing to the Kansas Dental Board, 3601 S.W. 29th, Suite 134, Topeka 66614. All interested parties will be given a reasonable opportunity to present their views orally during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant limit any oral presentation to five minutes.

The proposed revocation of regulation 71-1-13 will allow licensees to provide their own laboratory authorization forms in a format prescribed by the Kansas Dental Board. These books have been printed and mailed from the Kansas Dental Board.

The regulation was adopted to provide a safeguard against the practice of denturists in the state of Kansas. K.S.A. 65-1438 prohibits such activity and provides authority for the board to prosecute those persons who are illegally providing laboratory service without a prescription, and any dentist who utilizes such service without providing a prescription.

A one-time expenditure of approximately \$700 will be required to notify licensees of the revocation of K.A.R. 71-1-13 and to provide a copy of the format for the dentist to utilize. The Kansas Dental Board will experience decreased expenditures for printing and postage, and decreased receipts from the sale of the books, which result in no impact on the budget. It is anticipated that the cost to licensees may decrease by using private printing sources.

Pursuant to 1994 Session Laws of Kansas, Chapter 130, Section 1, the results of an election held in Pawnee County on November 8, 1994, on the question of whether a corporate swine production facility shall be established, were 1,038 votes in favor and 1,725 against such establishment. Swine production facilities are not allowed to be established in Pawnee County.

Pursuant to 1994 Session Laws of Kansas, Chapter 130, Section 1, the results of an election held in Kearny County on November 8, 1994, on the question of whether a corporate swine production facility shall be established, were 522 votes in favor and 784 votes against such establishment. Swine production facilities are not allowed to be established in Kearny County.

Pursuant to 1994 Session Laws of Kansas, Chapter 249, Section 1, the results of an election held in Pawnee County on November 8, 1994, on the question of whether certain business entities may establish dairy production facilities, were 1,367 votes in favor and 1,388 votes against such establishment. Dairy production facilities are not allowed to be established in Pawnee County.

Probate Code—Care and Treatment for Mentally Ill Persons—Sexually Violent Predator Act; Commitment to Secretary of Social and Rehabilitation Services; Escape Attempt; Use of Deadly Force. Charles E. Simmons, Acting Secretary, Kansas Department of Corrections, Topeka, November 10, 1994.

Where a Department of Corrections correctional officer has probable cause to believe that an escaping sexually violent predator poses a threat of serious physical harm during the escape, either to the officer or to others, it is not constitutionally unreasonable to prevent the escape by using deadly force. Criminal Procedure; Kansas Code of Criminal Procedure—Arrest—Jurisdiction of Certain Law Enforcement Officers; Authority of Tribal Law Enforcement Officers to Enforce State Law on the Reservation. Senator Don Sallee, 1st District, Troy, November 15, 1994.

Unless deputized or otherwise employed by the county in which the reservation is located, or some other appropriate state law enforcement authority, tribal law enforcement officers are not authorized to enforce state laws within the boundaries of the reservation even upon receiving certification from the Kansas Law Enforcement Training Commission. However, under the tribe's sovereign authority, and in order to preserve the peace, tribal law enforcement officers may detain persons who have committed an unlawful breach of the peace within the boundaries of the reservation and transport such persons, as far as the reservation border, to the proper authorities. What constitutes an "unlawful breach of the peace" will depend on the circumstances and the applicable law. Water right holders applying for a change in place of use must comply with K.S.A. 1993 Supp. 82a-708b. Subsection (a)(3) of that statute requires the applicant to demonstrate that the change in the water right would not divert water from a different local source of supply than was originally authorized by the water right in question. Taxation—Banks, Banking Businesses, Trust Companies and Savings and Loan Associations—National Banking Associations and State Banks; Tax Imposed; "Net Income" Defined. Vernon L. Jarboe, General Counsel, Department of Revenue, Topeka, November 17, 1994.

The tax imposed by K.S.A. 79-1107 on national banking associations and state banks for the privilege of doing business in this state is a franchise tax. K.S.A. 79-1109 requires those entities subject to the tax to add the amount of the tax paid the previous year to federal adjusted gross income for that year (if such taxes were deducted on the taxpayer's federal return) when determining "net income" for purposes of measuring the tax for the current year. This requirement does not result in violation of 12 U.S.C. § 3124, 12 U.S.C. § 548 or the equal protection provisions of the Kansas or United States constitutions. Failure of the Department of Revenue to correctly interpret the law in the past does not preclude the department from interpreting and administering it correctly in the future. Because the Kansas privilege tax is a tax measured by income within the meaning of K.S.A. 79-32,117(b)(ii), it must be added back to federal taxable income when computing income for privilege tax purposes.

Privilege taxpayers must add the taxes on or measured by income (which were deducted on the federal return) in arriving at federal taxable income. The Kansas Department of Revenue will implement the addition of taxes for all taxable years beginning after December 31, 1993 (privilege tax years 1995 and thereafter).

Adjustments may need to be made to any remaining 1995 privilege estimated tax payments to provide for this addition to federal taxable income.

Board of Cosmetology**Permanent Administrative
Regulations****Article 13.—INSPECTIONS**

69-13-1. Definitions. (a) "Board" means the Kansas state board of cosmetology.

(b) "Act" means Article 19 of Chapter 65 of the Kansas Statutes Annotated, entitled Examination and Registration of Cosmetologists and Beauty Shops.

(c) "Establishment" means any place where cosmetology, manicuring, or electrology is taught or practiced. (Authorized by K.S.A. 65-1907; implementing K.S.A. 65-1907 and K.S.A. 74-2702; effective Jan. 17, 1995.)

69-13-2. Routine inspections of establishments.

(a) Each establishment shall be subject to inspections, by the board or designated agents or employees of the board, to determine compliance with the act and all sanitary rules and regulations, at least once every year, but no more than twice during any 12-month period.

(b) Inspections shall be made between the hours of 8:00 a.m. and 6:00 p.m., or anytime the instruction or practice of cosmetology, manicuring, or electrology is being conducted, unless otherwise agreed by all interested persons or entities.

(c) Inspections shall be made by board members, the executive director of the board, or employees of the board.

(d) Inspections of establishments may be authorized by the board or its executive director.

(e) The authorized examination may be conducted without notice to the licensee. (Authorized by K.S.A. 65-1907; implementing K.S.A. 65-1907 and K.S.A. 2702; effective Jan. 17, 1995.)

69-13-3. Inspection generated by a complaint. (a) Each establishment shall be subject to inspection by the board or its designee, to investigate a specific complaint filed with the board, for violation of sanitary rules and regulations or other violations of the act.

(b) Any inspection generated by a complaint may be authorized by the board or its executive director at any time, but shall be limited as follows.

(1) Inspections shall be made only between the hours of 8:00 a.m. and 6:00 p.m. or anytime the practice or instruction of cosmetology, manicuring, or electrology is being conducted, unless agreed by all interested persons or entities.

(2) Inspections may be conducted by board members, the executive director of the board, or employees of the board. (Authorized by K.S.A. 65-1907; implementing K.S.A. 74-2702; effective Jan. 17, 1995.)

Regulations****Article 3.—INSTANT GAME RULES**

111-3-1. Definitions. The following definitions apply to all instant ticket games: (a) "Bare arm technique" means a type of drawing in which the person drawing the winning ticket from the receptacle or drum wears a short-sleeved (sleeve not extending past the elbow) or a no-sleeve shirt which exposes the drawer's bare arm.

(b) "Book" means a pack of fanfolded instant game tickets which are attached to each other by perforations, which perforations the retailer tears when selling a ticket from the book.

(c) "Book-ticket number" means the unique number appearing on each ticket which includes the number of the book from which it was removed and the serially assigned number of the ticket within that book. The book-ticket number is a number followed by a dash and then a 3-digit ticket number. The ticket numbers in each book start with 000. The book-ticket number is printed in black ink on the bottom right portion of the front of each instant game ticket without a bar code and on the bottom right portion of the back of each bar coded ticket below the bar code.

(d) "Claimant" means a holder of a ticket who presents it for payment of a prize.

(e) "Co-sponsor drawings" are the acts of drawing for prizes which may be held subsequent to the lottery drawings.

(f) "Co-sponsor(s)" means the person, retailer or organization designated by the executive director to assist in organizing and participating in the lottery drawings.

(g) "Drawings" are the acts of drawing prizes conducted by the Kansas lottery.

(h) "Drum" means a container which can be sealed and rotated for the purpose of mixing, and into which instant tickets are placed for the purpose of drawing preliminary and/or final drawing winners.

(i) "Executive director" means the executive director of the Kansas lottery, or the person designated by the executive director.

(j) "Instant game" means a lottery game in which a ticket is purchased by a player and the player can immediately determine whether he or she has won a prize by removing the removable covering on the ticket and comparing the exposed play numbers or symbols with those specified as winners in the published game rules for that instant game.

(k) "Lottery retailer" or "retailer" means a person or business authorized by the lottery to sell lottery tickets.

(l) "Lottery security" means the lottery security officer or a certified law enforcement officer(s) designated by the executive director or the person designated by the executive director.

(m) "Non-winning ticket" means any valid Kansas instant game lottery ticket not eligible to win a prize under any instant game rules.

(continued)

(n) "Participant" means any person, player, or contestant participating in a lottery game and anyone designated by a prize winner to appear on his or her behalf for any lottery game including any lottery drawing or televised draw show. In the event the prize winner or his or her designee fails to appear for a drawing or televised draw show, the executive director may designate an adult who may be a member of his staff to participate on behalf of the non-appearing prize winner. Any prize won by a participant appearing through a designee shall be payable to and delivered to the prize winner as provided by these rules and regulations.

(o) "Play area" is the portion of the front of each instant game ticket where the play or game symbols appear. It is covered by a removable layer of material which is intended to be removed ("scratched off") by the player to reveal the play or game symbols.

(p) "Play symbols" or "game symbols" are the numbers, letters, symbols, or pictures printed in the play area of each instant game ticket and which determine if the ticket holder is entitled to a prize.

(q) "Play symbol captions" or "game symbol captions" are the words or portions of words printed beneath each play or game symbol in the play area and are used to repeat or explain the play or game symbol. The play or game symbol caption associated with each play or game symbol is designated by the rules of the game.

(r) Prize tiers:

(1) "Low-tier prize" means a lottery instant game prize not exceeding \$25.00.

(2) "Mid-tier prize" means a lottery instant game prize of more than \$25.00 but not exceeding \$599.99.

(3) "High-tier prize" means a lottery instant game prize in excess of \$599.99.

(s) "Receptacle" means a container in which non-winning Kansas instant game lottery tickets are placed and from which the drawings are made. Receptacles shall be sealable and capable of being mixed.

(t) "Retailer validation code" means the small letters found under removable covering in the play area of each instant game ticket. The retailer uses this code to verify and validate winners which are to be paid by the retailer.

(u) "Special event" means a drawing or other method of awarding an additional prize or prizes within a group of lottery instant game winners as defined by the rules for a particular instant game.

(v) "Ticket holder" or "holder" means the person who has possession of an unsigned ticket or the person whose signature appears in the area upon a ticket designated for signature.

(w) "Ticket validation number" means a unique number appearing on each ticket which is used to validate winning tickets. The ticket validation number appears under the removable covering on the front of each instant ticket. (Authorized by and implementing K.S.A. 74-8710; effective, T-88-39, Oct. 15, 1987; amended, T-89-7, Feb. 26, 1988; amended, T-111-12-28-89, Dec. 21, 1989; amended, T-111-10-10-90, Sept. 15, 1990; amended, T-111-12-21-90, Dec. 14, 1990; amended, T-111-8-2-91, July 19, 1991; amended, T-111-12-20-93, Dec. 16, 1993; amended, T-111-11-8-94, Oct. 20, 1994.)

111-3-12. Determination of instant prize winners.

The following subparagraphs specify how an instant prize winner is determined for instant games:

(a) The player must remove or "scratch off" the removable layer of material covering the play area to reveal the play symbols and captions. If the designated number of play symbols match, the player wins the prize designated by the rules of the game.

(b) In any event, only the highest instant prize shall be paid on a given ticket unless it is a multiple game ticket.

(c) Once a player has collected a prize from a retailer, the player shall not be entitled to any other prize from the lottery whether or not the prize paid by the retailer was less than the prize to which the player was entitled.

(d) Only play symbols and validation numbers are used for determination of entitlement to instant prizes. Play symbol captions, agent validation codes, book-ticket numbers, any portion of the display printing and any extraneous materials are not play symbols or validation numbers, and shall not be usable or playable to win instant prizes.

(e) In all events, the determination of instant prize winners shall be subject to the general ticket validation requirements set forth in K.A.R. 111-3-13 and the requirements set forth on the back of each instant game ticket.

(f) An instant ticket is a bearer instrument. The prize payable for an instant ticket shall be paid to the bearer or holder thereof unless the ticket has been signed on the back. Once a ticket has been signed on the back, any prize payable for such ticket shall be paid to the apparent owner of the ticket as evidenced by such signature. The holder of a winning ticket shall sign his or her name on the back of the ticket.

(g) No particular prize may be paid more than once.

(h) All instant prizes must be claimed within 180 days following the termination of the game announced by the executive director, or in drawings involving non-winning instant tickets entered in a drawing, within 180 days of the drawing in which the prize was won. Any instant prize not claimed by such date and in the manner specified on the back of each ticket shall be forfeited. If a claim is to be mailed to the lottery, the envelope containing the winning ticket and the claim form must be postmarked within the 180-day limit noted above.

(i) The right of any person to a prize shall not be assignable, except that payment of any prize may be paid to the estate of a deceased prize winner or to a person designated pursuant to an appropriate judicial order. (Authorized by K.S.A. 74-8710 (b), (c), & (i); implementing K.S.A. 74-8710 (b), (c), & (i) and 74-8720 (b) & (d); effective, T-89-4, Jan. 21, 1988; amended, T-111-4-13-89, April 13, 1989; amended, T-111-3-14-90, March 2, 1990; amended, T-111-10-31-90, Oct. 19, 1990; amended, T-111-12-21-90, Dec. 14, 1990; amended, T-111-8-5-94, July 15, 1994; amended, T-111-11-8-94, Oct. 20, 1994.)

111-3-14. Payment of prizes. The procedures for payment of instant monetary prizes to the winners of the instant games are as follows:

(a) The executive director or his designee shall award the designated prize to the appropriate person as soon

as it is determined that all laws, regulations, and rules have been adhered to.

(b) Low-tier instant game prizes of \$25.00 or less shall be paid as follows:

(1) Present the ticket to any retailer. Upon receipt and computer validation of the ticket, the retailer shall immediately make payment for the prize to the claimant. If the retailer cannot validate the claim, the claimant shall fill out a claim form provided by the retailer and personally present or mail the completed form together with the ticket to Kansas lottery headquarters. If the claim is received and validated, then payment shall be made to the claimant by mail.

(2) Bring the ticket to any Regional office of the Kansas lottery during the hours that such office is open to the public for business. Upon receipt and verification of the claim, payment for such claim shall be made to the winner in the following manner:

(A) The prize for a validated free ticket winner redeemed in this manner shall be \$1.00 to be paid by the Kansas lottery.

(B) The prize for other validated low-tier winners redeemed in this manner shall be paid out of the lottery prize payment fund. Upon receipt and verification of the claim, the payment for the prize shall be mailed to the claimant.

(3) Mail the ticket with a completed claim form in any envelope to Kansas lottery headquarters. Claim forms can be obtained from any lottery instant game retailer or any office of the Kansas lottery. Upon receipt and verification of the claim, the payment for such claim shall be made to the winner in the following manner:

(A) The prize for a validated free ticket winner redeemed in this manner shall be \$1.00 which shall be paid by the Kansas lottery. Upon receipt and verification of the claim, the payment for the prize shall be mailed to the claimant.

(B) The prizes for other validated low-tier winners redeemed in this manner shall be paid out of the lottery prize payment fund. Upon receipt and verification of the claim, the payment for the prize shall be mailed to the claimant.

(c) Mid-tier game prizes in excess of \$25.00 but not exceeding \$599.99 shall be paid by any one of the following methods:

(1) Present the ticket to any authorized Kansas lottery retailer. Upon receipt and computer validation of the ticket the retailer shall immediately make payment of the prize to the claimant. A retailer choosing not to make the payment shall not computer validate the ticket, and the claimant may claim the prize at another retailer location or may claim the prize in another manner prescribed in these rules. On all mid-tier prizes not paid by the retailer, the winning ticket holder may elect to present or mail the winning ticket and claim form to the lottery. Claimant may request any Kansas lottery retailer to validate the claim by having the retailer call the lottery and validate the ticket. Although the ticket is validated, no authorization numbers will be provided the retailer when retailer is not paying the claim. No Kansas lottery retailer is entitled to any compensation for selling lottery tickets or shares, or paying claims, except as au-

thorized by contract and rules and regulations adopted by the lottery commission.

(2) Bring the ticket to any office of the Kansas lottery during the hours that such office is open to the public for business. Upon receipt and validation of the ticket, the payment for the prize shall be mailed to the claimant.

(3) Mail the ticket with a completed claim form in any envelope to the Kansas lottery headquarters. Claim forms can be obtained from any lottery instant game retailer or any office of the Kansas lottery. Upon receipt and validation of the ticket, the payment for the prize shall be mailed to the claimant.

(d) High tier instant game prizes in excess of \$599.99 shall be paid by any one of the following methods:

(1) Bring the ticket to any office of the Kansas lottery during the hours that such office is open to the public for business. Upon receipt and validation of the ticket, the payment shall be made to the claimant by the executive director by any means deemed appropriate. On all high-tier claims, should the winning ticket holder elect to mail the winning ticket and claim form to the lottery, claimant may insure validation by requesting any Kansas lottery retailer to verify the claim by having the retailer validate the ticket through the instant ticket validation system. Although the ticket is validated, no authorization numbers will be provided the retailer since retailer is not paying a high-tier claim.

(2) Mail the ticket with a completed claim form in any envelope to Kansas lottery headquarters. Claim forms may be obtained from any lottery instant game retailer or any office of the Kansas lottery. Upon receipt and validation of the ticket, the payment shall be made to the claimant by the executive director by any means deemed appropriate.

(e) Tickets submitted for payment of a prize shall become property of the lottery and shall not be returned to claimant. (Authorized by K.S.A. 74-8710(c); implementing K.S.A. 74-8710(c), 74-8712(a) and 74-8720(c); effective, T-89-4, Jan. 21, 1988; amended, T-89-7, Feb. 26, 1988; amended, T-111-7-7-88, July 5, 1988; amended, T-111-4-13-89, April 7, 1989; amended, T-111-12-28-89, Dec. 21, 1989; amended, T-111-4-26-90, April 6, 1990; amended, T-111-10-31-90, Oct. 19, 1990; amended, T-111-12-21-90, Dec. 14, 1990; amended, T-111-11-8-94, Oct. 20, 1994.)

111-3-19. (Authorized by and implementing K.S.A. 1987 Supp. 74-8710; effective, T-89-4, Jan. 21, 1988; amended, T-111-7-7-88, July 5, 1988; revoked, T-111-11-8-94, Oct. 20, 1994.)

111-3-25. Winner validation. The following validation requirements shall apply to all drawings conducted pursuant to K.A.R. 111-3-1 *et seq.* unless otherwise specified by individual game rules:

(a) Each ticket entered must be a valid non-winning Kansas instant game lottery ticket from any game specified by the rules and regulations of the drawing;

(b) The information form on the back of each ticket must be filled out in a legible manner;

(c) Each ticket must have been issued by the Kansas lottery in an authorized manner and must not be counterfeit in whole or in part;

(continued)

(d) Each ticket must be complete and intact and not mutilated, altered, unreadable, reconstructed, or tampered with in any way;

(e) Each ticket must not be blank or partially blank, misregistered, defective, or printed or produced in error;

(f) The display printing on each ticket must be regular in every respect and correspond precisely with the artwork on file at the Kansas lottery;

(g) Each ticket must not be stolen nor appear on any list of omitted tickets on file at the Kansas lottery;

(h) Each ticket must have exactly one ticket validation number, one book-ticket number, and a two-letter retailer validation code for non-barcoded tickets and a three-letter retailer validation code for barcoded tickets, each of which must be present in its entirety, be fully legible, be exactly as described in paragraph (d) above, and correspond precisely to the artwork on file at the Kansas lottery. Each ticket validation number shall correspond to the play symbols on the ticket;

(i) The ticket validation number of the tickets shall not appear on the Kansas lottery's official list of ticket validation numbers of winning tickets.

(j) Any ticket not passing all the validation checks in this section is void and is not eligible for drawings conducted pursuant to K.A.R. 111-3-1 *et seq.* (Authorized by and implementing K.S.A. 1991 Supp. 74-8710(b); effective, T-111-7-7-88, July 7, 1988; amended, T-111-5-28-91, May 24, 1991; amended, T-111-7-1-92, June 26, 1992; amended, T-111-11-8-94, Oct. 20, 1994.)

111-3-35. Return of unsold tickets. (a) A retailer may return unbroken books of unsold tickets anytime during the game and up until fifteen days after the expiration date of the game designated by the executive director. The amount of credit shall be based upon the number of unbroken books returned, as counted by the lottery, and the actual price paid for the tickets by the retailer.

(b) In the event the executive director announces the termination of a game and cessation of sales by retailers on a specific date, the lottery may reimburse retailers for one broken book of unsold tickets for that game from each cash register at the location where tickets are sold. The amount of credit shall be based upon the number of broken books returned, and the actual price paid for the tickets to be returned by the retailer. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-3-3-94, Feb. 25, 1994; amended, T-111-11-8-94, Oct. 20, 1994.)

Article 4.—INDIVIDUAL GAME RULES

RULES FOR INSTANT GAME NO. 82

"DOUBLE TAKE"

111-4-624. Name of game. The Kansas lottery shall conduct an instant winner lottery game entitled "Double Take" commencing on or after November 11, 1994. The specific rules for the "Double Take" game are contained in K.A.R. 111-3-1 *et seq.* and 111-4-624 through 111-4-627. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-11-8-94, Oct. 20, 1994.)

111-4-625. Definitions. The following definitions shall apply to the "Double Take" instant lottery game:

(a) "Game symbols" are the numbers, letters, symbols, or pictures printed in the play area of each instant

game ticket and which determine if the ticket bearer is entitled to a prize. In this instant game, the game symbols are printed in black ink in WGI Symbol Font 15 with matching symbols in WGI Cap Font. A game symbol appears in each of the six play spots within the play area. Each game symbol for this instant game is one of the following: \$1.⁰⁰ - \$5.⁰⁰ - 10.⁰⁰ - 20.⁰⁰ - \$2500 - \$5000 - \$\$.
