Department on Aging**Request for Proposals**

The Kansas Department on Aging is seeking applicants to provide education, training or services for the prevention of elder abuse, neglect or exploitation. The department has \$47,000 of Older Americans Act, Title VII, Chapter III funds for fiscal year 1995. Any Kansas non-profit or government organization including area agencies, SRS, adult abuse prevention advocacy groups, senior advocacy groups and nursing facility providers professional groups may apply for these funds. Only projects requesting \$12,000 or less will be considered.

Priority will be given to those applicants who want to provide education and/or training to adult protective services workers, in-home services case workers, law enforcement personnel, and long-term care direct care workers. Priority also will be given for a statewide training conference on self-neglect. Considered criteria include, but are not limited to, 1) experience in advocating for the prevention of elder abuse, neglect and exploitation, 2) commitment to preventing elder abuse, neglect and exploitation, 3) administrative capacity, and 4) brilliance.

Applicants' proposals must be at Kansas Department on Aging, Room 150-S, Docking State Office Building, 915 S.W. Harrison, Topeka, 66612-1500, by 5 p.m. September 15. Applicants will be notified of their selection by September 25. Funds are currently available for expenditure. Grant awards to obligate the funds must be signed on or before September 30. Funded applicants have until September 30, 1996, to expend the funds by providing the agreed upon services.

The Older Americans Act, Title VII, Chapter III, 1992 amendments contain the following requirements (extracted):

The state agency shall use the allotment made for activities to develop, strengthen, and carry out programs for the prevention and treatment of elder abuse, neglect and exploitation, including—

(1) providing for public education and outreach to identify and prevent elder abuse, neglect and exploitation;

(2) ensuring the coordination of services provided by area agencies on aging with services instituted under the state adult protection service program;

(3) promoting the development and data systems, including elder abuse, reporting systems, to quantify the extent of elder abuse, neglect and exploitation in the state;

(4) conducting analyses of state information concerning elder abuse, neglect, and exploitation and identifying unmet service, enforcement or intervention needs;

(5) conducting training for individuals, professionals or paraprofessionals, in relevant fields, on the identification, prevention and treatment of elder abuse, neglect and exploitation, with particular focus on prevention and enhancement of self-determination and autonomy;

(6) providing technical assistance to programs that provide or have the potential to provide services for victims of elder abuse, neglect and exploitation and for family members of the victims;

(7) conducting special and on-going training, for individuals involved in serving victims of elder abuse, neglect and exploitation, on topics of self-determination, individual rights, state and federal requirements concerning confidentiality, and other topics determined by a state agency to be appropriate.

"Highlights of a National Survey and Recommendations of Two Expert Panels, Executive Summary: Elder Abuse Training Priorities: Targets, Opportunities, and Strategies" is available by calling Wilda Davison at the Kansas Department on Aging, (913) 296-4986.

An "Application for Special Project Award," which is available from Wilda Davison, must be completed and the phone number and FAX number of the applicant agency should be provided. Also, in Section I-Statement of Application, a brief description of the experience of the applicant in the area of elder abuse, neglect and exploitation advocacy must be included.

Applicants must comply with applicable state and federal regulations.

Each successful applicant must submit a brief progress report (one page or more) of activities and accomplishments due January 15, 1996; April 15, 1996; and July 15, 1996. A final project report, which describes the outcomes and accomplishments, including recommendations for replication by others and a submission of products, materials and/or other information developed as a result, must be submitted by October 15, 1996. Financial reports are due quarterly on the same date as program reports.

The Department of Social and Rehabilitation Services is soliciting grant proposals for training attendants and coordinators of the Law Enforcement Attendant Care (LEAC) programs. The purpose of this project is to train attendants and coordinators that work with youth in a non-secure setting as an alternative to holding the youth in an adult jail or lock up. LEAC programs are designed so that counties can find a licensable room where they can take youth for up to 24 hours, excluding weekends and holidays. Trained attendants sit with the youth in eight-hour shifts. The state provides the training of attendants and reimburses the counties \$6 per hour for attendant services.

Applicants must demonstrate administrative capabilities to coordinate training for almost 40 county LEAC programs. Current available funding for training is \$40,000. It is expected that at least four coordinator and four attendant trainings will be provided through this project. This project minimally includes facility arrangements, policy training, new attendant training, material updates, a quarterly newsletter and quarterly data compilation.

Special Local Need Registration**

Notice is hereby given that pursuant to 7 U.S.C. 136v, Ciba-Geigy Corporation has filed an application for a special local need (SLN) registration for Dividend fungicide. Dividend is a systemic seed treatment that controls or suppresses certain seed-borne, soil-borne and fall season foliar diseases of wheat.

The current product label requires that within one year after planting Dividend treated seed, no other crop except wheat may be grown in treated fields. The purpose of this proposed SLN is to allow other crops to be grown as needed, after only 30 days, following the planting of Dividend treated seed. The proposed SLN registration would give producers more flexibility by allowing rotation to any crop, not just wheat.

Ciba-Geigy has provided data to the Kansas Department of Agriculture and the U.S. Environmental Protection Agency which confirms that seed treatment applications with Dividend would not transfer any appreciable residues to rotational crops planted 30 days after the planting of treated seeds.

Information submitted by the applicant is on file with the Kansas Department of Agriculture. Written comments, data, or other evidence supporting or opposing the proposed special local need registration may be submitted by September 18 to Gary E. Notice of Hearing on Proposed
Administrative Regulations

A public hearing will be conducted at 9 a.m. Friday, October 20, in the Kansas Racing Commission's conference room, 3400 S.W. Van Buren, Topeka, to consider the adoption of proposed permanent regulations of the Kansas Racing Commission. This 60-day notice constitutes a public comment period for the purpose of receiving written public comments on the proposed regulations.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting the secretary at the Kansas Racing Commission, (913) 296-5800.

A copy of the full text of the regulations and the economic impact statement may be reviewed or obtained at the commission office. The following is a summary of the proposed amendments:

K.A.R. 112-10-38. Vaccinations. This is a new regulation which is designed to safeguard the health of the greyhounds and the safety of their human handlers at race track facilities by requiring periodic vaccinations of each greyhound against each disease the animal health officer has determined is communicable to other greyhounds at the racing facility. The regulation requires that a record of vaccinations be maintained for each greyhound and proof of vaccinations be provided for new greyhounds coming to a race track before they may enter a race track facility.

Section (b) specifically requires every greyhound housed at a facility be vaccinated against rabies and receive an annual booster by a licensed veterinarian. Trainers or kennel owners shall provide a copy of the registration certificate, an individual certificate of identification for each greyhound brought to a racing facility, and a

small animal health certificate issued by the animal health division for the state or county of departure.

Economic Impact: The commission has agreed to bear the expense of vaccinating each greyhound at each of its racing facilities through November 30, 1995. The vaccine is purchased through the state contract system. For the beginning 1995 racing season, the commission purchased vaccine to vaccinate all greyhounds at the Wichita and Kansas City facilities (approximately 1,000 greyhounds per facility), for a total cost of \$916, or approximately 45 cents per greyhound. Based on figures for the year 1994, in which approximately 3500 greyhounds passed through the racing facilities, and with the addition of approximately 1,000 dogs anticipated to pass through the Camp-town facility, the commission anticipates a cost of \$2,025 to vaccinate all greyhounds through November 30, 1995.

Greyhound owners and/or trainers shall bear the expense of vaccinating each dog against diseases as determined by the animal health officer to be communicable to other greyhounds at the race track facility. The cost is estimated to range from \$3 to \$10 per dog depending on the number of dogs vaccinated at any one time and the fee the owner negotiates with his or her veterinarian.

If the commission chooses to continue to provide vaccinations by its veterinarians, owners and/or trainers may purchase the rabies vaccine from the commission at a cost of approximately 45 cents per dog. The cost of any other vaccinations depends on the disease to be vaccinated against.

K.A.R. 112-12-14. Registration of Arabian, Appaloosa, Paint and Standardbred horses. This regulation was first adopted as a temporary regulation on June 16, 1994, and later became effective as a permanent regulation, but was only effective through December 31, 1994. The commission, on March 10, 1995, voted to extend the regulation for one more year to continue to allow registration of minor breeds into the Kansas horse breeding development fund at a reduced rate.

Economic Impact: There are no costs anticipated to the agency or other governmental agencies or units. The cost to horse owners will be \$50 for registering each horse. The industry should see an increase in horses being eligible to race, increasing purses and the wagering dollars.

K.A.R. 112-16-14. Appeal, stewards' and racing judges' hearing. This regulation establishes the appeal procedure used by the commission stewards and racing judges for licensee hearings conducted at the Kansas race track facility for hearings that are not governed by the Kansas administrative procedures act. The amendment in this regulation allows for a decision on appeal to be affirmed. The term was inadvertently omitted in the original language in subsection (d).

Economic Impact: No costs are known; however, it is anticipated that the simplified procedures may mean some savings of expenses for licensees who will be able to appear immediately before the racing judges and stewards during the race meeting and not at a later day when most would probably have to travel a long distance to attend a hearing.

All interested parties may submit written comments prior to the hearing to the executive administrator of the Board of Nursing, Room 551-S, Landon State Office Building, 900 S. W. Jackson, Topeka, 66612. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing.

The proposed regulations and their economic impact follows.

Continuing Education for Nurses

K.A.R. 60-9-105. Definitions. Two new definitions have been added to the regulation with several revisions needed for clarification. These definitions for continuing nursing education (CNE) for nurses are utilized by licensees as well as by those providing continuing nursing education.

K.A.R. 60-9-106. License renewal. The regulation has been expanded to be more flexible for the professional or practical nurse in meeting continuing nursing education requirements for license renewal. All 30 hours of CNE may be obtained by independent study if an individual demonstrates extenuating circumstances. Also, use of fractions of CNE hours to meet requirements is being proposed. Additional changes are for clarification.

K.A.R. 60-9-107. Approval of continuing nursing education. This regulation delineates the requirements for providers of continuing nursing education. There have been a number of revisions reorganizing similar information into a more concise format. It is proposed that providers will have to submit less information on the annual report and will not have to send rosters to the board office. The board would also allow licensees to ask Kansas CNE providers to review and approve offerings that have not been approved by the board or offered by an approved provider.

K.A.R. 60-9-109. Exceptions. The exceptions to continuing nursing education requirements which were allowed in this regulation have been moved to K.A.R. 60-9-106(f), license renewal, and K.S.A. 65-1117, as presented and approved in 1995 Senate Bill 151. The board proposes revocation of this regulation.

Economic Impact

There should be no negative economic impact on the licensee in meeting continuing nursing education requirements for license renewal. Some licensees may have to obtain fewer classes since fractions of hours may be used.

Continuing nursing education providers will have some reduction of work with the changes in annual report requirements and preparation of rosters for the board. The providers will have the option of approving individual course requests. If they chose to approve the courses then they may be able to generate some revenues for their own programs.

The anticipated changes in these regulations will have minimal economic impact on the Board of Nursing staff.

A public hearing will be conducted at 9 a.m. Thursday, October 19, in the conference room in the office of the Kansas Real Estate Commission, Three Townsite Plaza, Suite 200, 120 S.E. 6th Ave., Topeka, to consider the adoption of proposed rules and regulations.

This 60-day notice of public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed regulations. All interested parties may submit written comments prior to the hearing to the Kansas Real Estate Commission, Suite 200, Three Townsite Plaza, 120 S.E. 6th Ave., Topeka, 66603-3511. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

These regulations are proposed for adoption on a permanent basis. A summary of proposed regulations and their economic impact follows.

86-1-10. Approval of courses of instruction, procedure. This regulation is amended to provide procedures whereby a school which is eligible under the statutes to offer courses approved by the commission may co-sponsor a course of a school which is not eligible. Amendments also provide that proctored examinations for correspondence courses must be closed-book examinations and that proctors must complete a certification form.

Licenses and course providers will benefit from the change, as co-sponsoring permits a greater number of courses to be offered. The potential economic impact cannot be quantified. The cost of a proctor signing a certification form for each examination administered will be minimal. Other governmental units, private citizens and consumers will not be affected by the amendments.

86-1-12. Monitoring courses; withdrawal of approval. The amendment is required to update references to other regulations. Other governmental units, private citizens and consumers will not be affected by the amendment.

86-1-13. Submission of evidence of course attendance. Amendments delete the requirement that licensees submit certificates to the commission and require licensees to retain certificates until after license renewal and furnish them to the commission upon request. The amendments will benefit both licensees and the agency.

Licenses will save the cost of mailing one to four certificates to the commission office each renewal period. The agency will benefit from time saved in opening mail, processing and filing certificates. Other governmental units, private citizens and consumers will not be affected by the amendments.

86-1-15. Change of last name. Amendments pertain to collecting or refunding a portion of the renewal fee when an expiration date is changed because of a change in a licensee's last name.

The economic impact is minimal. The current license must be returned for reissuance and the appropriate fee collected or refunded. Other governmental units, private citizens and consumers will not be affected by the amendments.

86-1-17. Responsibilities of schools. This new regulation includes provisions that have been deleted from 86-1-10. It also requires schools to furnish the commission a roster of students completing each course.

The cost to schools of providing rosters cannot be quantified. However, the cost is estimated to be minimal since course providers maintain records of students completing each course. Most providers already furnish rosters to the commission. Other governmental units, private citizens and consumers will not be affected by the regulation.

86-1-18. Alternative licensing criteria for broker applicants. An amendment to the license act passed by the 1995 Legislature permits the commission to waive or alter the experience requirements for a broker's license under certain conditions. The applicant must live in a county with a population under 20,000 and the commission must determine that the county suffers from a shortage of brokers. Under those circumstances, the commission may waive or alter the experience requirements for obtaining a broker's license. This new regulation sets forth criteria for such licenses.

The economic impact on applicants would be the cost of additional education that an applicant would be required to obtain. However, the education would be in lieu of obtaining additional experience as a salesperson. Consumers who live in the affected county would benefit. Other governmental units will not be affected by the regulation.

86-3-25. Disclosure of alternative agency relationships form. This new regulation prescribes a mandatory form which licensees must provide to prospective sellers and buyers of real estate.

The cost to the agency will be providing a camera-ready form to brokerage firms. The cost to firms will be the cost of reproducing the form and providing it to their licensees. Other governmental units, private citizens and consumers will not be affected by the regulation.

The Kansas State Treasurer shall serve as the bond registrar and paying agent for the bonds, and the principal of the bonds shall be payable upon surrender at the paying agent's principal offices in the city of Topeka, Kansas. Security for the Bonds

Temporary Administrative
Regulations

(Editor's note: The following regulations were published in the August 3, 1995, issue of the Kansas Register with an incorrect agency number. They are republished in this issue with the correct agency number of 122. The content of the regulations and their temporary effective dates are not changed.)

Article 1.—DEFINITIONS

122-1-1. Definitions. As used in these regulations: (a) the words and phrases defined by K.S.A. 75-4201 and amendments thereto shall have the meaning ascribed to them in such statute; and

(b) "chief investment officer" means the officer appointed by the board who is responsible for planning, directing and managing the investment programs of state moneys under the direction of the board in accordance with applicable statutes, rules and regulations and policies of the board. (Authorized by K.S.A. 1994 Supp. 75-4232; implementing K.S.A. 1994 Supp. 75-4222 and K.S.A. 75-4232; effective, T-122-7-27-95, July 27, 1995.)

Article 2.—DEPOSITORY BANKS

122-2-1. Qualifications for depository banks. (a) State moneys shall be deposited only in state financial institutions which have been determined to meet qualifications in this regulation for depository banks. Each depository bank shall be a state financial institution which has been determined by the board:

- (1) to have demonstrated credit-worthiness;
- (2) to have executed a security agreement with the board; and
- (3) to have executed a custodial agreement with the board.

(b) Moneys to be deposited in any state financial institution shall not be deposited until the financial institution's board of directors has executed and adopted the security agreement and custodial agreements required under subsection (a). Alternatively, moneys which may be invested in state financial institutions may be invested with such financial institutions in the form of a repurchase agreement wherein the state takes delivery of the underlying securities. (Authorized by K.S.A. 1994 Supp. 75-4232; implementing K.S.A. 1994 Supp. 75-4205, 75-4208, K.S.A. 1994 Supp. 75-4209, as amended by 1995 SB 9, Sec. 2, K.S.A. 1994 Supp. 75-4217, and 75-4218; effective, T-122-7-27-95, July 27, 1995.)

122-2-2. Collateral. (a) Each state bank account shall be fully collateralized at all times based on securities set out under K.S.A. 75-4201(p), and amendments thereto. Such securities shall be priced on a market value basis. The aggregate market value of the securities shall be sufficient to equal the outstanding amount of state funds deposited, plus accrued interest on the state funds, less federal deposit insurance coverage.

(b) The qualified depository institution shall ensure that deposits and accrued interest are always sufficiently collateralized. Sufficiency of collateral values shall be val-

idated by the board based on information received from the treasurer.

(c) Each qualified depository institution depositing securities with a custodial bank shall enter into a written custodial agreement with the custodial bank and the board for the safekeeping of the securities.

(d) Collateral based on corporate surety bonds as provided under K.S.A. 75-4201 shall be subject to the following requirements:

(1) The surety bonds shall be approved by the Kansas commissioner of insurance and shall be in a standard format approved by the treasurer.

(2) The issuer of the surety bond shall be admitted and licensed to issue surety bonds in Kansas.

(3) The treasurer shall be designated as the insured public depositor.

(4) The issuer and the qualified depository institution shall notify the treasurer by certified or registered mail no less than 90 days prior to non-renewal and no less than 45 days prior to cancellation of a surety bond.

(5) The ability of the issuer to pay claims shall be rated and shall remain rated in the highest rating category of one of the nationally recognized rating agencies acceptable to the treasurer. Within 48 hours of discovery of a downgrade of an issuer by a rating agency or notice of financial regulatory action by any jurisdiction in which the issuer is licensed, the issuer shall notify the treasurer by certified or registered mail.

(6) An issuer of a surety bond shall not provide surety bonds for any one qualified depository institution in an amount which exceeds 10% of surplus as regards policyholders of the surety bond issuer, minus reinsurance, as reported to the Kansas commissioner of insurance.

(7) No more than \$1,000,000, plus 50% of the collateral of a qualified depository institution in excess of \$1,000,000, may be in the form of surety bonds, and no more than \$100,000,000 of total state deposits may be collateralized in the form of surety bonds.

(8) The issuer shall send quarterly reports to the treasurer listing all Kansas banks which have purchased a surety bond for deposits, the insured amount covering deposits of the treasurer, and the total insured amount per qualified depository institution in the state of Kansas, noting the retainage and reinsured amounts for each qualified depository institution.

(e) Collateral based on a letter of credit shall be subject to the following requirements:

(1) The letter of credit must be in a format approved by the treasurer.

(2) The treasurer shall be designated as the irrevocable and unconditional beneficiary of the letter of credit.

(3) The issuer and the qualified depository institution shall notify the treasurer by certified or registered mail no less than 45 days prior to cancellation or non-renewal of a letter of credit.

(4) The securities of the issuer shall be rated, and shall remain rated, in the highest rating category of one of the nationally recognized rating agencies acceptable to the treasurer. Within 48 hours of discovery of a downgrade of an issuer by a rating agency, the issuer shall give notice to the treasurer by certified or registered mail.

(5) The issuer shall not provide letters of credit for any one qualified depository institution in an amount which exceeds 10% of the issuer's capital and surplus. (Authorized by K.S.A. 1994 Supp. 75-4232; implementing K.S.A. 1994 Supp. 75-4218; effective, T-122-7-27-95, July 27, 1995.)

Article 3.—INVESTMENT OF STATE MONEYS

122-3-1. Investment principles. (a) All state moneys which are available for investment shall be invested by the board in a manner which will:

(1) be consistent with the prudent person standard established under K.S.A. 1994 Supp. 75-4209, and amendments thereto; and

(2) conform to provisions of applicable laws governing the investment of state moneys.

(b) The primary objectives of the board's investment actions, in the following priority order, shall be considered in evaluating potential and existing investments.

(1) Safety. The foremost objective of investments shall be safety of the principal. Each investment of state moneys shall be undertaken in a manner that seeks to ensure preservation of capital.

(2) Liquidity. The second objective shall be to maintain sufficient liquidity to enable the state to meet all operating requirements which might be reasonably anticipated and meet the daily cash flow demands of the state.

(3) Return on investment. Each investment shall be designed with the objective of attaining a reasonable rate of return consistent with the above objectives.

(c) The investment portfolios shall be diversified so as to minimize exposure of state moneys to losses due to issuer defaults, market price changes, technical complications leading to temporary lack of liquidity, or other risks resulting from an over-concentration of assets in a specific maturity, a specific issuer, a specific geographical distribution, or a specific class of securities. (Authorized by and implementing K.S.A. 1994 Supp. 75-4232; effective, T-122-7-27-95, July 27, 1995.)

122-3-2. Portfolio management. (a) Following the primary objective of preservation of capital, each investment portfolio shall be actively managed to take advantage of market opportunities. In so doing, negotiable securities may be sold prior to their maturity for the purpose of:

(1) providing liquid funds as needed for cash flow purposes;

(2) enhancing portfolio returns; or

(3) restructuring maturities to increase yield, decrease risk or both.

(b) On and after January 1, 1996, exchanges of investments between the municipal investment pool fund and state money investments under paragraph (a)(2) of K.S.A. 1994 Supp. 75-4209, as amended, shall require the prior approval of the pooled money investment board and the state finance council. (Authorized by K.S.A. 1994 Supp. 75-4232; implementing K.S.A. 1994 Supp. 75-4232, K.S.A. 1994 Supp. 75-4209, as amended by 1995 SB 9, Sec. 2, and K.S.A. 1994 Supp. 12-1677a, as amended by 1995 SB 9, Sec. 1; effective, T-122-7-27-95, July 27, 1995.)

122-3-3. Investment instruments; requirements. (a) Except as otherwise authorized by statutes applicable to

a specific fund that is created by statute or by bond documents, investments of state moneys shall be limited to those instruments permitted under K.S.A. 1994 Supp. 75-4209, and amendments thereto.

(b) Repurchase agreements may be made in accordance with K.S.A. 1994 Supp. 75-4209(a)(2)(B) and amendments thereto. Reverse repurchase agreements may be made in accordance with K.S.A. 1994 Supp. 12-1677c and 75-4212a, and amendments thereto.

(c) Such repurchase and reverse repurchase agreements may be made only with Kansas banks and dealers that have entered into fully executed master repurchase agreements on file with the board.

(d) Except as otherwise authorized by the board, the market value of the securities underlying any repurchase agreement shall be maintained with a market value of at least 102% of the amount of the repurchase agreement. If market value of the securities falls below 102% of the amount of the repurchase agreement, additional securities shall be required to attain full security unless otherwise authorized by the board. (Authorized by and implementing K.S.A. 1994 Supp. 75-4232; effective, T-122-7-27-95, July 27, 1995.)

122-3-4. Maturity. (a) In scheduling the maturities of investment portfolios, projected cash flows shall be considered.

(b) Except as authorized by statute for specific investments, investment maturities of state moneys shall be limited to the lesser of:

(1) four years, pursuant to K.S.A. 1994 Supp. 75-4209(g) and K.S.A. 1994 Supp. 12-1677a, and amendments thereto, for all investments other than mortgage-backed securities; or

(2) the maturity date for securities obtained through repurchase agreements.

(c) The maturity of investments of municipal investment pool funds shall be consistent with the weighted average maturity limitations set out in K.S.A. 1994 Supp. 12-1677a, as amended. (Authorized by K.S.A. 1994 Supp. 75-4232 and K.S.A. 1994 Supp. 12-1677a, as amended by 1995 SB 9, Sec. 1; implementing K.S.A. 1994 Supp. 75-4209, as amended by 1995 SB 9, Sec. 2, K.S.A. 1994 Supp. 75-4232, and K.S.A. 12-1677a, as amended by 1995 SB 9, Sec. 1; effective, T-122-7-27-95, July 27, 1995.)

122-3-5. Investment transactions; requirements for brokers and dealers. (a) Investment transactions shall be conducted only with qualified institutions. Qualified institutions shall be limited to:

(1) qualified depository banks;

(2) the federal reserve bank in Kansas City, Missouri;

(3) primary government securities dealers, as defined in K.S.A. 75-4209 and amendments thereto; or

(4) broker-dealers engaged in the business of selling government securities which are registered in compliance with section 15 or 15C of the securities exchange act of 1934 and K.S.A. 17-1254, and amendments thereto.

(b) Before conducting any transactions, each broker-dealer conducting investment transactions with the board shall document compliance with registration requirements by providing to the board:

(1) proof of certification by the national association of security dealers;

(continued)

- (2) proof of Kansas registration; and
 (3) upon request of the board or its designee:

(A) a copy of the broker-dealer's most recent, audited annual financial statement; and

(B) a copy of the broker-dealer's most recent, unaudited quarterly financial statement. (Authorized by and implementing K.S.A. 1994 Supp. 75-4232; effective, T-122-7-27-95, July 27, 1995.)

122-3-6. Competitive selection of investment instruments. Each security transaction, other than directly-issued instruments, securities in syndicate or specially bid or offered securities, shall be executed through a competitive process involving solicitation of bids or offers from qualified institutions as set out in K.A.R. 120-3-5. When purchasing a security, the offer which provides the highest anticipated current and future rate of return and which meets the investment objectives of the portfolio shall be accepted. When selling a security, the bid which generates the highest sales price shall be accepted. (Authorized by and implementing K.S.A. 1994 Supp. 75-4232; effective, T-122-7-27-95, July 27, 1995.)

122-3-7. Safekeeping and custody. All security transactions entered into by the board pursuant to K.S.A. 75-4209(a)(2) and amendments thereto, including securities underlying repurchase agreements, shall be conducted on a delivery versus payment basis. Securities shall be held by the treasurer or a third-party custodian designated by the treasurer, as evidenced by safekeeping receipts held by the treasurer or a third-party custodian. (Authorized by and implementing K.S.A. 1994 Supp. 75-4232; effective, T-122-7-27-95, July 27, 1995.)

122-3-8. Conflicts of interest. (a) Except upon unanimous vote of the board members voting, no investment of any state moneys shall be made when one or more members, officers or employees of the board has personal business activity that:

(1) conflicts with proper execution of that investment; or

(2) could impair the ability of that member, officer or employee to make an impartial decision regarding that investment.

(b) Each investment officer and investment analyst appointed by the board shall disclose to the board any material financial interest in any financial institution that conducts business within the state and any personal financial or investment position that is related to the performance of any investment of the board. Each investment officer and investment analyst shall subordinate the officer's or analyst's personal investment transactions to those of the board, particularly with regard to timing of purchases and sales. (Authorized by and implementing K.S.A. 1994 Supp. 75-4232; effective, T-122-7-27-95, July 27, 1995.)

122-3-9. Performance monitoring. The performance of each investment portfolio shall be continually monitored and evaluated by the chief investment officer using investment strategies developed under the investment principles of K.A.R. 120-3-1. External comparative performance reviews shall be conducted as the board deems necessary. Summary reports shall be provided on a monthly basis for the board and annually for the legislature as required by statute. (Authorized by and imple-

menting K.S.A. 1994 Supp. 75-4232; effective, T-122-7-27-95, July 27, 1995.)

122-3-10. Chief investment officer qualifications. The chief investment officer shall meet qualifications established by the board with respect to:

(a) education and training in a finance-related field;

(b) experience as an investment or trust officer for a financial institution, association or corporation or experience in a finance-related field;

(c) experience in money market and fixed-income investments; and

(d) supervisory experience.

(Authorized by K.S.A. 1994 Supp. 75-4232; implementing K.S.A. 1994 Supp. 75-4222 and 75-4232; effective, T-122-7-27-95, July 27, 1995.)

Article 4.—MUNICIPAL INVESTMENT POOL

122-4-1. Municipal investment pool; earnings. (a) All investments in the municipal investment pool shall be managed as a single portfolio. Participants' earnings for the various investment options available to participants shall be based on a daily quoted rate factor which shall be determined in accordance with this regulation.

(b) All participants' earnings on investments in the municipal investment pool shall be calculated using the daily quoted factors that are determined each day. Each participant's earnings shall be credited to the participant's account on the last calendar day of the month.

(c) A daily quoted rate factor shall be specified for each investment option available to participants. The daily quoted rate factor shall be determined by the chief investment officer, subject to directives of the board. In determining the daily quoted rate factor for each such investment option, consideration shall be given to the duration of the deposits, the interest rates available from competing investments available to participants, yield factors of the municipal investment pool and other factors deemed relevant by the Board.

(d) Any portion of the daily yield on investments in the municipal investment pool that is not credited to participants' accounts pursuant to subsection (b) or (c) or credited to the municipal investment fee fund shall be placed in the municipal investment pool reserve fund. (Authorized by and implementing K.S.A. 1994 Supp. 12-1677a, as amended by 1995 SB 9, Sec. 1; effective, T-122-7-27-95, July 27, 1995.)

Article 5.—INVESTMENT ACCOUNTS IN QUALIFIED BANKS

122-5-1. Money available for investment. (a) In order to make state moneys available for investment pursuant to subsection (a)(1) of K.S.A. 1994 Supp. 75-4209 and amendments thereto, the board shall periodically, and at least annually, review and determine the liquidity needs of the state, the varying maturities of the investment accounts to be offered, and the amount of state moneys to be invested in each of the maturities offered.

(b) In conducting the review and making the determinations, consideration shall be given to the following factors:

(1) historical state cash-flow trends;

- (2) anticipated periods of peak disbursements and revenue receipts;
- (3) maturities of existing investments;
- (4) anticipated future expenditures and receipts;
- (5) contingencies for unanticipated obligations;
- (6) unforeseeable occurrences or unascertainable effects of foreseeable occurrences; and
- (7) general economic conditions of the state. (Authorized by K.S.A. 1994 Supp. 75-4232; implementing K.S.A. 1994 Supp. 75-4209, as amended by 1995 SB 9, Sec. 2; effective, T-122-7-27-95, July 27, 1995.)

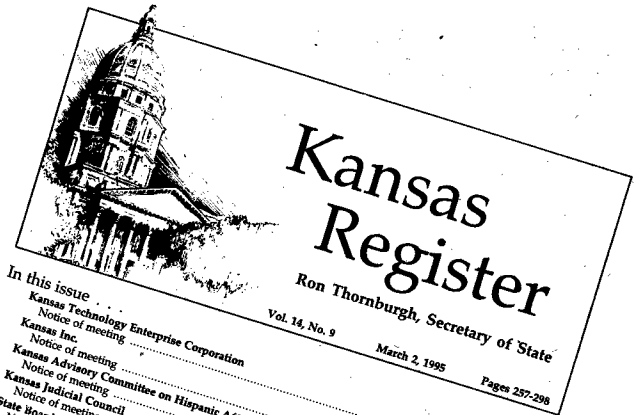
