Riley County is applying for a \$15,000 Solid Waste Management Base Grant from the Kansas Department of Health and Environment for the purpose of providing salaries for personnel conducting eligible base grant activities. Eligible base grant activities for which the grant is sought include: (1) public education and training, (2) solid waste management planning expenses, (3) solid waste reduction, reuse and recycling projects, (4) household hazardous waste management, and (5) closure and postclosure monitoring of old disposal areas. The county is seeking proposals from qualified contractors interested in providing the personnel services for these activities.

Description of Services Required

The selected contractor would be asked to perform the following tasks on an ongoing basis:

1. Prepare, publish and distribute the annual Flint Hills Recycling Directory; provide recycling information to the general public; and give solid waste/recycling presentations to schools, churches and civic organizations.
2. Provide coordination of all Riley County recycling programs.
3. Organize meetings of the Riley County Solid Waste Management Committee and the recycling subcommittee and prepare updates to the Riley County Solid Waste Management Plan under their direction.
4. Provide management of the Riley County Household Hazardous Waste program and facility.
5. Provide management of the postclosure monitoring activities of the closed Riley County Landfill.

Qualifications

The contractor should have a broad background in solid waste management activities including public education and awareness programs, planning, recycling programs, household hazardous waste program management, and management of landfill postclosure monitoring activities.

Kansas Commission on Governmental Standards and Conduct**Advisory Opinion No. 95-14**

Written August 17, 1995, to Robert Burtch, Information Writer II, Kansas Arts Commission, Topeka.

This opinion is in response to your letter of August 2, 1995, in which you request an opinion from the Kansas Commission on Governmental Standards and Conduct concerning the state conflict of interest laws (K.S.A. 46-215 *et seq.*).

Factual Statement

We understand you request this opinion in your capacity as Information Writer II for the Kansas Arts Commission. You advise us that the primary business of this agency is to grant state and federal funds to other governmental entities and not-for-profit organizations incorporated in the state of Kansas.

You further advise us that in your position with the state you are responsible for writing and editing publications about your agency's funding programs. You do not make decisions about which organizations receive funding, or how much funding they receive. Applications for funding are evaluated by panels of citizens and commissioners who submit their recommendations for funding to the full commission for formal action.

You are an alternate delegate to the board of directors of the Topeka Center for Peace & Justice, a not-for-profit organization. Although you are an alternate, the center lists you as a member of its board and you have served as a full board member in the past.

The Topeka Center for Peace & Justice has submitted to the Kansas Arts Commission an application for funding from one of its programs. You are concerned about a possible conflict of interest and the possibility that you may have to resign from the center.

Question

Is it permissible to serve on the board of directors of an organization which requests funding from the state agency where you are employed?

Opinion

K.S.A. 46-233, as amended by the 1995 Session Laws of Kansas, Chapter 77, Section 1, and K.S.A. 46-229 apply to your situation.

K.S.A. 46-233(a) states:

No state officer or employee shall in the capacity as such officer or employee be substantially involved in the preparation of or participate in the making of a contract with any person or business by which such officer or employee is employed or in whose business such officer or employee or any member of such officer's or employee's immediate family has a substantial interest and no such person or business shall enter into any contract where any state officer or employee, acting in such capacity, is a signatory to, has been substantially involved in the preparation of or is a participant in the making of such contract and is employed by such person or business or such officer or employee or any member of such officer's or employee's immediate family has a substantial interest in such person or business. Substantial interest means "sub-

stantial interest" as defined by K.S.A. 46-229, and amendments thereto, and any such interest held within the preceding twelve months of the act or event of participating in the preparation of making a contract.

Whenever any individual has, within the preceding two years participated as a state officer or employee in the making of any contract with any person or business, such individual shall not accept employment with such person or business for one year following termination of employment as a state officer or employee.

K.S.A. 46-229(d) states:

If an individual or an individual's spouse holds the position of officer, director, associate, partner or proprietor of any business, the individual has a substantial interest in that business, irrespective of the amount of compensation received by the individual or individual's spouse.

Under K.S.A. 46-229(d), you do hold a "substantial interest" in the Topeka Center for Peace & Justice by serving on its board of directors. Therefore, under K.S.A. 46-233, you could not participate, as a state officer or employee, in the preparation of or participate in the making of contracts or awarding of grants between the Arts Commission and the center.

As we understand the situation you have described, in your official capacity with the state you have no control over what organizations receive funding from the Arts Commission. Your job duties are to write and edit publications about funding programs and not to prepare or participate in the making of contracts or awarding of grants.

Therefore, since you do not, in your capacity as a state officer or employee, prepare or participate in the making of any contracts or awarding of grants between the Arts Commission and the Topeka Center for Peace & Justice, there is not a conflict of interest under the situation you have described, and you may continue to serve on the center's board of directors.

Advisory Opinion No. 95-15

Written August 17, 1995, to William F. Caton, President, Kansas Development Finance Authority, Topeka.

This opinion is in response to your letter of July 31, 1995, in which you request an opinion from the Kansas Commission on Governmental Standards and Conduct concerning the state conflict of interest laws (K.S.A. 46-215 *et seq.*).

Factual Statement

We understand you request this opinion in your capacity as president of the Kansas Development Finance Authority (hereinafter K DFA). You advise us that the K DFA regularly engages financial professionals and institutions to provide services for the issuance of bonds. Most housing bond issues require the use of a trustee. Generally, the trustee is a local or regional financial institution.

You further advise us that a K DFA board member has deposit relationships with several financial institutions that issue bonds or act as trustees. The board member has no other relationship to these financial institutions other than monetary deposits.

(continued)

The board members are normally not involved in the selection process on housing bond issues, as the borrower usually selects the finance team, including the trustee. When the K DFA selects a trustee, it is usually through a competitive selection process.

Question

Is it a conflict of interest if a K DFA board member participates, in his official capacity, in engaging a trustee financial institution if the member has a deposit relationship with that financial institution?

Opinion

K.S.A. 46-233, as amended by the 1995 Session Laws of Kansas, Chapter 77, Section 1, and K.S.A. 46-229 apply to your question.

K.S.A. 46-233(a) states:

No state officer or employee shall in the capacity as such officer or employee be substantially involved in the preparation of or participate in the making of a contract with any person or business by which such officer or employee is employed or in whose business such officer or employee or any member of such officer's or employee's immediate family has a substantial interest and no such person or business shall enter into any contract where any state officer or employee, acting in such capacity, is a signatory to, has been substantially involved in the preparation of or is a participant in the making of such contract and is employed by such person or business or such officer or employee or any member of such officer's or employee's immediate family has a substantial interest in such person or business. Substantial interest means "substantial interest" as defined by K.S.A. 46-229, and amendments thereto, and any such interest held within the preceding twelve months of the act or event of participating in the preparation of making a contract.

Whenever any individual has, within the preceding two years participated as a state officer or employee in the making of any contract with any person, or business, such individual shall not accept employment with such person or business for one year following termination of employment as a state officer or employee.

K.S.A. 46-229 states:

"Substantial interest" means any of the following: (a) If an individual or an individual's spouse, either individually or collectively, has owned within the preceding 12 months a legal or equitable interest exceeding \$5,000 or 5% of any business, whichever is less, the individual has a substantial interest in that business.

(b) If an individual or an individual's spouse, either individually or collectively, has received during the preceding calendar year compensation which is or will be required to be included as taxable income on federal income tax returns of the individual and spouse in an aggregate amount of \$2,000 from any business or combination of businesses, the individual has a substantial interest in that business or combination of businesses.

(c) If an individual or an individual's spouse, either individually or collectively, has received directly or indirectly in the preceding 12 months, gifts or honoraria having an aggregate value of \$500 or more from any person the individual has a substantial interest in that person. If a gift is received for which the value is unknown, the individual shall be deemed to have a substantial interest in the donor. A substantial interest does not exist under this subsection by reason of: (1) A gift or bequest received as

the result of the death of the donor; (2) a gift from a spouse, parent, grandparent, sibling, aunt or uncle; or (3) acting as a trustee of a trust for the benefit of another.

(d) If an individual or an individual's spouse holds the position of officer, director, associate, partner or proprietor of any business, the individual has a substantial interest in that business, irrespective of the amount of compensation received by the individual or individual's spouse.

(e) If an individual or an individual's spouse receives compensation which is a portion or percentage of each separate fee or commission paid to a business or combination of businesses, the individual has a substantial interest in any client or customer, who pays fees or commissions to the business or combination of businesses from which fees or commissions the individual or the individual's spouse, either individually or collectively, received an aggregate of \$2,000 or more in the preceding calendar year.

As used in this subsection, "client or customer" means a business or combination of businesses.

K.S.A. 46-233 prohibits a state officer or employee, in the capacity of a state officer or employee, from participating in the making of contracts between the state and any person or business in which a "substantial interest" is held. As we understand the situation you describe, the board member has no other relationship with any financial institution that comes before the K DFA, other than a deposit relationship. A deposit relationship does not create a "substantial interest," as defined by K.S.A. 46-229, in the financial institutions that come before the K DFA.

Therefore, because the board member does not hold a "substantial interest" in the financial institutions that come before the K DFA, he may participate on behalf of the state in the making of contracts with these institutions.

Advisory Opinion No. 95-16

Written August 17, 1995, to Roger Werholtz, Deputy Secretary of Corrections, Division of Programs and Staff Development, Department of Corrections, Topeka.

This opinion is in response to your letter of August 1, 1995, in which you request an opinion from the Kansas Commission on Governmental Standards and Conduct concerning the state conflict of interest laws (K.S.A. 46-215 et seq.).

Factual Statement

We understand you request this opinion in your capacity as Deputy Secretary of Corrections. You advise us that in this capacity you are responsible for the delivery of staff development and training programs, as well as the delivery of offender treatment and education services.

Due to your job responsibilities, you receive several solicitations to buy training, educational or treatment packages. You recently were solicited by the Franklin Quest Company, which markets a time management package, to attend a program on time management. The company wants to then sell a time management package to the Department of Corrections.

You mention that since there are numerous training programs on the market, you are unwilling to commit

department resources without knowing the content and quality of the package. When you mentioned this to the Franklin Quest representative, he offered to allow two of your staff to attend a session in Topeka at no charge. You believe the retail value of these registration tickets is well in excess of \$40.

Question

Is it permissible to attend or send employees to a training seminar or similar event when the cost of the event is paid for by the organization hosting the event?

Opinion

K.S.A. 46-237(a) and (c), as amended by the 1995 Session Laws of Kansas, Chapter 173, Section 3, relate to your question. Those subsections state:

(a) No state officer or employee, candidate for state office or state officer elect shall accept, or agree to, accept any economic opportunity, gift, loan, gratuity, special discount, favor, hospitality, or service having an aggregate value of \$40 or more in any calendar year from any one person known to have a special interest, under circumstances where such person knows or should know that a major purpose of the donor is to influence such person in the performance of their official duties or prospective official duties.

(c) No person licensed, inspected or regulated by a state agency shall offer, pay, give or make any economic opportunity, gift, loan, gratuity, special discount, favor, hospitality, or service having an aggregate value of \$40 or more in any calendar year to such agency or any state officer or employee, candidate for state office or state officer elect of that agency.

We first note that since the Franklin Quest Company itself is not licensed, inspected or regulated by you or your agency, the prohibitions found in K.S.A. 46-237(c) do not apply to this situation.

The question then turns to the application of K.S.A. 46-237(a). In K.A.R. 19-40-3a(b)(2)(A), "gift" was defined to exclude "goods or services which are provided to a state agency which does not license, inspect nor regulate the giver and are used to benefit the state as a whole." This commission has consistently held that in situations such as this where the state agency would have paid the costs of attending the seminar and the seminar serves a valid state interest, the state and not the individual employee is being benefitted.

Therefore, so long as your agency authorizes and would pay for the costs of attending the seminar, it is permissible for the company to pay for the costs of the registration tickets. However, if your agency would not authorize or be willing to pay for the costs of attending the seminar, then the employee, and not the state, would be receiving the benefit and the \$40 gift limitation in K.S.A. 46-237(a) would apply.

The commission suggests that the state pay for the cost of the seminar to avoid any possible appearance of impropriety.

Regulations****Article 1.—LOW-INCOME/COMMUNITY
DEVELOPMENT CREDIT UNIONS**

121-1-1. Low-income credit union non-member shares. (a) Designation of low-income status. A credit union may apply to the administrator for designation as a low-income credit union. A credit union may be designated by the administrator as a low-income credit union if the administrator determines that it is in the public interest that the administrator designate the credit union as a low-income credit union and that:

(1) a majority of members of the credit union are low-income members; or

(2) the credit union's field of membership is limited to geographic areas in which the majority of the residents, if members of the credit union, would be low-income members.

(b) Requirements. A credit union designated by the administrator as a "low-income credit union" may accept payments on shares from non-members of the credit union only if:

(1) the credit union has adopted and follows a written plan meeting the requirements of K.A.R. 121-1-1(e);

(2) the administrator approves the plan;

(3) at or before the time the credit union first receives a payment on shares from any non-member, and annually thereafter, the credit union provides to each non-member shareholder a written share account disclosure statement meeting the requirements of K.A.R. 121-1-1(f);

(4) except as provided in K.A.R. 121-1-1(g), the maximum amount of non-member shares outstanding at any time does not exceed 20 percent of the total shares of the credit union or \$1,500,000, whichever is greater; and

(5) the administrator has not revoked the designation of the credit union as a "low-income credit union."

(c) Maturity. Shares from non-members may be issued either with a fixed maturity not to exceed five years or without a fixed maturity. For shares issued without a fixed maturity, the terms of account required by K.A.R. 121-1-1(e) shall provide the credit union with the right to require up to 60 days advance notice before such shares may be withdrawn from the credit union.

(d) Uses. Except as limited by K.A.R. 121-1-1(g), a low-income credit union may use the payments on shares from non-members for any purpose permitted by law.

(e) Plan for non-member shares. Each plan for non-member shares shall include:

(1) a detailed statement specifying the credit union's need for, amount of, and sources and intended uses of non-member shares;

(2) the terms of the account, including maturity, dividend rate and calculation disclosures, withdrawal restrictions, and balance requirements;

(3) the credit union's loan and investment policies;

(4) the credit union's latest income statement and balance sheet;

(5) a pro forma income statement and balance sheet reflecting the issuance and uses of the amount of non-member shares specified in K.A.R. 121-1-1(e)(1); and

(6) a copy of the credit union's proposed disclosure statement meeting the requirements of K.A.R. 121-1-1(f).

(f) Required disclosure. Each non-member share account disclosure statement shall include:

(1) a statement that non-member shares do not provide the owner with membership or voting rights in the credit union;

(2) a statement that non-member shares are subject to the same statutory provisions as other shares of the credit union, including:

(A) the credit union's lien and right of set-off on non-member shares and dividends thereon;

(B) the proportionate reduction in the liability of the credit union to shareholders in accordance with the provisions of K.S.A. 17-2225 and amendments thereto;

(C) the priority in liquidation or dissolution of the credit union; and

(D) limitations on the credit union's ability to pay dividends; and

(3) the terms of the non-member share account, including the maturity, dividend rate and calculation disclosure, withdrawal restrictions and account balance requirements.

(g) Authority to receive additional payment on non-member shares. A low-income credit union may accept payments on shares from non-members in excess of the limitations provided in K.A.R. 121-1-1(b)(4) only if:

(1) the amounts in excess of the limits imposed by K.A.R. 121-1-1(b)(4) are used to fund loans to members; and

(2) the maximum amount of non-member shares outstanding at any time does not exceed \$5,000,000.

(h) Removal of designation as low-income credit union.

(1) The designation of a credit union as a low-income credit union may be removed by the administrator:

(A) at the request of the credit union if the administrator determines that such action will not adversely affect the members of the credit union and that such action would be in the public interest; or

(B) if, following notice to the credit union and the opportunity for a hearing, the administrator determines that the credit union no longer meets the criteria to be a low-income credit union and that removal of the designation is in the public interest.

(2) Immediately following the removal of the designation as a low-income credit union, the credit shall give written notice to all members of the removal of the designation.

(i) Redemption of non-member shares. If the designation as a low-income credit union is removed in accordance with K.A.R. 121-1-1(h), the credit union shall give written notice to each non-member shareholder:

(1) that the credit union is no longer eligible to receive payments on shares from non-members;

(2) that all non-member share accounts will be closed;

(3) that all shares of non-members will be redeemed without any early withdrawal penalty; and

(4) of the date of the redemption. The redemption date shall be as follows.

(A) The redemption date for shares issued either with a fixed maturity or with a notice period prior to withdrawal, shall be no later than the maturity date of such shares, or if the non-member gives or has given the required notice of withdrawal, the date on which such shares would be redeemed in accordance with the terms of the account for such shares, or 90 days after the effective date of removal of the designation as a low-income credit union, whichever occurs first;

(B) The redemption rate for shares issued without a fixed maturity shall be no later than the date the non-member requests withdrawal of such shares in accordance with the terms of account for such shares, or 90 days after the effective date of removal of the designation as a low-income credit union, whichever occurs first. 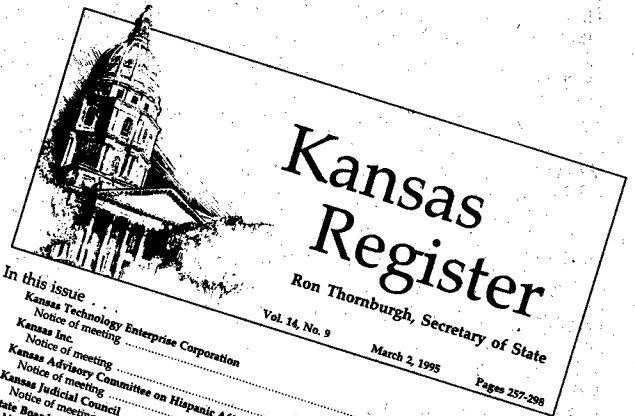
