Grant funds are available from the Federal Violence Against Women Grant Program for the fiscal year, November 1, 1996, through October 31, 1997. The purpose of this grant program is to fund units of state or local government and private not-for-profit organizations to develop strategies to combat violent crimes against women and to develop and enhance victim services in cases involving violent crimes against women.

The allocation of grant awards must reflect that 25 percent of each federal fiscal year grant will be allocated to each of the following areas: law enforcement, prosecution/courts, nonprofit victim service providers, and discretionary funds. Federal S.T.O.P. Violence Against Women Grant funds cannot be used to supplant state and local funds that would otherwise be available for targeting violent crimes against women.

Tobacco-Use Prevention Projects**

Kansas SmokeLess Kids Initiative, Inc., in cooperation with the Kansas Health Foundation, announces the availability of applications for a Community Tobacco Use Reduction Initiative (CTRI) grant.

Priority for an award may be given to Kansas communities and coalitions which are not presently funded by the Kansas Department of Health and Environment and the Kansas Health Foundation. The program's purpose is to foster projects focusing on social changes to reduce the physical and economic impact of tobacco use on Kansans, particularly children and teens. One community will be awarded funds of up to \$10,000 for tobacco-use prevention projects.

The method of selection for the grant is competitive. A diverse committee will review all letters of intent, and those accepted will be required to complete an application packet. From the completed packets, one community will be chosen. Proposals with a focus on environmental or social change, rather than behavioral change, will be given priority. The deadline for the letters of intent is November 29. Notification of application packets will be by January 3, 1997, and final award will be made by March 10, 1997.

**Notice of Hearing of Proposed
Administrative Regulations**

A public hearing will be conducted by the Wildlife and Parks Commission at 7 p.m. Thursday, November 7, at the Gateway Community Center, 1 Morgan Drive, Oberlin (southwest corner of Highway 36 and Highway 83), to consider the approval and adoption of two department regulations. There will be a public comment period at the beginning of the evening meeting for any issues not on the agenda, and additional comment periods will be available during the meeting on agenda items.

A workshop meeting on business of the Wildlife and Parks Commission will begin at 1:30 p.m. November 7 at the location listed above. The public also will be given the opportunity to comment on any nonagenda items at the beginning of and during the afternoon meeting on agenda items. The meeting will recess at 5 p.m., then resume at 7 p.m. at the same location for the regulatory hearing. Old and new business also may be discussed at this time. If necessary to complete the hearing or other business matters, the commission will reconvene at 9 a.m. November 8 at the same location.

If notified in advance, the department will have an interpreter available for the hard of hearing. To contact the department for this or any other reason, members of the public with a hearing impairment may call the TDD service at 1-800-766-3777. All public meeting areas are accessible to those who are physically disabled.

This 30-day notice period prior to the hearing constitutes a public comment period for the purpose of receiving written public comments on the proposed regulations.

All interested parties may submit written comments prior to the hearing to the chairman of the commission, Kansas Department of Wildlife and Parks, Suite 502, Landon State Office Building, 900 S.W. Jackson, Topeka, 66612. All interested parties will be given a reasonable opportunity at the hearing to express their views orally in regard to the adoption of the proposed regulations. During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending and approving, or rejecting the proposed regulations.

The regulations that will be heard during the regulatory hearing portion of the meeting are as follows:

K.A.R. 115-25-6. Turkey; spring season, bag limit, permits and game tags. This proposed exempt regulation will establish the spring archery and firearm turkey hunting seasons, hunting units, permit allowances and bag limits. Application dates are included. An extension of the season by one week is proposed.

Economic Impact Summary: It is estimated that 21,000 permits and 6,800 game tags would be issued, resulting in department revenue of approximately \$448,000. Certain businesses providing goods and services will benefit from sportsmen hunting turkeys. Revenue to the department represents a cost to sportsmen; however, such cost is voluntary.

K.A.R. 115-25-14. Fishing; creel limit, size limit, possession limit and open season. This proposed exempt regulation would establish the 1997 fishing seasons and limits. Included is a listing of those bodies of water open to trout fishing and the period of time that a trout permit will be required. The addition of one body of water to those listed for trout fishing is proposed.

Economic Impact Summary. Some additional fishing permits will be sold due to the addition of one body of water to those eligible for trout fishing. Otherwise, no change in the economic impact of fishing is anticipated, as the regulation basically continues 1996 fishing regulations.

Article 8.—BOARD ELECTION

80-8-2. Nominations. Any member who desires to be a candidate for election to the board may have the member's name placed on the ballot by submitting a petition to the board which meets the following conditions. (a) Each petition shall be accompanied by the signatures of at least 100 members of the system who desire to have the petitioner's name on the ballot. Each signature shall include the signer's social security number. The signature of each active member shall include the name of the member's current employer. The signature of each retired member shall include the name of the signer's employer at the time of retirement. The petition shall be in a form provided by the system.

(b) Each petition shall be submitted together with the petitioner's resume of qualifications. The resume shall be limited to 150 words and shall contain only biographical data. The petitioner's views on issues and other election comments shall not be permitted. The resume shall be in a form provided by the board.

(c) The executive secretary shall verify each petitioner's membership in the system and the signature and membership of at least 100 of the signers of each petition.

(d) The notice to submit petitions shall be distributed in the year preceding the year in which the term of an elected trustee expires. The notice shall announce the forthcoming election, and shall contain any other information the executive secretary deems appropriate.

(e) Each petition shall be received in the system's office on or before 5:00 p.m. on November 30 in the calendar year preceding the expiration of the term of an elected trustee and shall be verified only for the election announced in the notice described in paragraph (d) above.

(f) When there is only one nomination for a vacancy, the candidate shall be declared to be elected to the board at the April meeting.

(g) System employees shall not be nominated and shall not stand for election to the KPERS board of trustees.

(h) School members may only nominate and vote for school members. Non-school members may only nominate and vote for non-school members.

80-8-3. Voting. (a) Voice Response Voting.

(1) Contents.

(A) Candidate listings shall be prepared by the executive secretary and shall:

(i) List in alphabetical sequence the names of the candidates; and

(ii) contain a resume of not more than 150 words listing the qualifications of each candidate.

(B) Separate candidate listings shall be prepared for the board position for a school member and the board position for a non-school member, as necessary.

(2) Distribution.

(A) A candidate listing shall be distributed to each member in March of the calendar year in which the term of an elected trustee expires. Active member candidate listings shall be distributed to active members through the employers' designated agents. Retired member candidate listings shall be distributed directly to retired members by mail.

(B) The system shall maintain a listing of the names and social security numbers of each member to whom a candidate listing was sent.

(3) Voting will be by voice response using touchtone telephones.

(A) In accordance with subsection (a)(2)(B) of Section 7 of Pub. L. 93-579 (5 U.S.C. § 552a note) and K.A.R. 80-4-1, because KPERS uses social security numbers for the purpose of maintaining member records, the member's social security number shall be the voter registration number for this election process. Use of the social security number in this process shall be mandatory. There shall be no public disclosure of the social security numbers.

(B) Each member shall have from receipt of the candidate listing until April 30 to vote by touchtone telephone using a voice response system.

(C) The system shall keep a daily record of the number of votes received.

(b) Alternate voting method.

(1) The system shall set up an alternate method of voting for those individuals who may not have access to a touchtone telephone. Under the alternate method the member calling will be identified using the member's social security number. An alternate paper ballot shall be mailed to the member which the member shall return postmarked by 5:00 p.m. on April 30 as specified in paragraph (a)(3)(B) above.

(A) In accordance with subsection (a)(2)(B) of Section 7 of Pub. L. 93-579 (5 U.S.C. § 552a note) and K.A.R. 80-4-1, because KPERS uses social security numbers for the purpose of maintaining member records, the member's social security number shall be the voter registration number for this election process. Use of the social security number in this process shall be mandatory. There shall be no public disclosure of the social security numbers.

(B) The postmark date on the return envelope shall determine whether the alternate paper ballot has been returned within the prescribed period. The system shall date stamp all envelopes which are either hand delivered, not postmarked or received by the system after the last day for the return of alternate paper ballots.

(C) Each alternate paper ballot received after the time prescribed for the return of ballots shall be kept separately for inspection and disposition by the election committee.

(D) The system shall keep a daily record of the number of alternate paper ballots received.

(2) Tallying of alternate paper ballots.

(A) The system may tally the number of alternate paper ballots not earlier than four days after the last day for the return of alternate paper ballots by mail.

(B) Votes shall not be counted for write-in candidates. Alternate paper ballots where the number of votes exceeds the number of positions available shall not be counted. No alternate paper ballot containing an erasure shall be counted. Alternate paper ballots shall be marked pursuant to the instructions contained on the ballot or as provided by the system. The election committee shall be the sole judge as to the validity of any questionable ballot.

(C) Each alternate paper ballot which has been tallied shall be held by the system for a period of at least 30 days following the day when the last successful candidate takes office.

(c) Tallying of total vote count. After the final alternate paper ballot votes are counted, the votes shall be combined with the voice response totals to determine the winning candidates.

(d) Recounts.

(1) A recount of an election may be ordered by the board when the election plurality of the winning candidate over the candidate with the next highest number of votes is less than one percent of the total number of votes cast for all candidates contesting for the vacancy.

(2) Any candidate may request a recount, providing the candidate pays the total cost of the recount in advance.

80-8-4. Election committee. (a) The executive secretary shall appoint an election committee of three members who shall supervise the voting process. This supervision shall include the following:

- (1) tallying the voice response votes;
- (2) opening and tallying the alternate paper ballots; and
- (3) certifying to the board the results of the election upon completion of the tally.

(b) The election committee shall also supervise the tallying of votes for any recount.

FOR PUBLIC PURPOSES

1-18-1a. Mileage rates. (a) Subject to the provisions of subsection (d), each employee who has been authorized to use a privately-owned conveyance to engage in official business for an agency shall be entitled to reimbursement for use of that conveyance at the following rates:

- (1) 14¢ per mile for the use of a privately-owned motorcycle;
- (2) 30¢ per mile for the use of a privately-owned automobile;
- (3) 42¢ per mile for the use of a privately-owned airplane; or
- (4) 42¢ per mile for the use of a specially equipped van for the physically handicapped.

(b) In addition to the mileage allowance authorized under subsection (a) of this regulation, the employee may be reimbursed for:

- (1) parking fees when on an official trip;
- (2) toll road and toll bridge costs; and
- (3) airplane landing and tie-down fees.

(c) When an employee travels by privately-owned airplane, reimbursement may be made for one round trip in a privately-owned automobile or taxi fare charged in travel:

(1) between the official station or domicile and the airport in the city in which the official station or domicile is located; and

(2) between the airport in the destination city and the place of official business.

(d) Exceptions to the mileage rates prescribed in subsection (a) shall be as follows.

(1) When a mode of transportation is available and is less costly than transportation by privately-owned conveyance, mileage payments for use of a privately-owned conveyance shall be limited to the cost of that other mode of transportation.

(2) An agency may pay a specified mileage rate that is lower than prescribed by subsection (a) when an employee's travel is not required by the agency and the employee is informed of the specified rate in advance of the travel.

(3) For employees of the state of Kansas only, any state employee choosing to use a privately-owned automobile when a state-owned or leased vehicle, as defined by K.A.R. 1-17-1, is available for use shall be reimbursed at the central motor pool rate for compact cars, unless:

(A) the employee's agency head or the agency head's designee determines that the use of a state-owned or leased vehicle would be more expensive than the use of the employee's privately-owned automobile; or

(B) the employee has a disability which requires the use of a privately-owned vehicle which is specially equipped. (Authorized by and implementing K.S.A. 75-

Article 18.—KANSAS ATHLETE AGENT ACT
