Notice of Hearing on Proposed
Administrative Regulations

A public hearing will be conducted at 10:30 a.m. Monday, December 23, in the third floor conference room, Kansas Insurance Department, 420 S.W. 9th, Topeka, to consider the adoption of proposed changes in existing rules and regulations of the Kansas Insurance Department.

The 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments prior to the hearing to Anne Haught, Kansas Insurance Department, 420 S.W. 9th, Topeka, 66612-1678. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing.

A summary of proposed regulations and their economic impact follows.

K.A.R. 40-1-42. Diskette filing and filing quarterly financial statements. The regulation describes the manner in which annual financial statements are to be filed. In addition, the regulation requires certain Kansas companies to file quarterly financial statements and describes the manner in which they are to be filed. There should be minimal economic impact.

K.A.R. 40-1-43. Reinsurance trust instruments. The proposed regulation sets forth minimum provisions that are to be included in a trust instrument used for reinsurance purposes. The economic impact should not be significant.

K.A.R. 40-1-44. Actuarial opinion and memorandum. The primary purpose of the proposed regulation is to prescribe guidelines and statements of actuarial opinion and memoranda which pertain to all life insurance companies and fraternal benefit societies. There should be minimal economic impact.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Anne Haught at (913) 296-2188.

Request for Proposals

The Kansas Supreme Court is soliciting grant requests for its Access to Justice Fund. Grants shall be used solely for the purpose of making grants for operating expenses to programs, including dispute resolution programs, which provide access to the Kansas civil justice system for persons who would otherwise be unable to gain access to civil justice. Such programs may provide legal assistance to pro se litigants, legal counsel for civil and domestic matters, or other legal or dispute resolution services provided the recipient of the assistance or counsel meets financial qualifications under guidelines established by the program in accordance with grant guidelines promulgated by the Kansas Supreme Court.

The services provided should help lessen the burden pro se litigation imposes on the district courts. The financial qualifications temporarily established by the Kansas Supreme Court are set at or below 200 percent of the poverty guidelines.

Construction of walkways and boardwalks
for the Santa Fe Trail National Historic Site

This project is located on the north side of U.S. 50 about 9 miles west of Dodge City and about 1/2 mile east of the Ford-Gray county line. There is an existing parking lot near the Santa Fe Trail at this location.

Some of the proposed work is within the U.S. 50 Highway right-of-way, and some is located on adjacent land owned by the Boot Hill Museum.

The project consists of colored concrete sidewalk construction; natural color concrete sidewalk construction; removal of existing structures; grading, including stripping, hauling, placing and compacting "special topsoil" obtained from an on-site source; placing geotextile fabric; and furnishing, placing and compacting granular fill.

Other items included in the work includes: (1) relocation of two stone and concrete historic monuments, (2) temporary construction fencing, (3) split rail fencing, (4) pavement markings and accessible parking sign, (5) seeding disturbed areas, and (6) erosion control.

All equipment, materials and workmanship must be in accordance with the Standard Specifications for State Road and Bridge Construction of the Kansas Department of Transportation, 1990 Edition, with all supplemental specifications and the special provisions as included herein.

Copies of the contract documents are on file with the office of the Ford County Public Works Director, 100 Gunsmoke. Bidders and suppliers may secure a set of such documents (except the standard specifications) for the project from the county engineer's office for \$20. No refund will be made for the return of plans and specifications. Three additional sets of documents (except the standard specifications) will be furnished to the successful bidder.

No bidder may withdraw its bid for a period of 30 days after the date of the opening of bids.

The bidder to whom a contract is awarded will be required to furnish performance and statutory bonds acceptable to Ford County, each in the amount of the total contract price in conformity with the requirements of the contract documents.

The award of bid will be based on the base bid, and will not include alternate bid items.

The right is reserved by the county (owner) to reject any or all bids and to waive any or all information therein, to determine which is the lowest responsive bid most suitable to the county, and to approve the bonds.

Sealed bids for K-150 (Nall to State Line Road) median landscaping and irrigation, KDOT Project No. 150-46 TE-0020-01 STP-T002(001), will be received by the City of Leawood, Kansas, at the office of the Leawood city clerk until 2 p.m. November 26. At that time all sealed bids will be transferred to the first floor main conference room, City Hall, where they will be publicly opened and read aloud. Any bid received after the designated closing time will be returned unopened.

All bids shall be submitted in sealed envelopes addressed to the Leawood city clerk and marked "Bid for: K-150 (Nall to State Line Road) Median Landscaping and Irrigation, KDOT Project No. 150-46 TE-0020-01 STP-T002(001)."

Copies of plans, specifications, bid documents and other contract documents are on file at the office of Howard, Needles, Tammen & Bergendoff, Inc., 7007 College Blvd., Suite 150, Overland Park, Kansas. Contractors desiring the contract documents for use in preparing bids may obtain a set of such documents from HNTB upon payment of \$50, which amount is not refundable.

Contractors should read and be fully familiar with all contract documents before submitting a bid. In submitting a bid, the bidder warrants that it has read the contract documents and is fully familiar therewith and that it has visited the site of the work to fully inform itself as to all existing conditions and limitations and shall include in its bid a sum to cover the cost of all items of the work.

Should a bidder find "defects" as defined in paragraph GC-2 of the general conditions, it shall follow the procedures outlined in paragraph GC-3 to bring same to the attention of city. Changes necessitated thereby shall be in the form of an addenda issued by the consulting engineer.

All bidders shall verify that they have considered all written addenda. Neither the city nor the consulting engineer shall be responsible for oral instructions.

Any written addenda issued during the time of bidding shall be covered and included in the bid. There will be no clarifications or exceptions allowed on the bid. Bids are for a total bid package, total contract price.

Bids shall be completed upon the form provided, in ink or typewritten. Numbers shall be stated both in writing and in figures, the signature shall be long hand, and the complete form shall be without alteration or erasure. On alternate items for which a bid is not submitted, a written

indication of "no bid" on the bid form is required. No oral, telegraphic, facsimile or telephonic bids or alterations will be considered.

The following items must be included in the sealed envelope with the bid:

- a. Bid
- b. 5% Bid security—bid bond, cashier's check or certified check (see below)
- c. Signed documents (KDOT certifications)
 - Acknowledgement of contractor's obligation under the Davis-Bacon Act and agreement to submit verification of adherence
 - Certifications regarding noncollusion and history of debarment
 - Certification—federal funds—lobbying
 - Required contract provision certification—contractual services with current legislator or legislator's firm

Each bidder shall file with its bid a bid bond, a cashier's check or a certified check drawn on any acceptable bank, made payable to the City of Leawood, Kansas, in an amount of not less than 5 percent of the total bid, which shall be retained by the City of Leawood until a contract for the project has been executed. Bid bonds will be returned to the unsuccessful bidders, with the exception of the second qualifying bidder, at such time as their bids are rejected. The bid deposit of the successful bidder and the second qualifying bidder will be returned when satisfactory bonds in an amount equal to 100 percent of the contract amount, required insurance certificates and other required documents have been furnished and the contract documents have been executed.

In the event the successful bidder is unable to execute the contract, for whatever reason, the city may exercise its legal prerogatives, including, but not limited to, enforcement of its rights as to the bid security.

The city reserves the right to accept or reject any and all bids. Bids may be modified or withdrawn by written request of the bidder received in the office of the city clerk prior to the time and date for bid opening, provided, however, that no bidder may withdraw its bid for a period of 30 days from the date set for the opening thereof. All bidders agree that rejection shall create no liability on the part of the city because of such rejection, and the filing of any bid in response to this invitation shall constitute an agreement of the bidder to these conditions.

The purpose of the fish barriers is to prevent the loss of fish from the state fishing lakes from high-flow events without affecting the safety of the dam. Kansas Commission on Governmental Standards and Conduct**Advisory Opinion No. 96-16**

Written May 22, 1996, to all interested persons:

Pursuant to K.S.A. 25-4159, the Kansas Commission on Governmental Standards and Conduct takes the opportunity to issue its opinion on the permissible use of campaign funds by candidates and elected officeholders who are under the purview of the Kansas Campaign Finance Act (K.S.A. 25-4142 et seq.).

Opinion

K.S.A. 25-4157a(a) states:

No moneys received by any candidate or candidate committee of any candidate as a contribution under this act shall be used or be made available for the personal use of the candidate and no such moneys shall be used by such candidate or the candidate committee of such candidate except for legitimate campaign purposes, for expenses of holding political office or for contributions to the party committees of the political party of which such candidate is a member.

For the purpose of this section, expenditures for "personal use" shall include expenditures to defray normal living expenses for the candidate or the candidate's family and expenditures for the personal benefit of the candidate having no direct connection with or effect upon the campaign of the candidate or the holding of public office.

To be a permissible use of campaign funds, an expenditure must be for a legitimate campaign purpose, an expense of holding political office or a contribution to a party committee. In order to be a "legitimate campaign purpose or an expense of holding political office," the expenditure must have a "direct connection with or effect upon the campaign of the candidate or the holding of public office." All other expenditures are for personal use, and thus are prohibited. The commission has provided the following examples of expenses to be used as a guide for candidates and officeholders when making an expenditure from campaign funds.

Examples of Permissible Expenditures from Campaign Funds**Computers, Telefacsimile Machines and Cellular Telephones**

While expenditures for these types of items may be necessary for campaign purposes or holding office, they also have the potential to be used for the personal benefit of the candidate. Therefore, the commission advises all candidates and officeholders to refrain from using any items, purchased with campaign funds, for his or her personal use. Items purchased entirely with campaign funds may not be used for personal use.

Advertisements in Publications

The purchase of campaign ads in publications of charitable and civic organizations, yearbooks, school papers, etc., is a permissible expenditure.

Payment of Auto Expenses

One of the following options can be selected for the payment of auto expenses:

1. A candidate or officeholder can be reimbursed from his or her campaign fund for auto expenses up to \$.29 per mile. Any extraordinary maintenance or repairs will be determined on a case-by-case basis.
2. A candidate or officeholder can be reimbursed from his or her campaign fund for gas, oil and normal maintenance for automobiles used on campaign business. Any questions about what constitutes normal maintenance will be decided on a case-by-case basis.

Detailed records of these expenditures must be kept to substantiate any legitimate auto expenses.

Meals for Campaign Workers

Meal expenses may be permissible as a legitimate expense. However, the simple description of "lunch" or "food" on a candidate's receipts and expenditures report will not be sufficient to justify the expense. It will be necessary for the expenses of the meal to be described as for a campaign meeting, a political planning or strategy session, or for a campaign work session to be allowable.

Examples of Impermissible Expenditures from Campaign Funds

Donation to Charities and Local Fundraising Endeavors

Donations or contributions to charities and local fundraising endeavors, no matter how worthy the cause, are not permissible. This prohibition includes buying livestock at 4-H fairs.

Memberships to Civic and Fraternal Organizations

Dues to these types of organizations are not allowed. This prohibition includes membership dues paid to Chambers of Commerce, Kiwanis and Rotary.

Memberships and Dues to Country Clubs and Private Dinner Clubs

Expenditures for memberships and dues to country clubs and private dinner clubs are considered to be for the personal benefit of the candidate or officeholder and thus are prohibited. The commission does not believe it is necessary to entertain state clients, constituents or campaign workers at private clubs when there are facilities available to the general public that do not require memberships.

Mailing of Christmas Cards and Purchase of Office Decorations

These types of expenditures are considered to be for the personal benefit of the candidate or officeholder and thus are prohibited.

Purchasing or Renting Formal Wear for Governmental and Political Functions

Expenditures for buying or renting formal wear are considered to be for the personal benefit of the candidate or officeholder and thus are prohibited.

In closing, the commission suggests that candidates and officeholders seek guidance from the commission's staff prior to using any campaign funds for expenses that may be considered questionable.

Nothing in this opinion precludes a candidate or officeholder from using his or her own personal funds for the payment of any of these expenses.

Advisory Opinion No. 96-17

Written May 22, 1996, to Jerry Magnuson, Project Director, Department of Administration, Division of Purchases, Topeka.

This opinion is in response to your letter of May 13, 1996, in which you request an opinion from the Kansas Commission on Governmental Standards and Conduct concerning the state level conflict of interest laws (K.S.A. 46-215 et seq.). We note at the outset that the commission's jurisdiction concerning your question is limited to the application of K.S.A. 46-215 et seq., and whether some other statutory system, common law theory or agency rule and regulation applies to your inquiry is not covered by this opinion.

Factual Statement

We understand you request this opinion in your capacity as project director for the statewide personnel/payroll system (SHaRP) operated by the Department of Administration. You advise us that after a negotiated bid

process, Andersen Consulting was selected to provide services for SHaRP. As the assigned project director, you took part in the negotiated bid process with Andersen Consulting. This initial contract was executed on April 26, 1994, and several amendments have been made to the contract since that time.

Andersen Consulting subcontracted some of the software application for SHaRP to PeopleSoft. PeopleSoft is not a direct contractor with the state other than a licensing agreement for the use of software to protect copyright interests.

The project is now essentially complete, and your role as project director will no longer be required. You have the opportunity to work for either Andersen Consulting or PeopleSoft once the project is completed this summer.

Question

Is it a violation of the state level conflict of interest laws for a state employee to participate in a negotiated bid with an entity, and then accept employment with that entity after terminating state employment?

Opinion

K.S.A. 46-233 applies to your situation. That statute states in pertinent part:

(a) . . . Whenever any individual has, within the preceding two years participated as a state officer or employee in the making of any contract with any person or business, such individual shall not accept employment with such person or business for one year following termination of employment as a state officer or employee.

(d) Subsections (a) and (b) shall not apply to the following:

(1) Contracts let after competitive bidding has been advertised for by published notice; and

The commission first notes that in KCGSC Opinion 95-19, we stated that a "negotiated bid" was not a "competitive bid" for purposes of the exception found in K.S.A. 46-233 (d) (1). Therefore, this subsection would not apply to your situation. Thus, if you have participated in the amendments to the original contract within the past two years, you could not accept employment with Andersen Consulting for one year.

Based on the information you provided, we understand that PeopleSoft was merely a subcontractor of Andersen, and only entered into one initial contract directly with the state. Therefore, if you did not participate in PeopleSoft's initial contract with the state, or if you did participate and that contract was executed more than two years ago, you could accept employment with PeopleSoft upon terminating your state employment. This opinion is based on the understanding that PeopleSoft and Andersen Consulting are wholly separate legal entities.

Advisory Opinion No. 96-18

Written May 22, 1996, to William D. Grant, Jr., General Counsel, Office of the State Bank Commissioner, Topeka.

This opinion is in response to your letter of April 12, 1996, in which you request an opinion from the Kansas Commission on Governmental Standards and Conduct concerning the state level conflict of interest laws (K.S.A. 46-215 et seq.). We note at the outset that the commission's jurisdiction concerning your question is limited to

the application of K.S.A. 46-215 et seq., and whether some other statutory system, common law theory or agency rule and regulation applies to your inquiry is not covered by this opinion.

Factual Statement

We understand you request this opinion in your capacity as general counsel for the Office of the State Bank Commissioner. You advise us that a field examiner (employee) for the Bank Commissioner's office has an opportunity to participate in a program to market long distance telephone services. Businesses, including Kansas state-chartered banks, are potential purchasers of the service. The employee would not be involved in directly marketing the product to any Kansas state-chartered banks; however, individuals recruited to be part of the employee's marketing team would conduct direct marketing activities toward banks.

In the event that a member of the employee's marketing team would solicit a bank, the employee would not have any knowledge of which bank was being approached. The employee would not identify any banks as potential clients, nor would the employee's name ever be mentioned to a bank during the marketing process. While the employee would not directly supervise the members of the team, the employee would receive compensation from each sale.

Question

Do the solicitation and sale of the service by the employee's team member to a Kansas state-chartered bank constitute a violation of the state level conflict of interest laws?

Opinion

We have reviewed the state level conflict of interest laws in their entirety, and two sections may apply to your situation. K.S.A. 46-236 in pertinent part states:

No state officer or employee, candidate for state office or state officer elect shall solicit any economic opportunity, gift, loan, gratuity, special discount, favor, hospitality, or service from any person known to have a special interest, under circumstances where such officer, employee, candidate or state officer elect knows or should know that a major purpose of the donor in granting the same could be to influence the performance of the official duties or prospective official duties of such officer, employee, candidate or state officer elect.

K.S.A. 46-286 (a) states:

No state officer or employee, in the officer's or employee's official capacity, shall participate directly in the licensure, inspection or administration or enforcement of any regulation of or in any contract with any outside organization with which the officer or employee holds a position.

As you correctly note in your letter, so long as the employee does not solicit (K.S.A. 46-236) or hold a position with (K.S.A. 46-286) any Kansas state-chartered bank, the situation you describe would not be a violation of the state level conflict of interest laws.

Advisory Opinion No. 96-19

Written May 22, 1996, to William Caton, Member, Pooled Money Investment Board, Topeka.

This opinion is in response to your letter of May 21, 1996, in which you request an opinion from the Kansas

Commission on Governmental Standards and Conduct concerning the state level conflict of interest laws (K.S.A. 46-215 et seq.). We note at the outset that the commission's jurisdiction concerning your question is limited to the application of K.S.A. 46-215 et seq., and whether some other statutory system, common law theory or agency rule and regulation applies to your inquiry is not covered by this opinion.

Factual Statement

We understand you request this opinion, on behalf of the Pooled Money Investment Board (PMIB), in your capacity as a member of the board. You advise us that due to the passage of Senate Bills 475 and 476, the PMIB is required to implement several statutory changes. In order to comply with these mandates, the PMIB wants to enter into a short-term contract with an individual to do consulting work on current operational systems and procedures. The individual the PMIB wants to contract with is currently employed as an account vice president by PaineWebber. The individual would not be involved in any investment decisions or transactions while consulting for the state. PaineWebber may want to do business with the state in the future.

Question

Is it permissible for the Pooled Money Investment Board to contract with an individual as a private consultant, and later contract with that individual's private business?

Opinion

K.S.A. 46-233 (a) may apply to the situation you describe. That subsection states:

No state officer or employee shall in the capacity as such officer or employee be substantially involved in the preparation of or participate in the making of a contract with any person or business by which such officer or employee is employed or in whose business such officer or employee or any member of such officer's or employee's immediate family has a substantial interest and no such person or business shall enter into any contract where any state officer or employee, acting in such capacity, is a signatory to, has been substantially involved in the preparation of or is a participant in the making of such contract and is employed by such person or business or such officer or employee or any member of such officer's or employee's immediate family has a substantial interest in such person or business. Substantial interest means "substantial interest" as defined by K.S.A. 46-229, and amendments thereto, and any such interest held within the preceding twelve months of the act or event of participating in the preparation of making a contract.

Whenever any individual has, within the preceding two years participated as a state officer or employee in the making of any contract with any person or business, such individual shall not accept employment with such person or business for one year following termination of employment as a state officer or employee.

The commission has consistently held this section applies to employer/employee situations, and not to independent contractors doing consulting work. Therefore, assuming that the individual is not a state employee, this section would not apply.

Article 8.—EXAMINATIONS

109-8-1. Examinations. (a) On January 1, 1997, the written certification examination for first responders trained under the 1995 national standard curriculum, modified and adopted by the board, and emergency medical technician's trained under the 1994 national standard curriculum, modified and adopted by the board and mobile intensive care technician's shall be the national registry examination. Any certification candidate who fails the national registry examination may retake the examination the maximum allowable number of times pursuant to national registry policy during the period of eligibility as specified in K.S.A. 65-6129 and amendments thereto. Before January 1, 1997, a first responder, emergency medical technician or mobile intensive care technician certification candidate who fails the written certification examination approved by the board on October 4, 1991 may retake the examination a maximum of three times during the period of eligibility as specified in K.S.A. 65-6129 and amendments thereto.

(b) The written certification examination for instructor-coordinator, emergency medical technician-intermediate, and emergency medical technician-defibrillator shall be the examination approved by the board on October 4, 1991. Any instructor-coordinator, emergency medical technician-intermediate, or emergency medical technician-defibrillator certification candidate who fails the examination may retake it a maximum of three times during the period of eligibility specified in K.S.A. 65-6129 and 65-6129b and amendments thereto.

(c) The examinations for instructor-coordinator endorsement for mobile intensive care technician, emergency medical technician-intermediate, and emergency medical technician-defibrillator shall be the examinations approved by the board on June 8, 1990.

(d) The examinations for training officer I and training officer II approval shall be the examinations approved by the board on August 6, 1993.

(e) The examination for inter-active television endorsement of instructor-coordinators and training officers I and II shall be the examination approved by the board on August 5, 1995.

(f) Each certification candidate shall obtain a minimum score of 70 percent on each written examination and shall demonstrate competency in activities authorized by statute as evaluated by the administrator or administrator's designee using criteria approved by the board.

(g) Any attendant candidate who is tested in such activities and who fails any skill station may retest each failed station a maximum of three times during the period of eligibility prescribed in K.S.A. 65-6129 and 65-6129b and amendments thereto.

(h) After January 1, 1997, each first responder, emergency medical technician, and mobile intensive care technician candidate who is tested on such activities in accordance with national registry criteria and who fails any skill station may retest each failed portion the maximum allowable times under national registry policies during the period of eligibility specified in K.S.A. 65-6129 and amendments thereto.

(i) Any examination for certification may be modified by the board in order to field test proposed changes in either the written or practical skills examination. Article 5.—IN-HOME NUTRITION PROGRAM

26-5-6. Eligibility for nutrition services or in-home meals, and method of determining eligibility for specific population groups. (a) A certified assessor shall make a written determination of the eligibility of each individual requesting nutrition services or in-home meals using sections, designated by the department, of the state of Kansas uniform assessment instrument adopted in K.A.R. 120-1-1. The assessment shall be made at the individual's residence and shall be completed:

(1) not later than the end of the first week of meal delivery if that individual has not been a customer of the congregate nutrition program;

(2) not later than the end of the third week of meal service if that individual has been a congregate customer receiving home-delivered meals due to a temporary illness;

(3) not later than the third week of meal service if the individual has not been a congregate customer and needs meals on a temporary basis during a recuperative period after discharge from a hospital, and after the first week of meal service, needs a continuation of meal service as certified by a physician on a form prescribed by the department;

(continued)

(4) prior to the receipt of a home-delivered meal if that individual has been a congregate customer and is requesting home-delivered meals for reasons other than temporary illness;

(5) not later than six months after the first determination of eligibility for receiving nutrition services or in-home meals;

(6) annually for individuals whose condition has been determined by written assessment as not likely to improve; or

(7) every six months if the individual chooses, by request, not to receive meals at a congregate site and the certified assessor determines the individual is homebound due to psychological, emotional or social impairment.

(b) In order to be eligible to receive a home-delivered meal provided under either the in-home meal program or the older Americans act nutrition services program, each individual shall meet the qualifications in paragraph (1), (2), or (3).

(1) Any individual who is age 60 or older and homebound by reason of illness or incapacitating disability shall qualify for services.

(2) Any individual who is age 60 or older and who is homebound due to psychological, emotional, or social impairment shall qualify for services if the individual is:

(A) lacking an informal support system of family, friends, neighbors, or others who are willing and able to prepare the individual's meals without charge for the preparation; and

(B) unable to prepare meals at home for at least one of the following reasons:

(i) limited physical mobility;

(ii) cognitive impairment; or

(iii) lack of knowledge or skills to select and prepare nourishing and well-balanced meals.

(3) An individual who is age 60 or older and isolated because there is no nutrition site in the community of residence shall qualify for services if:

(A) there is no resource offering transportation to a neighboring community with a nutrition site; or

(B) the individual is not able to drive, or chooses not to drive, to a neighboring community with a nutrition site.

(c) Any provider may permit a person to receive home-delivered meals funded only under the older Americans act after determining that the following conditions exist:

(1) the person resides with, or cares for, an individual who is determined to be eligible for home-delivered meals under either paragraph (b)(1) or (b)(2);

(2) the person is:

(A) the eligible individual's spouse, regardless of age, who resides with an eligible individual;

(B) a person with a disability, regardless of age or relationship to the eligible individual, who resides in a non-institutional home with an eligible individual; or

(C) an eligible individual's unpaid, non-spousal caretaker, regardless of age, if the certified assessor has determined that providing the home-delivered meal to the caretaker would be a cost-effective alternative to institutionalizing the eligible individual; and

(3) the best interests of the eligible individual will be served by permitting the person to receive the home-delivered meal.

(d) For purposes of this regulation, "certified assessor" means a person who has received assessment training approved by the department and has been certified by the department to perform the required assessments. 26-5-9. Limitation on delivery of in-home or home-delivered meals. The provider shall only provide a meal to an eligible individual if the meal meets the individual's special dietary needs and conforms to the department's published meal pattern. 26-5-10. Targeting. Each provider shall give priority for receipt for in-home or home-delivered meals to those eligible individuals who are most in need and at greatest nutritional risk as determined by a nutritional risk assessment on the state of Kansas uniform assessment instrument adopted in K.A.R. 120-1-1. Description: The proposed action is to issue a new permit for stormwater discharges from the City of Topeka's stormwater system. The existing Topeka municipal separate storm sewer system (MS4) consists of over 37 miles of open major drainage channels, over 200 miles of conduit, and approximately 11,500 storm water inlets. The Topeka MS4 discharges to the Kansas River or any of the tributaries to the Kansas River within the City of Topeka or immediately downstream of the corporate limits of the city. The primary function and design basis of the existing MS4 is to relieve storm water quantities without specific water quality control. The City of Topeka has submitted a NPDES permit application in compliance with the 40 CFR Part 122.26(d) regulation. The actual quantity of water discharged is primarily dependent on precipitation within the drainage basins served by the individual segments of the MS4. Further monitoring of storm water discharge quality from the Topeka MS4 will be required under the NPDES permit.

The permit requires the permittee to implement the Storm Water Management Program as submitted with Part 2 of the NPDES application and as modified by the permit. This involves multiple programs for minimization of pollutant discharge to receiving waters, additional monitoring of the quality of storm water discharge and evaluation of pollutant loading of the principal pollutants of concern. The principal pollutants of concern as determined by KDHE, were selected based on review of the data included with the permit application. The principal pollutants of concern are biochemical oxygen demand, fecal coliform, lead, copper, silver and zinc. The requirements of this permit are pursuant to Kansas surface water quality standards, K.A.R. 28-16-28(b-f), and federal surface water criteria.

Written comments on the draft permits must be submitted to the attention of Lisa Duncan for agricultural permits or to the permit clerk for all other permits, Kansas Department of Health and Environment, Division of Environment, Bureau of Water, J Street and 2 North, Forbes Field, Building 283, Topeka, 66620. All comments post-marked or received by November 22 will be considered in the formulation of final determinations regarding this

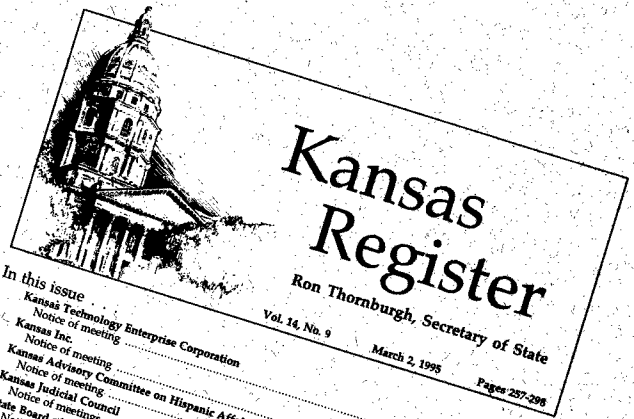
