Notice of Advisory Panel Meetings

The Kansas Arts Commission has scheduled meetings for two advisory panels to evaluate applications from Kansas performing artists to determine whether they may be added to the roster of performers eligible for the Kansas Touring Program.

The Theater Panel will meet from 1 to 4 p.m. Monday, November 18, and the Music Panel will meet from 10 a.m. to 4 p.m. Tuesday, November 19. Each panel will meet in the conference room in the Topeka offices of the Kansas Arts Commission.

Current roster artists are required to apply for re-evaluation on a regular, rotating basis. New artists annually apply for possible appointment to the roster. Applicants are evaluated annually by panels of skilled evaluators with expertise in music, theater and dance. Each panel is chaired by a commissioner.

The panels' recommendations will be acted upon by the full commission during its next quarterly meeting, scheduled for Thursday, December 5, at the Smoky Hill Museum, 211 W. Iron, Salina. The roster then will be updated, published and mailed to presenters.

Meetings of the Kansas Arts Commission, a state agency, and its advisory panels are open to public observation in accessible locations. All meetings are tape-recorded. Persons with special needs are asked to request accommodation to meet those needs at least one week before any meeting.

Sealed proposals for an extension of the Mill Creek Streamway Park Trail and associated site work in Lenexa, Kansas, will be accepted by the Johnson County Park and Recreation District Board of Commissioners, District Administration Building, 7900 Renner Road, Shawnee, Kansas, until 10 a.m. Tuesday, December 17. Bids will be opened and publicly read at 10 a.m. December 17 in the district's boardroom in the District Administration Building. The bids will be evaluated by the district Board of Commissioners at the scheduled meeting at 7:30 p.m. December 18, also in the district's boardroom.

A mandatory pre-bid conference will be at 1:30 p.m. December 3 in the District Administration Building. Failure to attend the mandatory pre-bid conference will make the bid nonresponsive and not eligible for award consideration.

This project is new construction of a bicycle/pedestrian trail along Mill Creek from approximately 95th Street north to the existing trail located near the northeast corner of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 25, T12S, R23E. The district and the Kansas Department of Transportation have entered into an agreement for the use of federal Transportation Enhancement (ISTEA) funds for this project.

There will be no discrimination against anyone because of race, age, religion, color, sex, disability or national origin in the award of contracts. Each bidder shall file a sworn statement executed by or on behalf of the person, firm, association or corporation submitting the bid, certifying that such person, firm, association or corporation has not, either directly or indirectly, entered into any agreement, participated in any collusion, or otherwise taken any action in restraint of free competitive bidding in connection with the submitted bid. This sworn statement shall be in the form of an affidavit executed and sworn to by the bidder before a person who is authorized by the laws of the state to administer oaths. The required form of the affidavit will be provided by the district to each prospective bidder. Failure to submit a sworn statement as part of the bid approval package will make the bid nonresponsive and not eligible for award consideration.

In addition to this requirement, each bidder shall execute all required documents in the plans, specifications and bid package. Failure to properly execute all required documents as part of the bid approval package will make the bid nonresponsive and not eligible for award consideration.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Pamela Dawes at (913) 291-3684. Handicapped parking is located at the west end of the Hutton Building, and the northwest entrance to the building is accessible.

Summaries of the proposed new regulations and their economic impact follow:

100-29-1. Application. This regulation specifies what information is required to be submitted with the application for registration as a physical therapist and certification as a physical therapist assistant.

100-29-2. Approval of physical therapy programs. This regulation specifies the educational programs for physical therapists and physical therapist assistants which shall be approved by the board.

100-29-3. Requirements for physical therapists and physical therapist assistants from non-approved schools. This regulation designates what type of documentation and/or testing shall be required of an applicant submitting an application when the applicant has received training from a non-approved school and/or a school at which English was not the language of instruction.

100-29-4. Examination. This regulation designates the examination required to be passed by all applicants to be registered as a physical therapist or certified as a physical therapist assistant.

100-29-5. Fees. This regulation authorizes the issuance of a temporary permit and specifies the requirements which must be met to obtain a temporary permit. Also, this regulation would limit the number of temporary permits permitted to any one person.

100-29-6. Lost or destroyed certificates; change of name; new certificates. This regulation establishes what

criteria is required in order for the registered or certified person to obtain a duplicate certificate of registration or certification.

100-29-7. Amount. This regulation establishes the fees to be collected by the board when submitting an application for registration as a physical therapist and certification as a physical therapist assistant and also for renewal, late renewal, reinstatement, duplicate certificate, temporary permit and for providing certified copies of registration or certification.

100-29-8. Registration renewal; expiration date; notification of supervision. This regulation sets the expiration date for every physical therapist and certification of every physical therapist assistant of each year. Additionally, this regulation establishes the requirements of notification of supervision at the time of renewal of certification and registration.

100-29-9. Registration renewal; continuing education. This regulation establishes the conditions of renewal for each registered physical therapist or certified physical therapist assistant.

100-29-10. Lapsed registrations and certifications; reinstatement. This regulation details the criteria required for each physical therapist and physical therapist assistant desiring to reinstate a lapsed registration or certificate.

100-29-11. Complaint; institution of proceedings; hearings. This regulation specifies the procedure used by the board when a complaint is received alleging one or more grounds for revocation or suspension of a registration or certificate.

100-29-12. Unprofessional conduct, defined. This regulation defines 26 specific grounds which would constitute unprofessional conduct by a physical therapist or physical therapist assistant.

100-29-13. Physical therapist assistants; notification to board. This regulation states the specific criteria required of a physical therapist before allowing a physical therapist assistant to work under the physical therapist's direction.

100-29-14. Physical therapist assistants; number. This regulation establishes how many physical therapist assistants may work at any one time under the direction of a physical therapist.

The above regulations are all related to the registration of physical therapists and certification of physical therapist assistants by the Kansas State Board of Healing Arts. There is no economic impact on state agencies or the general public. The economic impact on persons who wish to hold themselves out as a physical therapist or physical therapist assistant is a \$40 initial application fee when registration or certification is based upon certificate of prior examination. The initial application fee for a physical therapist or physical therapist assistant when based on examination is \$60. Renewal of a registration or certification is a \$40 annual renewal fee.

Subject to the terms and conditions of the complete official notice of bond sale dated November 12, 1996, of the City of Andover, Kansas, in connection with the city's General Obligation Internal Improvement Bonds, Series B, 1996, hereinafter described, sealed, written bids shall be received at the office of the city administrator at City Hall, 909 N. Andover Road, Andover, Kansas, until 7 p.m. Tuesday, November 26, 1996, for the purchase of the bonds. All bids shall be publicly opened, read aloud and tabulated on said date and at said time and shall immediately thereafter be considered and acted upon by the governing body of the city.

No oral or auction bids for the bonds shall be considered, and no bids for less than the entire amount of the bonds shall be considered.

Redemption of Bonds

Certain of the bonds are subject to optional redemption prior to their maturities as set forth in the official notice of bond sale. 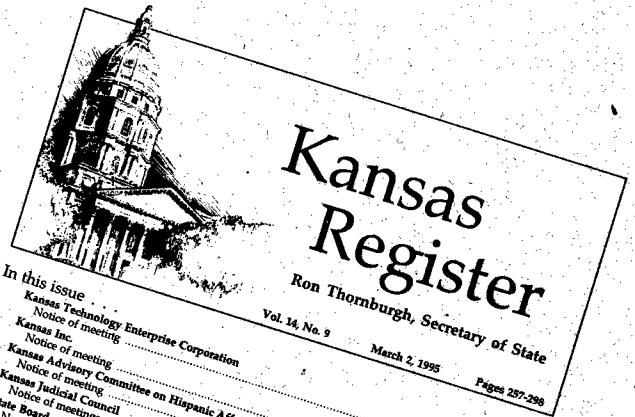
