Notice to Private Activity Bond Applicants

Applications for allocation of 1997 Private Activity Bond (PAB) authority are now being accepted for qualified uses, as defined by the Internal Revenue Code of 1986, and amendments thereto, with the exception of qualified mortgage bonds. Notice of allocation application procedures for qualified mortgage bonds will be made at a later date.

The State of Kansas currently receives \$150 million of federal authority for the issuance of PABs on an annual basis. Historically, the primary uses of this federal authority have included "qualified small issue bonds" used for construction and equipping of manufacturing facilities and beginning farmer programs; "exempt facility bonds" used by for-profit entities providing a public benefit, i.e., certain waste treatment facilities, qualified residential rental facilities, etc.; and "qualified mortgage bonds" issued to benefit first-time homebuyers. Allocations awarded by the Secretary of Commerce and Housing are subject to the provisions of K.S.A. 74-5060 et seq. and the limitations of the state volume cap.

Fees associated with private activity bond application and issuance are as follows:

(1) Application fee—A nonrefundable fee must accompany the application before the request can be processed. The application fee is determined as follows:

- \$250—Allocation request up to \$5,000,000.
- \$500—Allocation request from \$5,000,001 to \$10,000,000
- \$1,000—Allocation request of \$10,000,001 and above

(2) Issuance Fee—An issuance fee for allocation amounts utilized other than "Qualified Mortgage Bonds" shall be due and payable to the Kansas Department of Commerce and Housing at bond closing. Issuance fees shall be determined as follows:

Allocation Used	Fee
• \$0 - \$2,000,000	5 basis points (.05%)
• \$2,000,001 and above	10 basis points (.10%)
• "Qualified Mortgage Bond" programs will be assessed a fee equal to .5% of the mortgage loan amount upon each mortgage loan assisted through the program.	

Issuance fees shall be remitted within 30 days of bond closing.

Checks for both the application fee and issuance fee should be payable to the Kansas Department of Commerce and Housing Bond Fee Fund.

Notice is hereby given of the commencement of negotiations for architectural services for the Department of Corrections for housing and support expansions at the institutions listed below. At this time, these projects are not funded. It is the agency's desire to start the selection process; however, contracts will be contingent upon the legislature approving funding. The scope of the projects and their locations are as follows:

**Norton Correctional Facility and Hutchinson
Correctional Facility - East Unit**

This project is for the design and construction administration of a 200-bed secure housing unit at both of these facilities and a 24,000 square foot industry building at both facilities. Each housing unit will be two levels with 100 wet cells, double bunked. The housing units also will have a control center, day rooms, showers, janitor closets, laundry storage, three counselor offices and a unit team office. Executive Order No. 97-1

**Establishing the Advisory Committee on
Children and Families and Abolishing the
Kansas Commission on Children, Youth and Families**

WHEREAS, Article 1, Section 3 of the Constitution of the State of Kansas vests the supreme executive power of the state in the Governor; and

WHEREAS, the State of Kansas has a vital interest in the development and provision of high quality services to children and families; and

WHEREAS, Kansas State government has a wide range of responsibilities in the development and provision of services to children and families;

NOW, THEREFORE, pursuant to the authority vested in me as Governor and Chief Executive of the State of Kansas, I hereby establish the Advisory Committee on Children and Families.

(1) The Advisory Committee on Children and Families shall serve in an advisory capacity to the Governor and shall:

(a) Assist the Governor in developing and implementing a coordinated, comprehensive service delivery system to serve the children and families of Kansas;

(b) Identify barriers to service and gaps in service due to strict definitions of boundaries between departments and agencies;

(c) Facilitate interagency and interdepartmental cooperation toward the common goal of serving children and families;

(d) Investigate and identify methodologies for the combining of funds across departmental boundaries to better serve children and families;

(e) Propose actions needed to achieve coordination of funding and services across departmental lines; and

(f) Encourage and facilitate joint planning and coordination between the public and private sectors to better serve the needs of children and families.

(2) Membership on the Committee shall be by official commission of appointment of the Governor, certified by and filed with the Secretary of State.

(3) The Governor shall appoint a Chairperson of the Committee. The members of the Committee shall elect any additional officers from among its members necessary to discharge the Committee's duties.

(4) The Committee shall meet upon call of its Chairperson as necessary to carry out its duties under this Executive Order.

(5) Members of the Committee shall not receive compensation, but shall receive subsistence allowances, mileage and expenses as provided in K.S.A. 75-3223 and amendments thereto for travel and attendance at official meetings of the Committee. The subsistence allowances, mileage, and expense reimbursements shall be paid from available appropriations of the Department of Social and Rehabilitation Services except that expenses of members who are employed by a state agency shall be reimbursed by that state agency.

The Kansas Commission on Children, Youth and Families established by Executive Order No. 91-145 is hereby

abolished. Executive Order No. 91-145 is hereby suspended by this Order and the force and effect of Executive Order 91-145 is hereby rescinded.

This document shall be filed with the Secretary of State as Executive Order 97-1 and shall be effective immediately.

The invalid resolution did not exempt Wabaunsee County from distributing sand royalty funds to drainage districts as outlined in K.S.A. 82a-309; however, it is the court's function to determine if the drainage districts described in K.S.A. 82a-309 may be entitled to their proportionate share of sand royalty funds which Wabaunsee County had on hand at the time of the passage of Charter Resolution No. 92-9, and additional funds received thereafter. 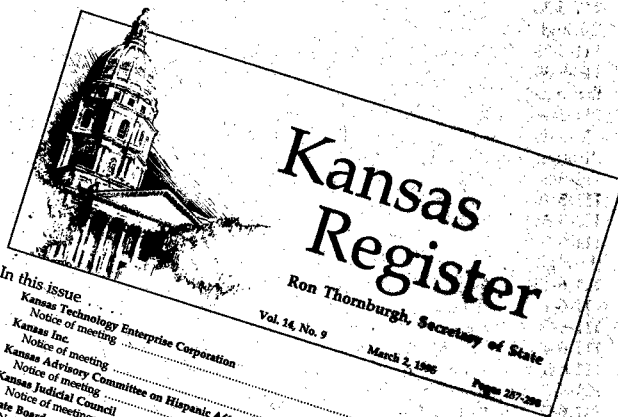
