Notice of Hearing on Proposed
Administrative Regulations

A public hearing will be conducted by the Wildlife and Parks Commission at 7 p.m. Thursday, April 24, at the Ramada Inn & Tower, 6th Street and I-70, Topeka, to consider the approval and adoption of six proposed department regulations.

A workshop meeting on business of the Wildlife and Parks Commission will begin at 1:30 p.m. April 24 at the same location. The meeting will recess at 5 p.m., then resume at 7 p.m. for the regulatory hearing. There will be public comment periods at the beginning of the afternoon and evening meetings for any issues not on the agenda, and additional comment periods will be available during the meeting on agenda items. Old and new business also may be discussed at this time. If necessary to complete the hearing or other business matters, the commission will reconvene at 9 a.m. April 25 at the same location.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Cindy Baugh, commission secretary, at (316) 672-5911. Persons with a hearing impairment may call the TDD service at 1-800-766-3777 to request special accommodations.

This 60-day notice period prior to the hearing constitutes a public comment period for the purpose of receiving written public comments on the proposed regulations.

All interested parties may submit written comments prior to the hearing to the chairman of the commission, Kansas Department of Wildlife and Parks, Suite 502, Landon State Office Building, 900 S.W. Jackson, Topeka, 66612. All interested parties will be given a reasonable opportunity at the hearing to express their views orally in regard to the adoption of the proposed regulations. During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending and approving, or rejecting the proposed regulations.

The regulations that will be heard during the regulatory hearing portion of the meeting are as follows:

K.A.R. 115-4-1. Turkey; legal equipment, taking methods, reports, tags, and general provisions.

K.A.R. 115-4-3. Antelope; legal equipment, taking methods, and general provisions.

K.A.R. 115-4-5. Deer; legal equipment, taking methods, and general provisions.

K.A.R. 115-4-7. Elk; legal equipment, taking methods, and general provisions.

The proposed amendments for these four big game regulations are substantially the same. The proposed amendments would allow the use of lighted pin sights, dot sights, holographic sights, optical scopes and range finders if the systems do not project visible light toward the target and do not electrically amplify light. The

changes would continue to prohibit laser scopes and nightscopes. Another amendment requires hunters to retain the big game tag until the animal taken on that tag is consumed, given to another person or otherwise disposed of. Similarly, persons receiving legally acquired meat would be required to retain the written notice accompanying that meat until the meat is consumed, given to another or otherwise disposed of.

Economic Impact Summary: Some economic benefit may be realized by businesses providing these products. Otherwise, the changes in these regulations will have no economic impact on the public or on other state agencies.

K.A.R. 115-4-6. Deer; management units. This regulation establishes deer management units for the taking of deer. The proposed amendment would merely change the description of certain boundaries to concur with the highway designations in the current official highway map of Kansas.

Economic Impact Summary: No economic impact is anticipated.

K.A.R. 115-4-13. Deer permits; descriptions and restrictions. This regulation provides descriptions and restrictions on deer permits. One proposed amendment would change the designation of a statewide archery permit from a primary permit type to a secondary permit type, thus allowing a person purchasing a statewide archery permit to also apply for a firearm deer permit. The other proposed amendment would allow deer hunters to use a leftover firearm deer permit or a leftover muzzle-loader deer permit during any open deer season with the equipment authorized during that season.

Economic Impact Summary: These amendments are anticipated to stimulate interest in hunting deer and will allow hunters to hunt deer during more than one season, thus stimulating the sale of sporting equipment associated with the various seasons. Some economic benefit may be realized by businesses providing these products, as well as by rural communities and businesses providing services to hunters. There may be an increase in the sale of statewide archery permits, and the amendments may increase the competition for some firearm permit types and further ensure the sale and use of leftover firearm permits. This may result in minor economic benefit to the agency. The change in the regulation will have no economic impact on other state agencies.

Notice of Policy for Investment Adviser
Registration Requirements
(Effective April 9, 1997.)

K.S.A. 17-1254 states that it is unlawful to transact business as an investment adviser in the State of Kansas unless registered with the Kansas Securities Commissioner or pre-empted by federal law. Exclusions to the definition of investment adviser are found in K.S.A. 17-1252.

The following items are required to be submitted to the Office of the Kansas Securities Commissioner as application to register as an investment adviser (whether a corporation, partnership, trust or sole proprietorship).

1. Form ADV including Parts I and II and all applicable schedules pursuant to K.A.R. 81-3-1.
2. Registration fee specified by K.A.R. 81-3-2.
3. Audited financial statements are required only if the investment adviser maintains custody of client securities or cash or requires prepayment of fees of more than \$500 paid more than six months in advance of providing services. Otherwise, no financial statements are required.
4. Affidavit statement that K.A.R. 81-3-1 has been reviewed and applicant is aware of post-effective requirements pertaining to annual reports, required records, post-effective amendments and unethical practices.
5. Copy of client contract or agreement to be used with Kansas residents.
6. Copy of client disclosure brochure, if applicable.
7. Copy of any solicitor agreement, if applicable.
8. Each investment adviser is required to register at least one investment adviser representative. Additionally, each and every individual for whom box E, F or G on page 1 of Schedule D is checked, or who meets the definition of investment adviser representative contained in the Kansas Securities Act (see attached proposed amendment to K.S.A. 17-1272(m)) is required to be registered.

The following items are required to be submitted as application to register as an investment adviser representative:

- (a) Schedule D of Form ADV or Form U-4.
- (b) \$30 per individual pursuant to K.A.R. 81-3-2.
- (c) For the initial registration of an investment adviser representative, documentation (unless available through the CRD system) of successful completion

of the Uniform Investment Adviser State Law Exam (Series 65) or the Uniform Combined State Law Exam (Series 66) within the two years prior to the date of filing the application; or, a written request for waiver of the exam which explains good cause.

- (d) For the initial registration of an investment adviser representative, documentation (unless available through the CRD system) of successful completion of the Non-member General Securities Exam (Series 2) or General Securities Exam (Series 7) within the two years prior to the date of filing the application; or, a written request for waiver of the exam which explains good cause. A waiver of this requirement will be considered if:
 - (i) the individual provides documentation of the successful completion of one of the above-mentioned exams along with evidence that the applicant has not had a lapse in employment as an investment adviser representative, or principal or agent of a broker-dealer, for a period exceeding the two years immediately prior to the date of filing an investment adviser registration application; or
 - (ii) the individual provides documentation of attainment of one of the professional designations of Certified Financial Planner (CFP), Chartered Financial Analyst (CFA), Chartered Financial Consultant (ChFC), or Personal Financial Specialist (PFS) within the two years immediately prior to the filing of the application; or, attainment of one of these professional designations at any time prior to the date of filing the application if evidence is presented that the applicant has not had a lapse in employment in the financial services industry for a period exceeding the two years immediately prior to the date of filing the application.

- (e) Thorough documentation of proceedings or actions required under Item 8 on Schedule D.

A Notice of Effectiveness will be issued upon compliance with all registration requirements. Each registered investment adviser is required to file an updated Form ADV and applicable schedules with the Office of the Securities Commissioner not later than required in the instructions to Form ADV. After initial registration, annual audited financial statements are only required to be filed with the Securities Commissioner upon request. Renewal registration applications are mailed in early November for the convenience of the registered investment adviser. It is the responsibility of the registered investment adviser to file an application for renewal not later than December 21. Registration expires on December 31. Registration renewal fees are stated in K.A.R. 81-3-2.

Traffic Regulations

The Kansas State University Administrative Council will conduct a public hearing from 3 to 5 p.m. Thursday, April 24, in the Student Union Building, Big 12 Room, Kansas State University, Manhattan, concerning the adoption by Kansas State University of regulations governing traffic and parking on its roads, streets, driveways and parking facilities. The following is a summary of the substance of the rules and proposed changes:

General

The regulations were completely revised to reduce excess verbiage and duplication of procedures. The new regulations have been rewritten to improve clarity, to reduce multiple interpretations, and to include a table of contents. Since the program to reduce reserved stalls started approximately three years ago, the number of nonmedical reserved stalls has dropped approximately 16 percent.

1. **Section II B, Permit Fee Schedule.** Reserved stall cost will increase \$100 per stall per year.
2. **Section A.2.** Lot designation has changed so that permit information will coincide with parking lot sign information.
3. **Section II.F.2.e.** Frequent visitor has been redefined as an individual who requires parking on campus in excess of one calendar day per week.
4. **Section II.H.** Individuals who are displaying forged, stolen or altered parking permits in their vehicles may lose their campus parking privileges for up to one year.
5. **Section V.B.23.** The fine for illegally displaying a stolen, altered, expired or unauthorized accessible parking identification device is \$100.
6. **Section V.C.4.** An excessive violator has been redefined to include an individual who has five or more unpaid parking citations.

Administrative Regulations

The Kansas State Board of Cosmetology will conduct a public hearing at 10 a.m. Monday, May 12, at the Kansas Corporation Commission, 1500 S.W. Arrowhead Road, third floor hearing room, Topeka, to consider proposed new regulations K.A.R. 69-15-1 through 69-15-30. The following is a summary of the substance of each proposed new regulation and its anticipated economic impact.

K.A.R. 69-15-1 lists the definitions as they relate to tattooing, permanent color cosmetics and body piercing. There is no economic impact as a result of this regulation.

K.A.R. 69-15-2 sets out the training requirements for tattoo artists, permanent color technicians and body piercers in a school or under the direct supervision of an approved trainer. There could be economic impact to the trainee, should there be tuition in the school or reimbursement to the trainer. There would be none to the agency.

K.A.R. 69-15-3 sets out the requirements to become an approved trainer for tattooing, permanent cosmetics or body piercing. There is no economic impact as a result of this regulation.

K.A.R. 69-15-4 sets out the requirements for approval of training in another state. There is no economic impact as a result of this regulation.

K.A.R. 69-15-5 sets out the procedure for applying for the examination for licensure. The economic impact to the candidate will be the one-time application fee and the fee

for the written and practical exam. The fee for written and practical is paid each time the licensee needs to take each exam.

K.A.R. 69-15-6 sets out the application completion and deadlines. There is no economic impact as a result of this regulation.

K.A.R. 69-15-7 specifies the content of the exam. It gives the candidate a clear indication of what knowledge, skills and abilities are required for the exam. There will be economic impact to the agency of developing, administering and scoring the exam.

K.A.R. 69-15-8 sets out the behavior expected at the exam. There will be no economic impact as a result of this regulation.

K.A.R. 69-15-9 gives the requirements for renewing a license. The economic impact to the licensee would be to pay the required fee for the initial license and a renewal fee each year after. There would be positive economic impact to the agency in the fees collected.

K.A.R. 69-15-10 requires the practitioner to display the license and inspection certificate in public view. There is no economic impact as a result of this regulation.

K.A.R. 69-15-11 gives the criteria for an inspection generated by a complaint. The economic impact to the agency would be in investigating any complaint.

K.A.R. 69-15-12 sets the requirements of 15 hours of continuing education for every three year licensing period. The regulation stipulates what will be accepted and considered as meeting the requirement. There will be an economic impact to the licensee in attending or participating in approved programs. The cost would involve any travel time, cost and time away from their practice. There would be an impact to the agency for reviewing and determining that continuing education reports meet the requirements.

K.A.R. 69-15-13 sets out the requirements for reporting continuing education. There is no economic impact as a result of this regulation.

K.A.R. 69-15-14 states the requirements for a facility to be licensed. The economic impact to the licensee would be to pay the fee for a license. The impact to the agency would be to perform the inspection of the facility.

K.A.R. 69-15-15 states the standards of practice for tattoo artists, permanent color technicians and body piercers, and restrictions in these areas. There is no economic impact as a result of this regulation.

K.A.R. 69-15-16 states the standards of a facility for tattoo artists, permanent color technicians and body piercers, and restrictions in these areas. There could be economic impact as a result of this regulation to the licensee if their facility did not meet all of the requirements and they have to make the necessary adjustments to their facilities.

K.A.R. 69-15-17 states the requirements for equipment, articles and materials in the place of business. The economic impact to the licensee could be the cost of adequate equipment to provide a safe procedure.

K.A.R. 69-15-18 gives the methods of cleaning instruments prior to sterilization. There is no economic impact as a result of this regulation.

K.A.R. 69-15-19 gives the sterilization standards for instruments used in tattooing, permanent cosmetics or

body piercing. There is no economic impact as a result of this regulation.

K.A.R. 69-15-20 gives the methods required for sterilization for instruments used in tattooing, permanent cosmetics, or body piercing. The economic impact to the licensee would be the purchase and monitor the effectiveness of necessary equipment to sterilize the equipment and instruments.

K.A.R. 69-15-21 gives the requirements of handwashing and protective gloves during tattooing, permanent cosmetics or body piercing. There is no substantial economic impact as a result of this regulation.

K.A.R. 69-15-22 gives the requirements of clean linens and storage of linens during tattooing, permanent cosmetics or body piercing. The regulation also gives laundering requirements. There is no substantial economic impact as a result of this regulation.

K.A.R. 69-15-23 and 69-15-24 give the requirements of clean instruments, products and chemical storage during tattooing, permanent cosmetics or body piercing. There is no substantial economic impact as a result of this regulation.

K.A.R. 69-15-25 and 69-15-26 give the requirements of handling disposable materials and waste receptacles used during tattooing, permanent cosmetics or body piercing. There is no substantial economic impact as a result of this regulation.

K.A.R. 69-15-27, 69-15-28 and 69-15-29 give the standard procedures, including preparation, procedure and aftercare, to be used during tattooing, permanent cosmetics or body piercing. There is no substantial economic impact as a result of this regulation.

K.A.R. 69-15-30 includes the fees required, including application and exam fees, license fees for individuals and facilities, and demonstration fees. The economic impact to the licensee would be to pay the required fee for appropriate licenses. There would be a positive impact to the agency in collecting the fees.

A copy of each of the proposed regulations and complete economic impact statement may be obtained by contacting the executive director of the State Board of Cosmetology, 2708 N.W. Topeka Blvd., Topeka, 66617, prior to the date of the hearing.

Permanent Administrative Regulations

Article 5.—LICENSES

65-5-6. Continuing education. (a) Except for any licensee who graduated from an approved optometry school within 12 months before the date of the application for license renewal, each licensed optometrist shall earn 20 hours of documented and approved continuing education during each license renewal period.

(b) On and after June 1, 1996 and until May 31, 2000, at least four hours of the 20 annual hours of documented and approved continuing education shall be on the topics of diagnosis and treatment of glaucoma.

(c) Each academic credit hour shall be equivalent to 15 hours of continuing education. Credit for auditing an academic course shall be given for actual hours attended during which instruction was given and shall not exceed the number of hours allowed for academic credit.

(d) The following educational programs may be used to meet the annual educational requirement:

- (1) educational meetings of the American optometric association;
- (2) educational meetings of the Kansas optometric association;
- (3) scientific sections of the American academy of optometry;
- (4) post-graduate courses offered at any accredited school of optometry; and
- (5) other educational programs approved by the board.

(e) On and after June 1, 1996, a licensee shall not use the same course to meet the requirements of K.S.A. 1995 Supp. 65-1505(d)(2) and amendments thereto, and the annual continuing education requirement.

(f) Any provider seeking board approval for a continuing education offering shall submit a copy of the continuing education program, schedule or outline to the secretary-treasurer at least 60 days before the date of the program.

(g) Each licensee shall submit a certificate of attendance to the secretary-treasurer with or prior to the licensee's application for renewal. The certificate of attendance shall contain:

- (1) the name of the sponsoring organization;
- (2) the name, signature, and address of the licensee;
- (3) the number of hours attended;
- (4) the subject of the approved education program;
- (5) the date of the educational program; and
- (6) any other evidence of attendance required by the board.

(h) The certificate of attendance shall be on a form approved by the board and shall be signed by the licensee and an appropriate representative of the sponsoring organization. (Authorized by K.S.A. 74-1504(a)(6); implementing K.S.A. 65-1509a; effective May 18, 1992; amended March 7, 1997.)

Article 6.—UNIFORM CONSUMER CREDIT CODE

75-6-26. Federal truth-in-lending act requirements.

Each creditor who, in the ordinary course of business, regularly extends or offers to extend consumer credit shall disclose to the consumer the information required by: (a) title I of the consumer protection act, 15 USC 1601 et seq., public law 90-321; 82 stat. 146, as amended and in effect on October 21, 1996;

(b) Regulation M, 12 CFR 213.1 through 213.8 and Appendices A, B, C and D, as amended and in effect October 31, 1996; and

(c) Regulation Z, 12 CFR 226.1 through 226.33 and Appendices A through L, as amended and in effect on October 21, 1996. 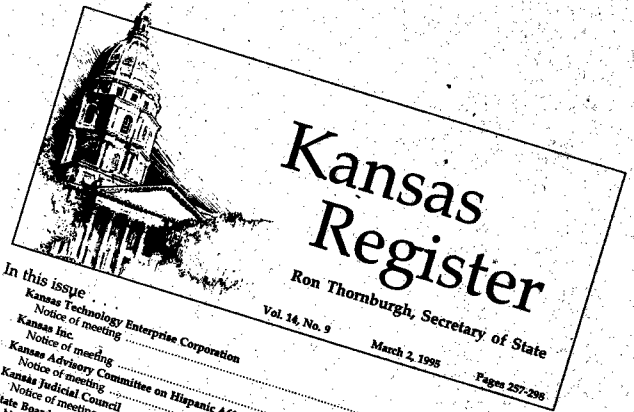
