The methods and standards for setting upper payment limits and rates for Medicaid nursing facilities (NFs) and NFs-mental health (MH) were reviewed and will not be changed when setting rates for services beginning July 1, 1997. These methods and standards will now utilize the calendar year 1996 Nursing Facility Financial and Statistical Reports. The upper payment limits for the cost centers will be set using the following:

Administration	115% of the median
Plant Operating	130% of the median
Room and Board	130% of the median
Health Care	125% of the median for a Case Mix Index of One

The method of inflating costs for upper payment limits and rates, the percentile used for setting the administrator, co-administrator, owner and related party upper payment limit and the percentiles used for the incentive factor ranges will remain the same as those used for state fiscal year 1997. The expected estimated annual aggregate increase in NF and NF-MH rates in state fiscal year 1998 is 7.2 percent.

Article 2.—LOTTERY RETAILERS

111-2-1. Application to become a lottery retailer. (a) Persons or businesses wanting to sell lottery tickets or shares shall apply to the Kansas lottery on forms available through the lottery headquarters in Topeka or through any lottery regional office.

(b) Each application to become an instant and on-line lottery retailer shall be accompanied by a fee of \$150.00. All fees shall be non-refundable once a contract is fully executed and a lottery retailer certificate issued. Prior to contract execution and the issuance of a certificate, should the lottery reject or the applicant withdraw an application, the lottery shall refund all but \$50.00 of the application fee. Any applicant for an instant and on-line certificate may also apply for a certificate to sell pull-tabs without paying an additional fee.

(c) Instant and on-line retailers shall be subject to the following:

(1) Retailers are required to have dedicated telephone lines for which they will be charged \$10.00 per week.

(2) Certain instant and on-line retailers whose businesses are seasonal, or are based at events in which Kansas lottery staff is participating, and regularly occur four or fewer days a week during the season, may qualify for cellular telephone services rather than dedicated telephone lines. There shall be no service charges for those on-line retailers selected to receive cellular telephone services available from the lottery.

(d) An applicant to become an instant and on-line lottery retailer shall actively offer for sale current instant games offered by the lottery, unless approved by the executive director as a "social environment establishment" defined at K.A.R. 11-6-1, and all on-line games offered by the lottery.

(e) Each application to become a pull-tab retailer shall be accompanied by a fee of \$25.00, unless the applicant has applied to become an instant and on-line retailer and paid the appropriate fee. All pull-tab application fees shall be non-refundable.

(f) An applicant receiving a lottery retailer certificate pursuant to K.S.A. 74-8708, as amended, may apply for a temporary lottery retailer certificate, good for no more than fourteen days, at a specific location, for special lottery events and other events approved by the executive director. An application for a temporary lottery retailer

certificate shall designate the event and the specific location where tickets will be sold.

(g) Effective April 21, 1997, all instant lottery retailers not also certified as on-line lottery retailers shall be eligible to become certified as on-line retailers without payment of the on-line application fee specified in subsection (c), although they shall be subject to the payment of line charges identified in subsection (c)(1). With the conversion to a new on-line system, all instant ticket validation terminals at instant only lottery locations will be replaced with on-line lottery terminals. All instant only retailers who wish to sell both instant and on-line lottery tickets and shares may submit an application for an instant and on-line certificate without any additional fee. As of October 5, 1997, the certificates and contracts of instant only retailers who choose not to become instant and on-line retailers shall be revoked.

(h) No sale shall be made at any location not authorized by the executive director or his designee. (Authorized by K.S.A. 74-8708 and K.S.A. 1996 Supp. 74-8710 and implementing K.S.A. 1996 Supp. 74-8710; effective, T-88-38, Sept. 28, 1987; amended, T-88-61, Dec. 19, 1987; amended, T-111-12-1-88, Dec. 1, 1988; amended, T-111-2-28-95, Feb. 17, 1995; amended, T-111-5-22-96, May 15, 1996; amended, T-111-6-9-97, April 18, 1997.)

111-2-59. Commission addition program. In addition to compensation specified in K.A.R. 111-2-4 and 111-2-6, the Kansas lottery may also offer the following as additional commissions to enhance the sale of all lottery tickets:

(a) The sales program will commence at 6:00 a.m. on May 1, 1997, and end at the close of the "lottery business day" of June 30, 1997. A "lottery business day" is the period from 6:00 a.m. until 1:00 a.m. which actually falls on the next calendar day.

(b) All lottery retailers who were authorized to sell instant tickets, on-line tickets, or both as of March 1, 1997, are eligible to participate based upon an increase in their "base sales total." The "base sales total" is arrived at by computing retailers' total lottery ticket sales for May and June of 1996 for each retailer selling instant and on-line tickets during that period as compared with instant and on-line sales during May and June of 1997. For new instant and on-line retailers, starting after May 1, 1996, the "base sales total" will be the total instant and on-line ticket sales occurring between March 1, 1997, and April 30, 1997, compared with instant and on-line sales during May and June of 1997.

(c) (1) When sales increase between five percent and 9.99 percent above sales for the base period, a retailer will receive an additional one percent sales commission applicable only to the increase.

(2) When sales increase between 10 percent and 14.99 percent above sales for the base period, a retailer will receive an additional two percent sales commission applicable only to the increase.

(3) When sales increase between 15 percent and 19.99 percent above sales for the base period, a retailer will receive an additional three percent sales commission applicable only to the increase.

(continued)

(4) When sales increase 20 percent or more above sales for the base period, a retailer will receive an additional five percent sales commission applicable only to the increase. The maximum sales increase to which the five percent shall be applied is a 20 percent increase.

(d) Commissions earned pursuant to this program will be addressed in electronic funds transfers after sales increases are determined following the end of the program. (Authorized by and implementing K.S.A. 1996 Supp. 74-8710; effective, T-111-6-9-97, April 18, 1997.)

The security person conducting the drawing shall be responsible for the final determination concerning the legibility of the name on any ticket drawn, but regardless of the number of entries a person whose name appears on a valid entry drawn in the "Corporate Woods Jazz Festival Drawings" has made, he or she shall not be eligible to win more than one prize. The first prize winning ticket drawn for such an entrant invalidates all other entries for the "Corporate Woods Jazz Festival Drawing" for that entrant.

(g) A person whose valid ticket has been drawn from the receptacle or drum at each drawing shall be determined a "Corporate Woods Jazz Festival Drawing" winner.

(h) Each winner shall be given a prize claim form to be completed and returned to the lottery.

(i) If the name of any ticket drawn is not legible, the ticket drawn will be void and the selection process shall be repeated until a valid winning ticket is selected. 111-4-1013. Name of game. The Kansas lottery shall conduct an instant winner lottery game entitled

"\$10,000 Clubs" commencing on or after April 21, 1997. The specific rules for the "\$10,000 Clubs" game are contained in K.A.R. 111-3-1 *et seq.* and 111-4-1013 through 111-4-1016. (Authorized by and implementing K.S.A. 1996 Supp. 74-8710; effective, T-111-6-9-97, April 18, 1997.)

111-4-1014. Definitions. The following definitions shall apply to the "\$10,000 Clubs" instant lottery game:

(a) "Game symbols" are the numbers, letters, symbols, or pictures printed in the play area of each instant game ticket and which determine if the ticket bearer is entitled to a prize. In this instant game, the game symbols are printed in black ink in 10 point WGI font with matching captions in WGI Cap font. A game symbol appears in each of 10 play spots within the play area. Each game symbol for this instant game is one of the following: image of a heart - image of a spade - image of a diamond - image of a club.

(b) "Game symbol captions" are the words or portions of words, letters or numbers printed beneath each game symbol in the play area and are used to repeat or explain the game symbol. The game symbol caption associated with each game is as follows:

Play Symbol	Play Symbol Caption
Image of a heart	HART
Image of a spade	SPDE
Image of a diamond	DIAM
Image of a club	CLUB

(c) "Ticket validation number" means a unique number appearing on each ticket which is used to validate winning tickets. For this instant game, the ticket validation number is an 11-digit number which appears on the front of each instant ticket and will be covered by latex.

(d) "Book-ticket number" means the unique number appearing on each ticket which includes the number of the book from which it was removed and the serially assigned number of the ticket within that book. For this instant game, the book-ticket number is an 8-digit book number followed by a dash and then a 3-digit ticket number. The ticket numbers in each book start with 000 and end with 299. The book-ticket number is printed in black ink on the back of each instant game ticket both above the information form and below the bar code.

(e) "Retailer validation code" means the small letters found under removable covering in the play area of each instant game ticket. The retailer uses this code to verify and validate winners which are to be paid by the retailer. In this instant game, the retailer validation code is a three letter code printed and appearing in three of eight varying locations among the game symbols. The codes and their meanings are as follows: ONE = \$1.00; TWO = \$2.00; FIV = \$5.00; TEN = \$10.00; TWY = \$20.00; FTY = \$50.00; HUN = \$100.00; THN = \$200.00.

(f) "Bar code" means the 16-digit bar-coded number appearing on the back of each ticket. (Authorized by and implementing K.S.A. 1996 Supp. 74-8710; effective, T-111-6-9-1997, April 18, 1997.)

111-4-1015. Determination of instant prize winners. An instant prize winner is determined for this instant game when the player removes or "scratches off" the removable layer of material covering the play area to reveal 10 play symbols. After removing the material covering the play area, if one or more club symbols are revealed, player wins the prize amount indicated in the prize legend on the front of the ticket. Prizes shall be awarded as follows:

50-2-25a. Electronic filing, definitions. (a) "Electronically filed document" means a "status determination report," an "employer's quarterly wage report and contribution return," or any document filed with the secretary of human resources, pursuant to chapter 44 of the Kansas statutes annotated, that is filed pursuant to these regulations.

(b) "Electronic filing" means the authorized electronic transmission of information required by the Kansas statutes annotated and these regulations when an employing unit or the employing unit's representative transmits to the secretary of human resources a "status determination report" or an "employer's quarterly wage report and contribution return," pursuant to chapter 44 of the Kansas statutes annotated and these regulations.

(c) "Filing party" means the following:

- (1) the employing unit;
- (2) the employing unit's representative; or
- (3) the person authorized to make electronic filings.

(d) "INK" means the information network of Kansas.

(e) "Secretary" means the secretary of human resources. (Authorized by and implementing L. 1996, Ch. 157, Sec. 1; effective July 7, 1997.)

50-2-25b. Electronic filing, authorized user. A filing may be authorized to use electronic filing upon the written authorization of the secretary or the secretary's designee and INK.

(a) The filing party shall be authorized by the secretary and INK to use electronic filing if these requirements are met:

- (1) the filing party has an account with INK; and
- (2) the secretary and INK determine, after appropriate testing, that the secretary is capable of receiving, indexing, and retrieving the data transmitted by the filing party.

(b) The filing party's authorization to use electronic filing may be suspended or revoked by the secretary when the secretary determines that a filing party's transmis-

sions are incompatible with the electronic filing system or when the secretary receives notification from INK that the filing party is delinquent in making payments on its account.

(c) Each request for authorization to use electronic filing shall be submitted to INK. Upon receiving a request for authorization, INK shall notify the secretary. INK shall provide the requesting party with the necessary information and software or specifications to test the filing party's electronic filing capabilities.

(d) If the filing party is authorized to use electronic filing, INK shall assign an identification number to the filing party. If the filing party will act as a representative for an employing unit, the filing party shall submit to INK a sworn statement attesting to that authorization signed by the employing unit, and INK shall assign an identification number to the employing unit. If the employing unit terminates its relationship with the filing party, the employing unit shall notify INK in writing, and its identification number shall be invalidated. (Authorized by and implementing L. 1996, Ch. 157, Sec. 1; effective July 7, 1997.)

50-2-25c. Electronic filing, contents of transmission. (a) Each transmission of one or more documents for electronic filing shall include the applicable requirements of chapter 44 of the Kansas statutes annotated and shall identify the filing party in a form approved by the secretary and INK.

(b) Each electronically filed document that requires identification of an employing unit shall contain the federal tax identification number and shall indicate whether the debtor is an individual or another entity.

(c) When a request is made for a paper copy of an electronically filed document, the copy printed by the secretary shall include a notation stating that the document is an electronically filed document. (Authorized by and implementing L. 1996, Ch. 157, Sec. 1; effective July 7, 1997.)

50-2-25d. Electronic filing, identification of employing unit. When a regulation adopted pursuant to chapter 44 requires the name of the employing unit or the address of the employing unit, the filing party shall transmit to the secretary and INK an employing unit identification number designated by INK with each document. (Authorized by and implementing L. 1996, Ch. 157, Sec. 1; effective July 7, 1997.)

50-2-25e. Electronic filing, date of filing. (a) An electronically filed document shall be deemed to have been filed on the date and at the time the transmission is received and confirmed by the secretary.

(b) Each filing party shall be provided by the secretary, through INK, a confirmation that all transmitted documents meet the requirements of these regulations, including the date and time of filing.

(c) Any document transmitted to the secretary that does not contain the information required by these regulations shall not be filed, and the filing party shall be provided by the secretary, through INK, with a notice that identifies the document and states the reason for rejection of the document. (Authorized by and implementing L. 1996, Ch. 157, Sec. 1; effective July 7, 1997.)

DETERIORATING CONDITION

121-5-1. Definitions. For the purpose of this article, the following definitions shall apply.

(a) "Average monthly loss" means an amount equal to the loss, if any, incurred by the credit union for the measuring period divided by the number of months in the measuring period.

(b) "Credit union" means a credit union, as defined in K.S.A. 17-2231, that serves primarily natural person members.

(c) "Loss," for any measuring period, means the amount, if any, by which total expenses and other charges against income exceed the total revenue of the credit union.

(d) "Measuring period" means the last complete fiscal year of the credit union, unless the review period is less than the last complete fiscal year. If the review period is less than the last complete fiscal year, the measuring period shall be the period covered by the credit union's latest report of condition filed with the administrator, through the last day of the month preceding the month in which the calculation for determination of status under this article five is made.

(e) "Review period" means the time period specified by the administrator for which the books and records of a credit union are to be reviewed in order to determine if a credit union may be deemed to be in a deteriorating condition, as stated in K.A.R. 121-5-2(a).

(f) "Unallocated reserves" means the aggregate of all reserves and undivided earnings, other than reserves required by K.S.A. 17-2217, plus any net income after required statutory reserve transfers for the measuring period. (Authorized by and implementing K.S.A. 1996 Supp. 17-2206(d); effective July 7, 1997.)

121-5-2. Determination of deteriorating condition.

(a) A credit union may be deemed, by the administrator, to be in a deteriorating condition when, for the measuring period, the quotient from dividing the unallocated reserves by the average monthly loss is less than 24.

(b) Before making a determination that a credit union is in a deteriorating condition, the administrator shall send a notice to the credit union stating the provision of K.A.R. 121-5-2(a) pursuant to which the credit union may be deemed to be in a deteriorating condition. The notice shall specify a date, not less than 15 days after the date the notice is sent by the administrator, by which the credit union may provide any information or plan of corrective action for the administrator to review before making a determination that the credit union is in a deteriorating condition.

(c) Any information provided on or before the date specified in the notice shall be considered by the administrator. Any information provided after the date specified in the notice may be considered by the administrator.

(d) After the date specified in the notice, the credit union may be determined by the administrator to be in a deteriorating condition. Such determination shall be evidenced by an order of the administrator issued pursuant to K.S.A. 1996 Supp. 17-2206(d) and amendments thereto. (Authorized by and implementing K.S.A. 1996 Supp. 17-2206(d); effective July 7, 1997.)

STANDARDS AND REGULATIONS

28-31-10a. Off-site hazardous waste treatment fees. (a) Each off-site hazardous waste treatment facility shall pay fees proportionate to the quantity of hazardous waste treated, subject to the caps set forth in K.S.A. 1996 Supp. 65-3431, subsection (x). These fees shall be based upon the following schedule:

Hazardous Waste Category	Fee
Dioxin	\$20 per ton
Fewer than 5,000 British Thermal Units (BTUs) per pound	\$10 per ton
Equal to or greater than 5,000 BTUs per pound	\$2 per ton

For the purpose of calculating these fees, these definitions shall apply.

(1) "Dioxin" shall mean hazardous wastes carrying EPA hazardous waste numbers F020, F021, F022, F023, F026, F027, or F028, or any combination of these hazardous waste numbers. "Ton" shall mean 2,000 pounds.

(b) Payment of the treatment fees assessed under subsection (a) of this regulation shall be made quarterly. The quarterly fee shall be paid on or before the last day of April, July, October, and January for the preceding three-month period ending the last day of March, June, September, and December.

(c) Each treatment fee payment shall meet these requirements:

(1) be made by check or money order made payable to the "Kansas department of health and environment—attention: environmental permit fund"; and

(2) be accompanied by a form, furnished by the department and completed by the facility operator. The form shall state the total weight of hazardous wastes treated during the reporting period and shall provide sufficient information to verify findings that a treatment process qualified as material or energy recovery. (Authorized by and implementing K.S.A. 1996 Supp. 65-3431; effective April 6, 1992; amended July 7, 1997.)

Oakley, Topeka State Hospital grounds, Topeka, to consider the adoption of amended changes to existing rules and regulations on a permanent basis effective October 1, 1997. Telephone conference will not be available.

This 60-day notice of the public hearing shall constitute a public comment period for the proposed regulations. All interested parties may submit written comments prior to or during the hearing to Hope Burns, Office of the Secretary, Department of Social and Rehabilitation Services, Docking State Office Building, Room 603-N, 915 S.W. Harrison, Topeka, 66612. All interested parties will be given a reasonable opportunity to present their views; it may be necessary to request each participant to limit any oral presentation to five minutes.

Copies of the regulations and the economic impact statement may be obtained by contacting Hope Burns at (913) 296-3969.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Hope Burns or by calling the Kansas Relay Center at 1-800-766-3777.

The adoption of the regulations will take place at 9 a.m. August 25 in the SRS executive conference room, 603-N,

Docking State Office Building. Telephone conference will not be available.

A summary of the proposed regulations and the economic impact follows. The phrase "Federal Mandate" following an item indicates that the change is required by federal policy. Optional changes in regulations related to federal programs are subject to approval by the U.S. Department of Health and Human Services.

Article 4.—PUBLIC ASSISTANCE PROGRAM

30-4-35. Application process. This regulation is being amended to change the application processing time to 30 days from the date the agency receives a signed application.

Economic Impact: This change is not expected to have any discernable economic impact.

30-4-39. Responsibilities of applicants and recipients. This regulation is being amended to remove the requirements for reporting of changes of circumstances within 10 calendar days of the change. This complies with changes previously made to K.A.R. 30-4-35.

Economic Impact: This change is not expected to have any discernable economic impact.

30-4-40. Agency responsibility to applicants and recipients. This regulation is being amended to require release of confidential information concerning the reporting of a person's name, address, and other identifying information to the Immigration and Naturalization Service when the agency knows the person is residing unlawfully in the United States.

Federal Mandate: This change is required by Section 411 A of Title IV of the Personal Responsibility and Work Opportunity Reconciliation Act of 1996 (PL. 104-192).

30-4-52. Act in own behalf. This regulation is being amended regarding a minor's ability to act in his or her own behalf. Unless emancipated based on age and marital status or based on court action, a minor shall not be deemed capable of acting in his or her own behalf and must reside with a qualifying caretaker to be eligible for assistance except in limited circumstances.

Federal Mandate: This change is required by Section 408 of the Social Security Act as amended by the Personal Responsibility and Work Opportunity Reconciliation Act of 1996 (PRWORA).

Economic Impact: This change is expected to result in decreased expenditures of \$534,332 (\$133,608 state general funds) on an annual basis.

Bearer of Cost: None

Affected Parties:

1. This change will have minimal administrative impact on SRS staff.
2. Approximately 168 teens may be impacted by the change such that they lose eligibility for assistance until residence is established with a caretaker.

Other Methods: No other methods were considered as this change is mandated by federal law.

30-4-70. Eligibility factors specific to the TANF program. This regulation is being amended to revise the definition of a child to include a child who is age 18 and in

secondary school or working towards the attainment of a G.E.D.

Economic Impact: This change is not expected to have any discernable economic impact.

This regulation also is being amended to remove reference to persons who are ineligible due to the receipt of a lump sum payment as it relates to persons whose needs are excluded in determining eligibility. Lump sum income is now exempted per K.A.R. 30-4-113.

Economic Impact: This change is not expected to have any discernable economic impact.

30-4-90. Eligibility factors specific to the GA program. This regulation is being amended to revise the criteria related to persons whose needs are to be excluded in determining eligibility. Reference to persons who are ineligible due to receipt of lump sum income has been removed as such income is no longer counted per K.A.R. 30-4-113. Reference has been added for persons denied assistance based on the provisions of K.A.R. 30-4-50 (c) or (d).

Economic Impact: This change is not expected to have any discernable economic impact.

30-4-96. Funeral assistance (FA) program. This regulation is being amended to clarify that eligibility for assistance shall be based on the assets of the family group as of the calendar month of death when the decedent was a child under age 21 and living with his or her parent at the time of death.

Economic Impact: This change is not expected to have any discernable economic impact.

30-4-106. General rules for consideration of resources, including real property, personal property, and income. This regulation is being amended to delete the provision for counting a portion of monies voluntarily contributed by a household member who is not part of the mandatory filing unit. Such monies shall now be counted in full. Other technical changes have been made.

Economic Impact: This change is not expected to have any discernable economic impact.

30-4-107. Property exemption. This regulation is being amended to increase the allowable resource standard in the cash assistance programs from \$1,000 to \$2,000.

Economic Impact: This change is not expected to have any discernable economic impact.

This regulation is being further amended to remove the provision for providing up to nine months of assistance if an applicant or recipient is attempting to dispose of excess real property.

Economic Impact: This change is not expected to have any discernable economic impact.

30-4-109. Personal property. This regulation is being amended to exempt the cash value of any life insurance policy.

Economic Impact: This change is not expected to have any discernable economic impact.

30-4-112. Income exempt from consideration as income and as a cash asset. This regulation is being amended to make a technical change in wording by replacing reference to coupon allotments for food stamps with reference to benefits provided.

Economic Impact: None.

30-4-113. Income exempt as applicable income. This regulation is being amended to clarify that the interest income exemption shall not exceed \$50 per month per family group.

Economic Impact: This change is not expected to have any discernable economic impact.

Article 5.—PROVIDER PARTICIPATION, SCOPE OF SERVICES, AND REIMBURSEMENTS FOR THE MEDICAID (MEDICAL ASSISTANCE) PROGRAM

30-5-94. Reimbursement for pharmacy services. This regulation is being amended because some pharmacies are charging the maximum Medicaid allowable for pharmacy services even though this is more than their usual and customary charge. This regulation clarifies that this is a violation of the Medicaid Provider Agreement.

Economic Impact: This will be an undeterminable cost savings due to this regulation.

Bearer of Cost: This savings will accrue to the Department of Social and Rehabilitation Services.

Affected Parties:

1. Pharmacies enrolled in the Kansas Medicaid Program that are charging more than their usual and customary charge for allowed pharmacy services. Certain pharmacies are charging the maximum of what the Medicaid program will reimburse regardless of the usual and customary charge. This regulation clarifies that this is a violation of the Medicaid Provider Agreement.

Other Methods: There were no appropriate methods that would yield the same outcome.

30-5-107. Scope of non-ambulance medical transportation services. This regulation is being amended to clarify that prior authorization is required only for non-commercial non-ambulance medical transportation services. Commercial services do not require prior authorization. This amendment makes the regulation consistent with current policy.

Economic Impact: No fiscal impact will occur as this regulation change is administrative only. This regulation change reflects the current policy on non-commercial ambulance medical transportation (NAMT). The only change to this regulation was to add the word non-commercial in front of NAMT to clarify that commercial NAMT did not require prior authorization.

Bearer of Cost: None.

Affected Parties:

1. No parties will be affected because this regulation change reflects current policy and procedures.

Other methods: There were no appropriate methods that would yield the same outcome.

Article 6.—MEDICAL ASSISTANCE PROGRAM— CLIENTS' ELIGIBILITY FOR PARTICIPATION

30-6-35. Application process. This regulation is being amended to change the application processing timeframe to 30 days for non-SSI while retaining the current 45 and

90-day processing times for SSI depending on whether a disability finding is required.

Economic Impact: This change is not expected to have any discernable economic impact.

30-6-52. Act in own behalf. This regulation is being amended regarding a minor's ability to act in his or her own behalf. Unless emancipated based on age and marital status or based on court action, a minor shall not be deemed capable of acting in his or her own behalf and must reside with a qualifying caretaker, representative payee for social security benefits, or a responsible adult to be eligible for assistance except in limited circumstances.

Economic Impact: See the economic impact statement for K.A.R. 30-4-52.

30-6-77. Poverty level pregnant women and children; determined eligibles. This regulation is being amended to adjust the maximum age in the older children category to under 19 based on current federal provisions regarding coverage of this group.

Economic Impact: This change is not expected to have any discernable economic impact as it reflects current policy.

30-6-82. Technology-assisted child; determined eligibles. This regulation is being amended to increase the age range for this program to age 18.

Economic Impact: This change is not expected to have any discernable economic impact.

30-6-106. General rules for consideration of resources, including real property, personal property, and income. This regulation is being amended to delete the provision for counting a portion of monies voluntarily contributed

by a household member who is not in the plan. Such monies will now be counted in full. Other technical changes have been made.

Economic Impact: This change is not expected to have any discernable economic impact.

30-6-107. Property exemption. This regulation has been amended to remove the provision for non-SSI for providing up to nine months of assistance if an applicant or recipient is attempting to dispose of excess real property.

Economic Impact: This change is not expected to have any discernable economic impact.

30-6-109. Personal property. This regulation is being amended to exempt the cash value of any life insurance policy in the non-SSI programs.

Economic Impact: This change is not expected to have any discernable economic impact.

30-6-112. Income exempt from consideration as income and as a cash asset. This regulation is being amended to make a technical change in wording by replacing reference to coupon allotments for food stamps with reference to benefits provided.

Economic Impact: None.

30-6-113. Income exempt as applicable income. This regulation is being amended to clarify that the interest income exemption shall not exceed \$50 per month per family group.

Economic Impact: This change is not expected to have any discernable economic impact.
