Request for Information

The Kansas Department on Aging is issuing a Request for Information (RFI) to obtain information from non-profit, private organizations regarding their interest in and capabilities for administering the State Long-Term Care Ombudsman Program for the State of Kansas and the Department on Aging. Information obtained from this RFI will be used to determine the feasibility of formulating competitive bid specifications for a Request for Proposals to administer the State Long-Term Care Ombudsman Program mandated by state law (K.S.A. 1996 Supp. 75-5916 *et seq.*) and the federal Older Americans Act (42 U.S.C. 3058g).

The state is soliciting concise, detailed and understandable information regarding an organization's interest and ability in administering a state and federally funded program that (a) delivers long term care ombudsman services to residents of nursing facilities throughout Kansas, and (b) collects and reports data on services delivered. The administrative services are to be provided in a systematic and integrated fashion. Consistency in the delivery of high quality services and in data collection are desired outcomes.

Information is being sought from qualified nonprofit private organizations possessing the objectivity, experience, knowledge, skills and abilities to effectively administer the performance of statutory duties of long-term care ombudsmen in nursing facilities across the state and to make required reports in a timely manner.

Administration will need to be provided for the existing program components that will be maintained, including, but not limited to:

1. Toll-free hotline;
2. Information and referral;
3. Complaint system: investigation, mediation and resolution;
4. Complaint investigation support;
5. Training of staff for complaint investigation, mediation and resolution;
6. Expansion of volunteer long term care ombudsman program;
7. Technical assistance; and
8. Access to legal counsel, including legal advice and defense.

Each respondent should include in its response its qualifications to administer the program, including a brief history of the respondent organization, evidence of credibility, and resumes for key staff members involved in preparing the RFI response. Not-for-profit organizations should supply evidence of corporate standing with the Kansas Secretary of State's Office (if corporations) and evidence of their not-for-profit status with the Internal Revenue Service. Any experience with state and federal programs for Kansas seniors or other senior citizens should be discussed. Respondents should supply information demonstrating their capacity and ability to provide the services required to administrate the program and to support the operations of the program.

Responses should be prepared in a simple and economical manner providing a straightforward, concise description of the information being requested in this RFI. Emphasis should be on completeness and clarity of content. Respondents shall bear all costs of producing and delivering their responses to the RFI and in answering questions posed by the state.

No formal conferences will be held prior to the deadline for the responses to the Request for Information. All questions received in writing will be answered; no questions received in person or by telephone alone will be answered. Due to the short time frame involved, the state will answer written questions by telephone, so respondents need to include the name and telephone number of the person who speaks on behalf of the respondent.

The state may request some respondents to appear, present its information and respond to questions. The state also may telephone some respondents with questions about its information.

Administrative Regulations

The Kansas Department of Health and Environment, Division of Environment, Bureau of Air and Radiation, will conduct a public hearing at 1 p.m. Wednesday, August 27, in the KDHE main conference room, Building 283, Forbes Field, Topeka, to consider the adoption of new permanent air quality regulations K.A.R. 28-19-721 to 727, and to consider the adoption of a Municipal Solid Waste Landfill Emissions Implementation Plan. These air quality regulations will establish standards for the control of emissions from large existing municipal solid waste landfills.

Proposed Regulations:

K.A.R. 28-19-721 adopts by reference the definitions from the New Source Performance Standards that also will be applied to the regulations for existing landfills.

K.A.R. 28-19-722 establishes criteria for determining which existing landfills will be affected by the proposed regulations. These criteria include: date construction or modifications occurred; whether the landfill has accepted waste since November 8, 1987, or has additional capacity; and whether the landfill has a design capacity greater than or equal to 2.5 million megagrams. In addition, this regulation includes a paragraph stating that landfills that qualify for the small landfill exemption (less than 20 tons per day) are exempted from the rule.

K.A.R. 28-19-723 requires landfills that meet the criteria outlined in K.A.R. 28-19-722 to prepare and submit an initial design capacity report, with a requirement for an annual update of the report, and a requirement for a closure notification.

K.A.R. 28-19-724 requires landfills that meet the criteria outlined in proposed K.A.R. 28-19-722 to calculate NMOC emissions to determine whether the landfill will be subject to collection and control requirements. Annually recalculation of emissions is required, and the proposed rule adopts by reference the EPA test methods and procedures used to calculate NMOC emissions.

K.A.R. 28-19-725 outlines requirements for those landfills required to install collection and control systems pursuant to K.A.R. 28-19-724, including system design, operations, compliance determinations and monitoring system effectiveness.

K.A.R. 28-19-726 adopts the federal recordkeeping and reporting requirements verbatim.

K.A.R. 28-19-727 establishes a time frame for existing MSW facilities subject to the proposed regulations to come into compliance.

The State of Kansas is required by the Federal Clean Air Act, as amended in November, 1990, to development NMOC emission guideline rules for existing landfills not subject to the federal new source performance standards to remain the primary authority for the administration and enforcement of the air quality program. The costs of compliance to affected facilities is therefore not changed by the state's adoption of the requirements; the initial fed-

eral promulgation imposed the compliance costs. The number of Kansas landfills large enough to have to meet the collection and control requirements of the emission guidelines rule will be very small, likely less than five sites. The approach taken by the department regarding notification and reporting of initial design capacities will be less costly to the owners and operators of exempt small landfills than would be required by federal implementation of the regulations.

Implementation Plan:

The proposed implementation plan describes how the department will implement proposed new air quality regulations, K.A.R. 28-9-721 to 727, relating to the control of non-methane organic compound emissions from large existing municipal solid waste landfills.

Section 111(d) of the federal Clean Air Act Amendments of 1990 requires states to submit to the Environmental Protection Agency (EPA) state plans to implement and enforce emission guidelines promulgated by the EPA. Regulations controlling the emissions of landfill gas from municipal solid waste landfills were issued as a final rule by the EPA on March 12, 1996. The regulations are entitled "Standards of Performance for New Stationary Sources and Guidelines for Control of Existing Sources: Municipal Solid Waste Landfills."

The time period between the publication of this notice and the scheduled hearing constitutes a public comment period for the purpose of receiving written comments on the proposed regulations. All interested parties may submit written comments to Gary Miller, Bureau of Air and Radiation, Kansas Department of Health and Environment, Forbes Field, Building 283, Topeka, 66620. All interested parties will be given a reasonable opportunity to present their views orally during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to require each participant to limit any oral presentation to five minutes.

Administrative Regulations

The Kansas Department of Health and Environment, Division of Environment, Bureau of Air and Radiation, will conduct a public hearing at 10 a.m. Wednesday, August 27, in the KDHE main conference room, Building 283, Forbes Field, Topeka, to consider the proposed revocation of existing Kansas air quality regulation K.A.R. 28-19-7, the adoption of proposed amendments to existing air quality regulation K.A.R. 28-19-16a, and the adoption of proposed new Kansas air quality regulations K.A.R. 28-19-200 and K.A.R. 28-19-201. These regulations establish the definitions of terms used in the Kansas air quality regulations.

K.A.R. 28-19-7 contains the existing primary definitions for the Kansas air quality regulations series. It is being proposed for revocation to allow for the renumbering of the regulation to K.A.R. 28-19-200 in accordance with planned improvements to the Kansas air quality regulations, and for the placement of certain lists in the existing regulation into a new, separate regulation, K.A.R. 28-19-201.

K.A.R. 28-19-16a establishes definitions under the Kansas nonattainment new source review program. This regulation is being proposed for amendment to eliminate duplicate definitions, *i.e.*, terms that are already defined in the primary definitions regulation, existing K.A.R. 28-19-7, and that will continue to be defined in new regulation K.A.R. 28-19-200. Changes also are made to correct grammatical and other nonsubstantive elements of the regulation.

K.A.R. 28-19-200 and 28-19-201 will replace existing K.A.R. 28-19-7. New regulation 28-19-200 also will in-

clude changes to improve and correct grammatical and other nonsubstantive errors identified in the review of 28-19-7. A definition for the term "municipal solid waste landfill" is added to coordinate with the proposed new regulations concerning emissions control from such facilities; the addition of the term to the definitions does not by itself create any new requirements. The definition of "de minimis" is amended to conform to the federal definition.

K.A.R. 28-19-201 is a proposed new regulation into which the lists of "volatile organic compounds" and "hazardous air pollutants" are placed to separate them from the main body of definitions. These lists are based on federal lists that are subject to occasional modification at the federal level, and consequently require updating of the lists by the state to assure consistency with the federal program. To minimize the expense and time involved in such updates, these lists are to be placed in new K.A.R. 28-19-201 so that these state changes may be adopted without also reviewing and reprinting the whole of the definitions each time. Also, this new regulation incorporates one such federal change to the Kansas air program, adding perchloroethylene to the list of negligibly photochemically-reactive compounds.

No additional economic impact upon the regulated community, the public or the agency is expected from these proposed regulatory changes.

The time period between the publication of this notice and the scheduled hearing constitutes a public comment period for the purpose of receiving written public comments on the proposed regulatory action. All interested parties may submit written comments prior to the hearing to Ralph J. Kieffer, Kansas Department of Health and Environment, Bureau of Air and Radiation, Building 283, Forbes Field, Topeka, 66620. All interested parties will be given a reasonable opportunity to present their views orally on the proposed regulatory action during the hearings, as well as to submit their written comments at that time. In order to give all parties an opportunity to present their views, it may be necessary to require each participant to limit any oral presentation to five minutes.

RegulationsArticle 9.—COLLECTION OF DEBTS OWED TO
DISTRICT COURTS AND RESTITUTION

16-9-1. Administrative costs. Each contracting agent who collects debts owed to district courts or restitution pursuant to K.S.A. 1996 Supp. 75-719 shall pay monthly to the attorney general an amount for administrative costs as established by contract, which shall not exceed one percent of the amount collected by that contracting agent that month. As needed, each contract shall specify other terms and conditions appropriate to facilitate collections and to ensure that these contracts for collection can be monitored statewide. (Authorized by and implementing K.S.A. 1996 Supp. 75-719; effective July 11, 1997.)

RegulationsArticle 39.—RAIL SERVICE
ASSISTANCE PROGRAM**36-39-1. Priorities for loan guarantee applications.**

(a) Compliance with the following criteria shall increase the priority standing of an application for a loan guarantee:

(1) the rail lines affected have less than 5,000,000 gross tons per mile annually;

(2) the application demonstrates a higher benefit-to-cost ratio than the minimum ratio required by statute and regulation;

(3) the application demonstrates that operations will be made more efficient by raising the minimum operating speed to one of the following F.R.A. classes:

(A) F.R.A. class one to F.R.A. class two; or

(B) F.R.A. class two to F.R.A. class three;

(4) the application demonstrates a positive statewide or regional economic impact;

(5) the application demonstrates that the project for which funding is sought will result in road or highway maintenance cost savings for state and local governmental entities;

(6) the application describes the tangible assets of and the net worth of the applicant; and

(7) the application demonstrates the commitment of capital, or the guarantee of a set amount of rail traffic by local shippers, governmental entities or other interested parties, to the applicant for the continued operations of rail service for which a loan guarantee is sought. (Authorized by K.S.A. 1995 Supp. 75-5050 and 75-5046; implementing K.S.A. 75-5040; effective Aug. 30, 1993; amended July 11, 1997.)

36-39-2. Definitions. As used in this article, the following words and phrases shall have the meanings ascribed to them in this regulation.

(a) "Applicant" means any qualified entity which submits an application to the secretary for a loan guarantee.

(b) "Commission" means the interstate commerce commission.

(c) "Equipment" means any type of new or rebuilt standard gauge locomotive or general service railroad freight car. General service railroad freight cars may include a boxcar, gondola, open-top or covered hopper car, and flatcar.

(d) "Facilities" means the following:

(1) track, roadbed, and related structures, including rail, ties, ballast, other track materials, grading, tunnels, bridges, trestles, culverts, repair shops, connecting tracks, and public improvements used or usable for rail service operations;

(2) signals and interlockers; and

(3) terminal or yard facilities, including trailer-on-flatcar and container-on-flatcar terminals, railroad terminal and switching facilities, and service to express companies and railroads and their shippers.

(e) "F.R.A." means federal railroad administration of the United States department of transportation.

(f) "Lender" means the obligee, holder or creditor under an obligation, except that when a bank or trust company is acting as agent or trustee for such an obligee, holder or creditor, pursuant to an agreement to which the obligor is a part, the term refers to such bank or trust company.

(g) "Loan guarantee" means a guarantee by the state of Kansas to pay off the remaining principal of a specific loan under the terms of K.A.R. 36-39-3.

(h) "Obligation" means a loan, note, conditional sale agreement, security agreement or other obligation issued or granted to finance or refinance facilities or equipment acquisition, construction, rehabilitation or improvement.

(i) "Obligor" means the debtor under an obligation, including the original debtor and any successor or assignee of such debtor who is approved by the secretary.

(j) "Qualified entity" means any railroad holding an interstate commerce commission certificate, a port authority established in accordance with Kansas law or any legal entity that obtains an interstate commerce commission certificate within six months after qualifying for a loan guarantee.

(k) "Secretary" means the secretary of the Kansas department of transportation, or the secretary's designee. (Authorized by K.S.A. 1995 Supp. 75-5046 and 75-5050; implementing K.S.A. 75-5046, 75-5047, 75-5048 and 75-5049; effective Aug. 30, 1993; amended July 11, 1997.)

36-39-3. Requirements and conditions for application for a loan guarantee. (a) Each qualified entity and its lender shall file with the secretary the original and 10 copies of each application.

(b) The loan guarantee program's aggregate annual obligations shall not exceed \$5,000,000. If, at the time of application, loan guarantees have previously been approved by the legislature or state finance council during the same fiscal year, the amount requested shall not ex-

ceed the difference of \$5,000,000 and the amounts previously approved during that fiscal year. The sum of the amounts sought in each fiscal year, including any outstanding loan guarantees previously approved pursuant to K.S.A. 1995 Supp. 75-5046, shall not exceed \$20,000,000.

(c) The applicant and lender shall acknowledge in the application that obligations of the state of Kansas resulting from the approval of an application shall be limited to payment of the remaining principal of the specific loan after lenders have exhausted all other available remedies against the obligor.

(d) Each application shall include the following:

(1) the full and correct name, principal business address, telephone number and facsimile number of the applicant;

(2) the date of the applicant's incorporation, or organization if not a corporation, and the name of the government, state, or territory under the laws of which it was incorporated or organized. If the applicant is a partnership, association or other form of organization other than a corporation, a full description of the organization shall be furnished;

(3) the name, title, and address of the person to whom correspondence regarding the application should be addressed;

(4) a certified copy of proposed or executed loan agreements, including related agreements or other documents, and detailed descriptions of the loan guarantee, including:

(A) the total amount of the loan to be guaranteed;

(B) a description of all facilities included in or directly affected by the proposed project, the physical condition of such facilities and a description of the project;

(C) each part or sub-part into which the project may reasonably be divided and the priority and schedule of expenditures for each part or sub-part;

(D) the estimated timing of the expenditure of the proceeds of the loan;

(E) a statement of whether the project involves another railroad or other participant, through joint execution, coordination, or otherwise. The applicant shall include a description of the relative participation of the applicant and the other railroad or participant, including a statement of the financing arrangements of each participant, the portion of the work to be performed by each participant and the contemplated level of usage of the facility by each participant when the work is completed, along with a statement by a responsible officer or official of the other railroad or participant that the information provided reflects their agreement on these matters;

(F) the effective date of the loan;

(G) a schedule of repayment of the principal and interest;

(H) a description of the security to be offered the secretary in connection with any loan guarantee, including a description of the priority of this loan in relation to other liens or security interests on the property that is designated as security, the applicant's opinion of the value of this security, and the basis for the opinion; and

(I) a description of the lender's security and remedies against the obligor or any other parties before the state of Kansas is obligated to pay any defaulted loan; and

(J)(i) if the loan for which a guarantee is sought is outstanding, the effective interest rate of the loan for which a loan guarantee is sought; or

(ii) if the applicant has discussed with a potential lender the terms of a loan guarantee to be issued, the proposed effective rate of interest.

(5) a statement, in summary form, showing financial obligations to or claims against the state of Kansas or obligations for which the state of Kansas is guarantor, if any. Such statements shall be made by the applicant, any affiliated corporate entity of the applicant or the applicant's parent, and shall describe the following:

(A) the status of any and all claims under litigation; and

(B) any other debts or guarantees existing between the applicant and the state of Kansas, including the name of the department or agency involved in such loans, claims or other debts;

(6) an analysis which includes the following:

(A) a statement that the financing is justified by present and future demand for rail services, that the financing will meet existing needs for such services and that the project will provide shippers with improved service. The applicant shall submit supporting evidence with the statement, including copies of all market analyses and studies which have been performed to determine present and future demand for rail services;

(B) a description of the impact of the financing upon the projected traffic to be originated, terminated, or carried by the obligor for at least the five years immediately following completion of the project;

(C) a five-year *pro forma* statement of cash flow attributable to the project; and

(D) a description of any other benefit which would accrue to the applicant from the proceeds of the obligation;

(7) a business plan, with supporting evidence, showing:

(A) that the applicant is financially capable of acquiring, rehabilitating, or improving facilities in an efficient and economical manner;

(B) that the ratio of benefits-to-costs for any project funded by such guaranteed loan will be greater than one. The benefit-to-cost methodology to be used for this determination shall be the "Benefit-cost methodology for the Local Rail Freight Assistance Program" approved by the F.R.A. in July, 1990;

(C) that the applicant will submit with the application audited financial statements, prepared in accordance with generally accepted accounting principles, for the past two annual accounting periods;

(D) any car supply agreements and the estimated rail traffic;

(E) a balance sheet, income statement, statement of changes in financial position or statement of cash flows, notes to financial statements, operating plans and appraisals of the assets to be acquired;

(F) that the applicant has been turned down by a lending institution and that adequate funding for the proposed project is not otherwise available on terms that would make the proposed project financially feasible, in the absence of a state loan guarantee; and

(continued)

(G) a written opinion from bond counsel that the guarantee of such loan by the secretary would not adversely affect the rating of bonds issued pursuant to K.S.A. 1991 Supp. 68-2314 *et seq.*, and amendments thereto;

(8) a statement, with supporting evidence, that the financing will improve the ability of the applicant to transport freight;

(9) a statement describing the maintenance program for the applicant's entire rail system and the planned maintenance program for the facilities financed by the proceeds of the obligation;

(10) from each existing lender or proposed prospective lender a statement which includes the following:

(A) the lender's full and correct name, principal business address, telephone number and facsimile number;

(B) references to applicable provisions of law, the lender's charter and other governing instruments that confer authority on the lender to accept the obligation;

(C) a copy of the loan agreement between the lender and the applicant;

(D) a brief statement of the circumstances and negotiations leading to the agreement by the lender to accept the proposed obligation;

(E) a copy of the lender's determination that the loan would not be economically feasible without the proposed loan guarantee;

(F) a statement of the nature and extent of any affiliation or business relationship between the existing or prospective lender and any of its directors, partners or principal executive officers, with the applicant and any of its directors, partners, or principal executive officers or with any person whose name is required to be furnished under this article; and

(G) a full and complete statement of all sums to be given to the lender in connection with the proposed obligation, including:

(i) the name and address of each person to whom any payment has been made or will be made and nature of any affiliation, association or prior business relationship between any person named in this paragraph and the lender or any of its directors, partners, or officers;

(ii) the amount of the cash payment or the nature and value of other consideration; and

(iii) any condition upon the obligation of the obligee to make any payment;

(11) a hazardous waste assessment report on the rail lines for which a loan guarantee is requested;

(12) a certificate of title to prove the applicant has the legal ability to allow its property to be encumbered;

(13) proof of liability insurance in effect in the amount of \$5,000,000 per occurrence;

(14) an opinion from applicant's counsel that applicant is legally authorized to make this application and has no outstanding litigation or impediment that would impair its ability to perform the obligation;

(15) an acknowledgement by the applicant that the secretary may conduct a pre-audit of applicant's accounting system to determine if the system is adequate to isolate and accumulate project costs; and

(16) any additional information that the applicant deems appropriate to convey a full and complete understanding of the project and its impact or to otherwise as-

sist the secretary in making a determination. (Authorized by K.S.A. 1995 Supp. 75-5046; implementing K.S.A. 1995 Supp. 75-5046 and 75-5047; effective Aug. 30, 1993; amended July 11, 1997.)

36-39-6. Rail service financial assistance; loans and grants. (a) Compliance with the criteria in K.A.R. 36-39-1(a) shall increase the priority standing of an application for a loan for railroad financing, acquisition and rehabilitation in the state of Kansas.

(b) Monies to be loaned shall originate from the rail service improvement fund.

(c) Each application for a loan shall meet the requirements of 49 C.F.R. 266 (1979), and 49 U.S.C.A. App. § 1654 (1990) unless projects have been previously evaluated in a Kansas rail plan or rail plan update.

(d) All funds loaned shall be repaid to the department of transportation within 10 years or less with an interest rate established in the loan agreement between the secretary and applicant that is equal to or less than the federal discount rate charged to depository institutions as published in the "Wall Street Journal" on the date of the application.

(e) Each application shall be in the form prescribed by the Kansas department of transportation.

(f) Monies for grants shall come from the federal railroad administration funds available through the local rail freight assistance act.

(g) Each grant application shall meet the requirements of 49 C.F.R. 266 (1979) and 49 U.S.C.A. App. § 1654 (1990) unless the project has been previously evaluated in a Kansas rail plan or rail plan update. (Authorized by K.S.A. 1995 Supp. 75-5050; implementing K.S.A. 75-5048 and 75-5049; effective Aug. 30, 1993; amended July 11, 1997.)

111-4-1018. Prerequisites for a drawing. Before the "Heartland Park Drawings" may be validly conducted, a location and the receptacle(s) or drum(s) must be approved by the executive director or his designee and the drawing must be open to the public. (Authorized by and implementing K.S.A. 1996 Supp. 74-8710; effective, T-111-6-9-97, May 16, 1997.)

111-4-1019. Prizes. The winners selected at the "Heartland Park Drawings" conducted pursuant to K.A.R. 111-4-1017 *et seq.* shall receive prizes as follows.

Eleven tickets shall be drawn, one at a drawing prior to each race final. Prizes shall be determined by the winning driver's speed in each of the eleven different classes with the winning dollar amount representing the actual speed of the winning driver with the minimum and maximum dollar amounts as follows:

111-4-1020. Entry into drawings. Entry into the "Heartland Park Drawings" is accomplished by the process detailed in the following subparagraphs:

(a) Obtain a valid \$1.00 Kansas instant lottery ticket from the lottery's selling location at Heartland Park Topeka;

(b) Determine if the ticket is a winning ticket in accordance with any instant game rules. If the ticket is a winning ticket, it is not eligible for the "Heartland Park Drawings," and shall be redeemed in accordance with the instant game rules;

111-4-1021. Determination of winners. (a) The receptacle(s) or drum(s) shall be sealed and mixed to ensure random selection.

(b) The executive director shall designate one individual of his choice to participate in the selection process.

(c) The selection of the "Heartland Park Drawings" winners shall be accomplished by the individual designated by the executive director, using a bare arm technique, removing only one ticket at a time from the contents of the receptacle(s) or drum(s) for each of the eleven drawings. Lottery security shall review the selected ticket to determine if the ticket is valid, the name stated on the information form located on the back of the selected ticket is legible, and that the ticket was purchased at Heartland Park Topeka. If the ticket is valid, the ticket is a non-winning ticket, the name is determined to be legible and

verification confirms the ticket was purchased at the Heartland Park lottery location, the name shall be announced to the audience.

(d) The named person need not be present at a drawing; but must, in any event, provide proper identification in order to claim the "Heartland Park Drawings" prize.

The audio and video tape shall contain no other material than the actual drawings beginning with the sealing of the receptacle or drum and continuing through the announcement and verification of the winner. 111-4-1023. Ticket disqualification. Such drawings, if conducted, shall be a part of the lottery "Heartland Park Drawings" and prizes, in addition to cash prizes presented by the lottery, may be donated by the co-sponsor(s). The person drawing tickets for the lottery may draw additional tickets for the co-sponsor(s) prizes. 111-4-1025. Cancellation of race/drawing. (a) If any "Heartland Park Drawing" is not held due to the Heartland Park race being cancelled because of rain out, power failure or any other unforeseen circumstance beyond the control of the Kansas lottery and Heartland Park after entries have been placed in the receptacle(s) or drum(s), it will be rescheduled. Any rescheduled drawing will be held as soon as practicable and at a location

and time determined by the executive director or the person designated by the executive director and the minimum prizes identified in K.A.R. 111-4-1019 will be awarded for each prize class which is rescheduled.

Article 5.—POWERBALL

"POWERBALL EXPLORER DRAWINGS"

111-5-58. Name of drawing. The Kansas lottery shall conduct a series of five drawings entitled "Powerball Explorer Drawings" and will accept entries on and after June 29, 1997, and ending on Sunday, September 14, 1997. The first four of the five drawings will be held at 10:00 a.m. on Fridays, July 18, 1997, August 1, 1997, August 15, 1997, and August 29, 1997, at lottery headquarters. The final drawings will be held soon after 6:00 p.m. on Sunday, September 14, 1997, at the Kansas state fair lottery building, Hutchinson, Kansas. Rules applicable to the "Powerball Explorer Drawings" are contained in K.A.R. 111-5-58 through 111-5-63 and K.A.R. 111-6-1 *et seq.* (Authorized by and implementing K.S.A. 1996 Supp. 74-8710; effective, T-111-6-9-97, May 16, 1997.)

111-5-59. Prize. (a) The grand prize winners selected in each of the "Powerball Explorer Drawings" shall receive a 1997 Ford Explorer and cash with a total value of \$45,000.

(b) There will be 10 additional winners selected at each of the five drawings and they shall each receive a \$1,000 cash prize.

(c) All prizes are subject to lottery validation, set-offs and deductions authorized by law. (Authorized by and implementing K.S.A. 1996 Supp. 74-8710; effective, T-111-6-9-97, May 16, 1997.)

111-5-60. Method of entry. Entry into the "Powerball Explorer Drawings" to be conducted on July 18, 1997, August 1, 1997, August 15, 1997, August 29, 1997, and September 14, 1997, shall be accomplished as follows:

(a) Obtain a valid "Powerball Explorer Drawings" entry coupon by purchasing a single Powerball ticket costing \$5.00 or more between June 29, 1997, and September 4, 1997, at any Kansas Powerball retailer. Entry coupons will automatically be issued by the on-line terminal at any Kansas Powerball retailer upon making such a purchase. Only valid entry coupons issued between these dates by all Kansas on-line retailers which are mailed pursuant to subsection (d) and received by the time specified in subsection (g) shall be eligible for the first four drawings. Mailed entries received by the post office identified in subsection (d) with the morning mail pickup on September 10, 1997, and entries issued at the Kansas state fair lottery building in Hutchinson, Kansas, and entered as specified in subsection (h) shall be eligible for the final drawing on September 14, 1997.

(b) Whether or not the \$5.00 Powerball ticket itself is a winning ticket, the entry coupon is eligible for the "Powerball Explorer Drawings" if entered as specified by subsection (d).

(c) Each individual entry coupon shall constitute one entry whether it comes from a single \$5.00 ticket or a \$5.00 multi-draw ticket.

(d) Place one entry coupon, not the Powerball ticket itself, into an envelope no larger than 4¾ inches x 11 inches and mail it to: "Powerball Explorer Drawings," P. O. Box 3561, Topeka, Kansas, 66601. The mailing address shall appear on each entry coupon issued. Entries in envelopes of a larger size and envelopes containing more than one Powerball entry coupon shall be ineligible for the drawings and shall be destroyed by lottery security.

(e) The holder of the entry coupon must complete the information form on each entry coupon in a legible manner. Only one name shall appear on an entry coupon in any one entry.

(h) Only valid entry coupons which are mailed and received by the morning mail pickup in Topeka, Kansas, on Thursdays, July 17, 1997, July 31, 1997, August 14, 1997, and August 28, 1997, are eligible for the first four drawings. All valid entry coupons which are mailed and received on and or between August 29, 1997, and by the morning mail pickup in Topeka, Kansas, on Wednesday, September 10, 1997, and entry coupons issued and entry coupons entered at the Kansas state fair lottery building between September 5, 1997, and 6:00 p.m. on Sunday, September 14, 1997, shall be eligible for the final drawing.

(i) Eligible entrants in any "Powerball Explorer Drawings" must be 18 years of age or older.

(j) Entrants will be eligible to win only one of the five grand prizes.

(k) Completing the information form on the entry coupon and entering the coupon into the drawing constitutes authorization to publicly identify the person whose entry

111-5-61. Certification of drawings. (a) The "Powerball Explorer Drawings" shall be personally observed by a member of the Kansas lottery division of security and the lottery event manager.

(b) Upon completion of the drawing, the security official and the event manager shall issue a report to the executive director, certifying that the name of the prize winner is correct, and that to the best of their knowledge the procedures required by these rules were followed in selecting the prize winner. (Authorized by and implementing K.S.A. 1996 Supp. 74-8710(b); effective, T-111-6-97, May 16, 1997.)

111-5-62. Selection of winners. The following process shall be used for the selection of winners in the "Powerball Explorer Drawings":

(a) Kansas lottery personnel shall pick up all mail containing "Powerball Explorer Drawings" envelopes at the United States Post Office in Topeka, Kansas, at the morning mail pickups on the Thursdays immediately preceding the Fridays of each drawing specified in K.A.R. 111-5-58. The entries for the final drawings on September 14, 1997, will be picked up at the Topeka post office in the morning mail pickup on Wednesday, September 10, 1997.

(b) For the first four drawings, lottery personnel shall transport the mail to the mail room where the entry envelopes will be retained in mail trays.

(c) The first four drawings shall be held at 10:00 a.m. at the lottery headquarters in a place accessible to the public and open for public attendance with lottery security personnel present. The final drawing shall be held at the Kansas state fair lottery building and shall be open to the public with lottery security personnel present. The drawings shall be audio and video taped.

(d) At the start of each Friday drawing, lottery security personnel shall present the mail trays, each containing approximately the same number of entries, to the person designated by the executive director to perform the drawing. Using the bare-arm technique, the person designated to perform the drawing shall insert a plastic divider into each mail tray between the entry envelopes and pull the envelope which is either behind or to the right side of the divider and place it in the drum. This procedure shall be repeated until 10 entry envelopes have been pulled from each mail tray and placed in the drum.

(e) Immediately following the placement of entry envelopes into the drum and prior to each drawing, the drum shall be sealed and the contents mixed by rotating the drum 10 times.

(f) The designated individual shall then unseal the drum, and using the bare-arm technique, while looking away, remove one envelope from the drum. The person whose name appears on the entry shall be the winner of the prize identified in K.A.R. 111-5-59, subject to validation by the lottery as set forth in these rules.

(g) After the envelope has been drawn and the entry has been verified as valid, 13 more entries will be drawn, one at a time. The first 10 valid entries drawn will receive a secondary prize of \$1,000. The last three entries drawn will serve as alternate entries. The alternate entries will

be marked in order drawn, 1A, 2A, and 3A and marked with the draw date. The alternate coupon entries will be used only if the original winners cannot be located or are declared ineligible. In the event the grand prize winning entry is disqualified or the winner cannot be located or notified within 30 days of the drawing, the second winning entry drawn will be declared the grand prize winner. Each of the remaining winners will move up one position in the order drawn.

(h) Following the morning mail pickup on Wednesday, September 10, 1997, the mailed entries will be opened by lottery personnel and placed in a secure receptacle or drum. At the final drawing on Sunday, September 14, 1997, lottery security personnel will be present with the person designated by the executive director to perform the drawing. Prior to the drawing, the receptacle or drum shall be sealed and the contents mixed by rotating the drum 10 times, if a drum is used; or by mixing the contents with a shovel or by other means for at least three minutes if another type receptacle is used.

(i) The designated individual shall then unseal the receptacle or drum, and using the bare-arm technique, while looking away, remove a single entry from the receptacle or drum. The person whose name appears on the entry shall be the winner of the prize identified in K.A.R. 111-5-59, subject to validation by the lottery as set forth in these rules.

(j) After a single entry has been drawn and the entry has been verified as valid, 13 more entries will be drawn, one at a time. The first 10 valid entries drawn will receive a secondary prize of \$1,000. The last three entries drawn will serve as alternate entries. The alternate entries will be marked in order drawn, 1A, 2A, and 3A, and marked "final draw date." The alternate coupon entries will be used only if the original winners cannot be located or are declared ineligible. In the event the grand prize winning entry is disqualified or the winner cannot be located or notified within 30 days of the drawing, the second winning entry drawn will be declared the grand prize winner. Each of the remaining winners will move up one position in the order drawn.

(k) The Kansas lottery security official present shall review each coupon drawn to determine the validity of the entry into the "Powerball Explorer Drawings" in accordance with these regulations. If it is a valid entry coupon and the name is legible, the event manager and the security person shall record the name of the winners and the winners shall be promptly notified.

(l) If the entry coupon is determined to be ineligible, it shall be discarded by the security person present and another coupon drawn. This procedure will be repeated until valid selections are obtained.

(m) All "Powerball Explorer Drawings" coupons remaining in the drum or receptacle after the winner has been selected and certified shall be destroyed after each drawing.

(n) Entry coupons are eligible for only one drawing.

(o) Grand prize winners will be eligible to win only one grand prize in the "Powerball Explorer Drawings."

(p) All "Powerball Explorer Drawings" coupons remaining in the drum or receptacle on September 14, 1997, after the winner has been selected and certified, shall be

Article 9.—INDIVIDUAL PULL-TAB GAME RULES

"TWISTER"

111-9-61. Name of game. The Kansas lottery shall conduct an instant pull-tab game entitled "Twister" starting on or around June 16, 1997. (b) "Play symbols" are the numbers, letters, symbols or pictures printed on the front and under each tab on the back of each pull-tab ticket and which determine if the ticket bearer is entitled to a prize. In this pull-tab game, the play symbols consist of images of a house, a lightning bolt, a flashlight, a van, a broken window, a radio, a cow, a power pole, a tree, and a tornado funnel. Two tornado funnels and the first seven symbols appear on the front of each ticket. Various combinations of symbols appear under each of the five tabs on the back of each ticket.

(c) "Carton" or "deal" means a box containing 2,688 pull-tab tickets.

(d) "Carton serial number" is the 9-digit number appearing on the front of the ticket.

(e) "Quarter carton" or "quarter deal" means one-fourth of a carton or deal containing 672 pull-tab tickets. (Authorized by and implementing K.S.A. 1996 Supp. 74-8710; effective, T-111-6-9-97, May 16, 1997.)

111-9-63. Determination of instant prize winners. Each tab on the back of the ticket is to be pulled open. If two tornado funnels and one of the symbols shown below appear horizontally, vertically or diagonally, with a red arrow running through all three symbols under any one tab, the player wins the prize which corresponds to the symbols appearing on the front of the ticket. On winning tickets, the amount won will appear under one of the tabs on the back of the ticket. The prize amounts are as follows:

111-9-67. Name of game. The Kansas lottery shall conduct an instant pull-tab game entitled "Blaze of Glory" starting on or around June 16, 1997. The specific rules for the "Blaze of Glory" game are contained in K.A.R. 111-9-67 through 111-9-72. Other applicable rules for the game may be found in K.A.R. 111-8-1 *et seq.* (Authorized by and implementing K.S.A. 1996 Supp. 74-8710; effective, T-111-6-9-97, May 16, 1997.)

111-9-68. Definitions. The following definitions shall apply to the "Blaze of Glory" pull-tab lottery game.

(a) "Ticket" or "card" means a Kansas lottery instant pull-tab game ticket.

(b) "Play symbols" are the numbers, letters, symbols or pictures printed on the front and under each tab on the back of each pull-tab ticket and which determine if the ticket bearer is entitled to a prize. In this pull-tab

The specific rules for the "Casino Action" game are contained in K.A.R. 111-9-73 through 111-9-78. Other applicable rules for the game may be found in K.A.R. 111-8-1 *et seq.* (Authorized by and implementing K.S.A. 1996 Supp. 74-8710; effective, T-111-6-9-97, May 16, 1997.)

111-9-74. Definitions. The following definitions shall apply to the "Casino Action" pull-tab lottery game.

(a) "Ticket" or "card" means a Kansas lottery instant pull-tab game "Casino Action" ticket.

(b) "Play symbols" are numbers, letters, symbols or pictures printed on the front and under each tab on the back of each pull-tab ticket and which determine if the ticket bearer is entitled to a prize. In this pull-tab game, the play symbols consist of pictures of a bundle of cash, an "Ace" and "Jack," a roulette wheel, poker chips, dice, champagne, a car, a slot machine, an empty pocket and a dealer. (e) "Quarter carton" means one-fourth of a carton containing 624 pull-tab tickets. (Authorized by and implementing K.S.A. 1996 Supp. 74-8710; effective, T-111-6-9-97, May 16, 1997.)

111-9-75. Determination of instant prize winners. Each tab on the back of the ticket is to be pulled open. If two symbols of a slot machine and one symbol of a bundle of cash, an "Ace" and "Jack," a roulette wheel, poker chips, dice or champagne, or a car appearing alone are printed horizontally, vertically, or diagonally under any tabs and match any combination of winning symbols shown on the front of the ticket, and are connected by a blue arrow, the player wins the prize(s) which corresponds to the symbols matched. On winning combinations, the total amount won will appear under a tab. The prize amounts are as follows:
