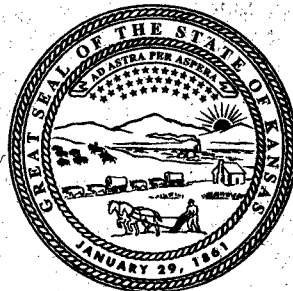

On August 27, 1997, the Policy Council met to determine a policy change regarding the application of payments to past due accounts. The change is set out below.

Issue:

Should the application of payments to past due accounts be applied to tax liability first, interest second, and penalty last?

Policy Council Decision:

The Policy Council has determined that effective with the implementation of the new integrated tax system, the application of payments to past due accounts will be assigned to tax liability first, interest second, and penalty last. Current programs will not be changed.

Reason for Policy Change:

The number one reason to change the policy on application of past due payments is to bring Kansas more in line with its neighboring states and with the IRS. The states surrounding Kansas and the IRS all apply payments for past due accounts to tax liability first and then to interest and penalty.

A public hearing will be conducted at 9 a.m. Friday, December 19, in Room 1051, Landon State Office Building, 900 S.W. Jackson, Topeka, to consider the adoption of proposed regulations on a permanent basis. This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed regulations. All interested parties may submit written comments prior to the hearing to Greg Reser, Director, Hospital and Medical Programs, Department of Health and Environment, Landon State Office Building, Suite 1001, 900 S.W. Jackson, Topeka, 66612-1290. All interested parties will be given a reasonable opportunity to present their views orally or in writing on the adoption of the proposed regulations during the hearing. Following the hearing, all written and oral comments submitted by interested parties will be considered as a basis for making changes in these proposed regulations.

Risk Management Regulations

These regulations provide further guidance to medical care facilities implementing provisions of K.S.A. 65-4922. Risk management programs in medical care facilities have been developed over the past decade and reflect basic standards of a risk management program. The regulations are proposed to provide further information to new facilities and risk managers related to implementation of K.S.A. 65-4921 *et seq.*

K.A.R. 28-52-2. This regulation provides further guidelines to medical care facilities in handling the submittal, receipt, logging and storage of risk management incident reports referenced at K.S.A. 65-4922(a)(3).

K.A.R. 28-52-3. This regulation defines the structure and role of risk management committees.

K.A.R. 28-52-4. This regulation clarifies the statutory definition of "reportable incident" determinations and requires risk management committees to document those determinations. The regulation allows committees to designate primary review clinicians if their decisions are upheld and documented by the designated committee.

There has been no significant economic impact identified as a result of the proposed regulations.

A public hearing will be conducted by the Wildlife and Parks Commission at 7 p.m. Wednesday, November 19, at the Municipal Building, 119 N. Hersey, Beloit, to consider the approval and adoption of two proposed exempt regulations of the Department of Wildlife and Parks. The public notice for six additional administrative regulations to be considered at the same meeting was published in the Kansas Register September 18, 1997.

A workshop meeting on business of the Wildlife and Parks Commission will begin at 1:30 p.m. November 19 at the same location. The meeting will recess at 5 p.m., then resume at 7 p.m. at the same location for the regulatory hearing. There will be public comment periods at the beginning of the afternoon and evening meetings for any issues not on the agenda, and additional comment periods will be available during the meeting on agenda items. Old and new business also may be discussed at this time. If necessary to complete the hearing or other business matters, the commission will reconvene at 9 a.m. November 20 at the same location.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Cindy Baugh, commission secretary, at (316) 672-5911. Persons with a hearing impairment may call the TDD service at 1-800-766-3777 to request special accommodations.

This 30-day notice period prior to the hearing constitutes a public comment period for the purpose of receiving written public comments on the proposed exempt regulations.

All interested parties may submit written comments prior to the hearing to the chairman of the commission, Kansas Department of Wildlife and Parks, Suite 502, Landon State Office Building, 900 S.W. Jackson, Topeka, 66612. All interested parties will be given a reasonable opportunity at the hearing to express their views orally in regard to the adoption of the proposed regulations.

During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending and approving, or rejecting the proposed regulations.

The regulations that will be heard during the regulatory hearing portion of the meeting, in addition to those whose notice has previously been published, are as follows:

K.A.R. 115-25-6. This proposed regulation establishes hunting unit boundaries, bag limits, application periods and season dates for the 1998 spring turkey hunting season. Under the proposal, the season would open on the second Wednesday in April and continue for 40 days, which constitutes an additional week to the end of the season. Proposed permit and game tag numbers represent no change.

Economic Impact Summary: It is estimated that 21,000 permits and 6,800 game tags will be issued in 1998, representing \$448,000 in revenue. Approximately 148,000 recreational days of hunting could occur, thus providing economic benefit to businesses providing goods and services.

K.A.R. 115-25-14. This proposed regulation establishes the 1998 fishing seasons and limits. Included is a listing of those bodies of water open to trout fishing and the period of time that a trout permit is required. The proposal would add one body of water for trout stocking and fishing, and eliminate another that is no longer being used. The proposal would also newly establish 15" statewide length limits for black bass and for walleye/sauger/saugeye.

Economic Impact Summary: The new water body for trout fishing will provide a new type of fishing opportunity, but is not expected to create additional trout permit sales, and therefore is not expected to have an economic impact. Nor are the statewide length limits anticipated to have an economic impact, as many waters already have posted length limits for these species.

86-1-3. Expiration of licenses. (a) Except for a temporary salesperson's license, the expiration date of each license shall be determined by the first letter of the licensee's last name, as established in the following chart:

86-1-5. Fees. (a) Each applicant shall pay a fee in an amount equal to the actual cost of the examination and the administration of the examination to the testing service designated by the commission.

(b) Each applicant shall submit the following fees for licensure to the commission:

(1) For submission of an application for an original salesperson's or broker's license, a fee of \$15;

(2) for a temporary salesperson's license, a six-month fee of \$20;

(3) for an original salesperson's license, a prorated fee based on a two-year amount of \$80;

(4) for an original broker's license, a prorated fee based on a two-year amount of \$125;

(5) for renewal of a salesperson's license, a two-year fee of \$80;

(6) for renewal of a broker's license, a two-year fee of \$125;

(7) for reinstatement of a license that has been deactivated or that has been canceled pursuant to K.S.A. 58-3047(d), and its amendments, or by reason of termination of a salesperson or associate broker, a fee of \$15;

(8) for reinstatement of each license canceled pursuant to K.S.A. 58-3047(e), and its amendments, a fee of \$7.50;

(9) for a duplicate license, a fee of \$10; and

(10) for certification of licensure to another jurisdiction, a fee of \$10.

(c) Each applicant shall submit the following fees related to courses of instruction to the commission:

(1) For approval of a course of instruction submitted by a course provider pursuant to K.S.A. 58-3046a, and its amendments, a fee of \$50;

(2) for renewal of an approved course of instruction pursuant to K.S.A. 58-3046a, and its amendments, a fee of \$15; and

(3) for approval of a course of instruction submitted by any licensee pursuant to subsection (j) of K.S.A. 58-3046a, and its amendments, a fee of \$10.

(d) For each prorated fee, a monthly amount, rounded off to the nearest dollar, shall be established by the commission. In addition, the fee, from the last calendar day of the month in which the license is issued to the expiration date of the license, shall be computed by the commission.

86-1-11. Minimum curricula and standards for course. (a) Each school offering a course approved by the commission under subsection (a) of K.S.A. 58-3046a, and its amendments, shall use a course syllabus provided by the commission and shall register the course under the title "Principles of Real Estate."

(b) Each school offering a course approved by the commission under subsection (b) of K.S.A. 58-3046a, and its amendments, shall use a course syllabus provided by the commission and shall register the course under the title "Broker Pre-License Course."

(c) The 12 hours of additional instruction required by subsection (c), paragraph (d)(2), paragraph (e)(2), paragraph (f)(2), and paragraph (f)(3) of K.S.A. 58-3046a, and its amendments, shall consist of courses approved by the commission.

(1) The hours required for each renewal of a salesperson's or broker's license between January 1, 1996 and January 1, 1999 shall consist of at least three hours designated as mandatory core hours and not more than nine hours designated as elective hours.

(2) The hours required for each renewal of a salesperson's license after January 1, 1999 shall consist of at least three hours designated as mandatory core hours and not more than nine hours designated as elective hours.

(3) The hours required for each renewal of a broker's license after January 1, 1999 shall consist of at least six hours designated as mandatory core hours and not more than six hours designated as elective hours.

(4) On and after January 1, 1994, each course approved by the commission shall be designated, at the discretion of the commission, as either meeting a mandatory core requirement or as elective hours.

(5) Each school offering a course approved by the commission to meet the mandatory core requirement pursuant to paragraphs (1) or (2) above shall use a course outline provided by the commission and shall register the course under the title "Required Salesperson Core."

(6) Each school offering a course approved by the commission to meet the mandatory core requirement pursuant to paragraph (3) above shall use a course syllabus provided by the commission and shall register such course under the title "Required Broker Core."

(7) Each salesperson shall meet the mandatory core requirement pursuant to paragraphs (1) or (2) above by taking any course designated by the commission as meeting a mandatory core requirement.

(8) Each broker shall meet the mandatory core requirement pursuant to paragraph (1) above by taking any course designated by the commission as meeting a mandatory core requirement and shall meet the mandatory core requirement pursuant to paragraph (3) by taking the course entitled "Required Broker Core."

(9) Credit given to any licensee for a course submitted by the licensee pursuant to subsection (j) of K.S.A. 58-3046a, and its amendments, shall be designated by the commission as either meeting a mandatory core requirement or as elective hours.

(10) Any nonresident of Kansas may receive credit as elective hours for courses approved by the commission of the nonresident's state of residence. A nonresident may receive credit for a mandatory core requirement only for courses approved by the commission pursuant to this regulation.

(11) Each approved course shall have a total instruction time of no fewer than three hours.

(12) Any licensee may receive a maximum of three hours credit during any renewal period for real estate appraisal courses designated as such by the commission and taken after January 1, 1992.

(d) Instruction required by paragraph (d)(1) of K.S.A. 58-3046a, and its amendments, shall include 30 hours of instruction designated by the commission as required hours and 20 hours elected by the licensee from courses approved by the commission pursuant to subsection (c) of this regulation.

(e) The 30 hours of instruction designated as required hours under subsection (d) of this regulation and the 30 hours of instruction required by paragraph (e)(1) and paragraph (f)(1) of K.S.A. 58-3046a, and its amendments, shall consist of a course registered under the title "Salesperson's Post-License Course," and any school offering the course shall use a course syllabus provided by the commission.

Article 2.—AUTHORITY OF COMMISSION; PROCEDURE

86-2-8. Examination of records. (a) All documents and records delineated in the Kansas real estate brokers' and salespersons' license act and the brokerage relationships in real estate transactions act and their accompanying regulations shall be examined by the commission or designated agents or employees of the commission at least once every five years, but no more than twice during any 12-month period beginning on July 1.

(b) Examination of records shall be made between the hours of 8:00 a.m. and 6:00 p.m., unless otherwise agreed by all interested persons or entities.

(c) Examinations shall be conducted by commission members, the director of the commission, or employees of the commission.

(d) Examination and inspection of a licensee's records or a group of licensees' records may be authorized by the commission or its director.

(e) The authorized examination may be conducted without notice to the licensee.

(f) This regulation shall not restrict the frequency of examinations that may be conducted to investigate a specific complaint filed with the commission. Such an examination may be authorized by the commission or its director at any time, but shall be limited as follows.

(1) Only those documents subject to the recordkeeping requirements of the acts specified in subsection (a) above and their accompanying regulations shall be examined.

(2) Examinations shall be made only between the hours of 8:00 a.m. and 6:00 p.m., unless otherwise agreed by all interested persons or entities.

(3) Examinations may be conducted by commission members, the director of the commission, or employees of the commission.

(4) The authorization for such examination of records may be made by either the commission or its director. (Authorized by K.S.A. 1996 Supp. 74-4202(b), as amended by 1997 H.B. 2264, Sec. 46; implementing K.S.A. 58-3061 and K.S.A. 1996 Supp. 74-4202(b), as amended by 1997 H.B. 2264, Sec. 46; effective Sept. 12, 1994; amended, T-86-10-1-97, Oct. 1, 1997.)

Article 3.—PERSONS HOLDING LICENSES; DUTIES

86-3-25. (Authorized by and implementing K.S.A. 1995 Supp. 58-30,110, as amended by 1996 SB 710, § 18; effective Nov. 17, 1995; amended Sept. 13, 1996; revoked, T-86-10-1-97, Oct. 1, 1997.)

86-3-26. Real estate brokerage relationships brochure. As required by K.S.A. 58-30,110, and amendments thereto, each licensee shall give any prospective buyer or seller a brochure entitled "Real estate brokerage relationships." Each brokerage firm may either obtain a copy of this brochure from the commission for reproduction and use by its affiliated licensees or design a brochure that

contains the minimum information contained in subsections (a), (b), (c), and (d). If a brokerage firm designs its own "Real estate brokerage relationships" brochure, the brochure may be in a format determined by the brokerage firm and may include the company name, company logo, and an explanation of the firm's brokerage relationships policy.

(a) Seller's agent. The seller's agent represents the seller only, so the buyer may be either unrepresented or represented by another agent.

(1) The seller's agent is responsible for performing the following duties:

(A) Promoting the interests of the seller with the utmost good faith, loyalty, and fidelity;

(B) protecting the seller's confidences, unless disclosure is required;

(C) presenting all offers in a timely manner;

(D) advising the seller to obtain expert advice;

(E) accounting for all money and property received;

(F) disclosing to the seller all adverse material facts about the buyer that the agent knows; and

(G) disclosing to the buyer all adverse material facts actually known by the agent, including the following:

(i) Environmental hazards affecting the property that are required to be disclosed;

(ii) the physical condition of the property;

(iii) any material defects in the property or in the title to the property; and

(iv) any material limitation on the seller's ability to complete the contract.

(2) The seller's agent has no duty to perform the following:

(A) Conduct an independent inspection of the property for the benefit of the buyer; or

(B) independently verify the accuracy or completeness of any statement by the seller or any qualified third party.

(b) Buyer's agent. The buyer's agent represents the buyer only, so the seller may be either unrepresented or represented by another agent.

(1) The buyer's agent is responsible for performing the following duties:

(A) Promoting the interests of the buyer with the utmost good faith, loyalty, and fidelity;

(B) protecting the buyer's confidences, unless disclosure is required;

(C) presenting all offers in a timely manner;

(D) advising the buyer to obtain expert advice;

(E) accounting for all money and property received;

(F) disclosing to the buyer all adverse material facts that the agent knows; and

(G) disclosing to the seller all adverse material facts actually known by the agent, including all material facts concerning the buyer's financial ability to perform the terms of the transaction.

(2) The buyer's agent has no duty to perform the following:

(A) Conduct an independent investigation of the buyer's financial condition for the benefit of the seller; or

(B) independently verify the accuracy or completeness of statements made by the buyer or any qualified third party.

(c) Transaction broker. The transaction broker is not an agent for either party, so the transaction broker does not advocate the interests of either party.

(1) The transaction broker is responsible for performing the following duties:

(A) Protecting the confidences of both parties, including the following information:

- (i) the fact that a buyer is willing to pay more;
- (ii) the fact that a seller is willing to accept less;
- (iii) the factors that are motivating any party;
- (iv) the fact that a party will agree to different financing terms; and

(v) any information or personal confidences about a party that might place the other party at an advantage;

- (B) exercising reasonable skill and care;
- (C) presenting all offers in a timely manner;
- (D) advising the parties regarding the transaction;
- (E) suggesting that the parties obtain expert advice;
- (F) accounting for all money and property received;
- (G) keeping the parties fully informed;
- (H) assisting the parties in closing the transaction;
- (I) disclosing to the buyer all adverse material facts actually known by the transaction broker, including the following:

(i) environmental hazards affecting the property that are required to be disclosed;

(ii) the physical condition of the property;

(iii) any material defects in the property or in the title to the property; and

(iv) any material limitations on the seller's ability to complete the contract; and

(J) disclosing to the seller all adverse material facts actually known by the transaction broker, including all material facts concerning the buyer's financial ability to perform the terms of the transaction.

(2) The transaction broker has no duty to perform any of the following:

(A) conduct an independent inspection of the property for the benefit of any party;

(B) conduct an independent investigation of the buyer's financial condition; or

(C) independently verify the accuracy or completeness of statements by the seller, buyer, or any qualified third party.

(d) Statement of representation. The following statement, in bold-faced type, shall be included in the brochure.

"Do not assume that an agent is acting on your behalf, unless you have signed a contract with the agent's firm to represent you. As a customer, you represent yourself. Any information that you, the customer, disclose to the agent representing another party will be disclosed to that other party. Even though licensees may be representing other parties, they are obligated to treat you honestly, give you accurate information, and disclose all known adverse material facts."

(b) Each broker shall use a transaction broker addendum form (TBA-COMM) approved by the commission on April 10, 1997, which is hereby adopted by reference, to obtain the informed consent of a seller client and a buyer client for the broker to act as a transaction broker, on a contemplated transaction between the buyer and seller, for the sale or lease of commercial property or the sale of residential property of more than four units.

(c) Each broker shall use a transaction broker addendum form (TBA-AG) approved by the commission on August 14, 1997, which is hereby adopted by reference, to obtain the informed consent of a seller client and a buyer client for the broker to act as a transaction broker, on a contemplated transaction between the buyer and seller, for the sale of agricultural land.

(d) Each broker shall use a transaction broker addendum form (TBA-DA) approved by the commission on April 10, 1997, which is hereby adopted by reference, to obtain the informed consent of a seller client and a buyer client for a designated agent to act as a transaction broker, on a contemplated transaction between the buyer and seller.

86-3-28. Buyer's or tenant's consent. (b) Before initiating a contract with a buyer who has an agency agreement granting exclusive representation to another broker, any transaction broker shall obtain the buyer's signature on a "buyer's consent to initiate a contract with a transaction broker engaged by a seller" form approved by the commission on September 10, 1997, which is hereby adopted by reference.

109-6-2. Renewal of attendant and instructor/coordinator certificate. (a) Each attendant certificate and instructor/coordinator certificate shall expire on December 31 of the year following the date of initial issuance or the last renewal, unless the agency receives a sufficient application for renewal on or before January 31 immediately following expiration.

(b) An application for renewal shall be considered sufficient when these requirements are met:

(1) the information requested on the application form is provided in full, and no additional information is required by the agency to complete the processing of the application; and

(2) a money order, cashier's check, or an institutional check in the amount of the renewal fee prescribed by the board is included with the application. "Institutional check" means a negotiable instrument, warrant, payment voucher, or purchase order from an ambulance service, fire department, or municipality, as defined at K.S.A. 65-6112 and amendments.

(c) All applications for certification renewal shall be submitted on the original form provided by the administrator. Copies, facsimiles, electronic filings, or other reproductions shall not be accepted.

(d) If the agency receives a sufficient application for renewal before January 31, the existing certificate shall not expire until the agency has taken final action upon the renewal application, or if the agency's action is unfavorable, until the last day for seeking judicial review of the agency's action or a later date fixed by the reviewing court.

(e) If no renewal application is received on or before January 31 immediately following expiration, or if the application is received on or before January 31 but is not sufficient, the existing certificate shall be void.

(f) Upon receipt of an insufficient renewal application, the applicant shall be notified by the agency of any deficiencies. However, if the applicant fails to correct the deficiencies on or before January 31, the existing certificate shall become void. Each corrected application for renewal shall be received by the agency no later than January 31. (Authorized by and implementing K.S.A. 1995 Supp. 65-6129 and K.S.A. 65-6129b; effective Nov. 1, 1996; amended Oct. 31, 1997.)

The landfill's current area is approximately 13 acres, and the proposed expansion would add a 3-acre tract east of the existing landfill. KDHE is providing public notice of its intent to issue an amended municipal solid waste landfill permit to Haskell County that increases the permitted area. As a condition of the amended permit, the county is required to modify environmental monitoring procedures, update operation and closure plans, and file a restrictive covenant. Once this information is submitted and approved, the requirements of new state and federal regulations for small arid landfills, which became effective October 9, 1997, will be fulfilled.

The Kansas Department of Health and Environment is proposing to issue a five-year permit to the following facilities pursuant to Title IV (Acid Deposition Control) of the Federal Clean Air Act and to implement regulations found at 40 CFR Parts 72 through 78. The effective date of the permit is January 1, 2000 through December 31, 2004.

Each sulfur dioxide (SO₂) allowance authorizes the utility boiler to emit up to one ton of SO₂ during or after each of the years specified above. All facilities propose to comply with the Acid Rain Program emission requirements by holding enough allowances to cover all sulfur dioxide emissions. Issuance of this permit will not affect the responsibility of the facility to meet all other existing local, state and federal emission requirements.

All coal-fired units must comply with the Acid Rain Program nitrogen oxides (NO_x) emission requirements by not exceeding the Phase I (if an early elect unit (*) or a Phase I unit (^)) or Phase II emission limitation. All coal-fired Phase II facilities that have not committed to a NO_x emission limitation will have their permits reopened prior to January 1, 1999, to incorporate the NO_x emission limitation.

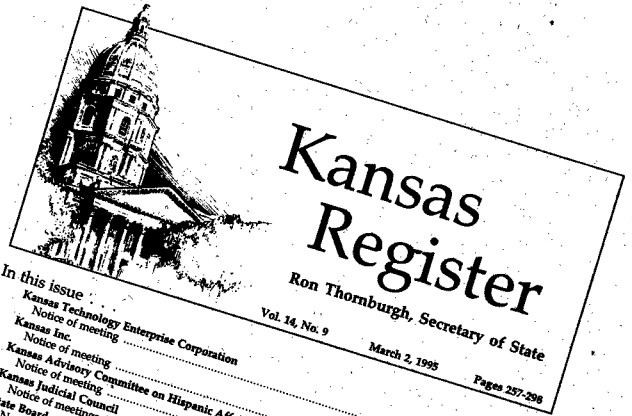
